







Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Before and After School Programs:

The Drop In Center for our middle school and high school students takes place in the BHS library for a period of time in the mornings and then again after school. Students make use of the time available to print work, complete homework before they leave the building, work on projects, and receive free tutoring with certified teachers and members of the National Junior Honor Society. Students are also given the opportunity for free tutoring/free SAT Prep after school to close the achievement gap created during the pandemic and/or increase SAT scores. Bogota also proudly hosts an adult ESL program at night.



Staff and Professional Learning:

Our major focus for Professional Development includes RTI, hybrid learning, and mental health. Teachers are also trained in Marzano, Unit Planning, Suicide Prevention, Anti-Bullying, and Data Analysis to name a few. Strategic action plans and teacher teams were created to further assist these students. Our Math and ELA department chairpersons have taken on more of an instructional role, providing additional support and direct assistance for our teachers.



For the class of 2024, 89% of the students were enrolled in post-secondary education, with the majority staying local, the 10% enrolled in a technical school, the armed forces, or employed. Naviance is used for career and college searches, scholarships, resumes, and applying to college. Members of the graduating class have been accepted to many colleges including Fordham, NJIT, Steven's Institute of Technology, Villanova, and Rutgers.

Student Supports and Services:

Gen. ed. students may be put through the RTI process to receive interventions. ESL classes are available for ELL students. A before & after school homework club is run by a teacher to provide extra help where NHS students provide tutoring and free tutoring is available after school. The district also offers special ed. services for students with disabilities including LLD classes, In-Class Support & Resource Replacement with related services (for all) such as counseling, OT, PT, & speech. A behaviorist is available, as needed. This year we have a full time SAC and Care plus services for our students.



Students participate in PE daily 3 marking periods. The 4th marking period is dedicated to Health Education, including physical and mental health. Breakfast/lunch is offered daily and students have the opportunity to spend time on the playground during lunch. BHS has been designated a Stigma-Free Zone and is committed to educating our students about mental health issues. Students are also asked to complete 35 hours of community service over the life of their high school career. BHS also opened up its Wellness Center to provide students and families with counseling for mental health, family, social and emotional issues. This is open full year. We have developed a strong partnership with BACSA and are creating a Jr. BACSA housed at the high school. Our mentoring program continues to provide support for at-risk students and gives them the daily one-to-one attention needed to bridge the gap between school and home life.



Parent and Community Involvement:

Being a small school we are closely connected to the community. Strong communication and support exists with the Bogota Police and Fire Departments and the Recreation Department. These relationships help build a strong school community and give our students a solid foundation. Organizations such as the PTO, Bogota Beautiful, the Band Parent Organizations, and the Bogota Advisory Council of Substance Abuse all support and enrich our programs and community collaboration. This year we've also adopted an additional system of communication, 'thrill share' facilitating and sustaining home-school communication.

We continue to increase electives/technology and update classrooms/labs. As a school, we understand the need for a strong STEM curriculum and believe these changes will support our goals. Currently we offer Forensic Science, Nutritional Science, Anatomy and Physiology, Engineering, AP biology, AP Environmental, AP Computer Science, AP Statistics, AP pre-Calculus, and AP Calculus. We also introduced our new STEM club. The purpose of the STEM club is to provide students who are interested in pursuing these careers, opportunities to explore various professions including careers in health care, medical, and scientific research.



We also offer a variety of dual enrollment classes through our partnerships with Bergen Community College and Fairleigh Dickinson University. We've also adopted 'thrill share', an additional communication system to keep parents informed. BHS is also a data-based school. This means we gather information which we then disseminate to our teachers in order to provide in-depth analysis of student performances. This then enables teachers to develop an educational strategy to be employed by each student. We also used our social media accounts to communicate with parents/students, promote school events, and celebrate student accomplishments.
