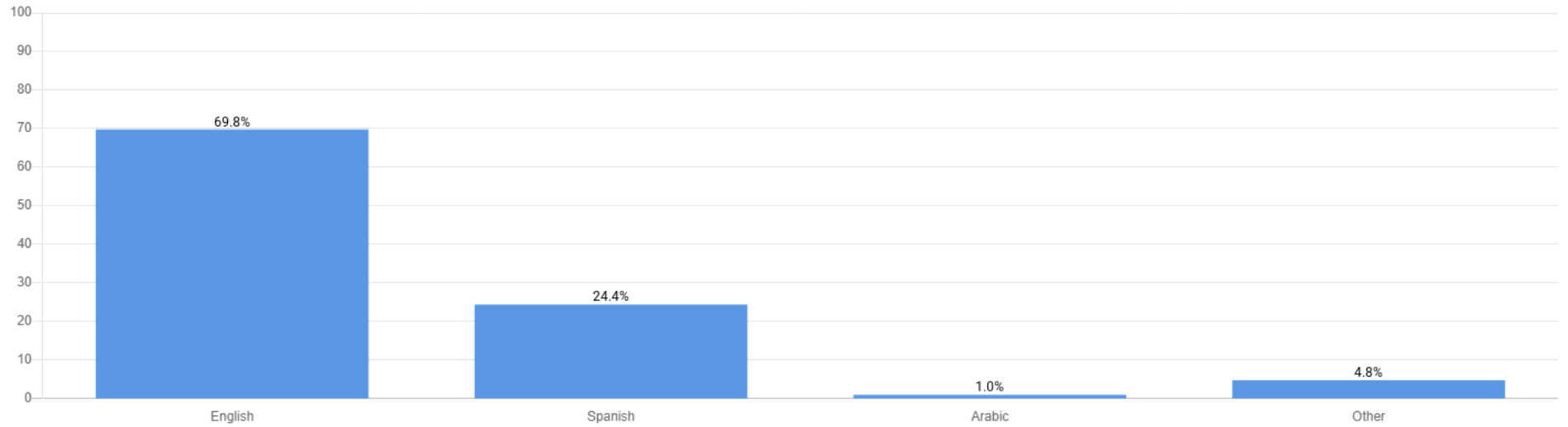

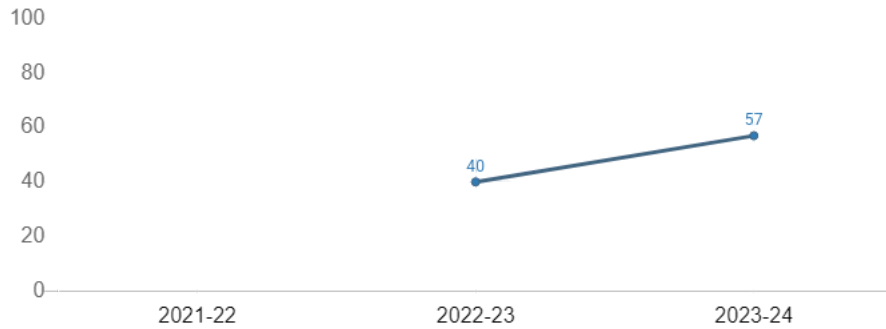

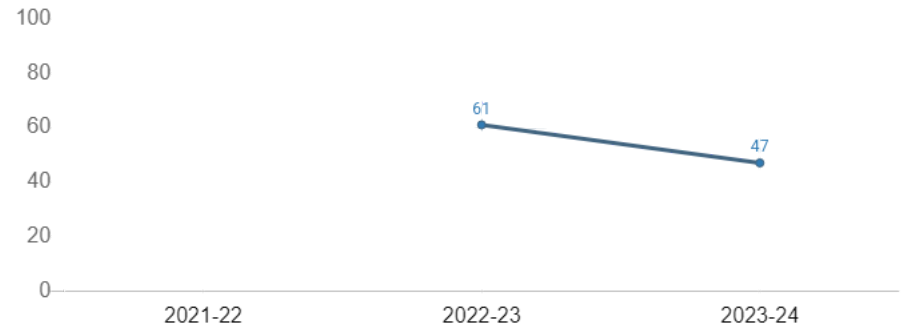

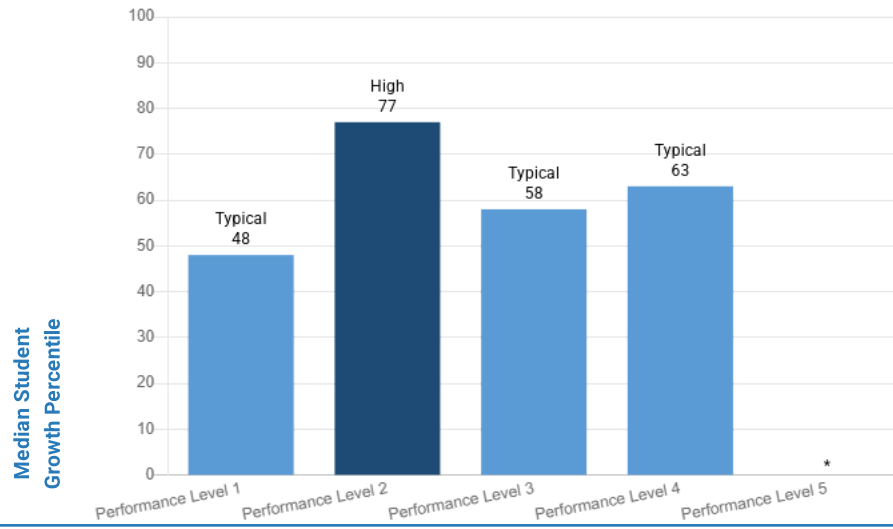

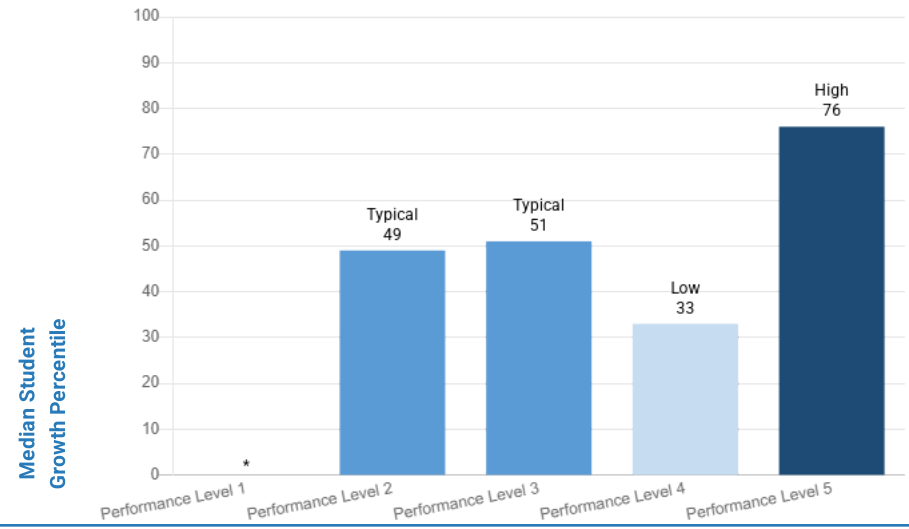

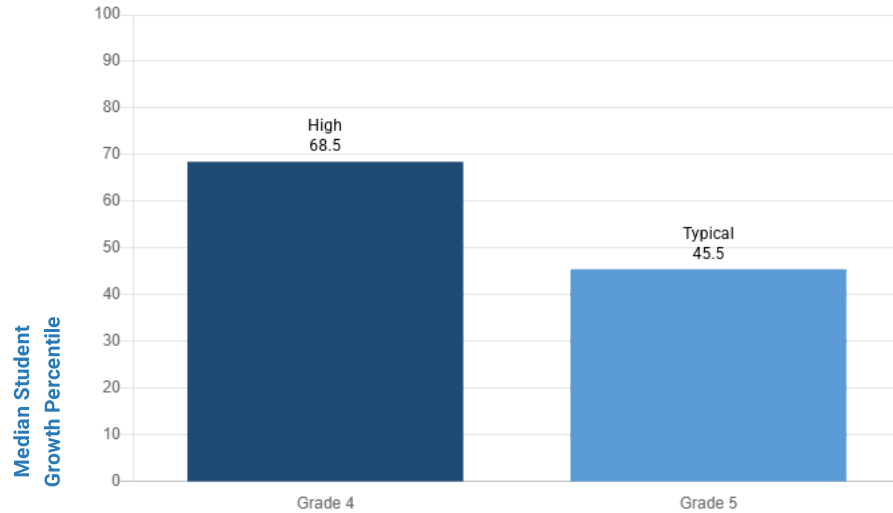

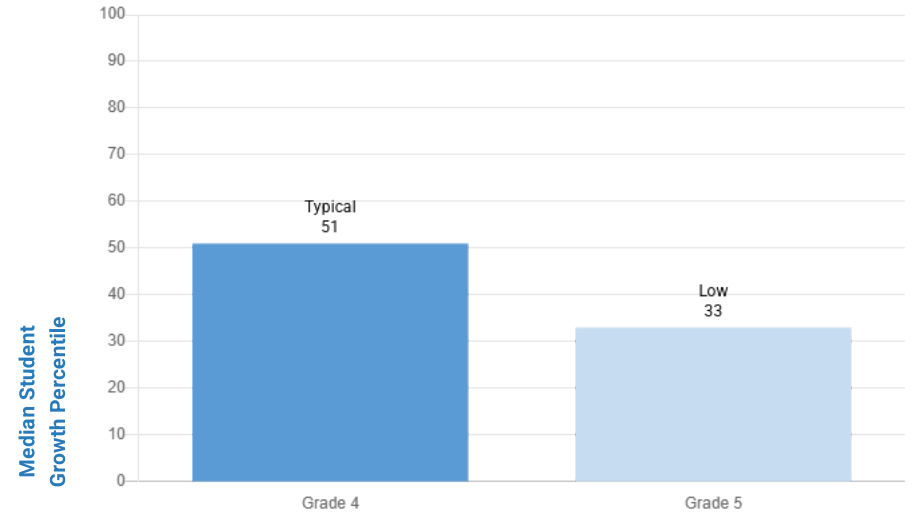

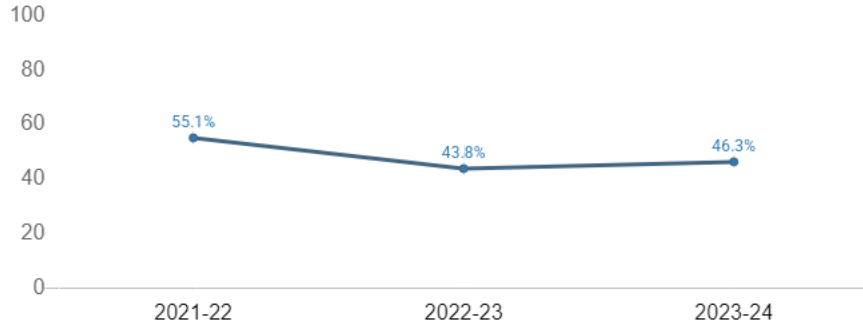

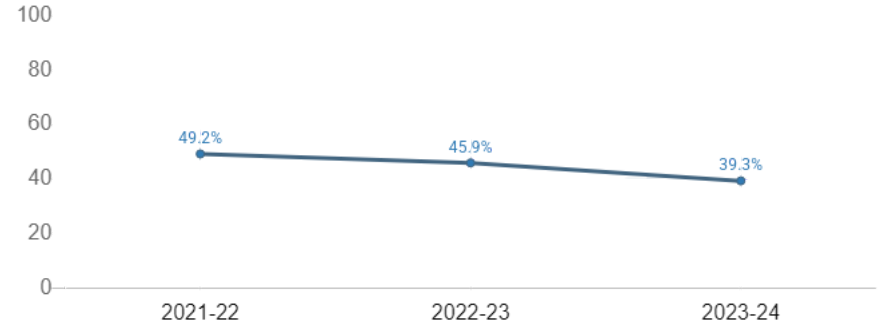
English Language Arts and Mathematics Performance Trends

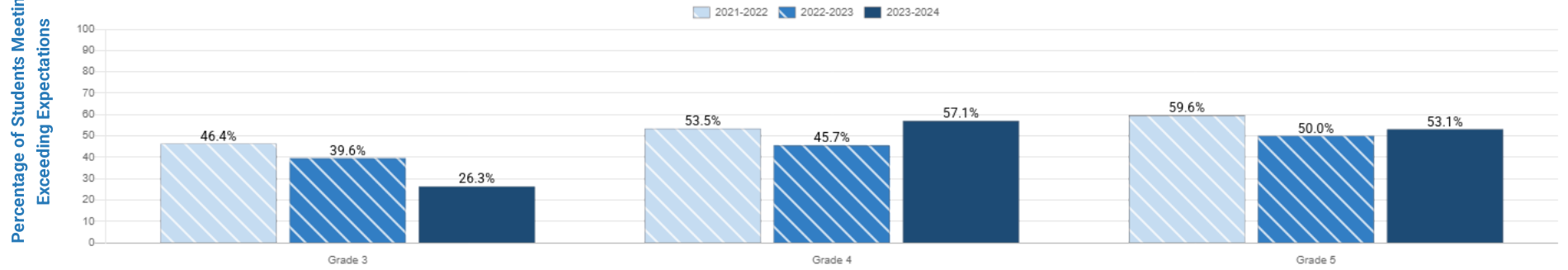

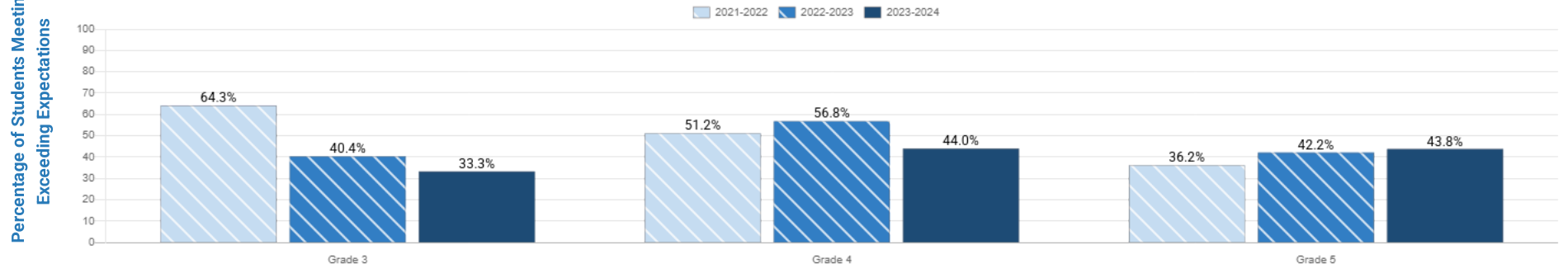

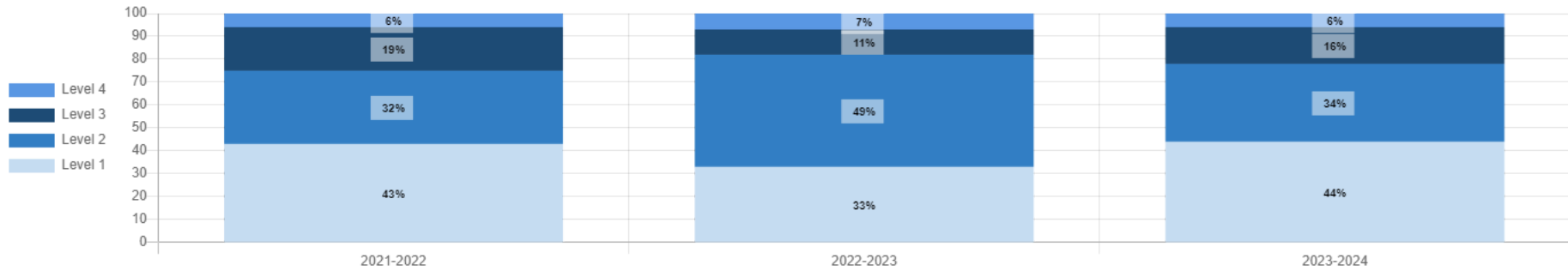

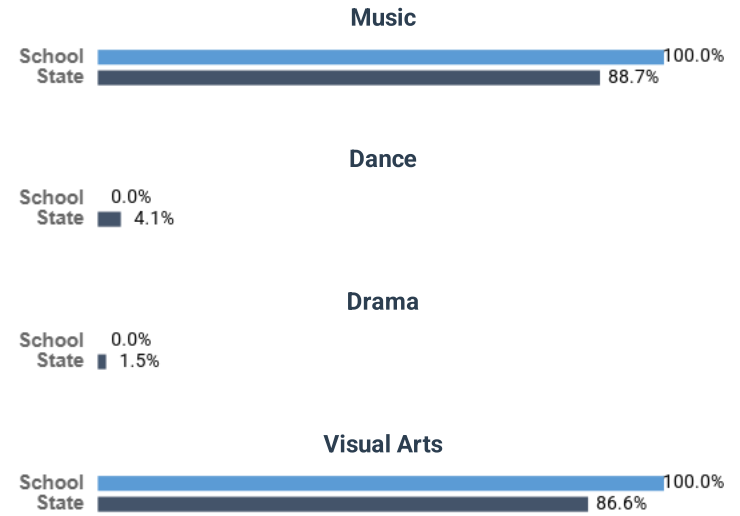

Students enrolled in one or more classes by discipline:



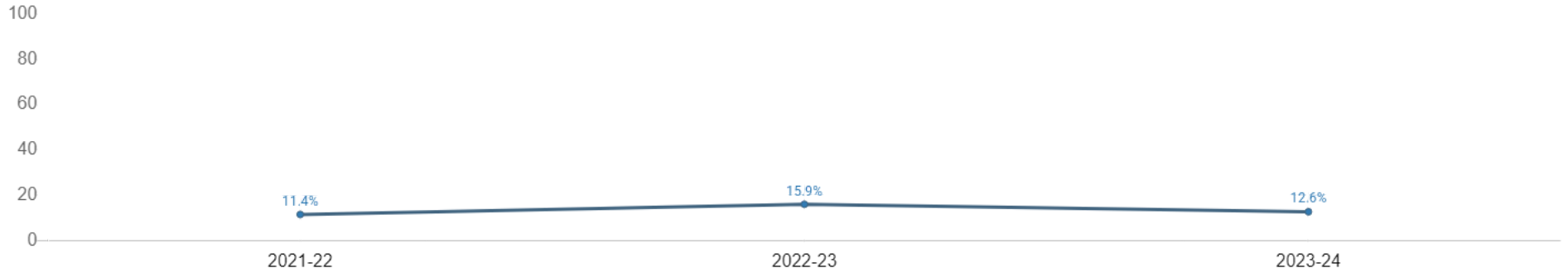

The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

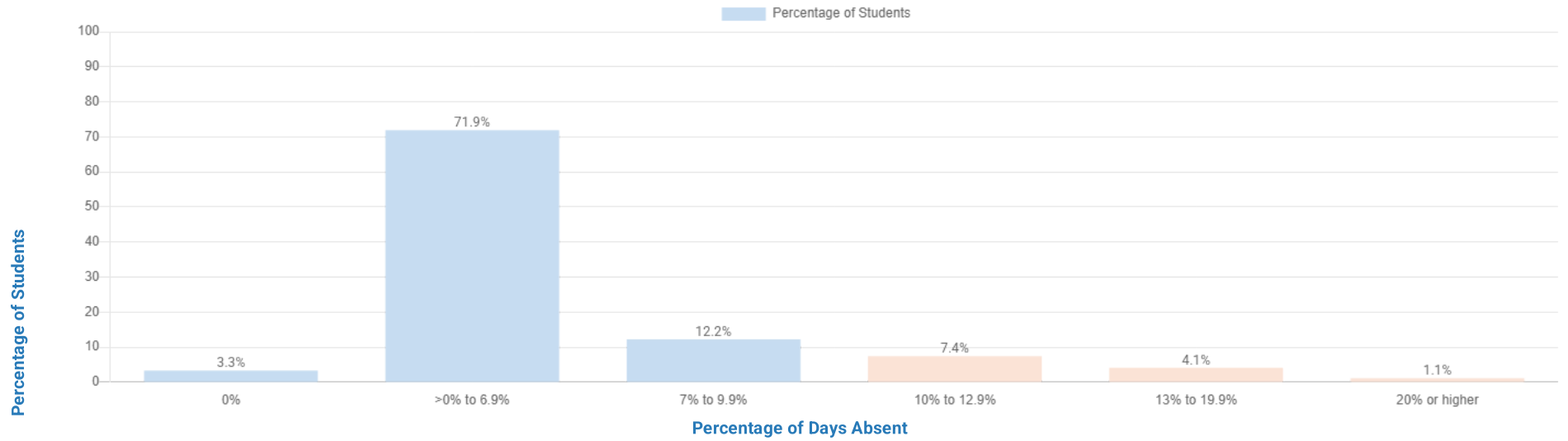

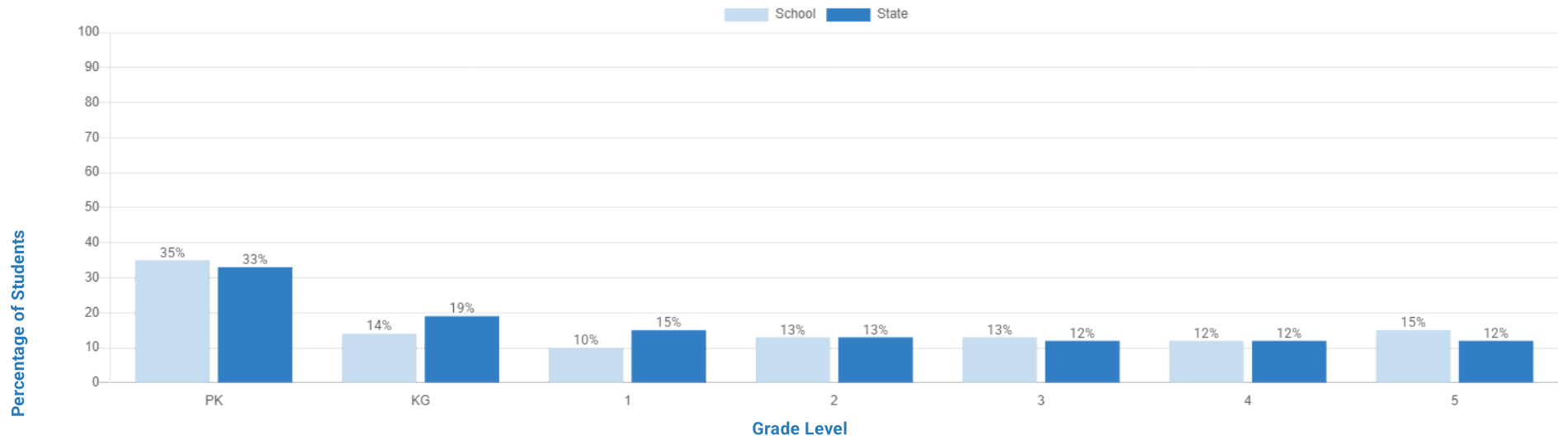

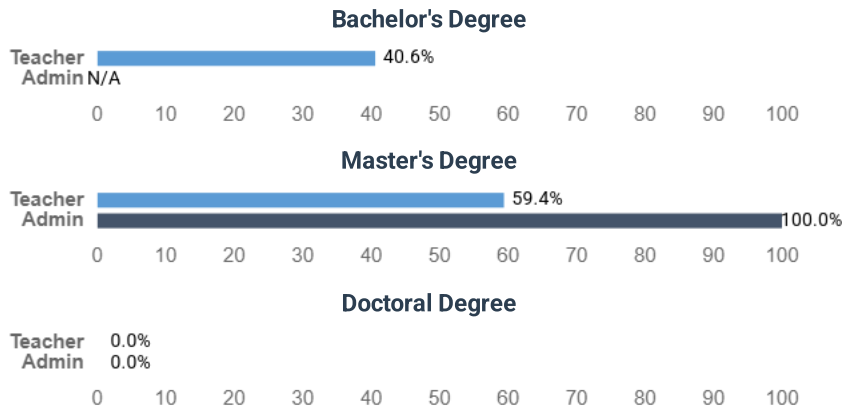

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

The expectations outlined in the New Jersey Student Learning Standards are met and exceeded. The teachers work diligently to meet the individual learning styles of all the students through differentiated instruction and student-centered learning. We utilize a standard based instruction approach for language arts, Envision Math Series 2.0 and Mystery Science. There are many specialists who work with classroom teachers to help meet the needs of the students. In addition to the daily instruction in the core academic subjects, students receive weekly instruction in art, music, media, Spanish and physical education. The school also provides a program for gifted and talented students in which they receive additional instruction. Staff and Professional Learning:

A schedule was created school-wide to provide Common Planning period for all grade levels. This gives teachers time to collaborate weekly to ensure all students are receiving high quality instruction and the teacher's pacing is aligned to the curriculum. Additionally, staff receives various trainings throughout the year regarding instruction and academic/behavioral supports.



Student Supports and Services:

They are available to help all the students with a variety of issues and challenges they face daily. They provide counseling services, run lunch groups, character education programs as well as a variety of other activities deemed appropriate for the students. We also have a partnership with CarePlus to help those students in need. We also work with FDU to provide counseling to students through our mental health grant.

We offer breakfast to our students daily as well as a balanced lunch program. Our students receive recess daily, along with physical education two times a week. There is one 40 minute period a day that teachers create lessons that focus on the social emotional wellness of all students.
