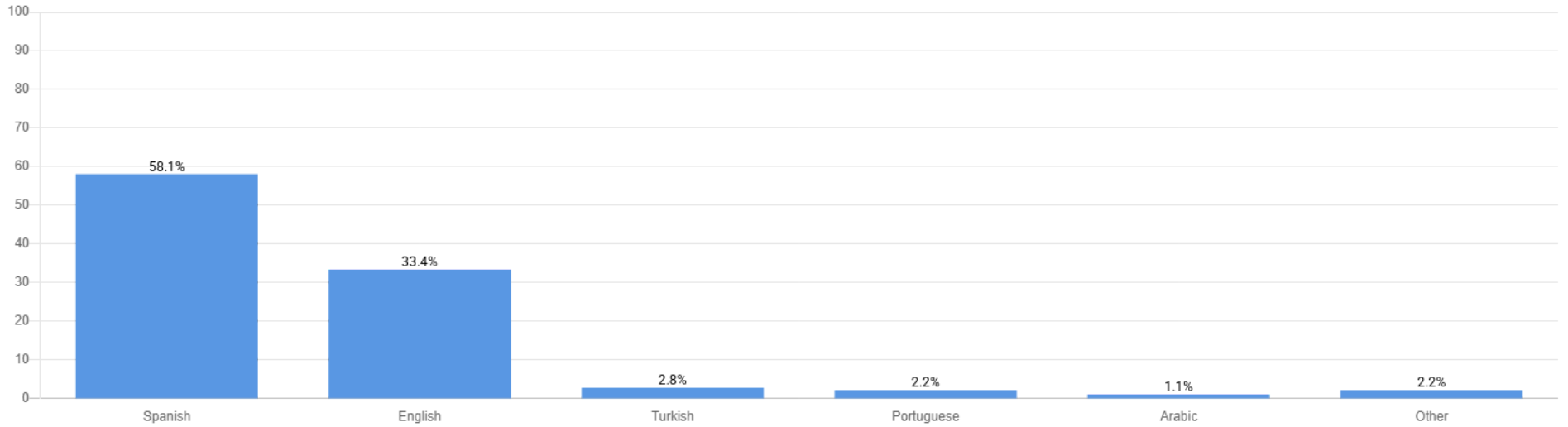

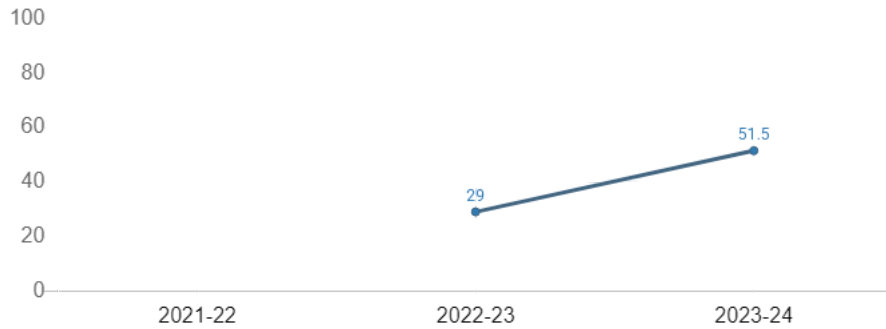

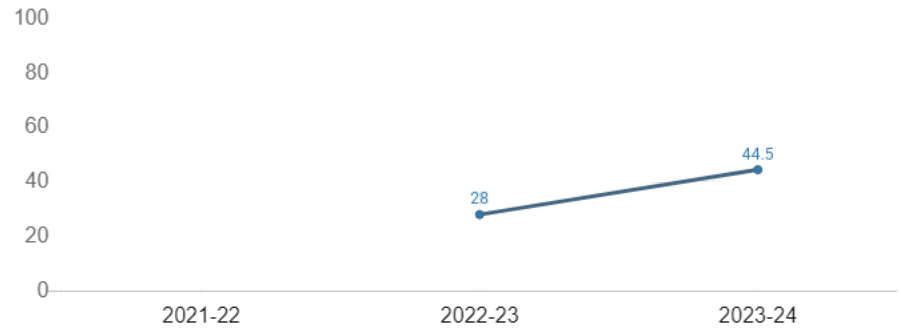

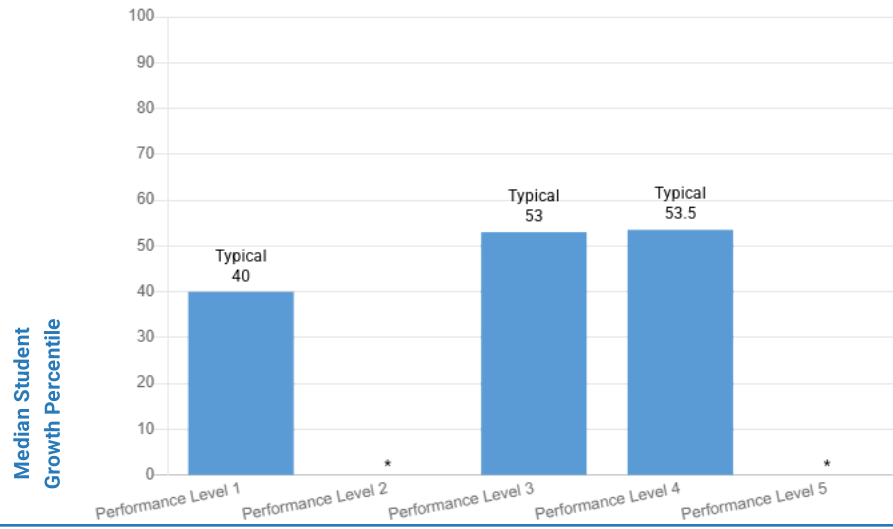

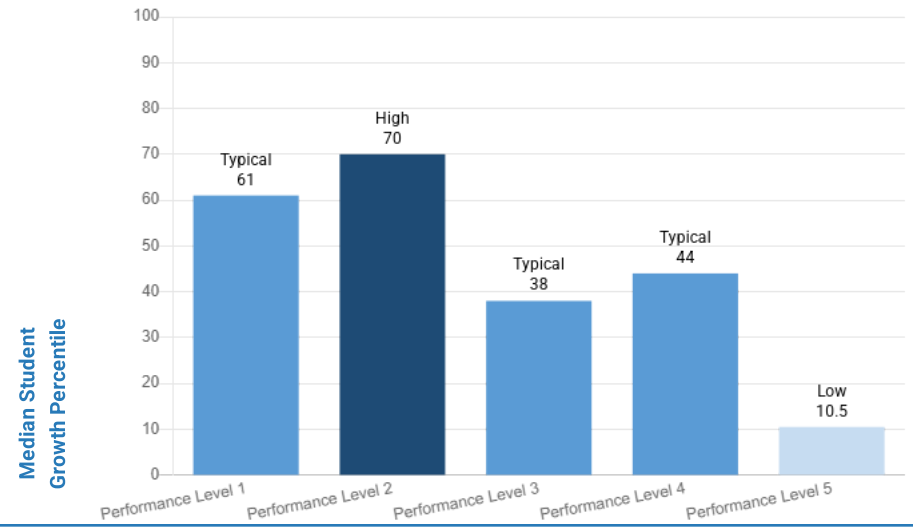

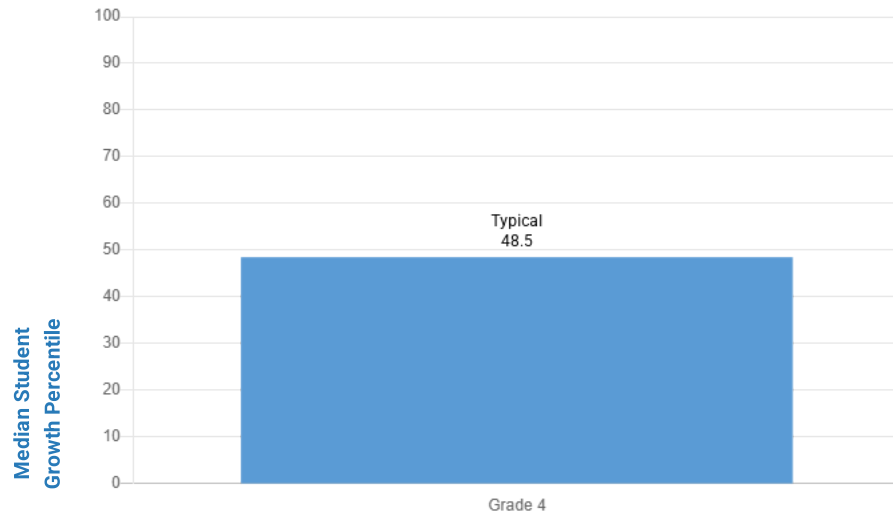

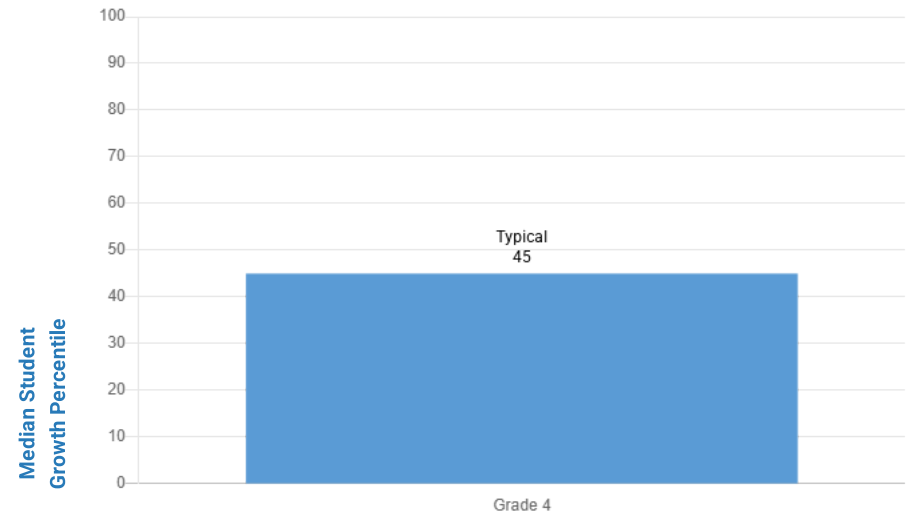

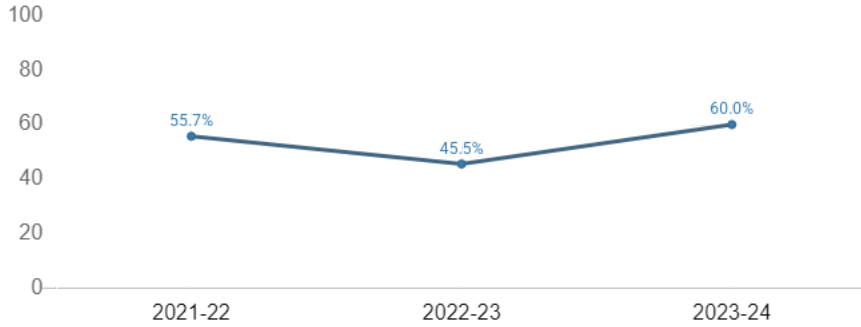

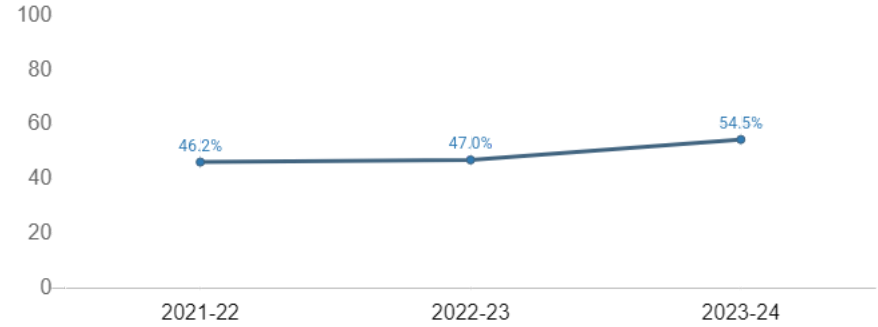
English Language Arts and Mathematics Performance Trends

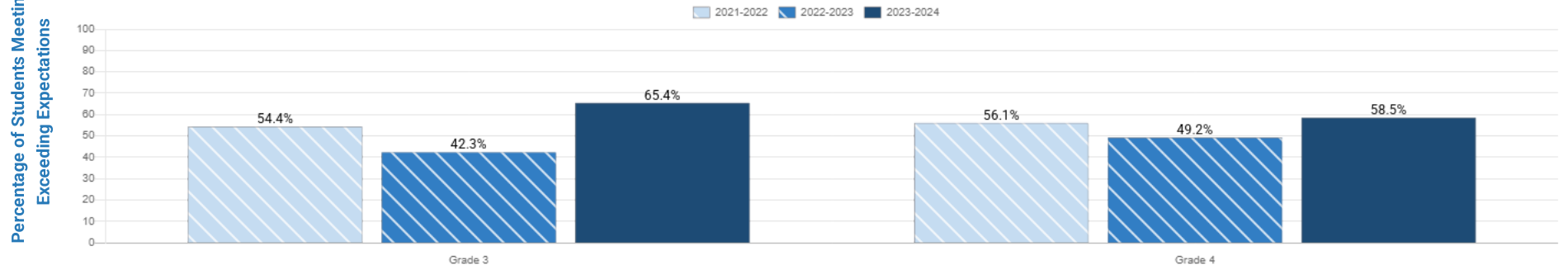

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. 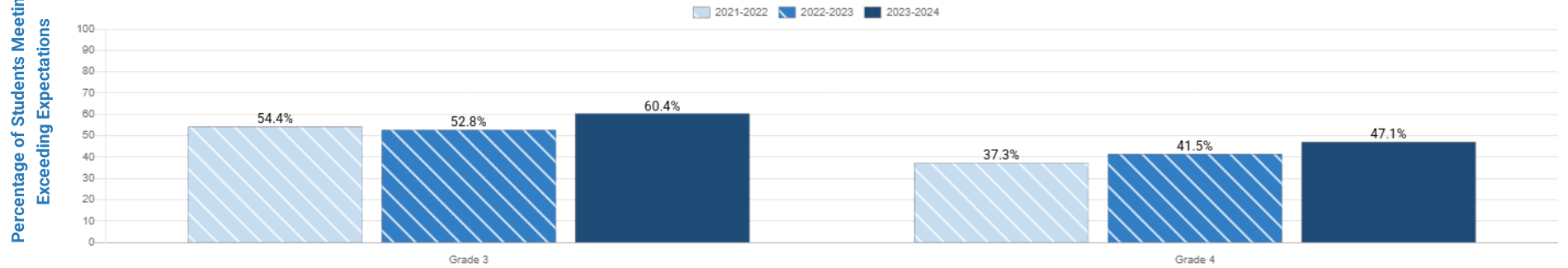

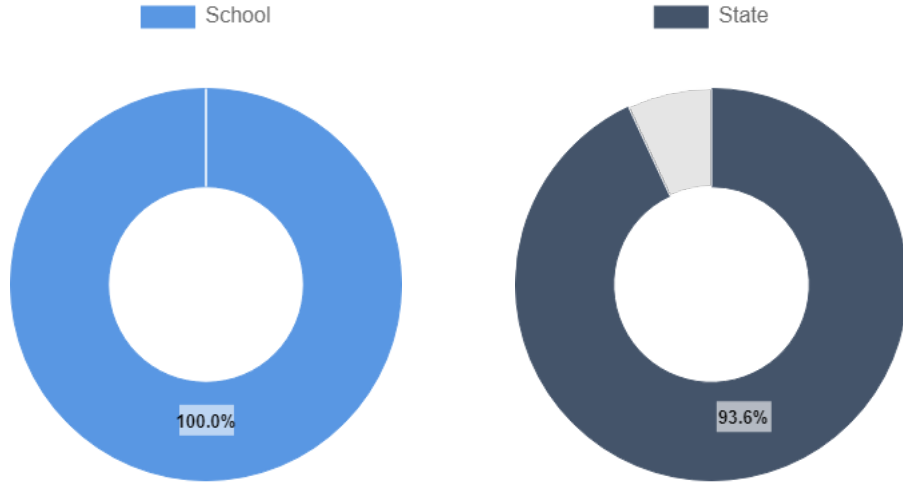

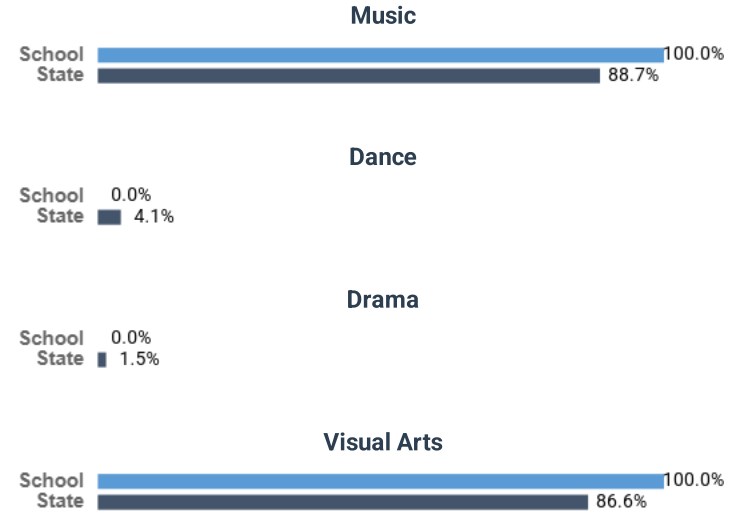

Students enrolled in one or more classes by discipline:



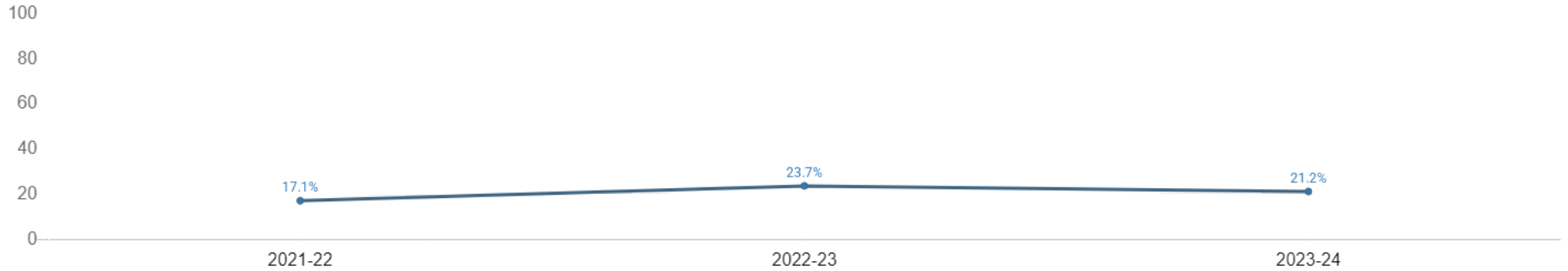

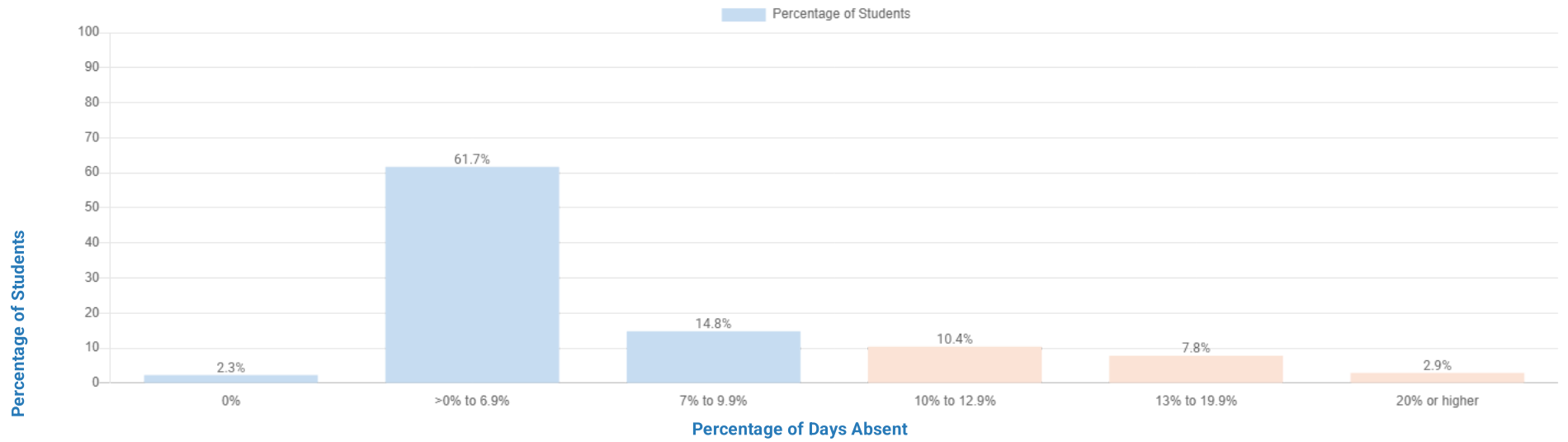

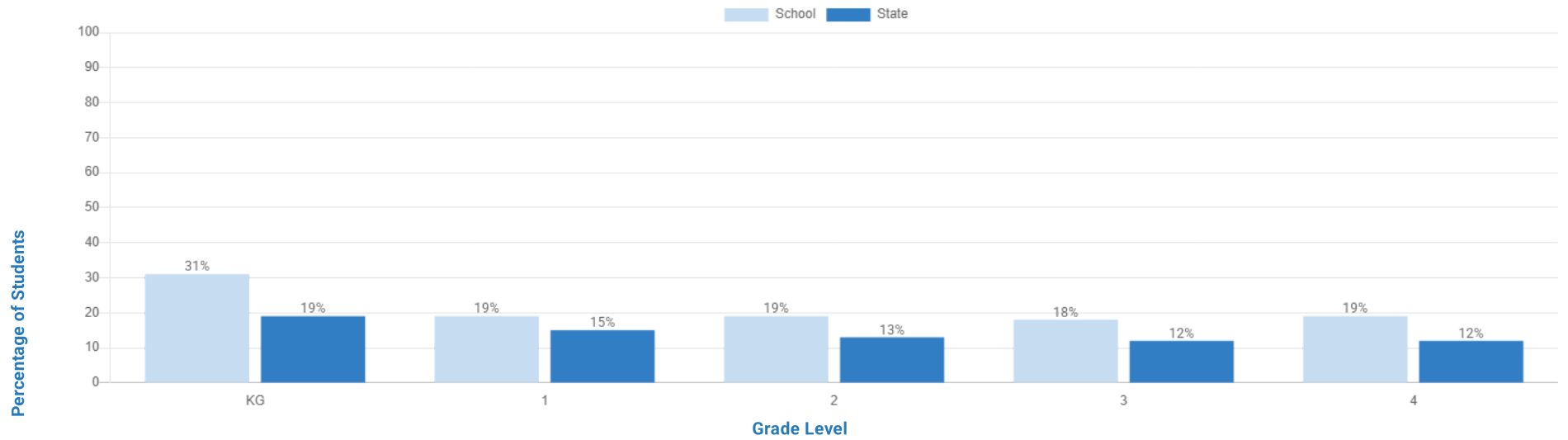

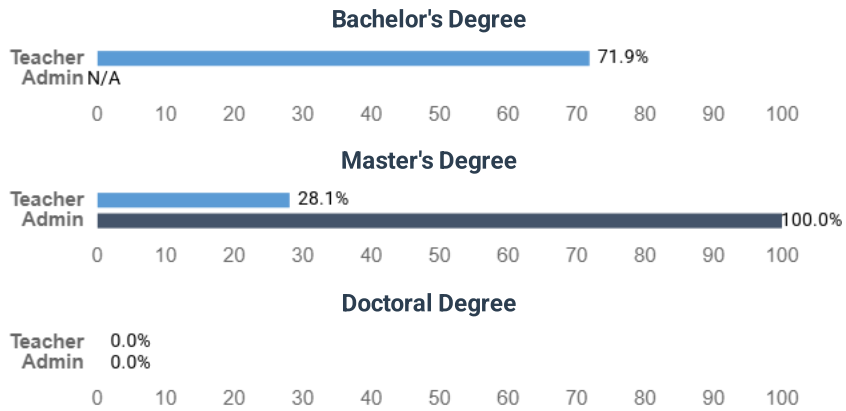

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Student Supports and Services:

The district offers an array of support services to meet the needs of diverse learners. This includes comprehensive programs for Special Education students, English Language Learners, students with 504 Plans and students with Health Plans. The district uses Intervention and Referral Services. Guidance Counselors and Child Study Teams work closely with students and their families, and teachers consistently integrate differentiated instructional strategies. CPSD has partnered with Jewish Family Services, a fully licensed and accredited mental health organization, to provide a school-based counseling program which directly supports students and their families. The therapists are experienced in youth development, therapy and case management and utilize a variety of effective models to develop skills and strategies for personal growth.



Student Health and Wellness:

School Three has a Health and Wellness Committee that meets to discuss and implement programs for our students. We also organize a special week with a variety of activities for both the teachers and the staff. Our school nurse and her amazing team are actively involved in researching, implementing programs and teaching lessons in the classrooms. Other Information:

School Three is a caring learning community with a population of approximately 374 students in grades kindergarten through four. Visitors immediately sense the warmth and spirit of cooperation present at our school. Parents and teachers work together to provide an academically challenging curriculum and culturally rich environment for our children. Recognizing that the ability to read and write is the foundation for success in all academic disciplines, developing a literate student body is a primary focus of the educational program and staff development initiatives. Teachers collaborate with one another to differentiate language arts instruction using the workshop model. Using literature and informational texts as guides, students learn the skills necessary to become truly literate readers and writers. Children publish personal narratives, memoirs, essays, realistic fiction, and informational pieces. The elementary mathematics program combines the practice of foundational skills with problem solving. Our goal is for the students to apply their knowledge of mathematics to life situations in an accurate, efficient, and thoughtful manner. Enrichment activities, as well as support programs, provide the children with an exemplary experience in mathematics. An inquiry-based science program gives our students opportunities to make predictions, collect data, take notes, graph information, reach conclusions, and create hypotheses. Hands-on experiences with earth, environmental, life, and physical science materials allow students to develop both process and thinking skills and apply them in making decisions and solving real-world problems. The study of communities, cultures, and history is the basis of our social studies program. Grade level teams implement units of study designed to allow children to experience the traditions of others and life in the past. Infused in all lessons is the importance of showing respect to individuals and groups.
