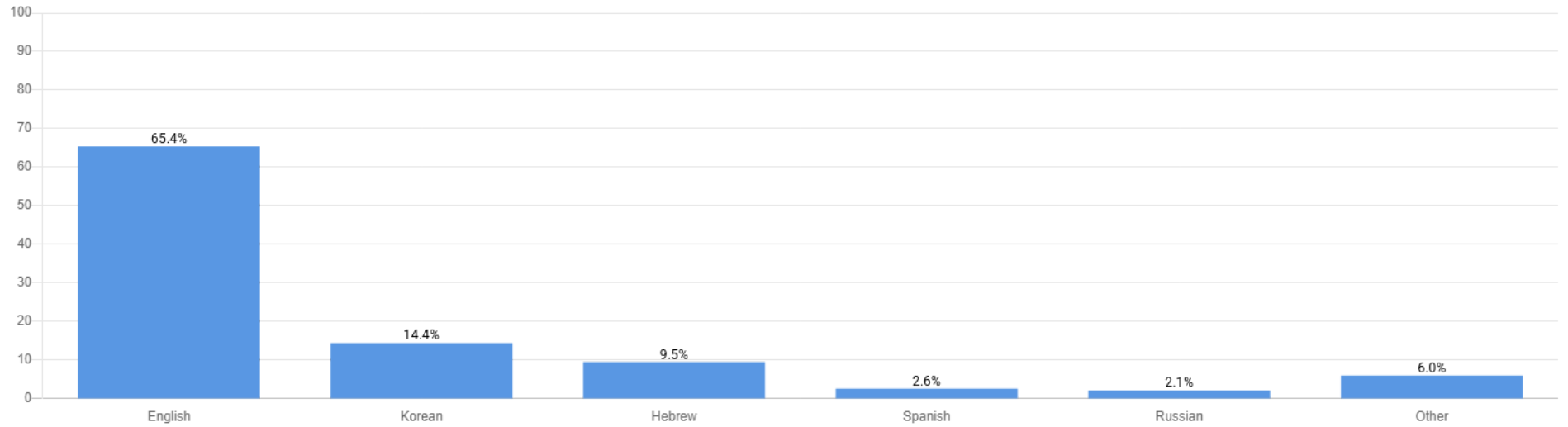

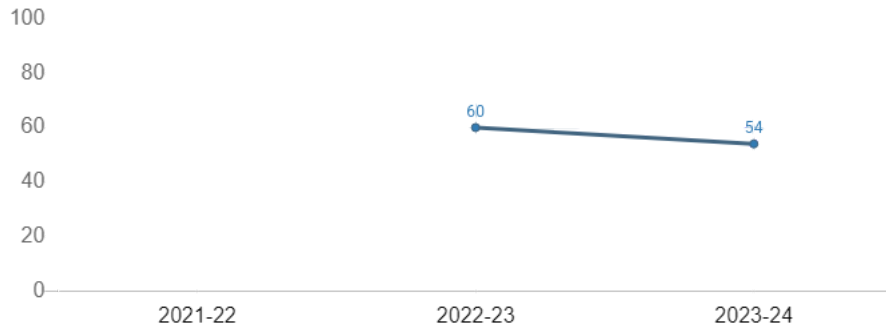

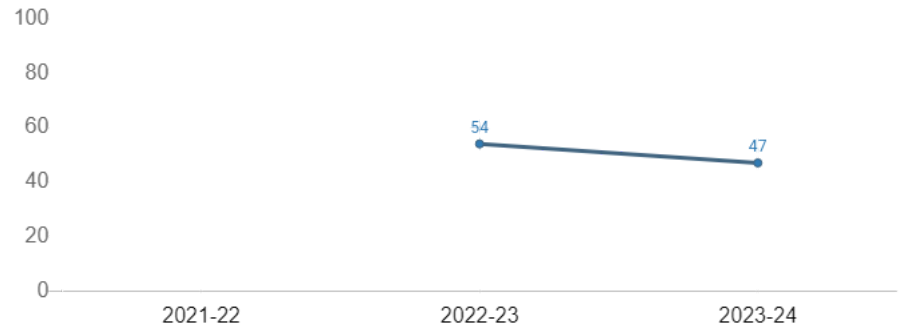

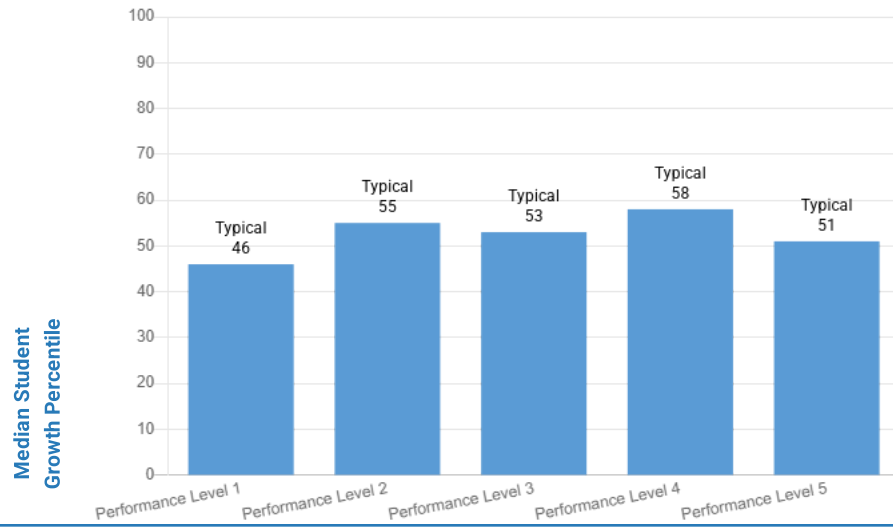

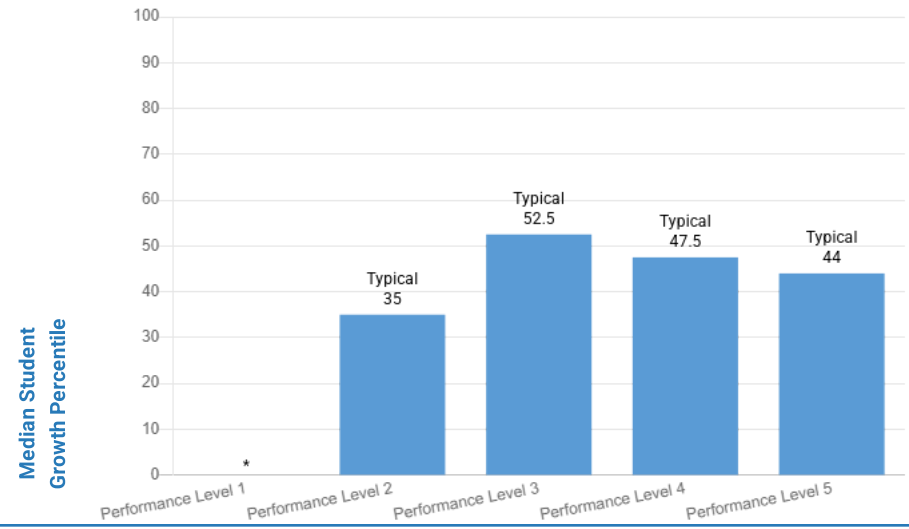

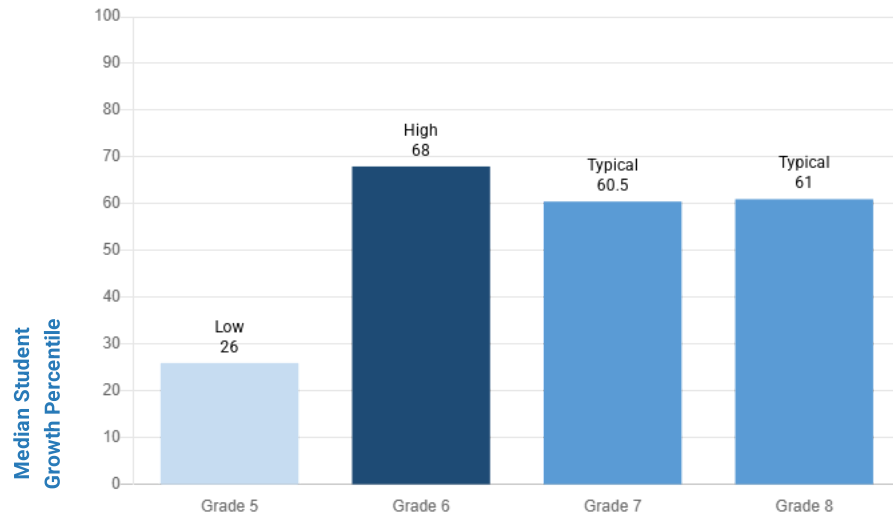

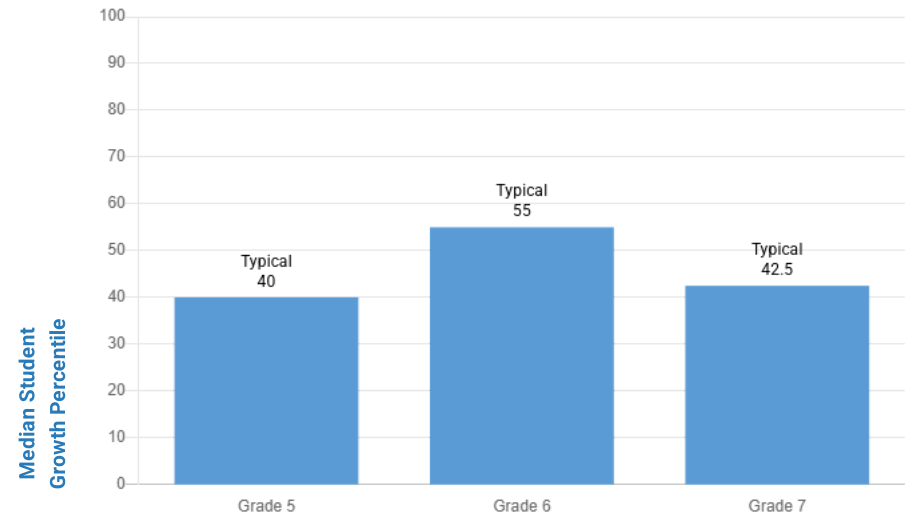

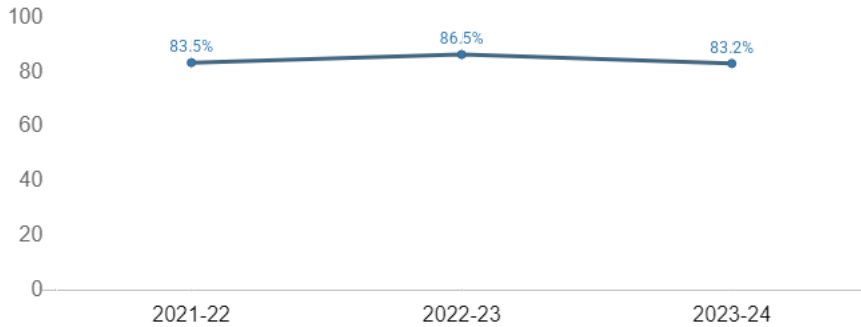

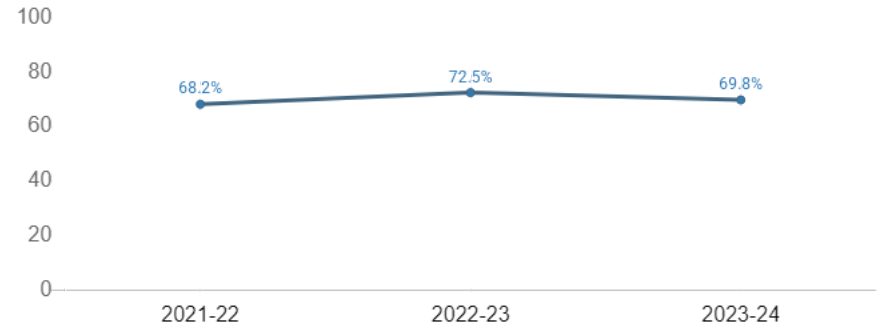
English Language Arts and Mathematics Performance Trends

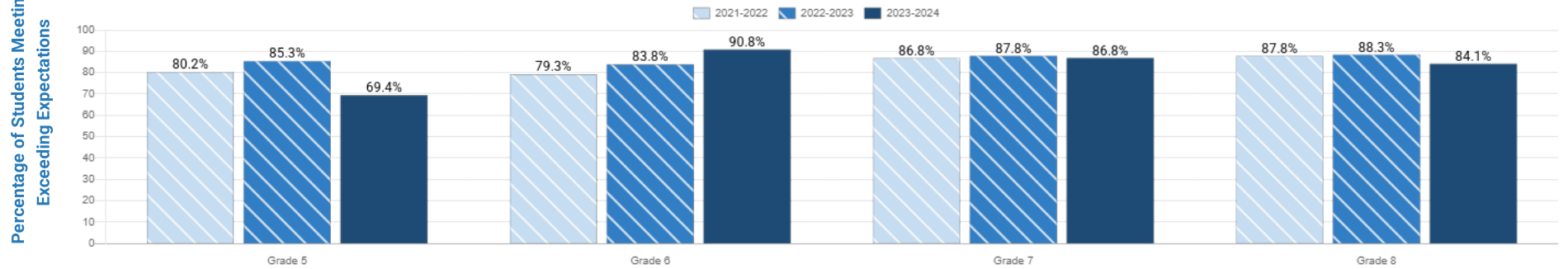

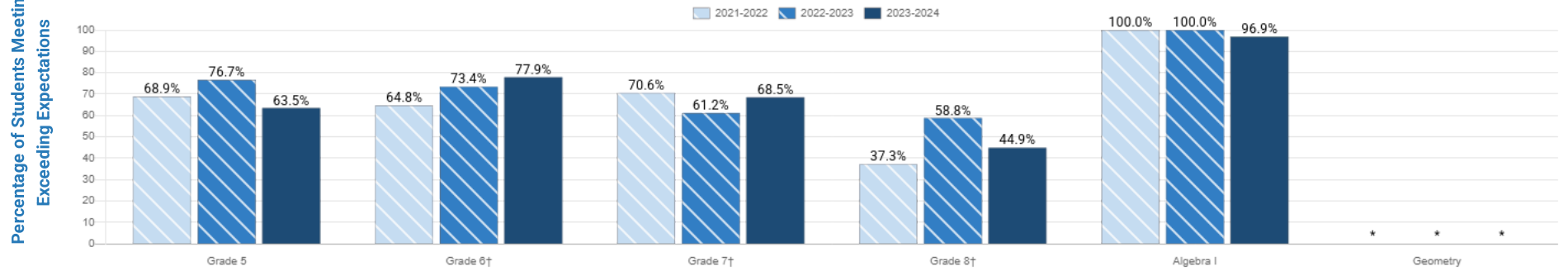

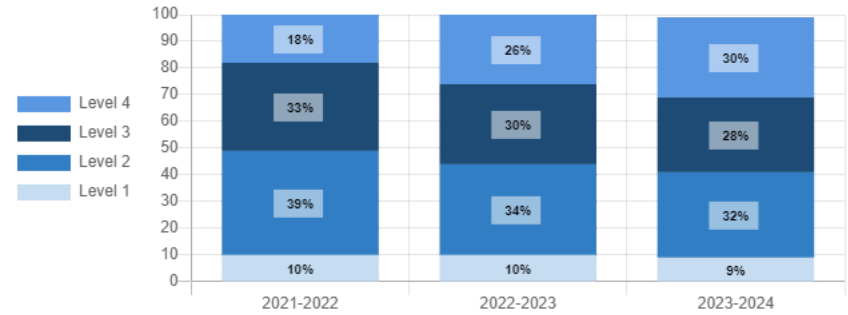

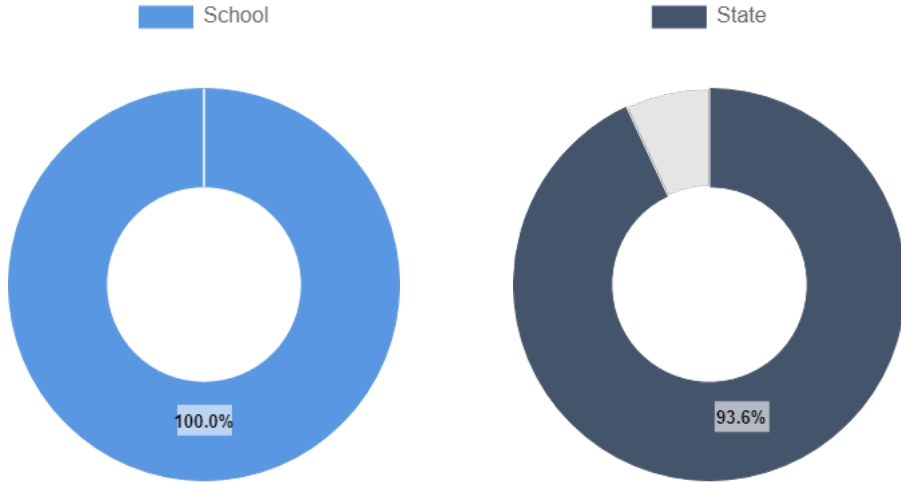

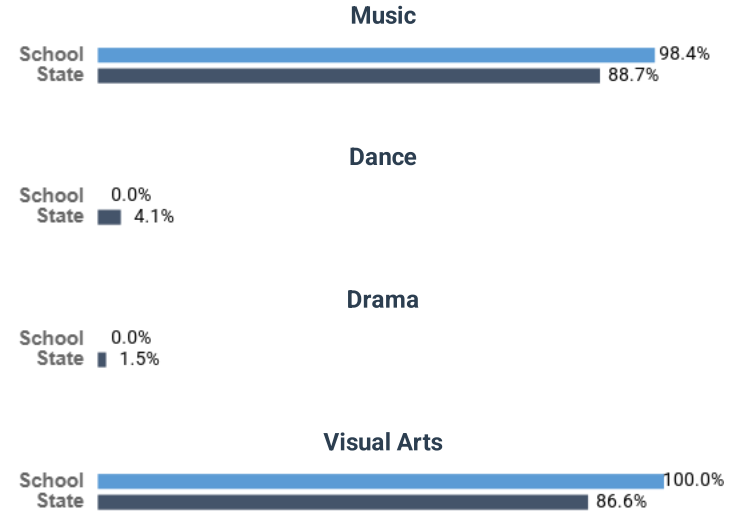

Students enrolled in one or more classes by discipline:



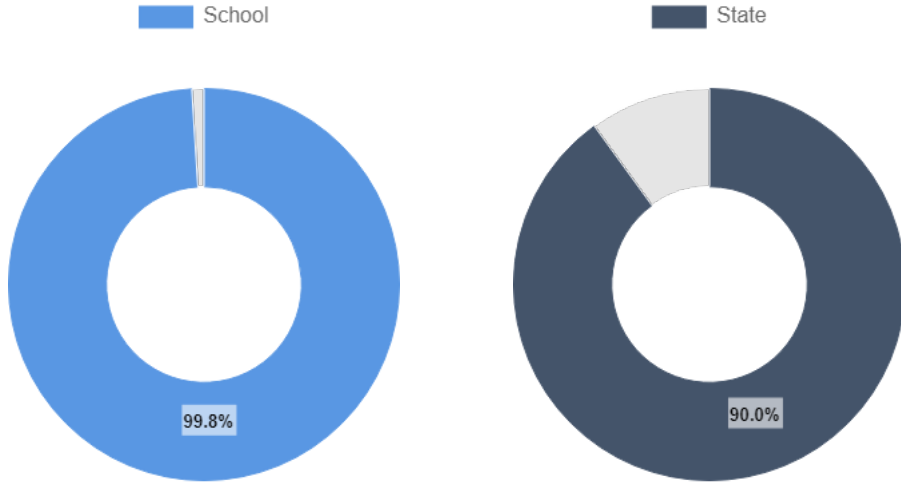

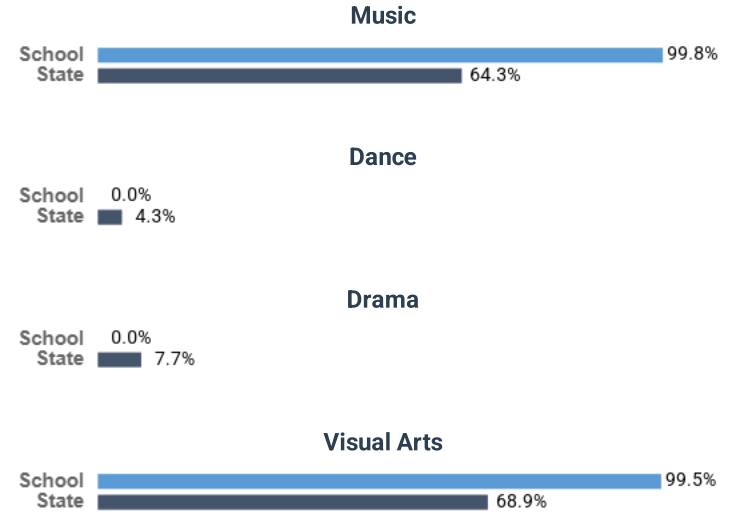

Students enrolled in one or more classes by discipline:



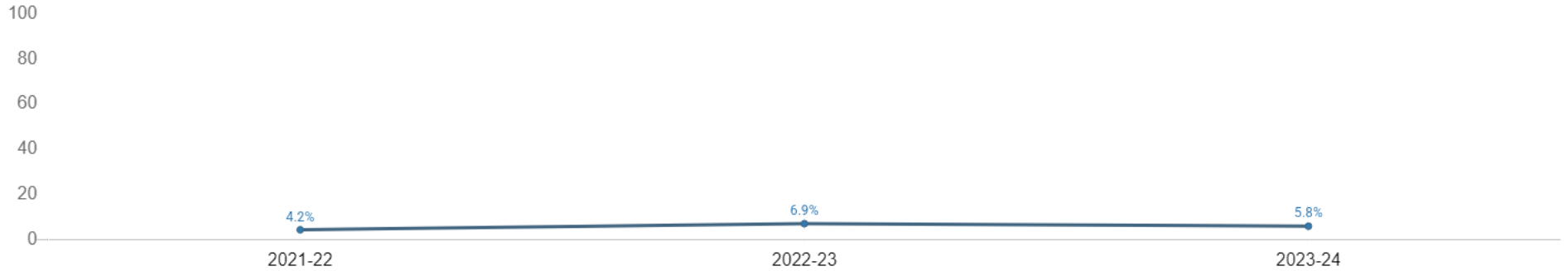

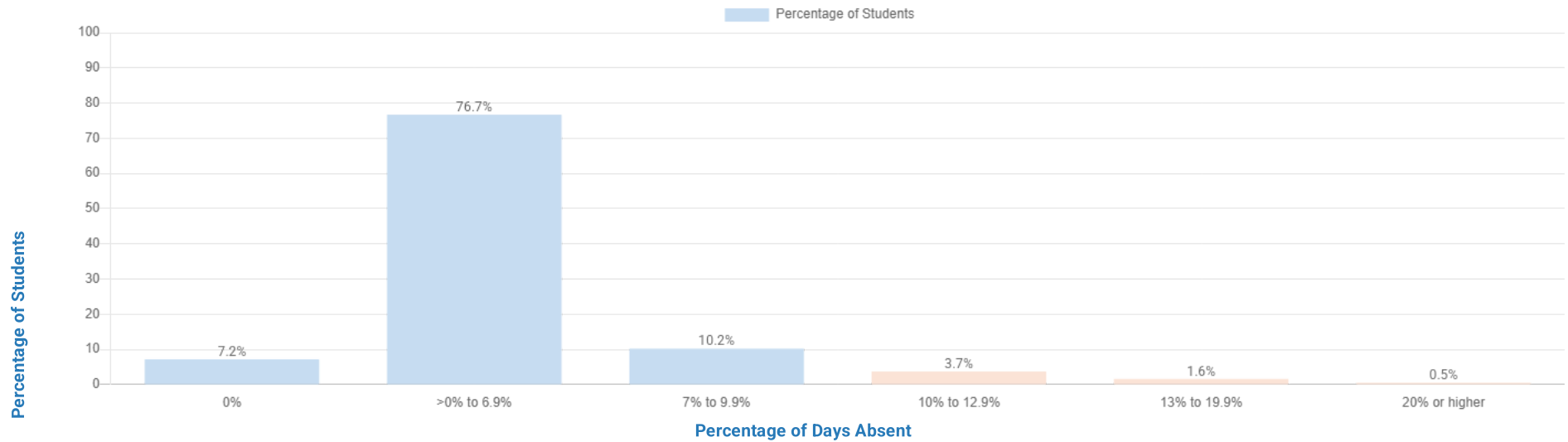

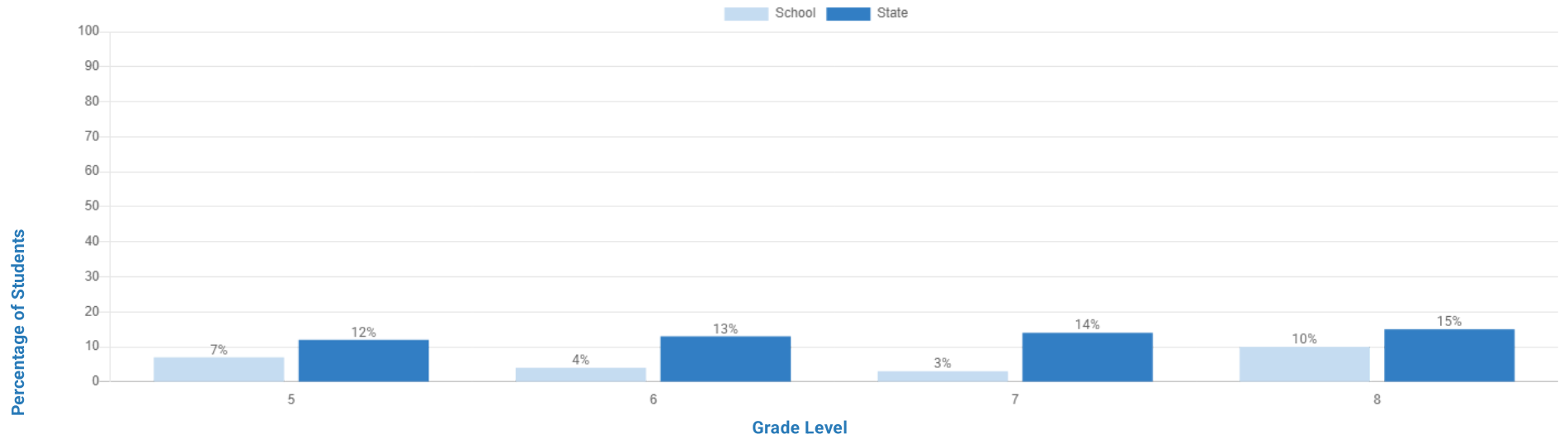

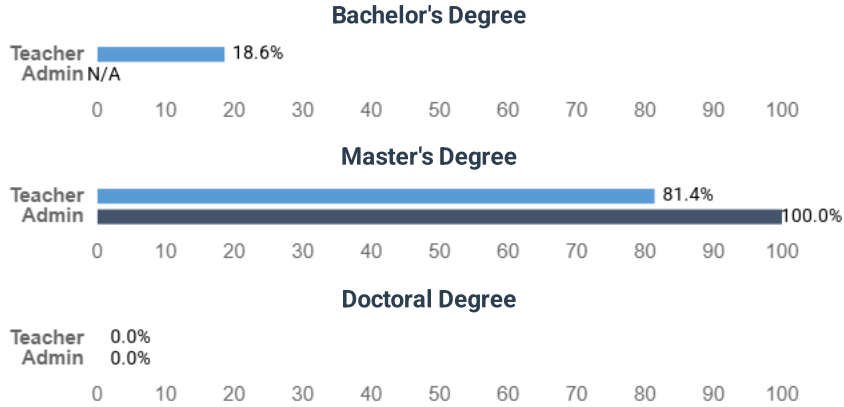

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses includes world language offerings in Spanish and Mandarin, a Gifted and Talented program, and accelerated math. Cycle classes of Executive Functioning, STEM, Ukulele, and Digital Media are implemented in all grades, and Financial literacy is taught in a sixth grade entrepreneurial course. Instruction includes integration of technology in all classes, including a schoolwide 1:1 program, and all instruction utilizes Schoology, our Learning Management System, along with Google Apps for Education.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cross Country (Coed), Soccer (Coed), Softball (Girls), Track and Field - Spring (Coed), Volleyball (Boys & Girls)
Students in sixth through eighth grade can participate in our middle school sports program, which includes volleyball, cross-country, soccer, basketball, track-and-field, baseball, and softball.



Clubs and Activities:

Clubs available to all students include dance, chemistry, kids tutoring, ambassadors club, service club, stage crew, newspaper, culture club, photography club, newspaper, Continental Math League, garden club, television broadcasting, and student council. Grade seven and eight clubs include debate and science olympiad. Eighth graders can participate in peer-to-peer and tutoring for community service.

The PTO sponsors various after school programs, including fitness, STEM, ping-pong, sewing, theatre, sculpturing, cartooning, and intramurals. Academic enrichment programs are offered after school. Grades 5, 7, 8 are offered math and Students in grades 6 are offered assistance in Language Arts, Math, Art, and ESL.



Staff and Professional Learning:

Teachers participate in various professional learning clubs of their own design, as well as grade level and subject department learning communities. Administration offers different professional development opportunities in the morning and faculty meetings in the afternoon. There are tailored to the needs of the staff. Additionally, teachers participate in two district professional development days each year, and two to three outside professional development offerings.



Student Supports and Services:

Students speaking English as a second language are enrolled in our ELL program. For students with disabilities, we offer in-class support, replacement classes, study skill classes, and LLD classes. Struggling students receive support from our BSI Plus program, multi-sensory reading program, and various teacher and student tutoring programs.

Additionally, Tenakill boasts the services of a full-time nurse and two school counselors, students also have access to outdoor recess equipment and playground resources.

Facilities:

Tenakill Middle School mixes both traditional 19th century architecture with more contemporary architecture. The original building was constructed over 100 years ago with additions being added in 1996. The building has an auditorium with a stage and balcony, a STEM lab and library, science labs, and a gymnasium and fitness room. The lobby has been designed as a student centered area for students to work, talk, or relax at various times during the day.



Technology and STEM:

Tenakill has STEM initiatives for the students to participate in during the day and after school. Hillside has several science labs and a STEM lab used as classrooms for students in grades 5-8. Instruction focuses on the Next Generation Science Standards (NGSS) curriculum. Coding is embedded in grades 5 and 6 as a part of the curriculum. After school activities and clubs infuse STEM after school such as Chemistry Club, CML, Computer Clud and Science Olympiad. The Closter Nature Center supports the curriculum for grade 5, investigating the local environment and animal habitats. Regarding technology, all teachers use Macbooks and Promethean Boards, while students utilize Chromebooks.

The school day consists of 6 hours and 10 minutes of daily instructional time over 8 periods on a five-day A-B rotating schedule. Students consist of mostly local residents with some tuition students. All students have access to technology throughout the school day and at home with district issued Chromebooks. The library contains books and audiobooks for students to check out, along with access to various research databases. Teachers maintain all class material in our learning management system (LMS). Online discussion boards, assignments, and assessments are completed and submitted within the LMS, allowing for parents and students to receive immediate feedback from teachers and other students. Parents are kept informed of class and school news through email, phone and LMS notifications.
