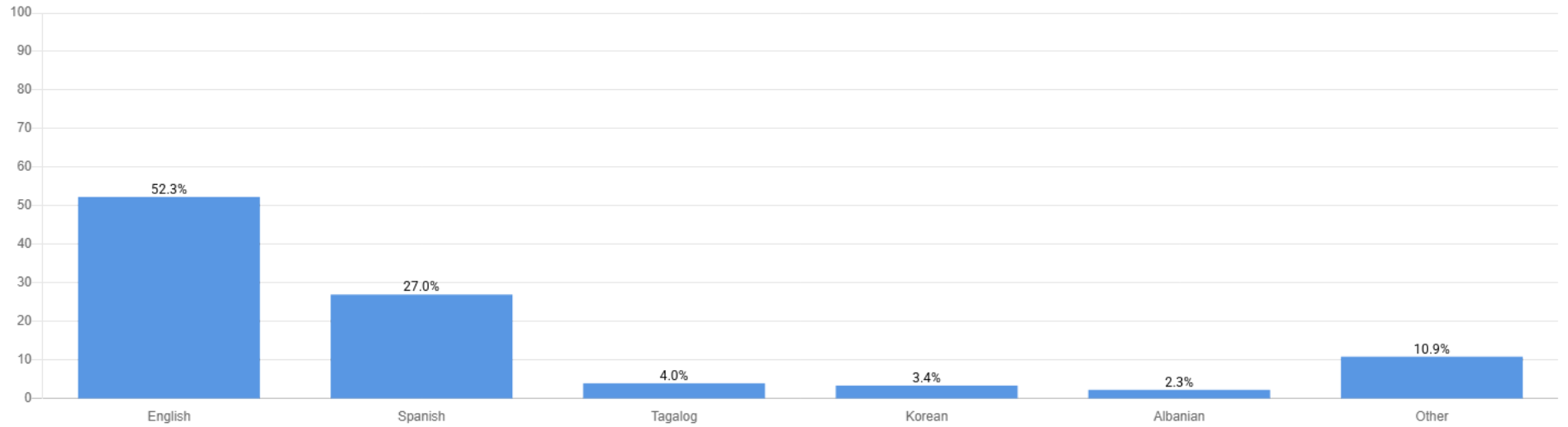

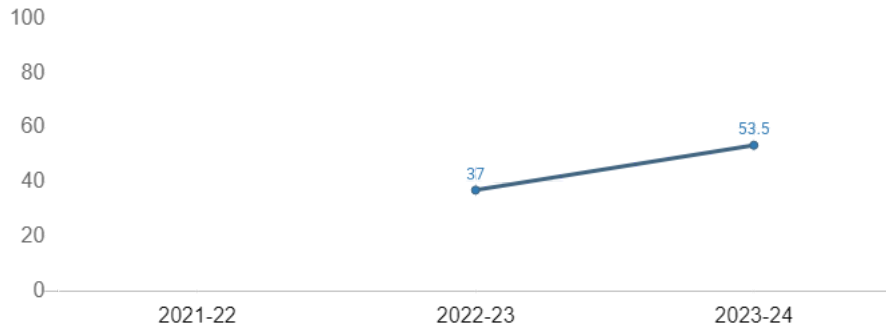

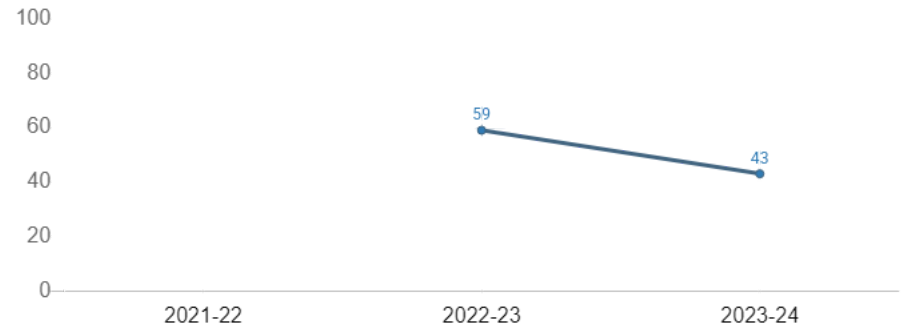

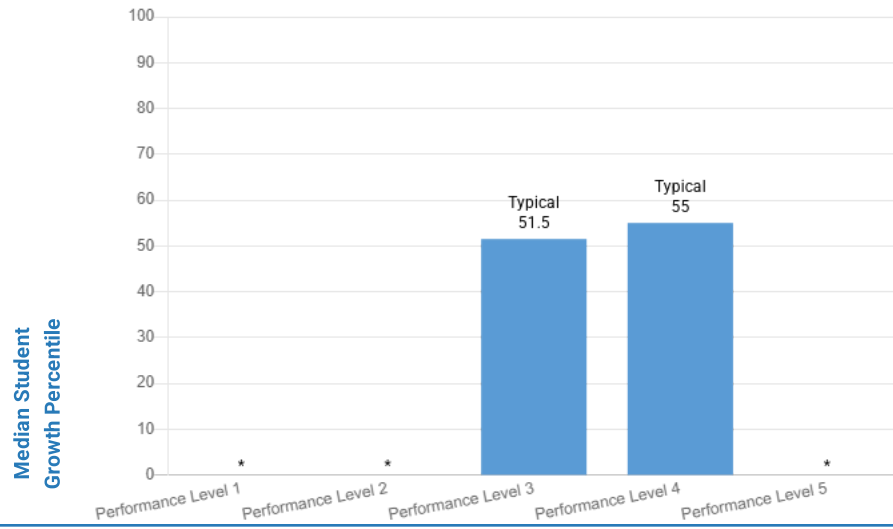

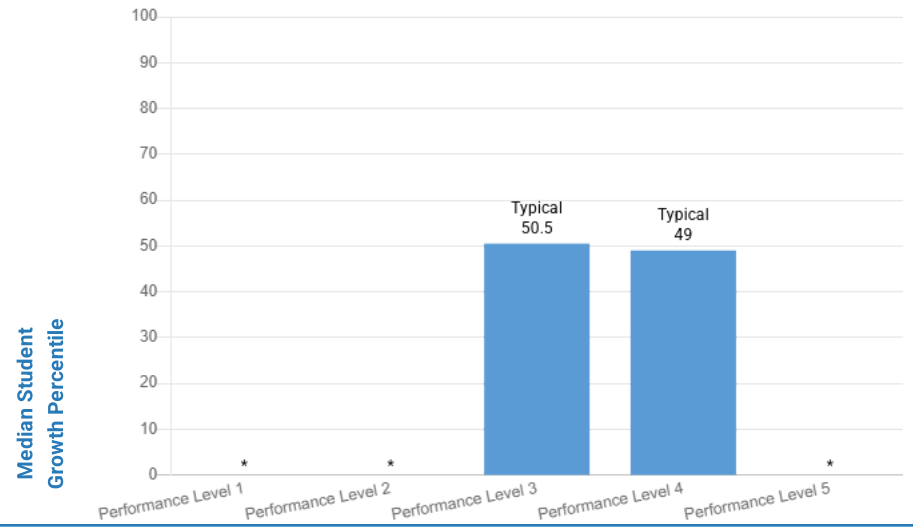

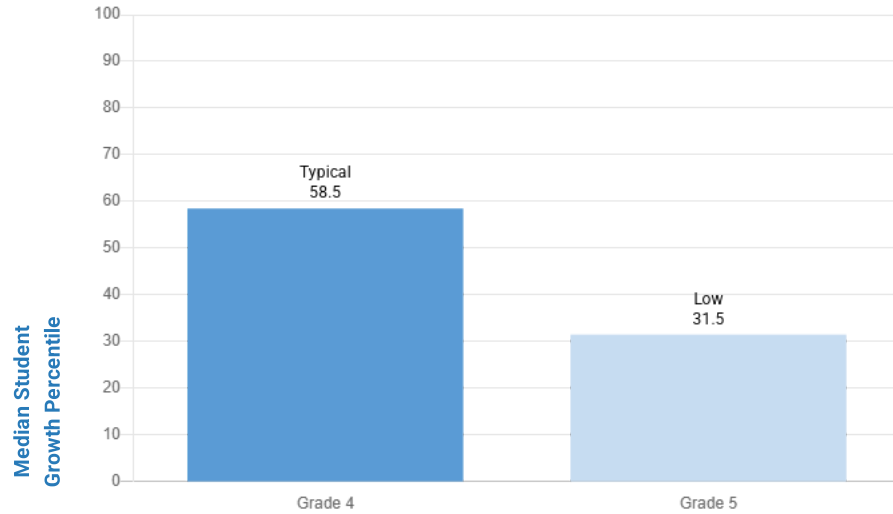

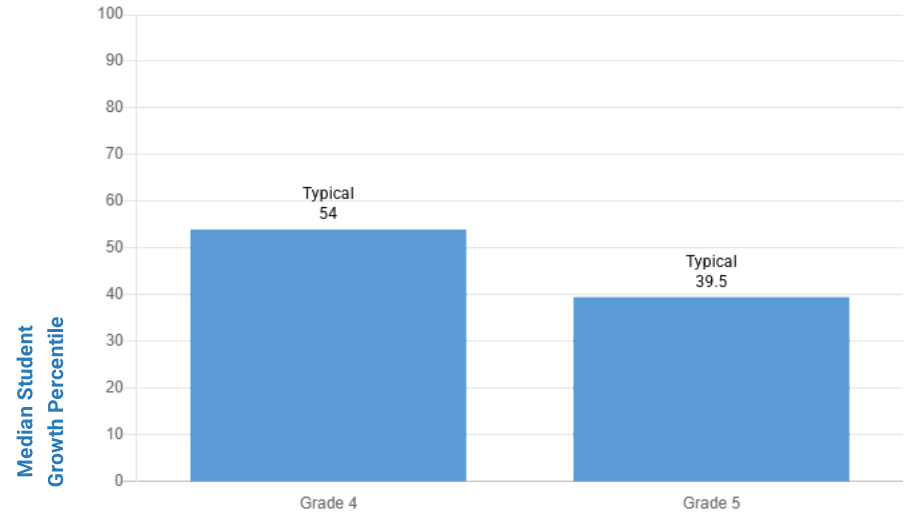

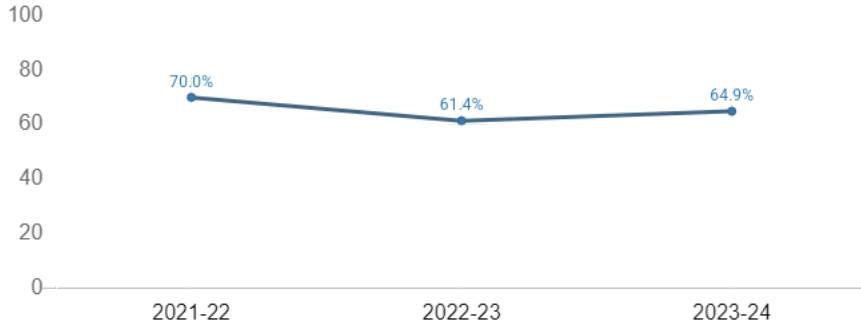

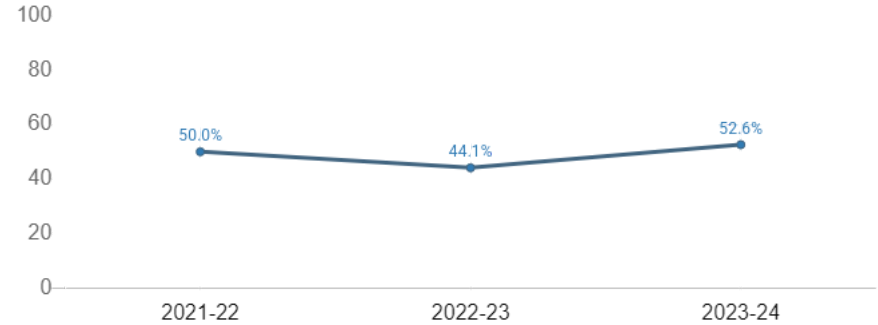
English Language Arts and Mathematics Performance Trends

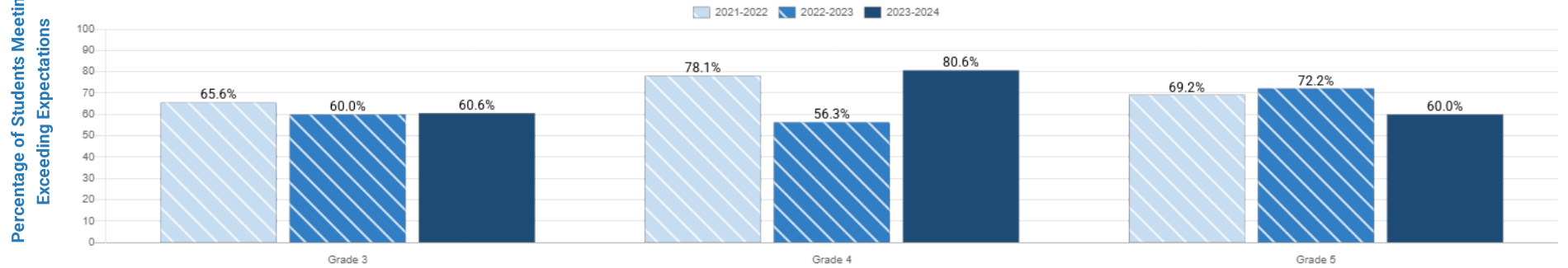

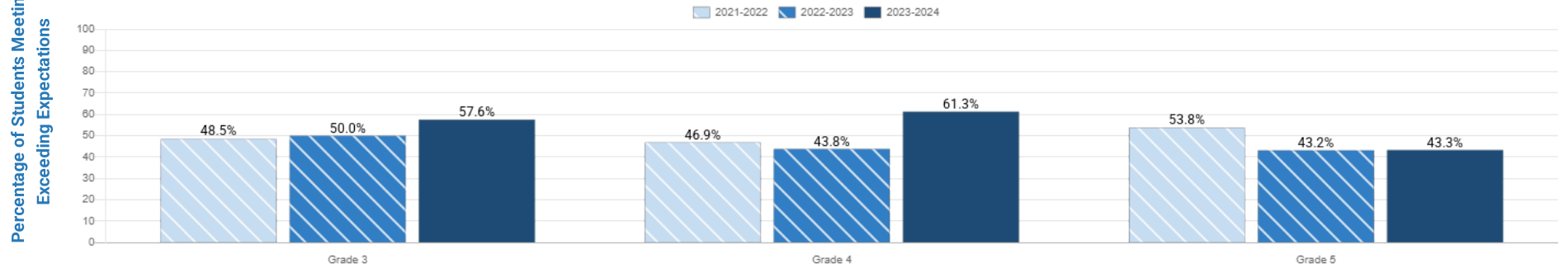

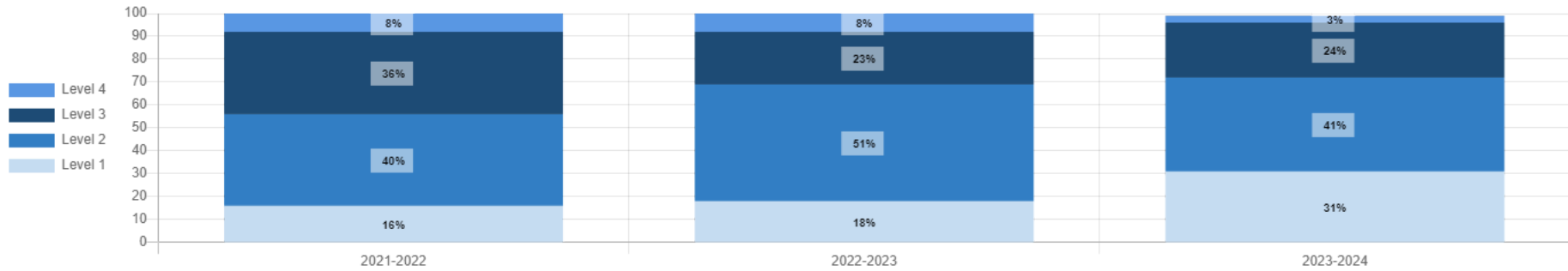

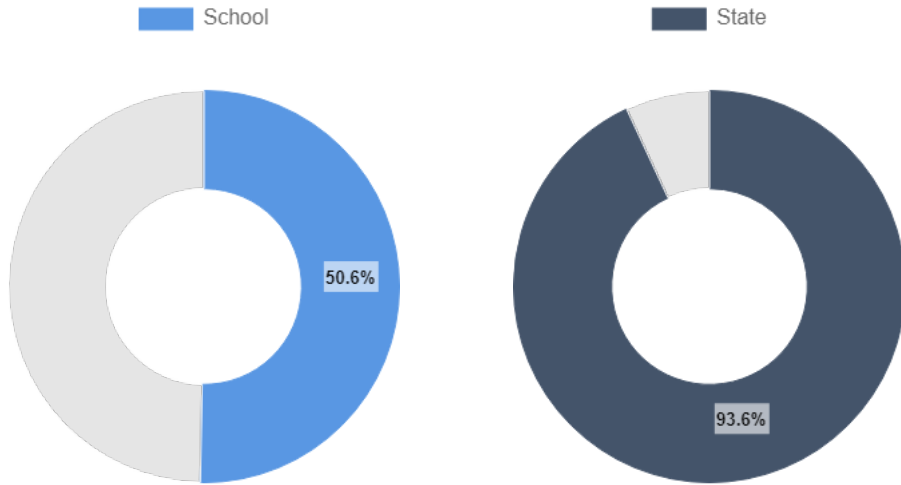

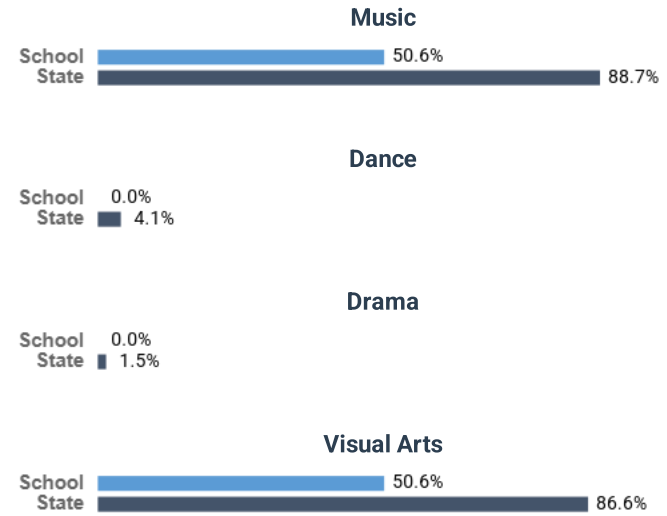

Students enrolled in one or more classes by discipline:



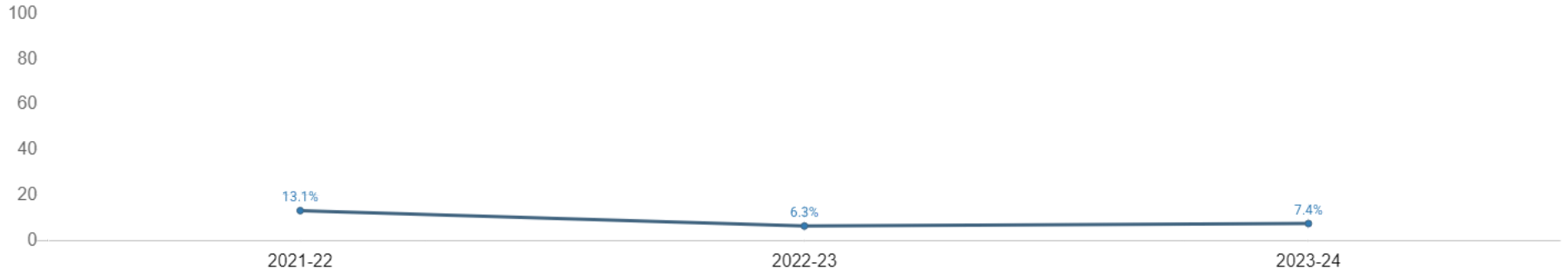

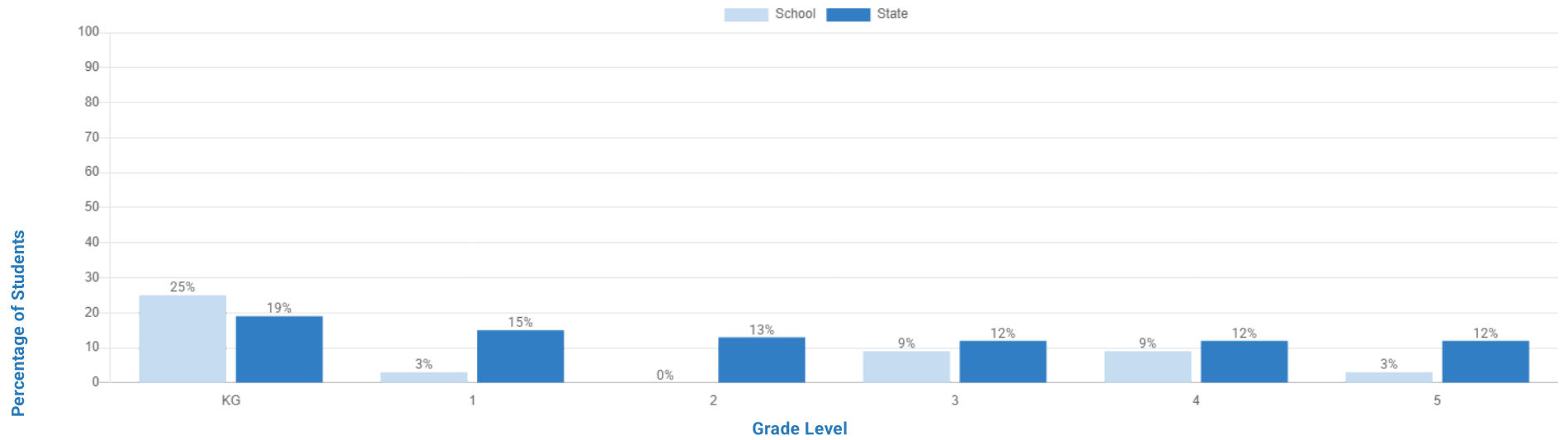

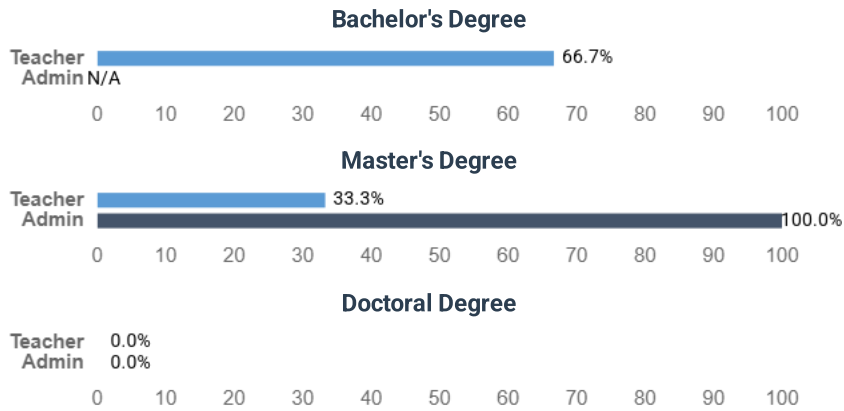

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Each year, teachers participate in a wide range of workshops and conferences including: differentiated instruction, remediation strategies for struggling readers, balanced literacy, SEL strategies, inclusion, team-teaching, co-teaching, guided reading, incorporating the new Sunday essentials phonics program, curriculum standards, and strategies for working with ELL students.



Student Supports and Services:

Lincoln School provides Supports and Services for English Language Learners and Students with Disabilities. We provide intervention services through a Basic Skills program, and use the Intervention and Referral Services to take advantage of the available supports (OT/PT consultations, Speech, School Psychologist, Behaviorist consultations, Basic Skills progress monitoring through DIBELS/DRA assessments, etc.) to assist students who are struggling in school. Our teachers also differentiate instruction and provide extra help to remediate and enrich instruction on an individual basis.



Student Health and Wellness:

Lincoln School employs a full time registered nurse who schedules important safety programs regarding topics like fire prevention, healthy diets, home emergencies, dental care, and bicycle safety. The students and families have access to a school counselor for social and emotional supports as they pertain to the school environment. The students receive The Great Body Shop lessons each month. The students participate in 150 minutes of PE/health per week.

In cooperation with a hard-working PTO, we plan programs for parents and students throughout the year, which include: High Touch, High Tech (a hands on Science program for the entire student body); Cultural Awareness Day; Read-a-Thon; Book Fairs; Breakfast with Santa; Senior Citizens Day; Pre-School Story Hour; a Family Picnic; Healthy Heart Day; and our Lincoln Day Breakfast.



Facilities:

Our beautiful main building is now 111 years young, and it is kept in tip-top shape by a team of dedicated custodians and maintenance staff. The latest major addition to Lincoln School was completed in 2007, and it added new Art and Music Rooms, a state-of-the-art Media Center, and a large gymnasium. We also have a newer playground (purchased by our PTO), resurfaced blacktop and sidewalks, newer windows and doors, new HVAC units, and security cameras throughout the entire school.



School Safety:

Lincoln School has numerous security cameras both inside and outside of the building which offer a wide view of the hallways and exterior grounds. All exterior doors are locked at all times, and visitors must ring a bell and state their name and reason for requesting access before they are let into the building. There is also an exterior drop box for parents and/or visitors to drop off items for students during the school day, further limiting access to the school. And finally, the school is equipped with the LENS emergency notification system where a complete lockdown can be initiated in seconds from anywhere in the building via an emergency button or school phones in each room.

Technology and STEM:

Grades K through 5 have Technology classes once a week. Students participate in a Stem Program known as Maker's Space during Media.



Attendance:

Lincoln School used a variety of evidence-based interventions to address learning loss during the fractured schedules due to the pandemic. We identified our most at-risk students and held a combination after-school homework / remediation work program for students in Grades 1 & 2, held twice a week for 6 months of the school year. We also held a similar program just for ELL learners in Grades 1-3. Throughout the school day, students are exposed to the Soliday Program, which is a multi-sensory research based Orton Gillingham product. The children receive direct instruction on phonemic awareness and sound segmentation. We also tailored school counseling lessons to meet students' mental health needs. Besides special groups dependent on grade levels and specific needs, our school counselor developed her lessons to focus on maintaining and growing students' social emotional health and how to ask for help when necessary.
