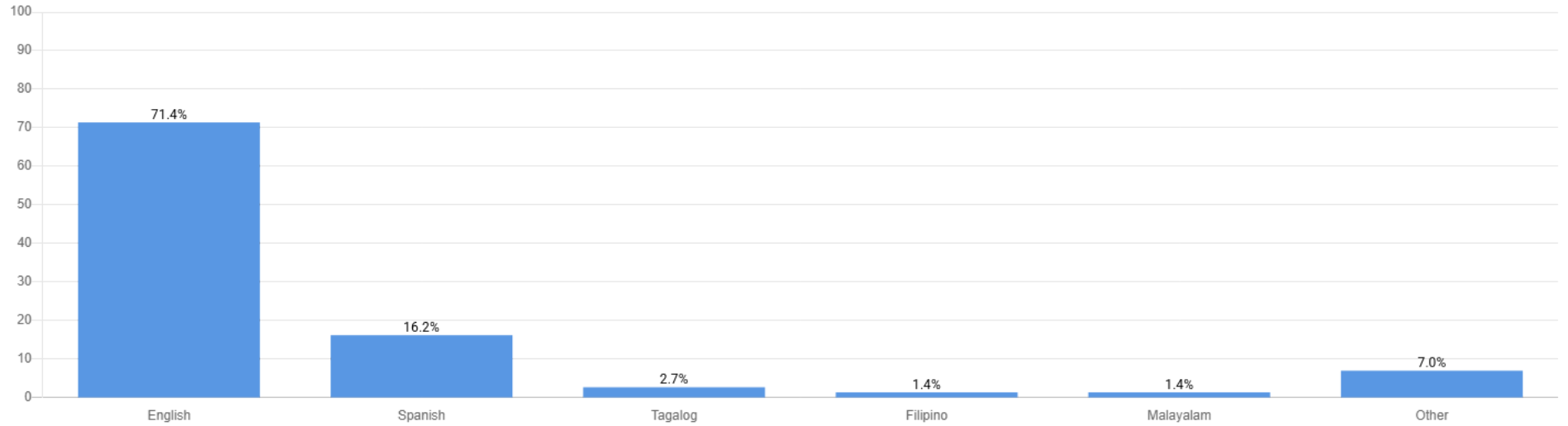

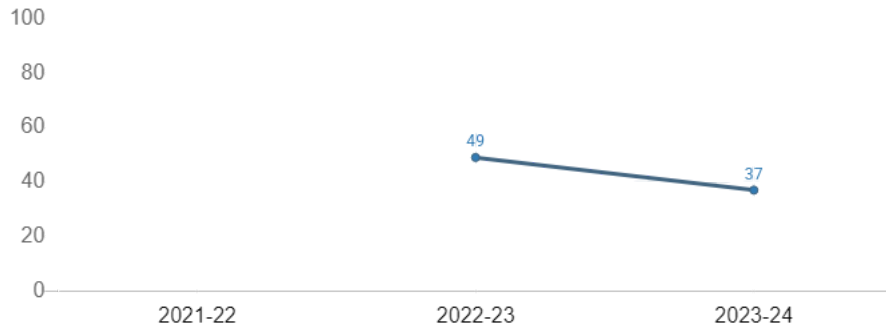

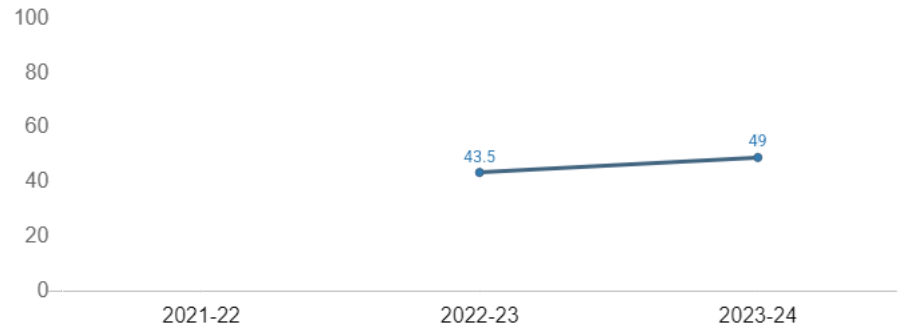

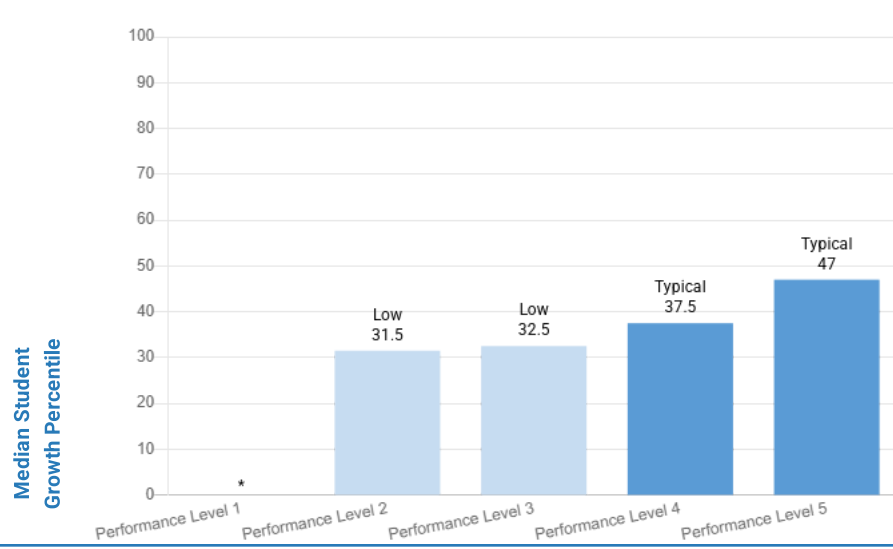

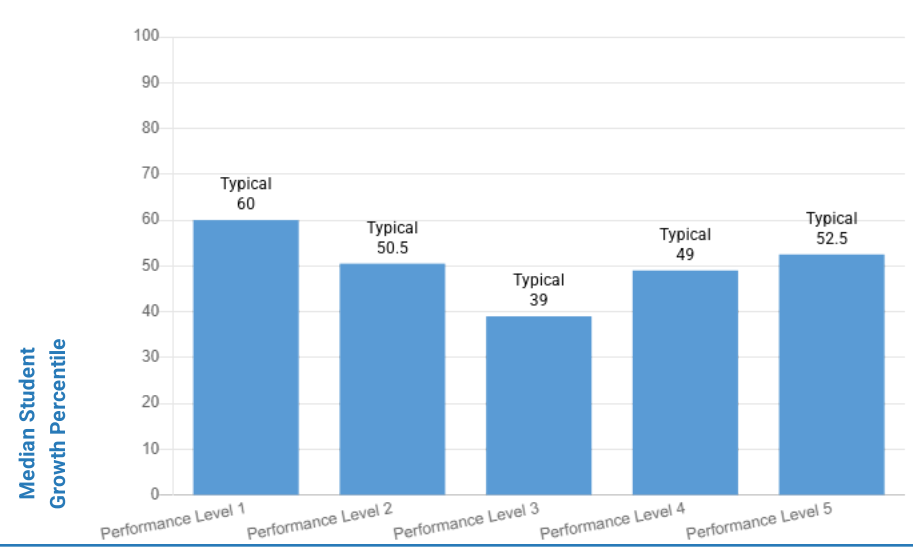

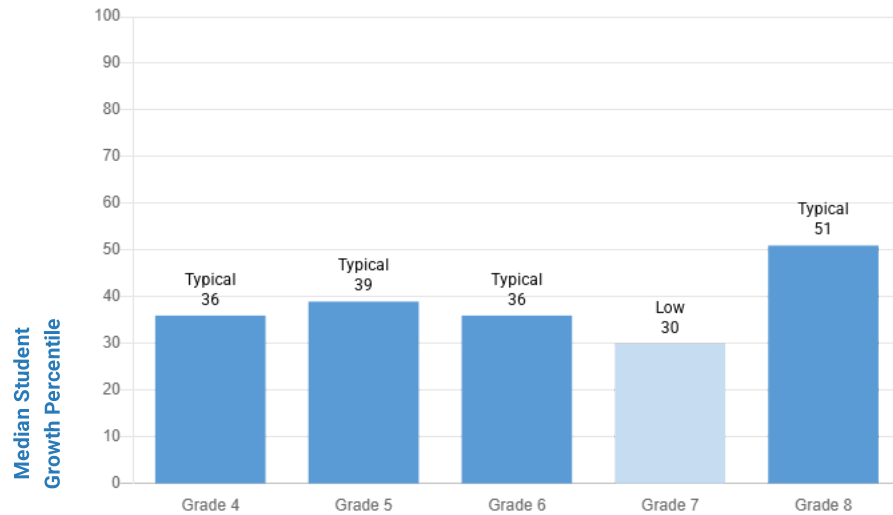

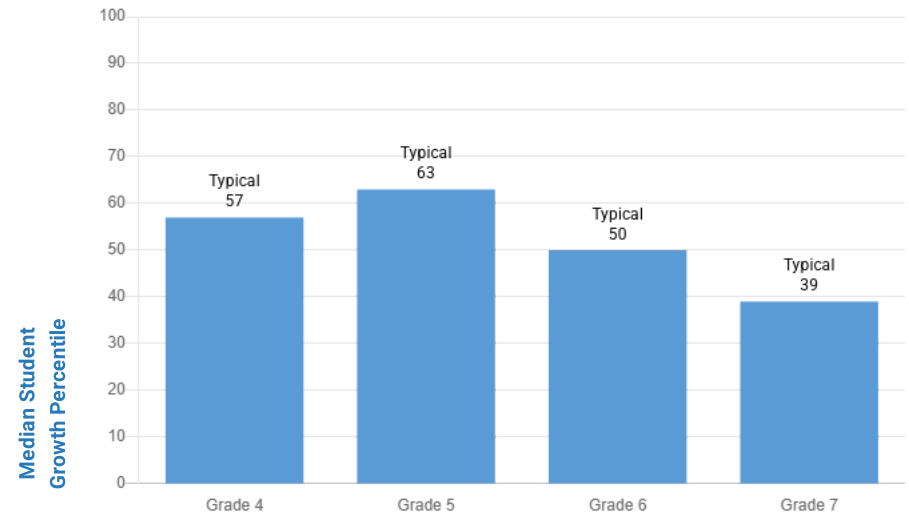

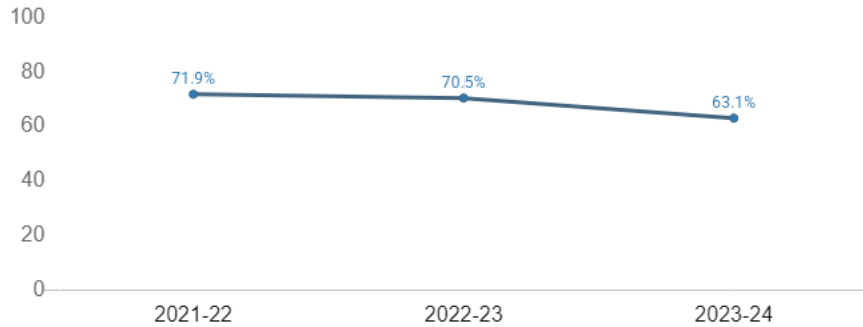

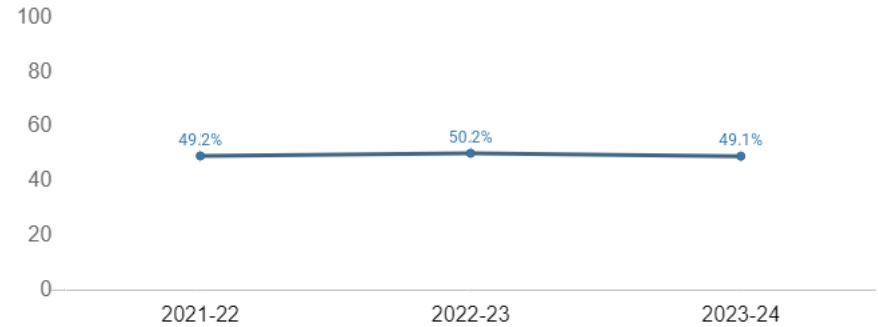
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 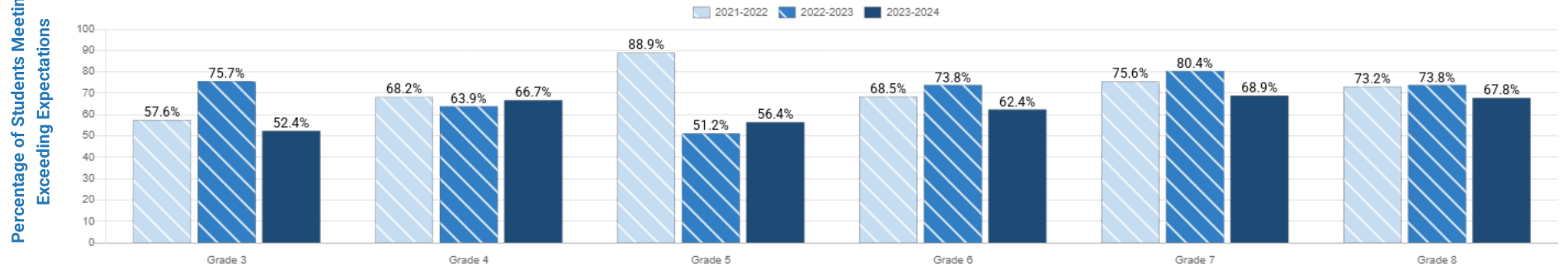

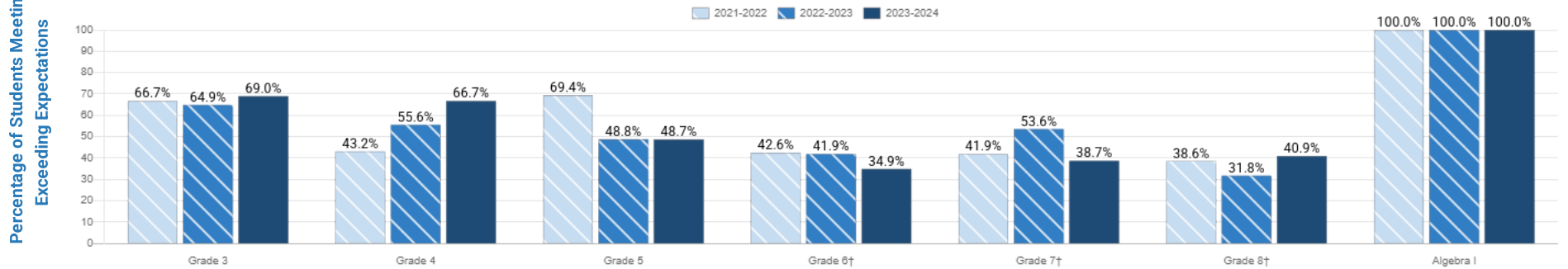

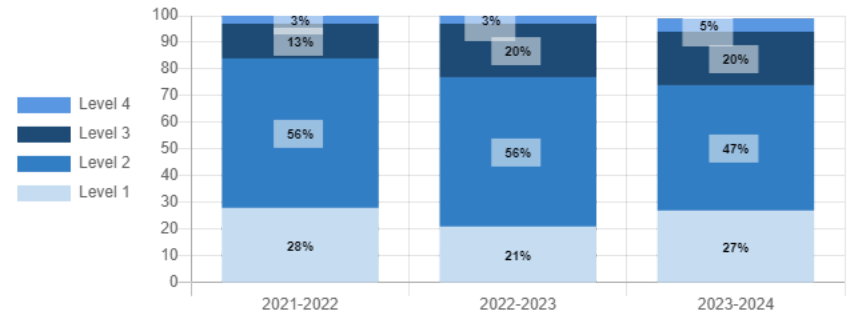

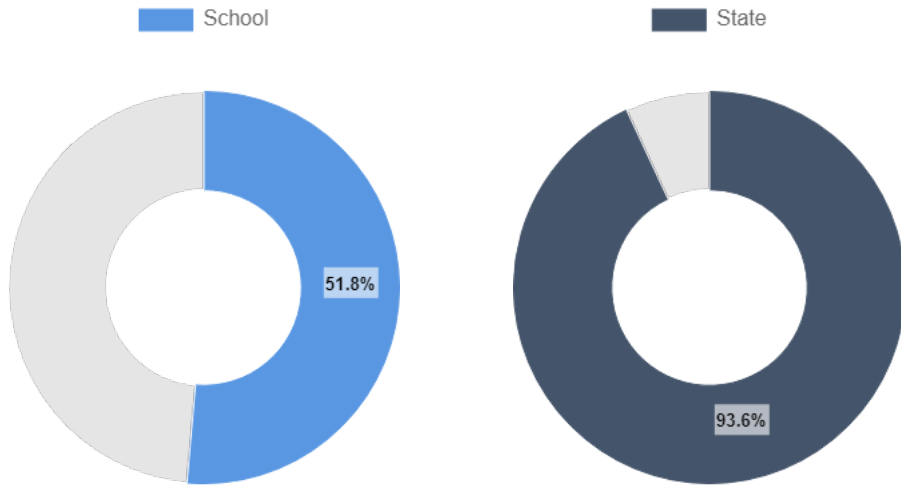

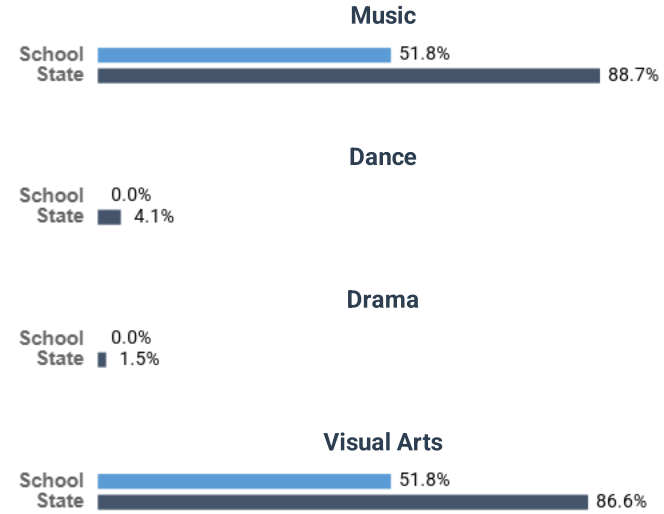

Students enrolled in one or more classes by discipline:



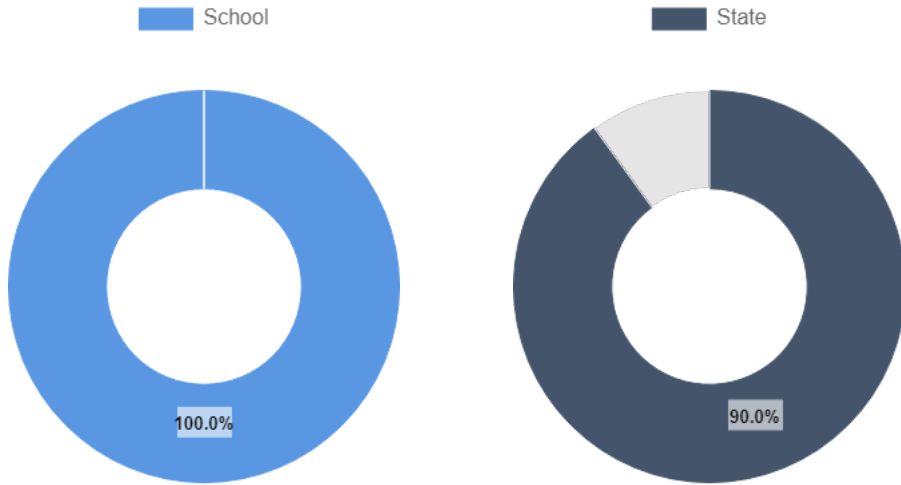

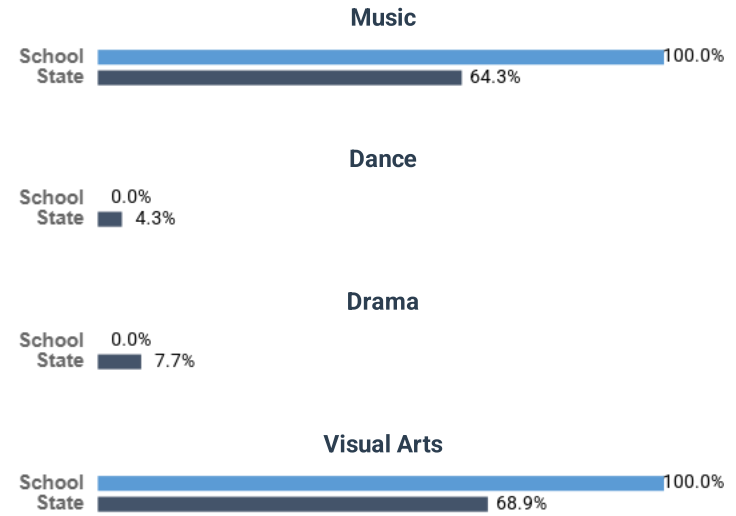

Students enrolled in one or more classes by discipline:



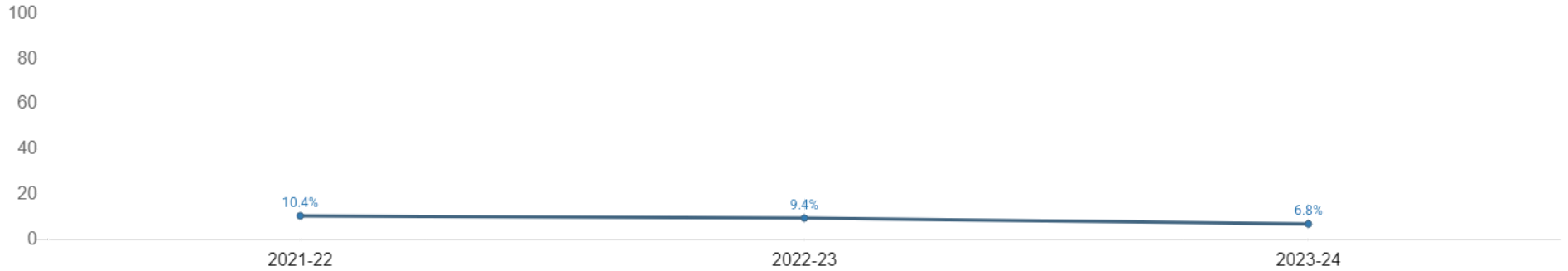

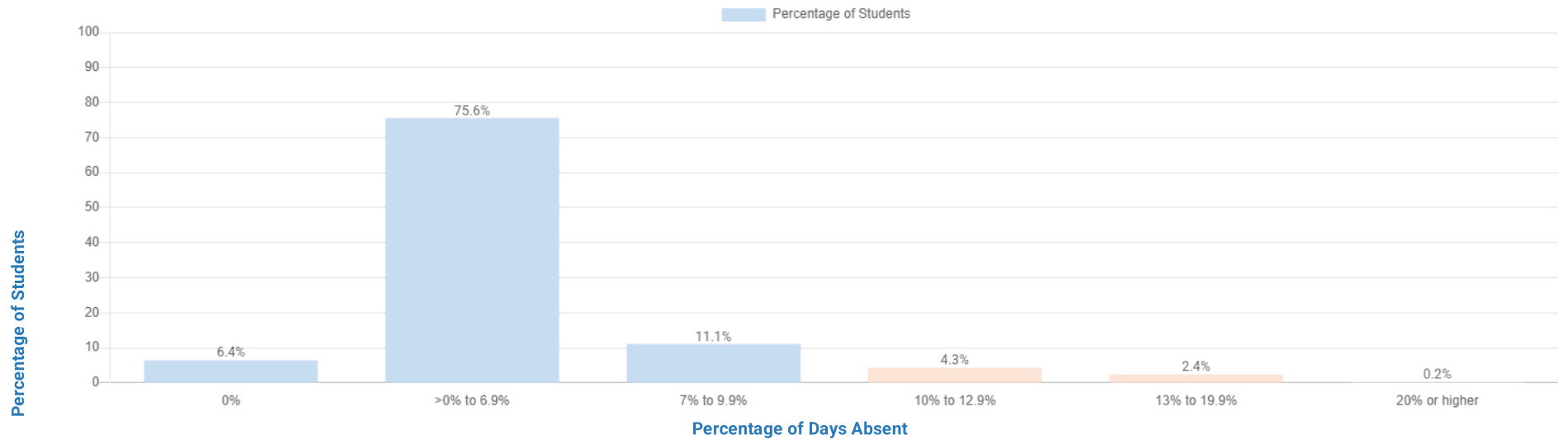

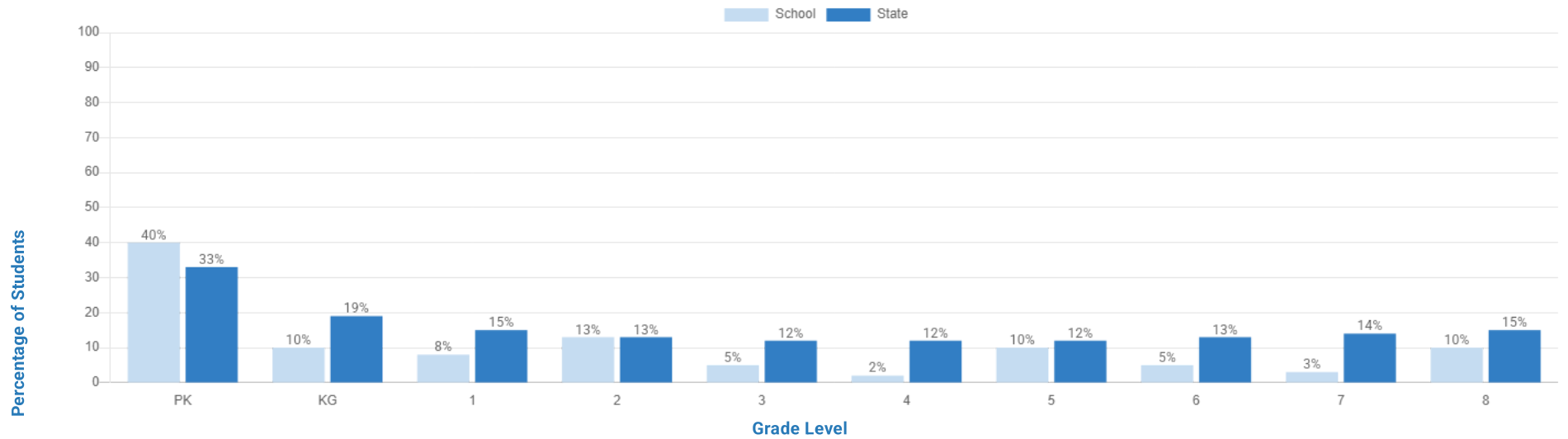

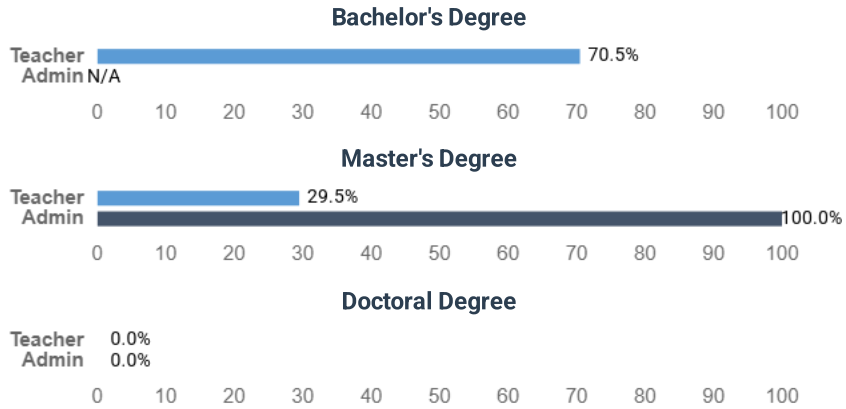

The program emphasizes academics. Our curriculum is reviewed and revised regularly, and it is articulated from grade to grade. Grades pre-kindergarten through five are self-contained programs. At grades six through eight, the program is designed as a middle school. Students receive a fully departmentalized program. The middle grades are organized into teams and the teachers meet several periods per week to plan together.
