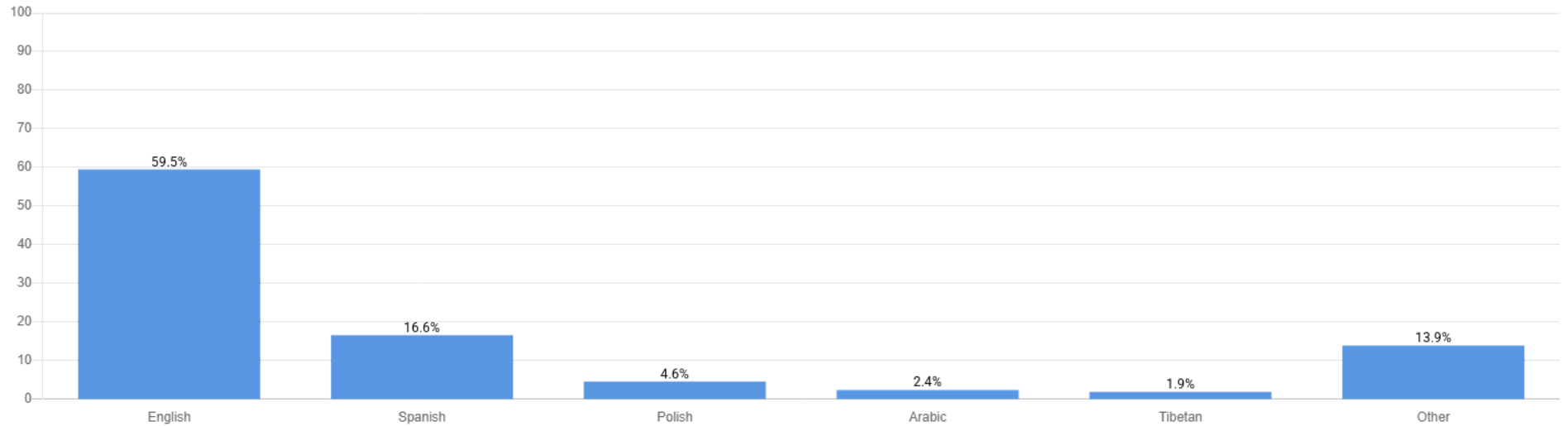

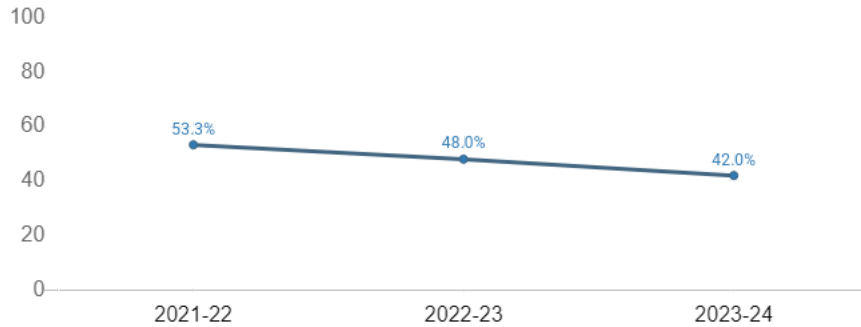

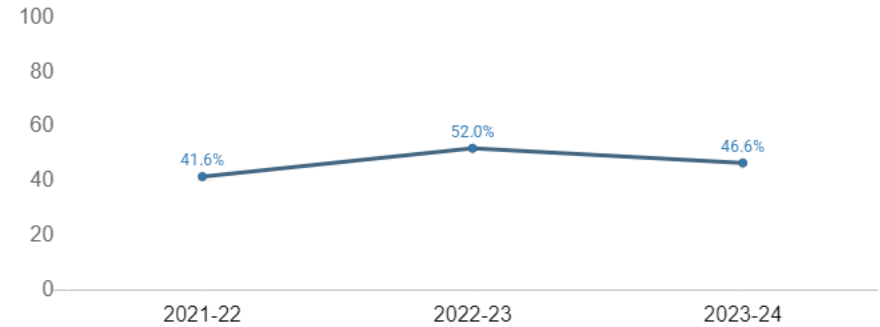
English Language Arts and Mathematics Performance Trends

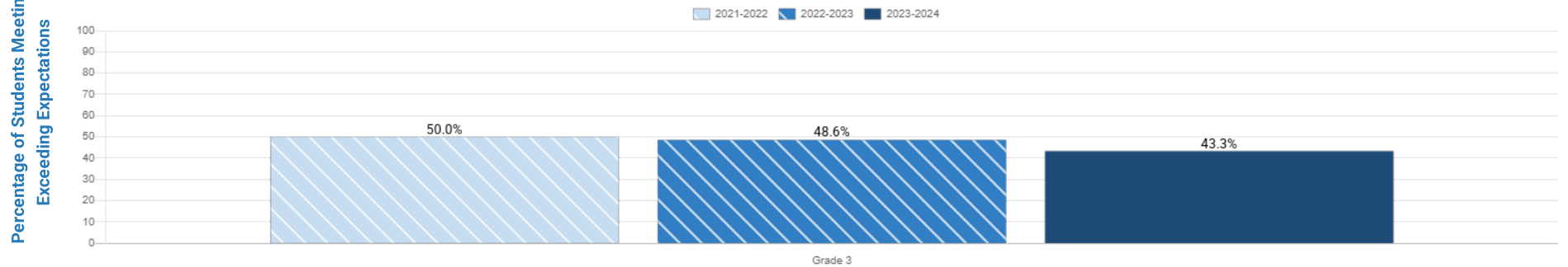

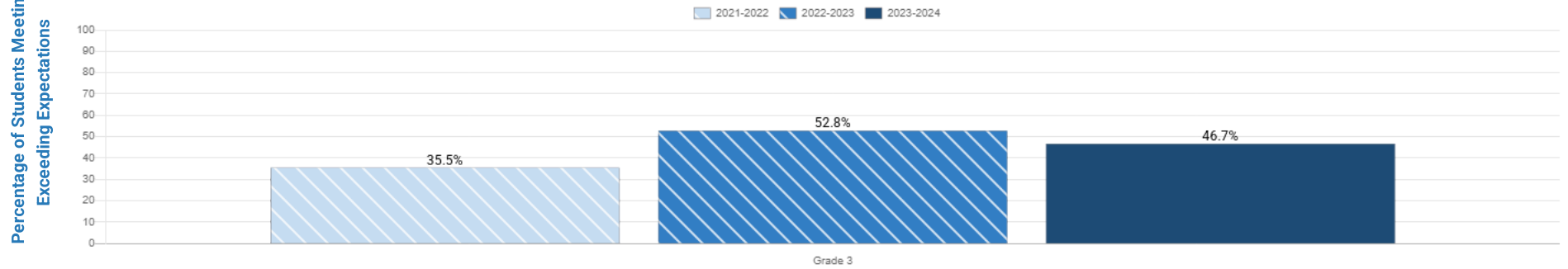

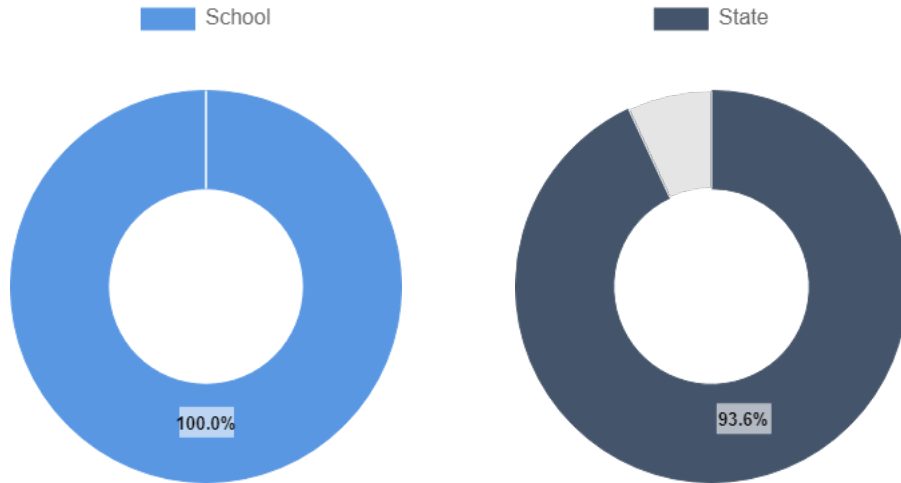

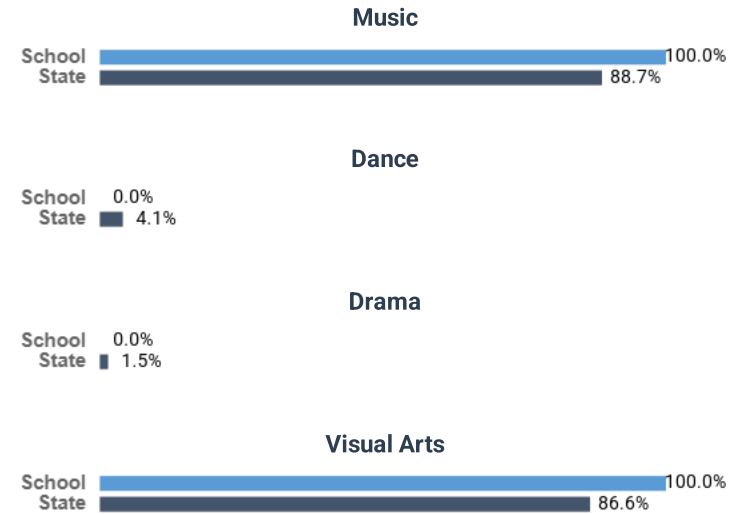

Students enrolled in one or more classes by discipline:



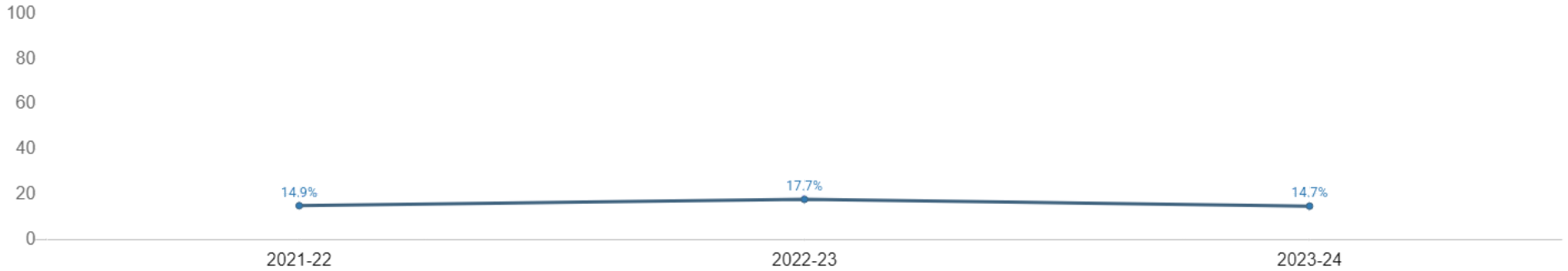

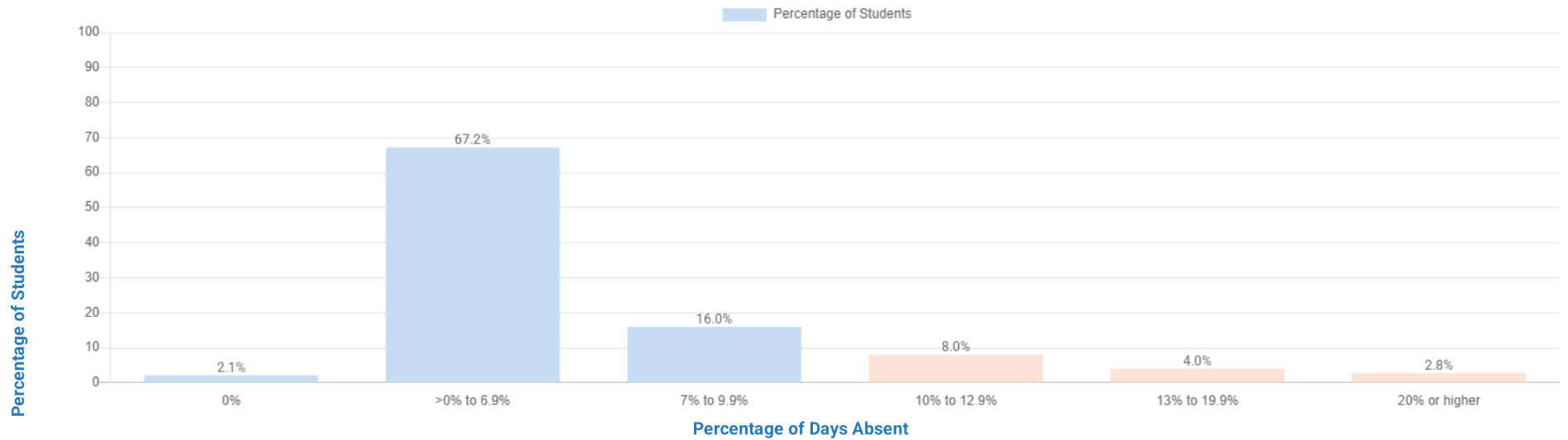

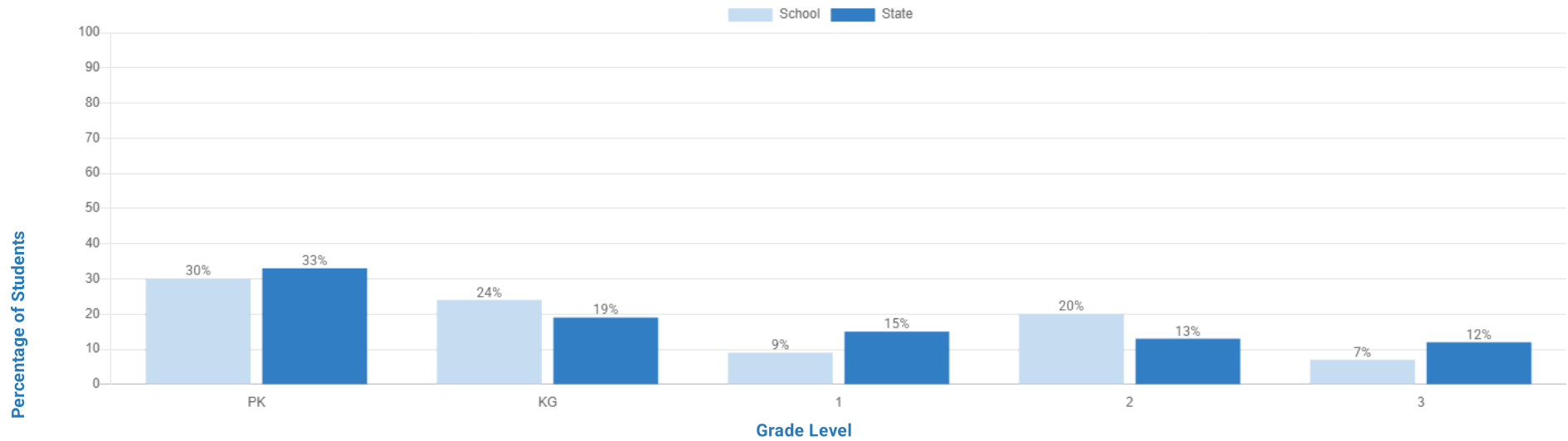

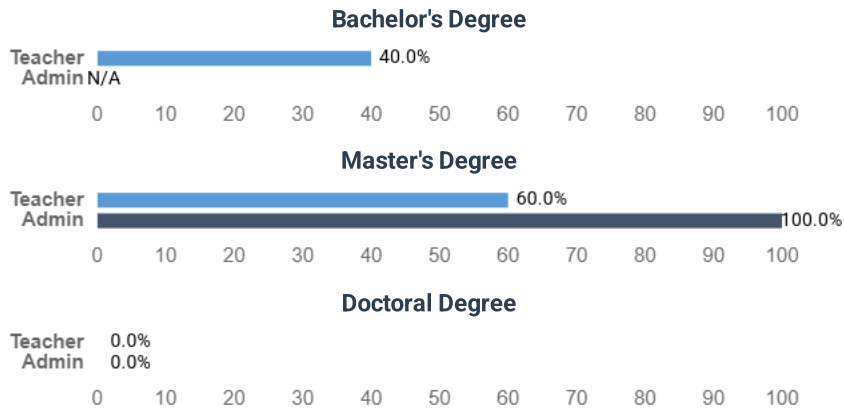

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Recognizing the importance of developing responsible citizenry within our democratic society, we teach our students to be respectful and accepting of our diverse ethnic and cultural backgrounds and perspectives within East Rutherford Public Schools and the broader community.



Courses, Curriculum, Instruction:

At McKenzie School, Mathematics skills and student literacy is a main focus at all grade levels. Writing across the curriculum is a priority and is in effect school-wide. McKenzie School is continually updating our comprehensive curriculum that is integrated and aligned with the New Jersey Student Learning Standards and allows for all levels of ability while encouraging students to work collaboratively and be problem-solvers. Students are presented with a program of study that includes instruction in reading/language arts, mathematics, science, health and physical education, social studies, art, music, and technology skills. The Gifted & Talented Program at the elementary level was revised and expanded to provide in-class support services Kindergarten through 2nd Grade and pull-out services at the 3rd Grade level.

Student Supports and Services:

The I & RS committee reviews requests from teachers or parents for assistance with students who are experiencing difficulty in the classroom. Individualized action plans are developed for students and data is tracked over a period time to determine growth and progress. Students who display limited progress are then referred to the CST for further testing and evaluation. The District utilizes a multi-tiered approach with emphasis placed on academic performance, chronic absenteeism, social emotional and behavioral challenges.
