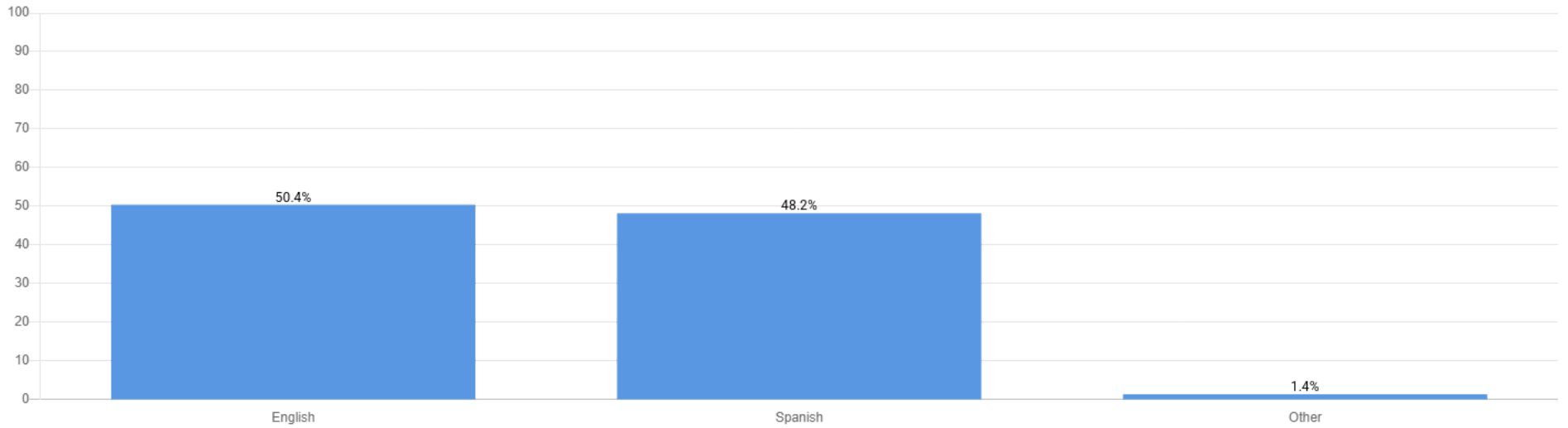

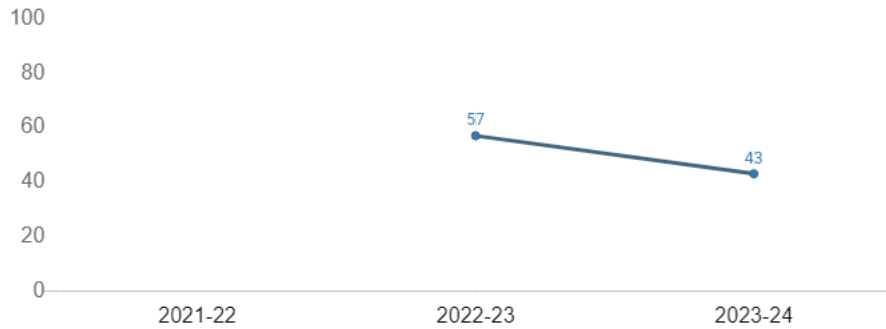

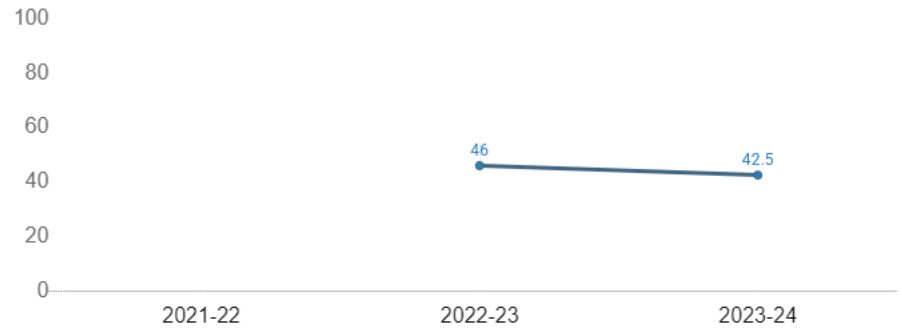

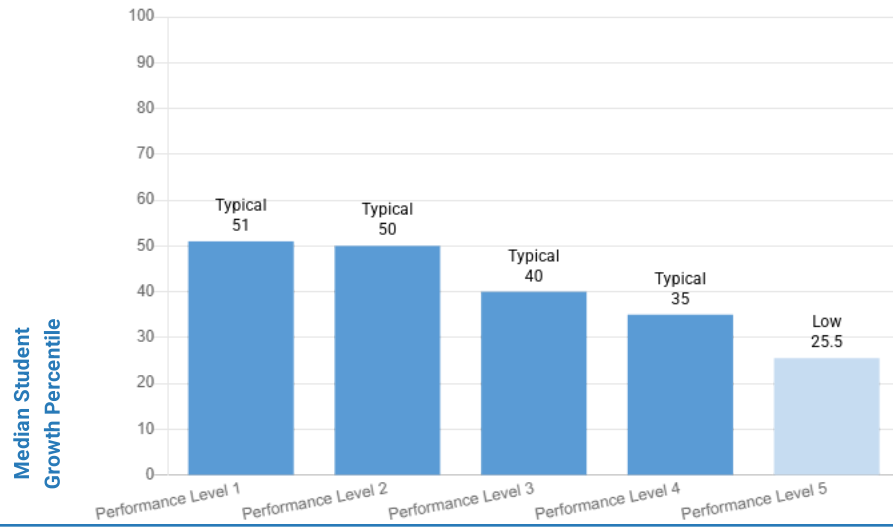

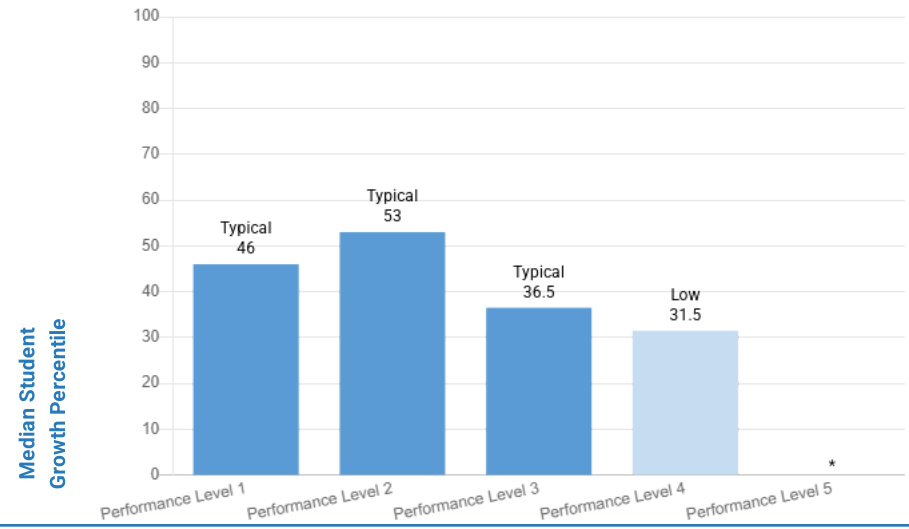

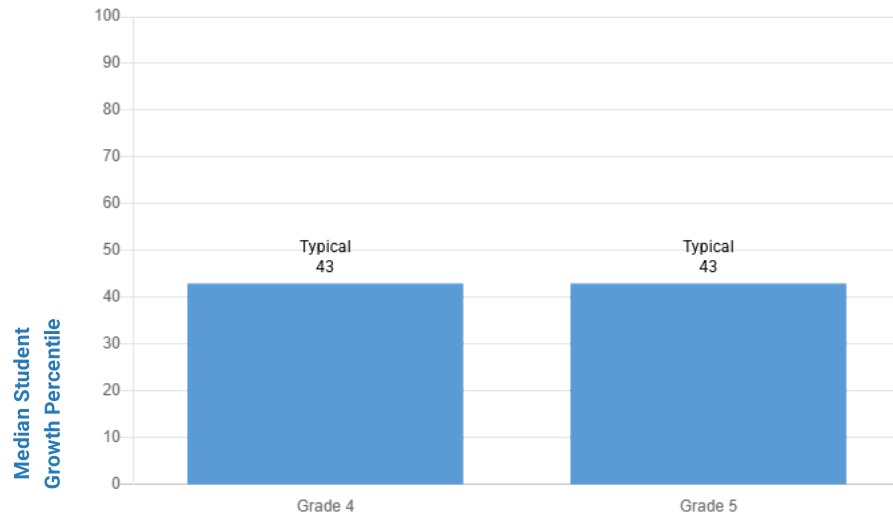

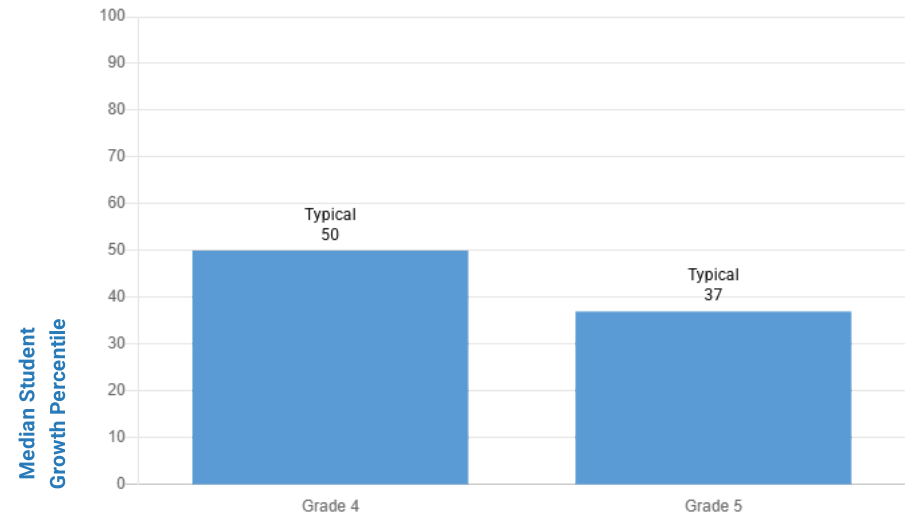

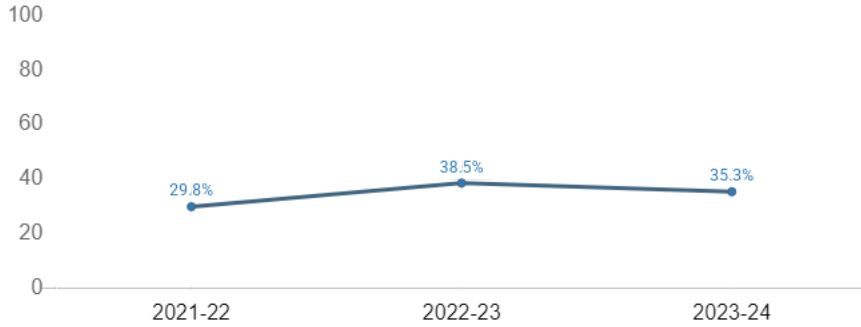

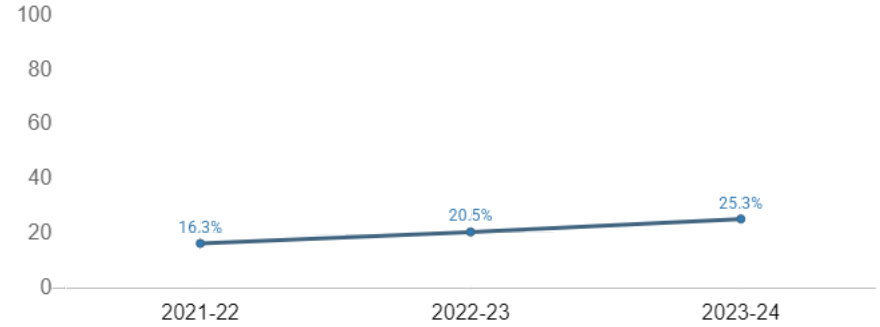
English Language Arts and Mathematics Performance Trends

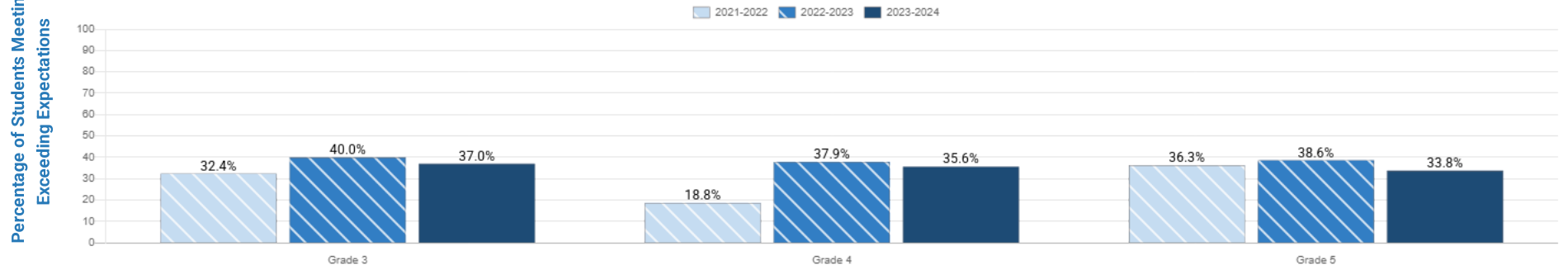

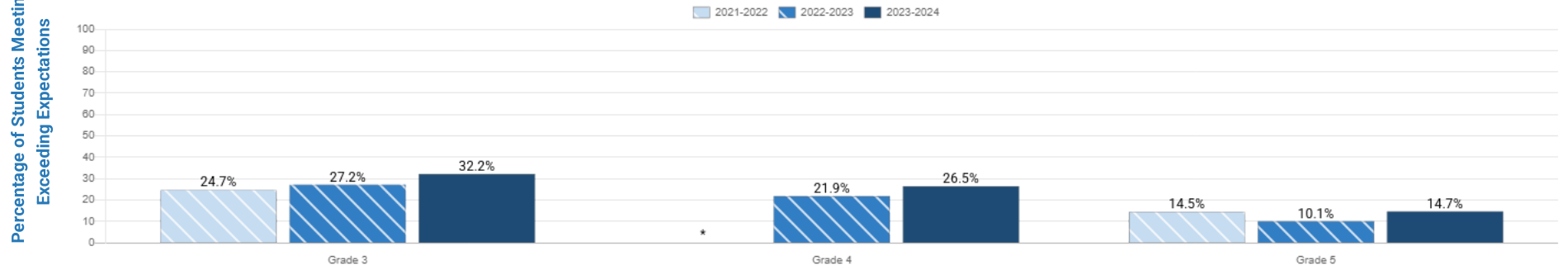

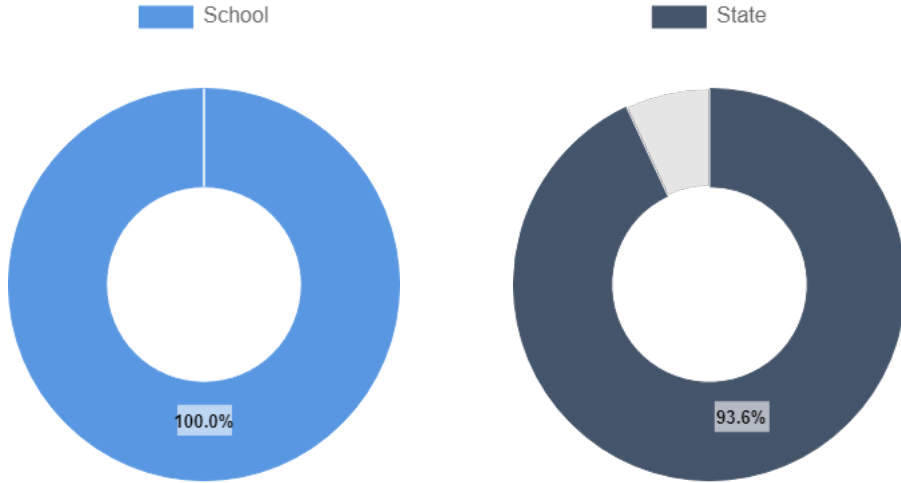

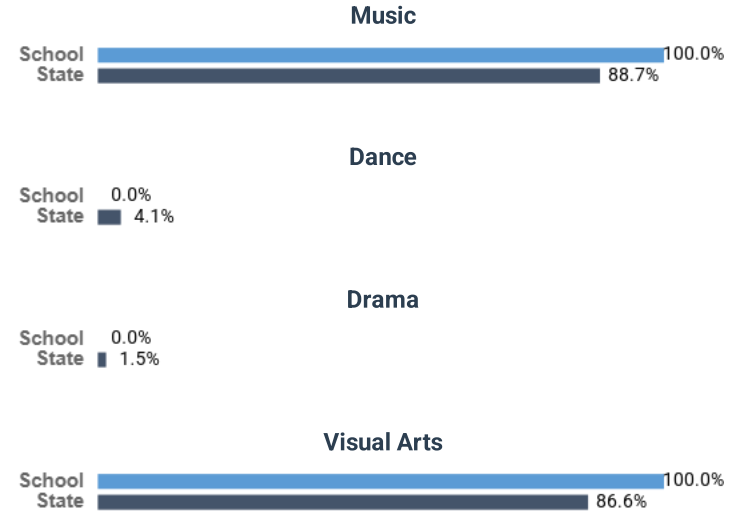

Students enrolled in one or more classes by discipline:



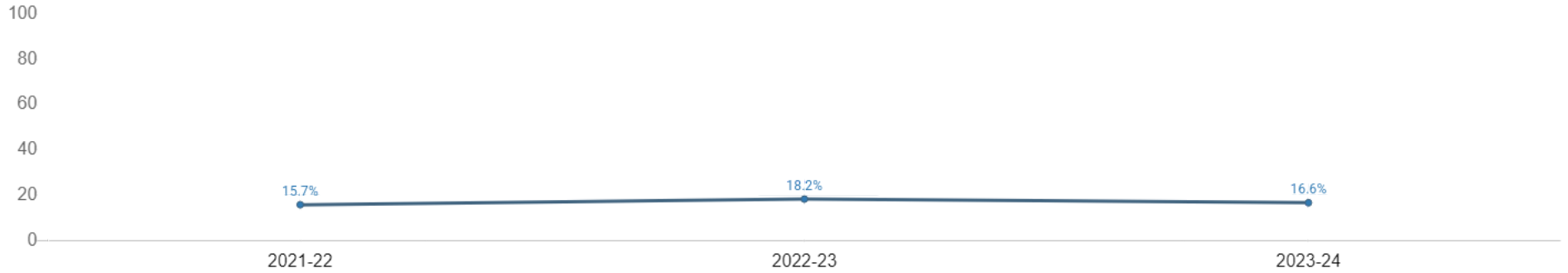

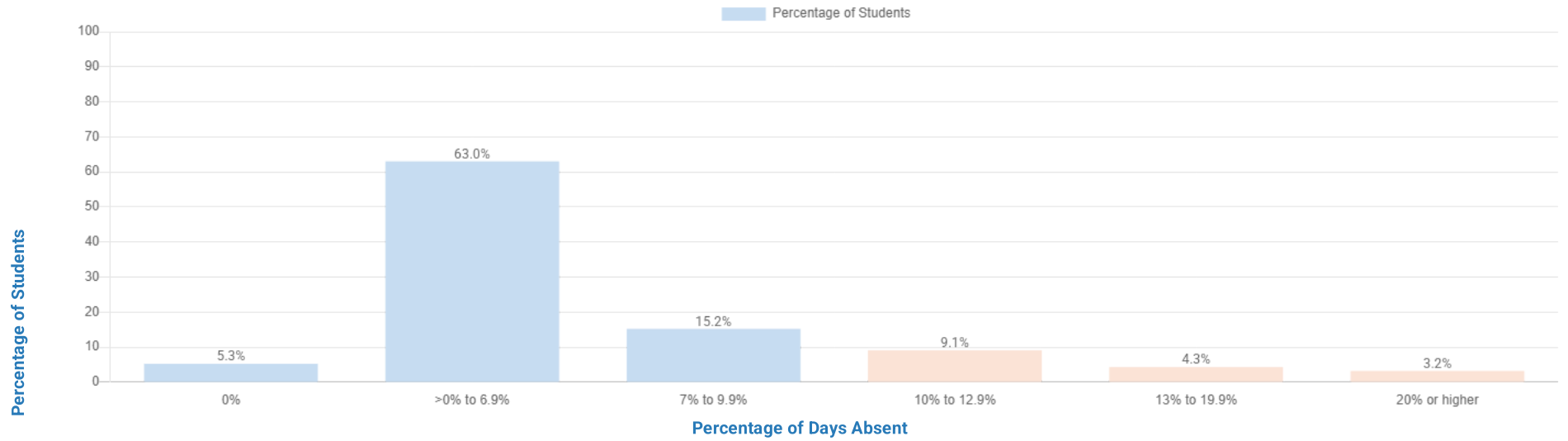

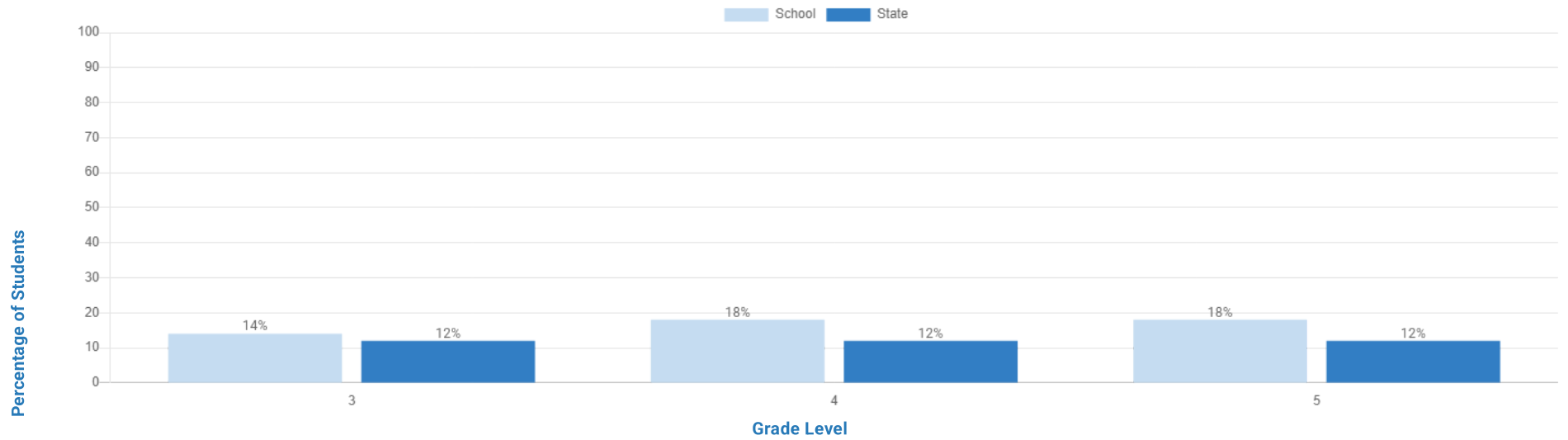

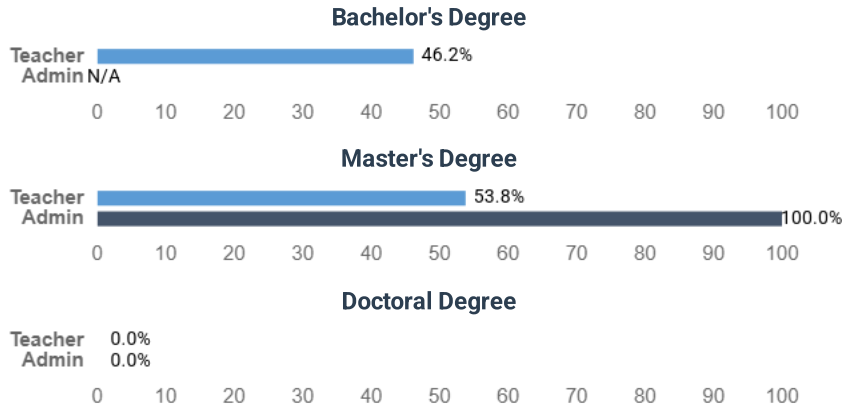

The curriculum is authentic in nature providing students with challenging and rewarding experiences. An emphasis is on Critical thinking and 21st Century Skills to enhance the educational experience. A full complement of academic and related arts coursework is offered to all students. This year, three new curriculum offerings have been introduced for grades 4-6 in ELA, Social Studies, and Health. Students engage in various instructional experiences throughout various platforms, including digital, hands-on, and text. Our primary focuses include writing across the curriculum, ensuring students develop strong writing skills in all subject areas. We also emphasize mathematical discourse, encouraging students to discuss and explore mathematical concepts. Life skills, such as physical and mental organization, are taught to help students manage their responsibilities. Additionally, we prioritize student success skills, including communication, self-advocacy, and study skills.



Sports and Athletics:

Sports are offered in an intramural manner as part of after-school clubs. Additional sports are offered by the town recreational department.

McCloud offers a wide range of extracurricular clubs and activities to engage students in various interests. Recreational and after care programs are offered to students by Bergen Family Center. These programs are hosted on full and half days. A breakfast program is offered to all students.



Staff and Professional Learning:

The Staff is engaged in district-sponsored professional development, scheduled weekly. These activities ensure that the teachers are trained in pedagogy and skills that support the district's articulated curriculum. Teachers also participate in various PD days scheduled at the start of the school year, quarterly and during the two days embedded into the calendar. Staff members are trained in additional items such as I&RS, HIB, and 504s.



Student Supports and Services:

McCloud is supported by two full-time counselors and a full-time nurse. Our I&RS (Intervention and Referral Services) teams meet bi-weekly to collaborate with students and teachers in creating tailored support plans for those facing challenges in academics, behavior, or other areas. Our Child Study Team includes a social worker, LDTC, and psychologist, all working together to provide comprehensive support. In addition, students receive weekly tutoring from teachers, and we have two part-time behaviorists on staff to assist with behavioral needs.

Facilities:

The original building was completed in the 1930's. The new addition was added in 2008. The building has two floors with offices and classrooms. There is a gymnasium, media center, cafeteria, chorus room, band room, stage and two outdoor playgrounds. Currently 483 students attend the school.

School Safety:

The safety of our students and staff continues to be a priority in our schools. All schools practice safety drills every month, such as fire drills and either a shelter-in-place, lockdowns, or evacuation drill. There is a School Safety Team and three security guards at the school. We have safety assemblies and local police and fire department visits to the school.



Technology and STEM:

Each student is equipped with their own Chromebook to bring home with them and use in school. All teachers are provided with MacBook computers and there is a "Smartboard" in every classroom. McCloud also has a STEM club that meets weekly.

For several reasons, McCloud Elementary School does have to deal with chronic absenteeism and has developed a Corrective Action Plan that targets some of the areas the school believes may be contributing to this situation, including, but not limited to student motivation, cultural uniqueness, mental health, and parental involvement.
