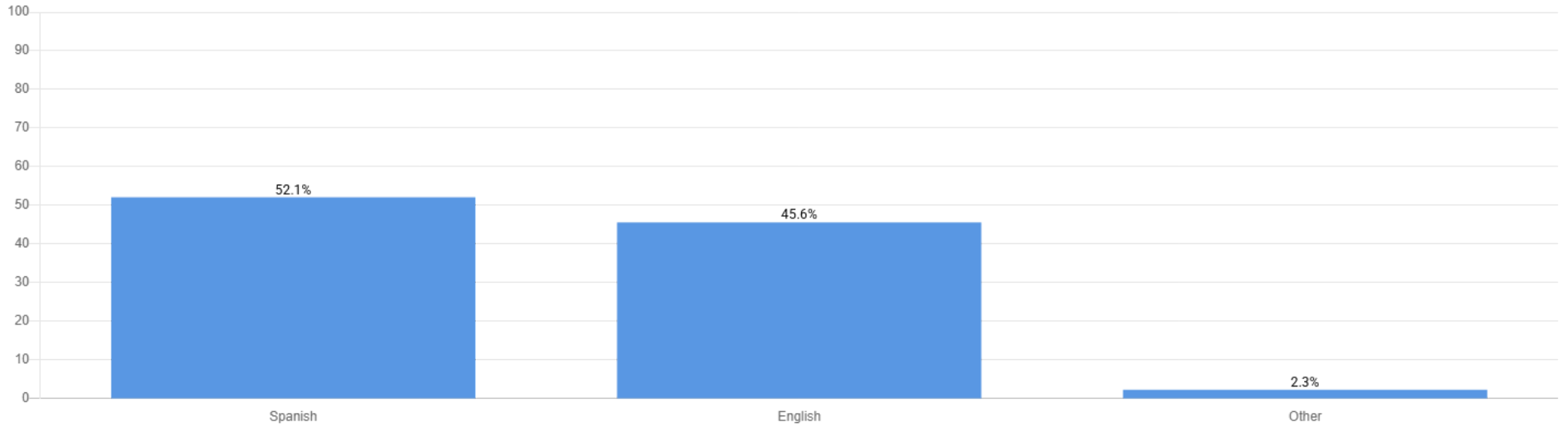

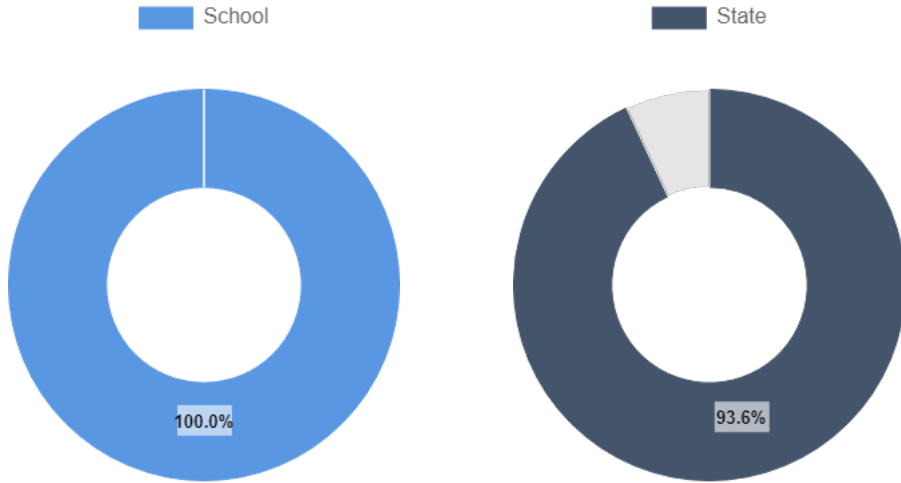

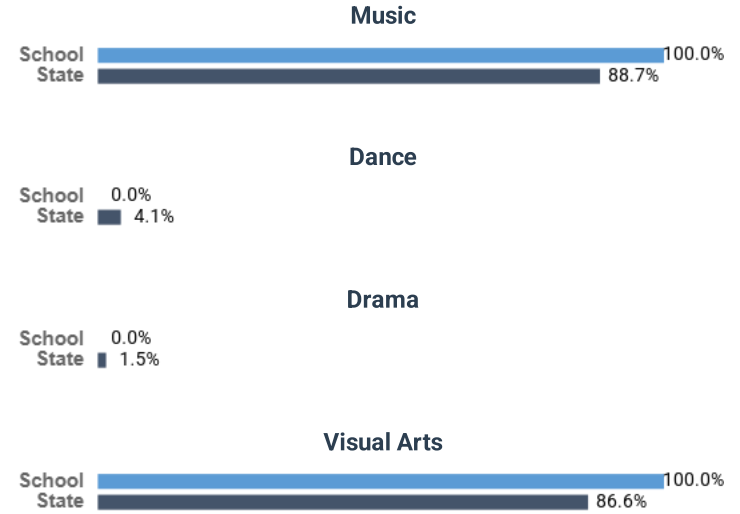

Students enrolled in one or more classes by discipline:



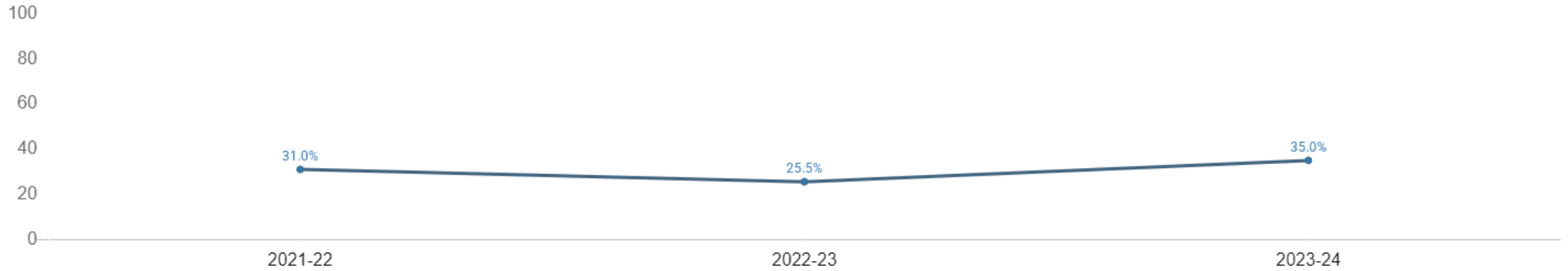

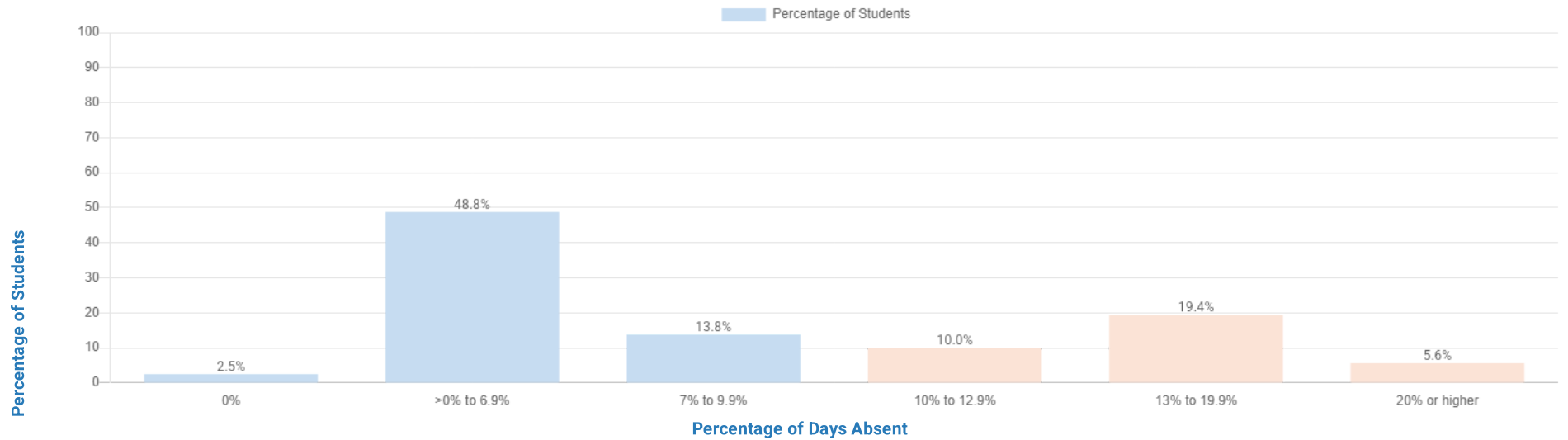

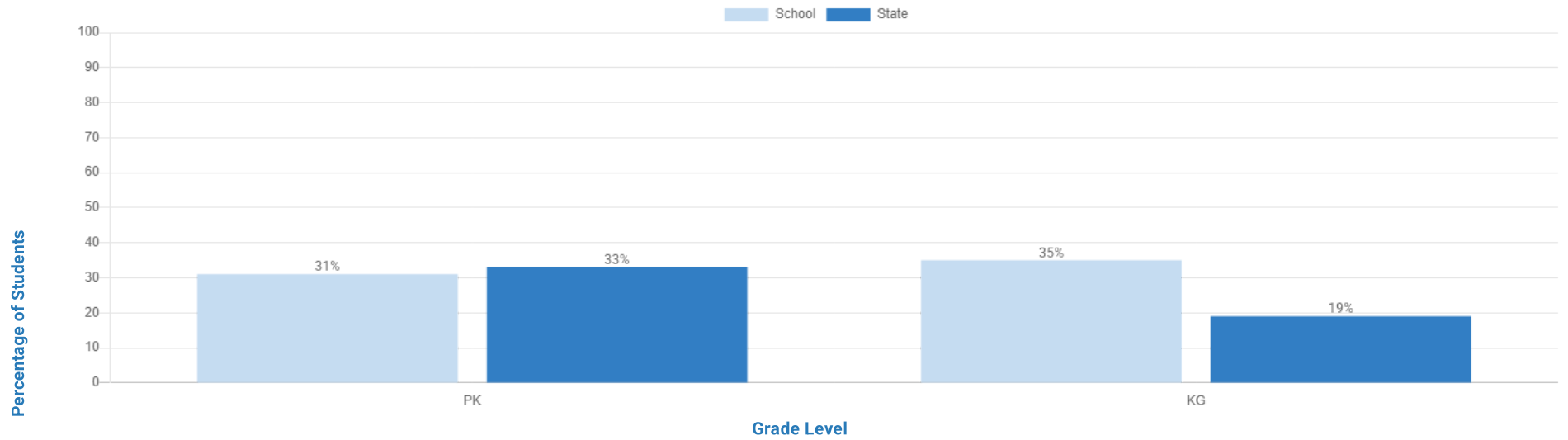

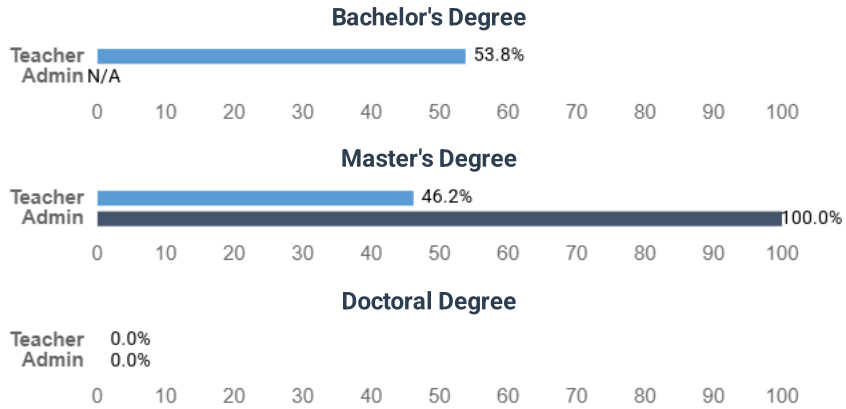

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

Our curriculum provides a comprehensive, developmentally appropriate learning experience for students from pre-school through kindergarten. Pre-school utilizes the Tools of the Mind curriculum, focusing on cognitive, social, and emotional development. In kindergarten, we use HMH for core subjects-math, English Language Arts, and science-providing an integrated approach to foundational skills. Social studies is supported by McGraw Hill, while The Great Body Shop curriculum delivers engaging health education. Additionally, students participate in a well-rounded Related Arts program, receiving instruction in art, music, Spanish, physical education, and media, which encourages creative expression, cultural awareness, physical health, and digital literacy.



Before and After School Programs:

There is an after-school program offered to all students for a monthly fee through Bergen Family Center.



Staff and Professional Learning:

Professional learning is coordinated through the Office of Curriculum and Instruction. In addition to district professional development, there is specific training provided to the pre-school teachers through the NJ Workforce Registry as well as professional development provided through our Pre-school Instructional Coach and PIRT Specialist. Our district coaches also offer professional learning opportunities to all staff via staff meetings and classroom visitations. We also work with Apple for teacher coaching and professional development for staff in using technology to support academic programming.

Facilities:

Our campus is designed in a California-style layout, featuring nine buildings in total. Each building houses four classrooms, except for one which accommodates eight rooms. We also have three playgrounds, all equipped with ADA-compliant play structures. Additionally, our campus includes specialized spaces such as an art room, media center, music room, cafeteria, gym, and an outdoor classroom.



School Safety:

We follow the state guidelines of two security drills per month and work closely with the EPSD Supervisor of Security and the Englewood Police Department to ensure the safety of all students and staff. We also have a School Safety Committee.

Early Childhood Education:

Our pre-school program follows the guidelines designated by the NJDOE. Each general education classroom has a maximum of 15 students with one teacher and one classroom assistant. In pre-school there are also self-contained classrooms for students whose IEP requires this type of classroom. In kindergarten, the maximum number of students in a classroom is 21 with a classroom teacher and classroom assistant in a general education room. In kindergarten we also have inclusion classrooms and self-contained classrooms.



Attendance:

Though pre-school and kindergarten are not mandated programs in the state of New Jersey, we take the education of early learners very seriously and address absenteeism and tardiness with families. Absenteeism challenges occur as students adapt to school routines and build stronger immune systems through their early school experiences. We are pleased to report that we have systems in place to address absenteeism, including a Consecutive Absence Flow Chart that was developed with our leadership team in our school. The flow chart itemizes steps such as parent phone calls, home visits, notification to DCP&P and more.
