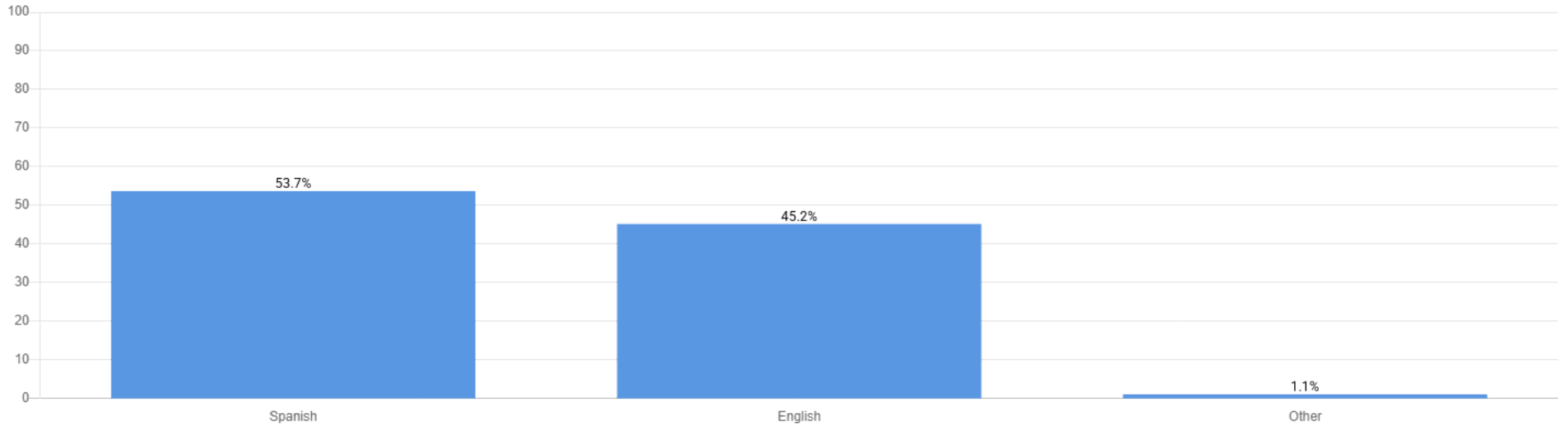

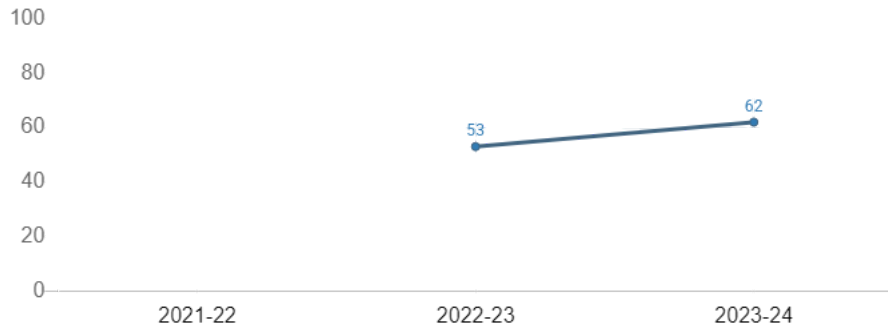

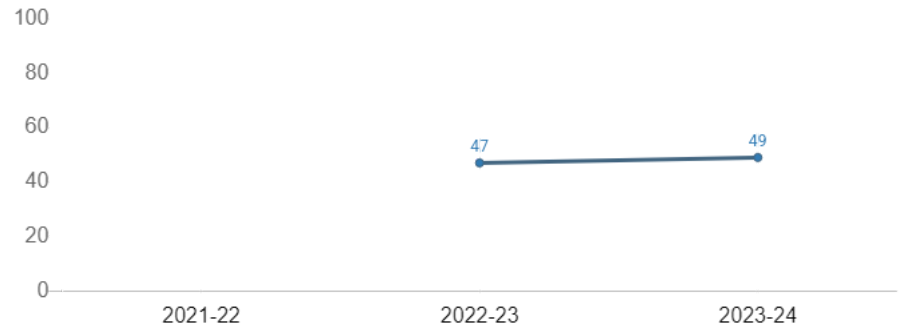

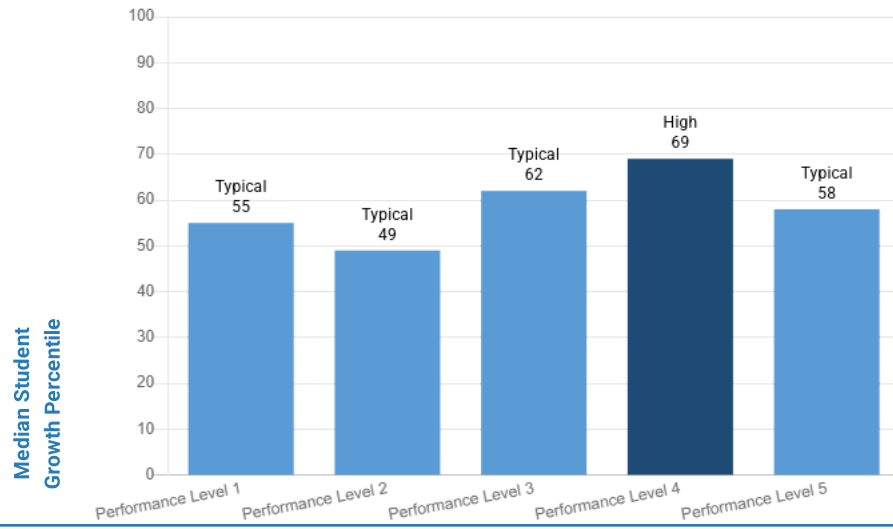

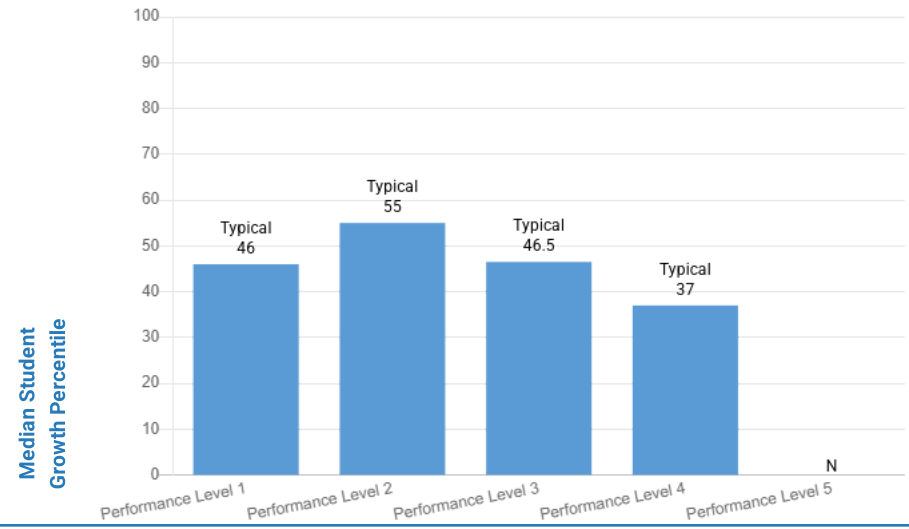

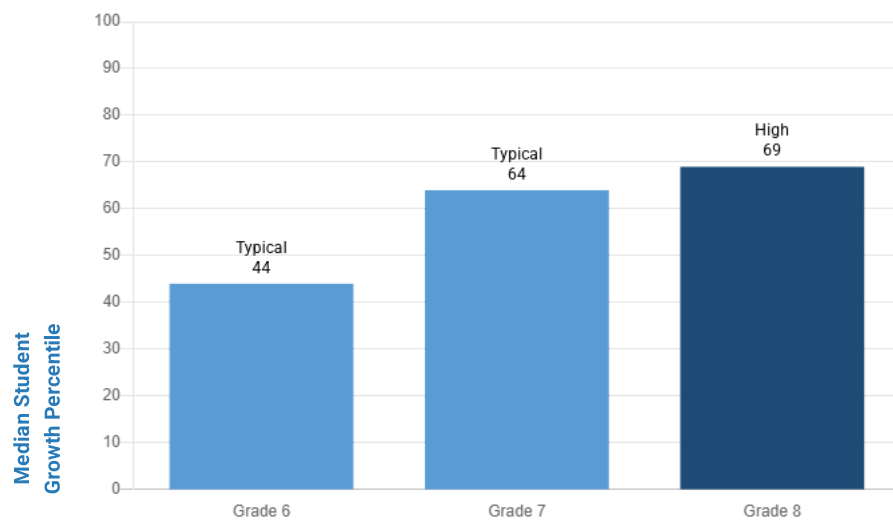

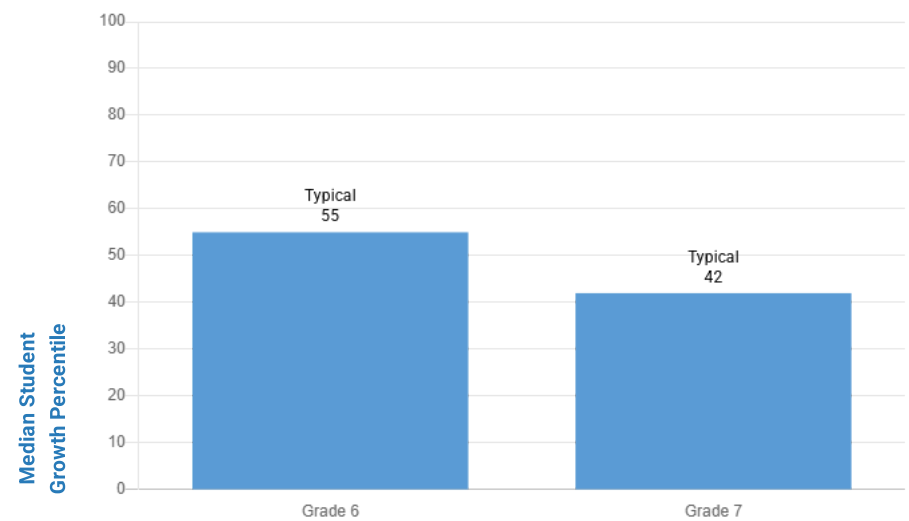

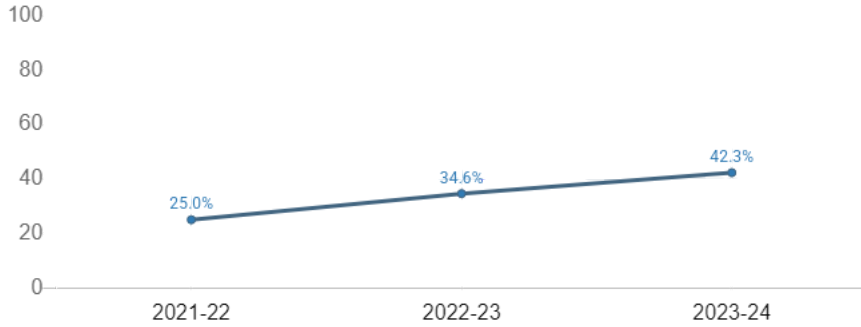

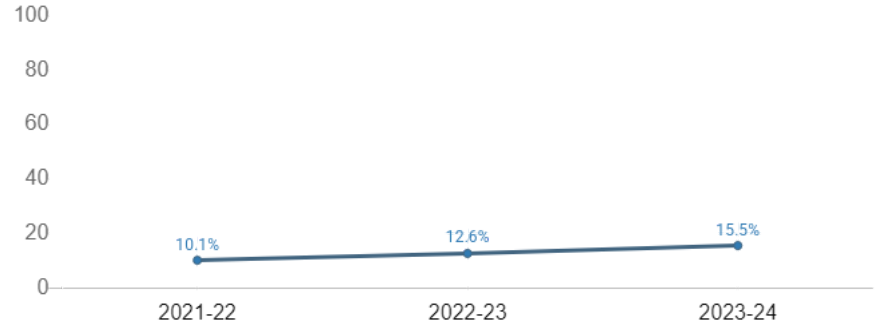
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 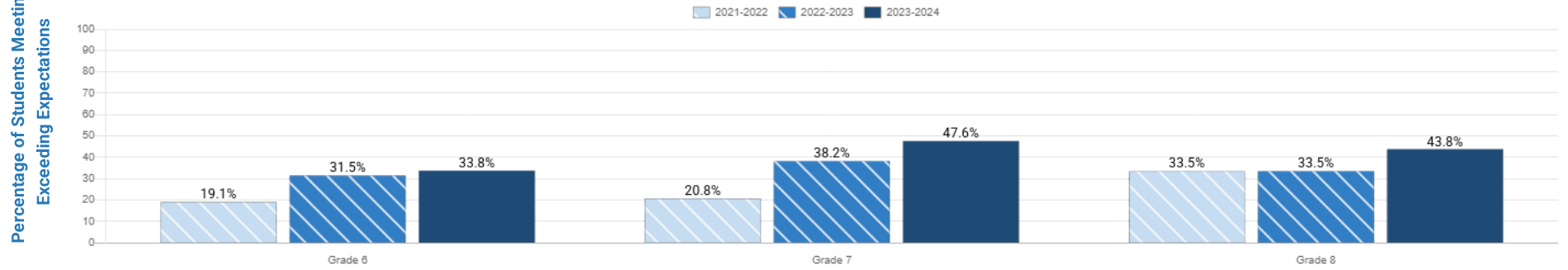

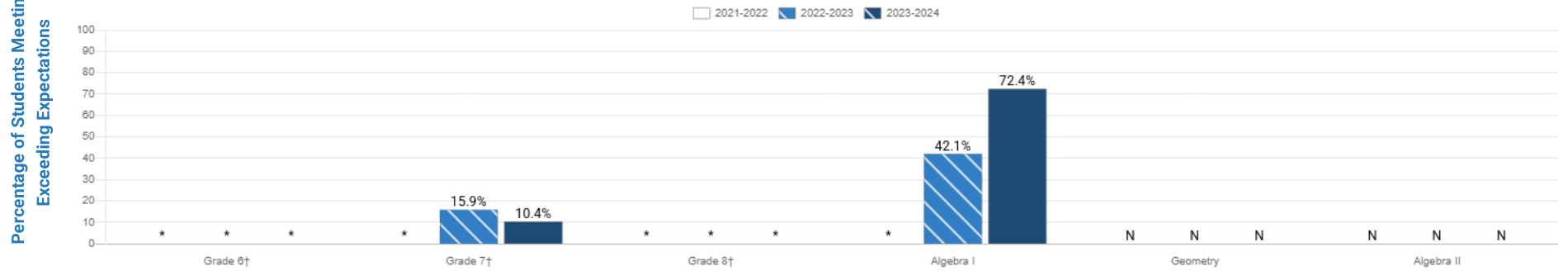

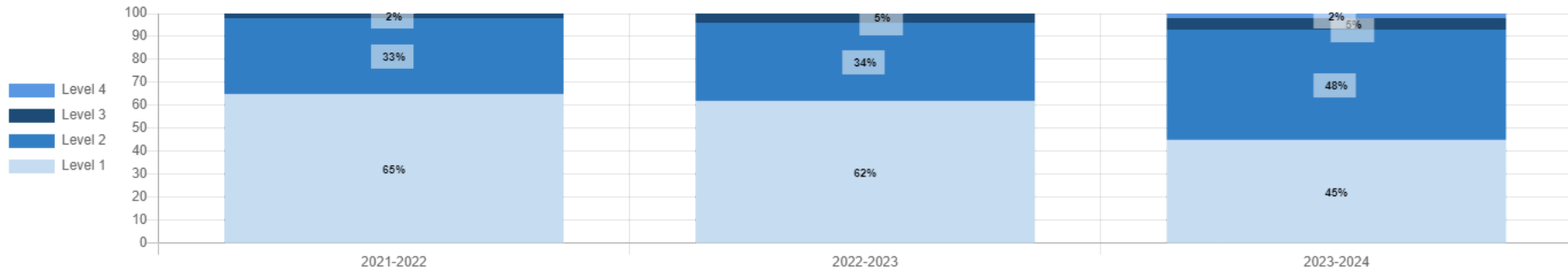

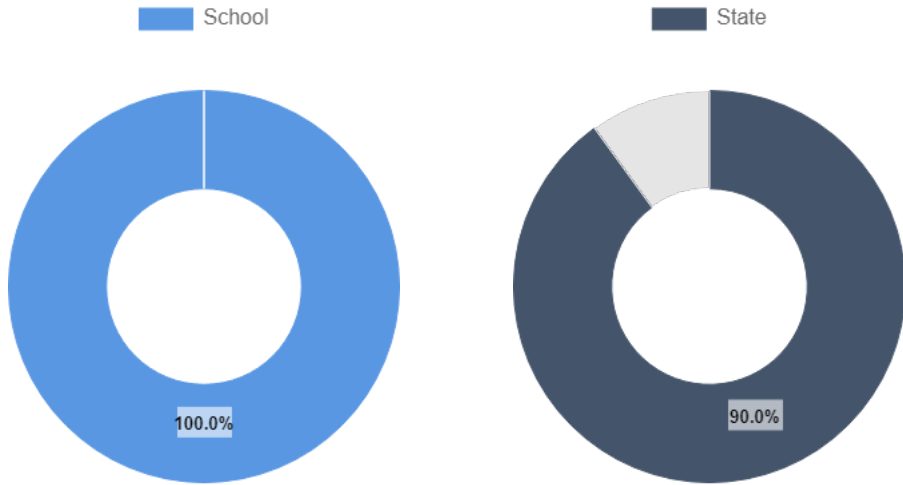

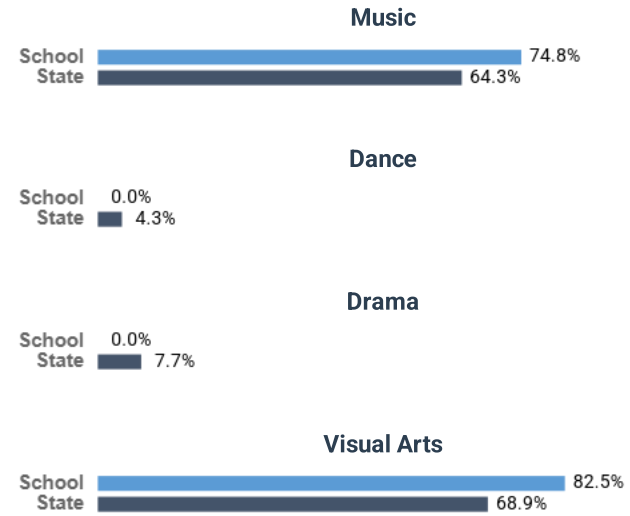

Students enrolled in one or more classes by discipline:



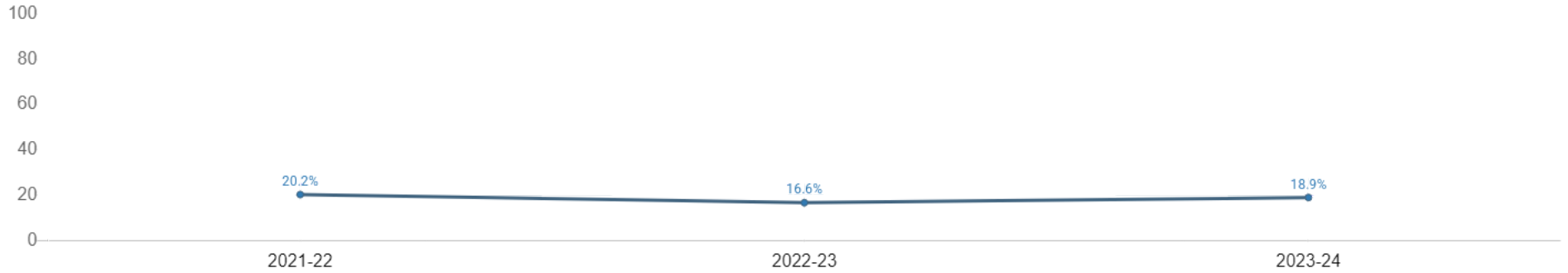

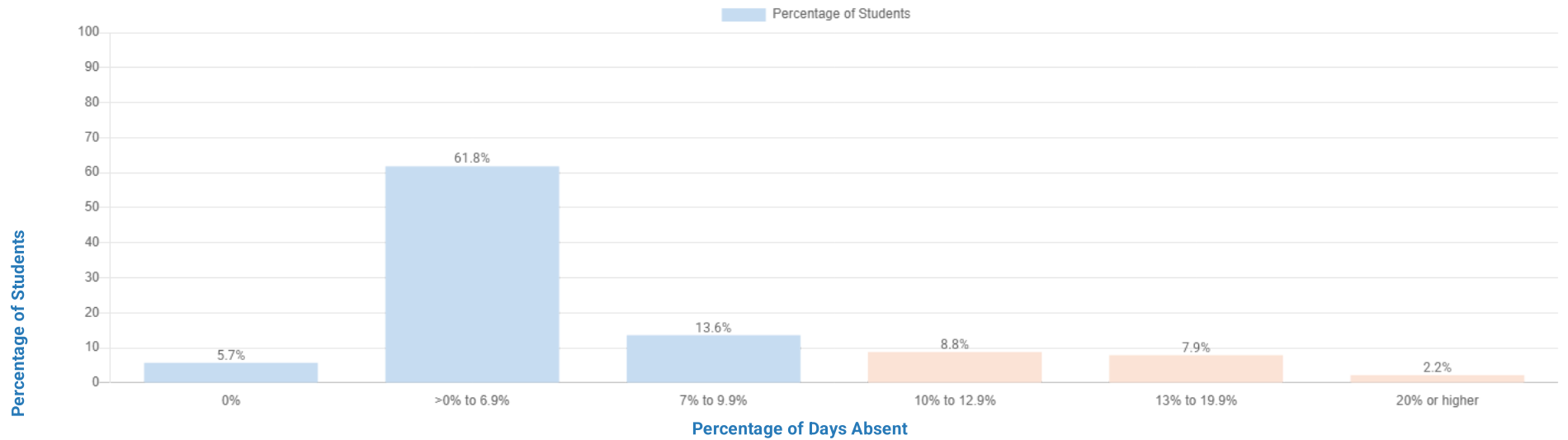

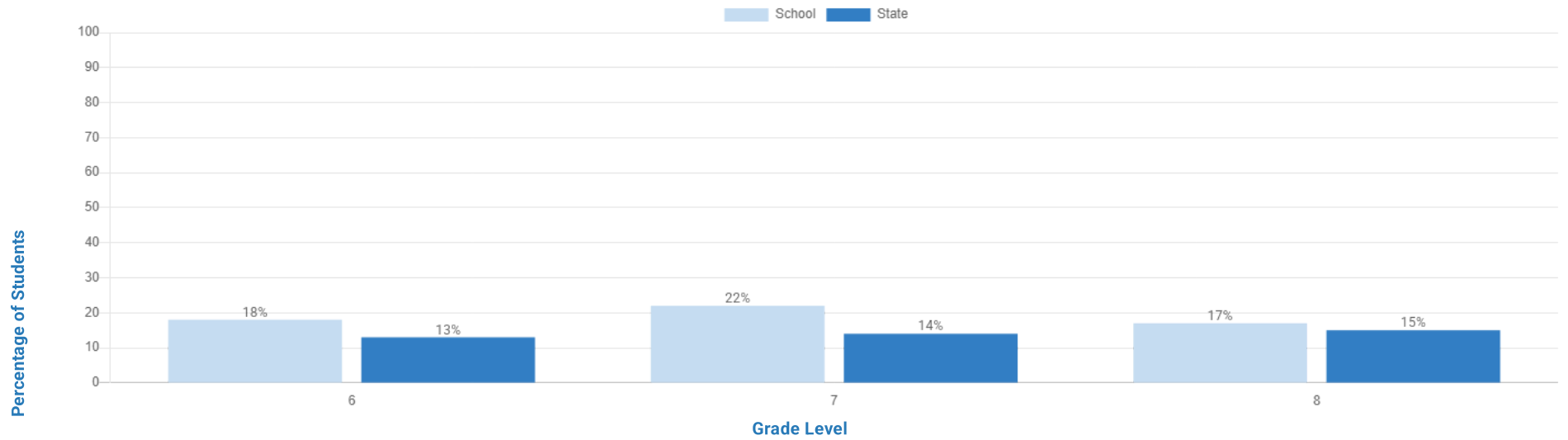

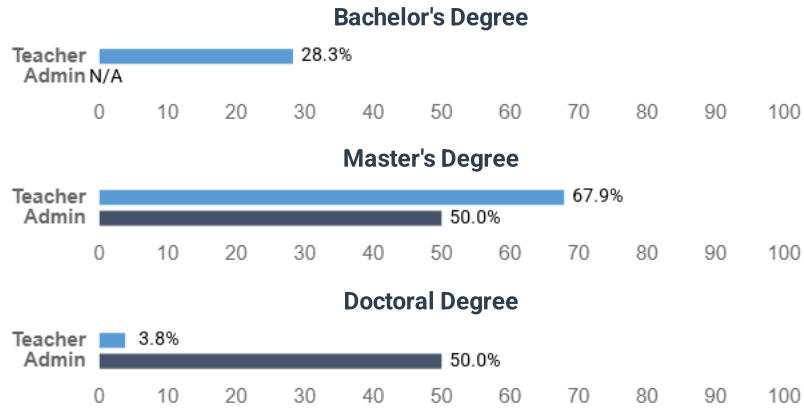

- JDMS is a community of learners and teachers consisting of 342 students and 68 staff members, housing grades 7-8 in a nurturing and orderly environment.
- JDMS is focused on empowering life-long learners through creativity, innovation and inspiration.
- JDMS houses one of the most experienced administrative teams in the Englewood Public School District, anchored by Dr. Laura Mathieu (19 years) and Mr. Abraham Alarcon (24 years).



Mission, Vision, Theme:

Vision: Creating an academically rigorous environment for all students governed by the "Core Values" of Unconditional Love, Family, Educational Excellence and Community. Mission: Increase student achievement using data driven instruction. Focusing on the content and skills needed for students to obtain proficiency in both ELA and Math. Working with all stakeholders to ensure that student sub-groups receive diversified, structured academic support. Balance our pursuit of academic excellence while also promoting the development of a positive rapport and relationships among staff, students and their families. Theme: We have the expectation that our students have the capacity and the ability to be academically high achieving.

The Janis E. Dismus Middle School has been selected to be a Verizon Innovative Learning School (VILS). As a VILS, JDMS was able to provide all students with new laptops, enabled with Verizon Wireless. As a VILS school, JDMS will receive professional development for staff and various other resources for students. Dr. Laura Mathieu (JDMS Interim Principal) was named New Jersey Principals and Supervisors Association Visionary Leadership Award Assistant Principal of the Year.

Courses, Curriculum, Instruction:

Student schedules integrate RTI reading / mathematics support for students including additional academic support for ESL and special education students. Students are strategically placed into a related arts rotation that includes art, music, band, theater, dance and technology to assure a blend of opportunities for students. Specialized academic programs such as IXL, HMH, Read 180, and RTI are utilized to create an academically rigorous instructional program. JDMS has a continued partnership with the Algebra Project. The Algebra Project is a national U.S. mathematics literacy program aimed at helping low-income students and students of color achieve the mathematical skills in high school that are a prerequisite for a college preparatory mathematics sequence. Additionally, JDMS has partnered with Rutgers University and the Center for Effective School Practices for the Computer Science Teaching & Learning Collaboratory to acquire data regarding culture and climate.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Volleyball (Girls)
Janis E. Dismus Middle School offers educational based athletics for both boys and girls in all 3 seasons. Student athletes have the opportunity to compete against surrounding middle schools. Football, Cheerleading and Hockey are offered to students in this age group via Englewood Recreation Department.

Before and After School Programs:

After School programming is provided to JDMS through the Zone, a School-Based Youth Service Program and Homework Haven, a school-based tutorial program. The ZONE @JDMS is a School-Based Youth Services Program operated by the Bergen Family Center. The ZONE is dedicated to building upon the strengths and capabilities of students as they strive for academic achievement and social and emotional wellness. The Zone is led by Director Elizabeth Acevedo. The Zone promotes healthy youth development through individual, family, and group counseling, lunch activities, after school programs and class presentations. Programs are offered during the students' lunchtime period and after-school from 2:30pm-4pm. Homework Haven is a school-based tutorial program staffed by a variety of JDMS teachers. Homework Haven offers academic support for students both before school (Monday-Friday, 7:15 AM - 7:45AM) and after-school (Tuesday-Friday, 2:45AM - 4 PM).



Staff and Professional Learning:

JDMS Staff engage in a variety of Professional Learning Opportunities. All JDMS staff have common planning time built into their schedule daily. Additionally, JDMS staff experience weekly Professional Learning Communities. Math teachers receive continuous professional development from the Algebra Project. ESL and ELA teachers have received Professional Development from HMM. All JDMS staff have received technology professional development from Verizon through our Verizon Innovative Learning School partnership. JDMS also retains an instructional coach and a Verizon Technology coach, who provide instructional and professional development support to JDMS Staff.



Student Supports and Services:

Various support services are offered to the students of Janis E. Dismus Middle School and their families. Our Nurse facilitates the "Gift of Sight" Program through Lens Crafters. Our Guidance Counselors work with students and families to address social-emotional issues. Our Guidance Department has taken the initiative to create partnership with various mental health agencies to provide support services to our students and their families. The Child Study Team provides support services for all students with disabilities. JDMS has implemented a Community-Based Instruction Program (CBI), to support students with extensive special needs. JDMS also offers a Language Learning Disabilities Program (LLD). The Language Learning Disabilities (LLD) Program is designed to meet the individual needs of students with language and/or learning disabilities, such as Communication Impairment and Specific Learning Disabilities.

Student Health and Wellness:

At JDMS, students are offered many opportunities to be active, including recess, Health Class which also incorporates character education within the traditional health curriculum, as well as Middle school athletics. Middle School athletics include Basketball, Volleyball, Baseball, Softball, and Soccer. School intramural sports are also offered after school, including a Soccer Futsal tournament, a 3 on 3 Basketball tournament, and a stadium specific Field Day in the Spring.



Parent and Community Involvement:

The JDMS has created many opportunities to promote parental and community involvement. Updates and alerts are communicated to parents via the Genesis Parent Portal, our school's website, X (Twitter), YouTube Channel, Facebook Page and Instagram account. Our active Parent Teacher Organization fosters many programs in support of our students. Partnerships with the community includes several community-based organizations such as the Englewood Health Department, Englewood Library, Bergen Performing Arts Center, Englewood Recreation, John T. Wright Arena, Bergen Family Center, the Rotary, the Englewood Environmental Commission, the Gardening Club of Englewood and the Links.



Facilities:

The Janis E. Dismus Middle School was erected in the 1960s. The building houses an elevator for handicap use. The building hosts a Media Center, five Science Labs, a VILS Lab, a Technology Lab, an Art room, a Dance Studio, a Gymnasium which includes a Basketball Court, a Greenhouse, and a Community Garden. All classrooms have individual air conditioning units. The Gym, Media Center and the Main Office have central air conditioning. JDMS also houses the Zone which serves as a drop-in center for students. JDMS is also in the process of creating a Student Cafe in the Media Center and a Calming Room for students.

School Safety:

JDMS maintains a security staff that provides daily security oversight of the JDMS campus. JDMS provides a secure check-in for all visitors. JDMS maintains a robust security surveillance system on the campus.



Technology and STEM:

Technology is incorporated through various ways in JDMS. Students have the opportunity to take a Technology elective class. Additionally, students can participate in various technology/STEM elective activities such as the STEM Club and JDMS Tech Teams. JDMS partnership with Verizon as a VILS school has also resulted in all JDMS students receiving Chromebooks on the Verizon cellular network, thus providing students with Wi-Fi access regardless of their location.



Attendance:

During the 24-25 school year, JDMS exceeded 10% in chronic absenteeism. Analysis of chronic absenteeism data has revealed that JDMS is still reeling from the prolonged effects of the Covid pandemic, with students who have battled extensive mental health challenges. JDMS will create a CAP (Corrective Action Plan) to address chronic absenteeism through the assistance of an Attendance Officer and an Attendance Matters Campaign. Additionally, JDMS continues to create to provide mental health support to students and their families as well as expand partnerships with mental health providers.
