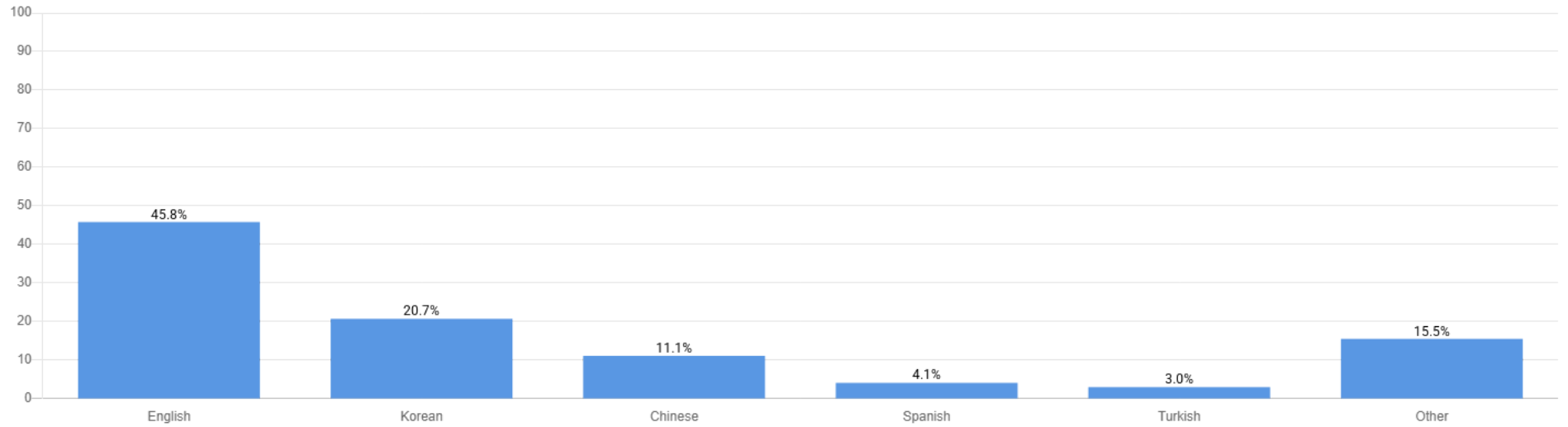

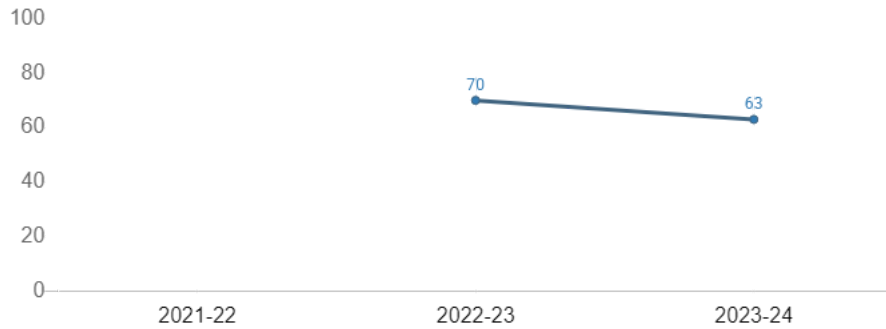

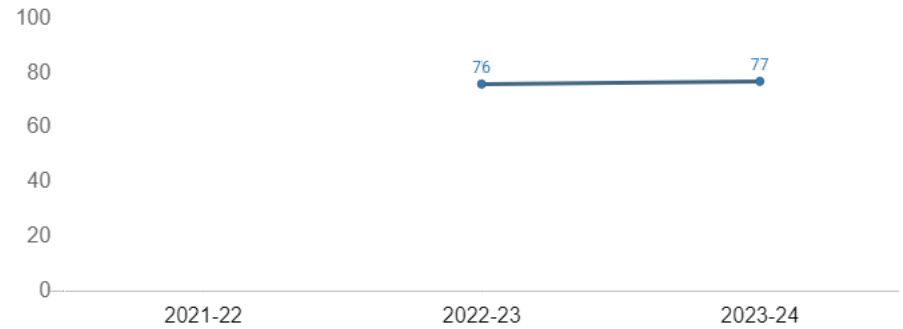

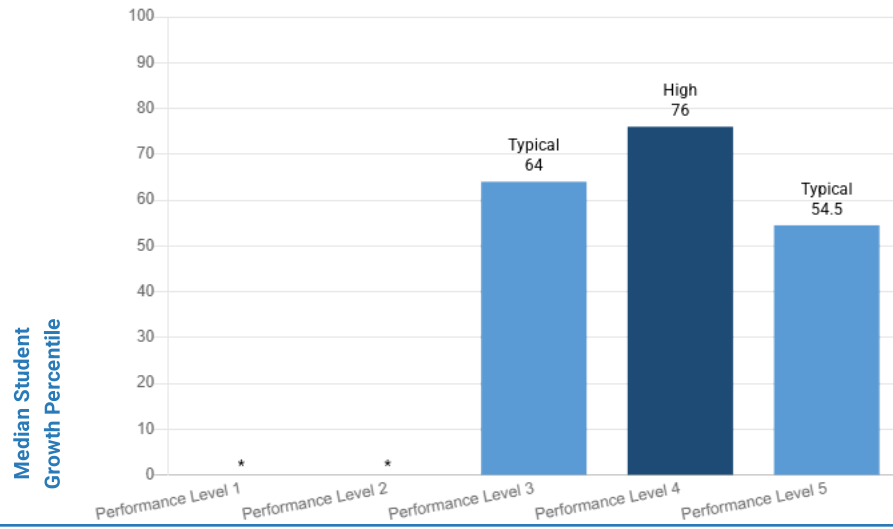

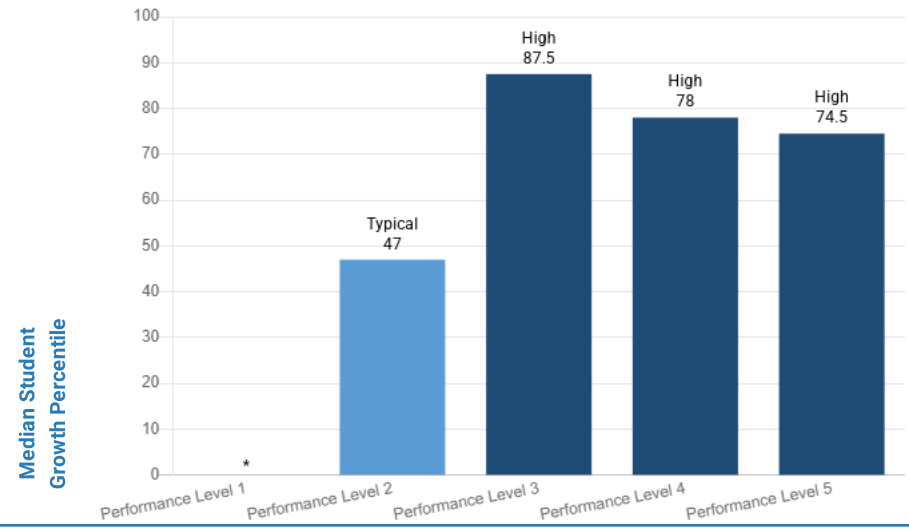

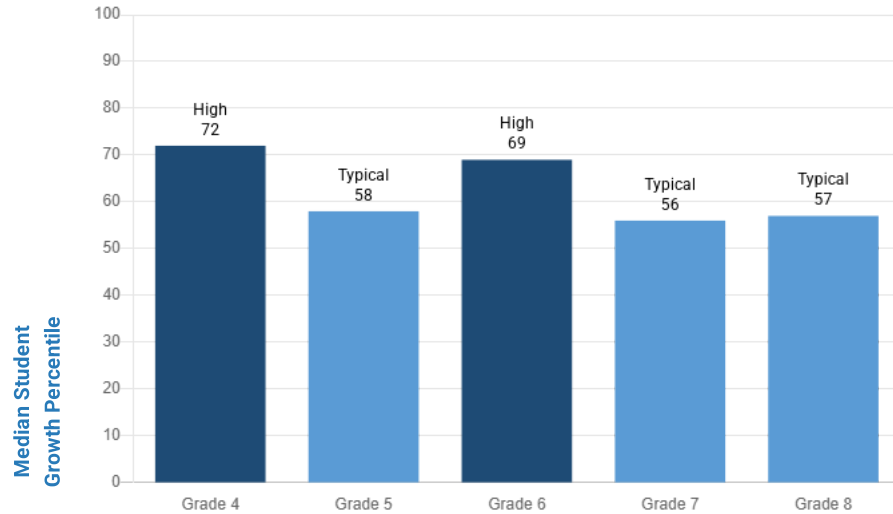

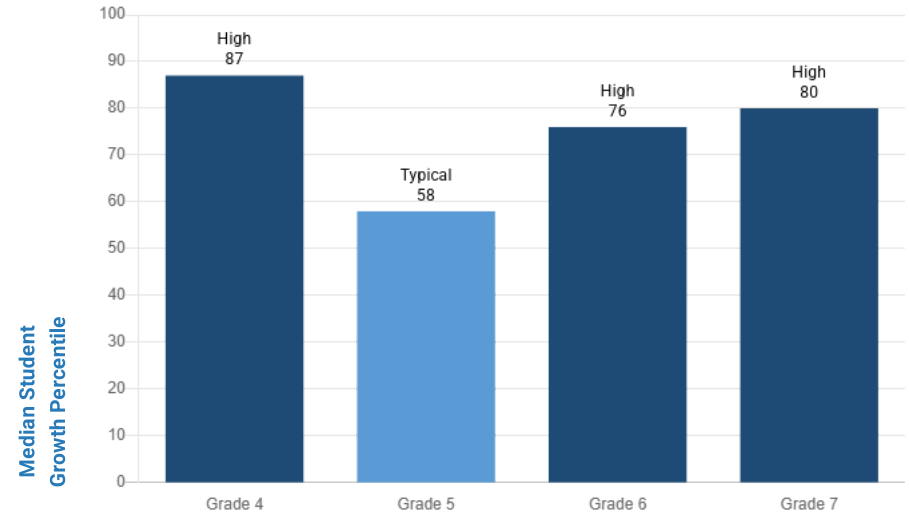

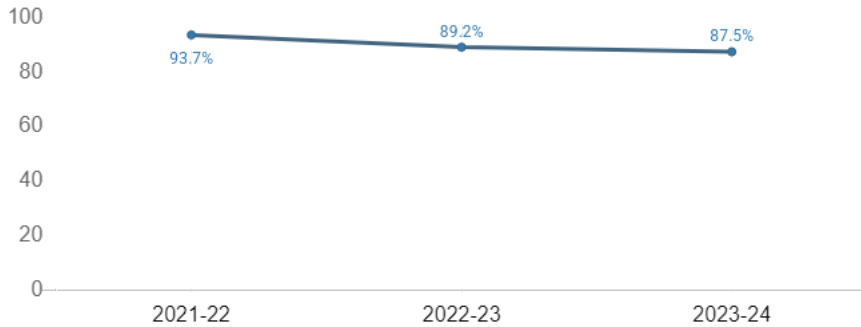

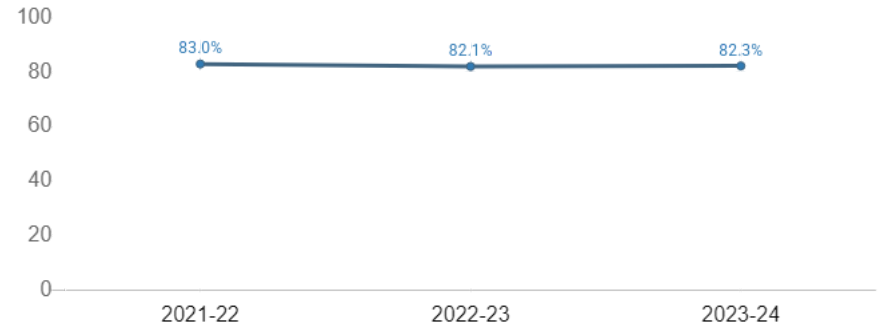
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 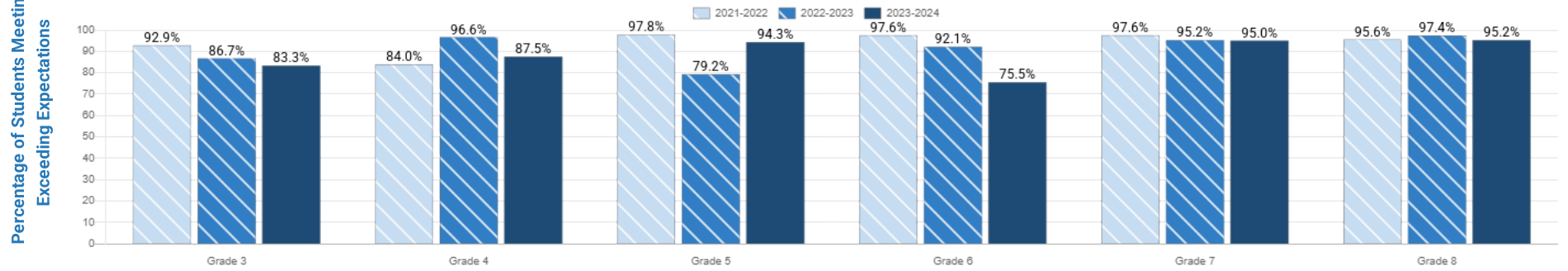

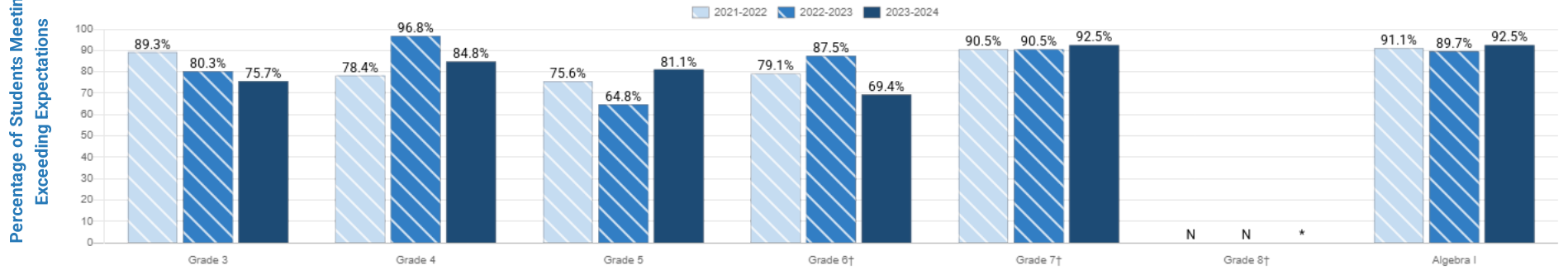

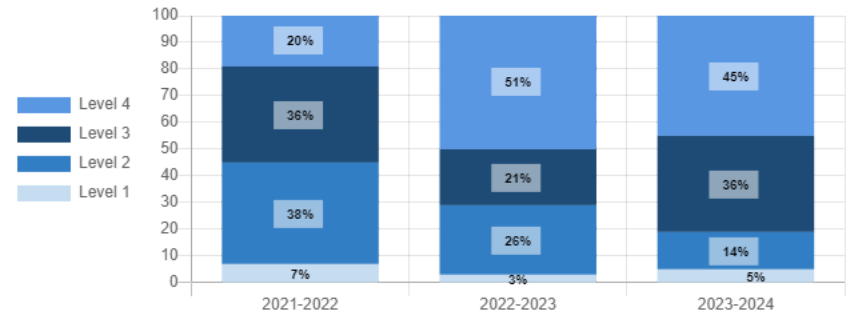

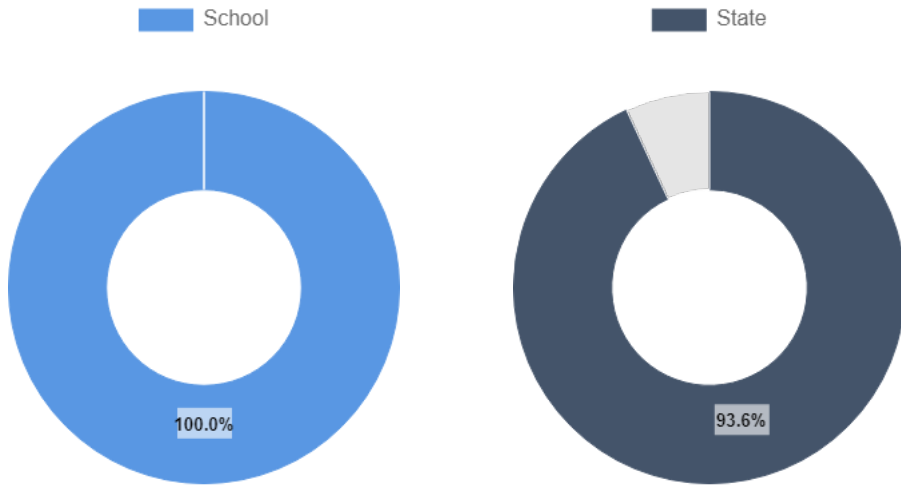

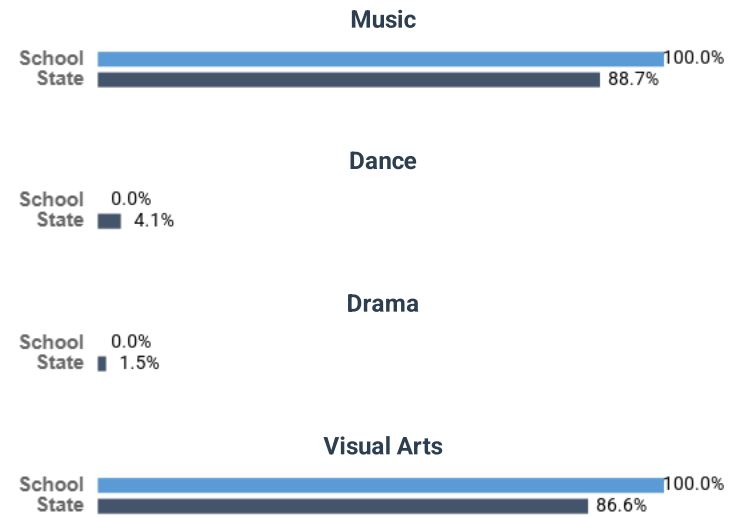

Students enrolled in one or more classes by discipline:



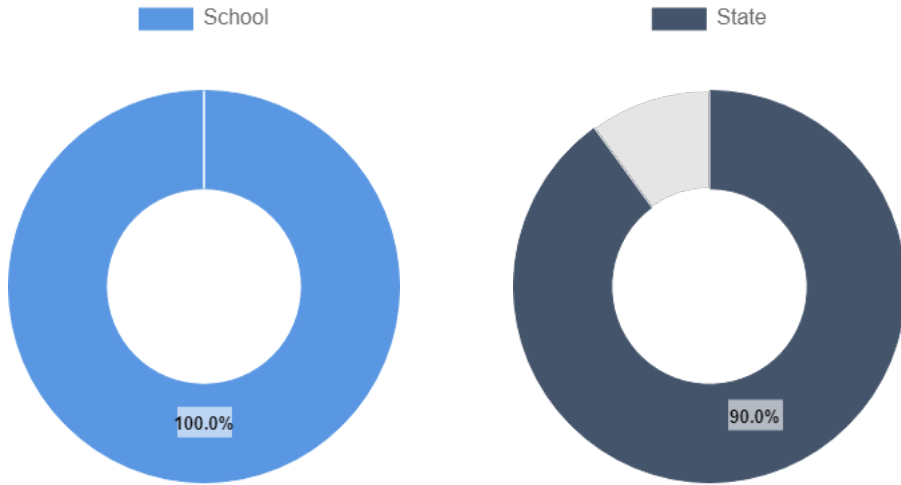

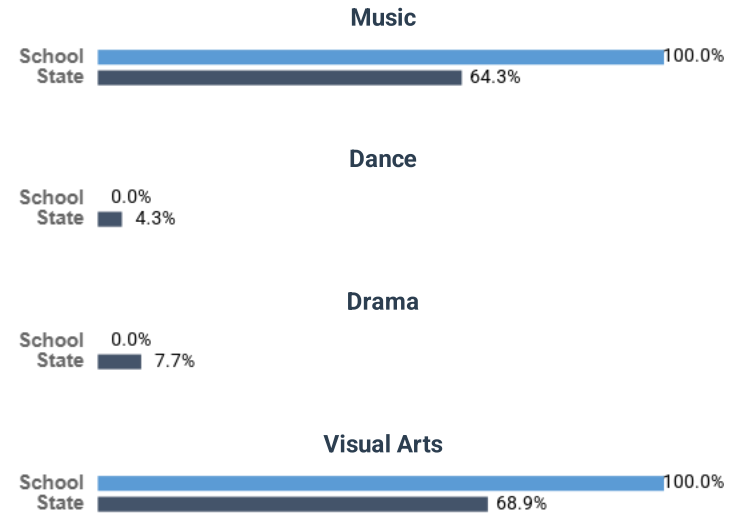

Students enrolled in one or more classes by discipline:



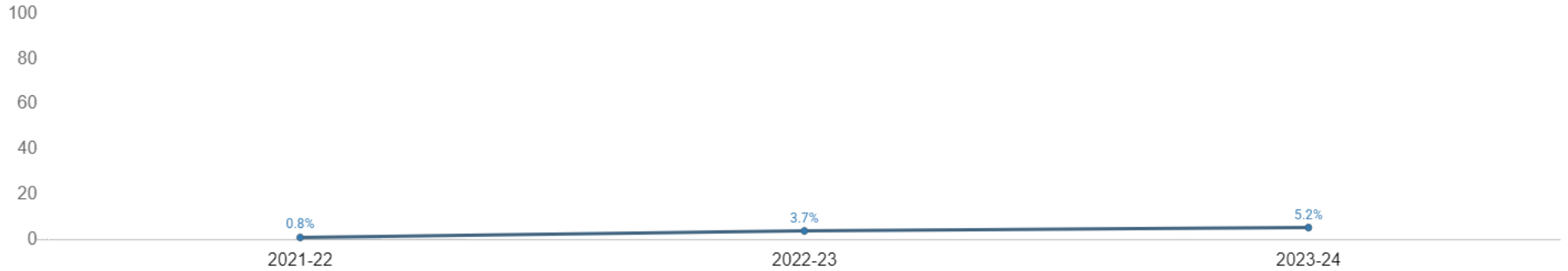

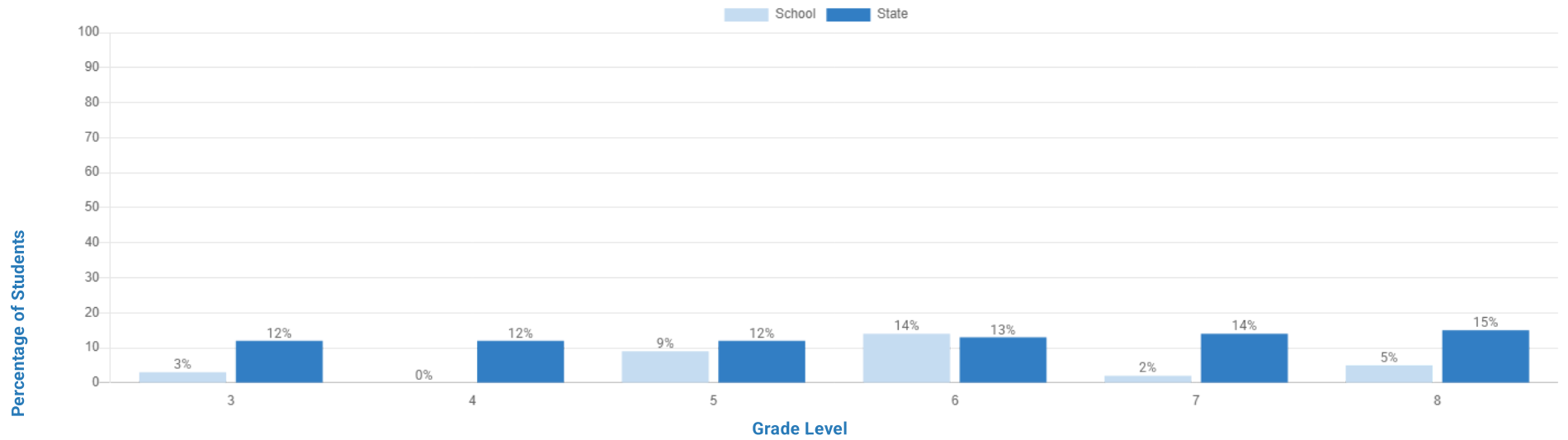

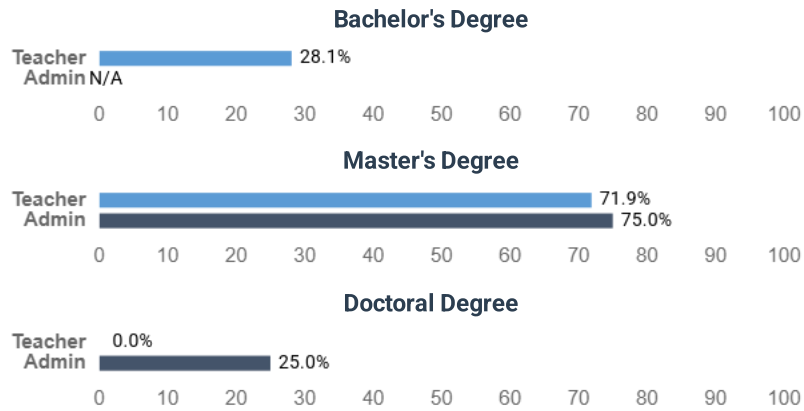

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Highlights:

- Upper School is a third grade through eighth grade school. The school has 274 students.



Clubs and Activities:

Upper School offers many opportunities to participate in various clubs and activities. Students in grades 6-8 participate in "Educate to Innovate," which includes student leadership activities, community service opportunities, and skill building through competitions. Students in grade 5 participated in a Social Skills course that explicitly taught key social-emotional competencies to all learners. A large percentage of the school participates in band, glee, and school musicals. Students are also given opportunities to participate in various competitions including the Math Counts competition (grades 6-8), Scripps Spelling Bee (Grades 3-8), a speech competition (Grade 8), a science fair (grades 5-8), and GATE (Gifted and Talented). GATE students participate in the Future City competition and the Invenengineering Expo. Every year, we are proud to have many of our students accepted in to Bergen County Choir and Band.



Student Health and Wellness:

At Upper School, the nurse and physical education teacher work in collaboration to develop and deliver health education and promotion of student well-being. Our nurse provides on-site health services including treatment of minor ailments, managing chronic health cases, offering family support and education, and providing information on current health issues and trends. School nurses provided in class lessons focused on respiratory etiquette, hand washing, preventing the spread of germs, and mental wellness. A district wide field day was also facilitated for students. Responsive Classroom, a program that permeates all subject areas, is intended to support students' social-emotional competencies and fosters a strong school community. Upper School hosts annual health related assemblies and physical activities to promote the health and well-being of the whole child through positive character development and making good choices. Some examples include: Week of Respect and Anti-Bullying.
