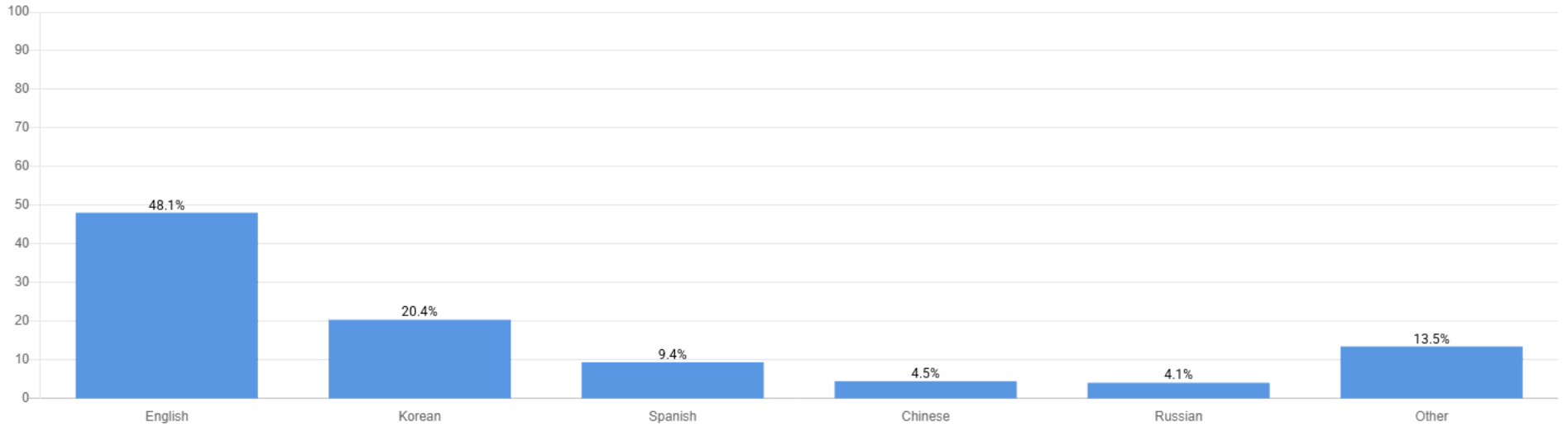

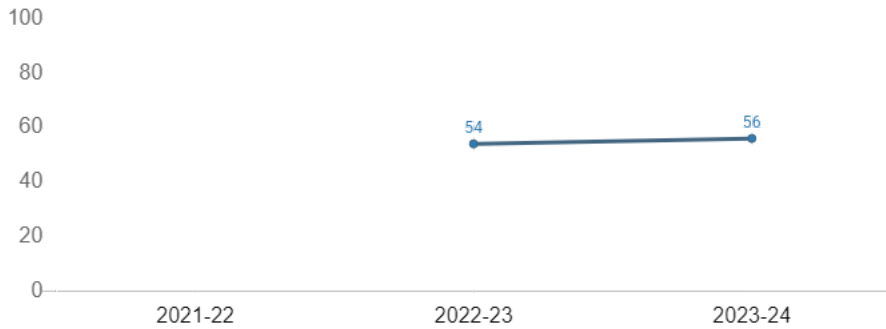

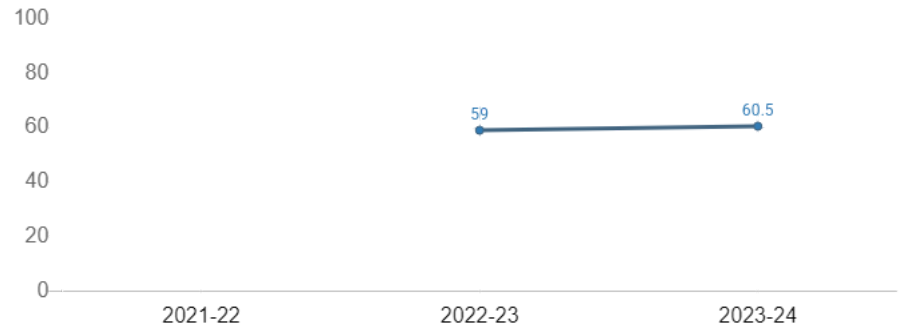

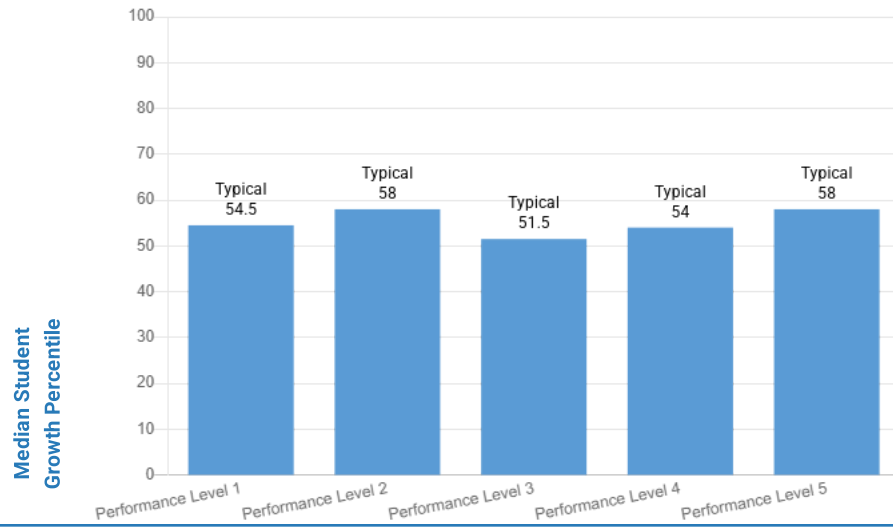

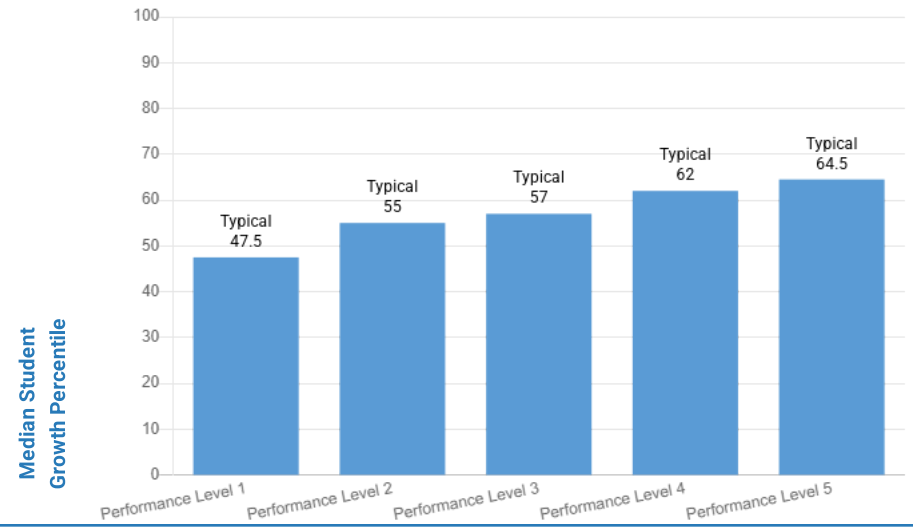

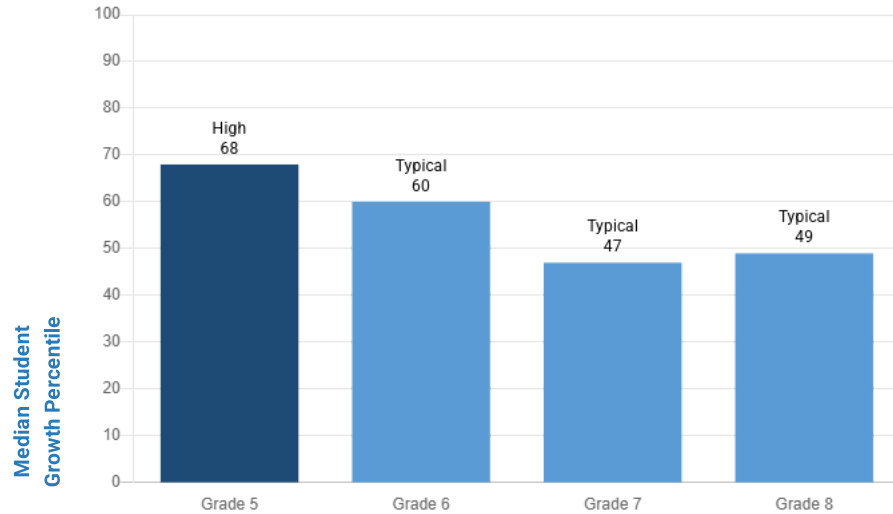

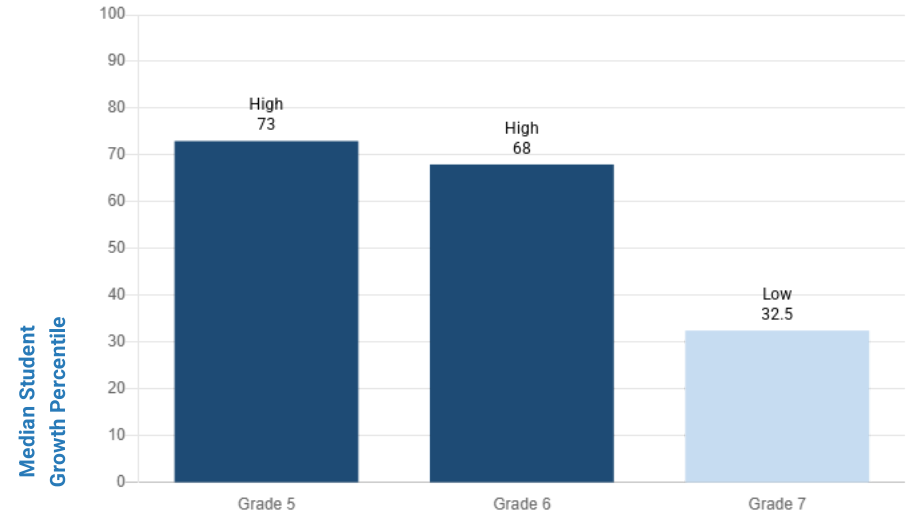

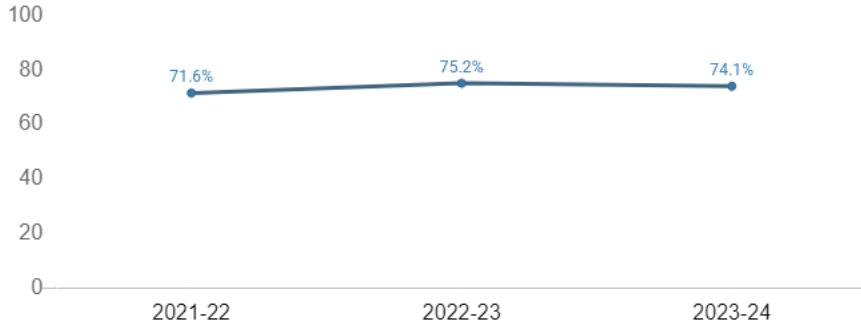

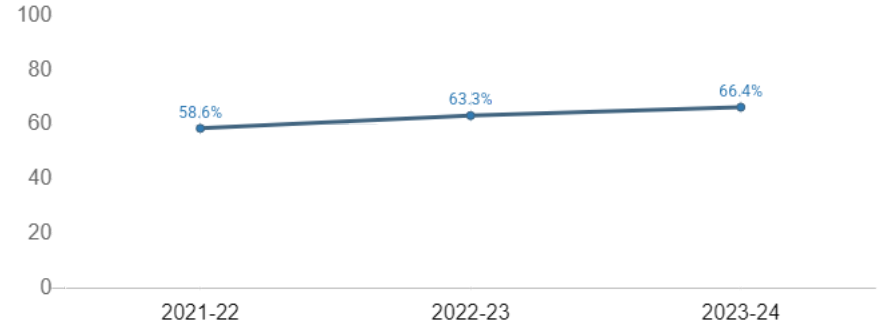
English Language Arts and Mathematics Performance Trends

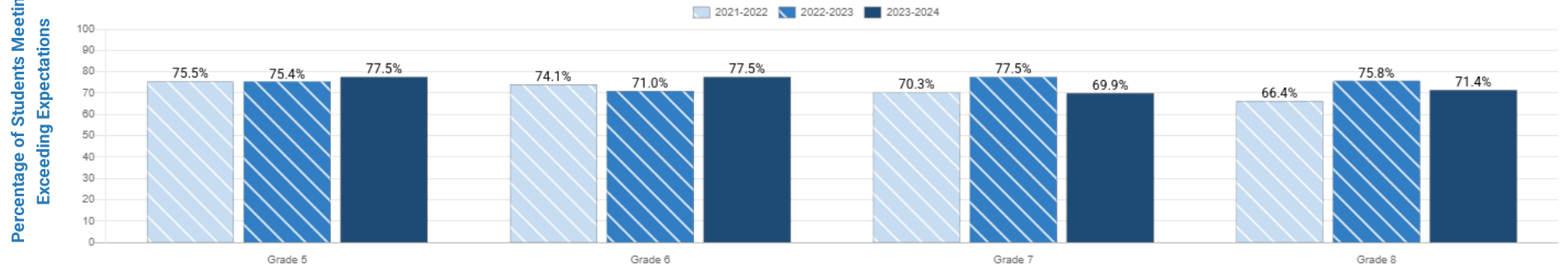

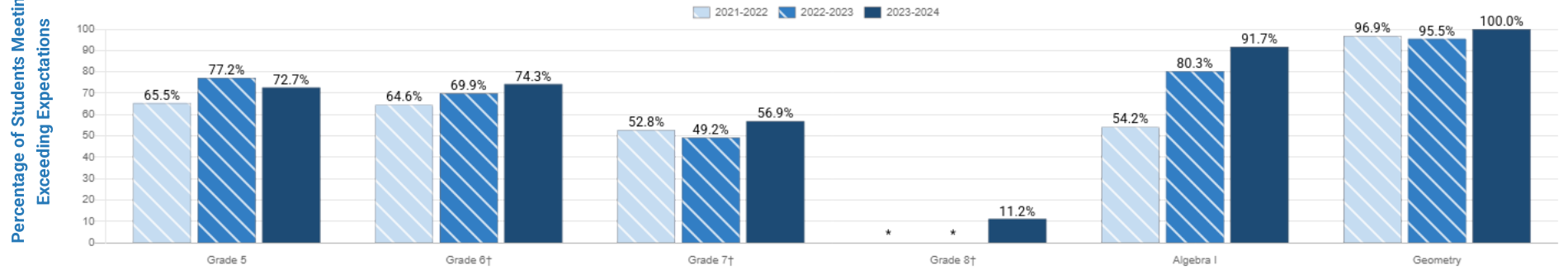

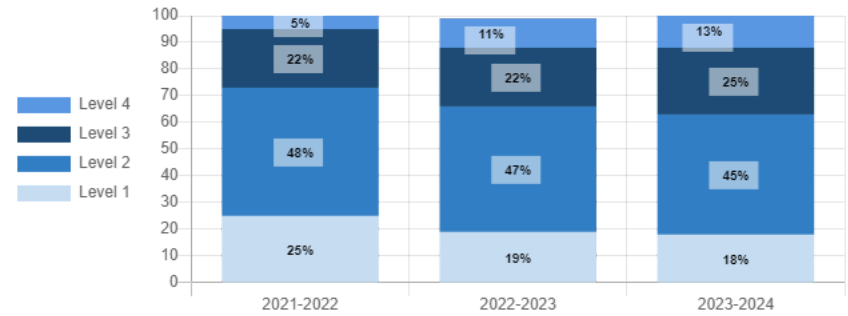

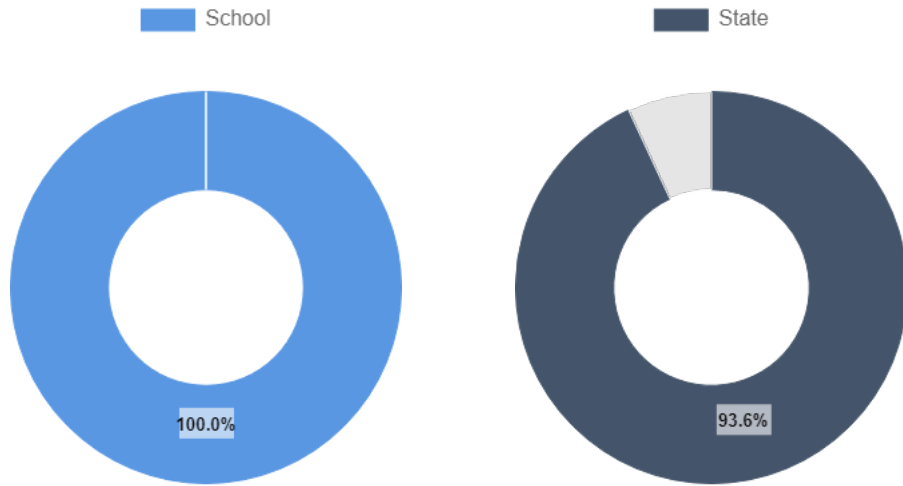

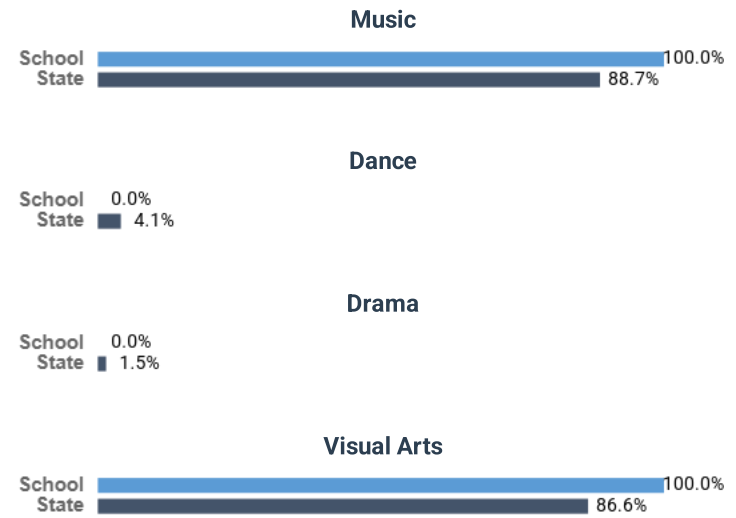

Students enrolled in one or more classes by discipline:



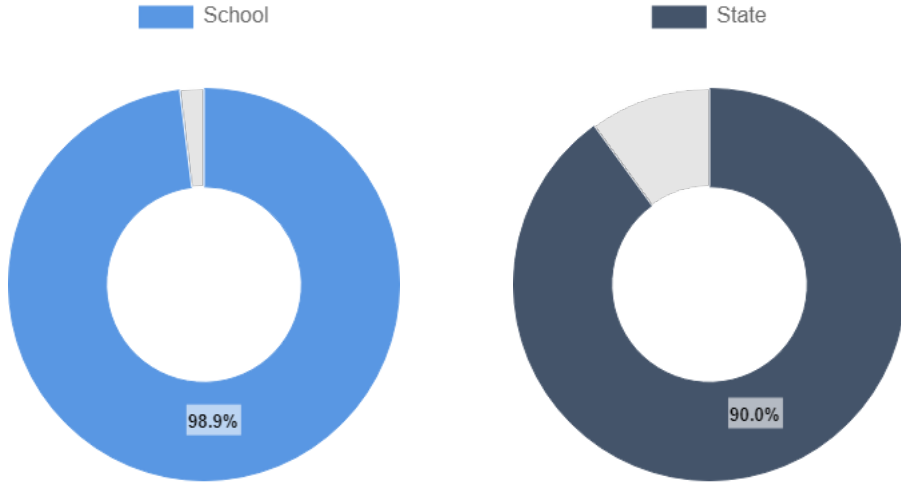

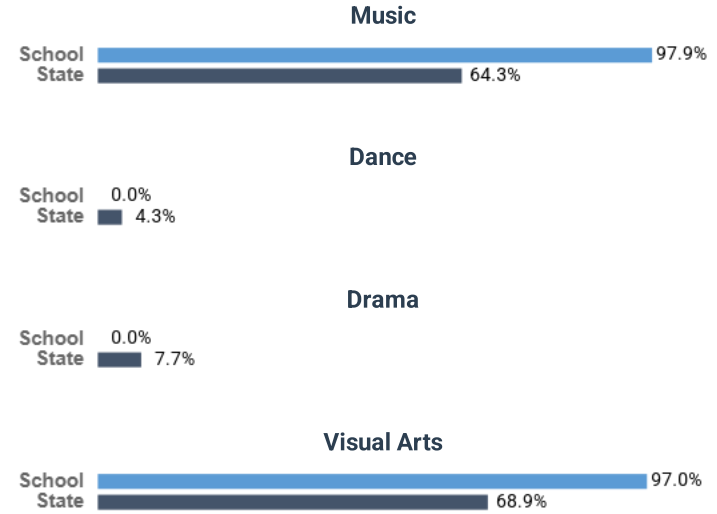

Students enrolled in one or more classes by discipline:



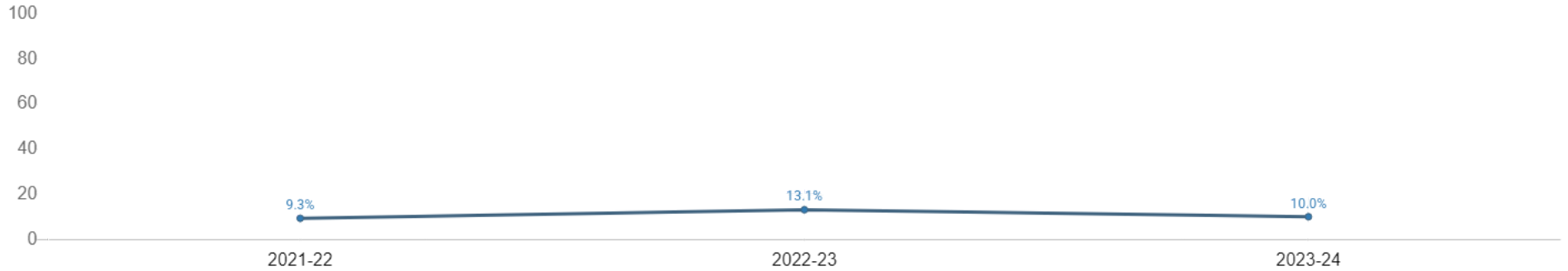

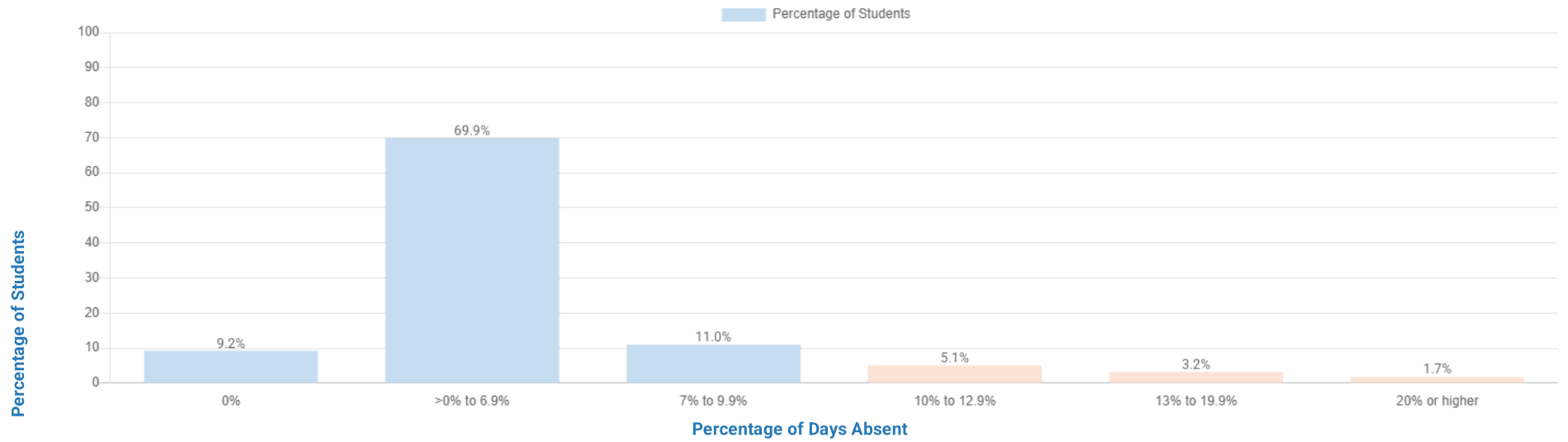

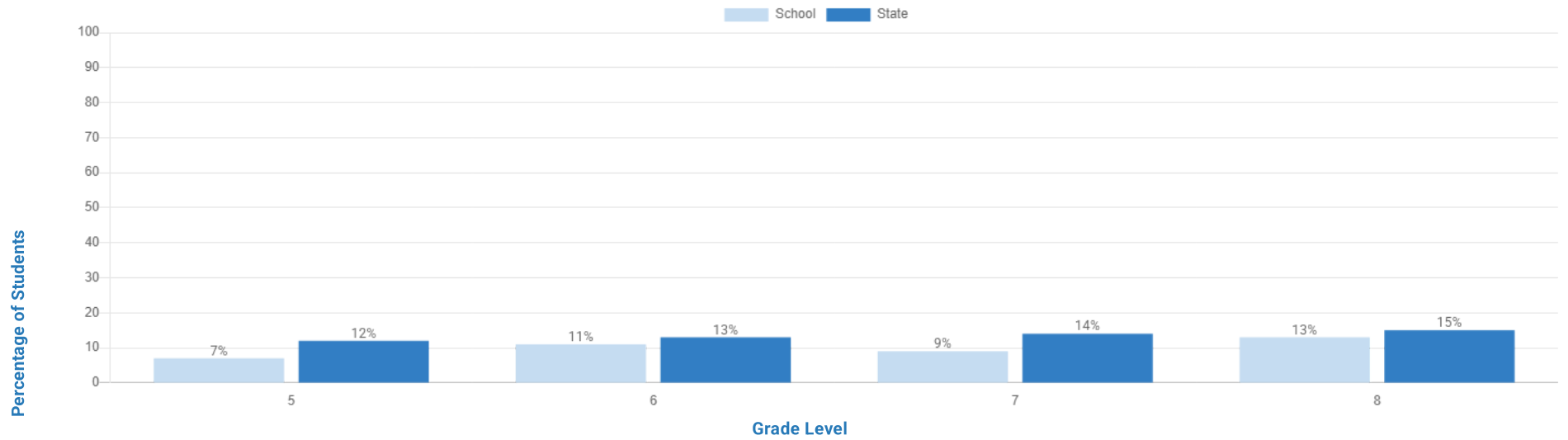

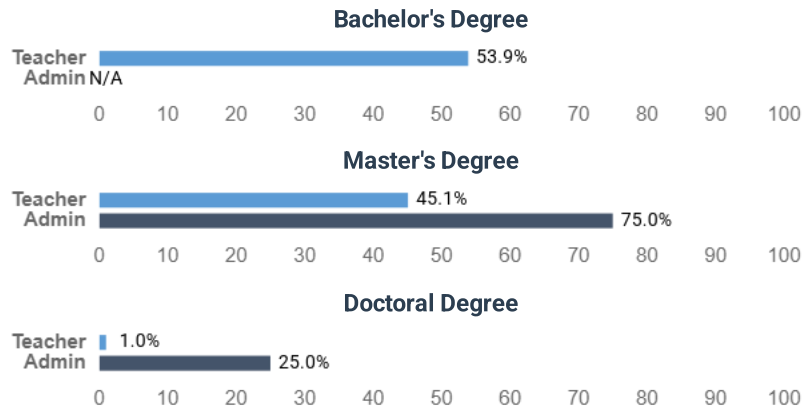

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Highlights:

- The Lewis F. Cole Intermediate and Middle School campus services a total of approximately 1200 students in grades 5 through 8. The combined staff total is approximately 180.
- Intermediate and Middle School students engage in character education through the Wingman initiative, fostering mentorship. Plans are underway to expand visits to elementary schools in 2024-2025.
- Our Student Ambassador Team completed 300+ community service hours last year, excelling in supporting Multiple Disability students during Unified Arts classes.



Awards, Recognition, Accomplishments:

Sixth grade Gifted and Talented (G&T) students contributed to the Lewis F. Cole Intermediate School time capsule, a project initiated during the 2020-2021 school year but delayed by the Covid pandemic. In 2021-2022, fifth graders collected artifacts and wrote letters, while in 2022-2023, sixth graders kept a weeklong journal. By 2023-2024, fifth graders explored landscape design, calculating plantable areas and creating proposals and budgets to beautify the circle. Seventh graders, pioneers of the project, participated in the 2023-2024 ceremony. Additionally, Intermedia, the Lewis F. Cole Middle School art and literary publication, marked its 51st anniversary in 2023. We are now awaiting judging results from the Columbia Scholastic Press Association (CSPA), which evaluates publications the year after release.



Clubs and Activities:

We offer 25 extra-curricular clubs and activities to develop well-rounded students. These programs include opportunities for community service, character education, the arts and leadership development. Programs span from grades 5-8 and are highly encouraged to develop peer relationships outside of the classrooms. The Intermediate School added Chess, STEAM, and Media/Communications as clubs.
