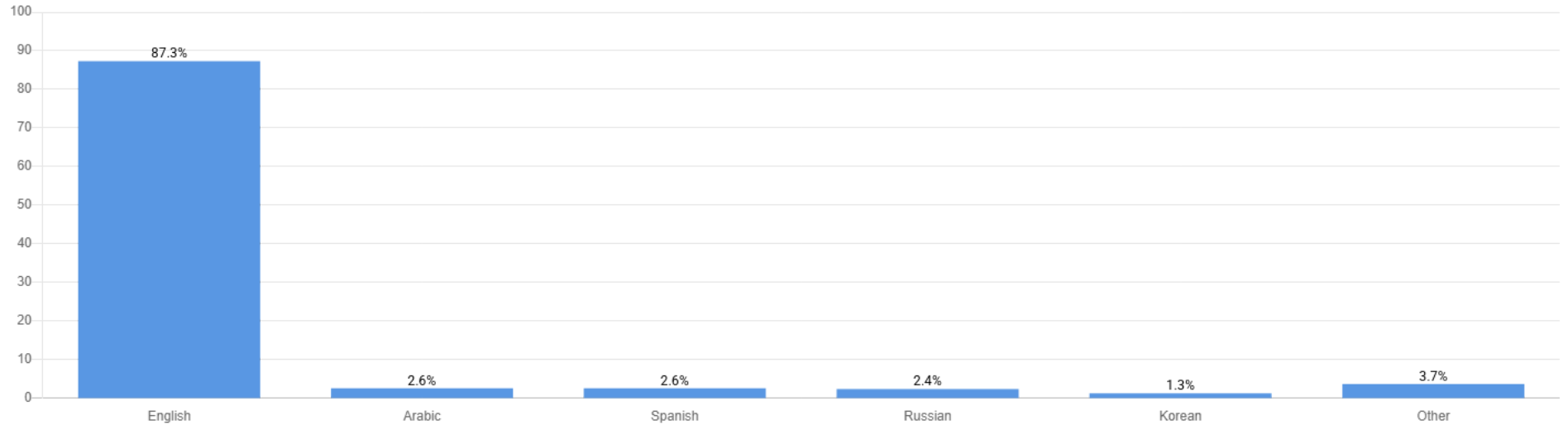

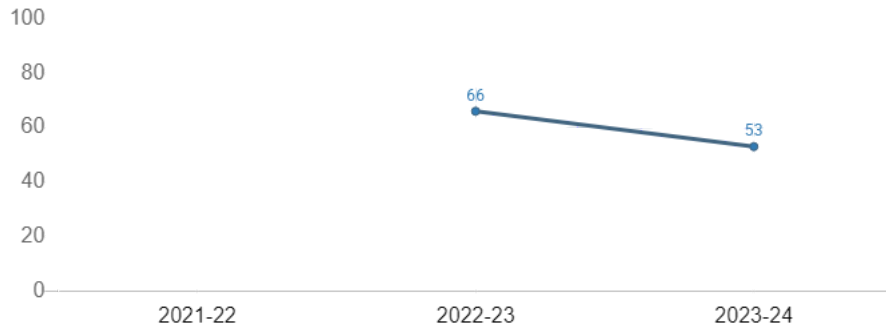

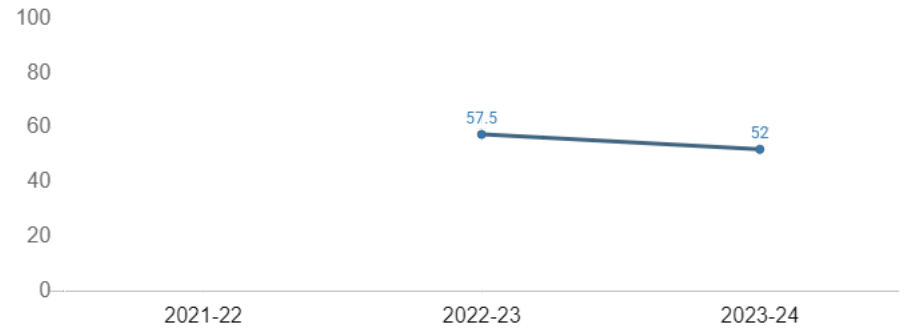

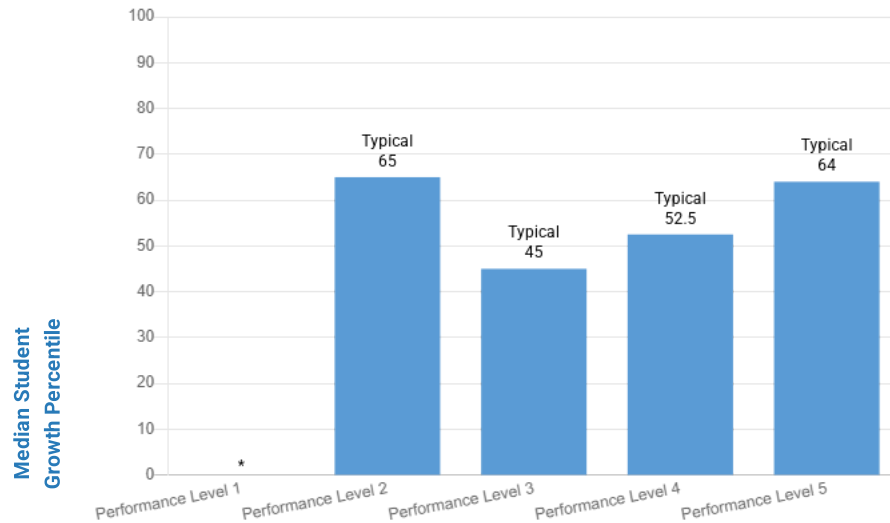

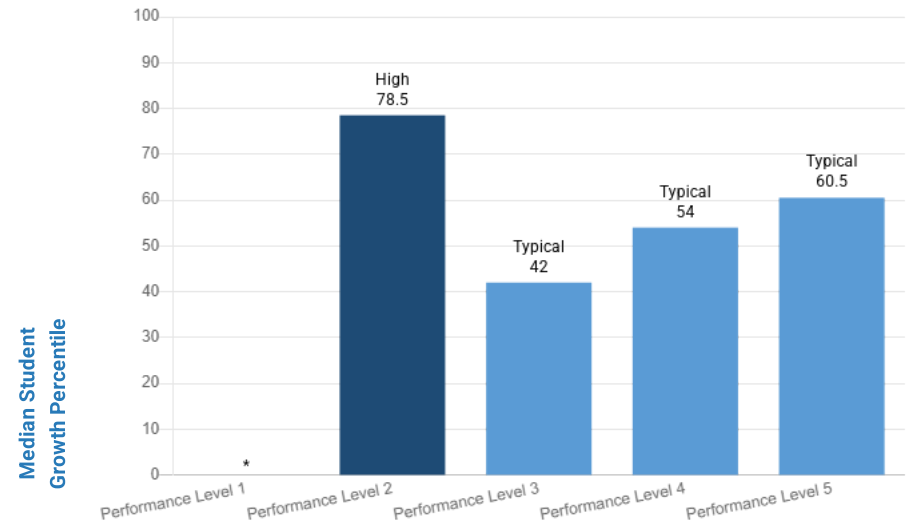

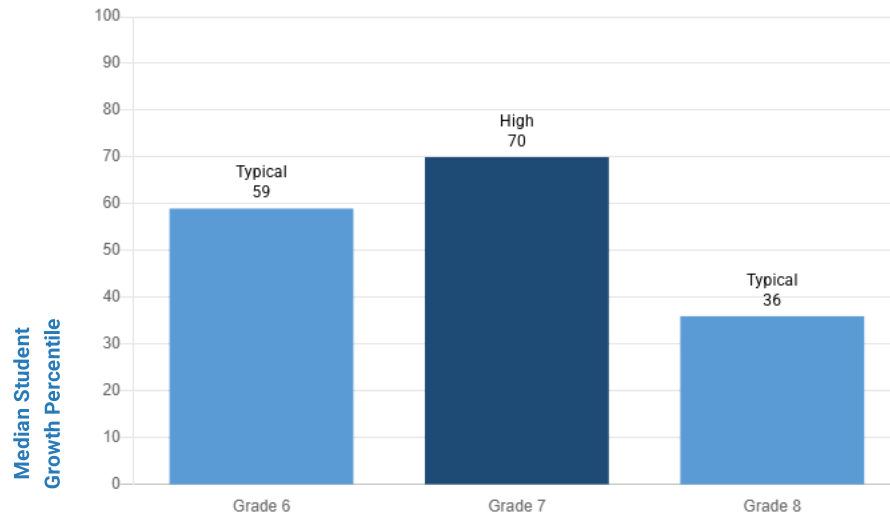

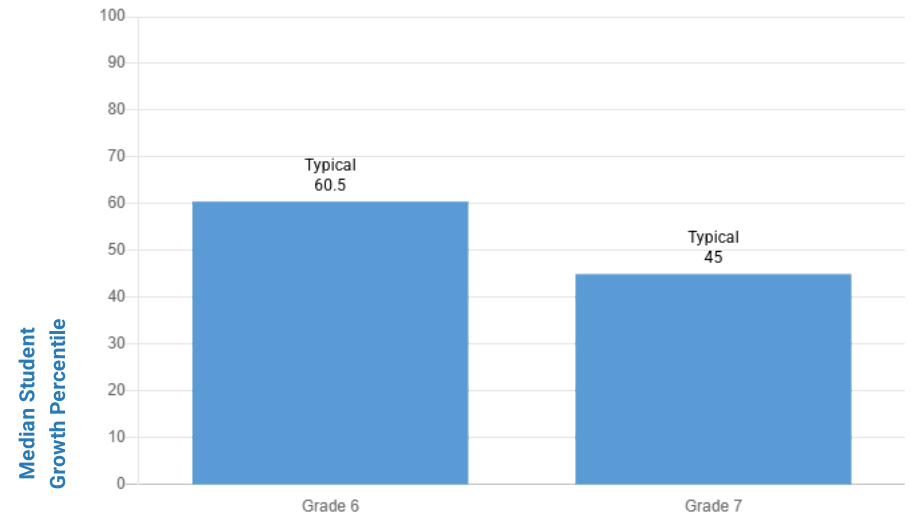

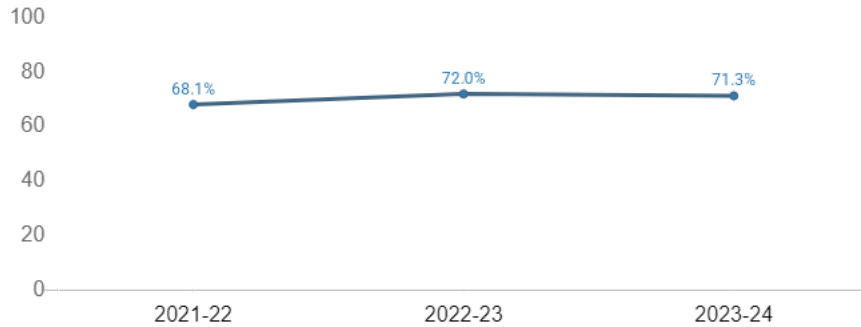

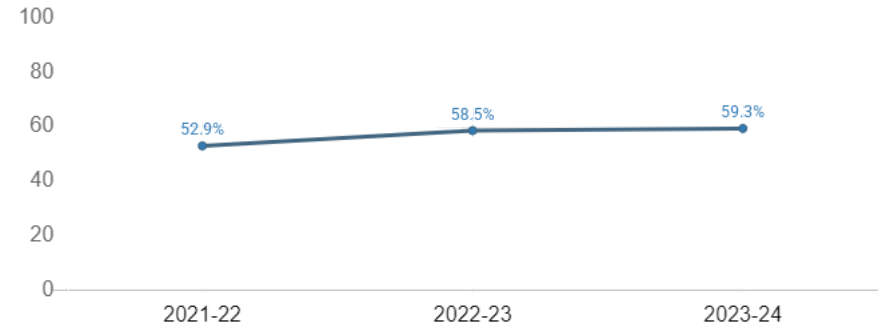
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 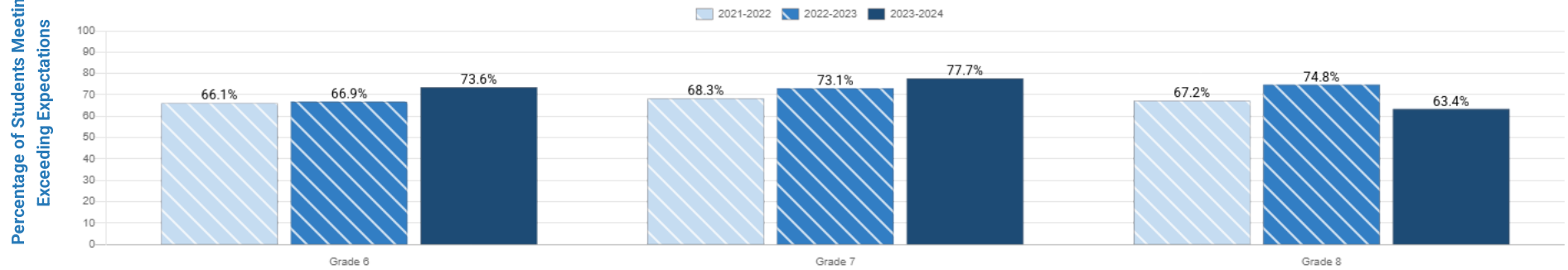

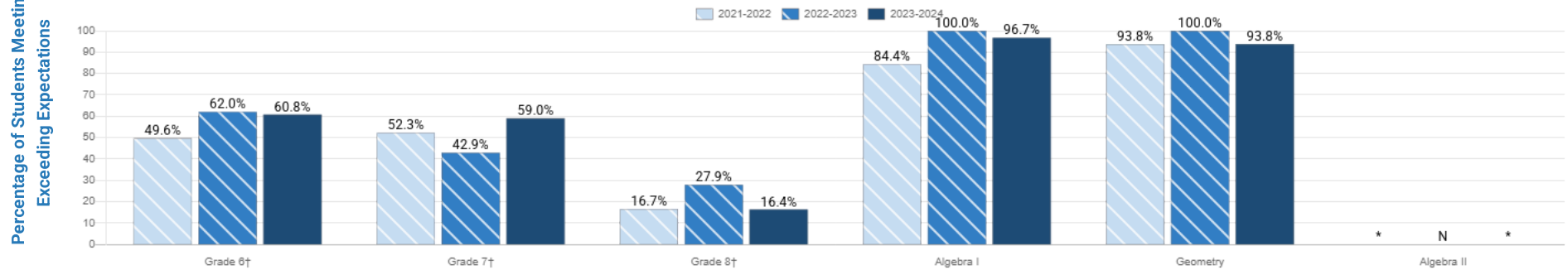

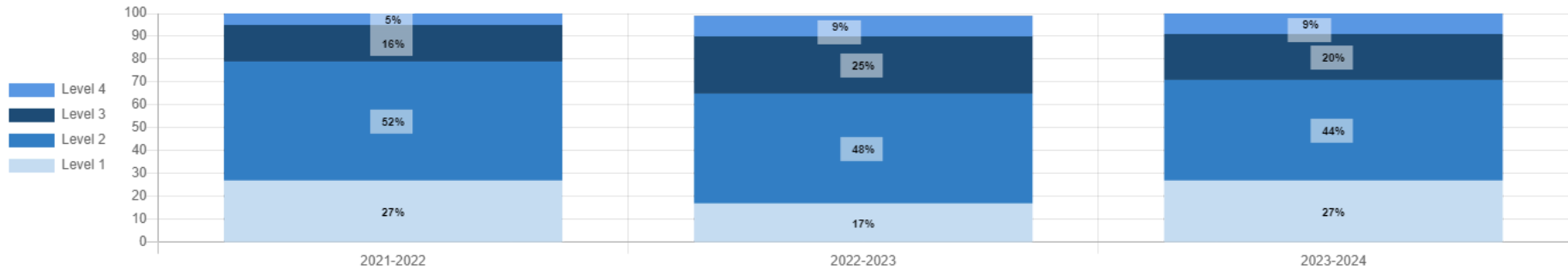

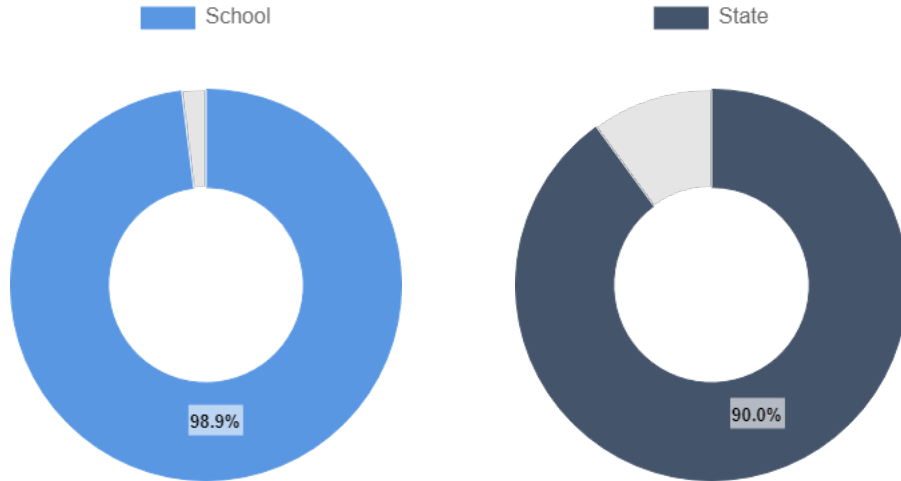

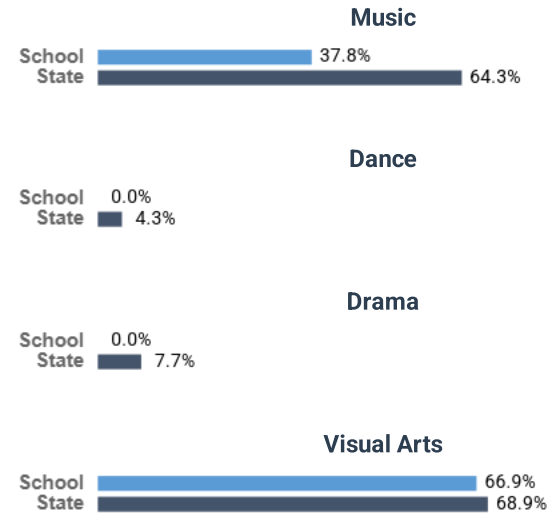

Students enrolled in one or more classes by discipline:



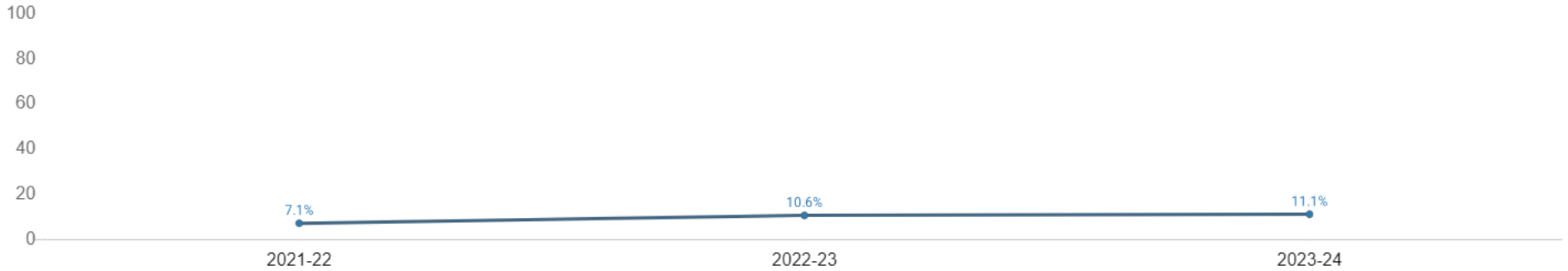

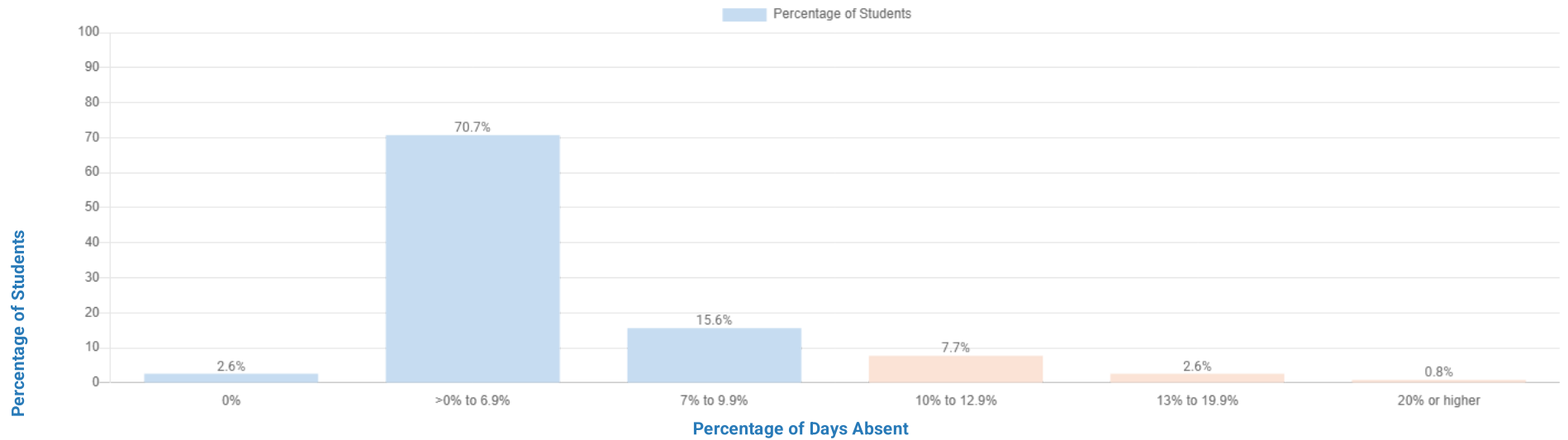

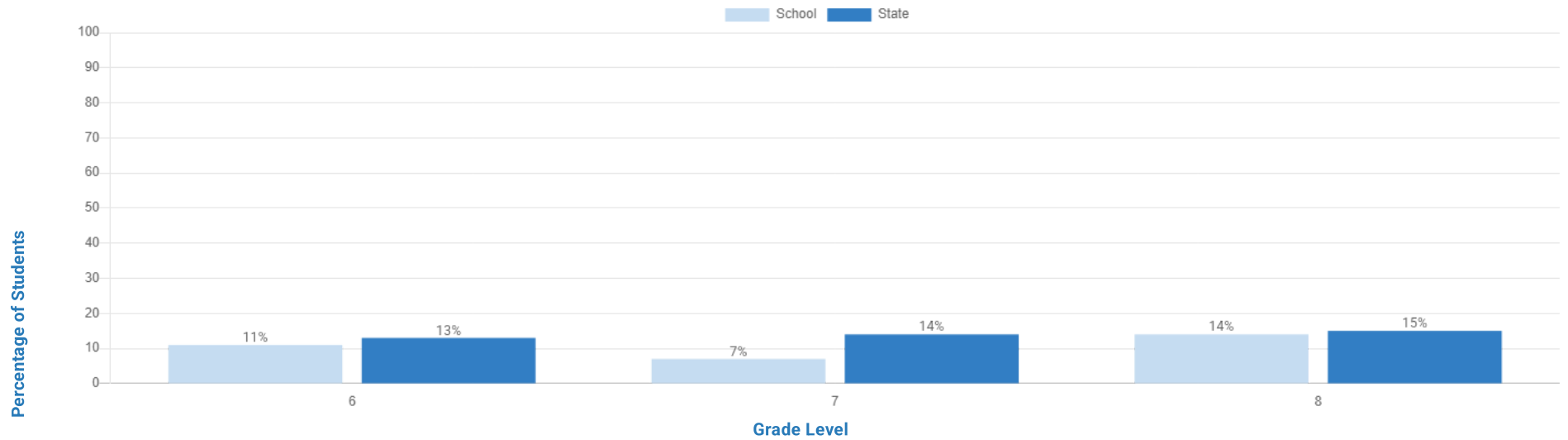

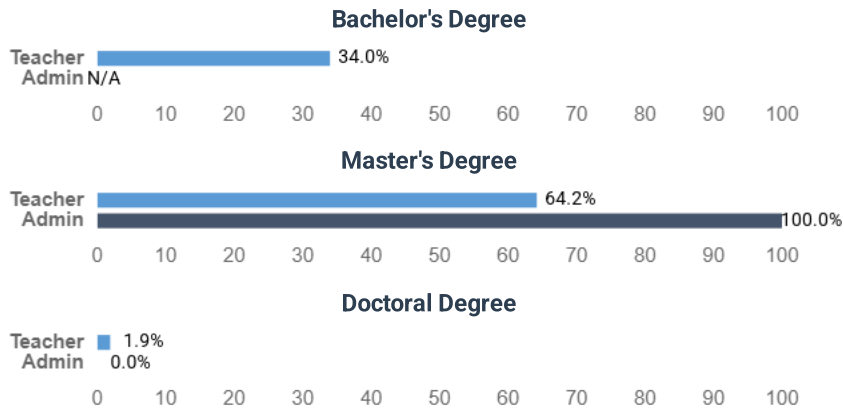

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Staff and Professional Learning:

Recognizing the importance of job-embedded professional learning for educators and staff, the district proudly employs one instructional coach per school to serve as an on-site professional support. We support our staff in growing and sharing expertise beyond the boundaries of the District, and proudly boast recent presentations at county, state, and national conferences including: AMLE, Character.org, NJASA, TechSpo, NJECC, AMTNJ, and NJAGC. In-service days and Professional Learning Communities are regularly occurring opportunities within the school calendar that provide opportunities to collaborate and learn with colleagues. Additionally, our faculty is encouraged to attend out-of-District workshops and conferences programs as appropriate.



Student Supports and Services:

In conjunction with differentiated classroom instruction, the District provides tiered academic intervention services throughout grades Kindergarten to 8th grade to support students' academic growth. Students who invited to participate in these programs are progress monitored on a regular basis and exit services as soon as performance is determined to be meeting grade-level expectations. The district employs two ESL teachers to support the needs of Multilingual Learners. Several programs support students with disabilities: in-class supplemental/replacement instruction is provided at all schools in Reading and Writing, Mathematics, Science, and SS throughout all schools. Additionally, self-contained programs are housed at each of our schools: CAPS (CRS), Bridges (WAS), Bright Horizons preschool (HMRS), and the Pathways program (FAMS) which provide students with access to specialized educators, other certified staff, and services to meet individual needs.



Student Health and Wellness:

We provide a healthy educational environment that fosters sound bodies, sound spirits, and sound minds. Speech, physical/occupational therapy, behavioral and counseling support are provided. Physical ed classes, daily recess, and daily movement opportunities support physical activity goals. A Character Education program is employed throughout the District.

The Franklin Avenue Middle School houses grades 6-8. Built in 1954, the facility was renovated and enhanced in 1981, 1995, and 2002. Currently the building is being updated with a new roof, HVAC, and window projects. Approximately 85,000 square feet in size, the two-story building is air-conditioned and handicapped accessible, including an elevator. Features include a STEM lab, a TV studio, computer labs, and outdoor garden classroom.

School Safety:

The District supports school safety by employing two full-time School Resource Officers. Additionally, the District participates in regional shared services with the FLOW district (Wyckoff, Oakland, and Franklin Lakes K-8) and the Ramapo/IHHS high school district. The group collectively employs a FLOW School Security Coordinator to assess security procedures and provide training and consultation. Each school conducts regular safety drills of various types. All schools in the District are equipped with video surveillance and double-entry security systems. All staff use the SHARE 911 system for communication during drills or real-life events.



Technology and STEM:

Teachers and administrators at the Franklin Lakes School District strongly support the continued integration of STEM teaching and learning to support students as life-long learners and 21st century citizens. STEM teaching supports ongoing development of creativity by encouraging students to apply 21st Century Skills such as collaboration, problem solving, critical thinking, creativity and innovation. All K-8 students are provided a 1:1 device and students begin learning to code as early as Kindergarten.
