





# Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, of if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

There is a current potential for students to earn 50+ college credits through dual enrollment with Bergen Community College and Farleigh Dickinson University. We also offer 7 AP classes in the subjects of Calculus, Computer Science, Literature & Composition, Language & Composition, Biology, US History, and Spanish, with student participation and matriculation increasing every year. A CTE program including Drafting & Design Technology/Technician was also officially introduced. Additional courses added recently include Accounting, Latin American Studies, Adventures in Graphic Novels, and First Aid.

Our Garfield Athletic Hall of Fame is very active and each year the committee comes together to acknowledge the accomplishments of past teams and alumni.

The Extended Day Program offers tutoring by GHS teachers for all students in the major subject areas before and after school. We also have teacher-lead Extended Year Programs for all ESL students and qualifying students with disabilities. In addition, Summer College Prep classes are made available to students enrolling in AP and dual enrollment classes. Finally, GHS has implemented a Mentoring Program for at-risk students who meet regularly with a mentor teacher.



For the past two decades, Garfield has partnered with Saint Peter?s University to offer advanced degree programs, enabling a plethora of teachers to earn Masters degrees. We also have teachers who are currently enrolled in the Doctoral program. By attaining these advanced degrees in content, some are then able to become onsite adjunct professors. To further attain excellence in their fields, teachers also meet with their academic departments or course-level colleagues during daily planning time for professional learning and collaboration. This attention to continued education begins upon hiring as the Garfield School District Mentoring Program recognizes the need to provide quality, research-based professional development in the areas of effective teaching practices, facilitating, student achievement, and maintaining a standard of excellence in teaching throughout. Addedly, the district is committed to promoting growth for all instructional and support staff.



Garfield High School offers Financial Aid Night, College Fairs, access to Career Cruising, and hosts numerous college campus and representative visits. All students in grades 10-11 take the PSATs. Over 70% of graduates are accepted to colleges both in-state and out of state, while 15% enter the work force, 8% attend technical schools, and 4% join the armed forces.

# **Student Supports and Services:**

In the 2019-2021 school year, the Garfield School District introduced an RTI/IR&S program to cater to at-risk students, aiming for a personalized educational approach. The focus is on addressing individual needs, providing a foundation, and resources to overcome challenges, fostering personal growth. Notably, in 2022-2023, 29 seniors graduated successfully due to RTI interventions and supports. The initiative involves an intensive process, elevating students to appropriate growth levels for flexible learning. Additional programs include Student Youth Development (SYD) for behavioral concerns and School Safety Teams organizing activities and mediating student sessions. Recognizing evolving student needs, the district remains open to implementing or modifying programs for better service.



AT GHS, we believe social and emotional well-being is just as important as physical health. During the pandemic, we became especially mindful of students? mental health and following the NJDOE?s guidelines for SEL competencies, CASEL?s framework for SEL, and ASCA standards for school counseling programs. It is something we remain mindful of incorporating still. In addition, our school offers outside referrals/wraparound supports, mental health supports, mentoring, and SEL/counseling groups. We also encourage all staff to follow mindfulness practices with their classes.

Most notably, staff and students take a comprehensive online survey once a year. Through its implementation, it has shown that a vast majority of our school community respects and embraces diversity, that students are encouraged to think critically, and educational activities are modified to meet student learning needs. Information from every survey given is also analyzed by our school data team in order to make suggestions for general school improvement and development of new programs.



The main building of Garfield High School was constructed in 1955. Two major additions include a wing of classrooms in the 1960s and an additional gymnasium in 1980. Between 2012-2014, we completed major renovations in all of our science labs, auditorium, cafeteria, as well as our halls and lockers. In 2021, our auditorium had an updated sound and light system installed and finally initiatives of the art department complete projects throughout the year to update and beautify various aspects of the building as well. Our newly renovated media center opened in Fall 2023 along with our new athletic complex.



GHS has a staff of safety officers who assist with building wide safety and security and we utilize the Raptor Alert system. In addition, our school routinely practices a variety of drills so that safety procedures and protocols are understood by staff and students and in place for a range of situations. We also regularly work together with the Garfield Police Department and our School Safety Team in order to plan training and practice activities, as well as discuss any concerns.

**Technology and STEM:** 



We continue to offer coding classes (including AP Computer Science Principles), dual enrollment classes in engineering and design, as well as upper level science and mathematics courses. In general, all classrooms are equipped with Promethean Boards. Teachers also utilize different types of diverse and tech-based communication tools such as: Remind, Twitter, Socrative, RealTime Parent Portal, Teams, and many more. We have one computer lab, but most notably we have attained a 1-1 school-wide status, and we have updated our network infrastructure to support this initiative. In 2023, we have also begun to distribute new laptops to students. All of this has enabled the use of technology more seamlessly throughout students? educational experiences at GHS.

GHS has partnered with Bergen Community College to initiate the Early College Program where students can receive an Associate Degree in Professional Studies concurrently while earning their high school diploma. The Class of 2021 was our inaugural group attaining the AS degree, with 19 students graduating from the program last year in 2024. The cohorts for 2025, 2026, and 2027 include an additional 42 students.

The school follows an A/B schedule with 4 block classes per day, 80 minutes each. This structure permits each class ample time to utilize different types of learning activities within a class period, including labs, group work, and in-depth discussion. Attaining 1-1 status and utilizing Microsoft Teams as our district platform has also enabled further integration of technology across the board. Within the past 4 years, all of our academic curricula have been updated to reflect current learning standards and the number of dual enrollment classes has grown to 14, with total enrollment in these classes reaching over 600, and 200+ individual students taking one or more dual enrollment classes. For English Language Learners, GHS offers 4 levels of varied English classes as well as a Port of Entry Class. Additionally, ELL students receive additional supports in select core classes to further ease their transition and promote language acquisition.
