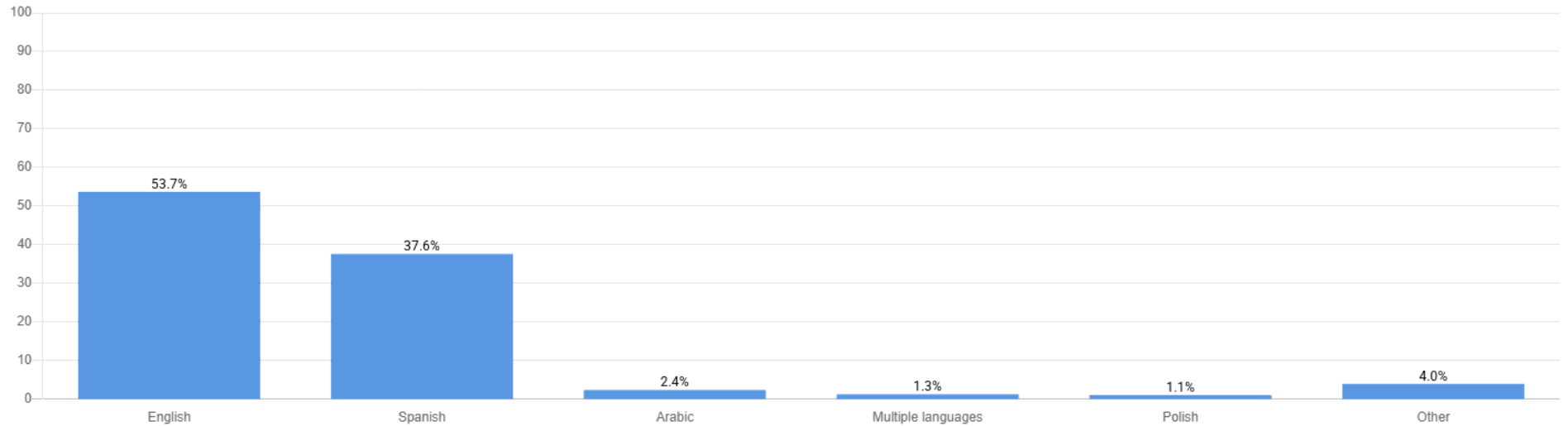

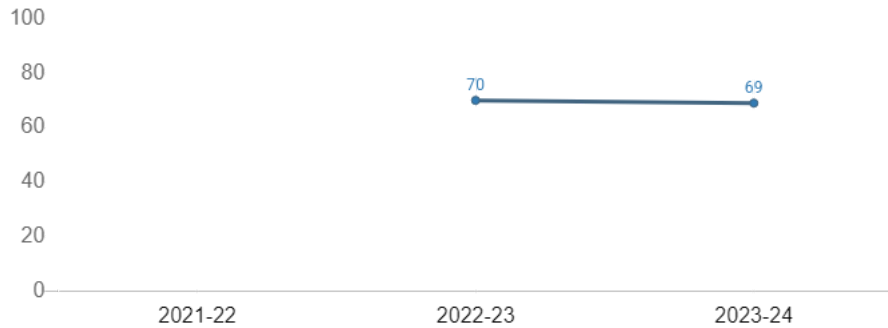

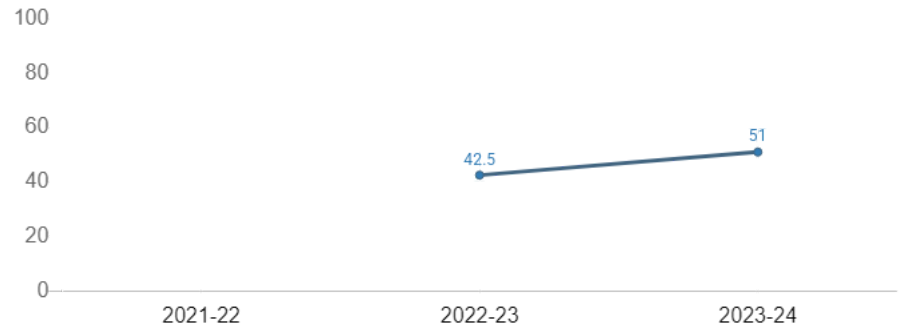

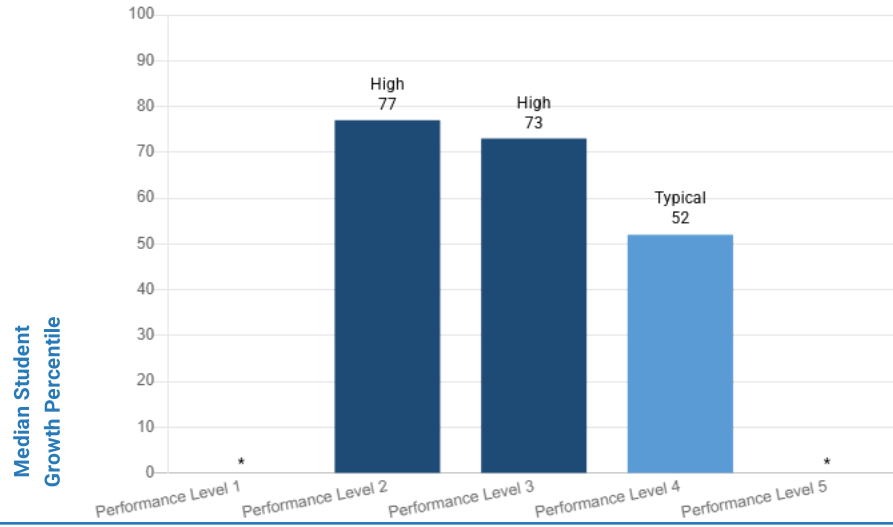

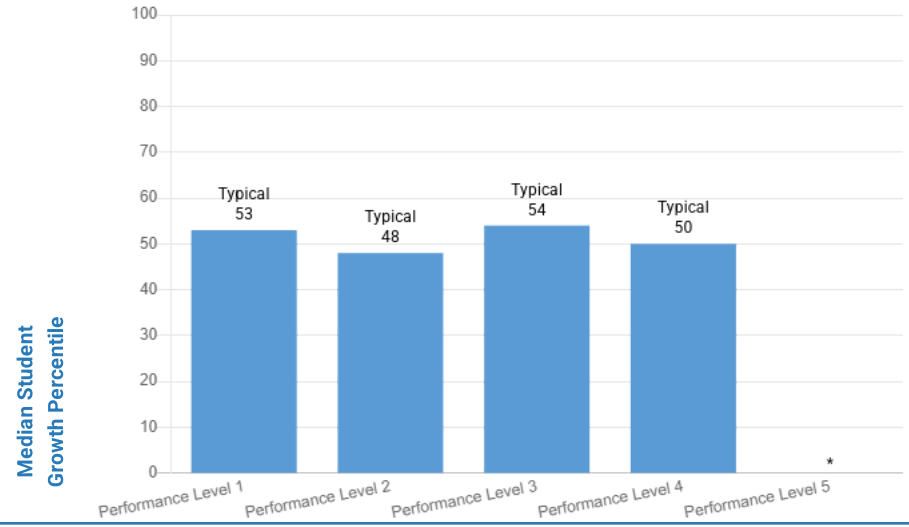

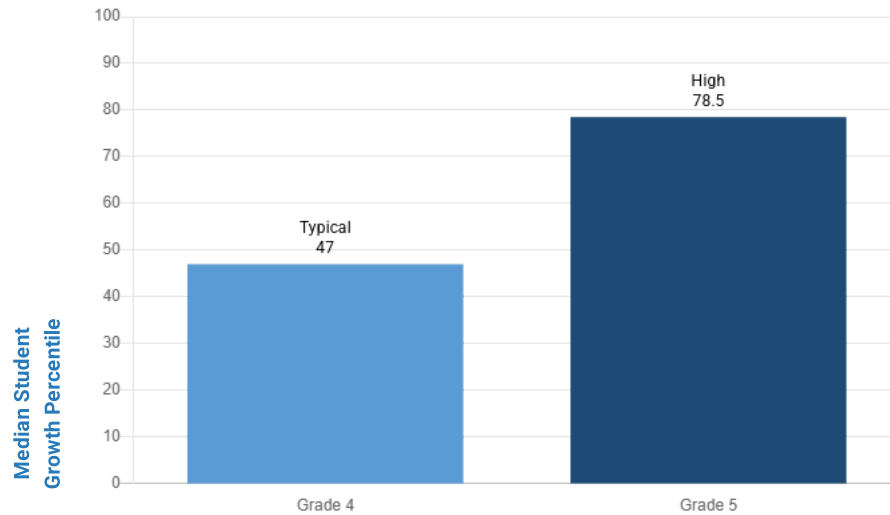

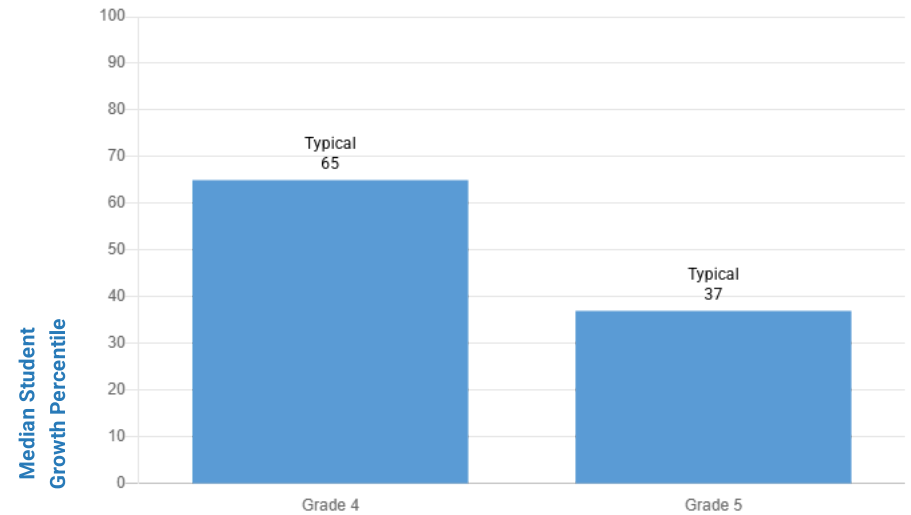

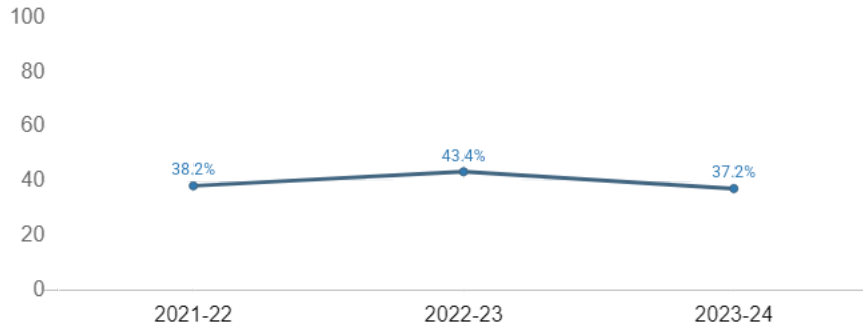

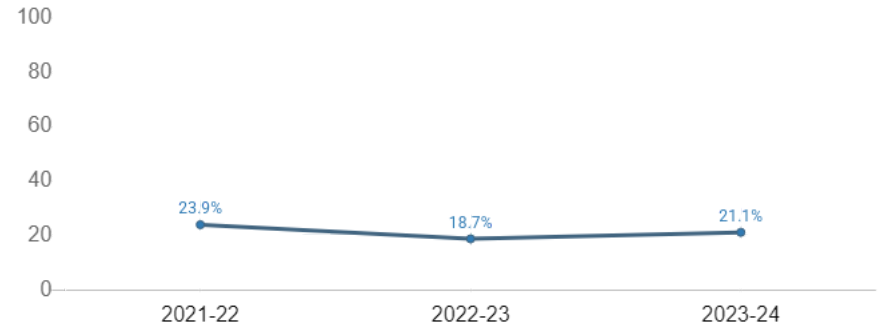
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 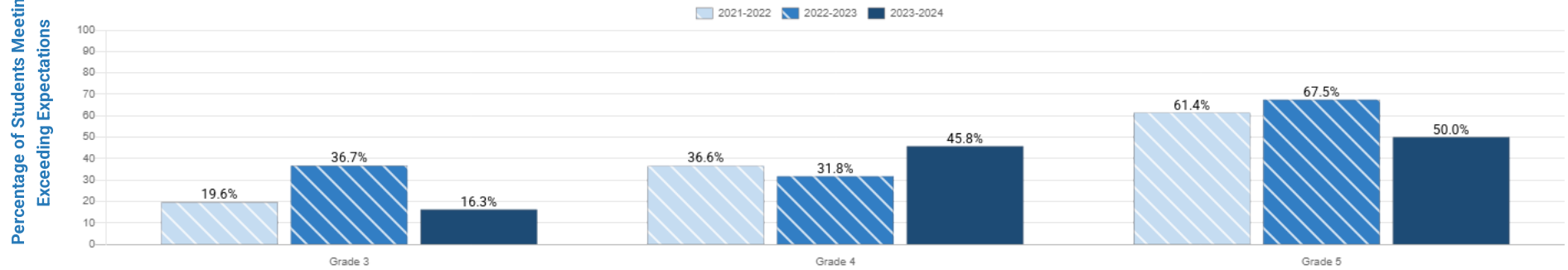

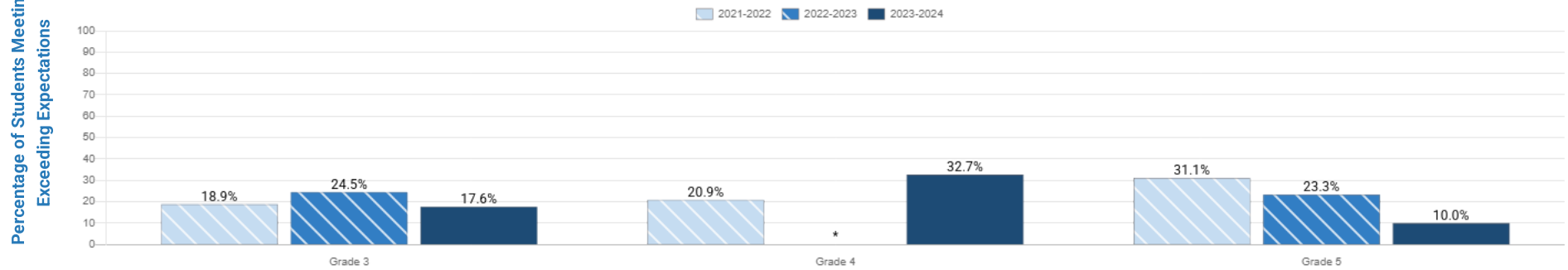

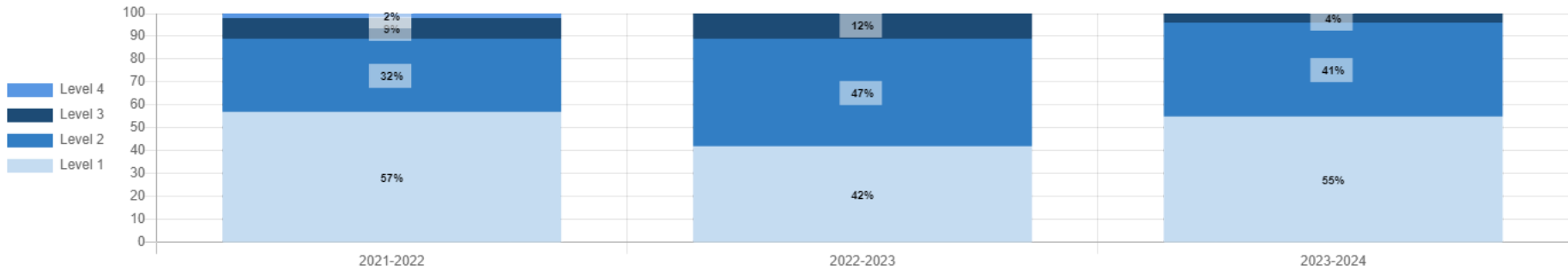

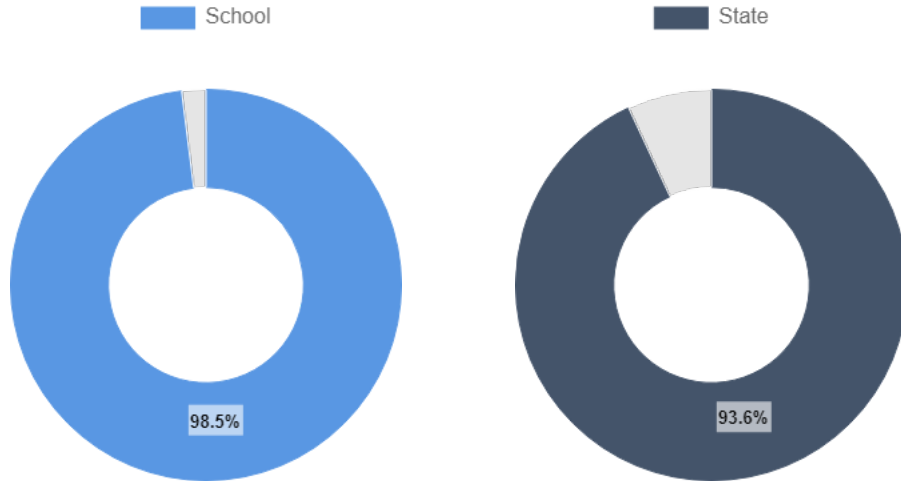

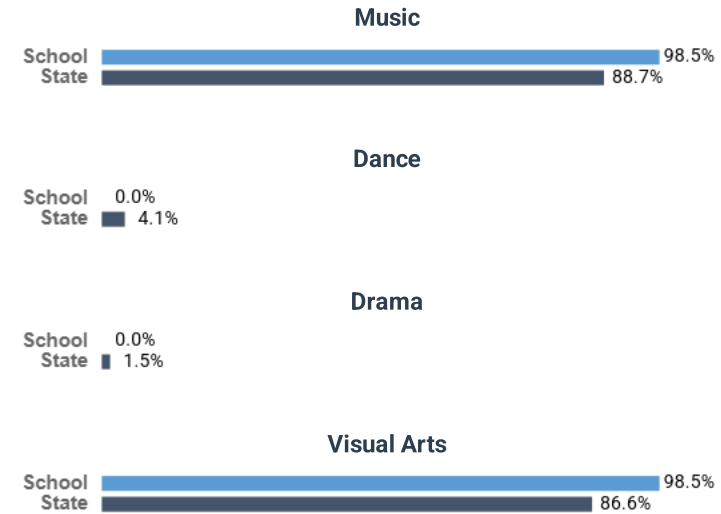

Students enrolled in one or more classes by discipline:



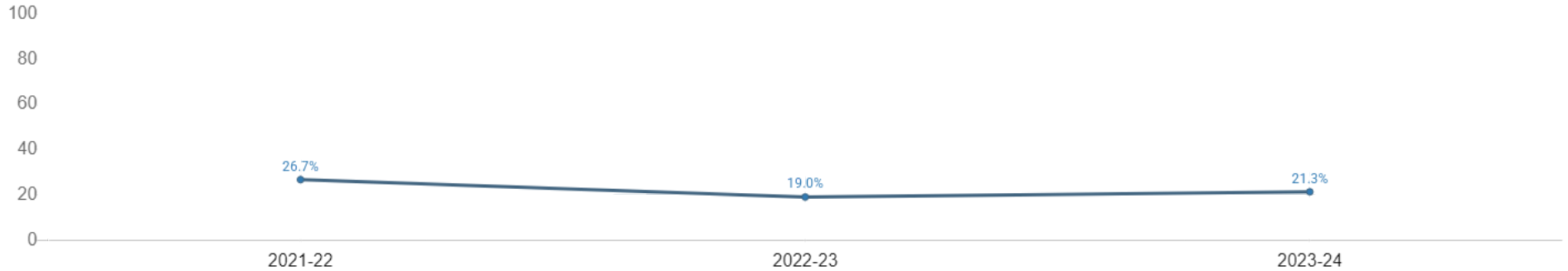

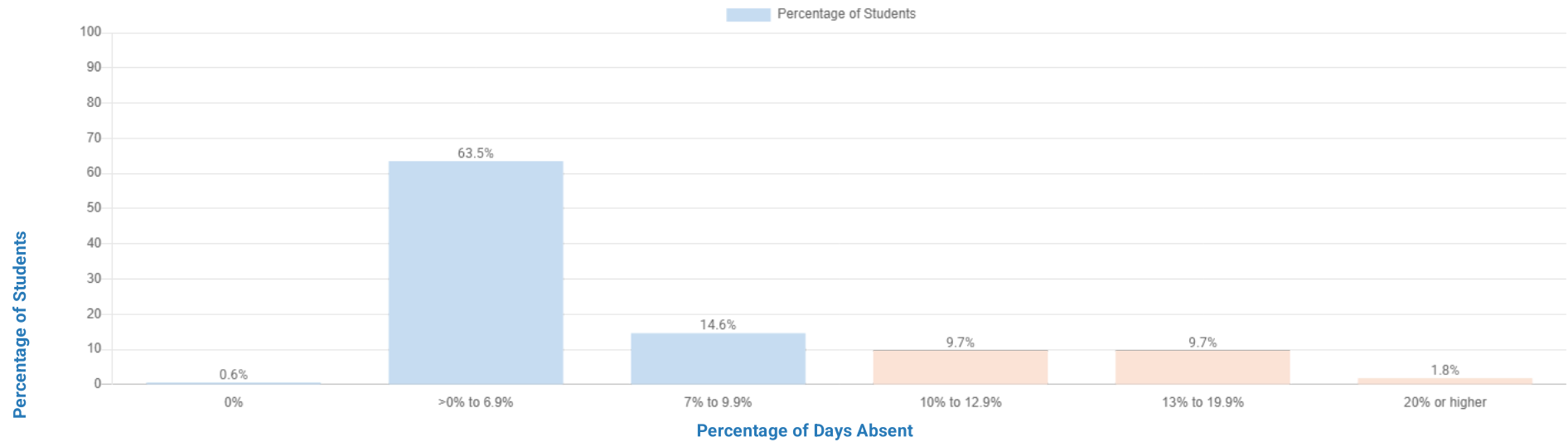

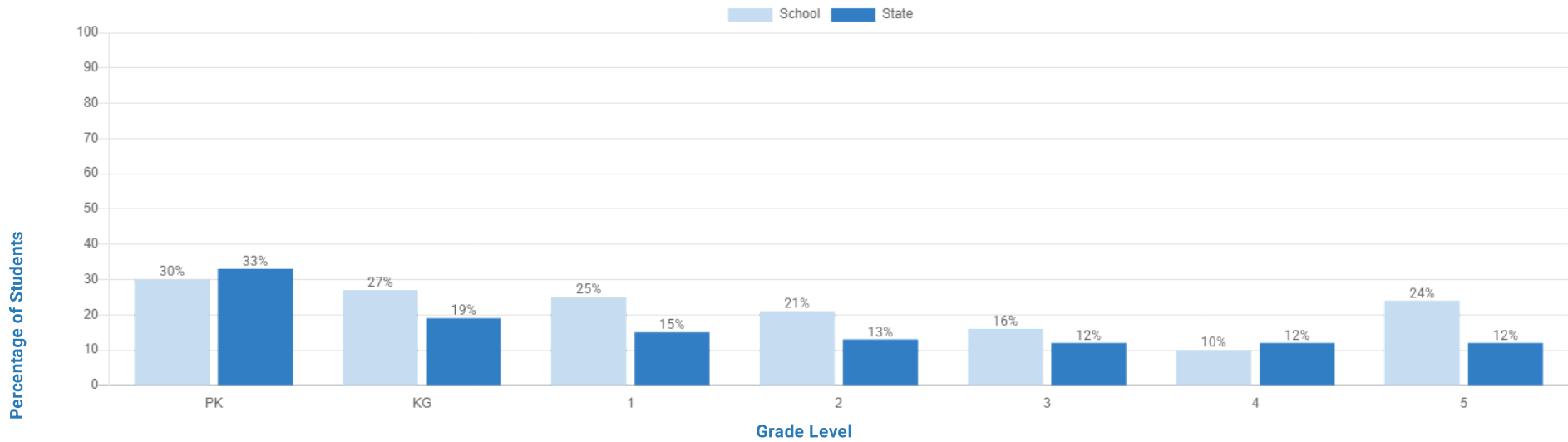

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

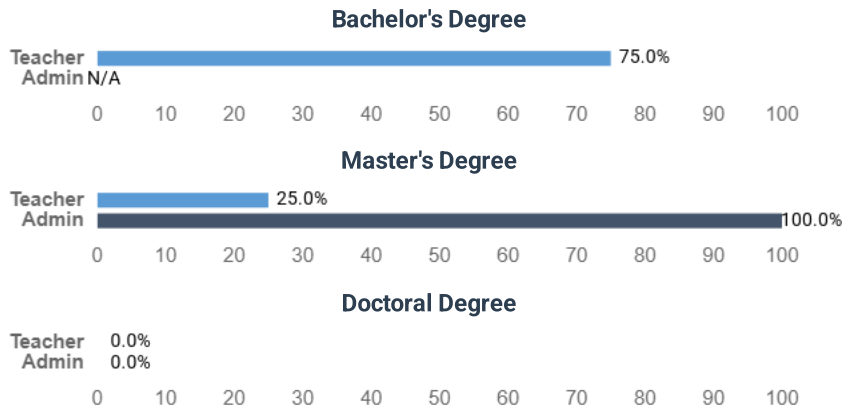

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. The school building is 100+ years old, mobile classrooms (8) are approximately 23 years old. As could be expected, we encounter facility/infrastructure issues on a somewhat regular basis.



School Safety:

Using school surveys that are conducted twice a year to a given population of students and to all parents and staff, the School Safety Team reviews the results for the changes to be addressed. Periodic meetings are held. The school is supported by an armed security guard, cameras on all entrances and in all hallways, and all doors remain locked from the exterior of the building. Ground & first level doors are now armed with alarms once school has begun to help improve school safety. Every classroom has a locked door and is identified by window stickers from the exterior. Staff has access to a district app for notification on Crisis Management, training on all drills is conducted yearly and 2 drills are run every month and supported by the district security team.



Technology and STEM:

We have a full service STEM/computer lab with a 3d printer and space for 25 students in this newly renovated STEM labs. All students in grades K-5 have 1-1 technology initiative and students are permitted to use devices at home as well. The STEAM classes worked this year to enhance their instruction of coding and project based learning STEAM.
