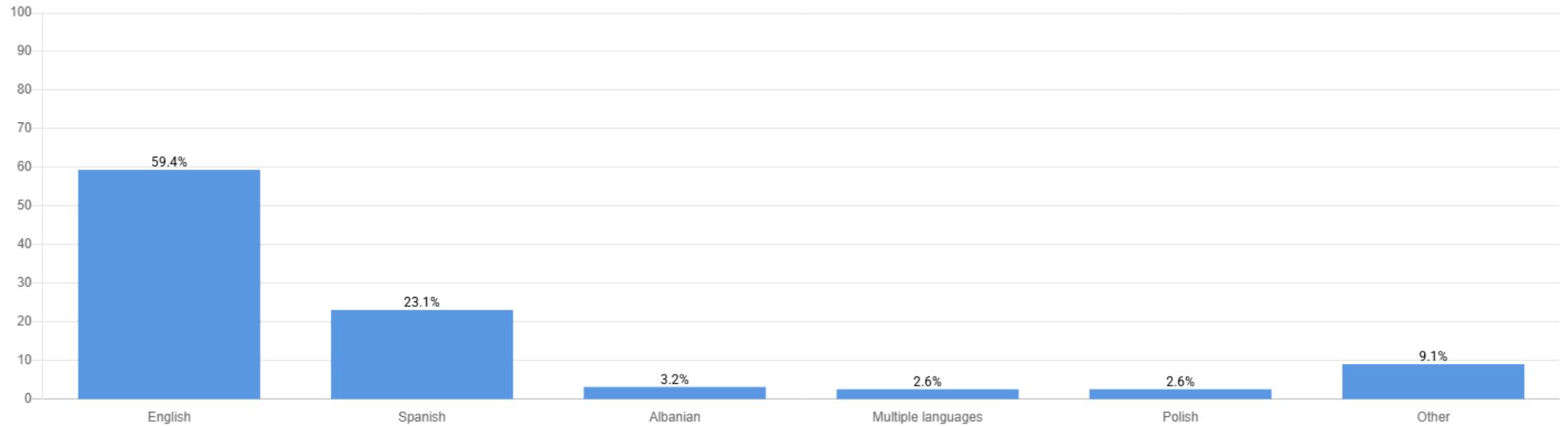

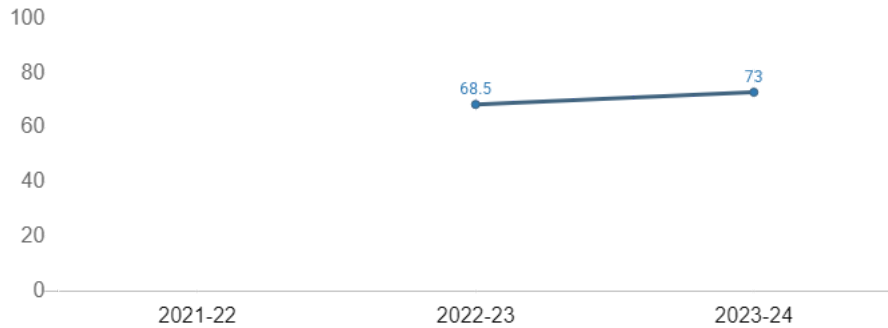

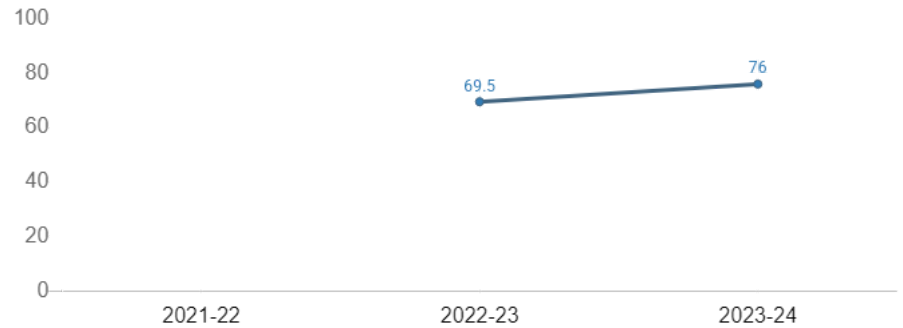

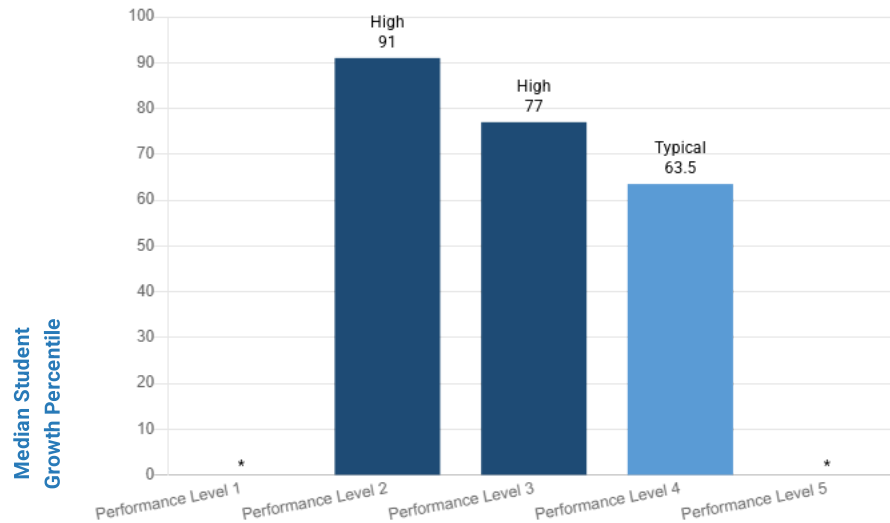

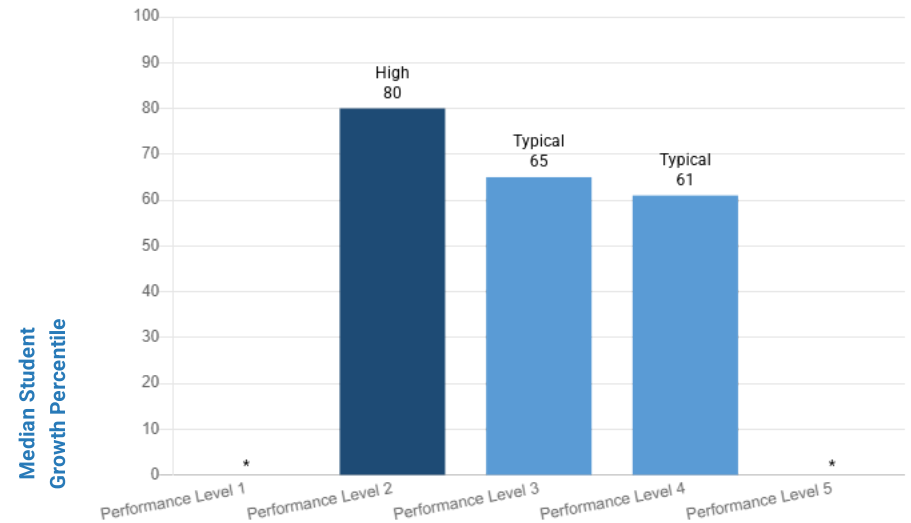

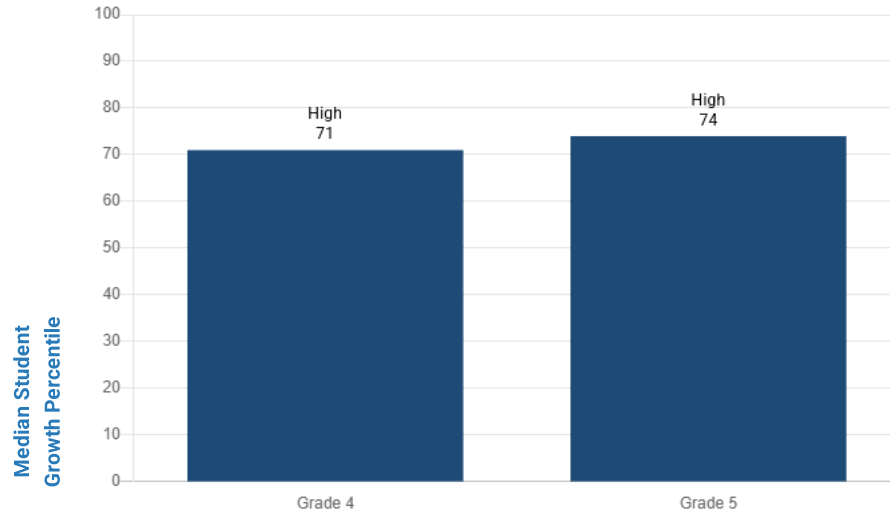

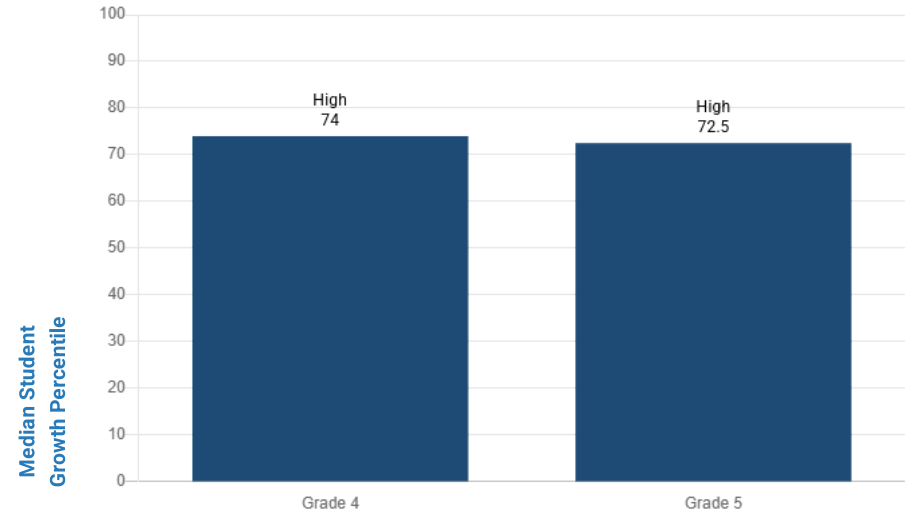

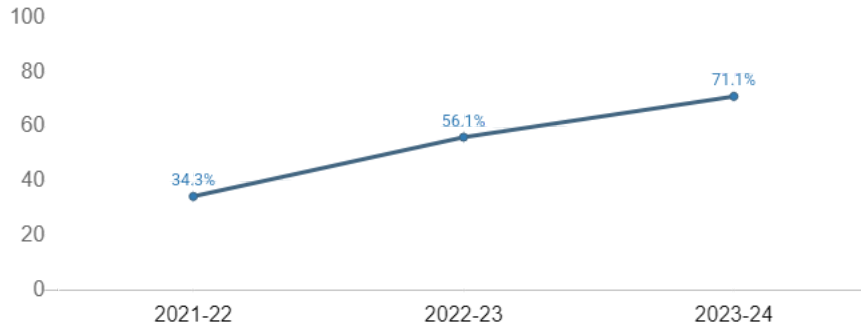

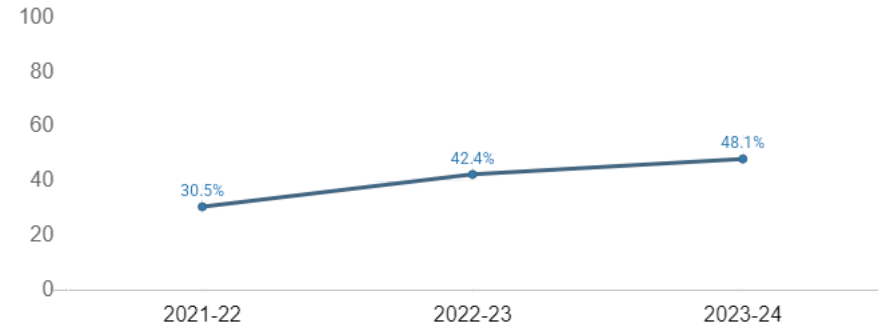
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 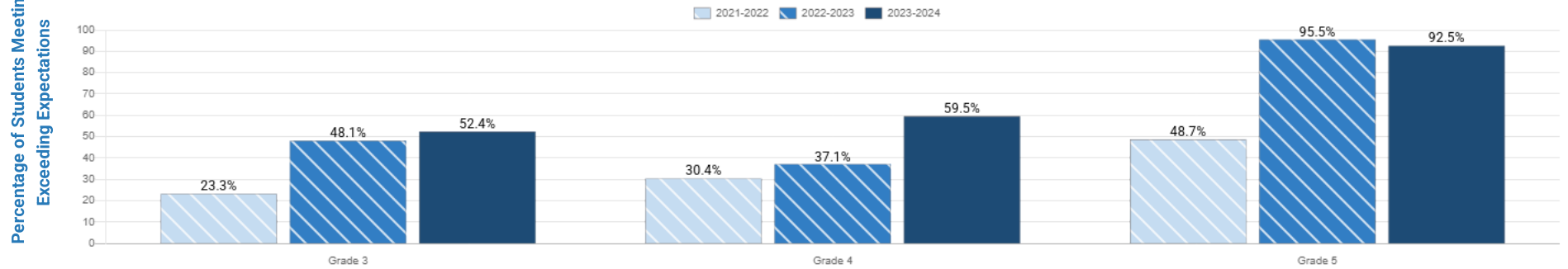

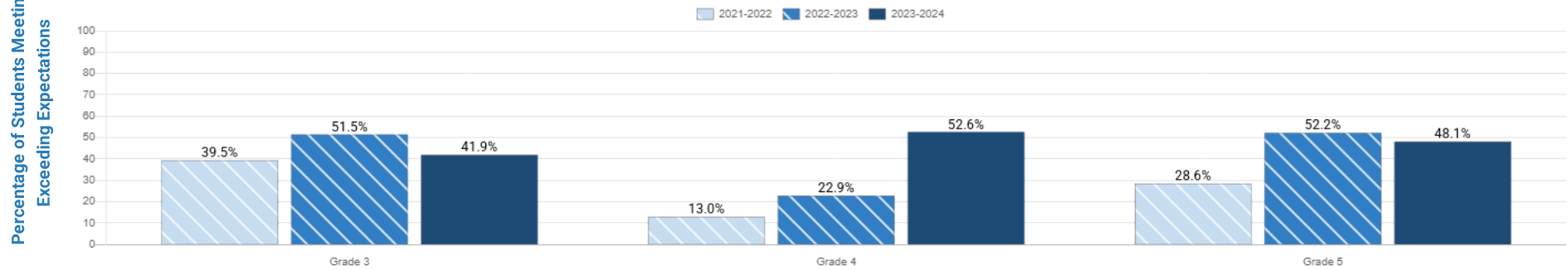

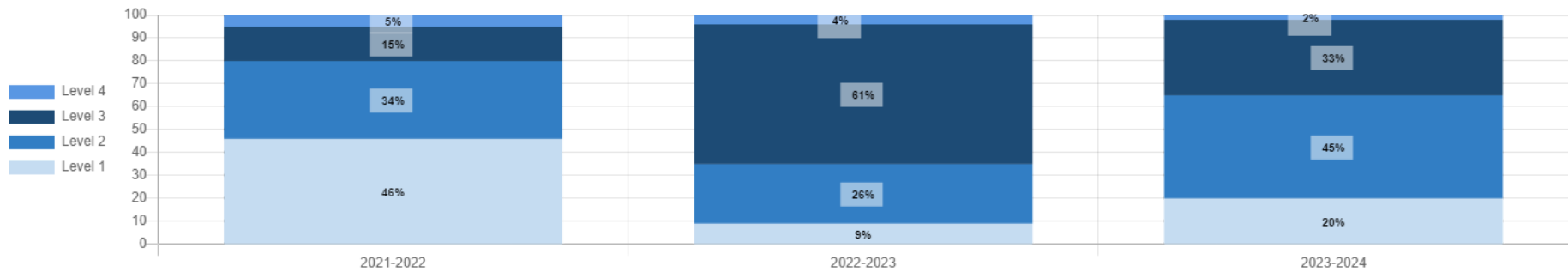

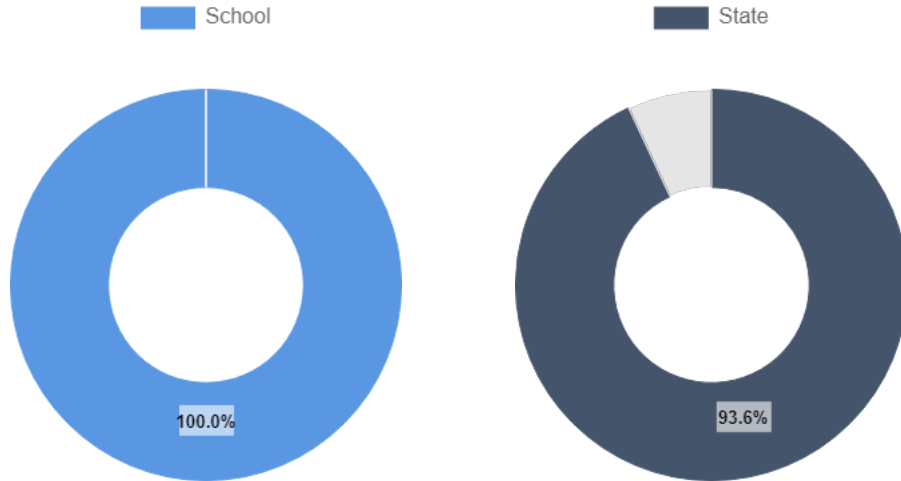

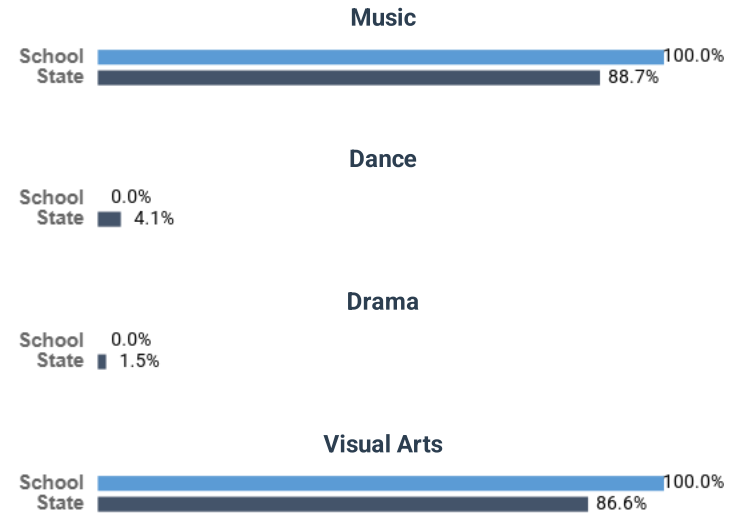

Students enrolled in one or more classes by discipline:



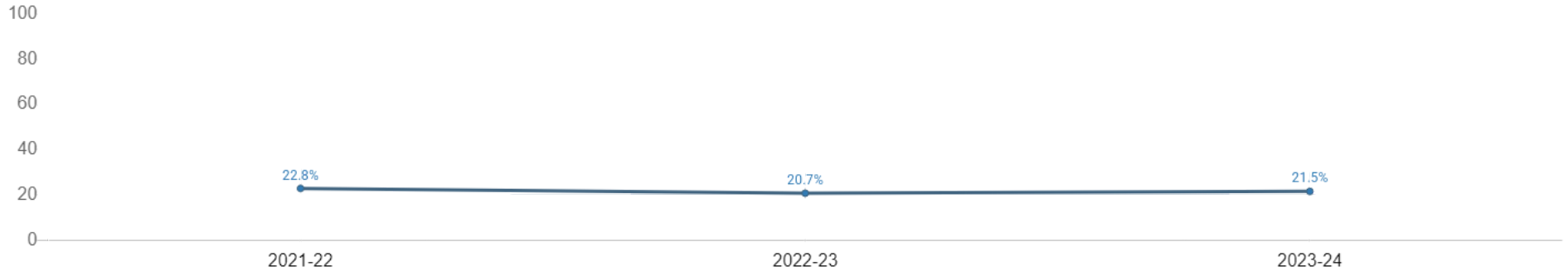
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. 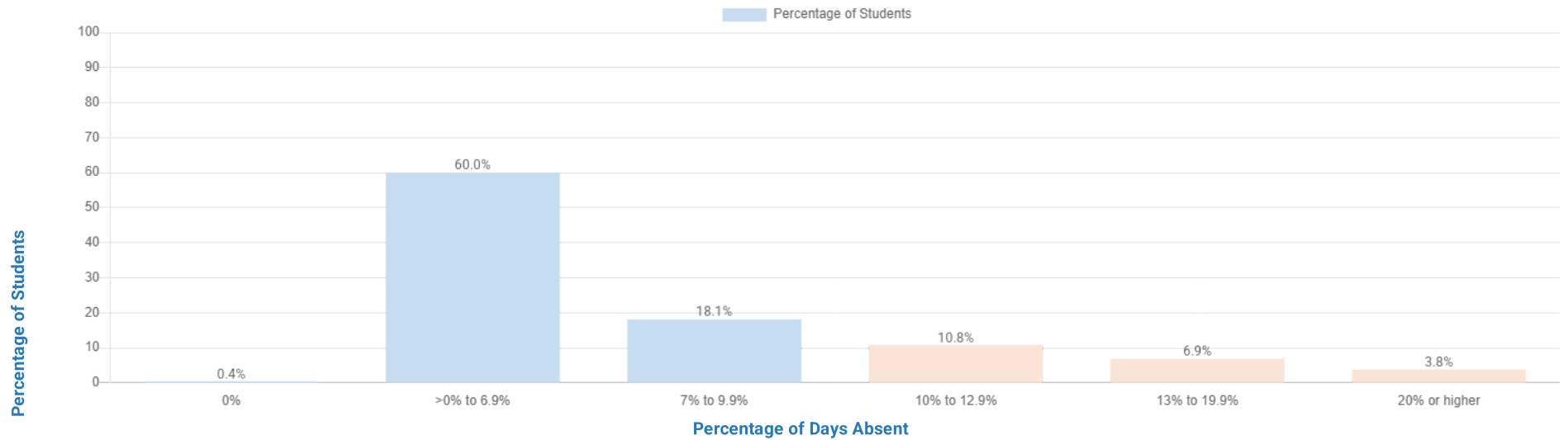

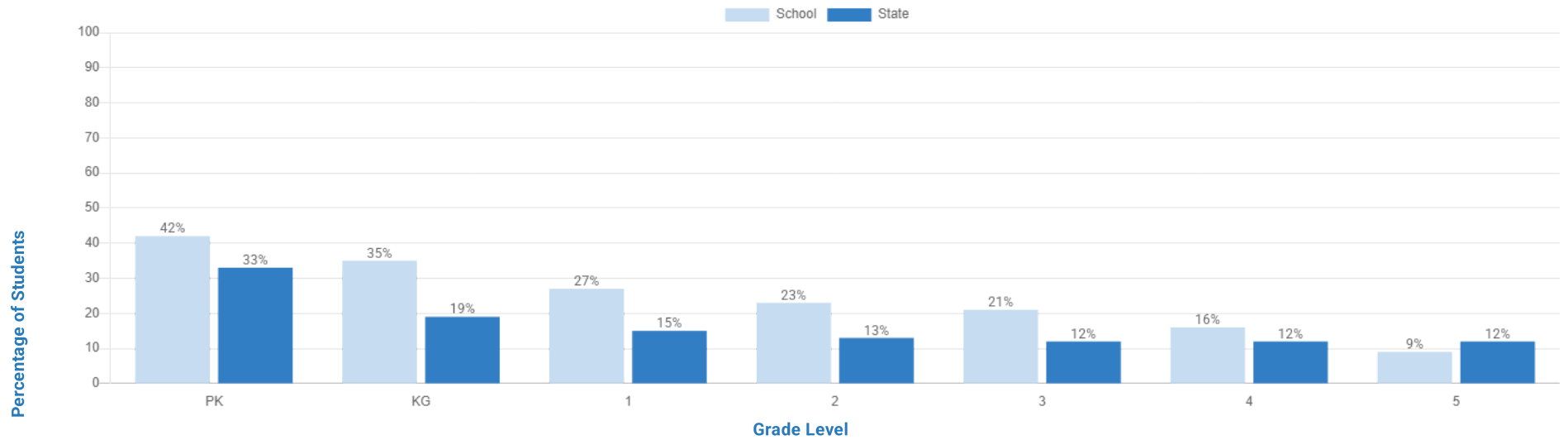

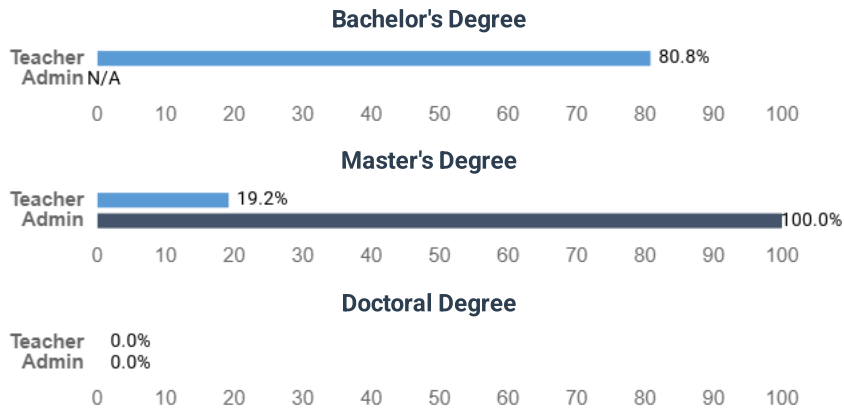

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Professional development sessions included a Reading and Writing Workshop led by the literacy coach. Teachers received coaching by grade level within their schools, focusing on both large and small-group instruction, as well as guided reading techniques. Additionally, teachers utilized Performance Matters to analyze reading data, which informed their instruction and guided small-group lessons. School Safety:

The School Safety Team conducts surveys twice a year for students, parents, and staff to review results and identify areas for improvement. Monthly meetings are held to discuss findings. The school is equipped with an armed security guard, surveillance cameras at all entrances and hallways, and locked exterior doors with alarms installed last year. Each classroom features a locked door marked with window stickers for identification. Staff members have access to a district app for crisis management notifications. Annual training on emergency drills is provided, with two drills conducted each month in collaboration with the district security team.



Technology and STEM:

Students in grades K-5 participate in a 1-1 technology initiative. All grade levels had STEAM classes which enhances their instruction of coding and project-based learning.



Early Childhood Education:

Theodore Roosevelt School 7 has 3 full-day Pre-K classrooms with approximately 15 students in each class using the Creative Curriculum. Curricula are monitored by an Early Childhood Supervisor

All elementary schools in our district have School-wide Title I Programs. Basic Skills Improvement Program teachers, provide collaborative instruction in Reading/Language Arts and Mathematics in the classrooms. Additionally, all BSIP teachers are certified in Wilson Reading System Level I and are certified to provide Wilson Reading Remediation as indicated by the I&RS team's recommendation. The Garfield District has a uniform policy that was created by a ?Dress Code Committee? consisting of students, teachers, administrators, and Board Members. The students are asked to wear a polo shirt in a certain color depending on the grade level and khaki pants. PE days were taken into consideration and the dress code for that class has been modified.
