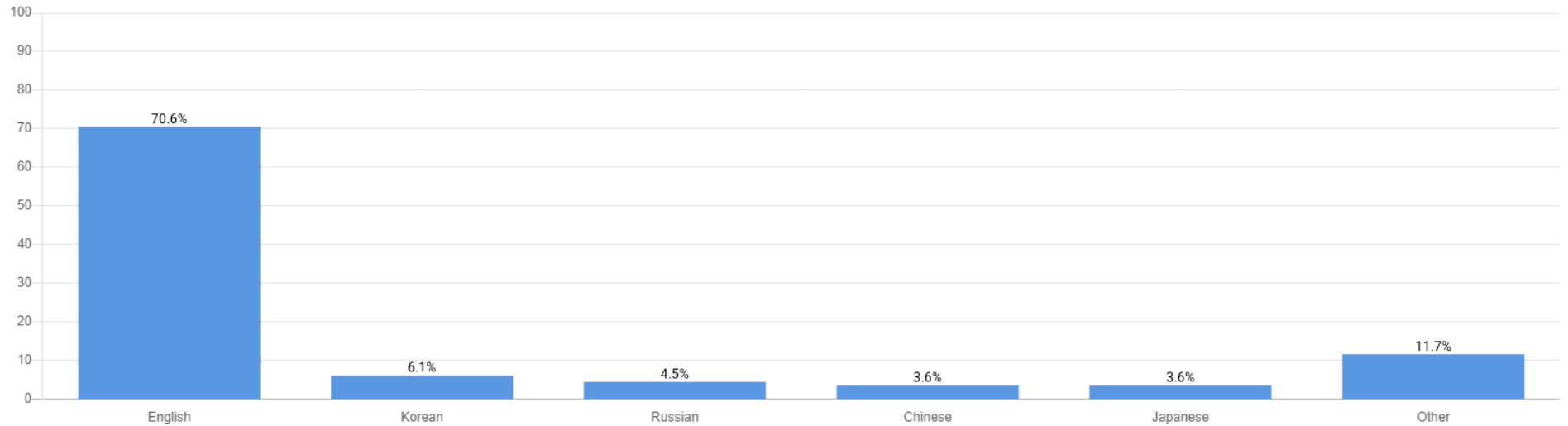

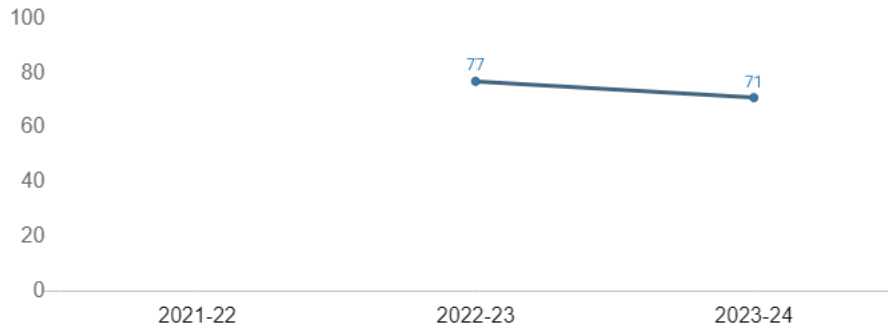

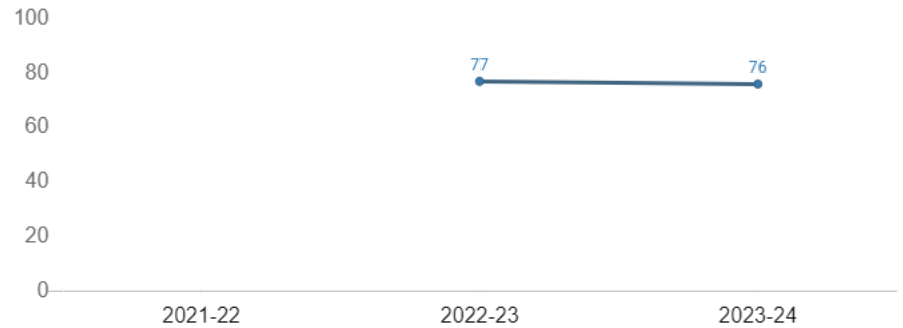

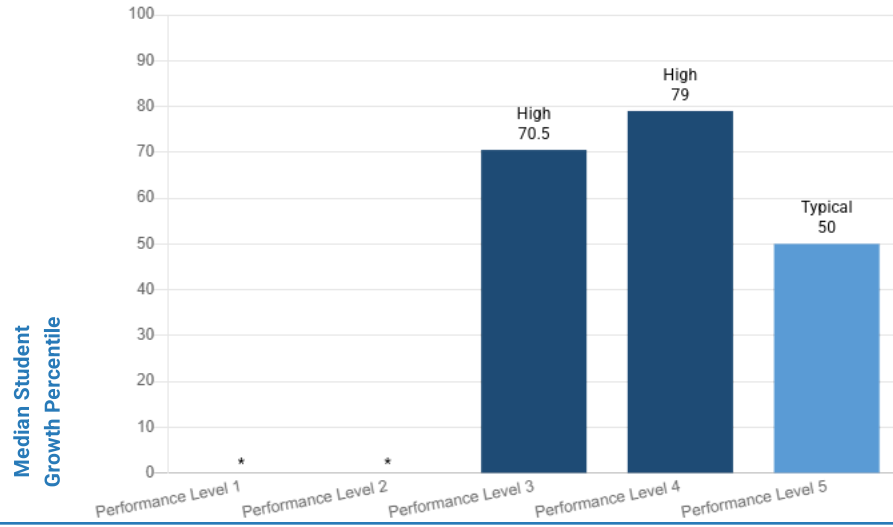

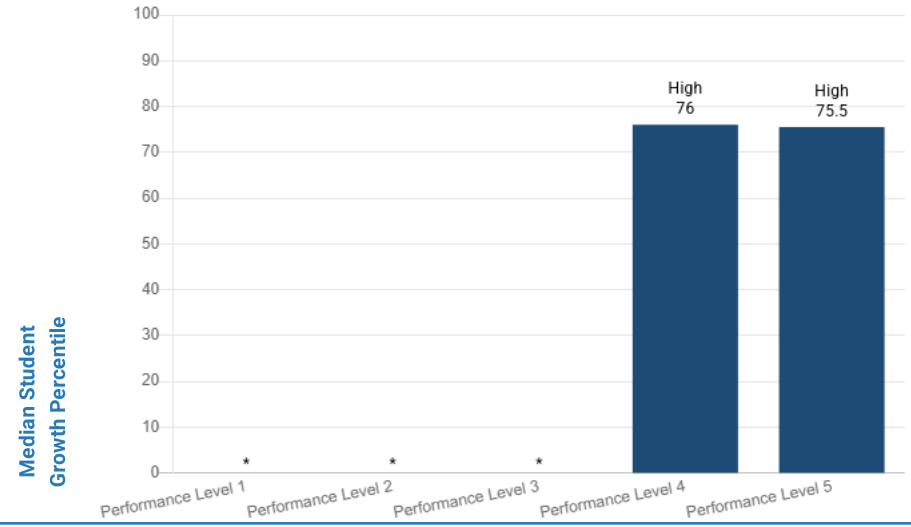

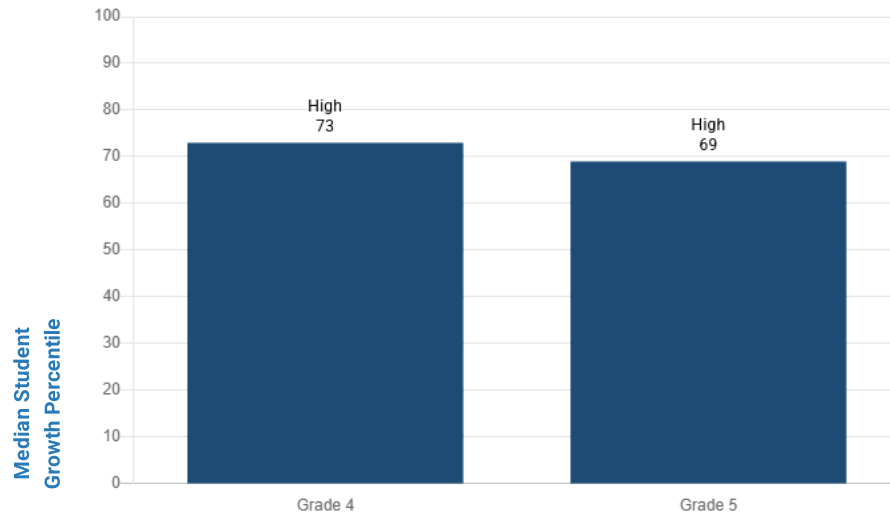

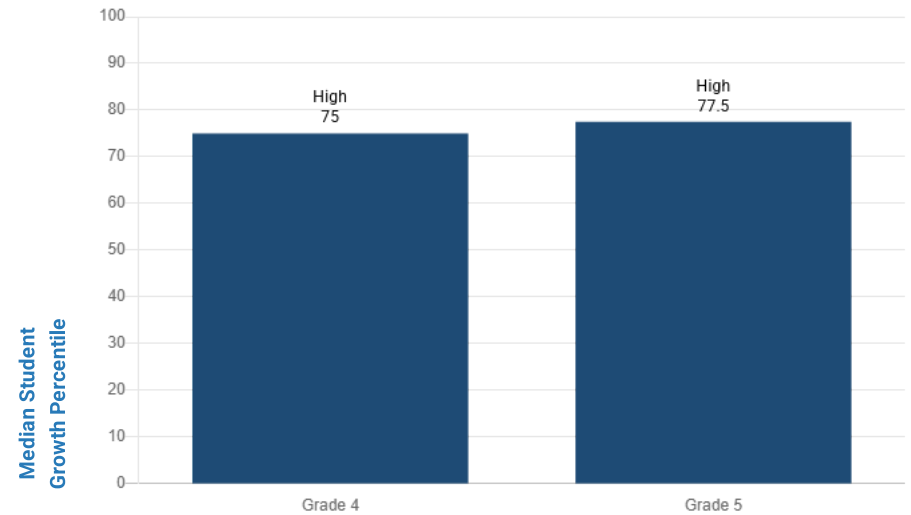

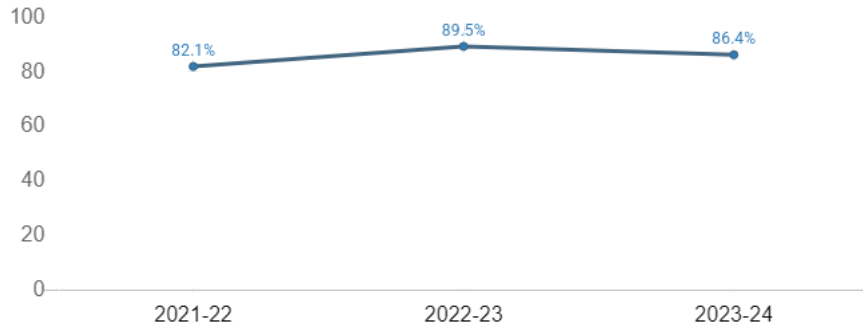

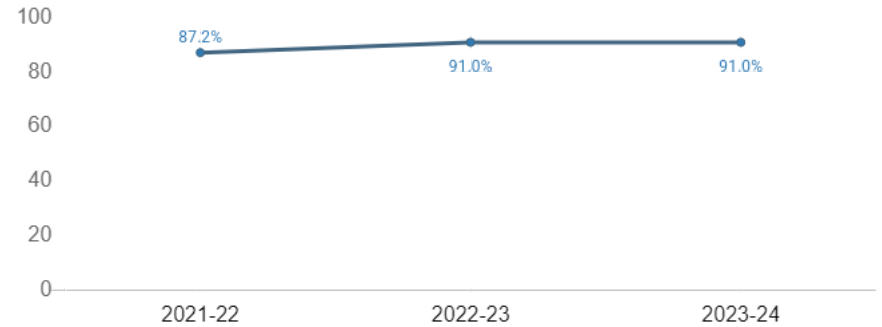
English Language Arts and Mathematics Performance Trends

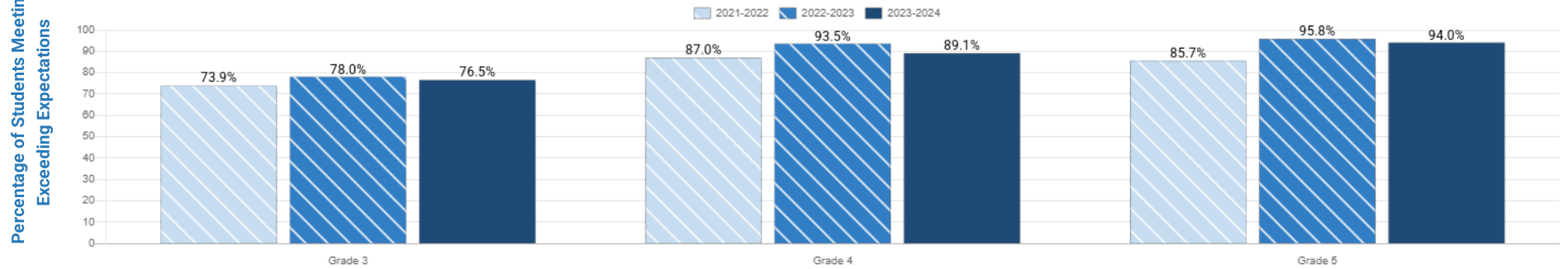

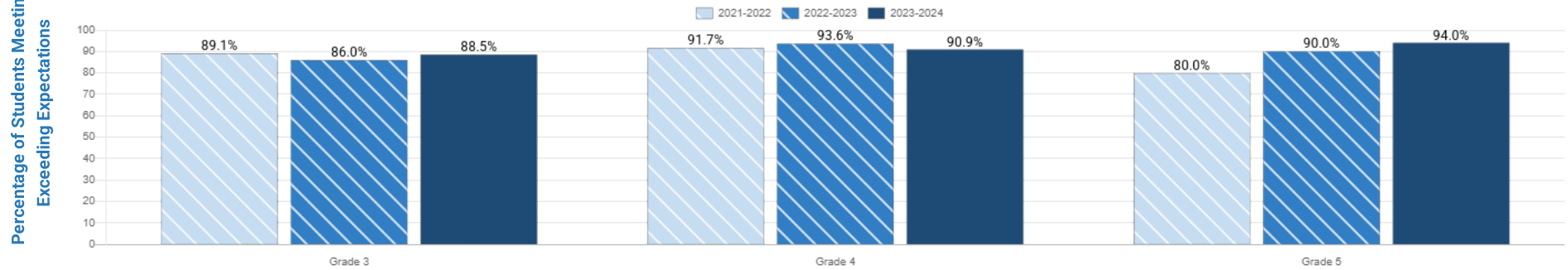

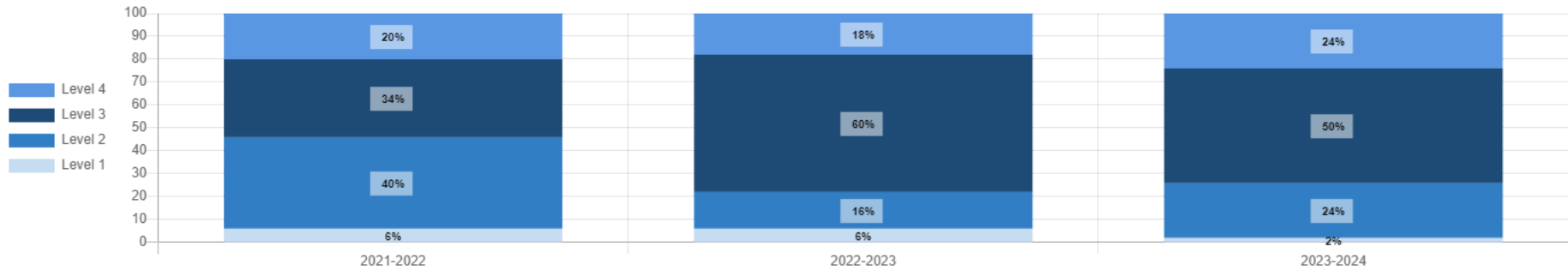

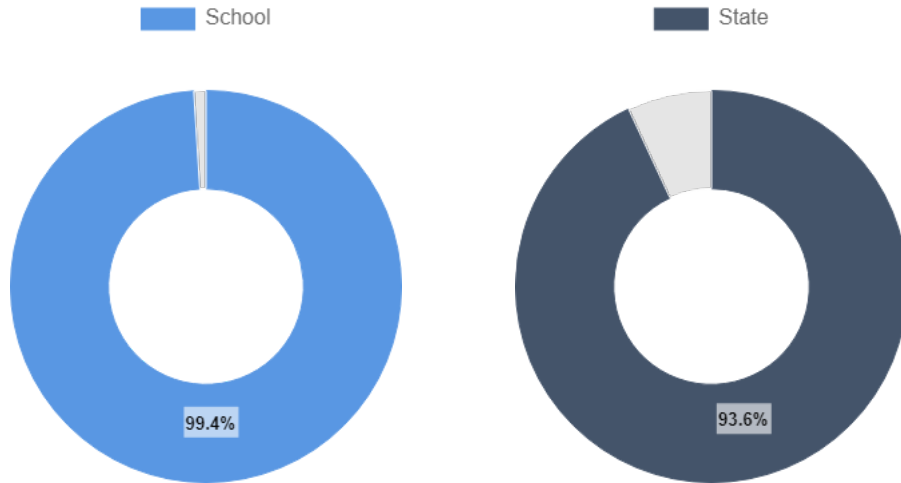

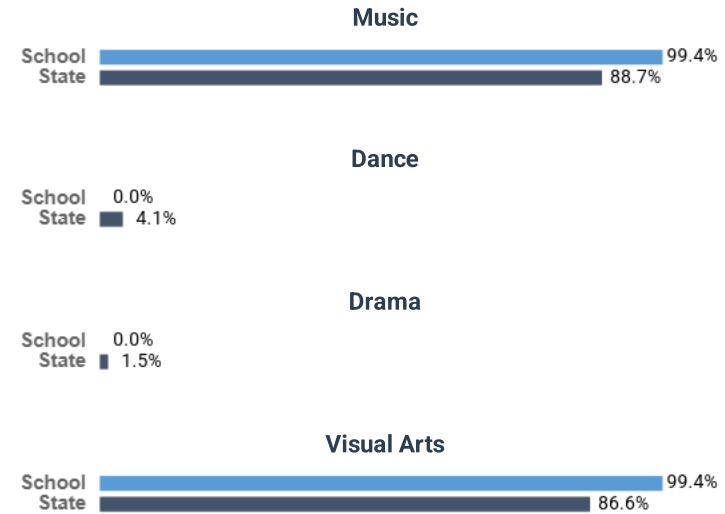

Students enrolled in one or more classes by discipline:



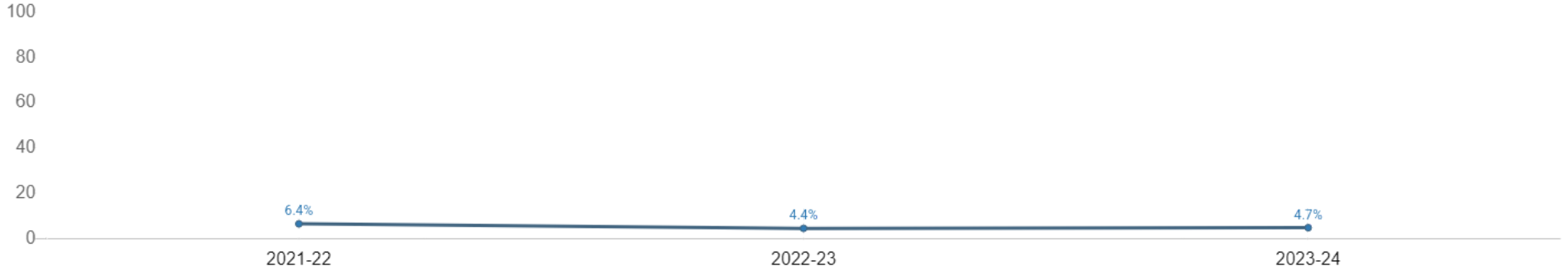

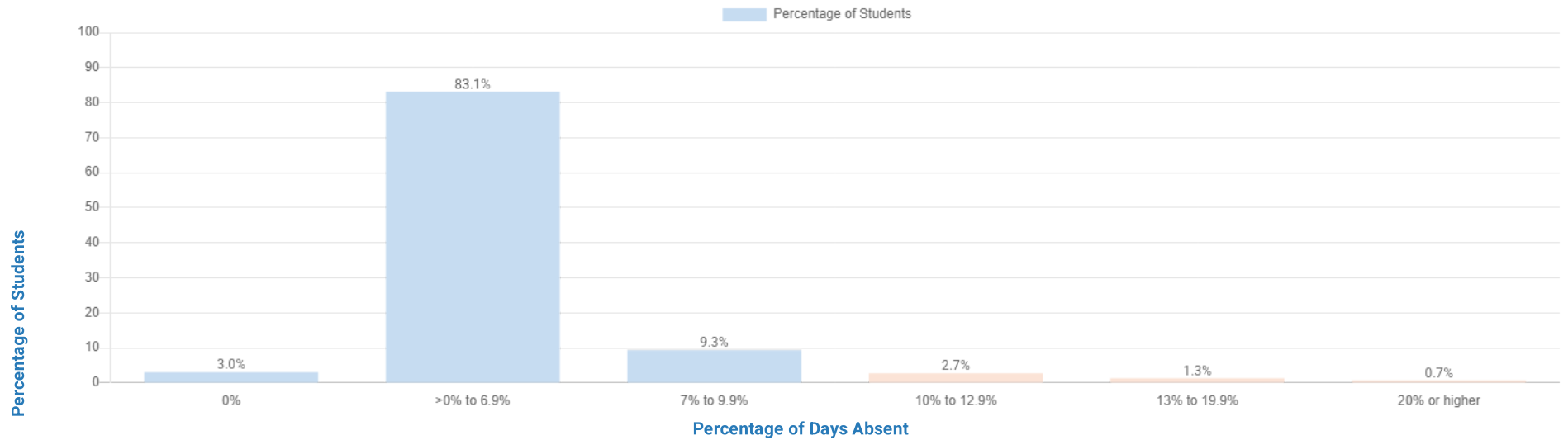

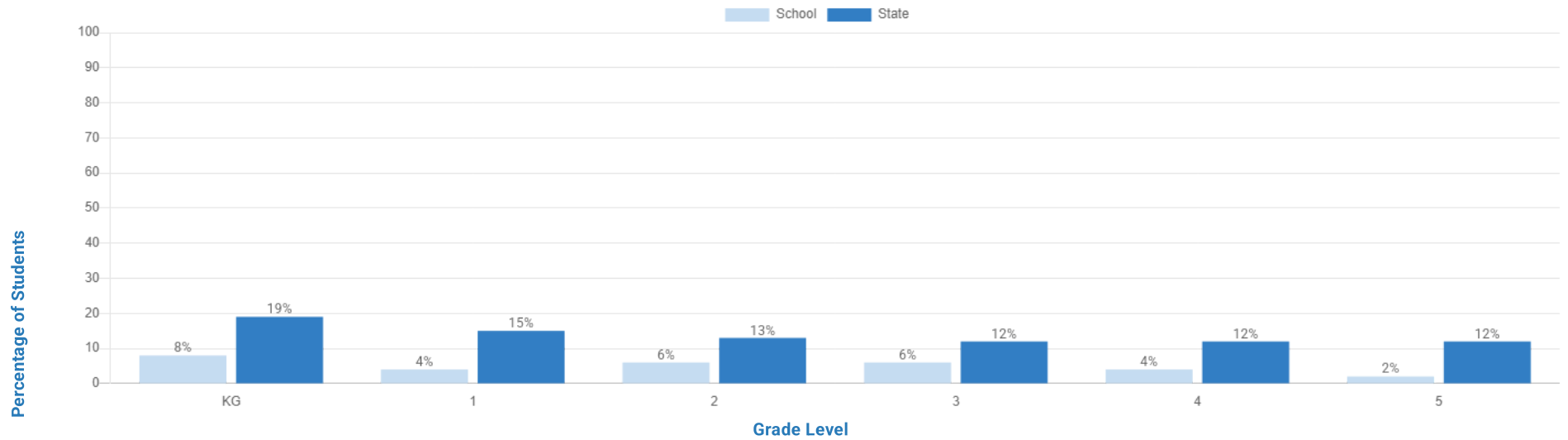

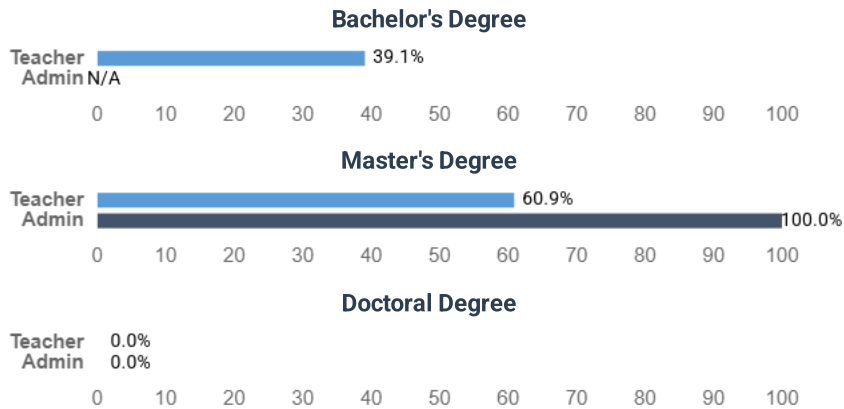

Instruction at Hamilton Schools aims to be engaging, rigorous and developmentally appropriate. Language Arts Literacy is taught using a balanced literacy approach, blending workshop and phonics, that supports students in becoming lifelong readers and writers. Everyday Math is used and supported with online resources; Science, Social Studies, and RULER (SEL) are also part of students' daily program. Our special programs include Art, Music, Library, Physical/Health Education, Spanish and Mandarin Chinese.



Clubs and Activities:

Hamilton students participate in a variety of clubs during and after school: Yoga/Mindfulness, Chorus, Band, Art, Student Council, Safety Patrol, Environmental Club, and STEM.

Staff and Professional Learning:

The faculty at Hamilton School is highly professional and committed to using best practices in all instructional areas. Articulation occurs vertically and horizontally in order to provide students with a meaningful and rigorous continuum of learning. A professional book study, PLCs, as well as faculty meeting discussions, have enhanced engagement in student and teacher learning. Literacy and math coaches are available for teachers for PD in-class and for workshops.



Student Supports and Services:

There is a continuum of support services aimed to meet students' individual needs. ESL is available for our MLL students. The I&RS committee meets weekly to address the needs of struggling students. Students who meet the criteria for special education programs receive a replacement, collaborative or TA support for both one-to-one and small group settings. Related services such as speech, OT, and PT are also available for students who need this level of support. Students who excel may be recommended for the G & T program. MTSS is utilized to identify strategies and resources for students who may need additional support within the general education programs. Basic Skills Instructional programs are offered in the areas of Reading and Math. A guidance counselor is available for social and emotional needs. A full-time nurse is also present for students with medical concerns.



Student Health and Wellness:

Health lessons are taught by the PE/Health teacher in grades K-5. Character Education is part of the classroom schedule and focuses on respect and kindness. The guidance counselor holds lunch groups and provides assemblies and workshops in the area of character education and anti-bullying messages. Hamilton School has also made a conscious effort to include a daily recess for every class at least twice per day, brain breaks between subjects, and mindfulness activities in all classes.
