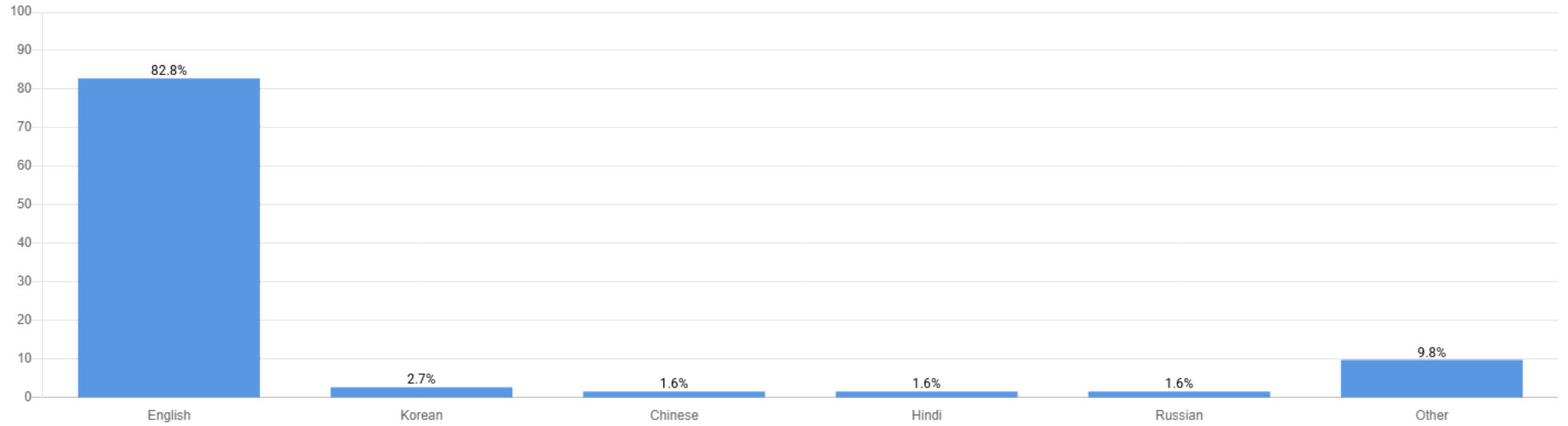

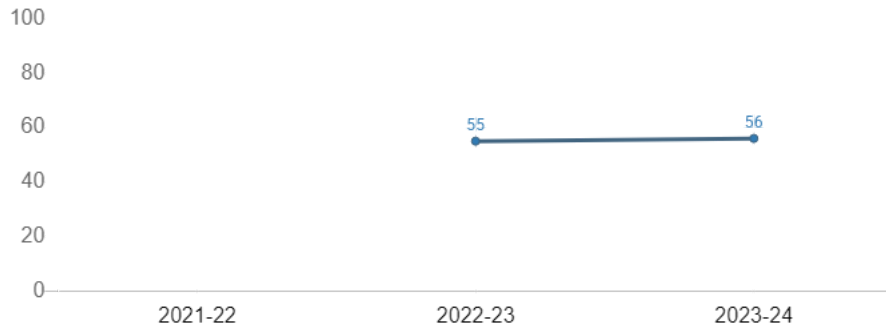

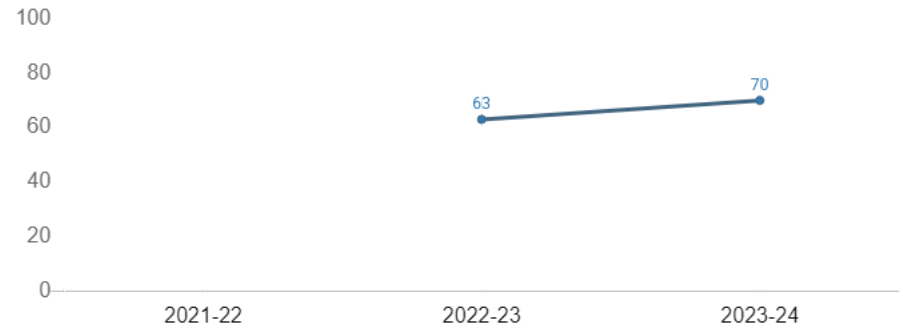

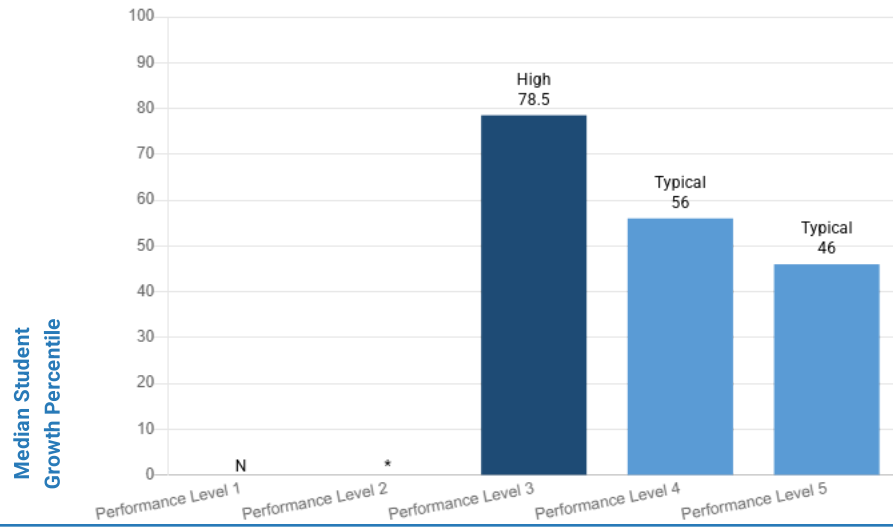

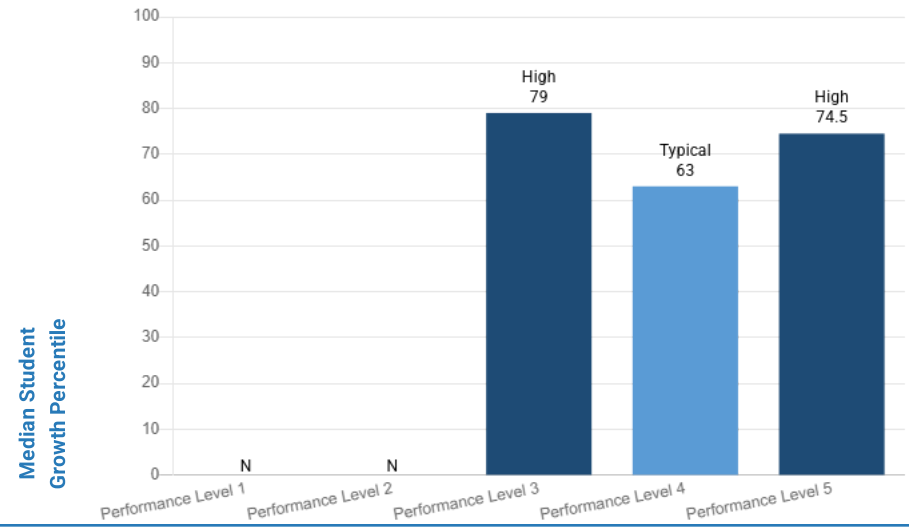

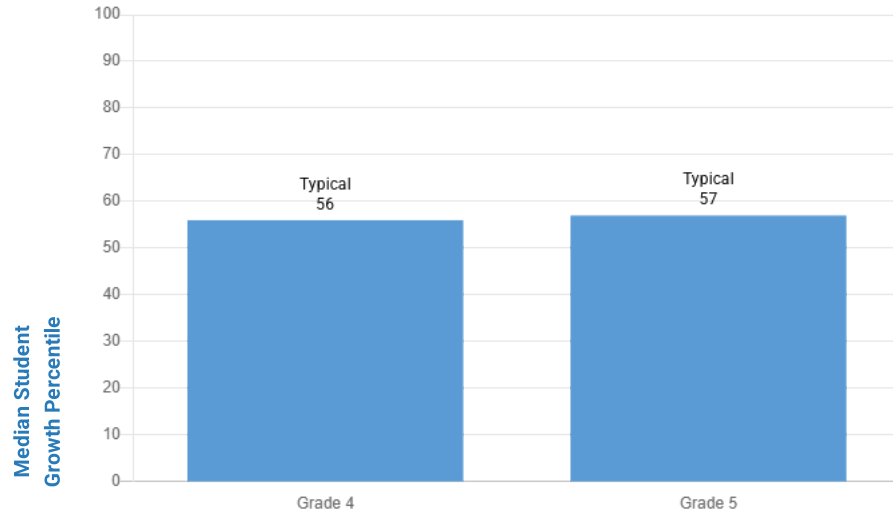

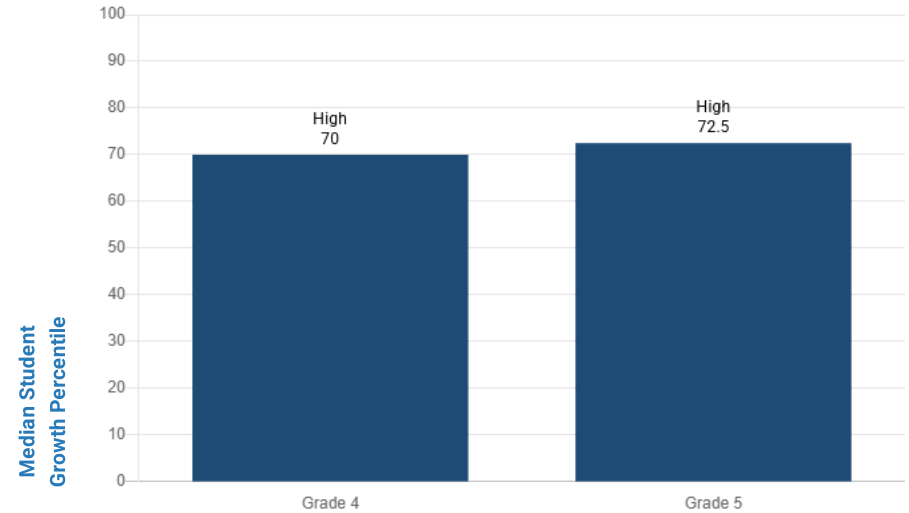

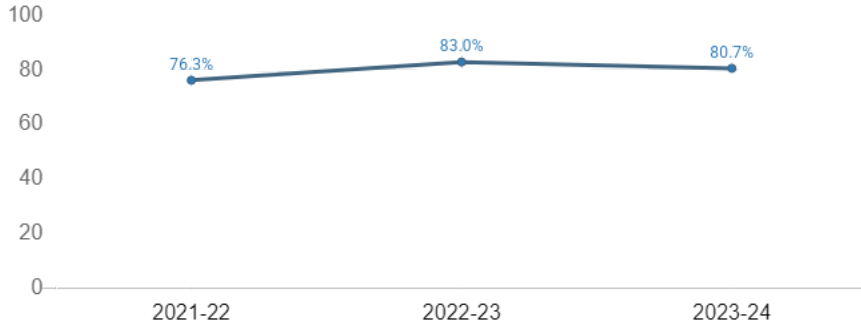

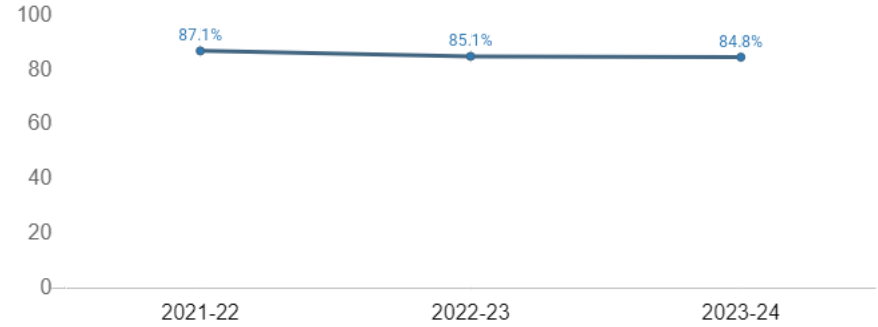
English Language Arts and Mathematics Performance Trends

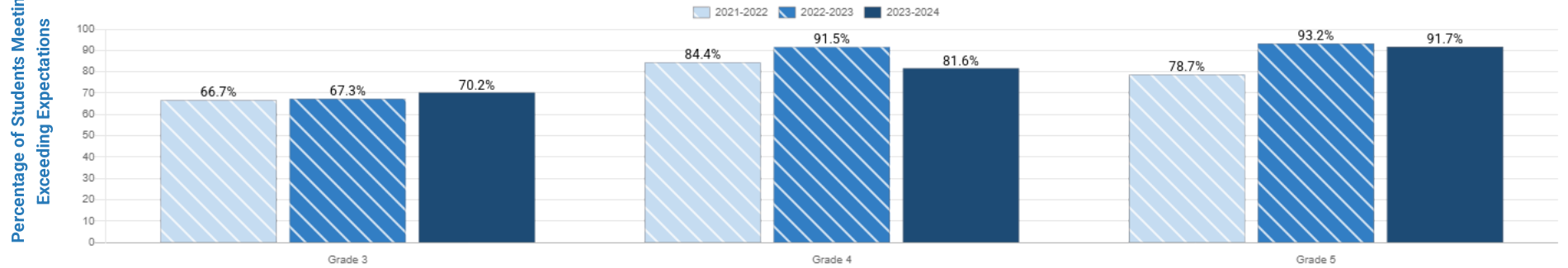

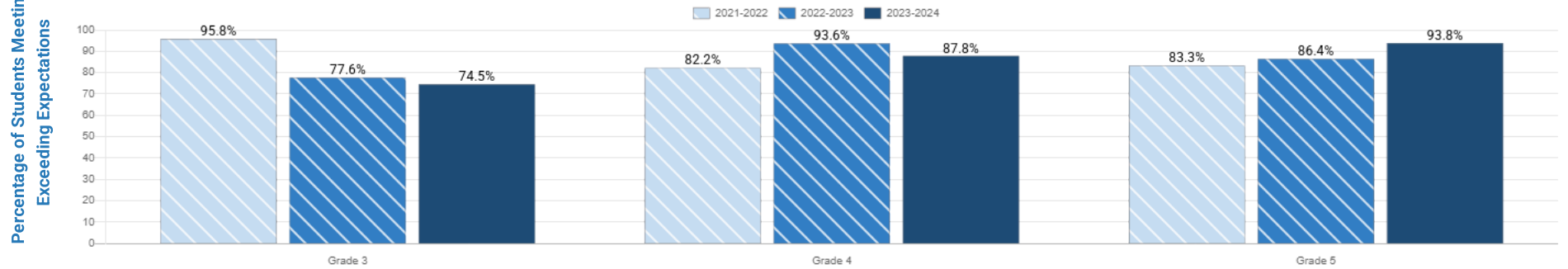

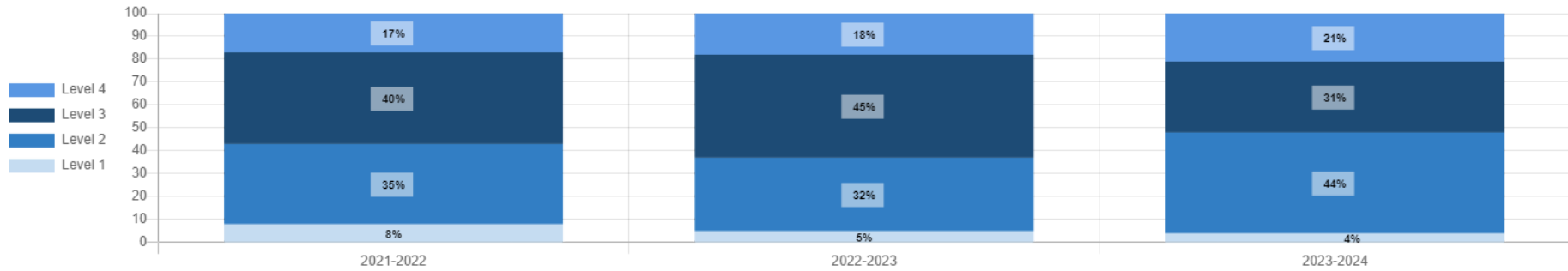

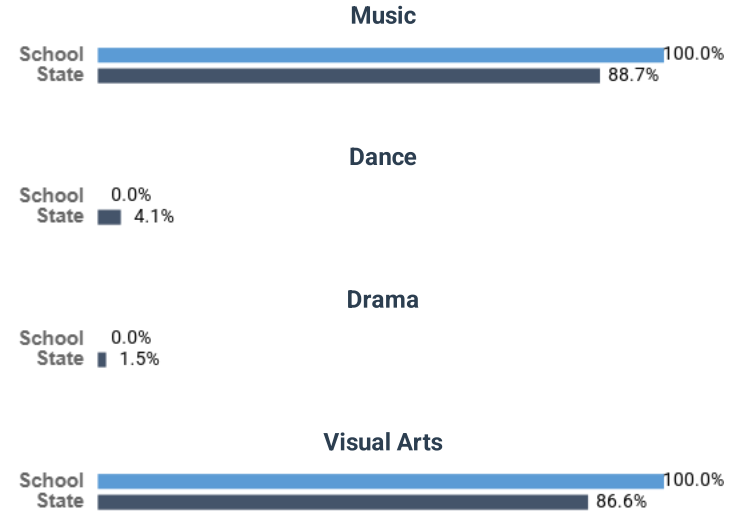

Students enrolled in one or more classes by discipline:



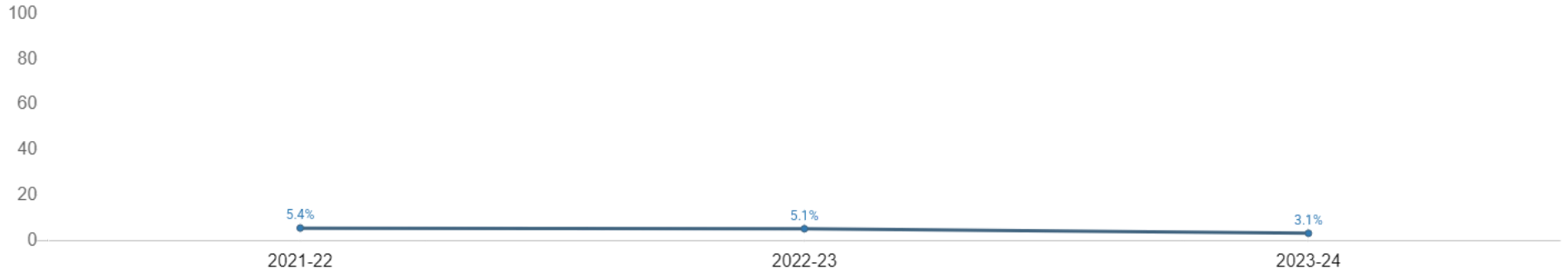

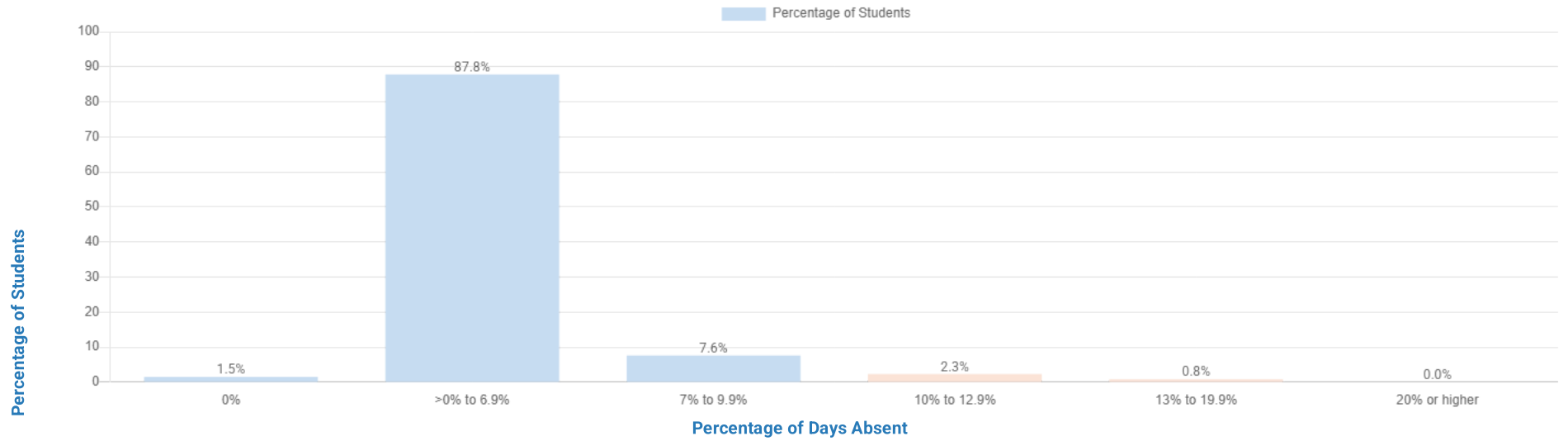

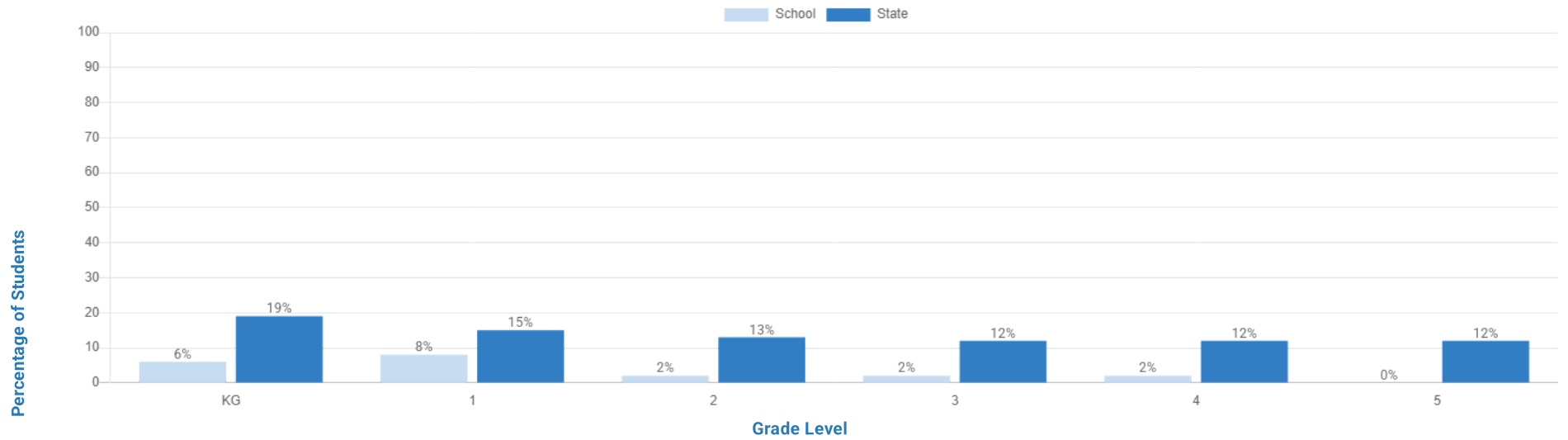

Staff

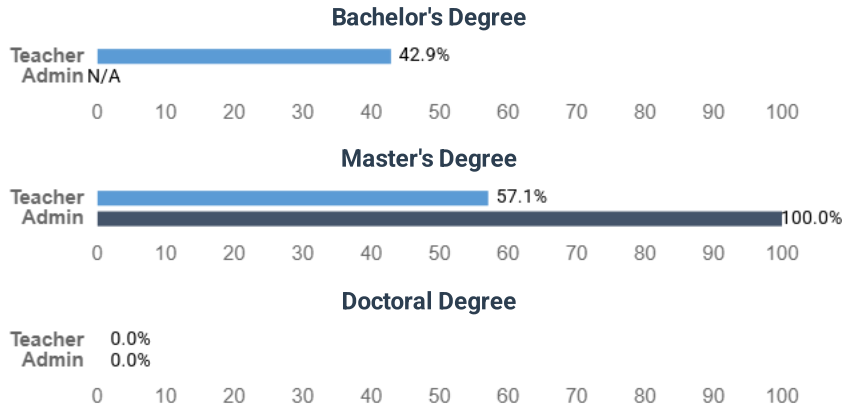

Accountability Summary by Student Group - 2023-24 School Year

Resource Room and Collaborative class opportunities for students with IEP accommodations. I&RS committee meets weekly to address the needs of struggling students and formalize action plans to support the academic and social emotional needs of those that require intervention. TA supports are in place for both one-to-one and small group settings. A full time Guidance Counselor is on staff to support the social emotional growth of our students and faculty. School nurse is present for students with medical concerns. Speech, Reading and Basic Skills Instruction opportunities available.



Student Health and Wellness:

Health lessons are taught in grades K-5; School nurse teaches hygiene lessons to younger students. To support social emotional learning, we utilize the RULER program in each of our classrooms. RULER is the evidence-based approach to social and emotional learning developed at the Yale Center for Emotional Intelligence (YCEI). Through daily Community Circles and the use of the Mood Meter, students are encouraged to promote emotional literacy, which includes Recognizing, Understanding, Labeling, Expressing, and Regulating emotions (the "RULER" skills). The guidance counselor supports this work through classroom lessons and lunch groups and provides assemblies and workshops in the area of character education and anti-bullying messages. Byrd School has also made a conscious effort to include daily recess, brain breaks between subjects, and mindfulness activities in all classes.
