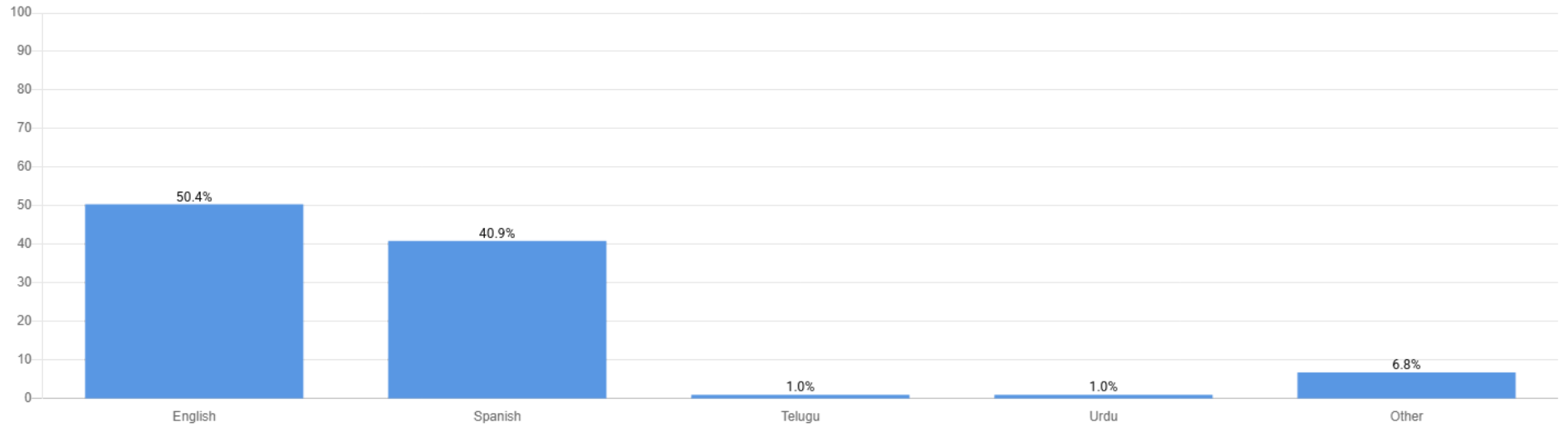

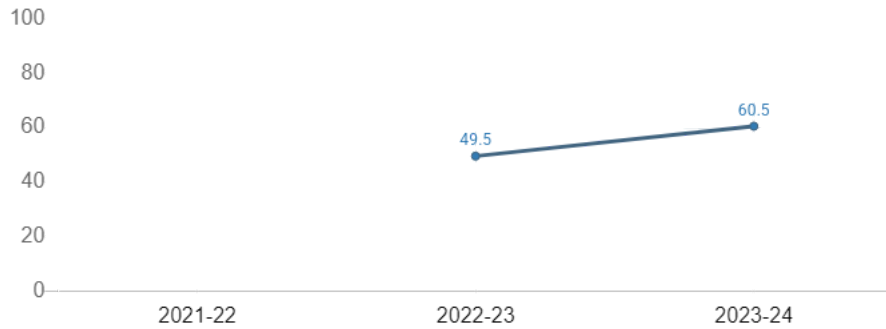

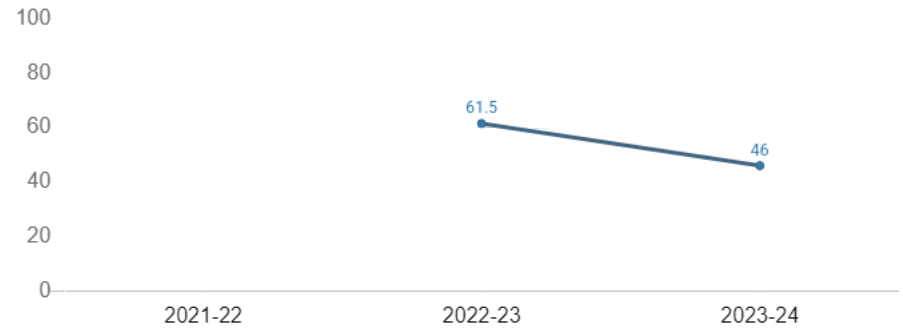

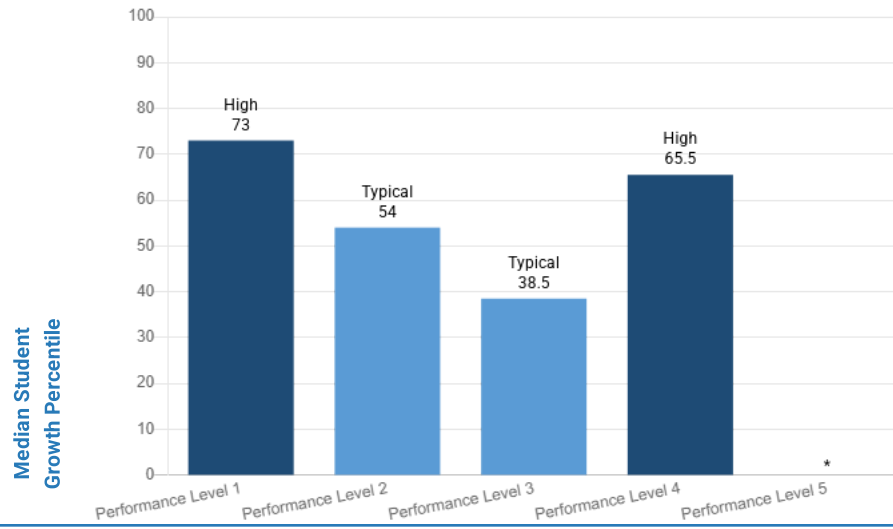

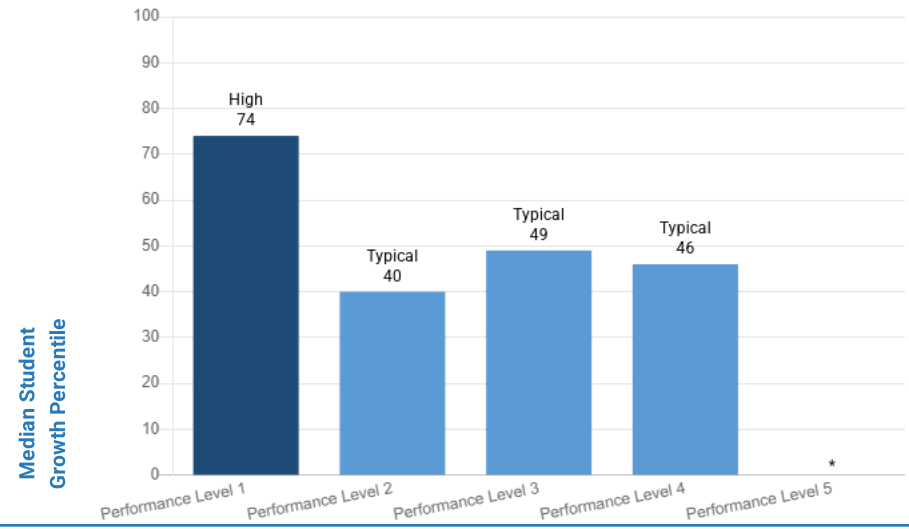

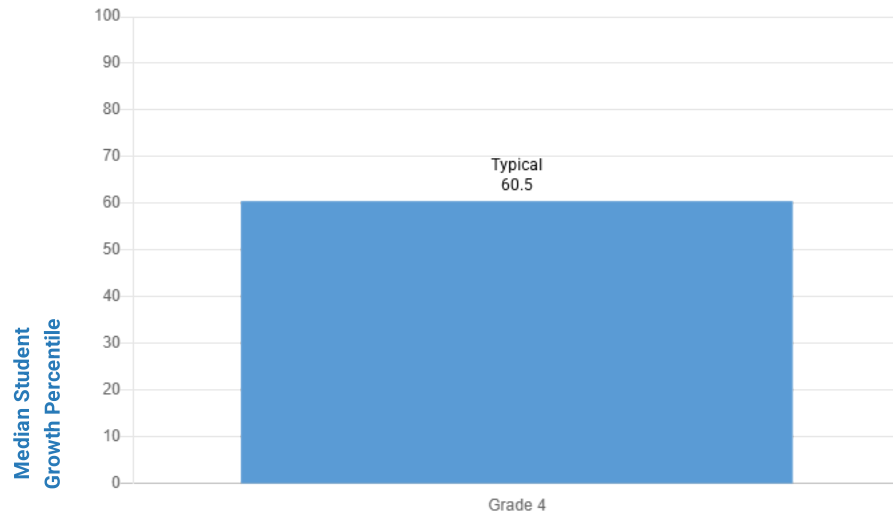

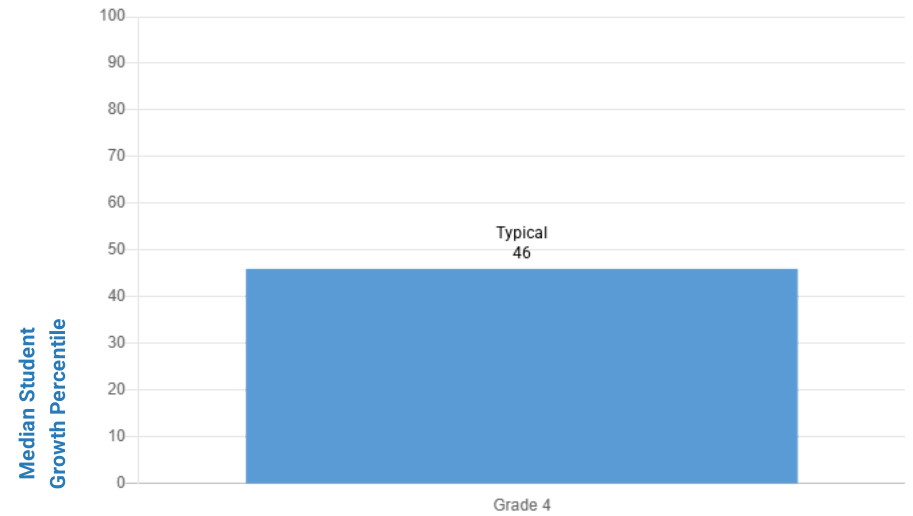

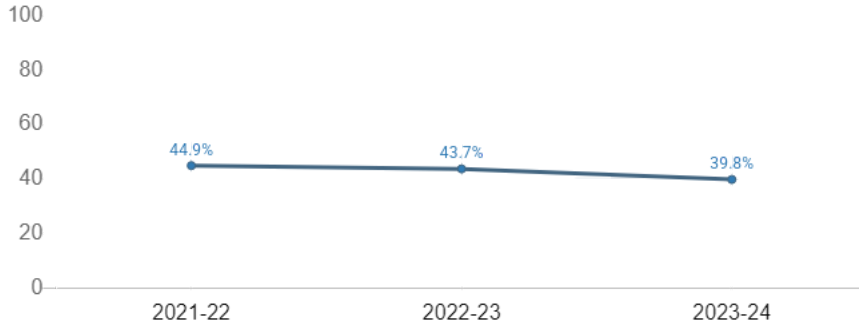

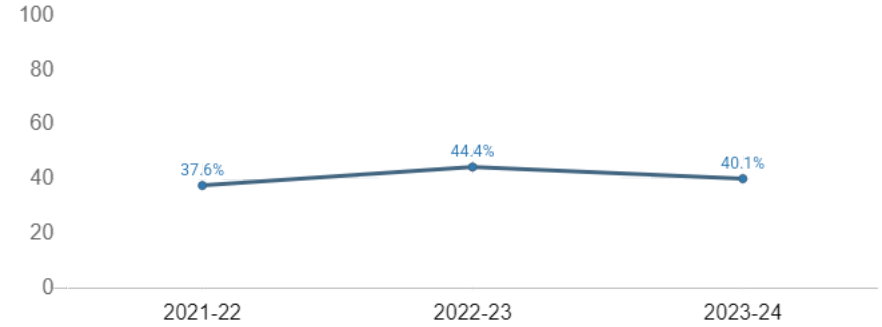
### English Language Arts and Mathematics Performance Trends

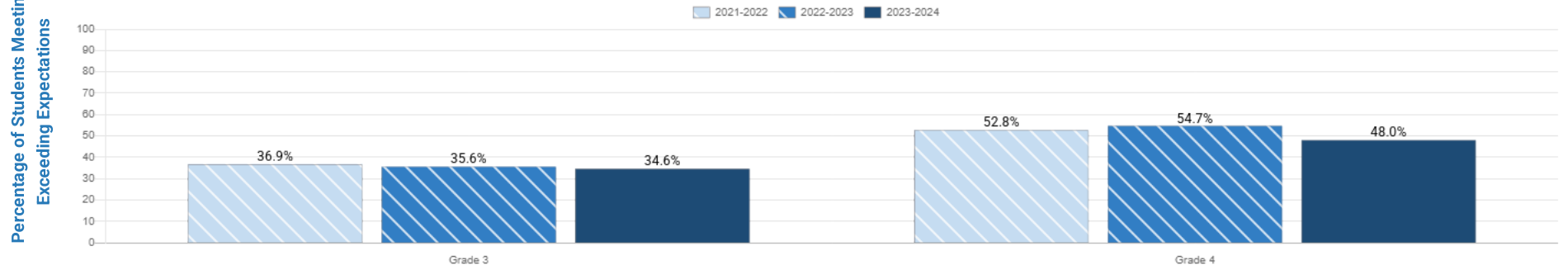

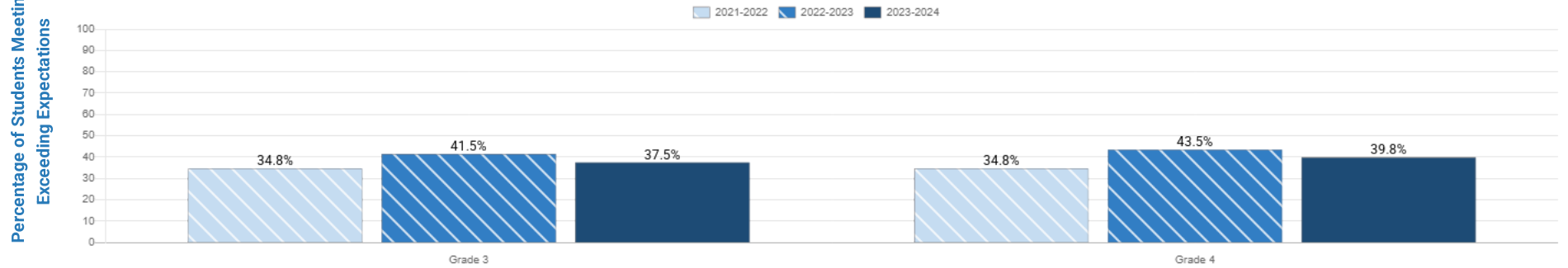

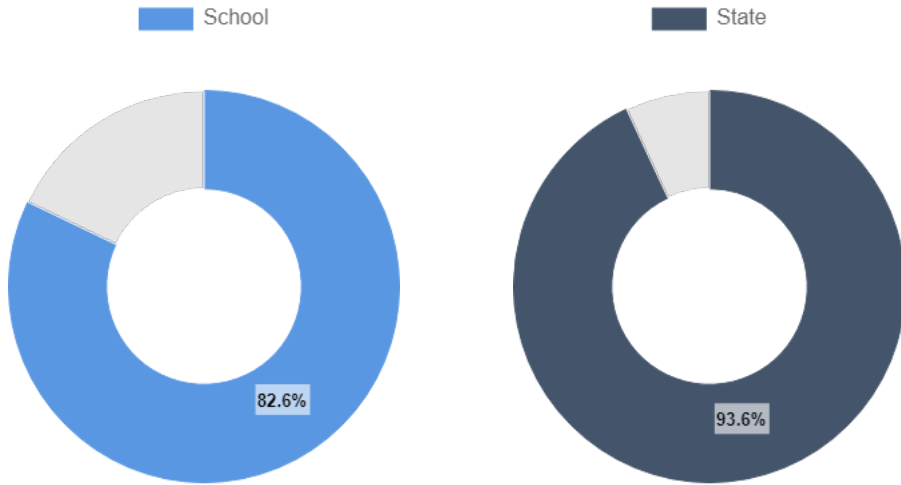

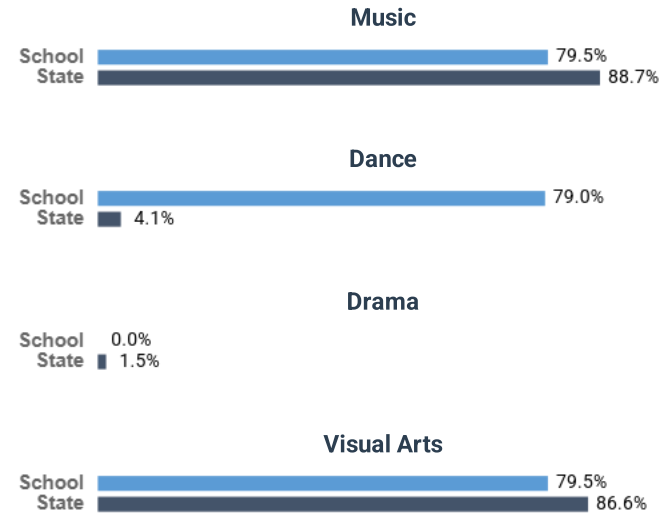

**Students enrolled in one or more classes by discipline:**



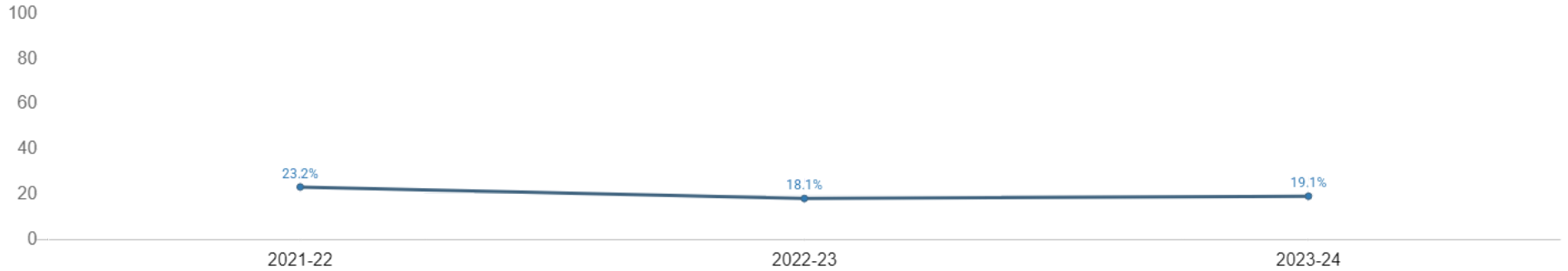

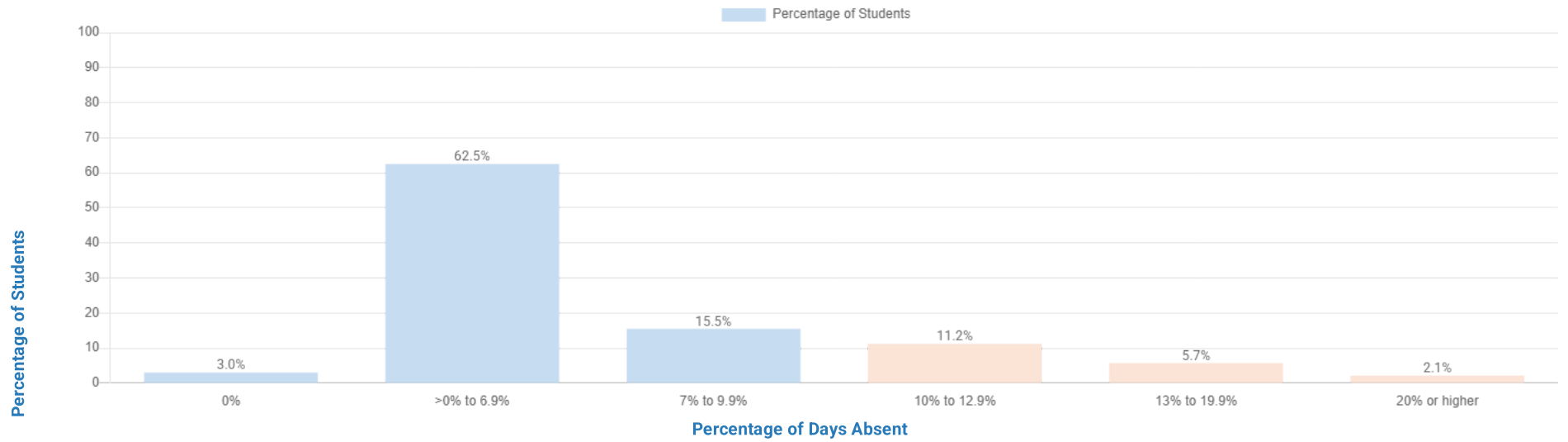

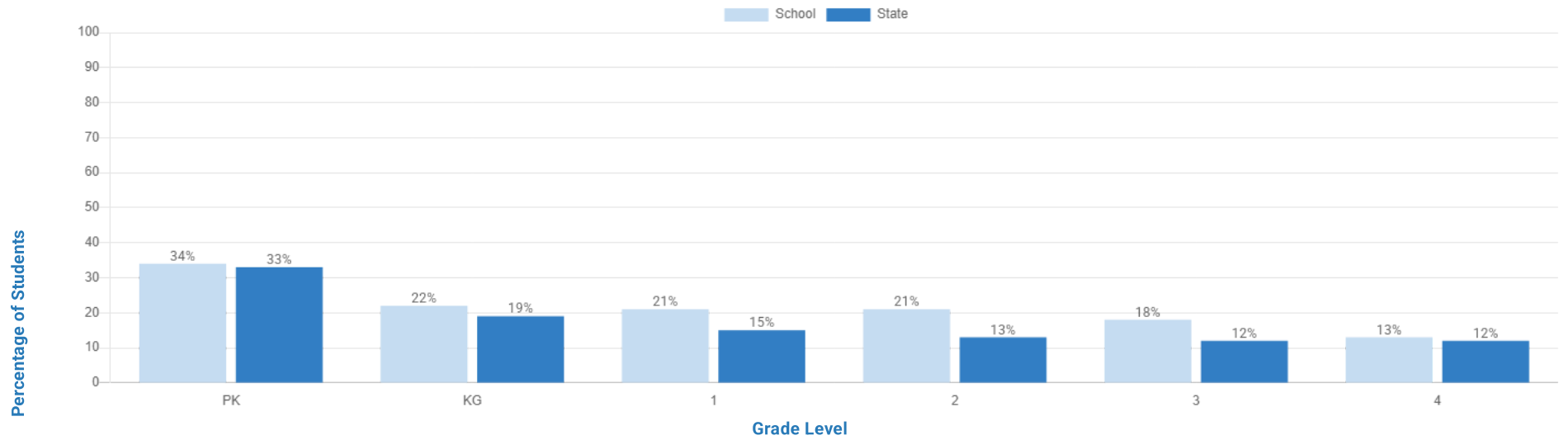

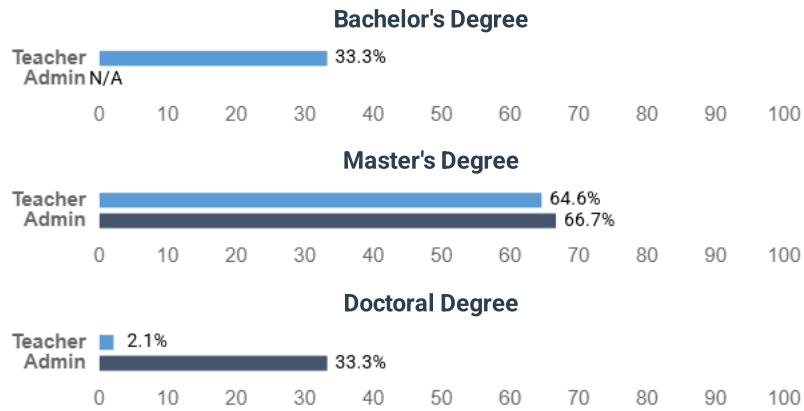

For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

**Out-of-Field:** A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

### Teachers by Subject Area

This table shows the counts of teachers by subject area with gender breakdown, experience, and level of education. The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). Note that some teachers may teach in multiple subject areas and may be counted more than once in this table, or they may only be counted in their primary subject area. Additionally, in many elementary schools, teachers are not assigned to specific subject areas, so they will appear in the Elementary (Not Subject Specific) category and not in the other subject areas, but that does not mean those subjects are not being taught in the school. Digital learning and effective use of technology is used in all subject areas. ELA and Math instruction are aligned to the NJSL. The core programs are a Balanced Literacy Approach utilizing the Reading and Writing Workshop Model and Reveal Math. Both math and literacy focus on whole and small group instruction. The Science Curriculum supports the Next Generation Science Standards through Amplify Science which focuses on hands-on instruction and STEM. Pearson's My World is the Social Studies core program.



### Clubs and Activities:

Parker offers Lego League, Mad Science, World Language, Dance, Instrumental Music and Chorus. Students partake in Walk-a-Thons, Field Day, a Talent Show and several art competitions. All students perform in assemblies for the entire school. Students participate in Winter and Spring Concerts. Our school-wide Safety Patrol is made up of student volunteers.
