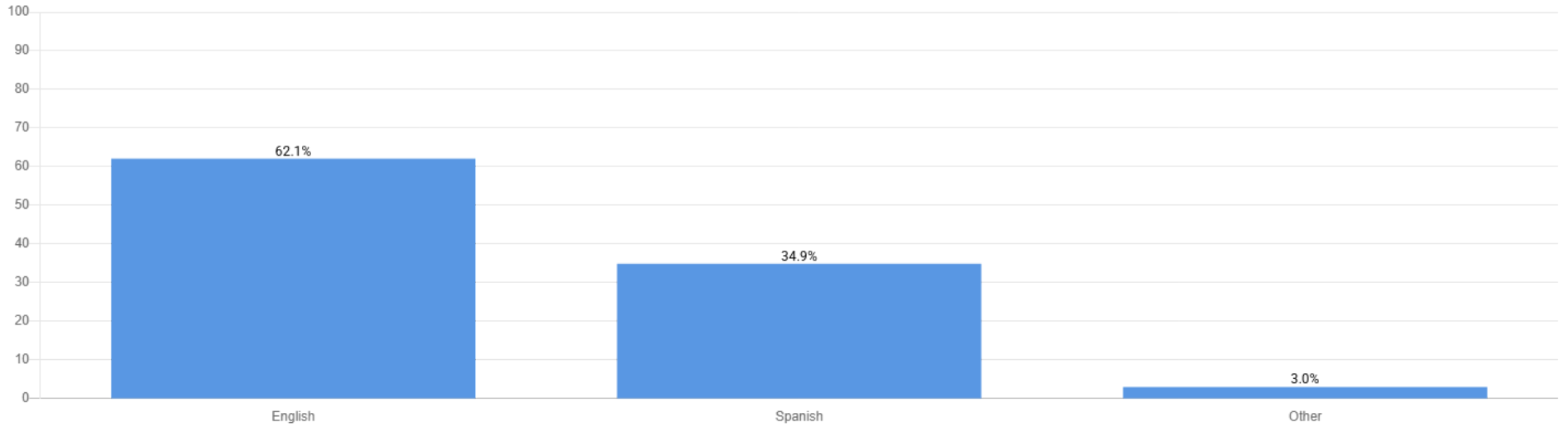

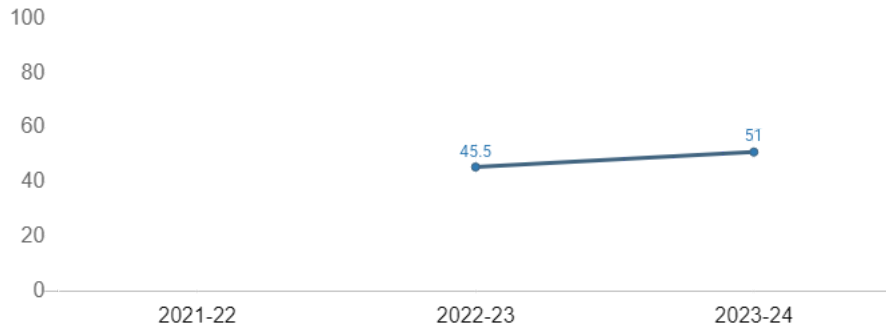

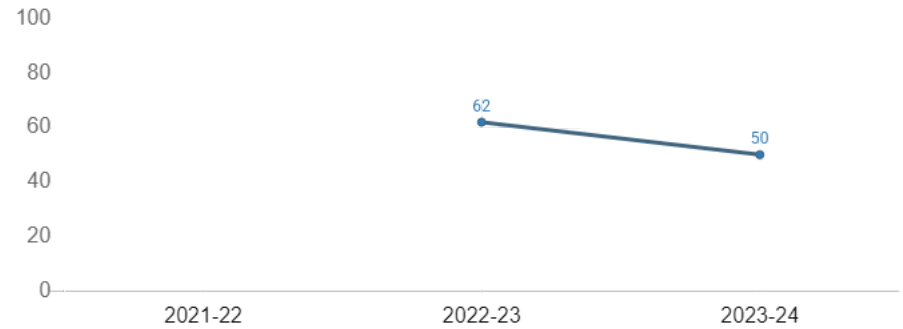

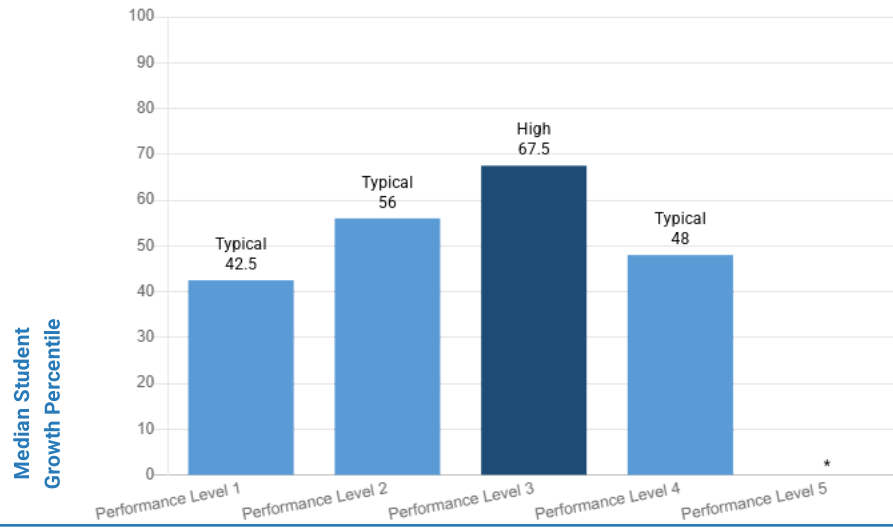

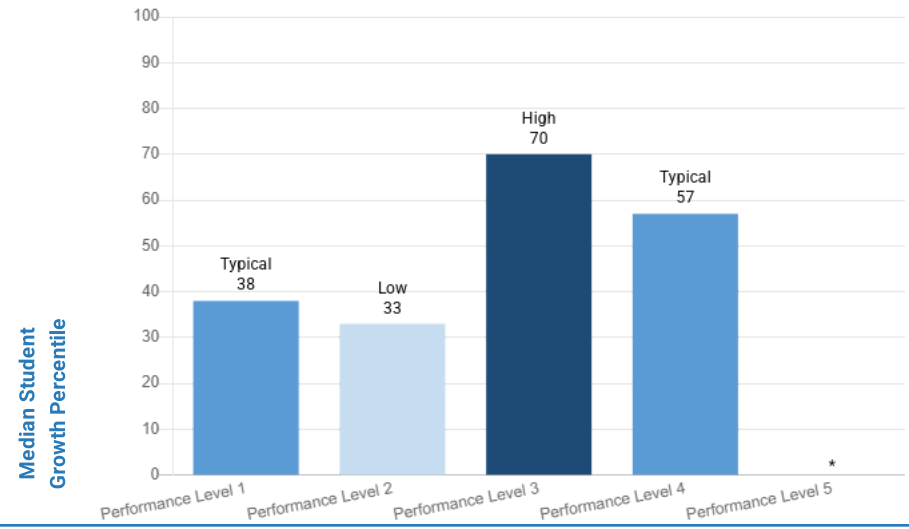

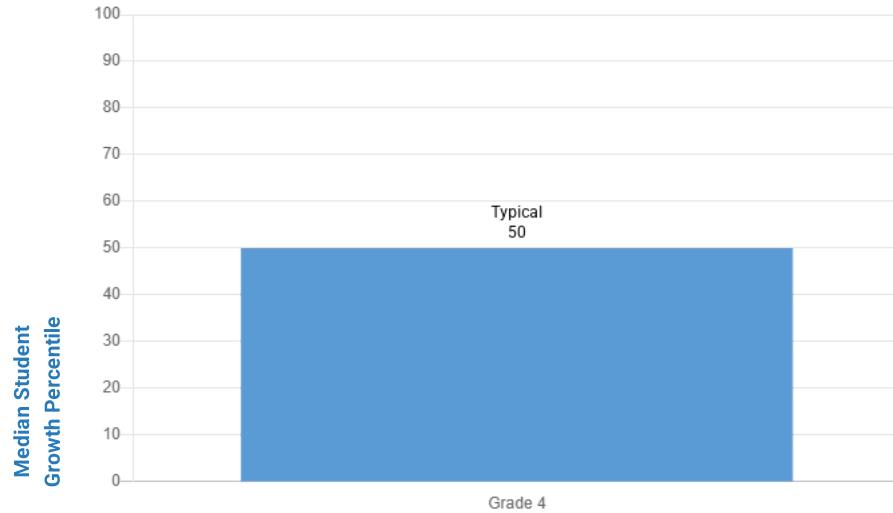

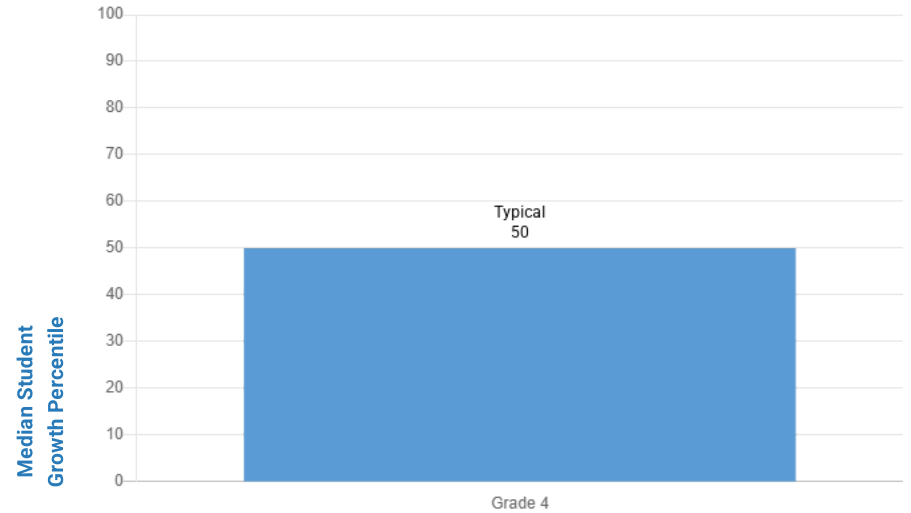

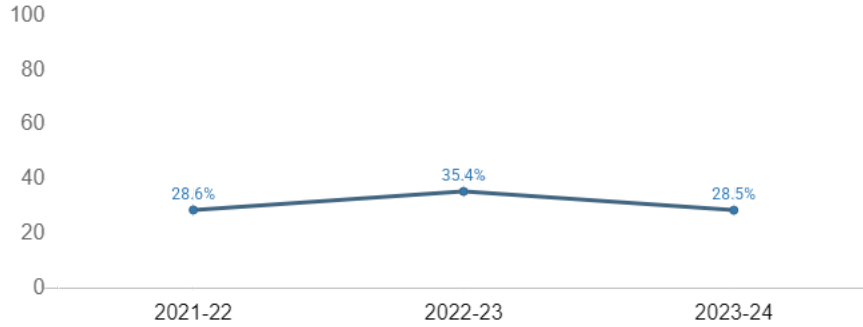

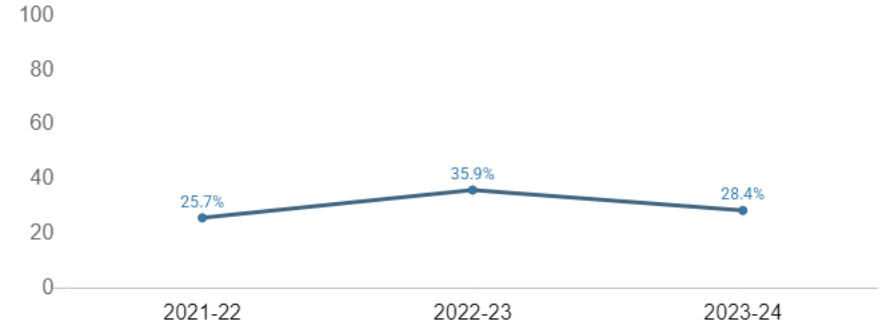
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 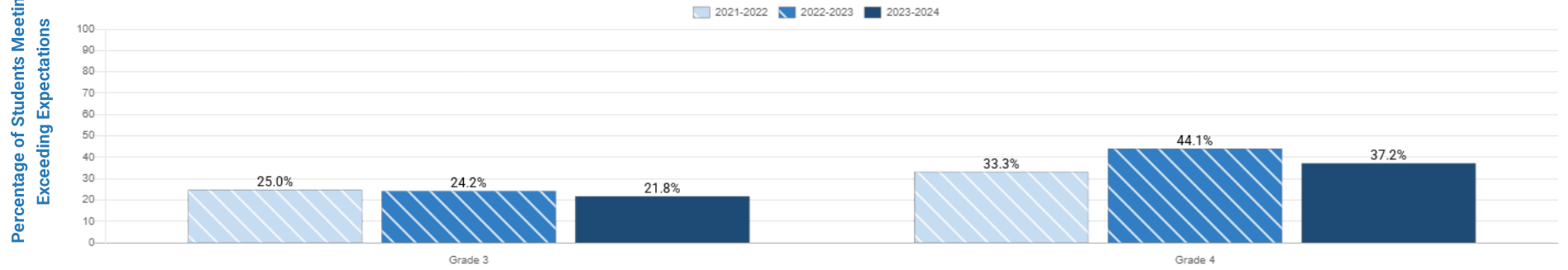

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 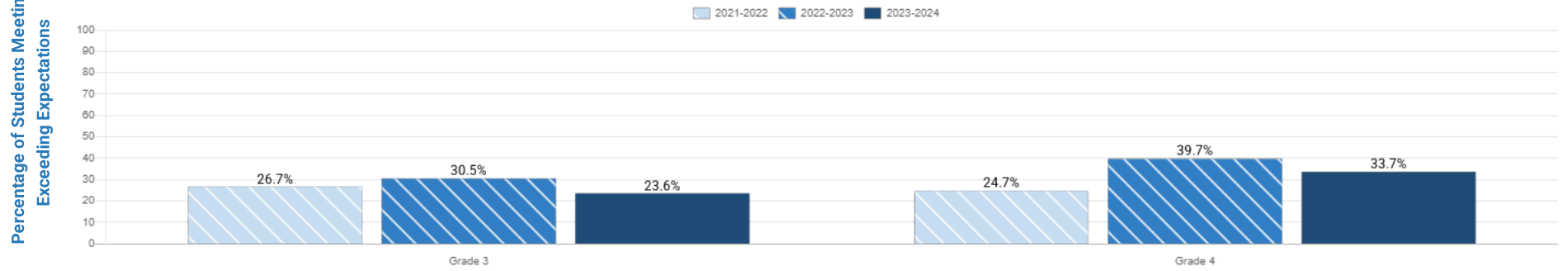

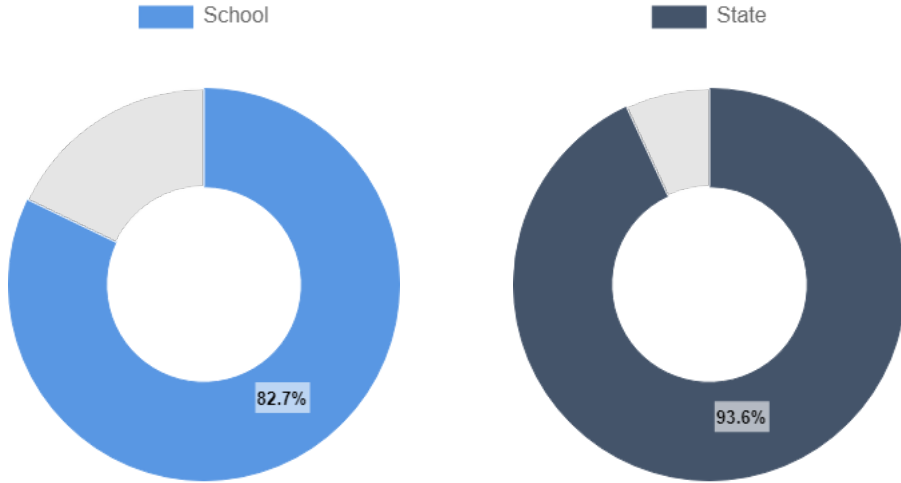

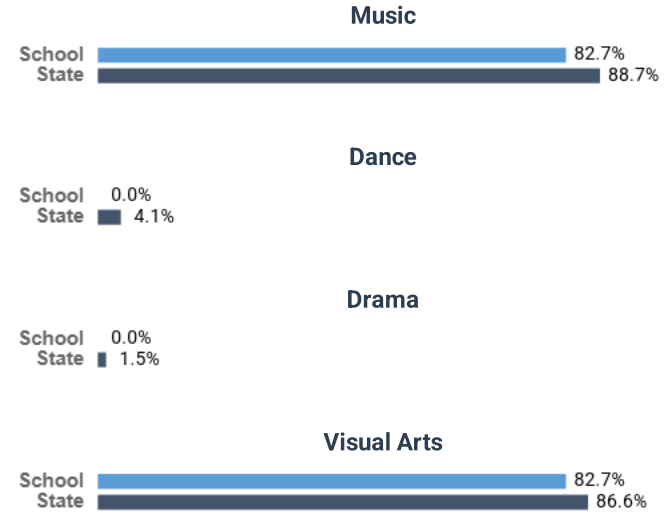

Students enrolled in one or more classes by discipline:



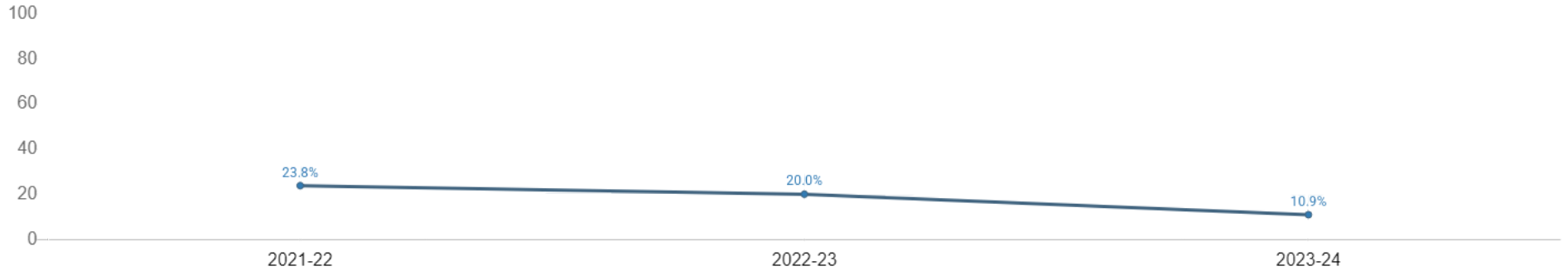

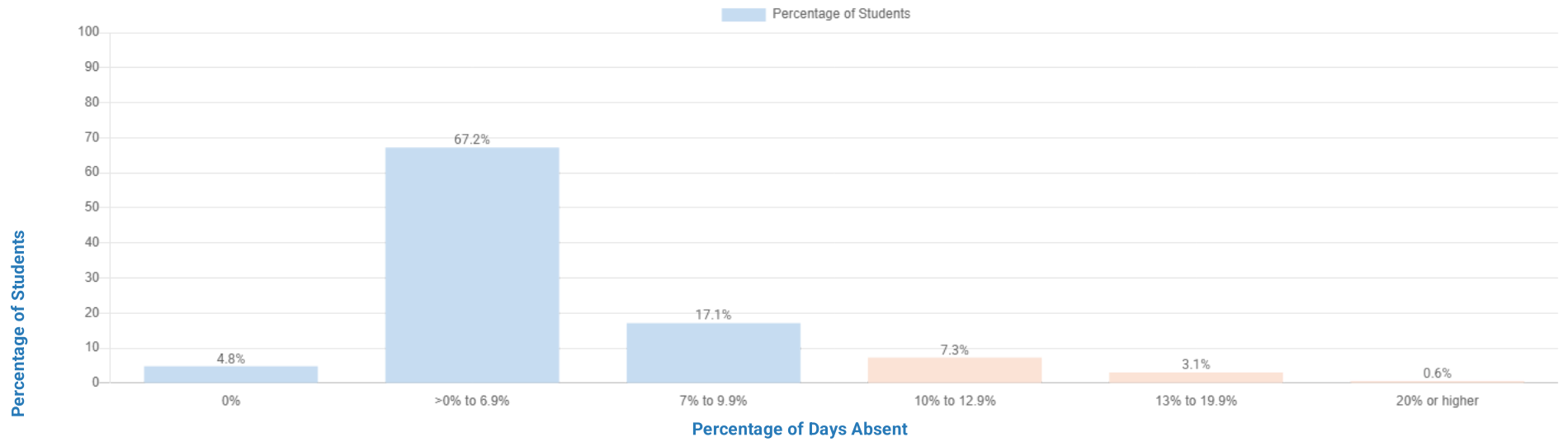

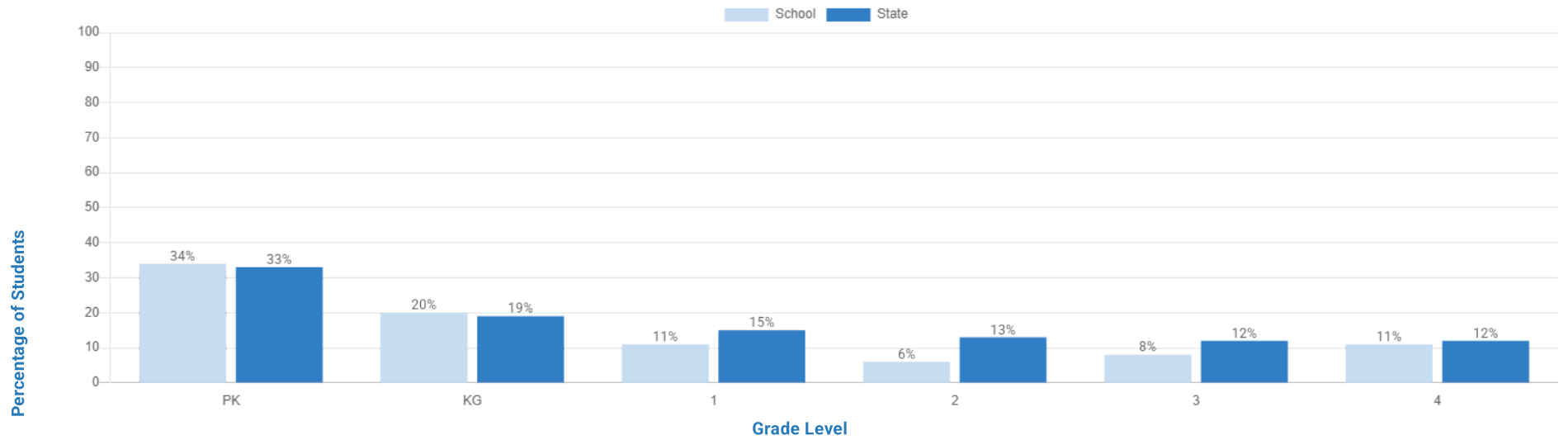

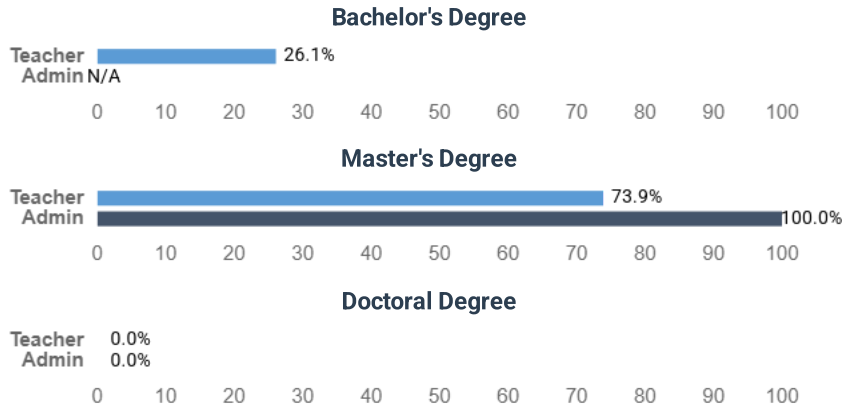

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Teachers use the NJSLs as a resource and guide to plan daily instruction for their students. Our teachers use HMH Into Reading for ELA and our core programs are Reveal Math for Mathematics and Pearson My World for Social Studies. Our Amplify Science Curriculum supports the Next Generation Science Standards for grades K - 4. Teachers use a variety of strategies to differentiate their instruction and teach in whole group, small group, and individual instructional groupings.



Clubs and Activities:

Book Fairs, Art Exhibits, Read Across America, Heritage Month Read-Ins and student led assemblies are just some of the activities our students enjoy annually. All of the students participated in activities such as Instrumental Music, Mini-Marathon, and Field Day. Before and After School Programs:
