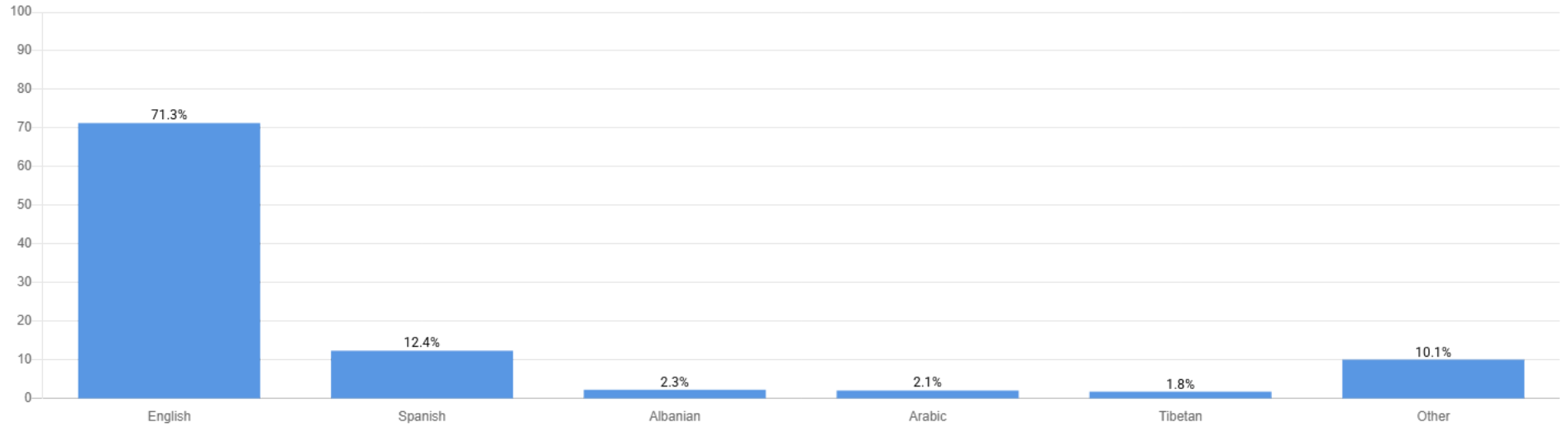

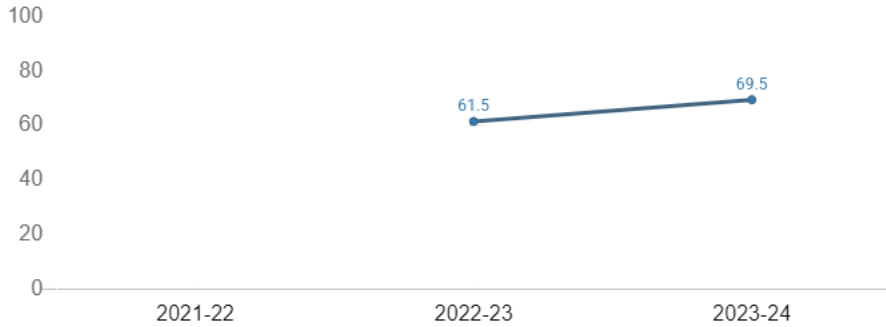

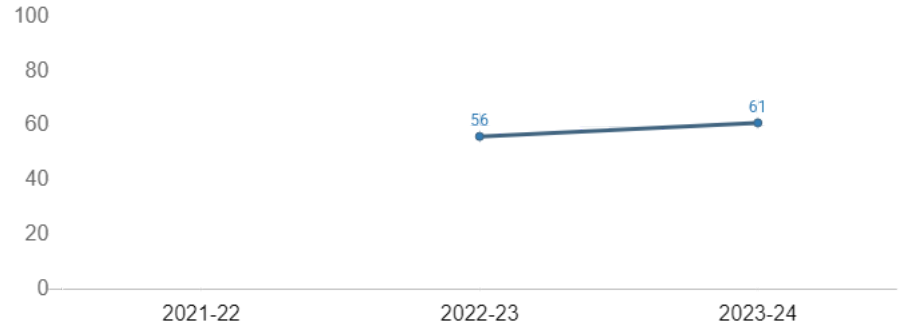

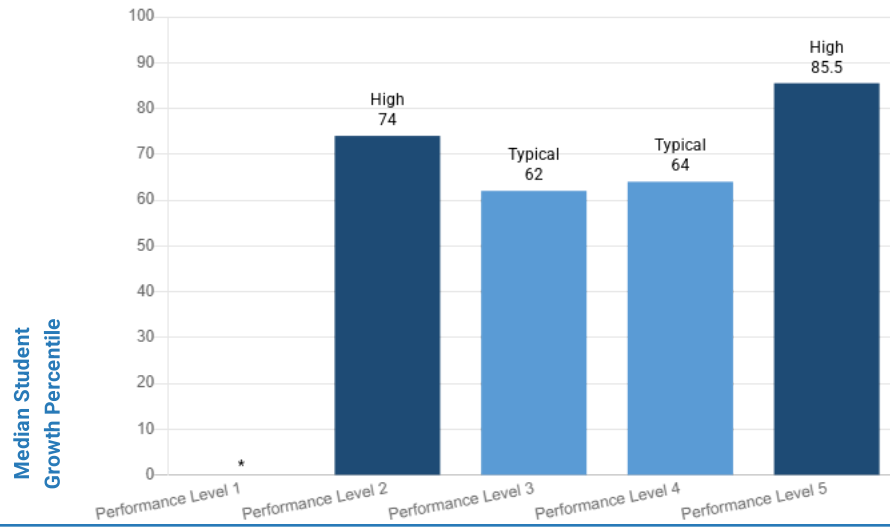

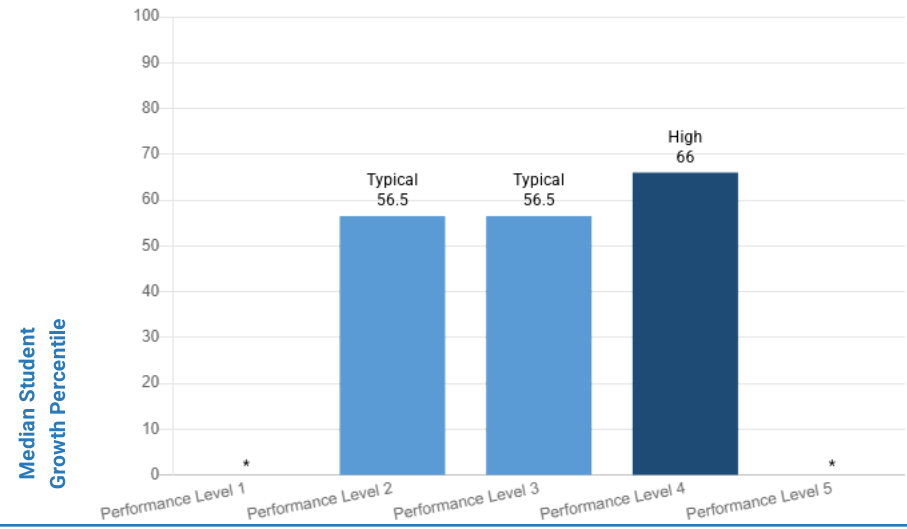

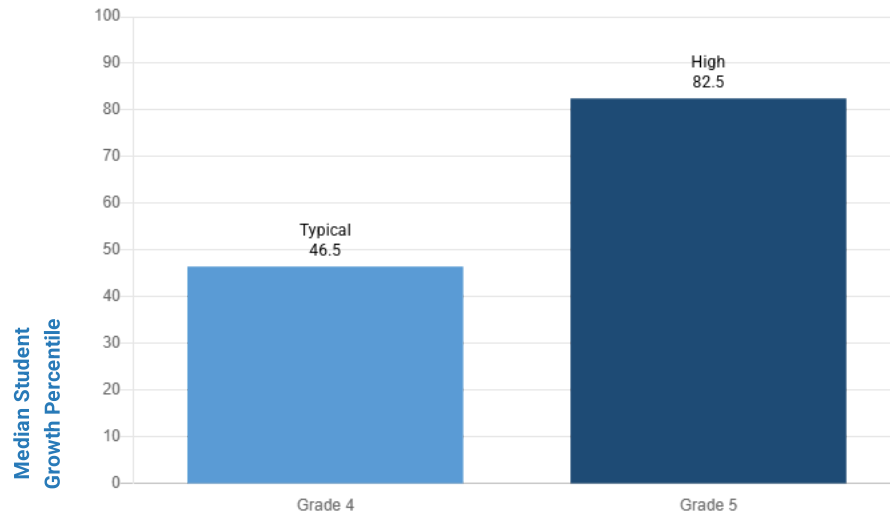

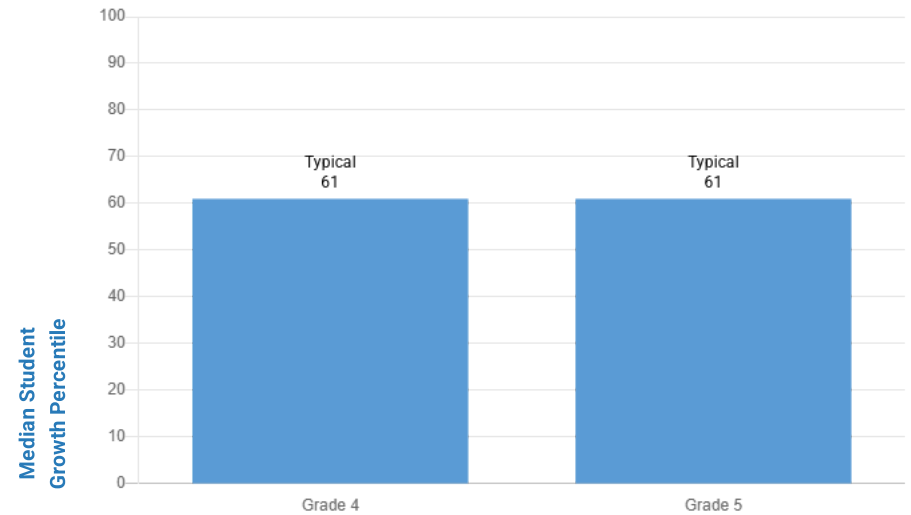

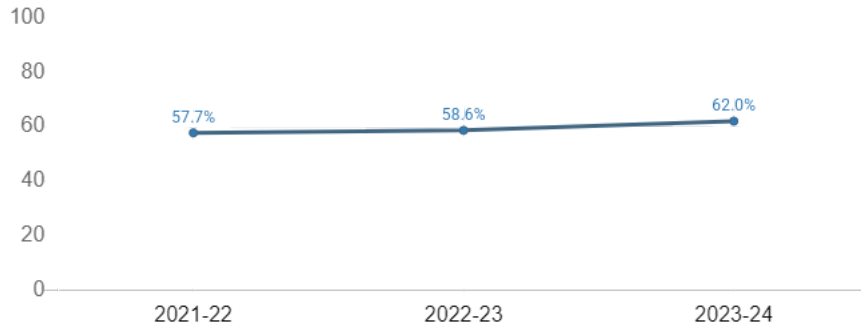

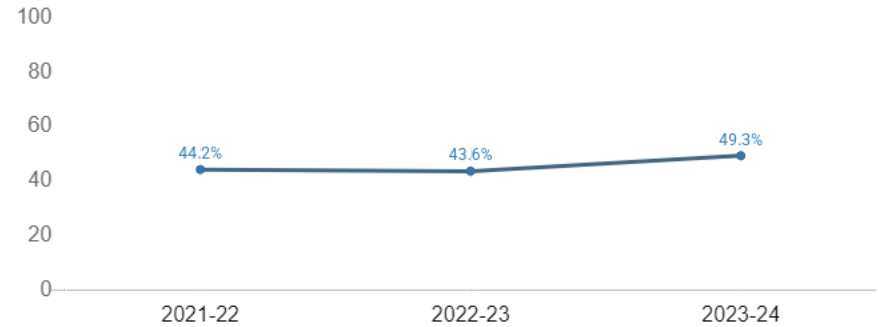
English Language Arts and Mathematics Performance Trends

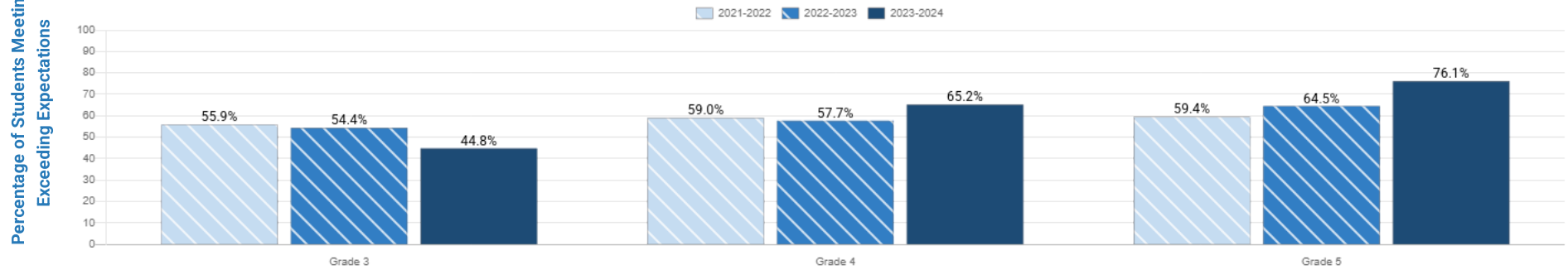

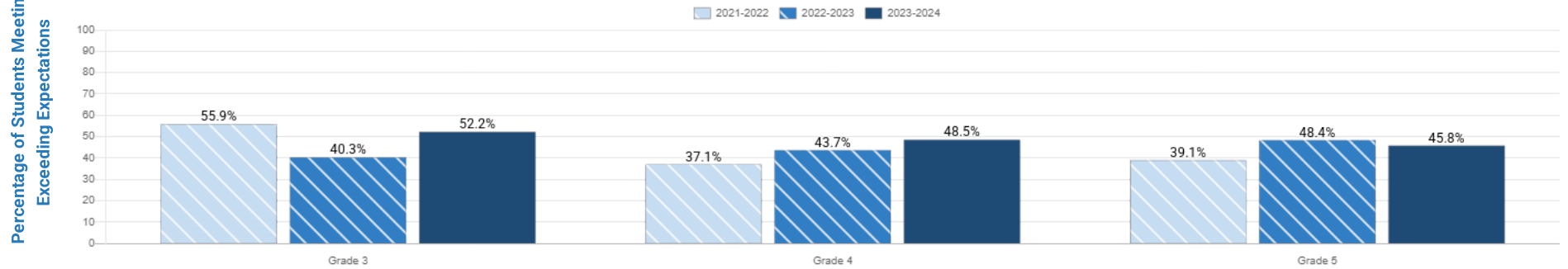

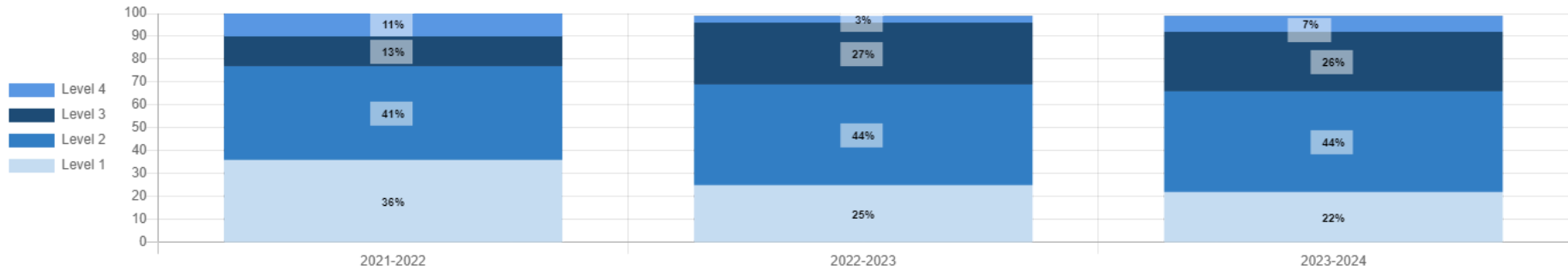

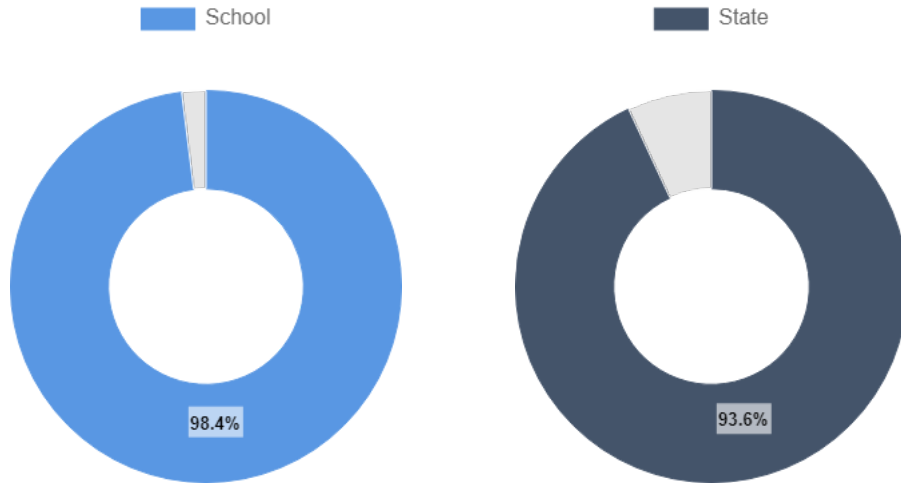

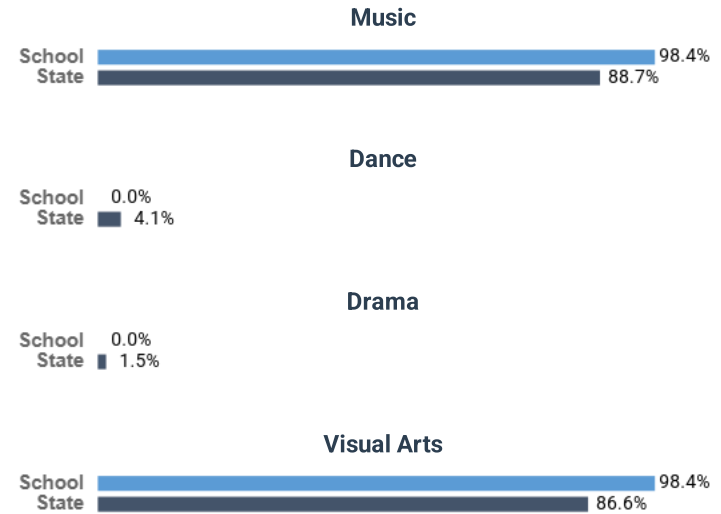

Students enrolled in one or more classes by discipline:



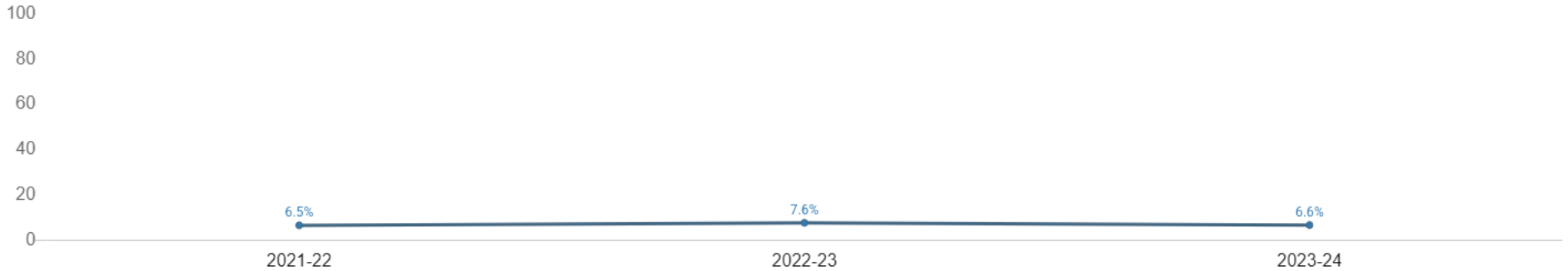

The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

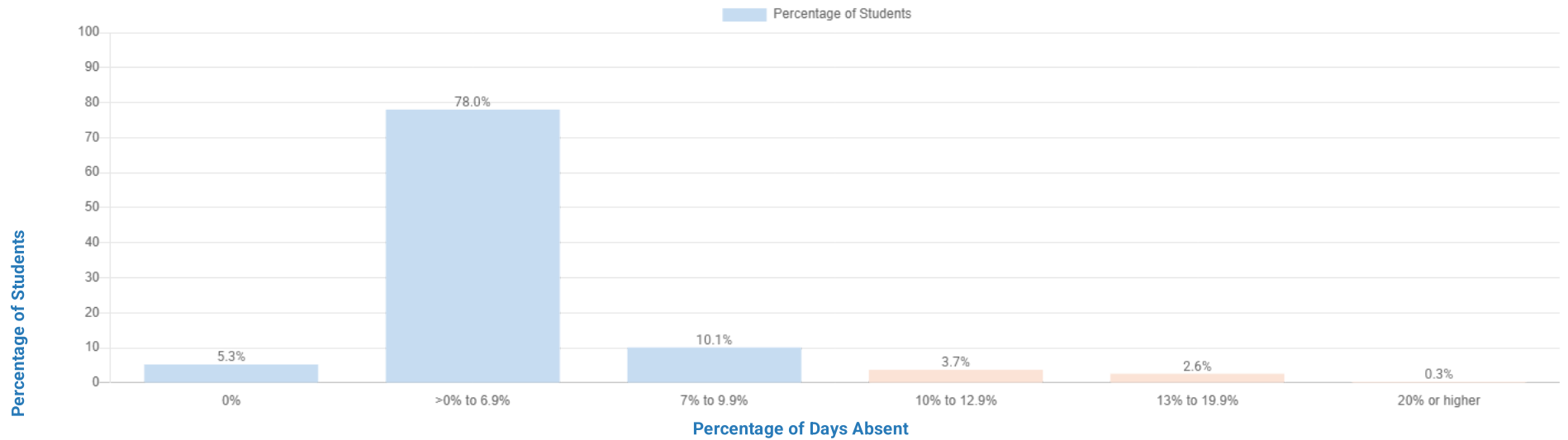

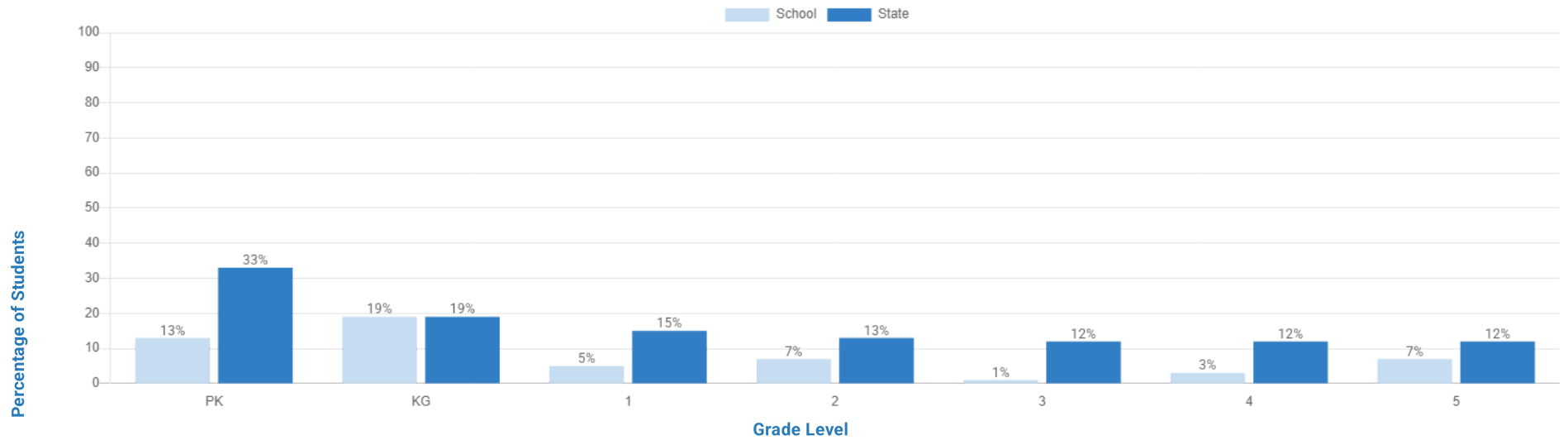

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. 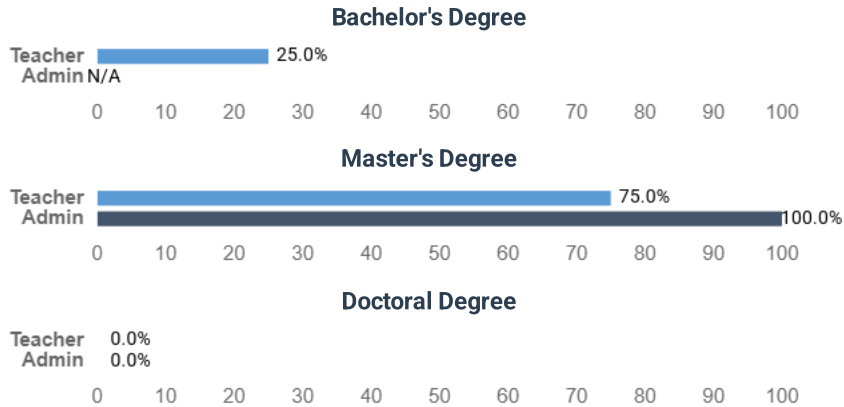

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. The academic curriculum at Lincoln School includes Reading, Writing, Mathematics, Science, and Social Studies. We implement the "Workshop" approach of teaching Reading and Writing. In Mathematics, we are utilizing the "GO MATH!" series to challenge our students on higher order mathematical operations. Our Guidance Department delivers Social Emotional Learning lessons within the classrooms. The special area courses include Art, Media, Music, Physical Education and World Language.



Clubs and Activities:

The Hasbrouck Heights School District sponsors a before and after school child care program, called the "Keys" Program, for Kindergarten through Fifth Grade Students at Euclid School. The morning program starts at 7:15 a.m. while the after-school program runs from 3:08 p.m. to 6:00 p.m. Certified teachers along with support staff supervise the program's activities, which includes playtime, snack time, homework time and project time.

Staff and Professional Learning:

Teachers at Lincoln are lifelong learners and attend a multitude of professional development. Staff development in the area of Readers and Writers Workshop is provided by Advancing Literacy. Mathematics teachers work in grade level professional learning teams with their building principal and district admin to ensure practices align with the current state standards. We are continuously sending teachers to the IMSE Comprehensive Orton-Gillingham 1 week Training.



Student Supports and Services:

Lincoln School focuses on meeting the needs of all students. Teachers themselves are available half hour once per week to provide extra help to students. We have a Reading Specialist and Basic Skill teacher. Our support service professionals support our comprehensive instructional programs. They include: two Speech/Language Therapists, an ESL Teacher, an Occupational and Physical Therapist, a Behaviorist and a School Social Worker. We also have an I&RS Team and offer before and after school extra help.



Student Health and Wellness:

Lincoln School's food service provider offers a healthy choice menu for students/parents. Students receive Physical Education three times a week; 43 minutes per period. They also have a 30 minute recess period each day.

In order to address the impact of Covid 19, the HHSD offered Summer Enrichment in the areas of Reading, writing and Mathematics during the month of July for 40 hours for all current K-5th grade students who wished to attend. During the School year the Euclid School was provided an additional Basic Skills Teacher to support at risk students. ESSER funds provided the teaching staff that made possible the summer enrichment program, the Basic skills teacher as well as PD in Math. While ESSER funds did not provide for an additional Guidance Counselor for the Elementary School, the District incurred the cost to ensure that this addition would remain beyond Covid. Each of the two Elementary Schools now have a full time guidance counselor within the building. The Guidance Counselors teach Social Emotional Learning to the whole class, small group and individuals. The Guidance Counselor also leads the Intervention and Referral Team.

The day begins with the Flag Salute, a Core Value announcement and student/staff birthday announcements. Instruction immediately follows until 11:38 a.m., at which time the entire school breaks for a one hour lunch/recess period. Faculty, staff, and students return to their instruction until the end of the day. At this time, our students are dismissed directly to their parents/guardians. Safety is our number one priority at Lincoln School. No one is permitted within the building without permission from the office staff and visitors are met in our Welcome Center. We have a strong relationship with the Hasbrouck Heights Police Dept which include our Class III Officer(s).
