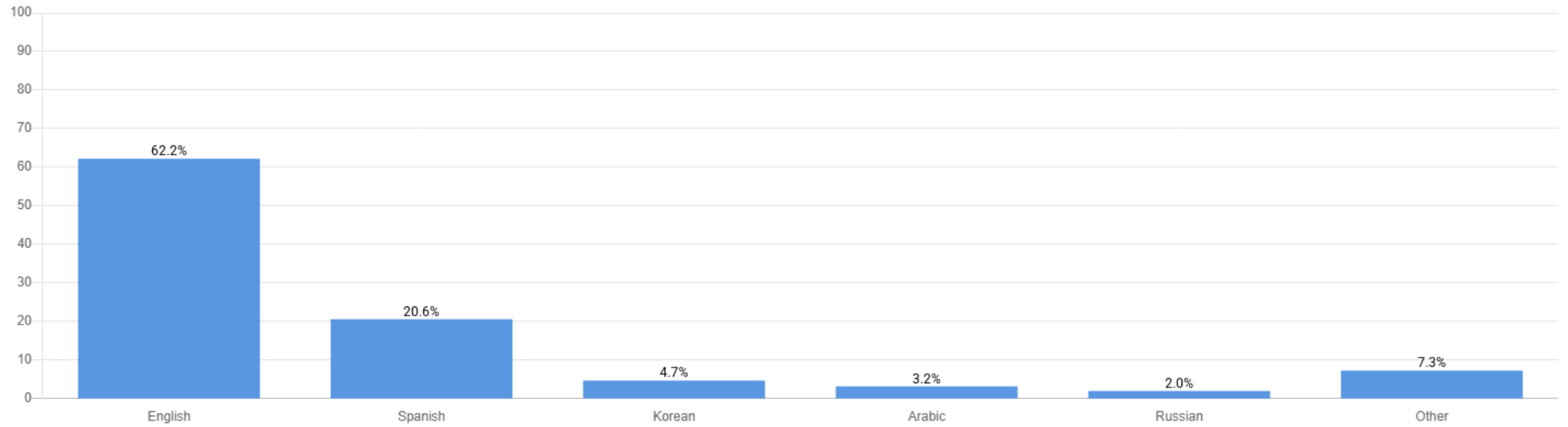

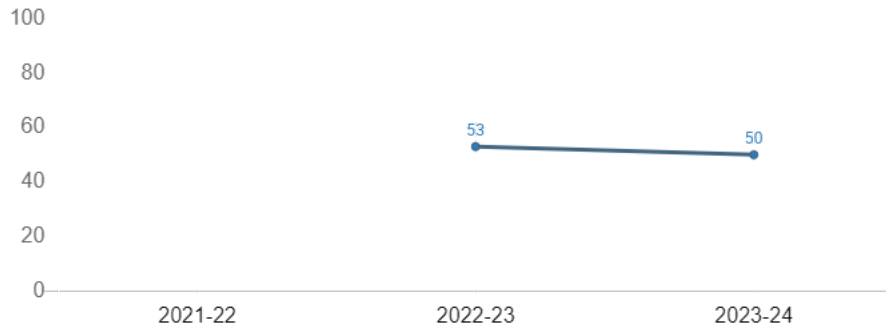

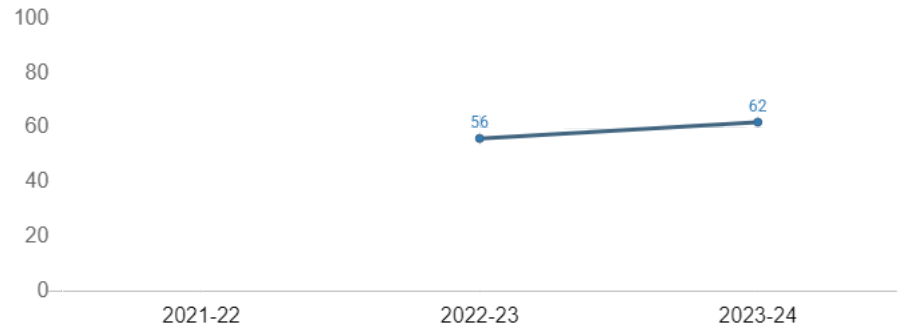

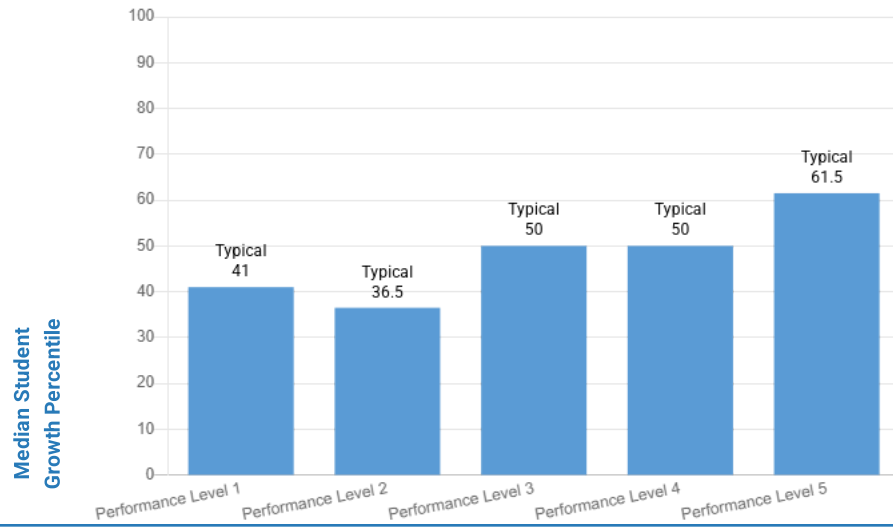

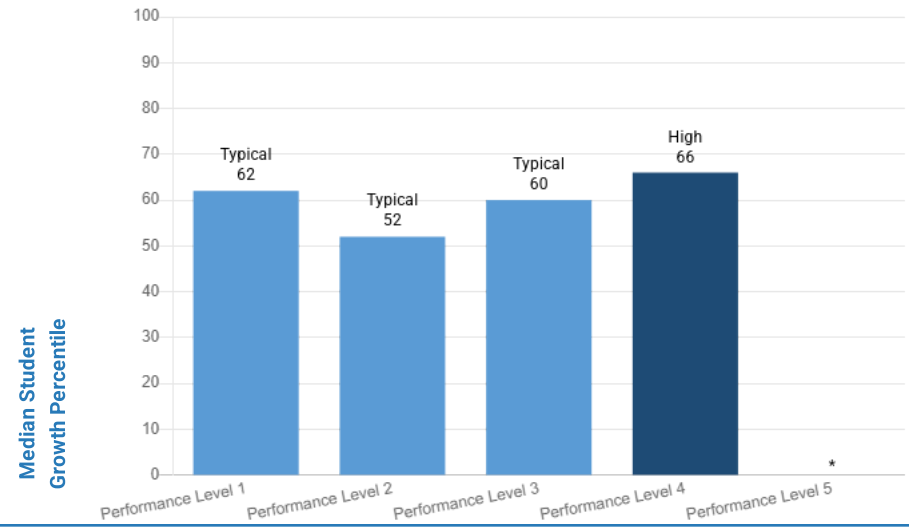

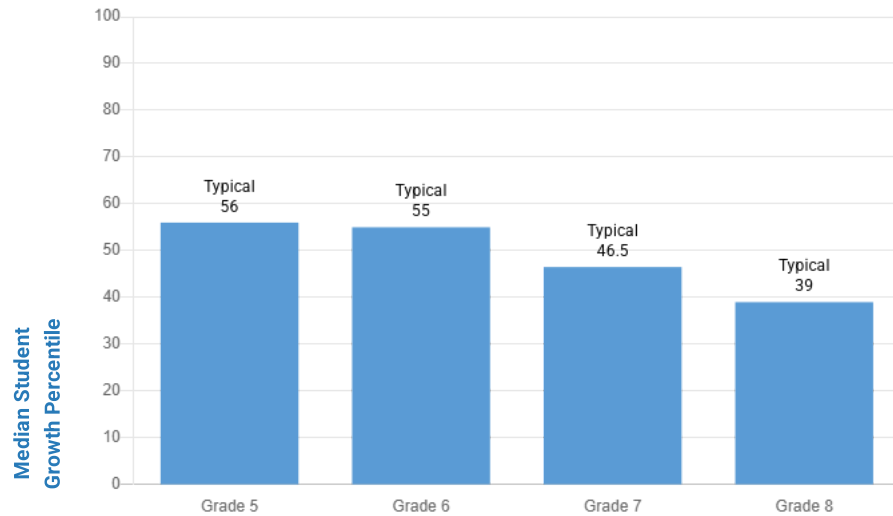

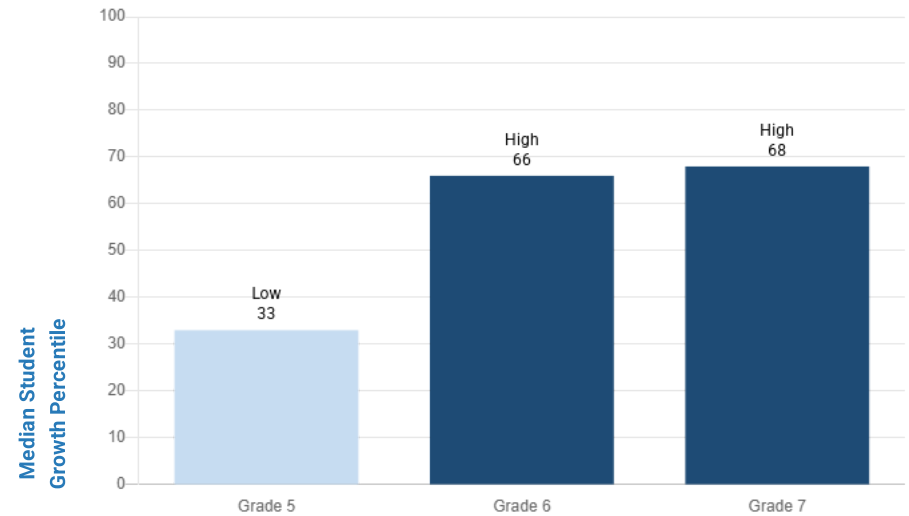

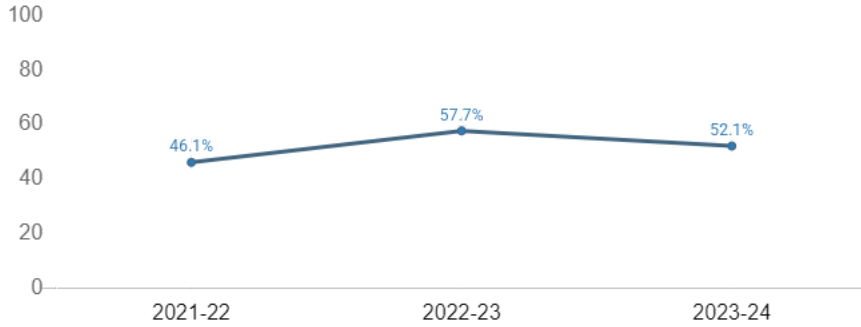

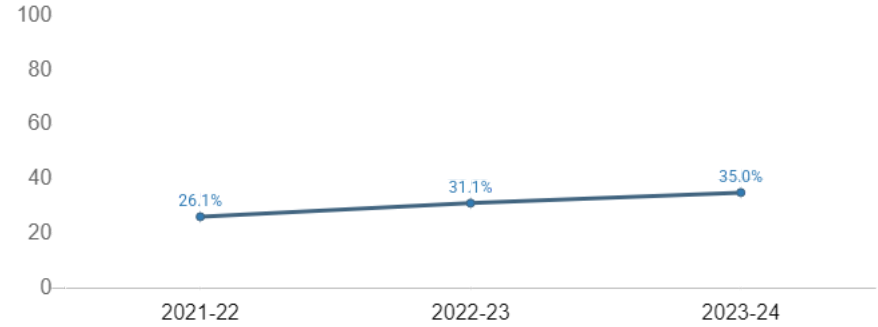
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 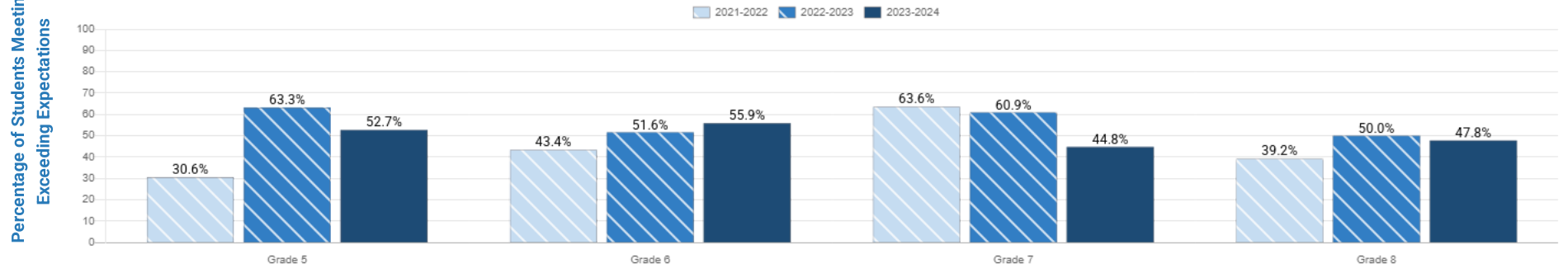

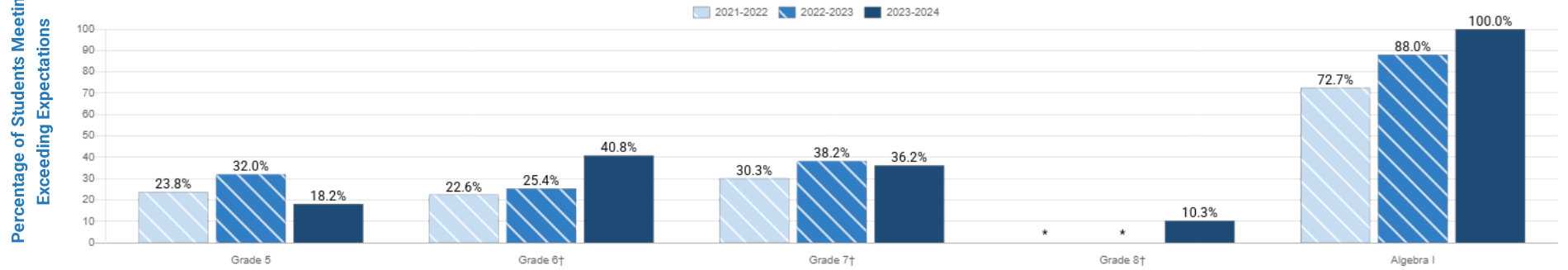

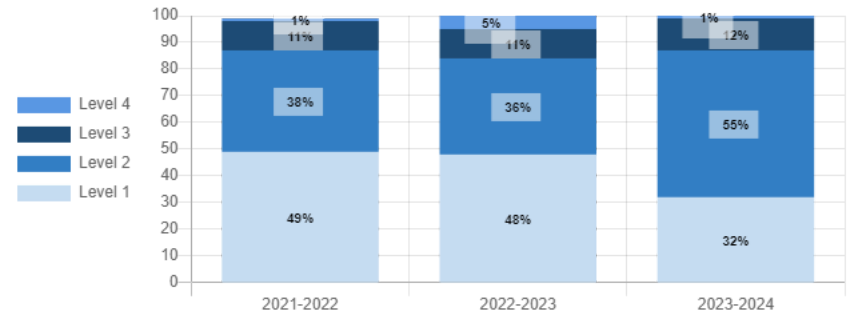

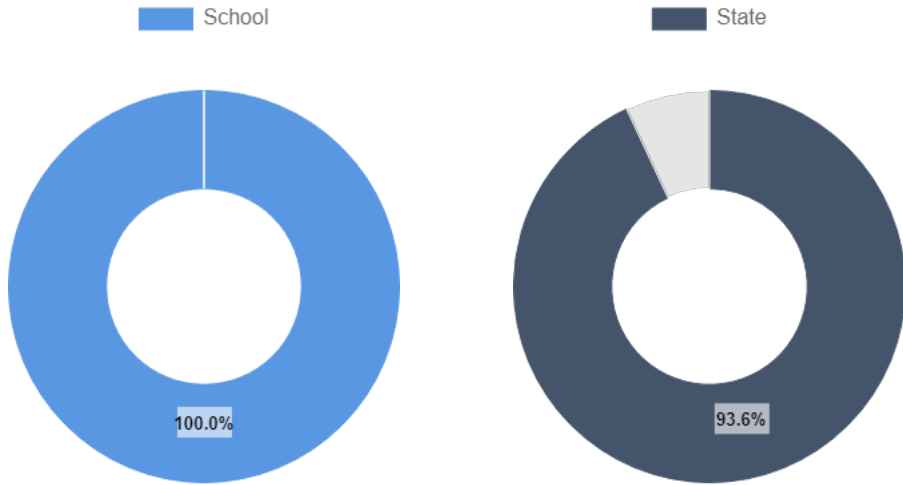

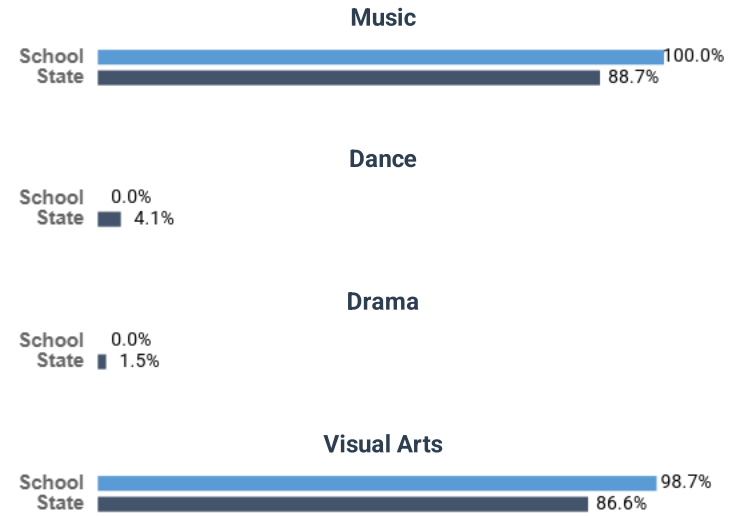

Students enrolled in one or more classes by discipline:



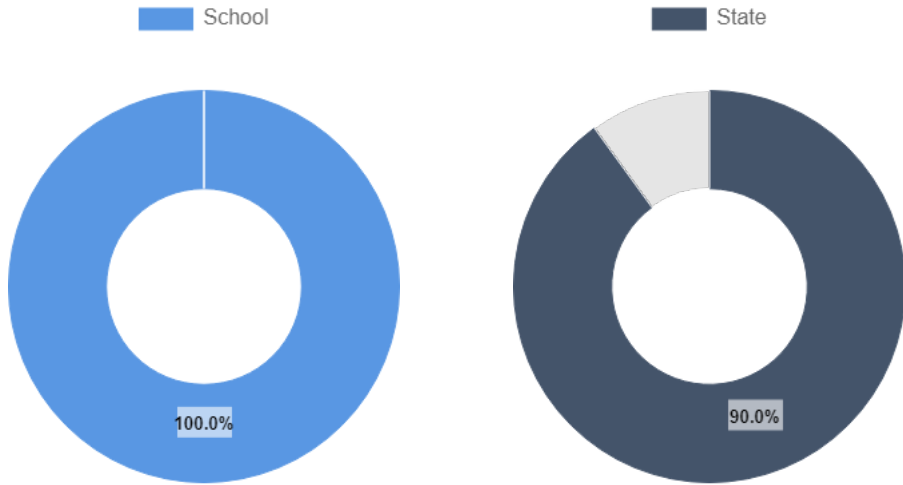

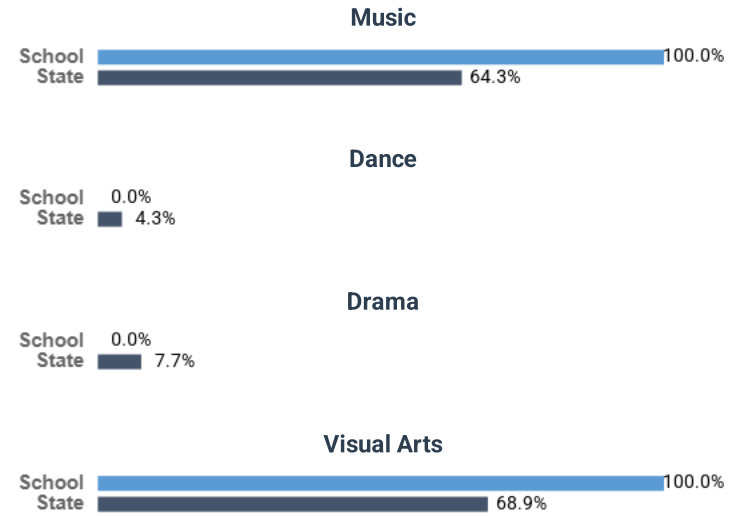

Students enrolled in one or more classes by discipline:



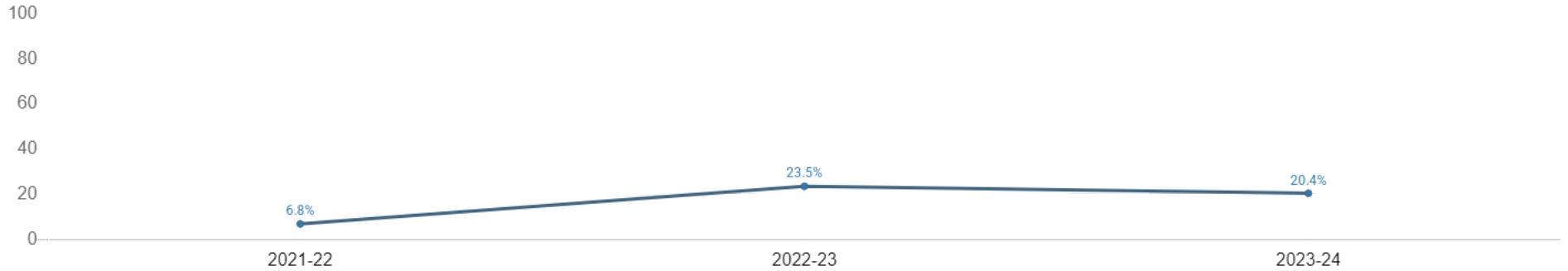

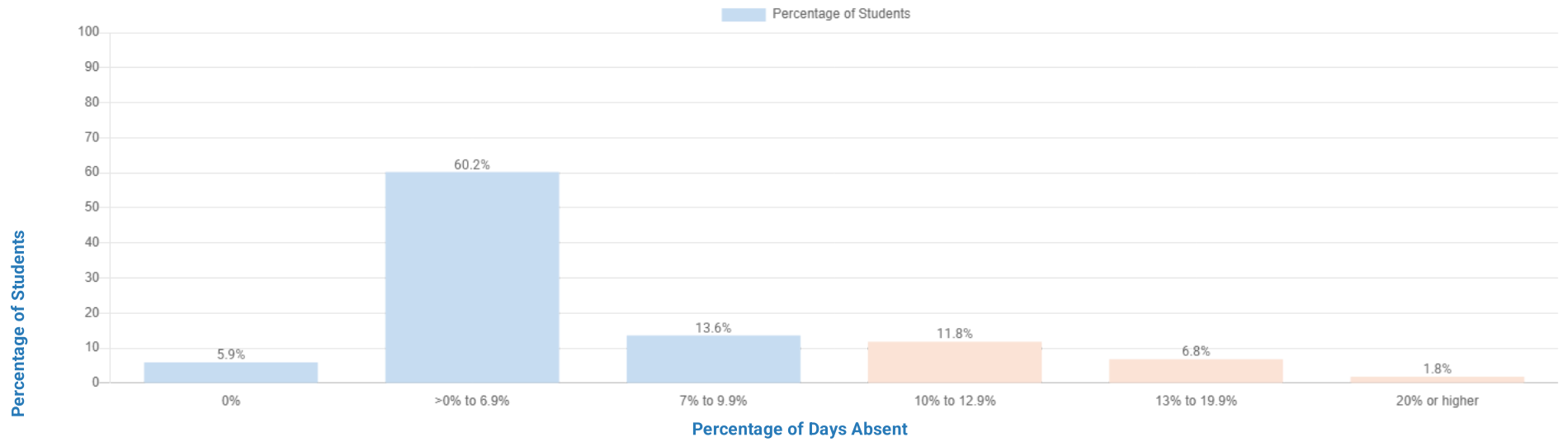

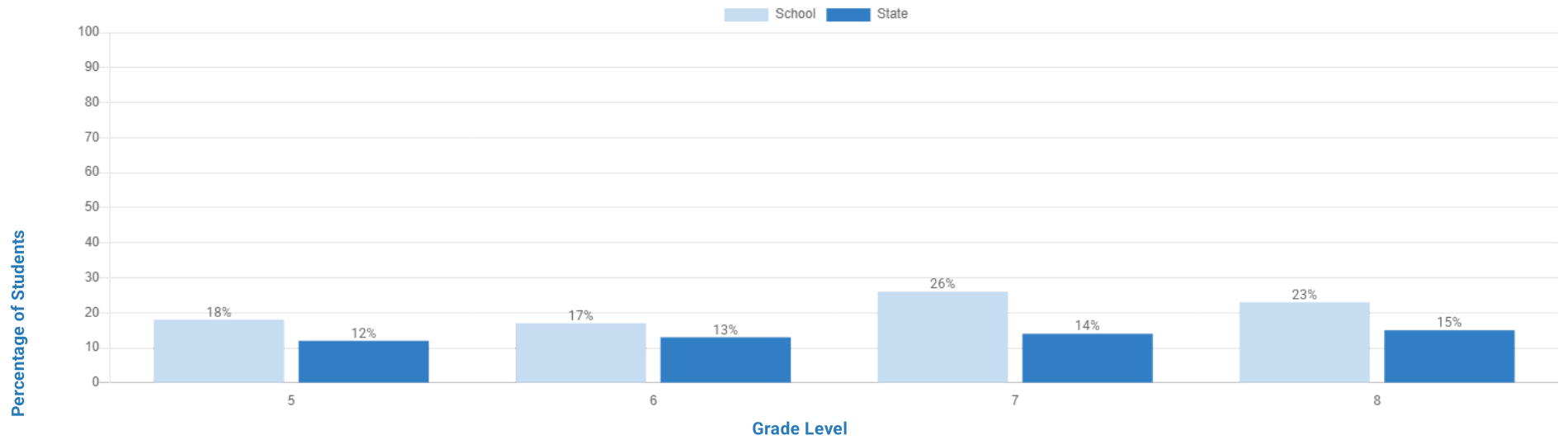

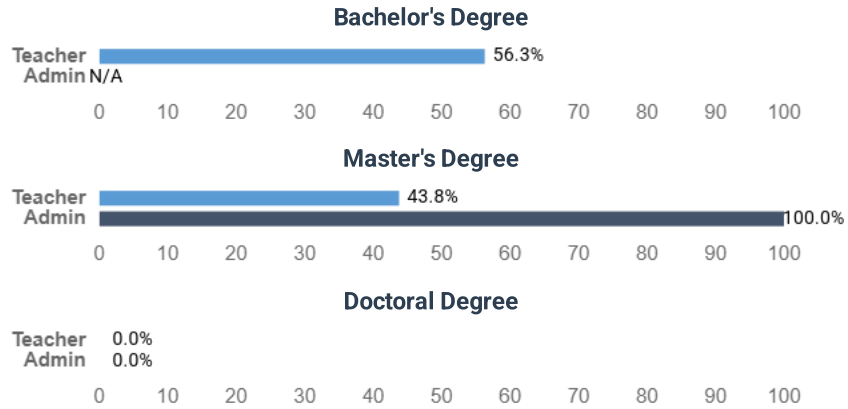

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. I&RS assists staff members experiencing difficulty addressing specific needs. The ESL program supports learners with an inclusion and pull out model. We have a social worker who strives to help the students develop cognitive skills, emotional maturity, and social awareness. For the 23-24 school year, we continued to contract with Thrive. Thrive provides therapeutic services to both general education and special education students supporting their mental well being. We provide a least restrictive environment mainstreaming our classified students into most core subjects.



Student Health and Wellness:

Students health was consistently monitored during the 23-24 school year. Our school nurse audited absences on a daily basis checking in with families while providing the quarantining guidance. Our social workers and guidance counselors also checked in on the students emotionally holding sessions on an as needed basis. Our school lunch program provides nutritional breakfast and lunch following all guidelines. The Nurse coordinates health screenings yearly, covering, eye exams, scoliosis screenings, dental screenings, & hearing tests.



Parent and Community Involvement:

Our Parent/Teacher Association continues to be an integral part of our school community. They continued to collaborate with teachers and administrators to ensure that our students are provided meaningful programs and events. They facilitated the Scholastic Book Fair, dances, winter wonderland, Holiday Shop, and funded programs for our students.
