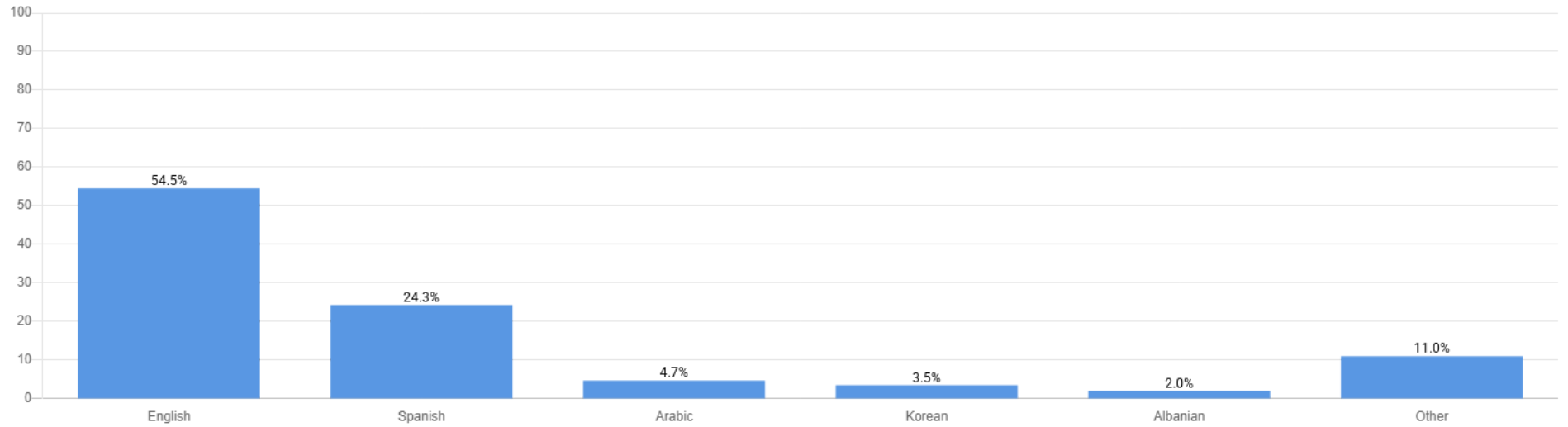

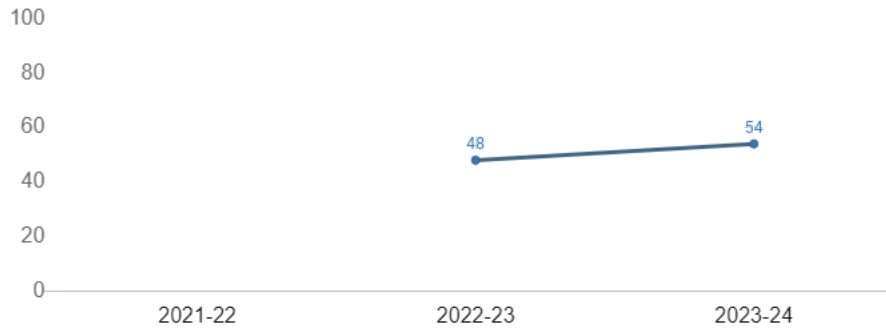

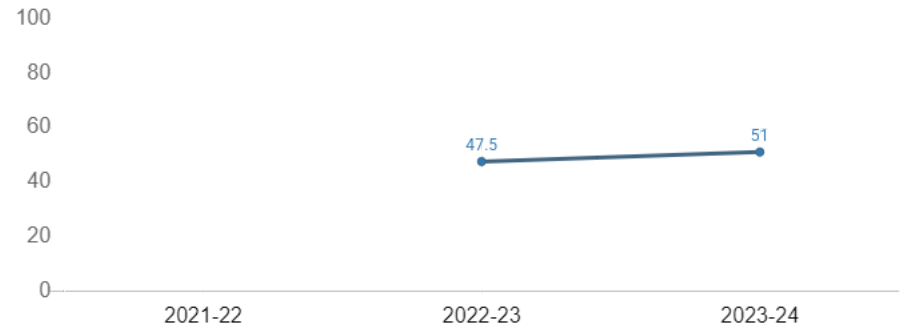

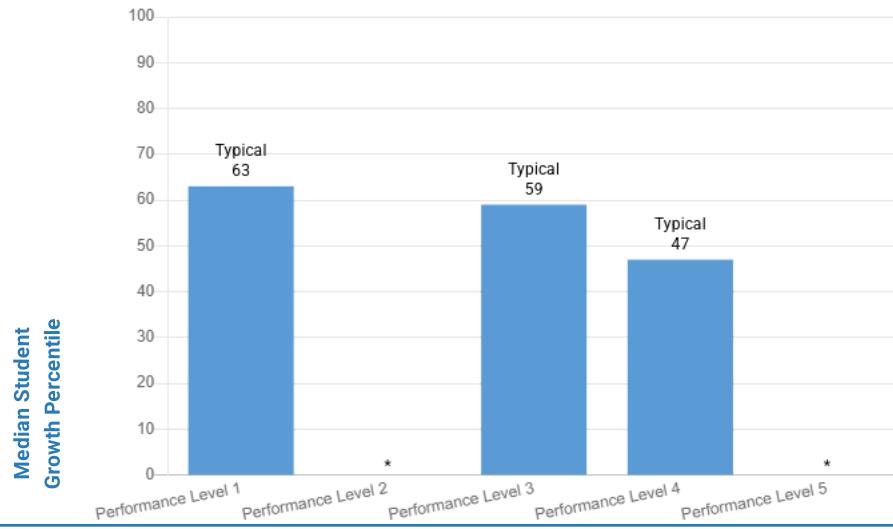

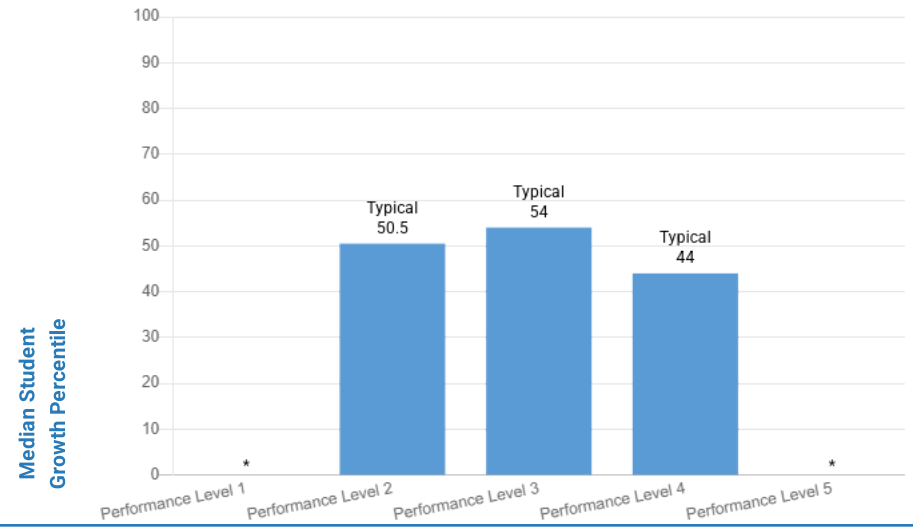

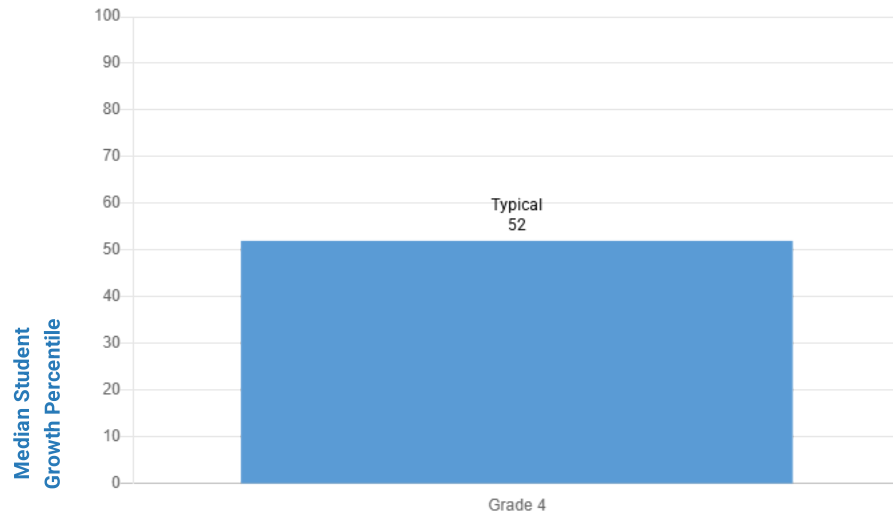

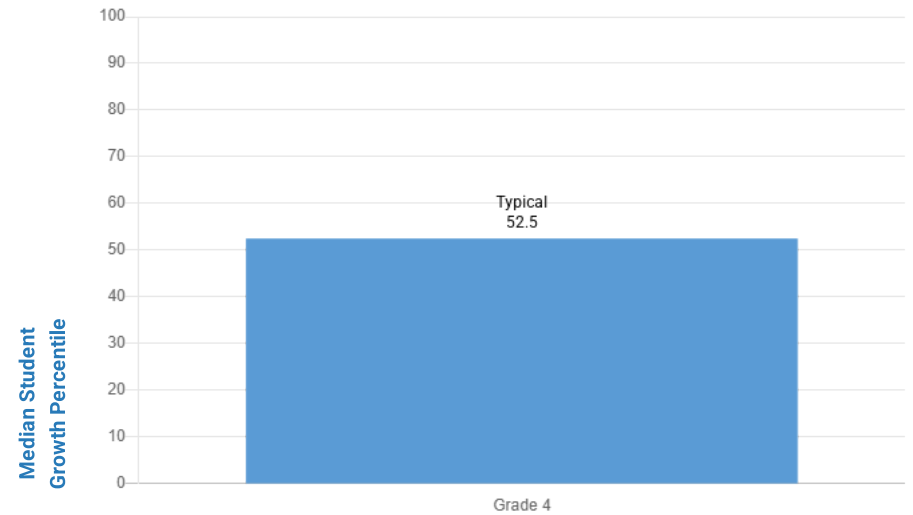

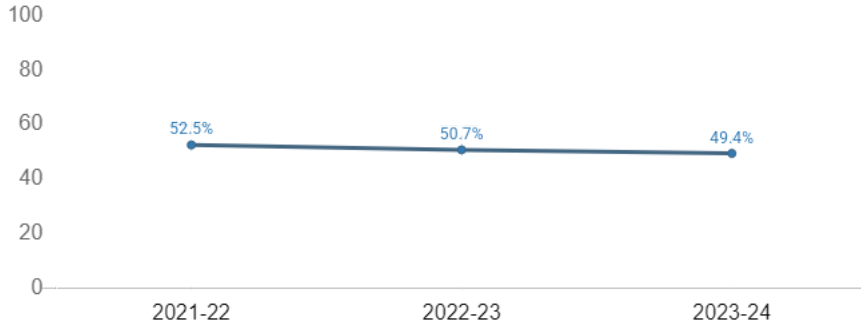

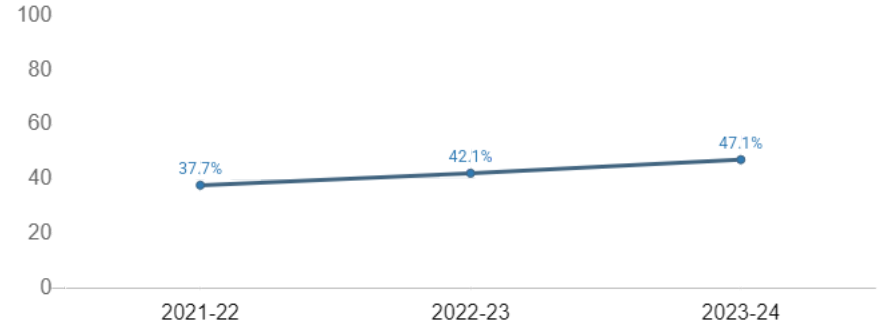
English Language Arts and Mathematics Performance Trends

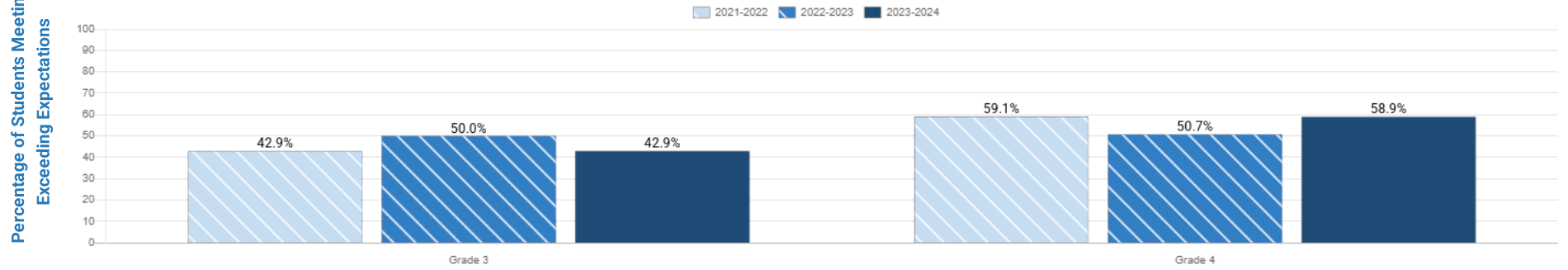

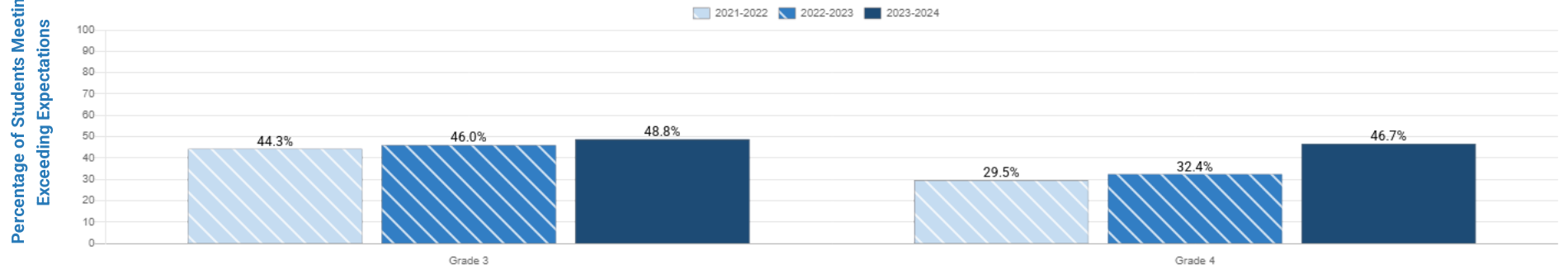

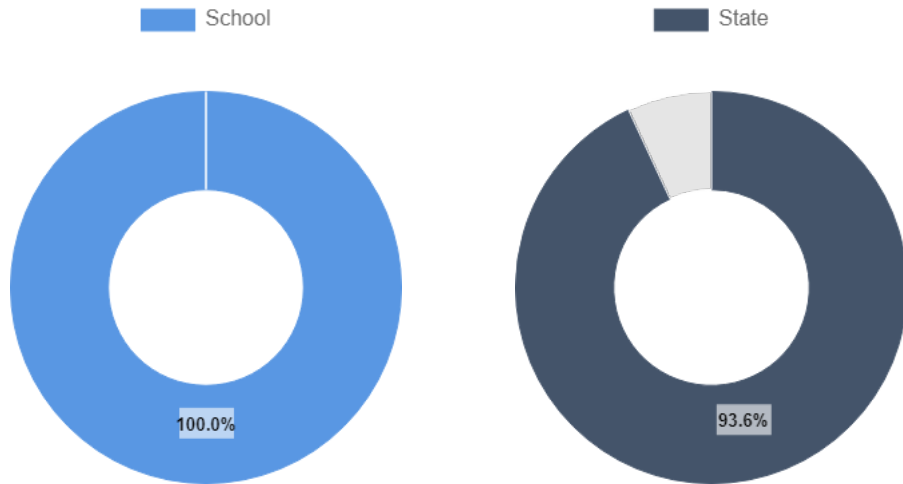

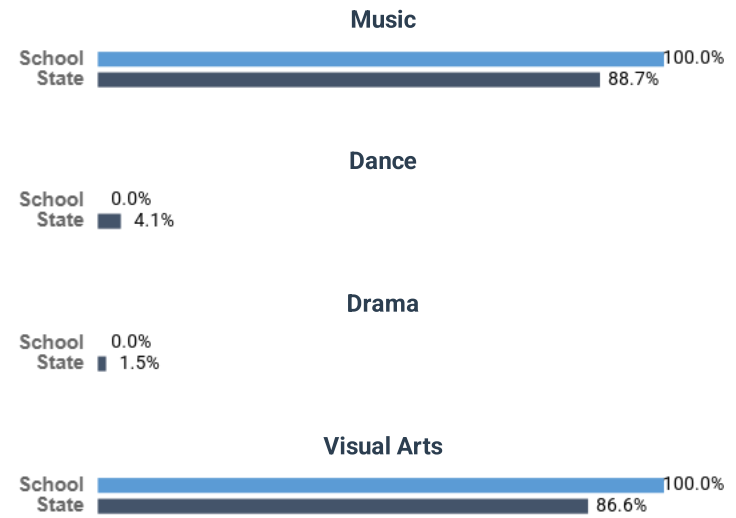

Students enrolled in one or more classes by discipline:



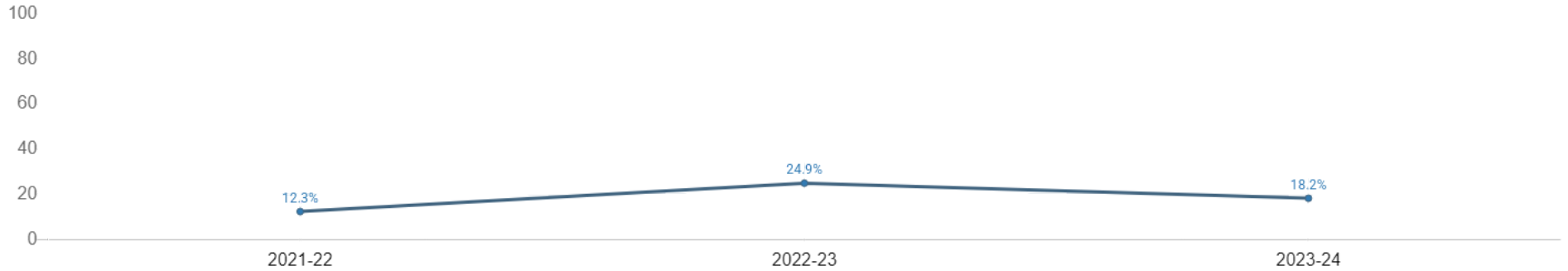

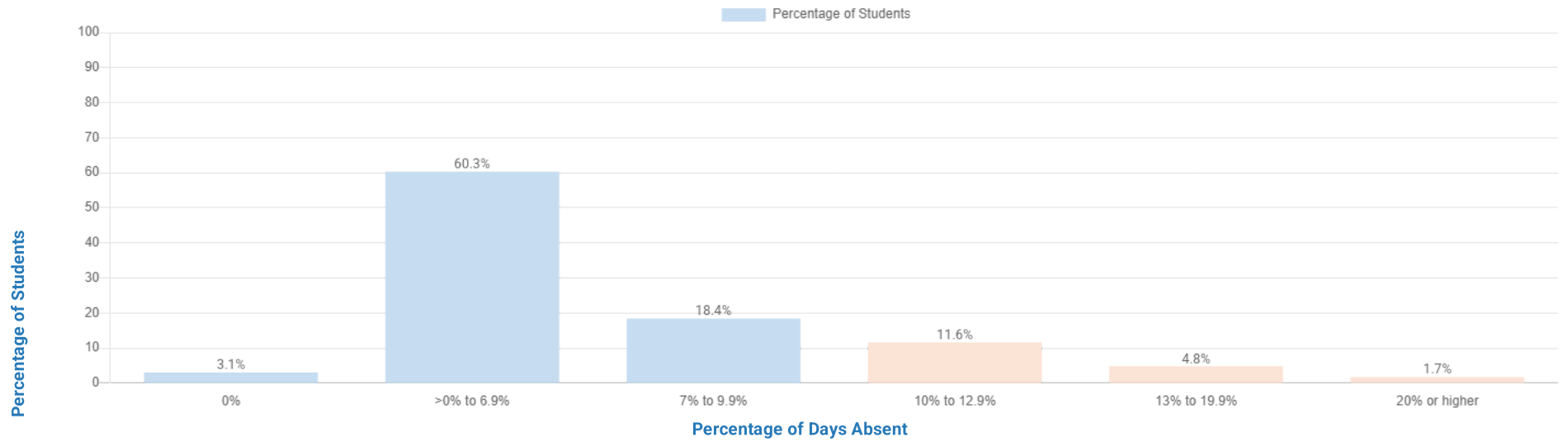

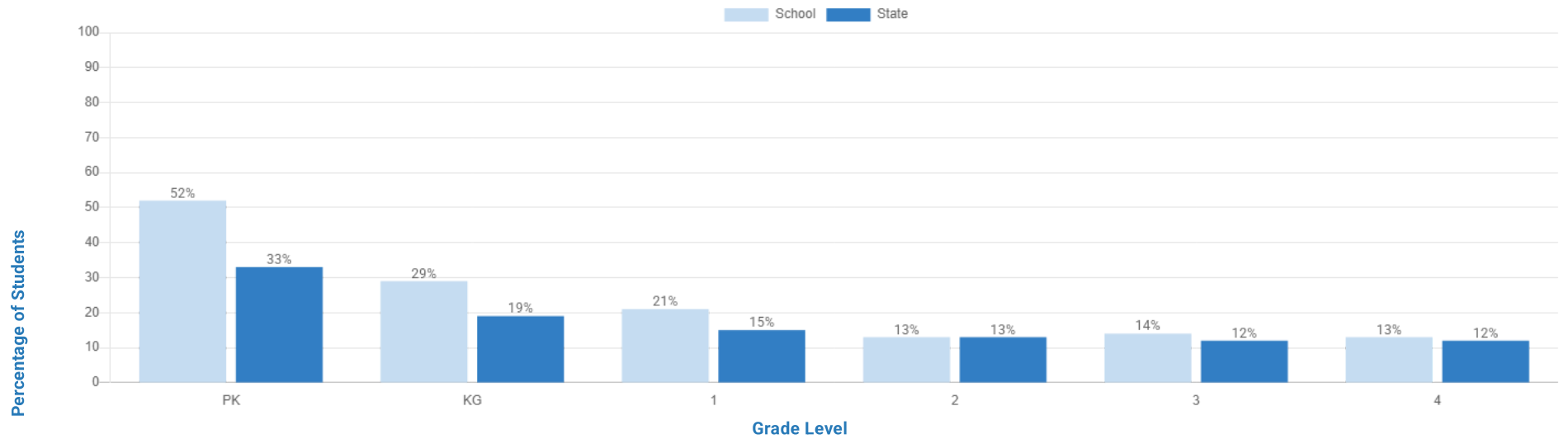

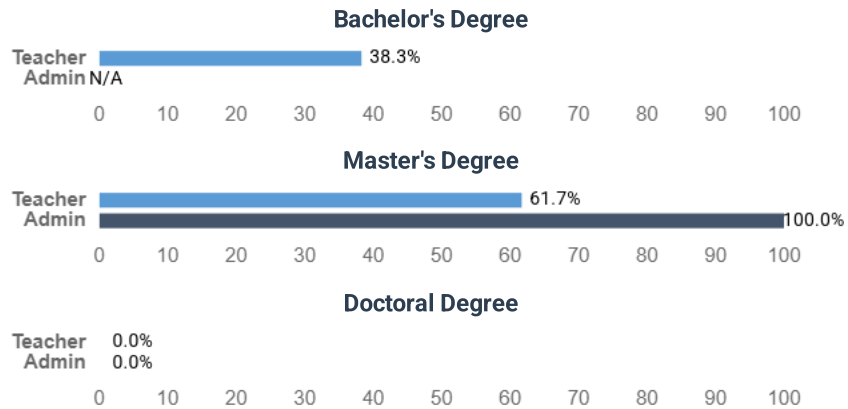

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. The I&RS team remains committed to working collaboratively to assist staff members experiencing difficulty addressing specific needs. Our ESL program also continued to support learners in all facets of learning. Our school social worker continued to work with students helping them develop with their social and emotional needs. Lastly, continued to provide students with the least restrictive environment mainstreaming students into all core subjects.



Student Health and Wellness:

Students health was consistently monitored during the 23-24 school year. Our school nurse audited absences on a daily basis checking in with families while providing the quarantining guidance. Our social workers and guidance counselors also checked in on the students emotionally holding sessions on an as needed basis. Our school lunch program provides nutritional breakfast and lunch following all guidelines. The Nurse coordinates health screenings yearly, covering, eye exams, scoliosis screenings, dental screenings, & hearing tests.
