









Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.



LHS offers a variety of Advanced Courses and programs for our gifted and talented students including 17 AP Courses, the Anatomy and Physiology Summer Program, The Felician University/Lodi High School Academy of Research and Advanced Academics and the Junior Academy for gifted 8th grade students. An increased focus on reading and writing across all curricular areas has been a priority for preparing students for success in college and 21st century careers. We have added courses in Computer Science, Engineering and Construction Technology as part of an increased focus on STEM related course offerings. In the medical field, we are offering courses in Principles of Bio Medicine, Dynamics of Healthcare and Premed Survey: Science of Health Profession.

Before and After School Programs:

We offer Saturday instruction providing students with tutoring by certified Math and Language Arts teachers. LHS also offers a before school and after school homework club providing tutoring and assistance. An after school writing program is offered to assist students with writing assignments throughout the curriculum as well as assisting them with essays for their college entrance and scholarship applications. Summer programs provide supplemental instruction in Math and Language Arts. Our summer Anatomy and Physiology Course supplements instruction for advanced students who plan on pursuing medical careers. LHS offers a summer STEM Program for students in Grades 5-8 each summer in collaboration with the Boys and Girls Club Leap Program. LHS offers an Extended Year Program for IEP Students in all areas of instruction.



Lodi High School is committed to providing our Staff with high quality professional learning opportunities. New teachers are provided with a summer orientation program as well as a first year mentoring program which provides them with rich opportunities to develop effective instructional practices. Professional Development days and after school PD Meetings provide teachers with the opportunity to collaborate with their peers in Professional Learning Communities to revise and develop curriculum and share best practices for implementing highly effective instructional strategies. Our Educational Technology Committee researches and experiments with new educational technology applications and provides turnkey training to the instructional staff. A continued focus for professional development has been placed on the dangers of anxiety related disorders, strategies for relieving anxiety and for supporting student, teacher and staff social emotional wellness.



At LHS we offer a variety of programs to support the college process such as college admissions counselor information sessions, EOF Advisory Panel, ML College Parent Night, College Visit Field Trips, Senior Parent College Night, Junior Post-Secondary Planning Night, College Kick Off Week, National College Decision Day, NJ Stars Information Session, Instant Decision Day, FAFSA Day, Alumni Panel and Career Week. In addition, all students in grades 9-11 take the PSAT NMSQT at no expense to the student. Post-graduate plans include the following: 27.4% - 2 Yr College, 62.5% - 4 Yr College, 3.5% - Career Education, 3.5% - Employment, 3.1% - Military. Recent graduates have been accepted to Princeton, Stanford, Columbia, Johns Hopkins, Duke, Vassar, Amherst, UCLA and other highly selective and prestigious post-secondary institutions. Several students in the top 15% of the senior class participate in the NJ Stars Program which affords them the opportunity to attend Bergen Community College.

Student Supports and Services:

Lodi High School provides a Comprehensive Program which provides a wide array of support services to meet the diverse needs of all students. Our programs include support services for Special Education Students, students with 504 plans and English Language Learners. Our school counseling program provides supports and services which address our students' academic, social-emotional, and mental health needs. School counselors provide students with a wide variety of post-secondary planning events and individual counseling sessions to assist them in developing and pursuing their individual post-secondary plans. Our Intervention and Referral Services Team provides our teaching staff with support and guidance to develop high quality I&RS plans which are designed to assist students who are experiencing difficulties. The School Counseling Department provides group counseling sessions on topics such as transitioning for new transfer students and post-secondary transitioning for HS seniors.



Lodi High School is committed to providing a comprehensive Health and Wellness program to our students. A Driving Safety Program was instituted in collaboration with Hackensack University Medical Center. Students participated in a hands only CPR curriculum through their Health Courses. Several substance abuse prevention programs are offered annually by the SAC in collaboration with the Bergen County Sheriff's Department.



Parent and Community Involvement:

The Genesis Parent Portal provides parents with timely information regarding their student's grades, attendance and conduct. ESL courses are offered to our students' parents in collaboration with Bergen County Technical Schools. Parents are invited to attend PTA Back to School Night and Holiday Programs. A senior/junior Parent College Planning Night and an ELL Parent College Night is offered through our School Counseling Department. Our Student Resource Officer provides a mandatory Pre-Prom Safety Meeting for all parents. Students participate in a Thanksgiving Food drive and a Holiday Toy Drive. LHS conducts a Scholarship Night where students receive scholarships from Local Businesses, Lodi High School Clubs and other Community Organizations.

The facilities at LHS help to create a strong learning environment for all students. The halls are decorated with orange and blue motivational quotes and statements which are directly related to our school's core values. This creates a sense of school spirit and high expectations for academic achievement and personal growth. Our modern classrooms are equipped with interactive Promethean panels, high speed hard wired and wireless internet access with access to chromebook carts. Chromebooks are provided to all students. Our Media Center has a computer lab, a College and Career Center, and Innovations Lab. Our athletic facilities include an oversized gymnasium, state of the art Turf Athletic Field, Wrestling/Auxiliary Gymnasium, a recently renovated Athletic Trainer's Facility, and newly equipped weight room. We have added a multipurpose, state of the art Bio/Chemistry, Anatomy, Pre-Medicine Lab and hope to continue renovating science labs.



Lodi High School has a Comprehensive School Safety program. The school is monitored by our School Resource Officer and two School Safety Officers. Additional monitoring is provided through an indoor/outdoor security camera system. We conduct monthly School Security Drills to ensure that all students and staff are trained in how to respond to school security events. In the past, we have provided our staff with training in Trauma Informed Instruction and provided all district staff with a one day Interactive Threat Seminar provided by Tomahawk Strategic Solutions, national experts on school safety. Representatives from the Bergen County Prosecutor's Office, Bergen County Swat team, the Lodi Police Department and Tomahawk Strategic Solutions conducted a review of our school safety measures at Lodi High School as well as our physical building and applauded our school for our efforts in planning for school safety.



All classrooms at LHS are equipped with Promethean Panels. Students are provided with individual Chromebook as part of our 1:1 initiative. Teachers have implemented Google Classrooms to provide students with rich opportunities to use technology throughout their learning process. Students will have the opportunity to participate in several new STEM Courses in Computer Science, Engineering and Construction Technology which have been added to the HS program. With the addition of a new Engineering and Construction Technology Lab at Lodi High School students have access to state of the art technology, facilities, and equipment to pursue their interest in STEM related post-secondary programs/careers. We have created a state of the art Bio/Chemistry Lab to support the educational goals of our Science Department. The lab includes Smart Manikins used in conjunction with 3D goggles to simulate medical training scenarios for students.

Attendance is essential for student success. We systematically analyze attendance data to identify trends and provide targeted support for students at risk of chronic absenteeism. Our schools utilize positive reinforcement strategies, including recognition programs that celebrate students with perfect or improved attendance. We also prioritize family engagement through consistent communication about the importance of attendance, offering resources to help address barriers such as transportation challenges or health issues.
