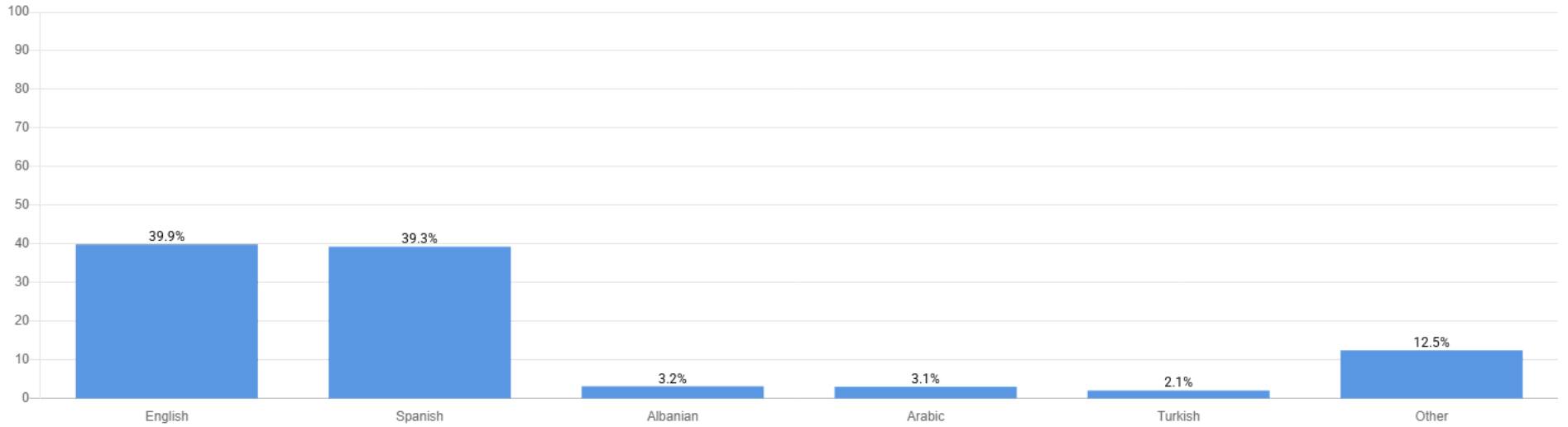

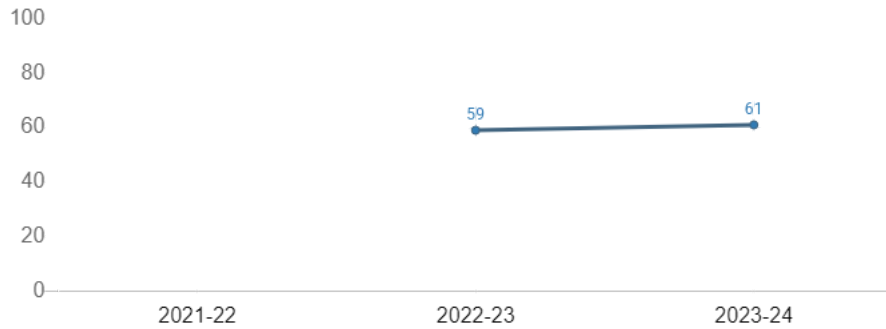

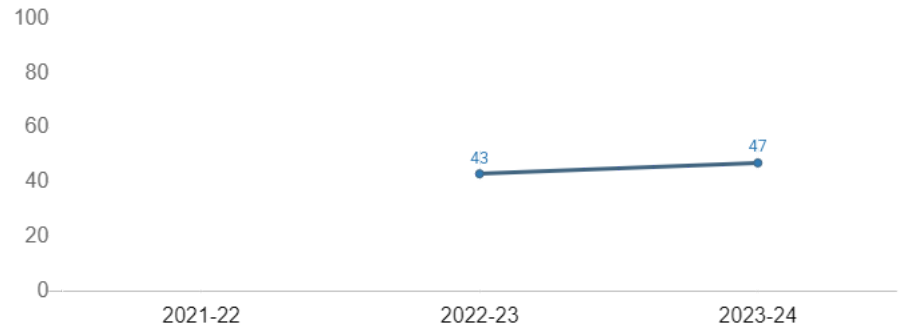

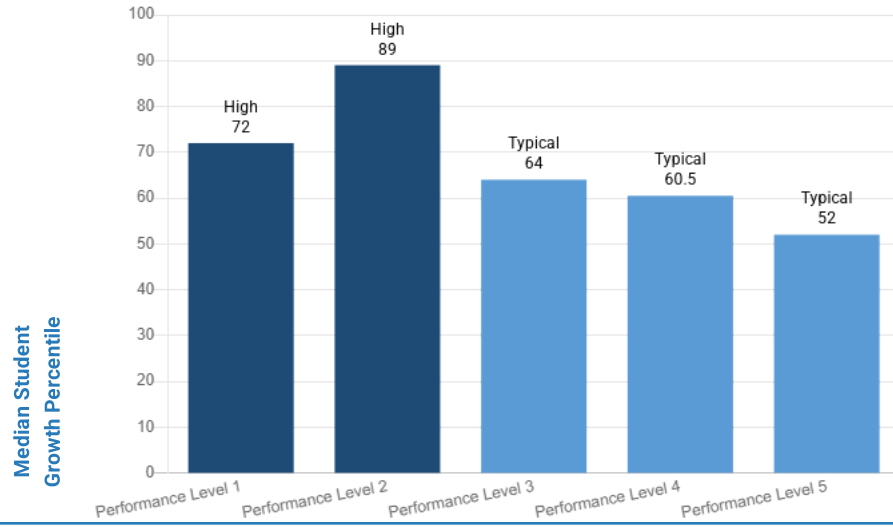

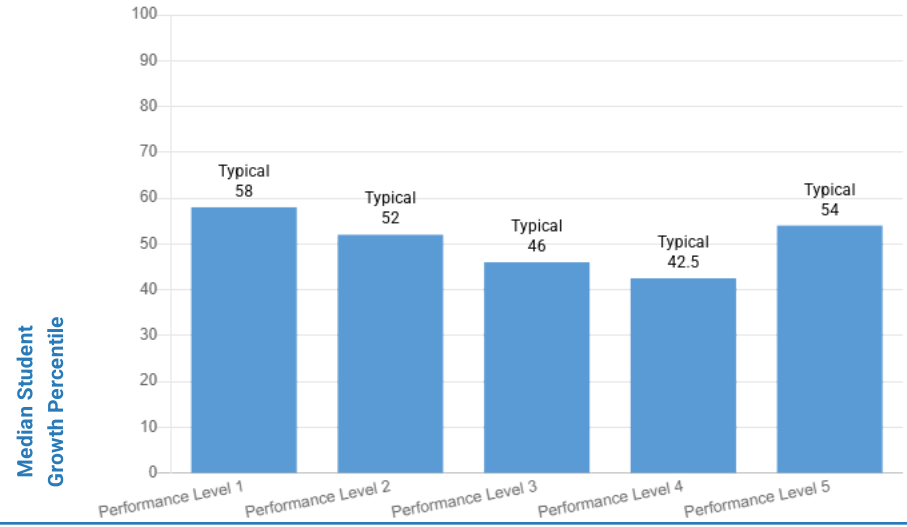

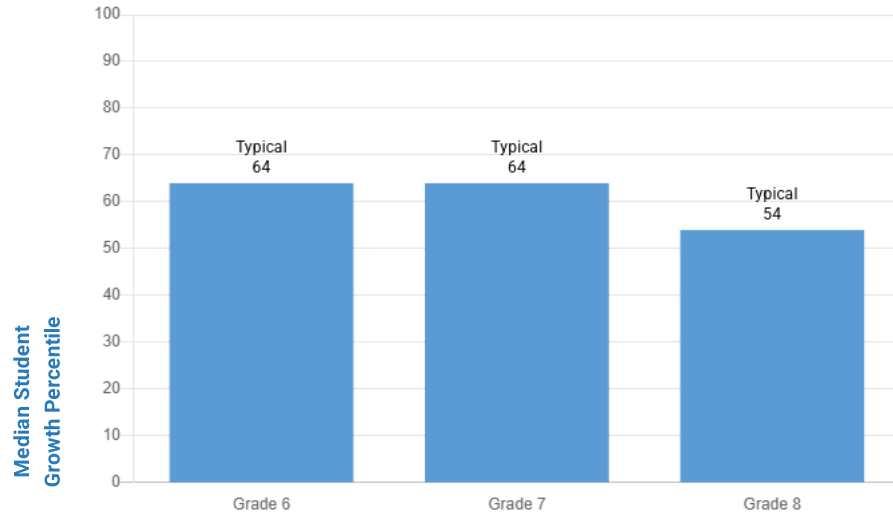

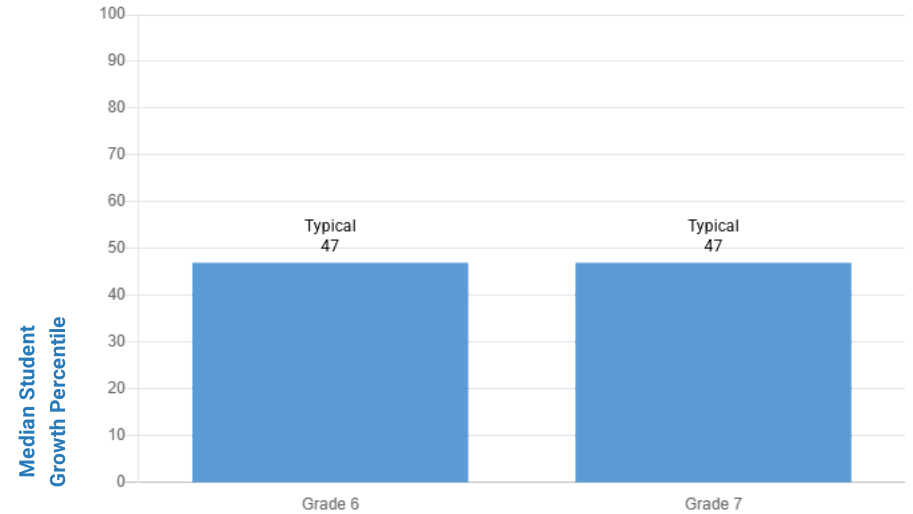

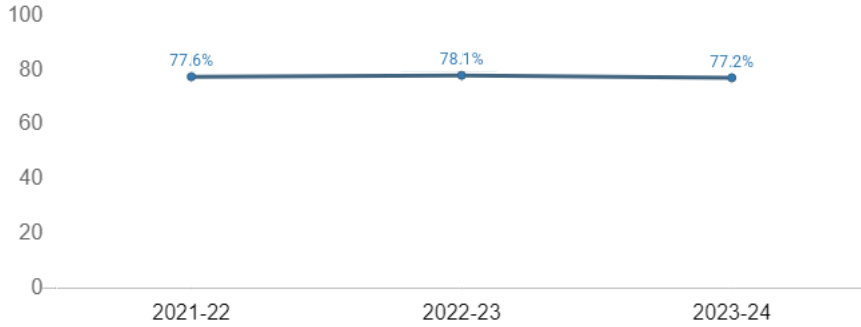

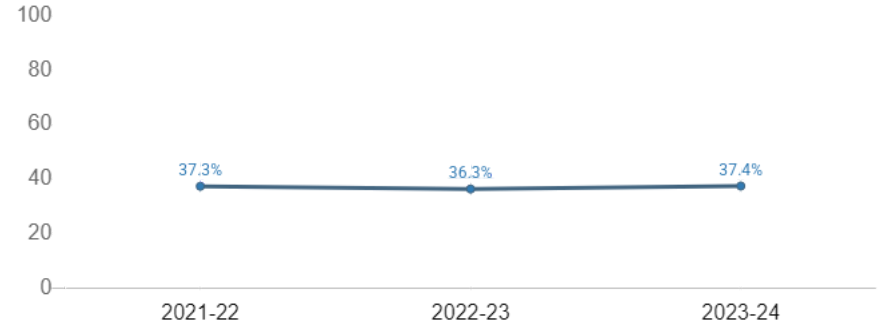
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 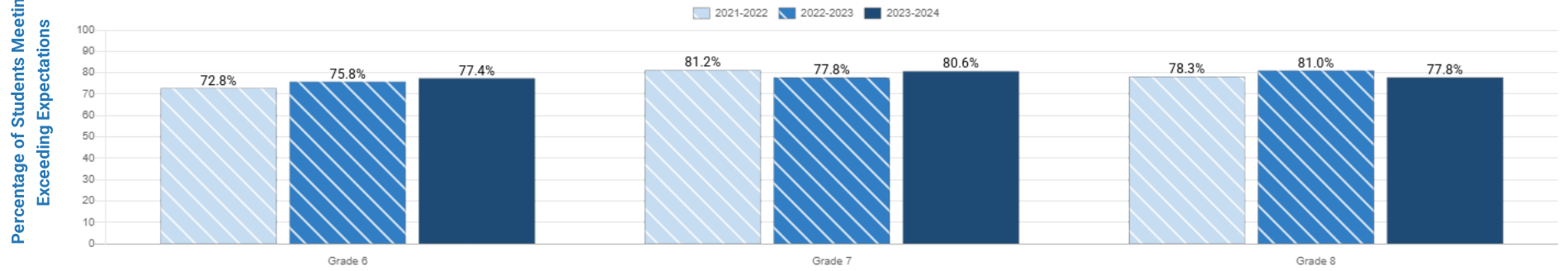

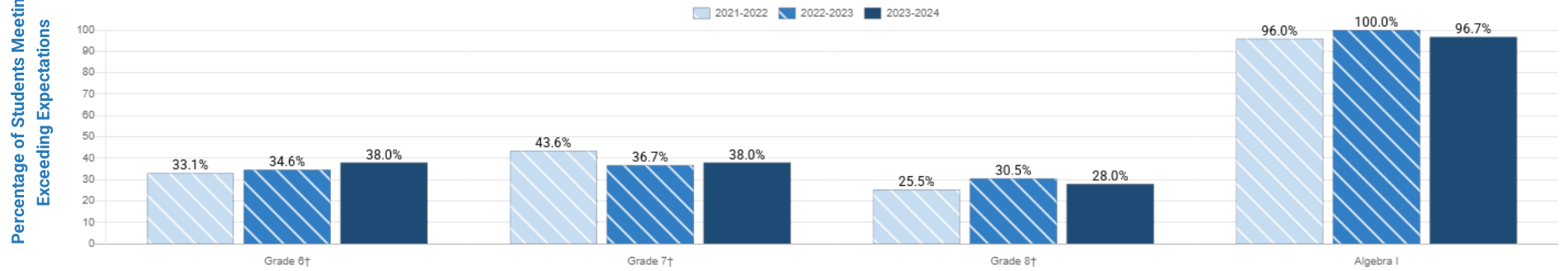

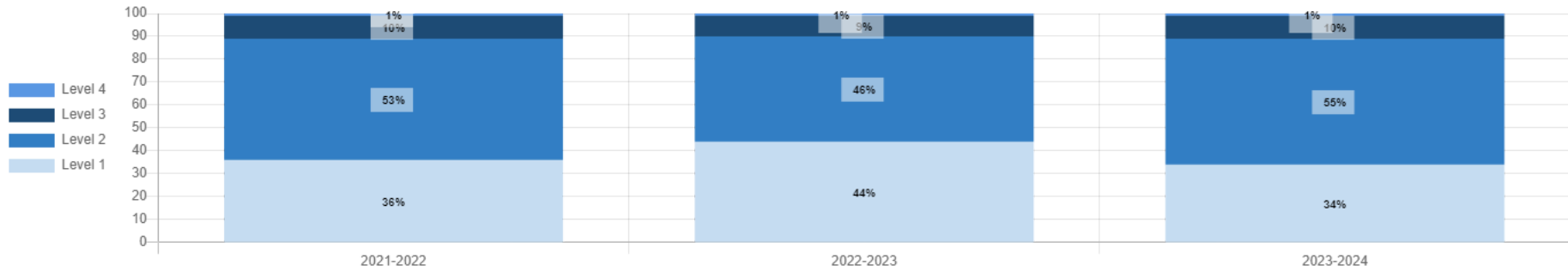

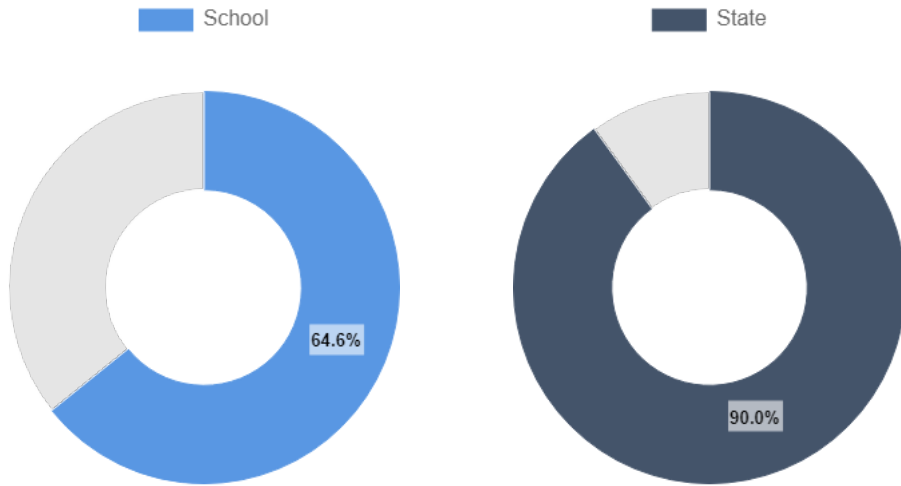

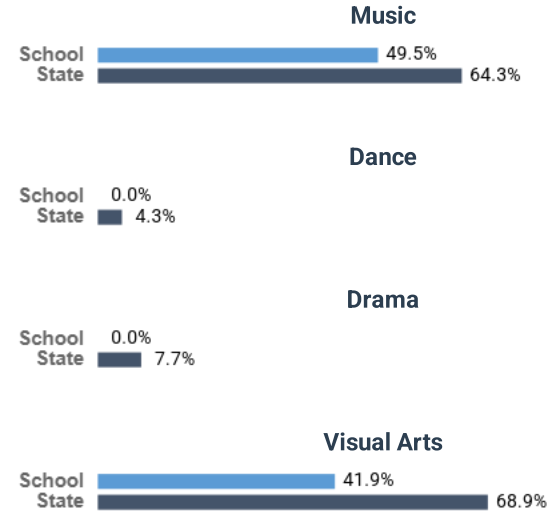

Students enrolled in one or more classes by discipline:



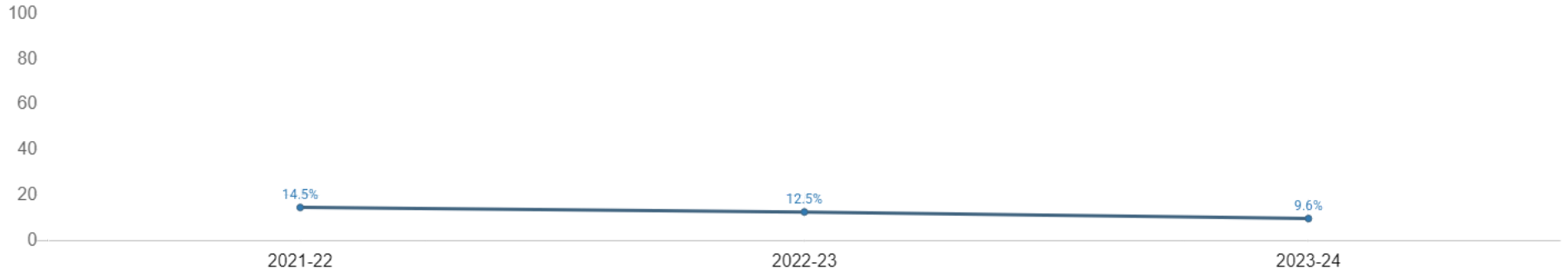

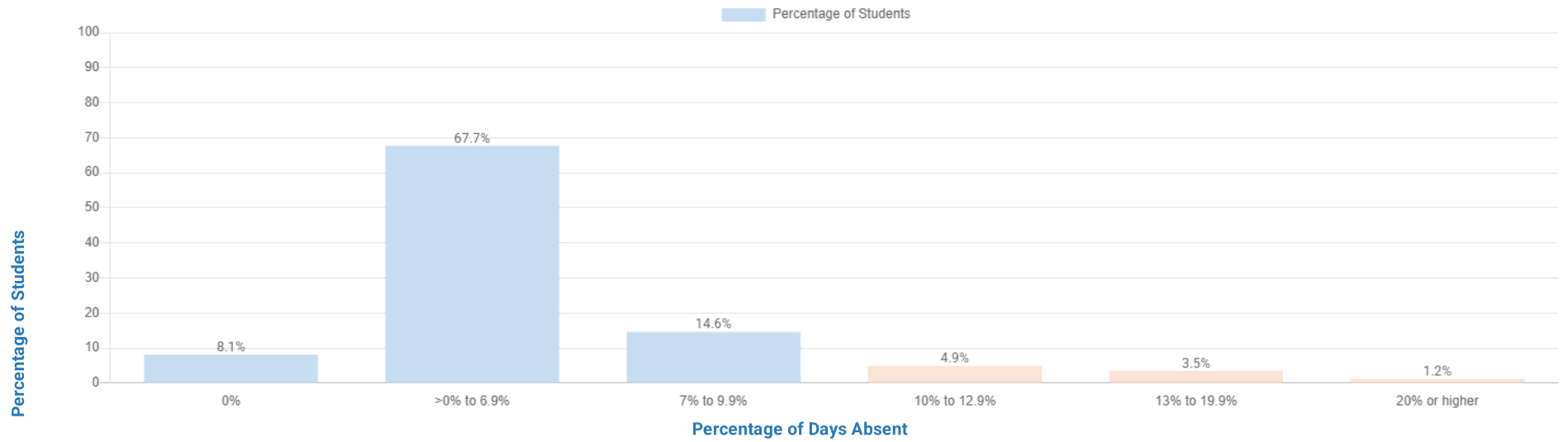

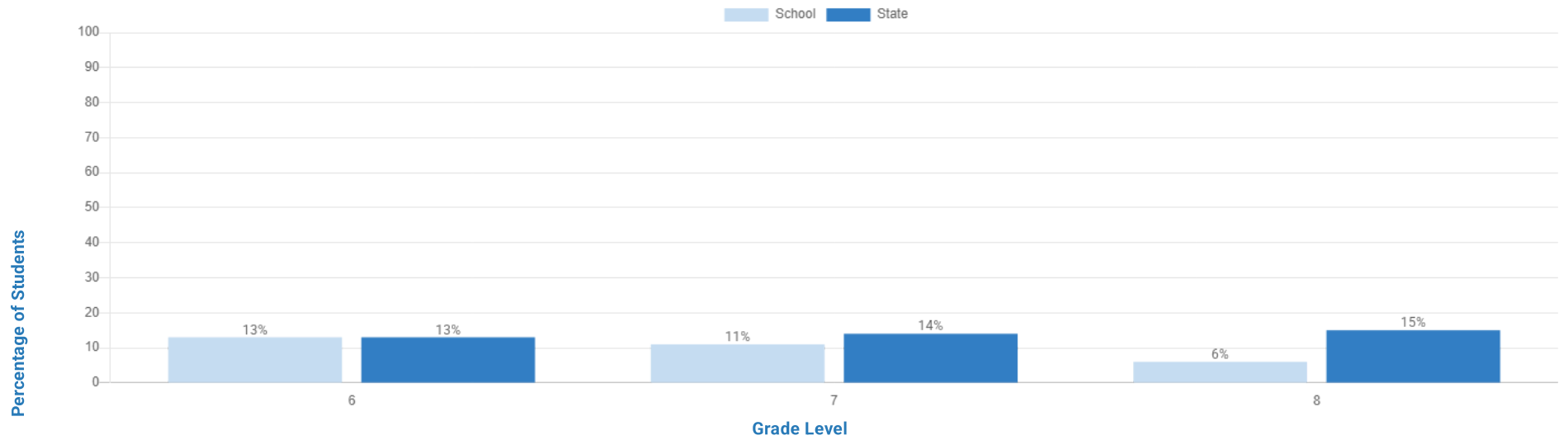

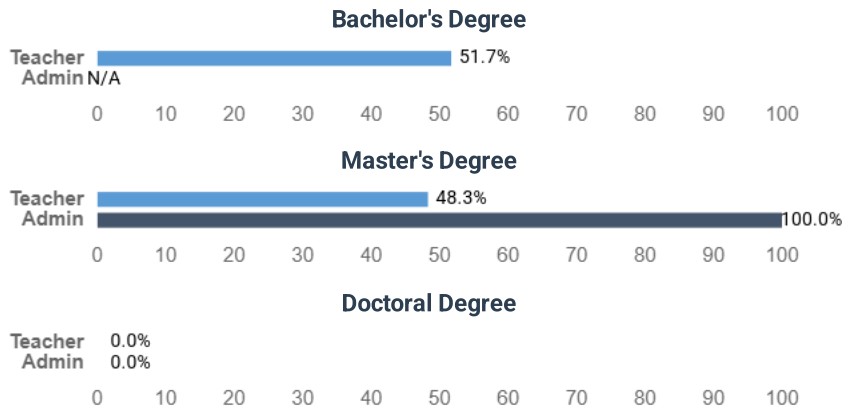

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Courses, Curriculum, Instruction:

The curriculum for grades 6, 7, and 8 is designed to equip students for the challenges of the 21st century. A technology-focused course, Digital Design, helps prepare students for success on standardized tests and college entrance exams. This newly branded cycle class encourages critical thinking, problem-solving, decision-making, and teamwork. Courses offered include Language Arts, Pre-Algebra, Science, Social Studies, World Languages (Spanish and Italian), Financial Literacy, Digital Design, Art, Music, and Health and Physical Education. Additionally, a balanced literacy program through Readers/Writers Workshop actively engages students in reading and writing instruction to enhance their literacy skills and reading stamina.



Sports and Athletics:

Sports Offered: Basketball (Boys & Girls), Cheerleading (Boys & Girls)
Thomas Jefferson Middle School (TJMS) offers a boys' and girls' basketball team, as well as separate cheerleading teams for both girls and boys. These athletic programs provide students with opportunities to develop their skills, foster teamwork, and engage in healthy competition. Participating in these teams not only promotes physical fitness but also encourages school spirit and camaraderie among students.



Clubs and Activities:

TJMS provides a variety of clubs and activities that align with school goals and encourage positive interactions among students. These include the National Junior Honor Society, Student Council, Chorus, Band, LGBTQ Club (Oz Club), Book Club, Poetry Club, Drama Club, Gaming Club, Yearbook Club, Robotics Club, STEAM Club, Community Service Club, Choir, Volleyball Club, and the Tri-M Music Honor Society. Before and After School Programs:

TJMS has collaborated with the Lodi Boys and Girls Club to introduce the Lodi Enrichment Afterschool Program (LEAP) at the school. LEAP is a free program supported by a grant from the New Jersey Department of Education, provided through the Federal Government's 21st Century Community Learning Center (21st CCLC) grant program. This program focuses on a STEAM (Science, Technology, Engineering, Arts, and Mathematics) theme. Additionally, the EPIC club, in partnership with the Center of Drug and Alcohol Resources, meets once a month.



Staff and Professional Learning:

At the beginning of the school year, teachers engaged in professional development focused on Renaissance Place to learn how to administer benchmark assessments in ELA and Math, targeting standards that indicate areas of academic loss. Staff members also take part in a one-hour professional development session each month. Additionally, there are two in-service days throughout the year dedicated to full-day professional development activities. Guidance services receive training from various organizations aimed at fostering a positive school culture and promoting the social and emotional well-being of students. Furthermore, professional development opportunities are offered through HIBster/Onspire for our guidance department, teaching staff, and students, ensuring that strategies to support and enhance the school community are continually provided.



Postsecondary Information:

Eighth-grade students enrolled in at least one Honors class are invited to take the PSAT at Lodi High School, free of charge. They also gain access to the College Board website, which familiarizes them with college expectations and prepares them for future PSAT, SAT, and ACT assessments. Seventh-grade students will participate in College Kickoff events, which will introduce them to the world of post-secondary education. Meanwhile, sixth-grade students will engage in Career Interest Inventories to begin their career exploration journey.

In collaboration with our School Counseling Department, TJMS provides a range of programs and support services designed to address the needs of the whole student. These offerings include ELL classes at three levels, Special Education programs, Basic Skills classes in Math and Language Arts, Intervention and Referral Services, Speech Therapy, Occupational Therapy, Physical Therapy, and Care Plus Social and Emotional Counseling.



Student Health and Wellness:

All schools in the Lodi School District offer a breakfast program to serve our students. We provide free health screenings throughout the year, which include vision, dental, and scoliosis assessments. Physical Education classes include fitness testing, and our Field Day event promotes skills, endurance, and teamwork. Additionally, we participate in a grant program with the Bergen County Center for Alcohol and Drug Prevention.



Parent and Community Involvement:

To build strong partnerships with parents and community members, TJMS hosts monthly PTO meetings and bi-monthly committee meetings for the PTO. The school offers recreational and intramural sports through the Recreation Department and the Boys and Girls Club. Events such as Band and Chorus Concerts, Back to School Night, and Parent Conference Night further engage families. Additionally, the Lodi Police Department provides a Junior Police Academy for seventh graders. The Bergen County Council on Alcohol and Drug Prevention also offers a Strengthening Families program for our school community.

Facilities:

Founded in 1933, TJMS transitioned to a middle school for grades 6-8 in 1998. The Media Center serves as the heart of the school, featuring reference materials and a computer lab designed to enhance instructional activities. The newly renovated TJMS Auditorium, with a seating capacity of 820, is utilized for assemblies, concerts, performances, and graduation ceremonies. This facility also hosts a variety of community events.



School Safety:

TJMS currently employs two full-time School Security Officers whose expertise is vital in shaping best practices for emergency drills and everyday procedures. Additionally, we have a School Safety Committee that convenes to discuss process improvements and evaluate the effectiveness of school emergency drills.



Technology and STEM:

TJMS offers Financial Literacy courses for 7th and 8th graders in a dedicated lab, along with a Digital Design Course conducted in our computer lab. Additionally, TJMS has partnered with the Lodi Boys and Girls Club to bring the Lodi Enrichment Afterschool Program (LEAP) to the school. This free program is funded by a grant from the New Jersey Department of Education through the Federal Government's 21st Century Community Learning Center (21st CCLC) grant program and focuses on a STEAM (Science, Technology, Engineering, Arts, and Mathematics) theme. Our newly adopted science curriculum supports STEM learning for grades 6-8, providing students with deeper opportunities for research and problem-solving. Furthermore, we offer a STEAM club as an extracurricular activity that meets monthly.
