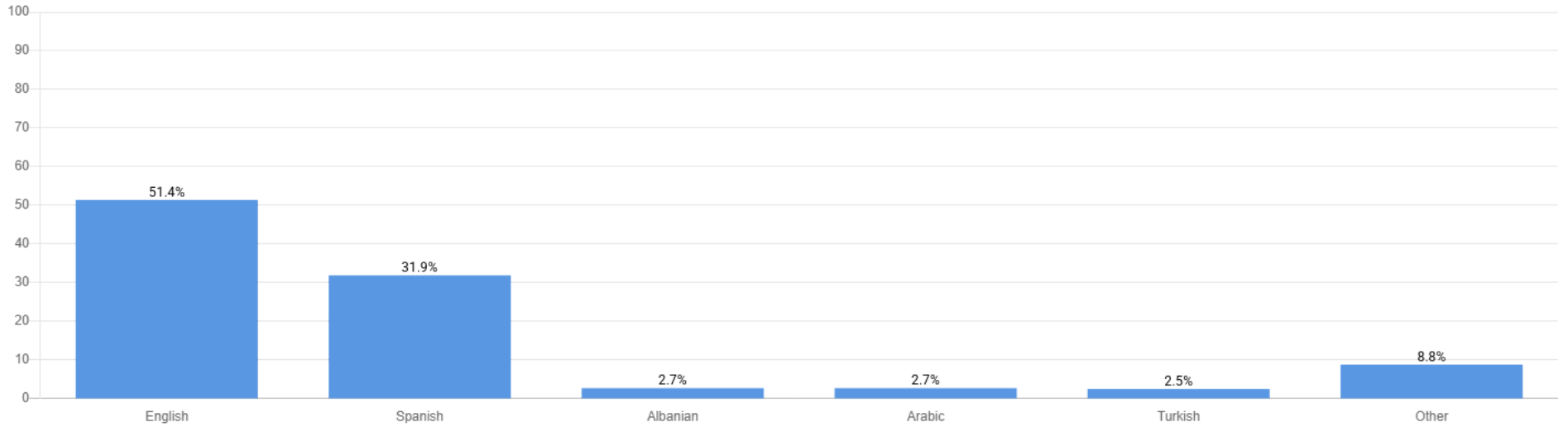

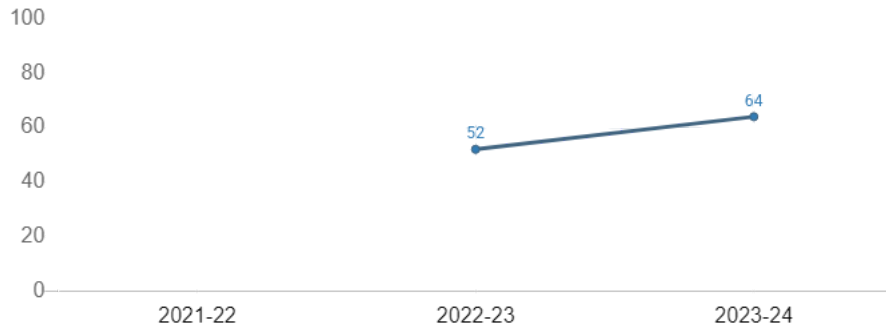

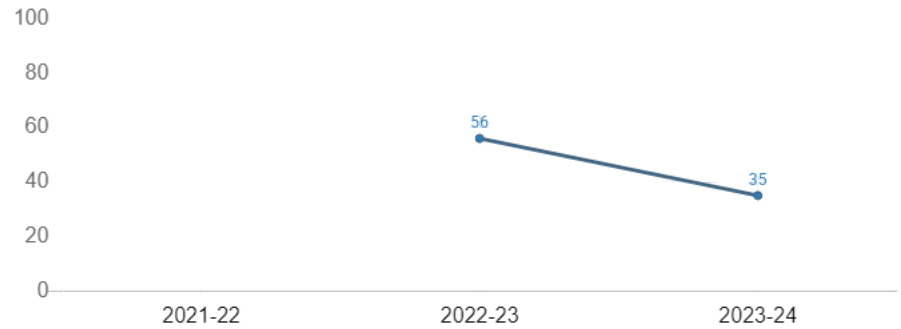

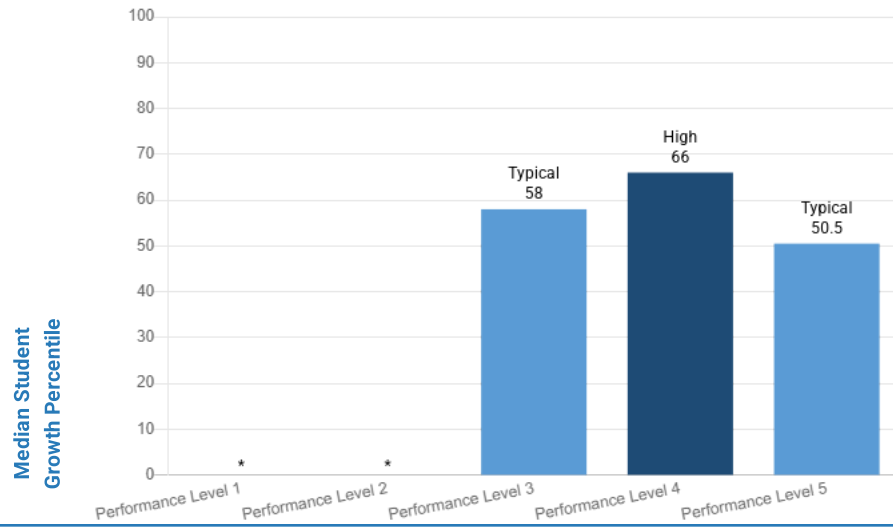

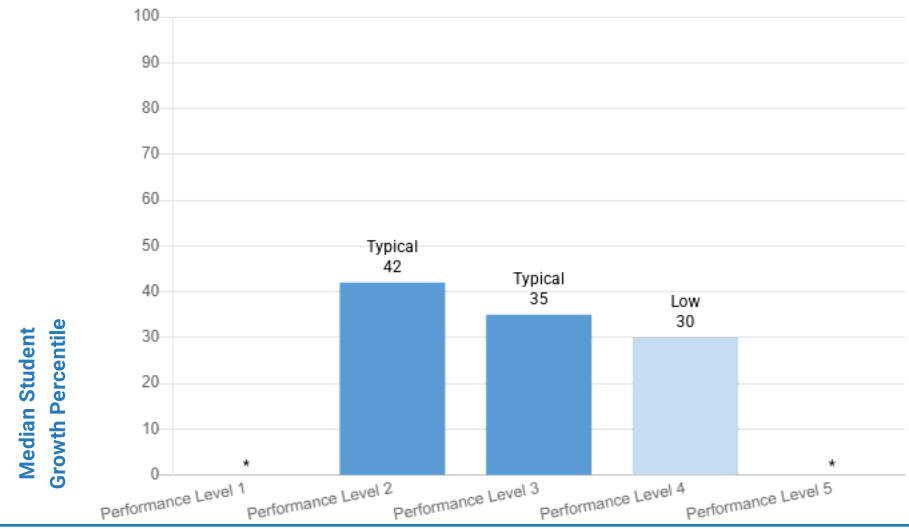

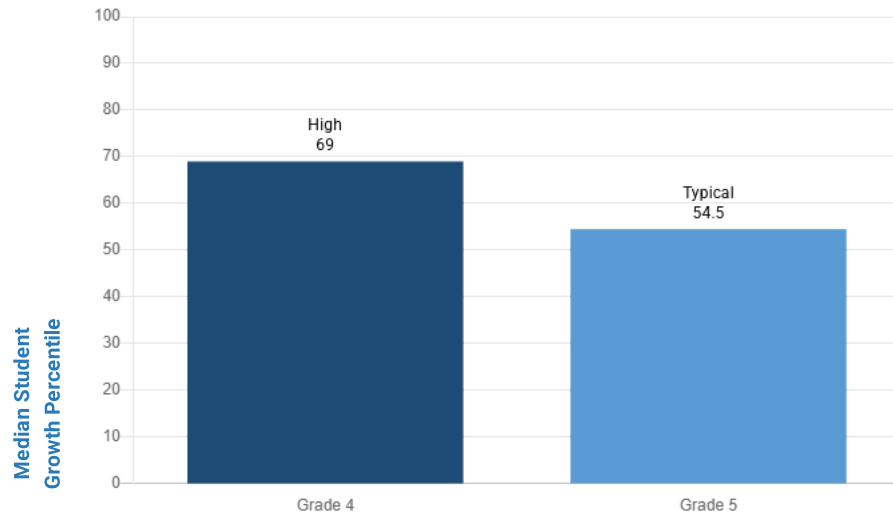

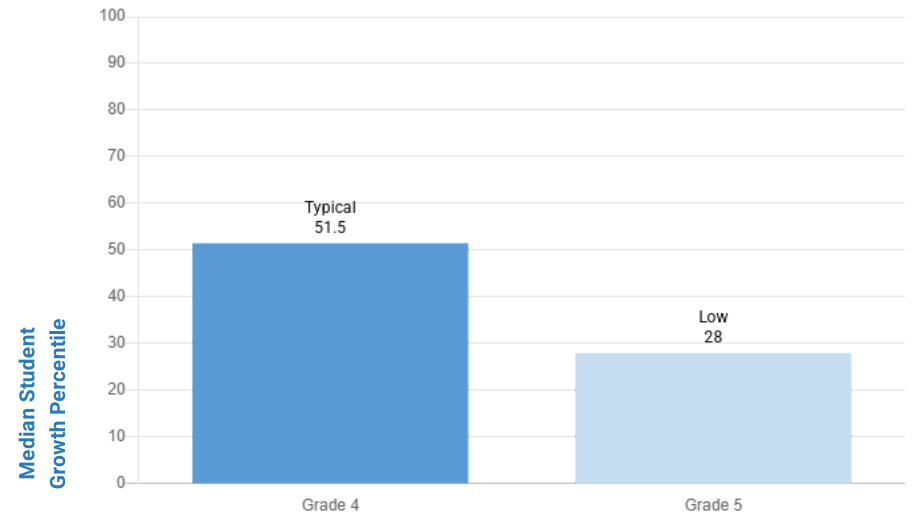

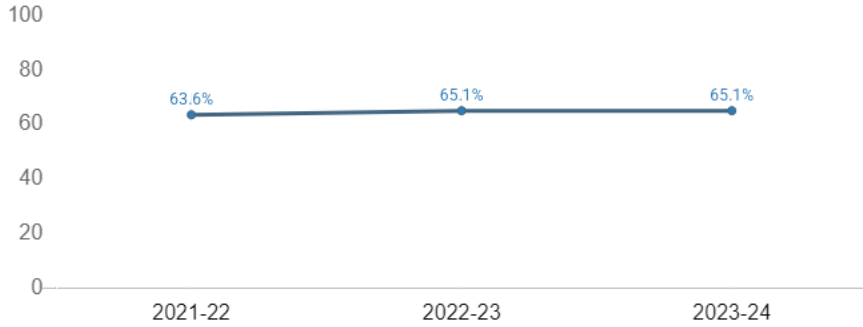

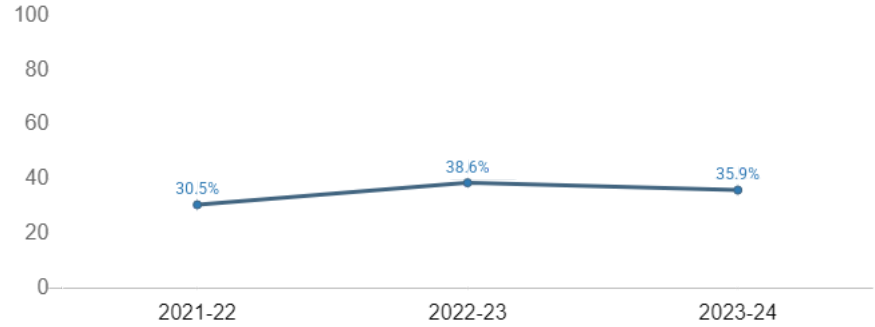
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 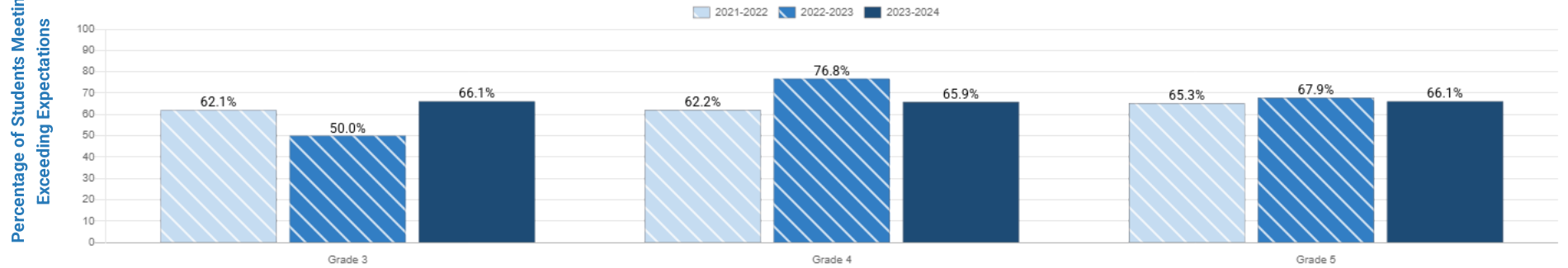

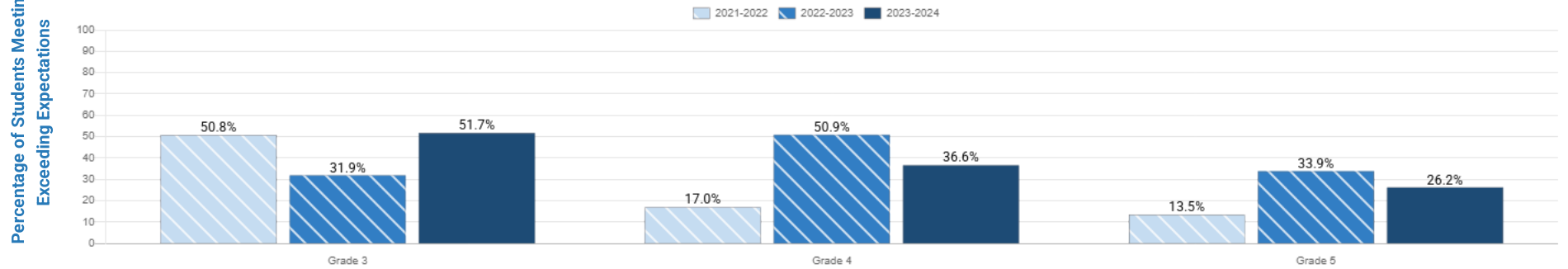

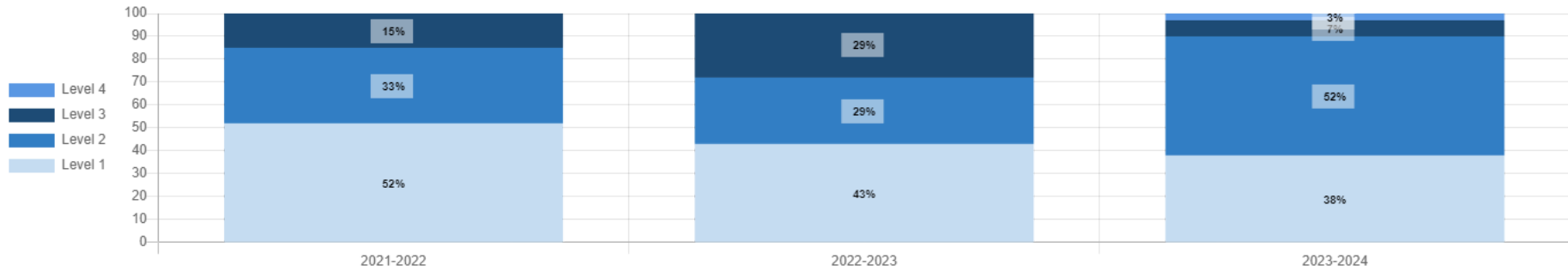

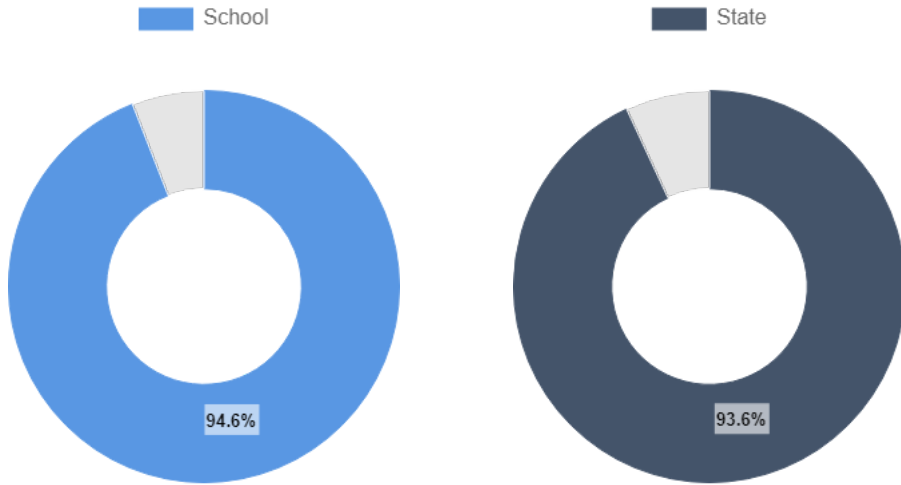

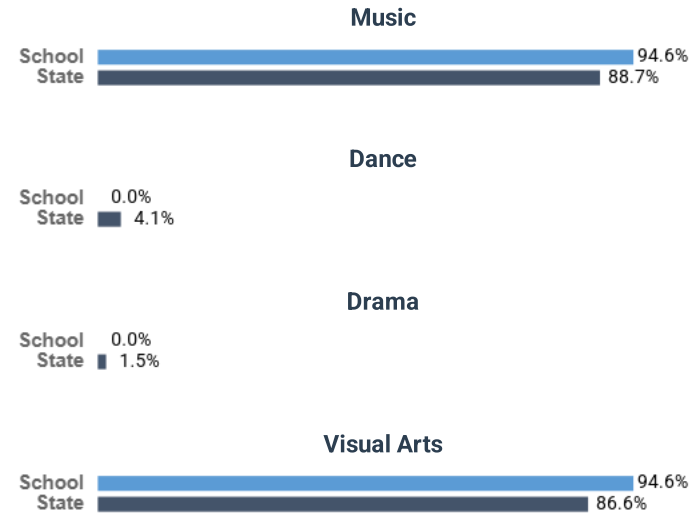

Students enrolled in one or more classes by discipline:



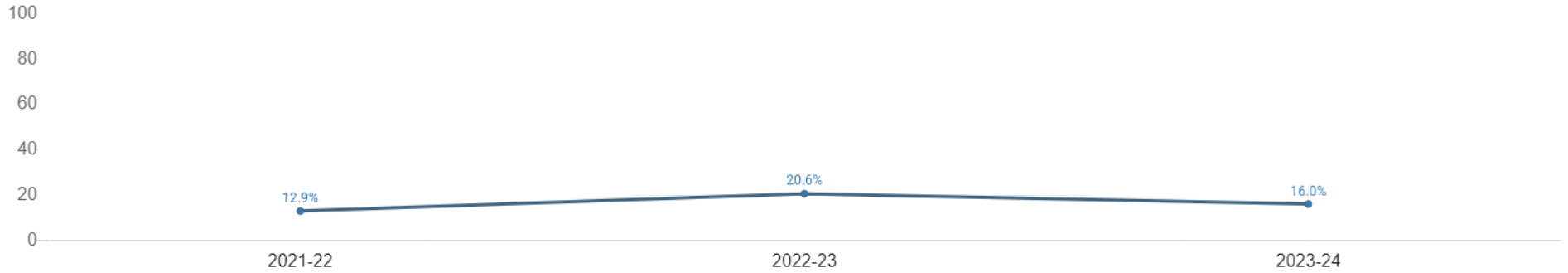

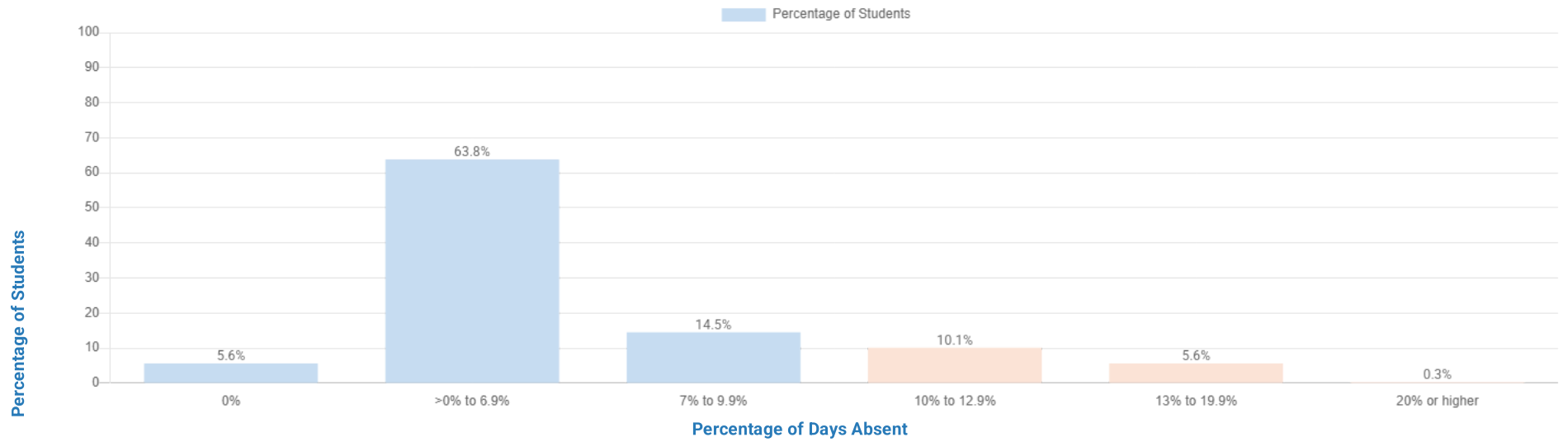

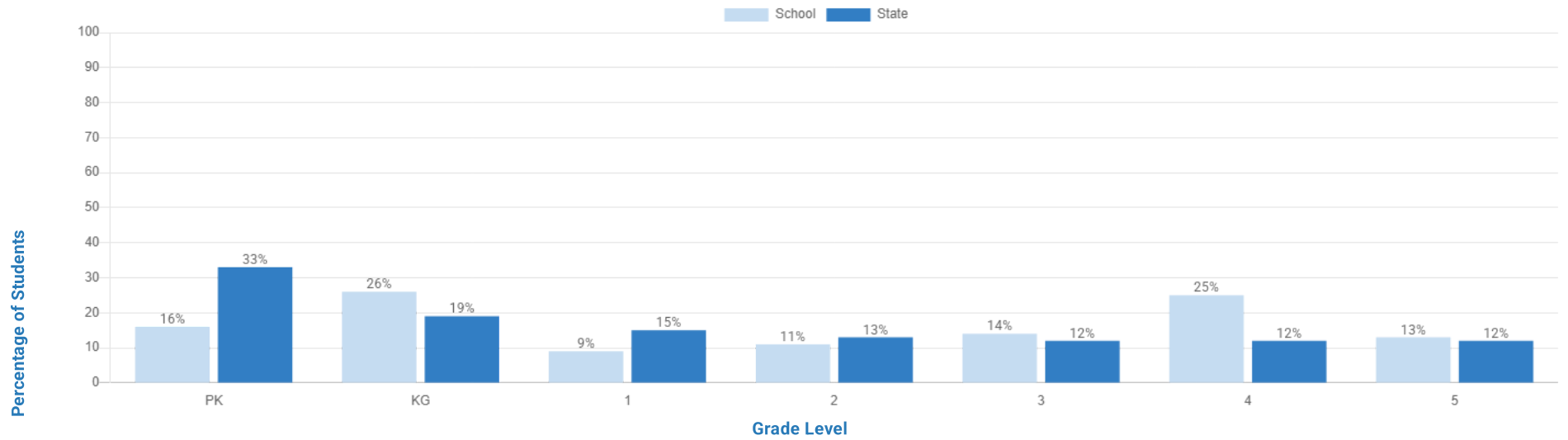

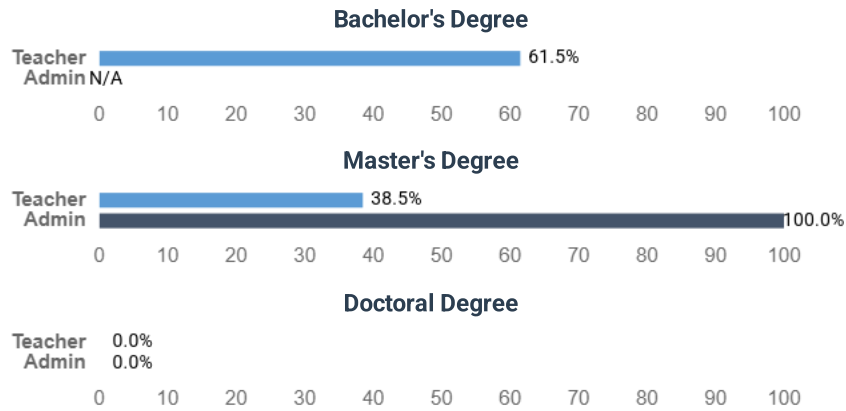

Our curriculum encourages critical thinking, problem-solving, and collaboration skills that will be crucial as students transition into middle school, high school, and beyond. We also introduce students to a variety of career options and pathways through special projects and guest speakers, helping them envision their future possibilities. By integrating technology and STEM into daily learning, we give students exposure to fields that are in high demand, fostering an interest in careers related to science, technology, engineering, and mathematics.



Student Supports and Services:

Our school offers a range of academic supports to ensure all students thrive. The Title One Program provides targeted assistance in Math and ELA, while our ESL Program supports non-native English speakers in their language development. The I&RS Team collaborates to address individual student needs, and our Literacy and Math Coaches work closely with grades K-5 to enhance instructional practices. For younger students in grades K-2, Foundations and the Early Birds program provide foundational skills in literacy and math. In addition to academic support, we prioritize social-emotional learning (SEL) services, which include access to a School Counselor, a Thrive Counselor, and a Behaviorist, as well as the I&RS Team and the Positive Behavior Support in Schools (PBSIS) framework. Together, these resources foster a supportive and inclusive learning environment for all students.

Early Childhood Education:

A third pre-K class was added to expand access for all resident students. The early childhood program uses Teaching Strategies Creative Curriculum. This New Jersey Department of Education approved curriculum uses positive interactions and relationships with adults to provide a critical foundation for successful learning in school. It is based on the belief that social-emotional competence is a significant factor in school success. Learning is facilitated through constructive, purposeful play which supports essential learning. The physical environment is used to affect the type and quality of learning interactions and teacher-family partnerships are viewed as essential to promote development and learning. Developmentally appropriate practices are utilized and encourage teachers to take into consideration child development and how children learn, the individual strengths, needs and interests of each child and each child's family and community cultures.
