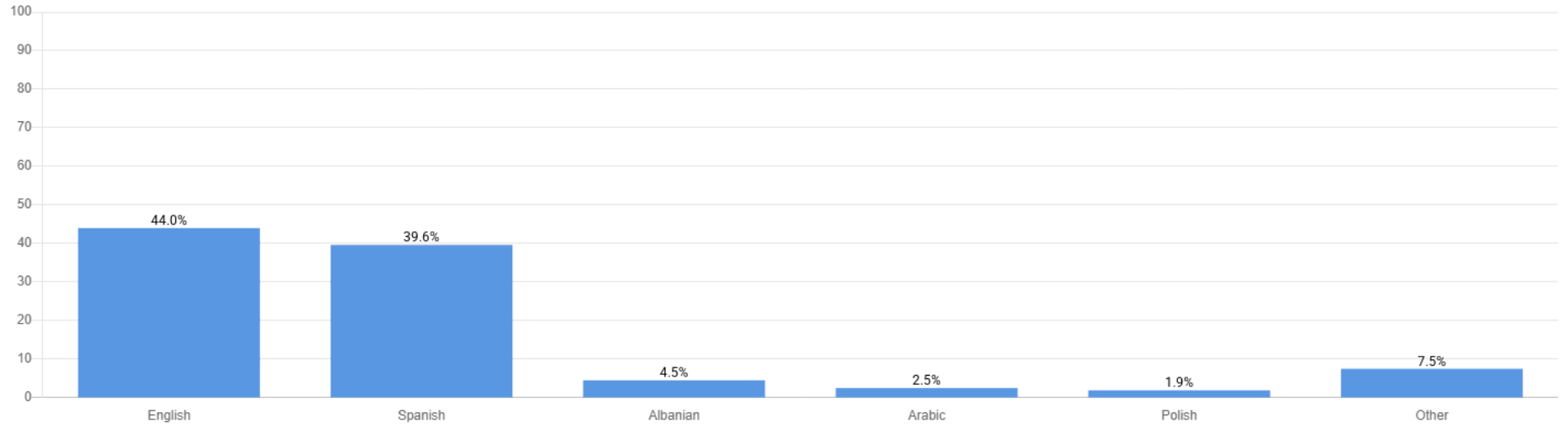

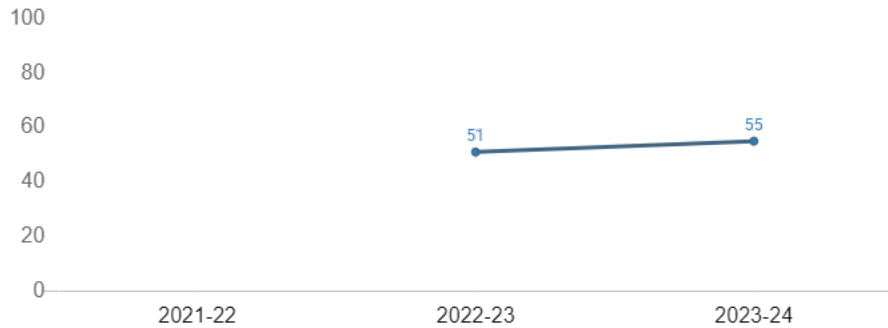

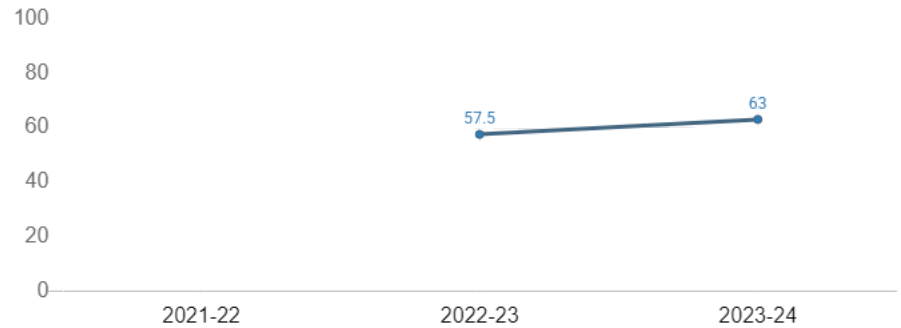

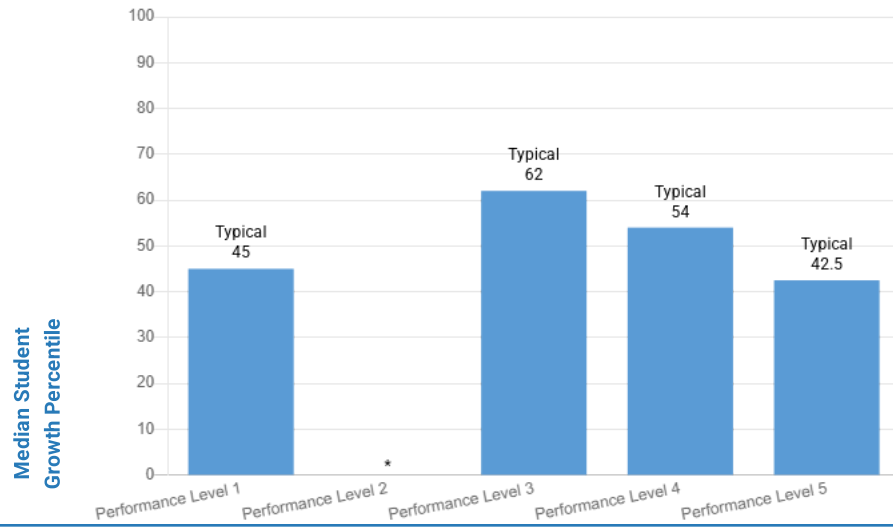

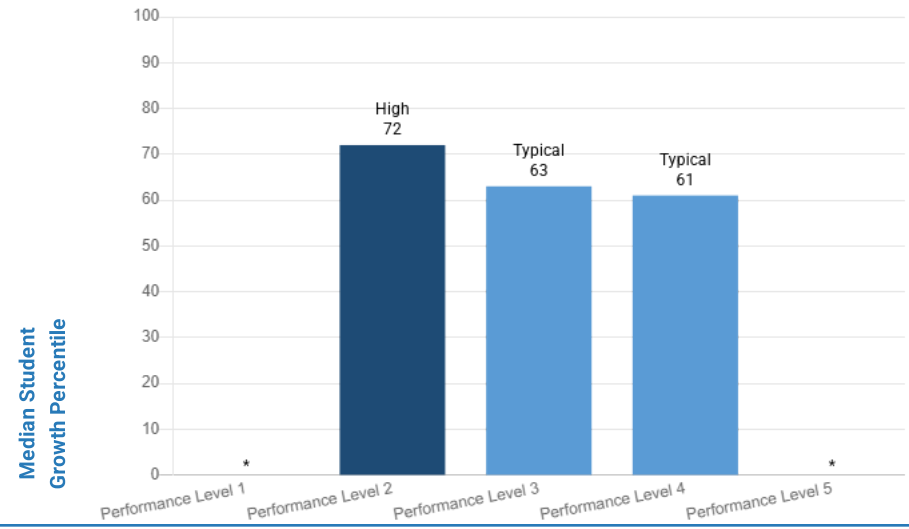

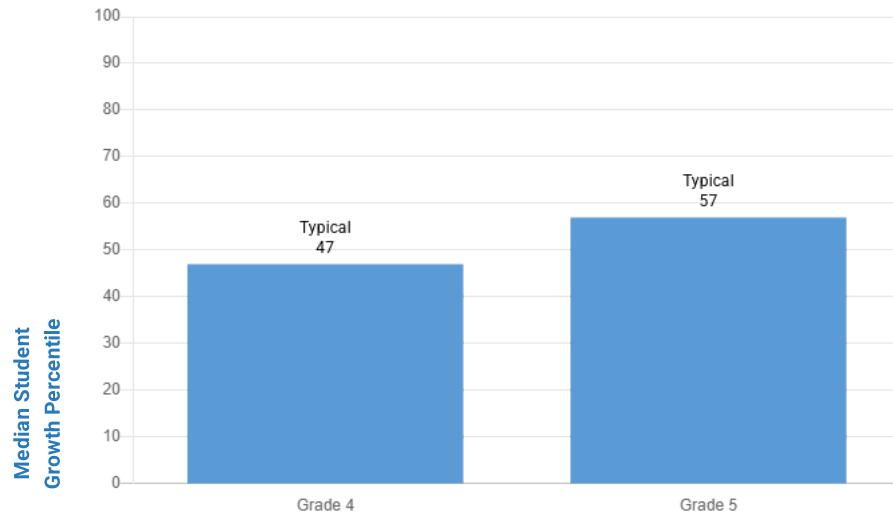

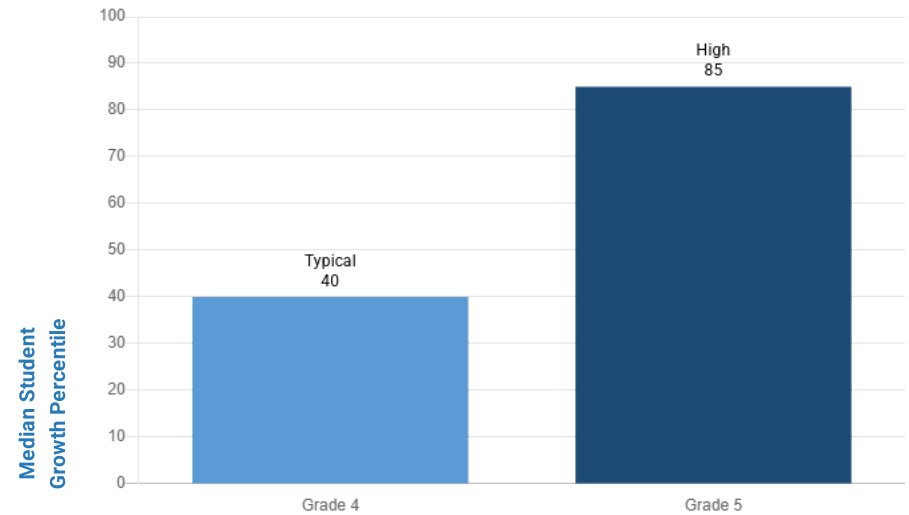

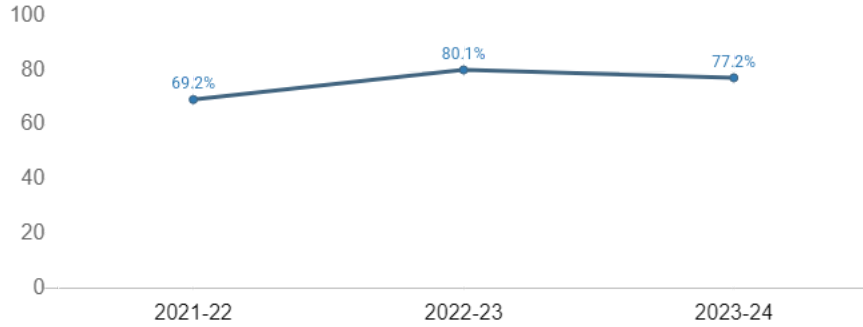

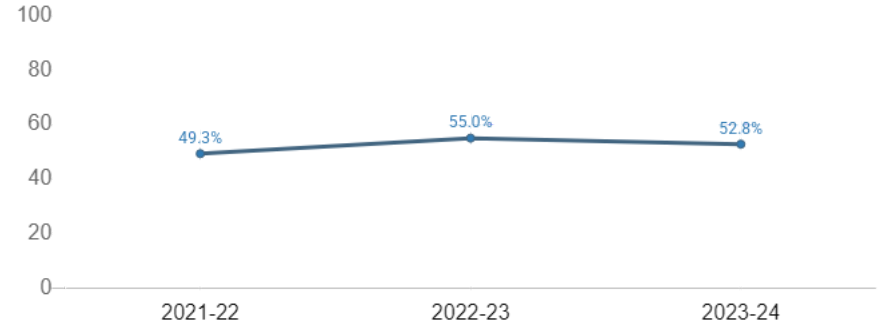
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 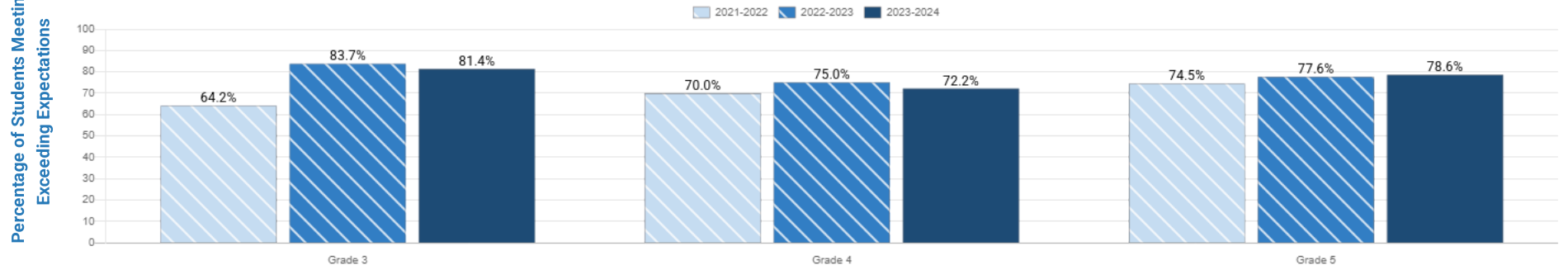

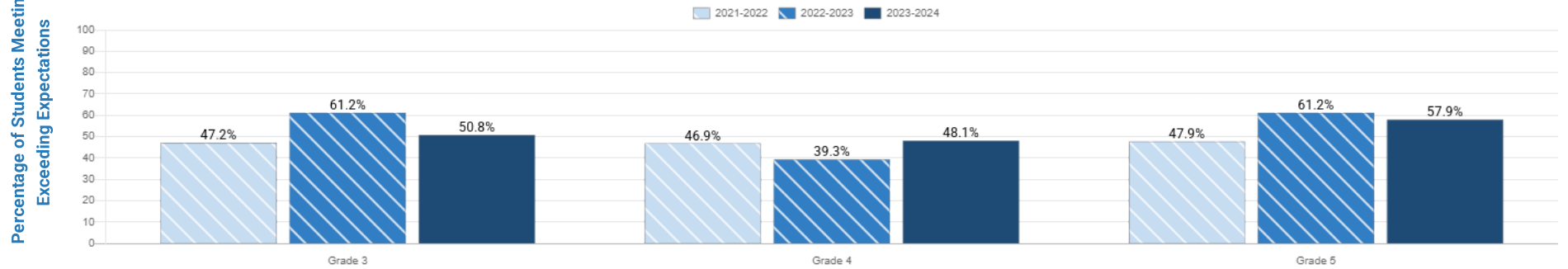

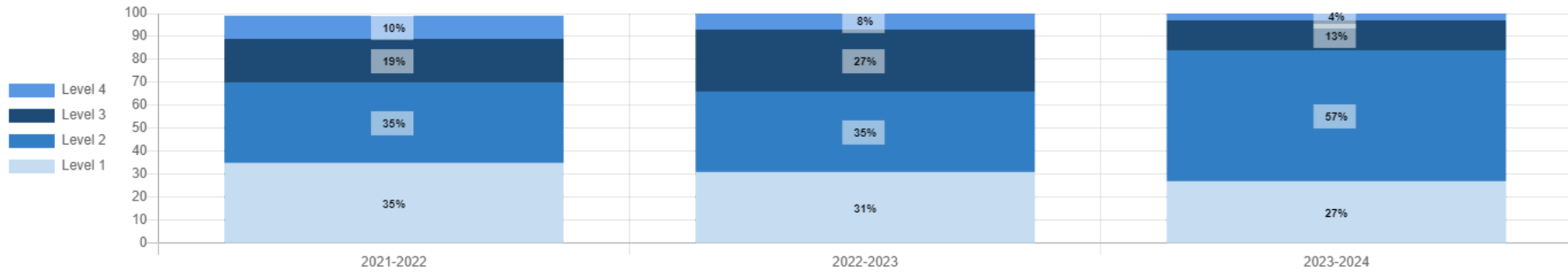

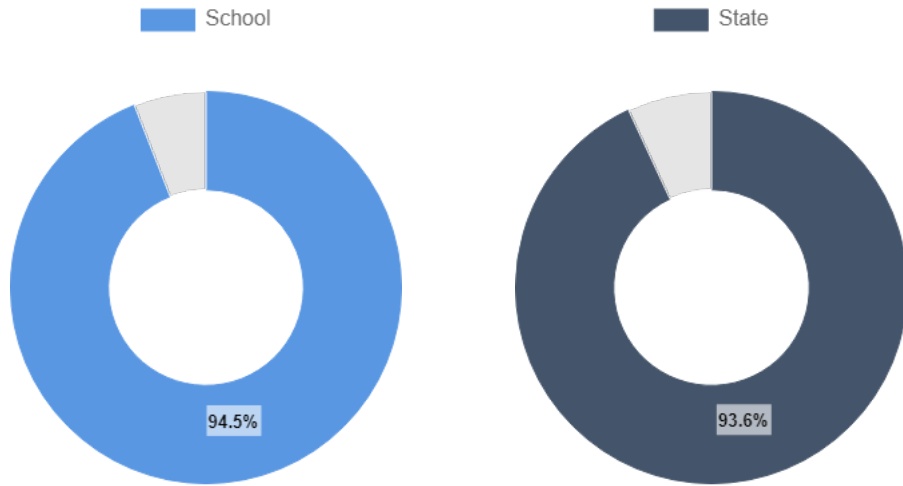

Students enrolled in one or more classes by discipline:



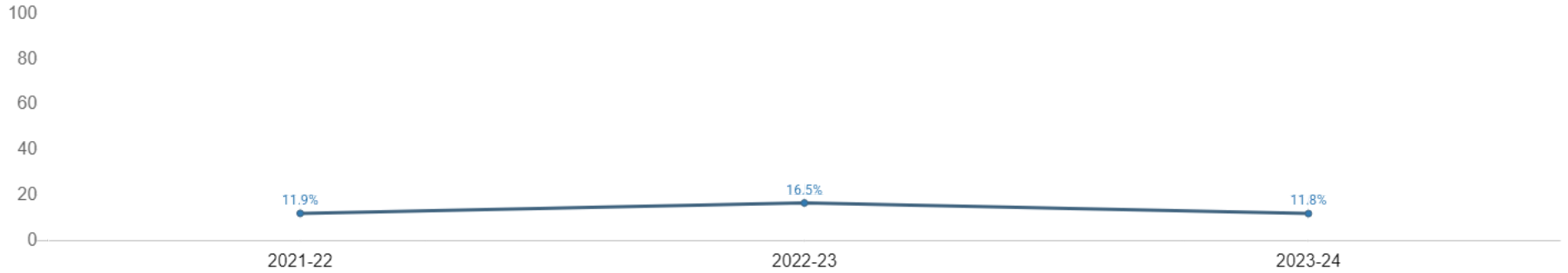

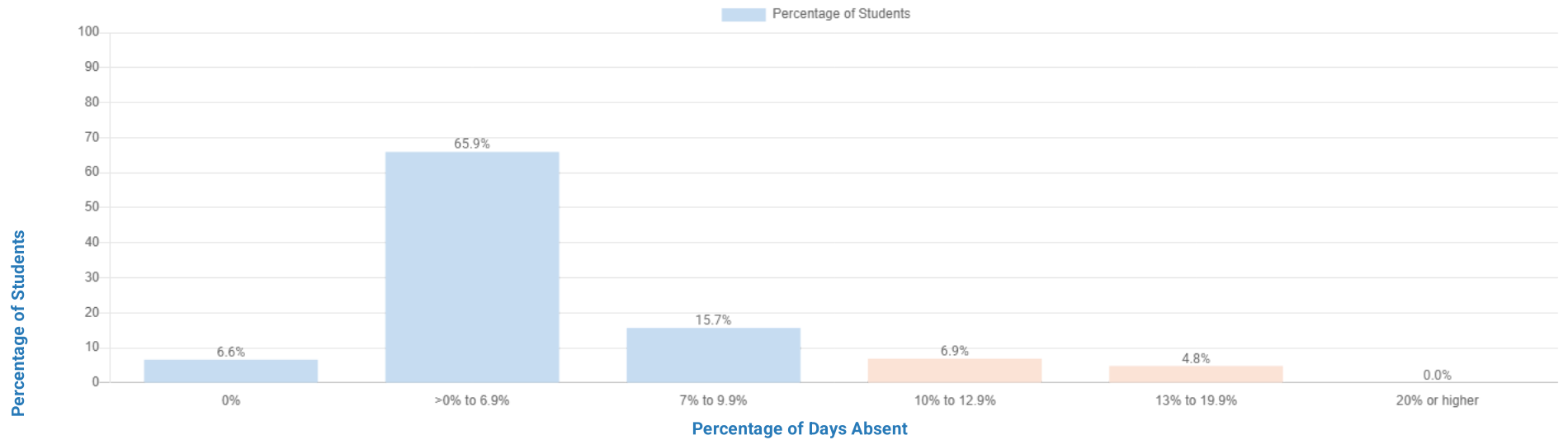

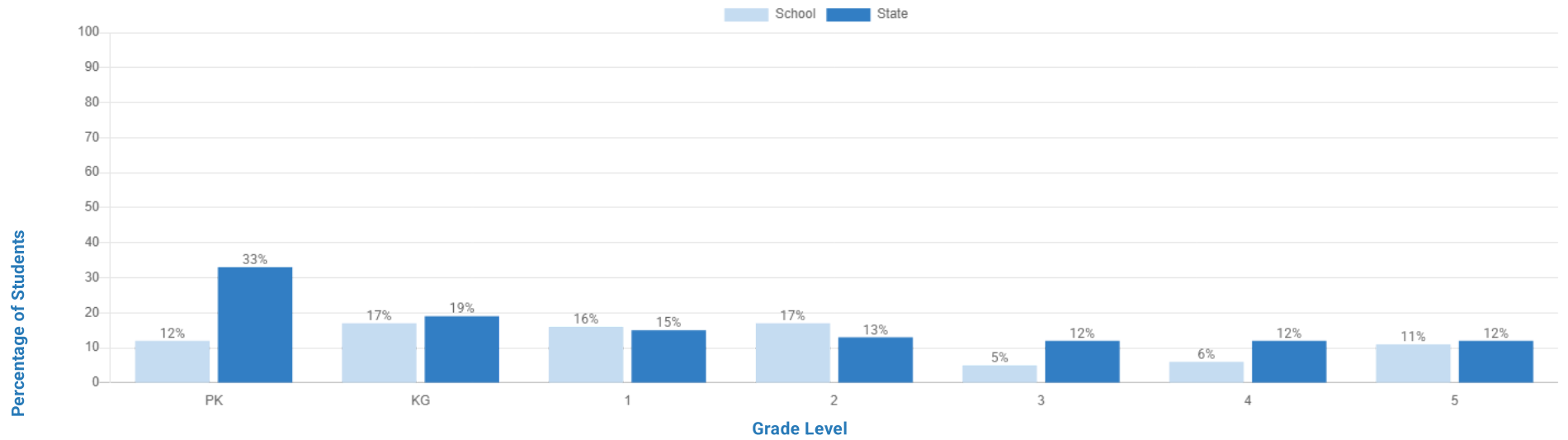

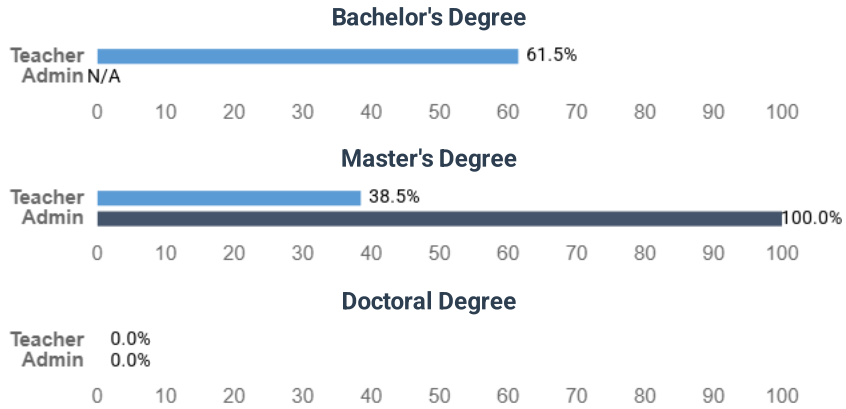

For those interested in the arts, we have a Drama Club and a STEAM Club that promotes hands-on learning in science and technology. Students can also join the Elementary Morning Band or participate in our After-School Music Program. Additionally, our Gifted & Talented program provides advanced learning opportunities for eligible students, ensuring a well-rounded and engaging school experience.



Before and After School Programs:

Our school offers an after school band program for students who are eager to explore music and learn to play an instrument. This program provides a supportive and engaging environment where students can develop their musical skills, work collaboratively with peers, and perform in school events. Whether they are beginners or have some prior experience, students receive personalized instruction to help them grow as musicians. Staff and Professional Learning:

Once a month, all faculty members participate in a one-hour professional development workshop aimed at improving their teaching practices. Topics are chosen based on interest and need. A district-wide Literacy Coach collaborates with faculty during these monthly sessions, both in and out of the classroom. Additionally, a district-wide Math Coach works with teachers to foster effective practices that enhance student learning. For Grades K-2, a Foundations Reading Coach provides targeted support.



Postsecondary Information:

At our elementary school, we lay the foundation for post-secondary success by focusing on developing essential academic and life skills that will serve students long after they leave our classrooms. From an early age, we emphasize the importance of setting goals, developing a strong work ethic, and cultivating a growth mindset, all of which are key to future academic and career success. Developmentally appropriate practices are utilized and encourage teachers to take into consideration child development and how children learn, the individual strengths, needs and interests of each child and each child's family and community cultures.
