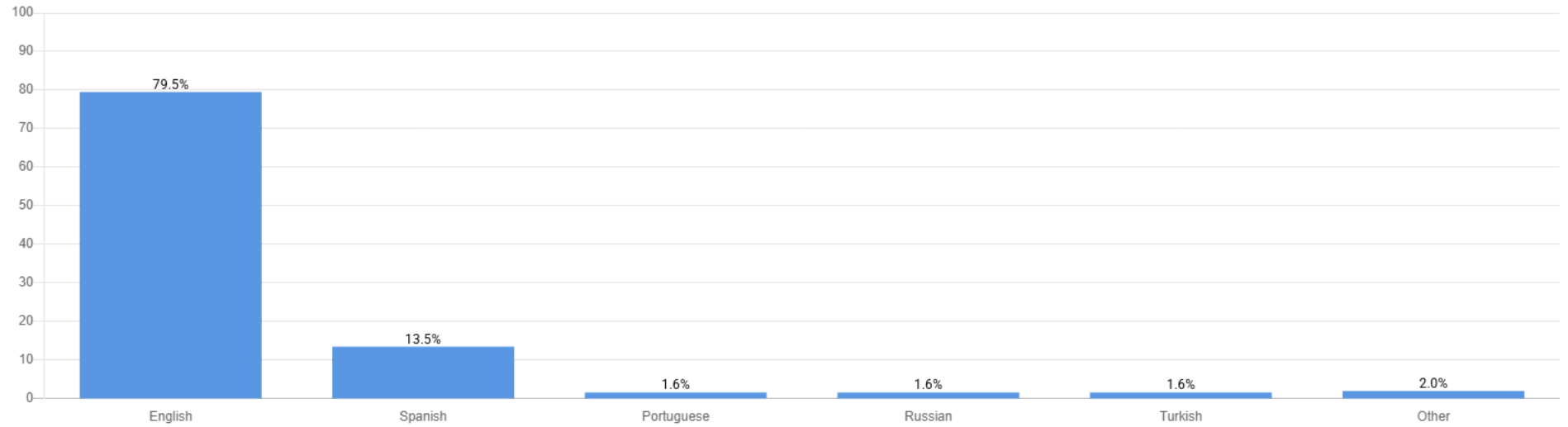

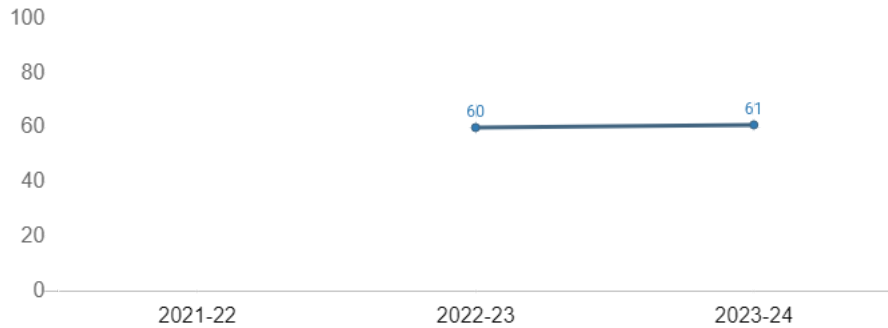

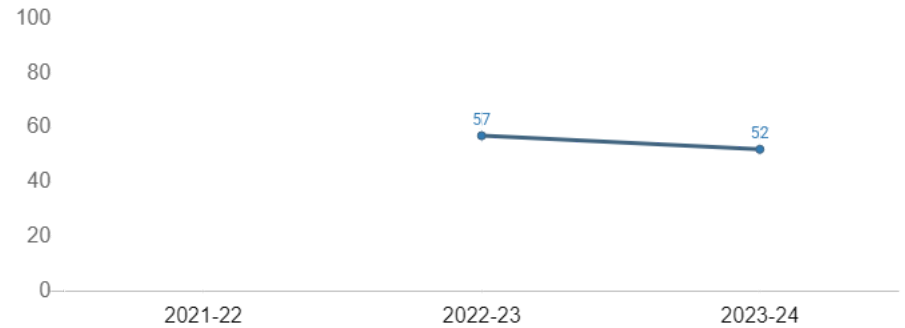

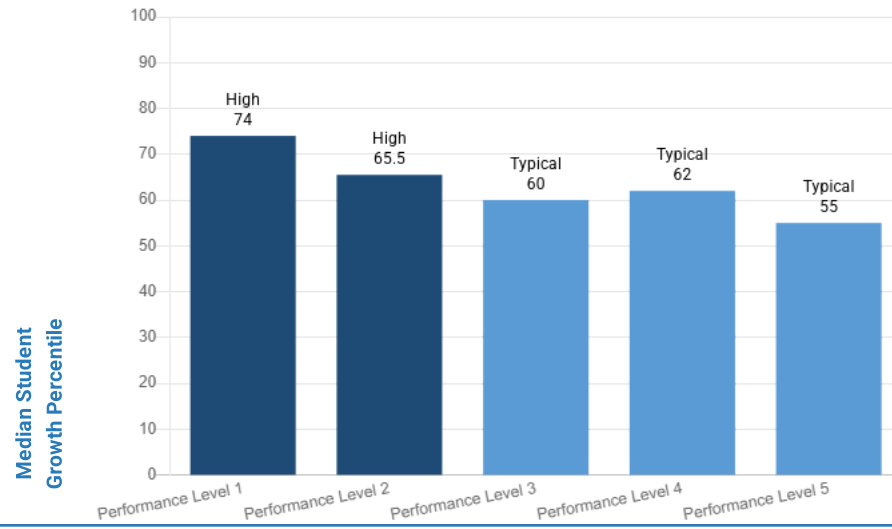

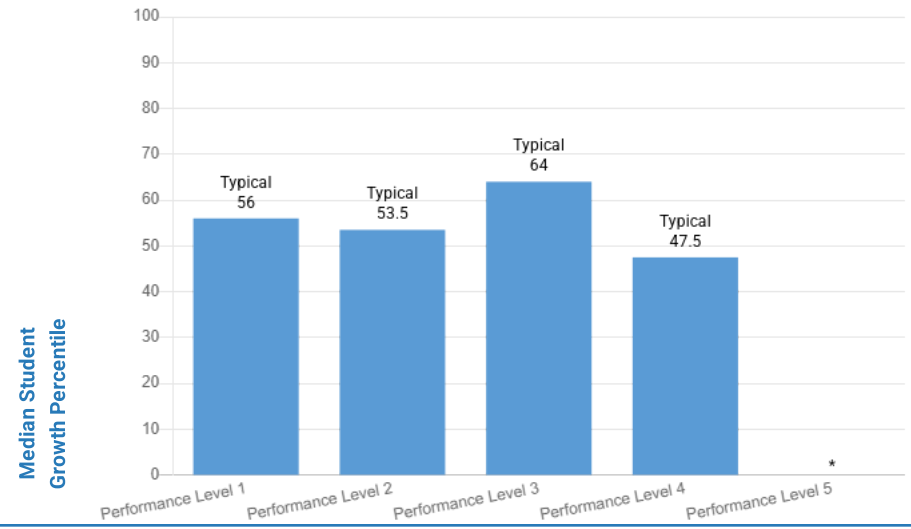

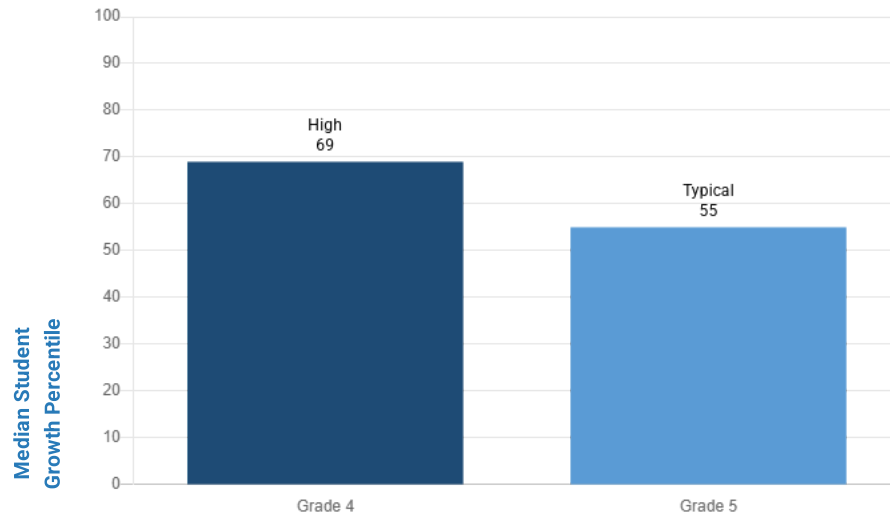

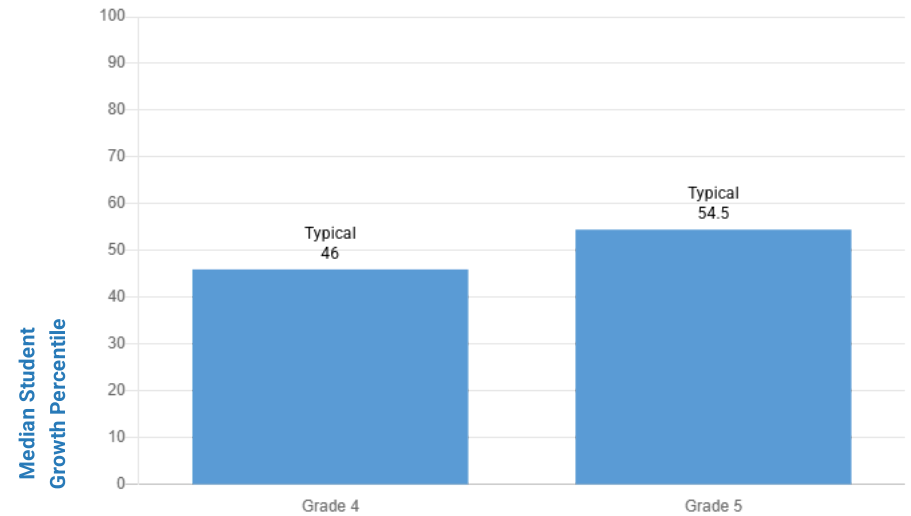

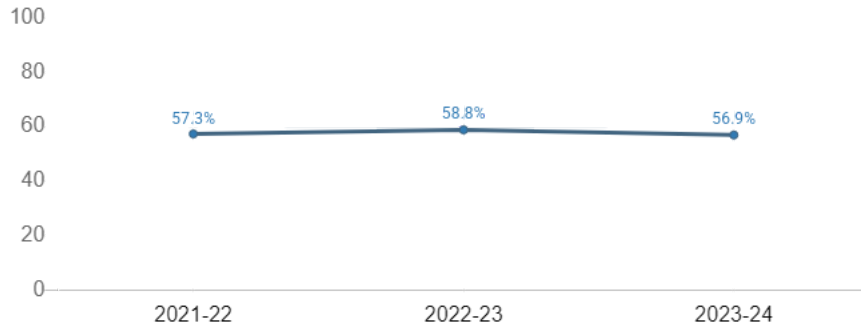

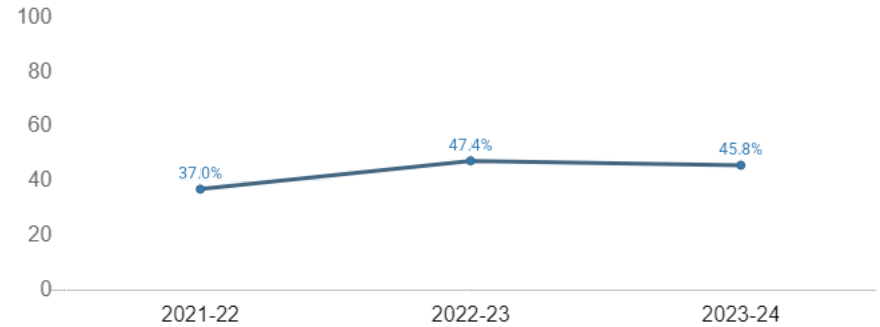
English Language Arts and Mathematics Performance Trends

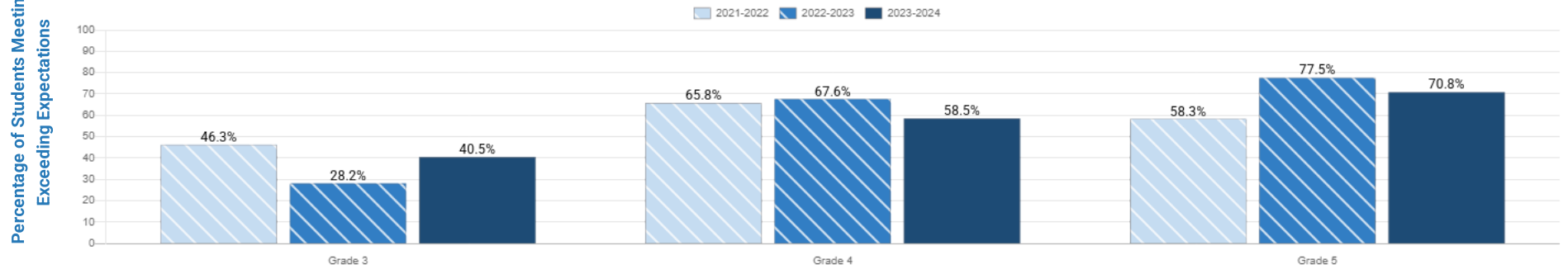

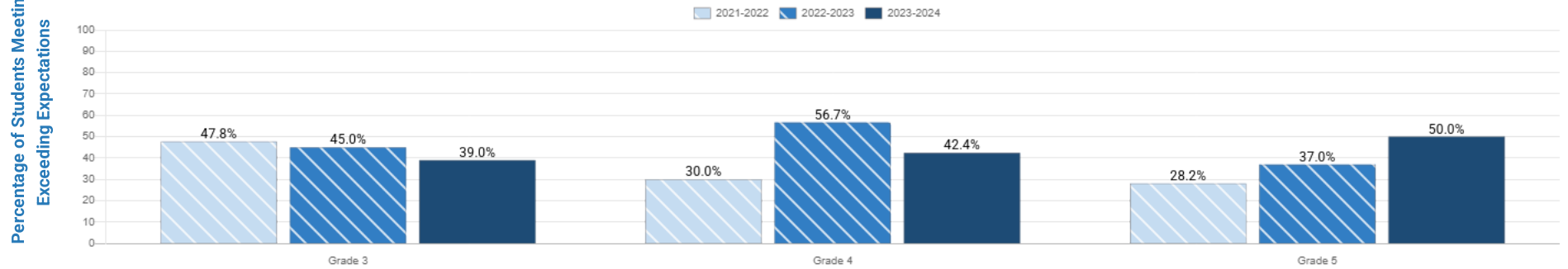

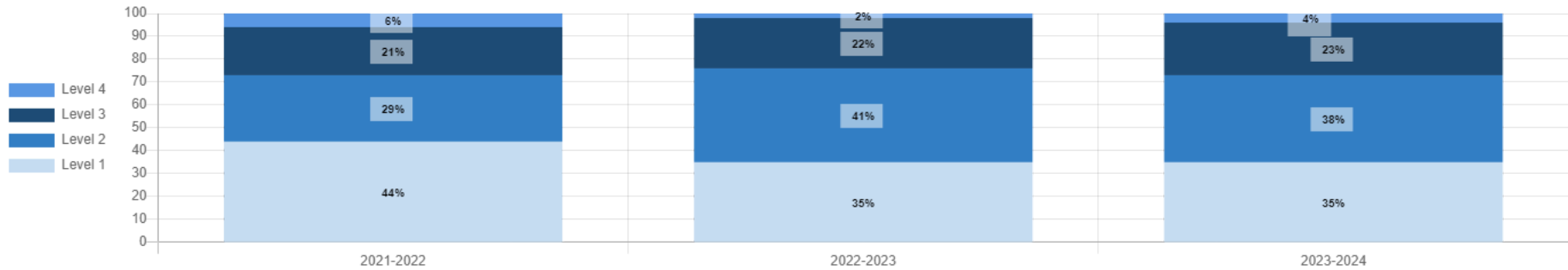

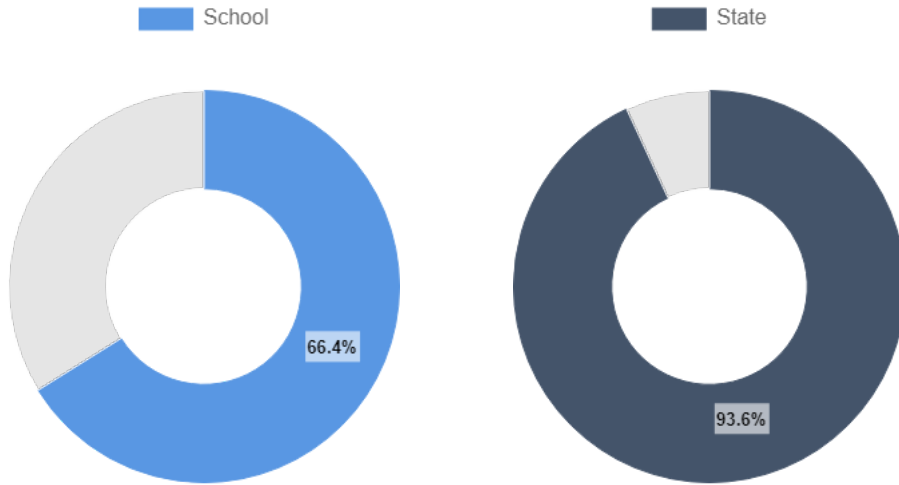

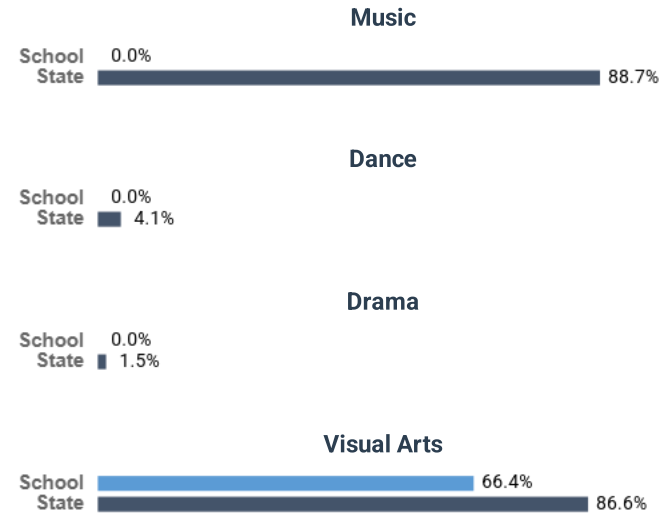

Students enrolled in one or more classes by discipline:



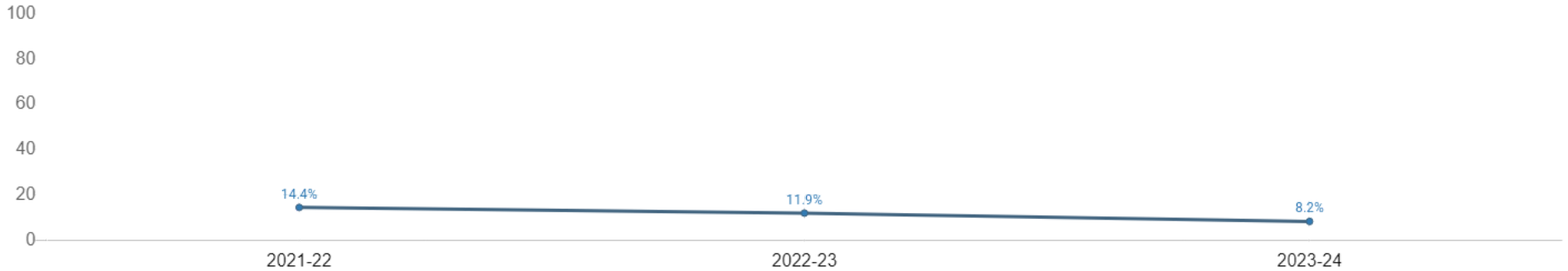

The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. 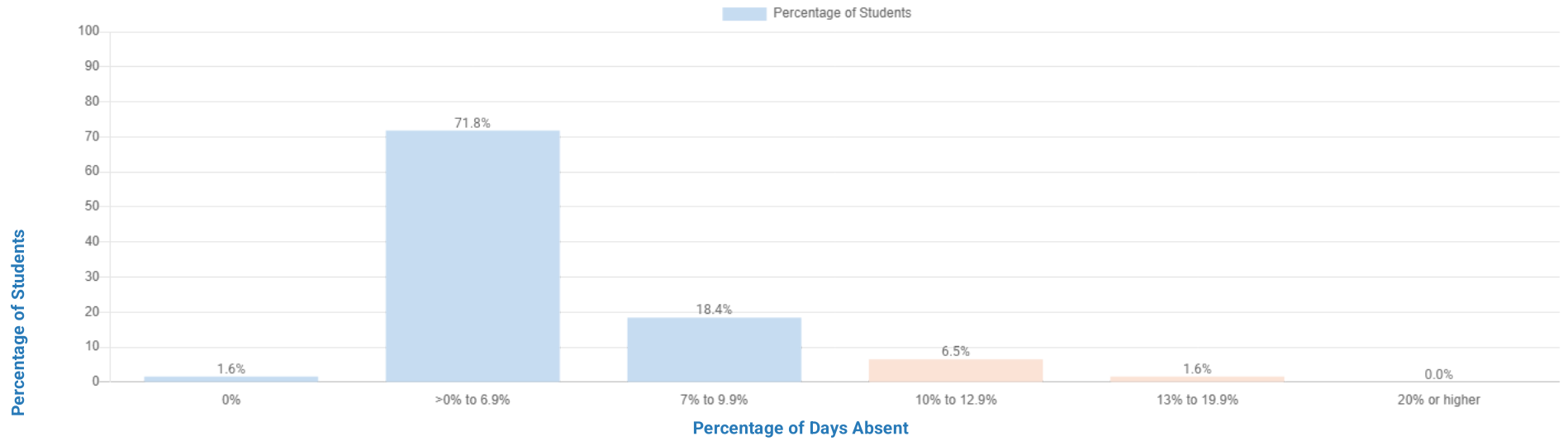

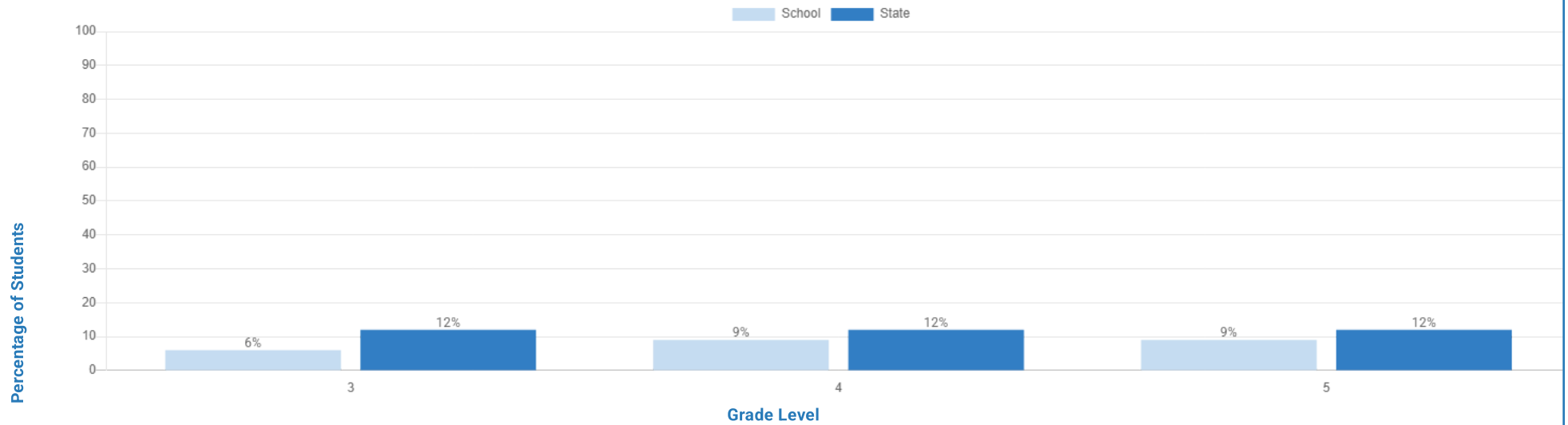

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 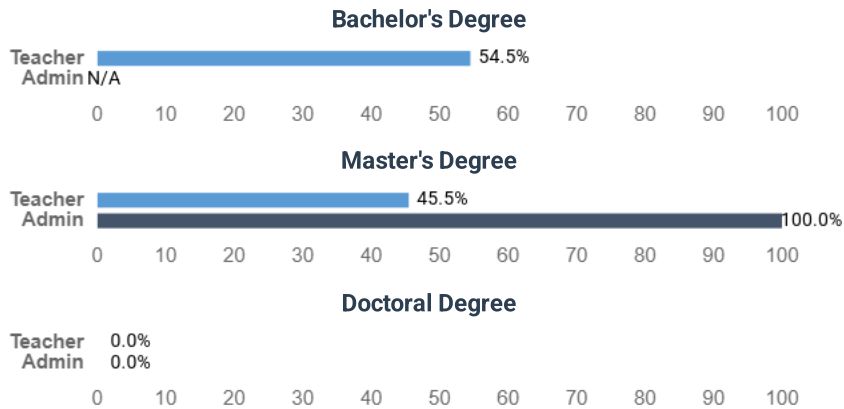

Jefferson School, in collaboration with students, educators, parents and the community, is committed to developing 21st century learning and thinking skills through a rigorous, relevant and comprehensive curriculum, while preparing students to be innovative, productive citizens in an interconnected world. We provide positive and supportive learning environments that address all components of a student's welfare, from academics to social emotional health as well as physical well-being. We encourage differentiated learning experiences with rigor, independence and creativity.



Awards, Recognition, Accomplishments:

Members of our third, fourth and fifth grades are given "Principal Recognition Awards" for achievement and effort to academics. "Random Acts of Kindness" awards are given to students to promote Social Emotional Health and Awareness. Jefferson School was also awarded the BCUA grant in the area of recycling. Jefferson school was awarded a grant by the NJDOE to provide high impact learning for Tier II and Tier III students with an afterschool program which ran two days a week from January through June. Courses, Curriculum, Instruction:

Jefferson School's educational goals and objectives set by the Board of Education serve as a framework for the development of academic and intellectual skills, scientific understanding, aesthetic expression, career development and an awareness of the interaction between the individual and society.



Before and After School Programs:

The Township of Lyndhurst offers an extensive, affordable before and after school program in our school facilities for all students. It is run by teachers and supported by certified caretakers in order to provide balanced programming that supports the academic, social and emotional growth of our students. Our special education students can join our afterschool "Play Unified" program that promotes inclusive relationship building through athletic competitions.



Student Supports and Services:

ESL services, I&RS (intervention and referral services), remedial instruction, and special education instruction are all available. Over 80% of all ELA and Math courses across all grade levels have multiple support staff in addition to the classroom teacher. We have 1 full time remedial staff member. Jefferson School also employs a full-time school counselor / Anti-Bullying Specialist, as well as a part-time behaviorist.

Parent and Community Involvement:

Jefferson School offers a very productive Parent Teacher Association. Together, many learning opportunities are offered throughout the school year, with no cost attached for the school or the student. In addition, Jefferson School offers a parent portal as a window in your child's educational progress. Through the portal you can check homework, grades, quizzes, classwork and attendance. All teachers utilize Google classroom and class "Dojos" to keep students and parents updated on upcoming work and information. Family night workshops both informational and collaborative with students are offered through PTA sponsored events on a monthly basis. We also run a "TREPS" program for 6 weeks that culminates in a TREPS family night for future entrepreneurs.



School Safety:

Jefferson School conducts a minimum of two safety drills each month in coordination with our SRO and the Lyndhurst Police Department. Jefferson School makes sure their building is secure at all times. The School Safety Team reviews all HIB related issues and discusses ways to improve building safety on a quarterly basis. Staff is continually updated on all the latest procedures and theories with regards to student safety.



Technology and STEM:

All Jefferson School students have a lap top computer as we implemented a 1-1 technology device initiative. Lastly, students can attend our STEAM / TAG program if they meet certain criteria.
