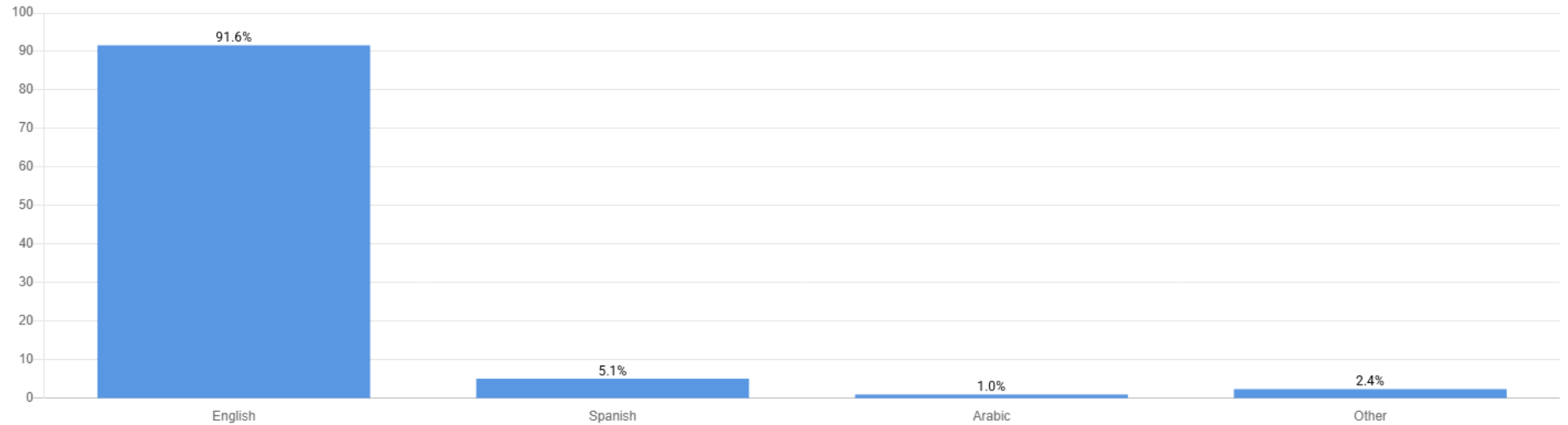

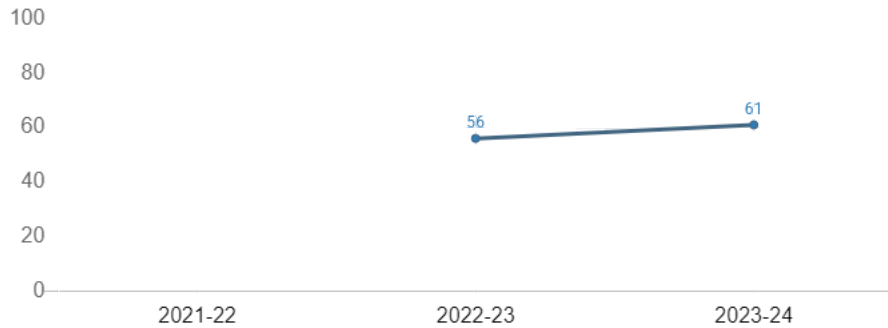

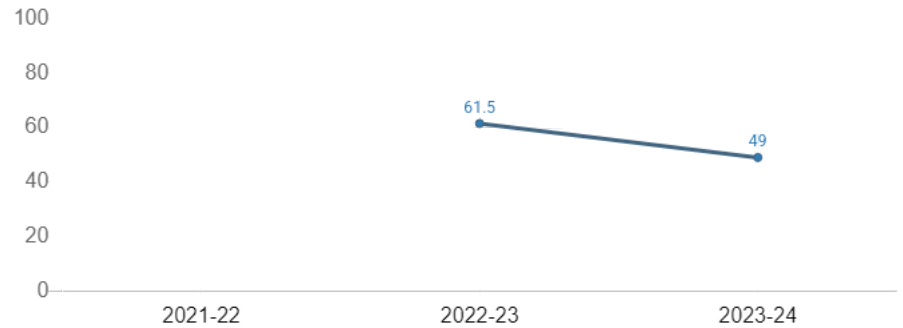

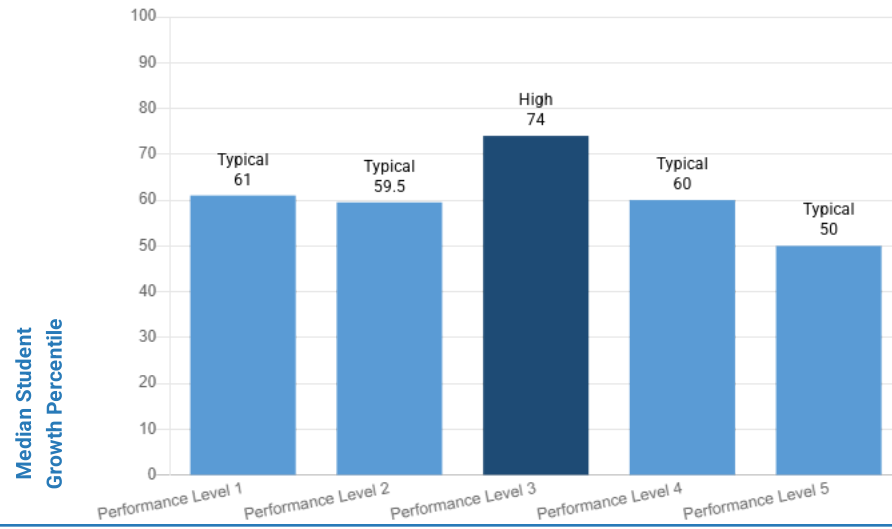

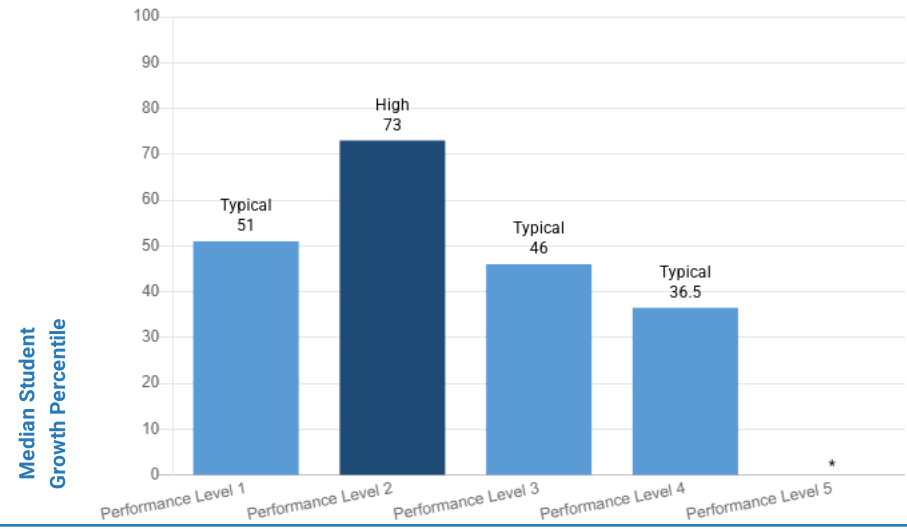

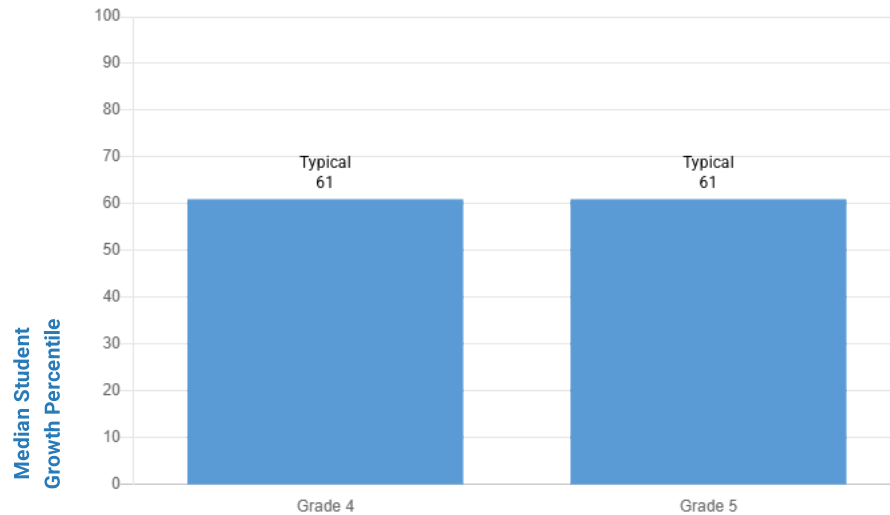

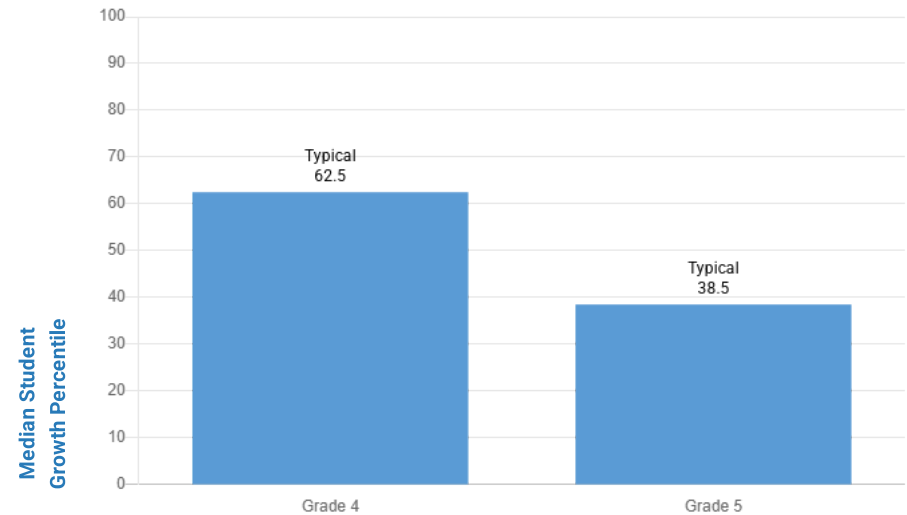

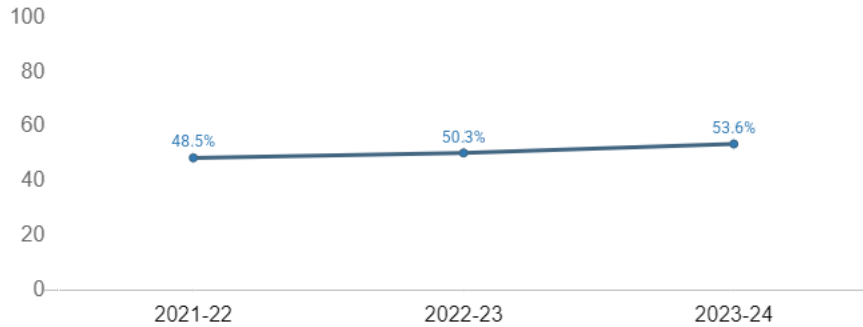

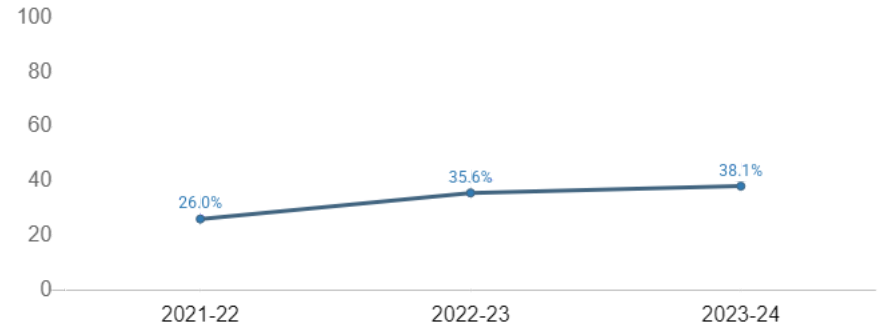
### English Language Arts and Mathematics Performance Trends

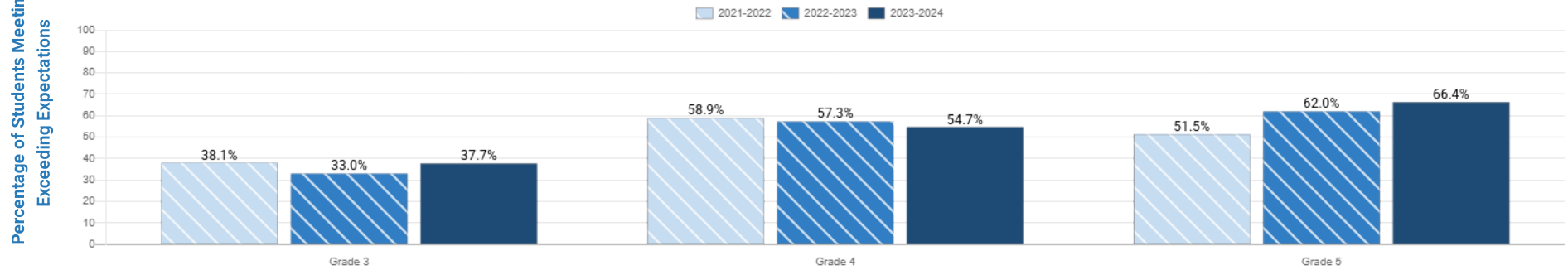

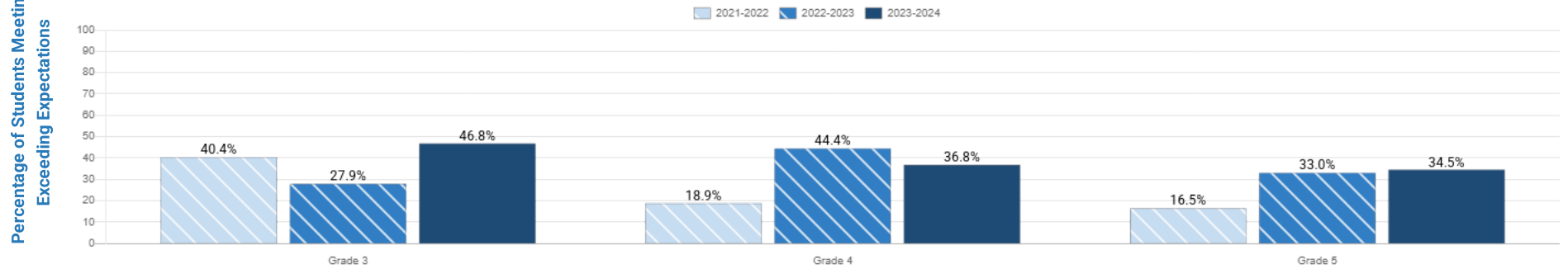

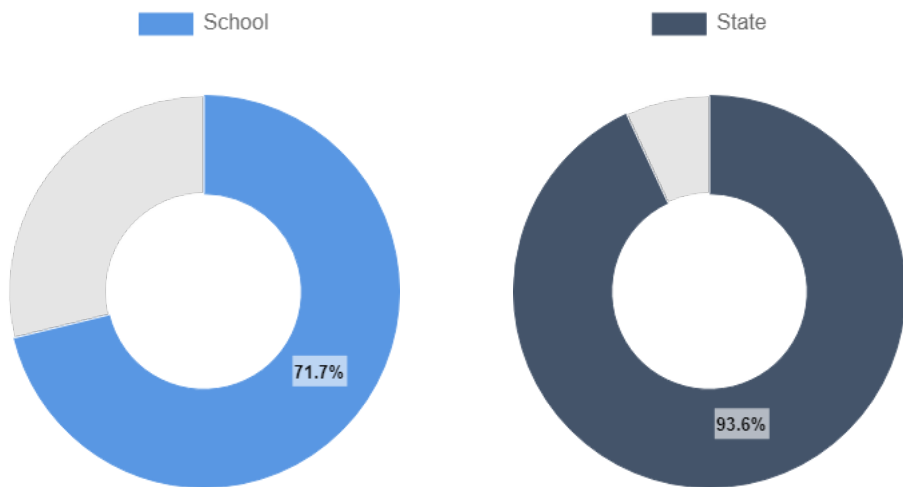

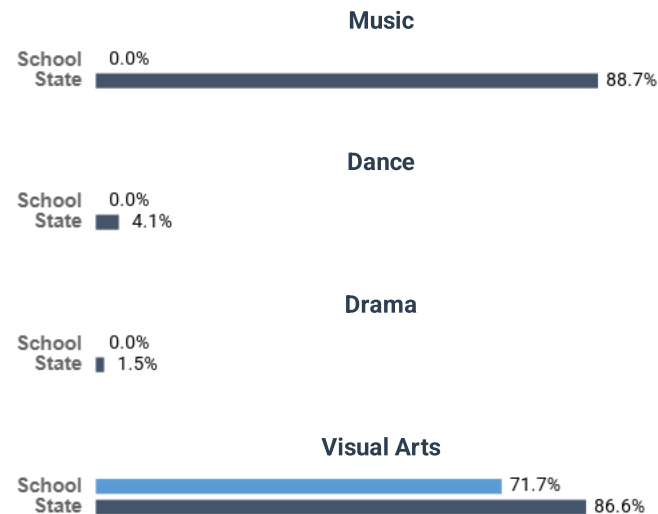

**Students enrolled in one or more classes by discipline:**



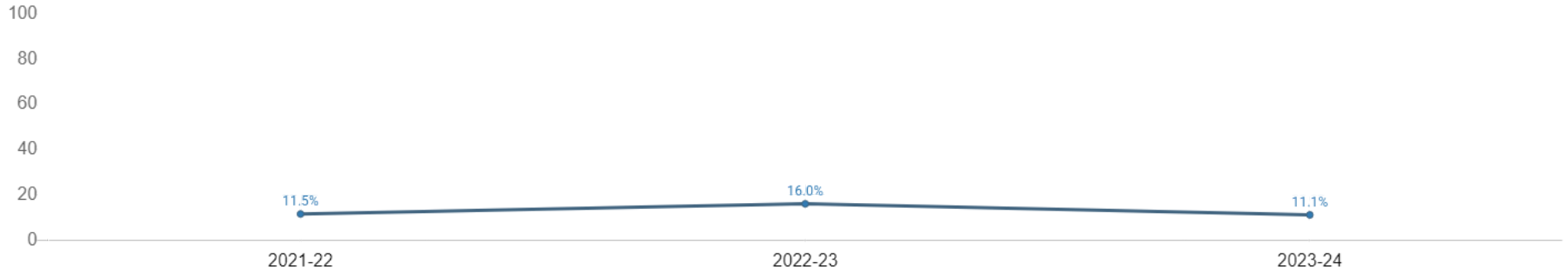

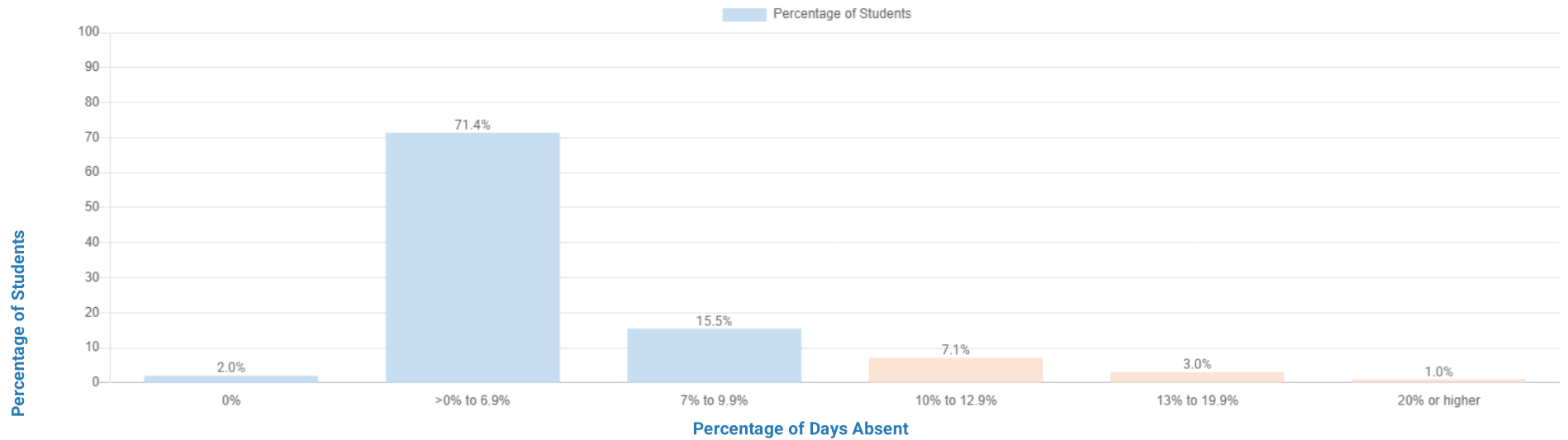

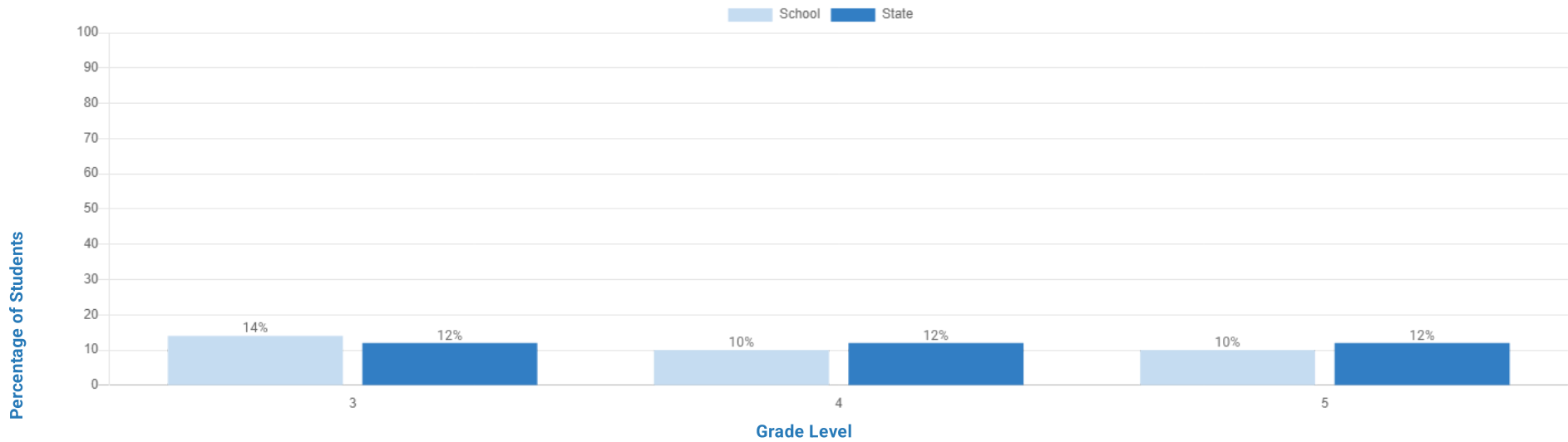

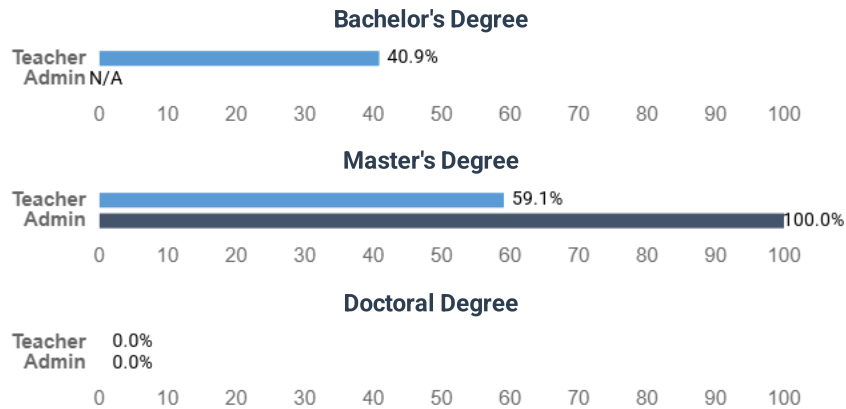

## Accountability

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
  - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
  - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

We provide positive and supportive learning environments that address all components of a student's welfare, from academics to social emotional health as well as physical well-being. ### Before and After School Programs:

The after-school program at Roosevelt School, offered by AlphaBest, provides students with a supportive environment to complete homework and engage in enriching activities. In addition to academic assistance, the program offers a variety of play opportunities, allowing children to enjoy physical activities and socialize with peers. This combination of learning and recreation helps students thrive both academically and socially after school hours.



### Student Supports and Services:

At Roosevelt School, students receive comprehensive support through various services, including Intervention and Referral Services (I&RS) and specialized special education instruction. Over 80% of ELA and Math courses across all grade levels have multiple support staff in addition to the classroom teacher, ensuring tailored assistance for all learners. The school also employs a full-time school counselor/Anti-Bullying Specialist and a part-time behaviorist to support students' emotional and social well-being. Additionally, Roosevelt School has integrated i-Ready, an online supplemental program that creates individualized learning paths for each student, further enhancing personalized instruction and academic growth.



### Parent and Community Involvement:

Roosevelt School boasts a highly productive Parent Teacher Association (PTA) that provides a variety of learning opportunities throughout the school year, all at no cost to the school or the students. The school also offers a parent portal, which allows parents to stay informed about their child's academic progress by checking homework, grades, quizzes, classwork, and attendance. All teachers use Google Classroom and ClassDojo to keep both students and parents updated on upcoming assignments and important information. Monthly family night workshops, sponsored by the PTA, offer both informational and collaborative events for students and their families. Additionally, Roosevelt School has introduced a book vending machine, where students can retrieve books at no cost by earning incentive credits, further encouraging reading and academic engagement.
