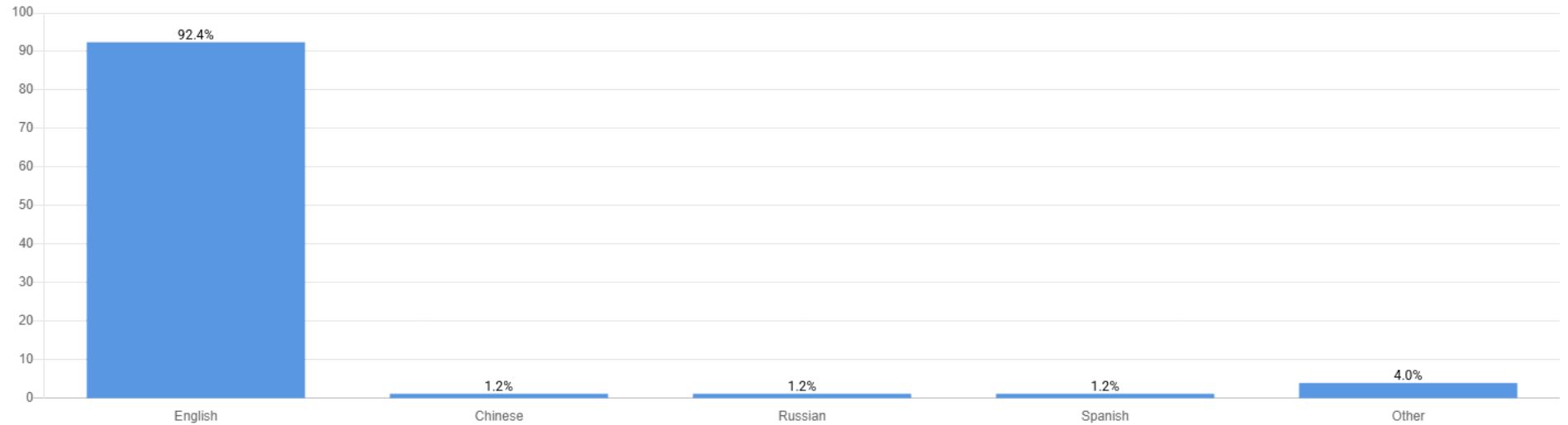

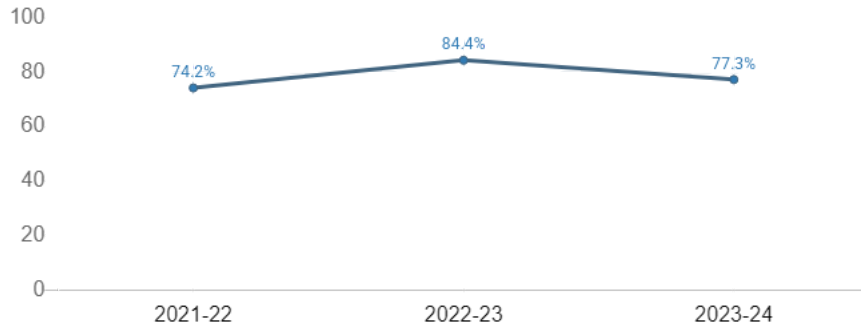

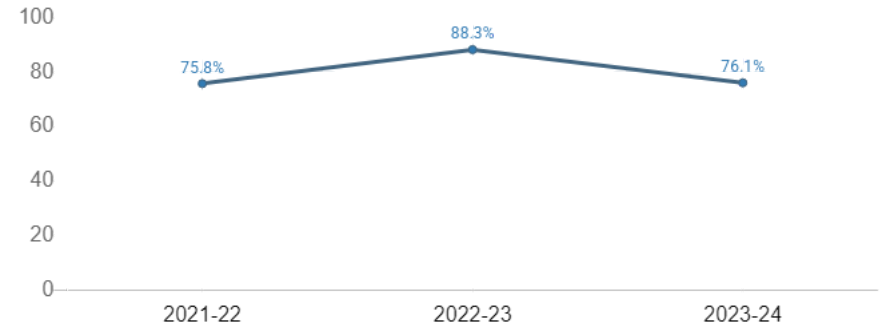
English Language Arts and Mathematics Performance Trends

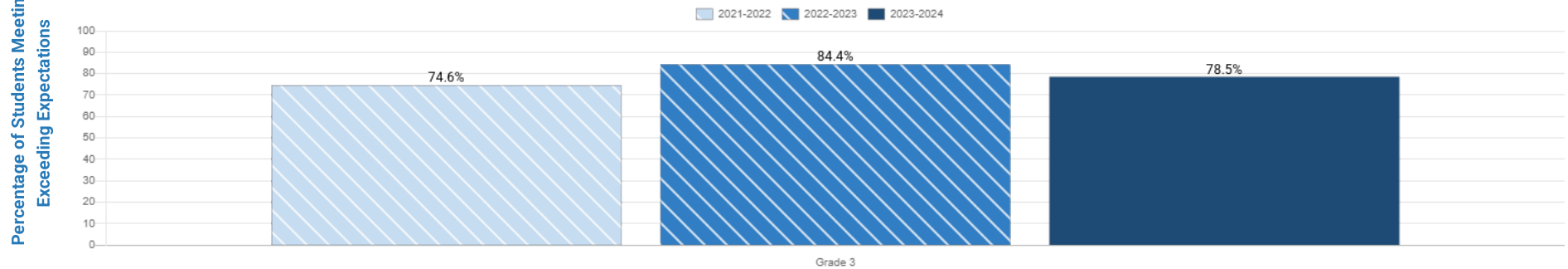

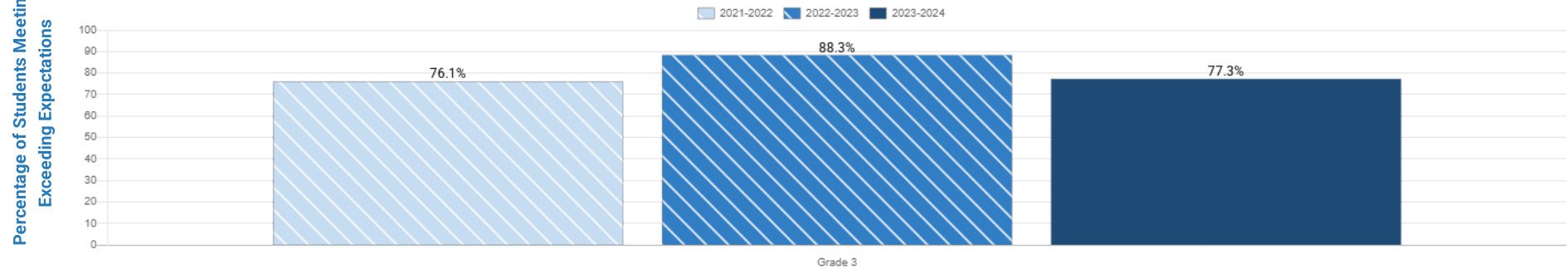

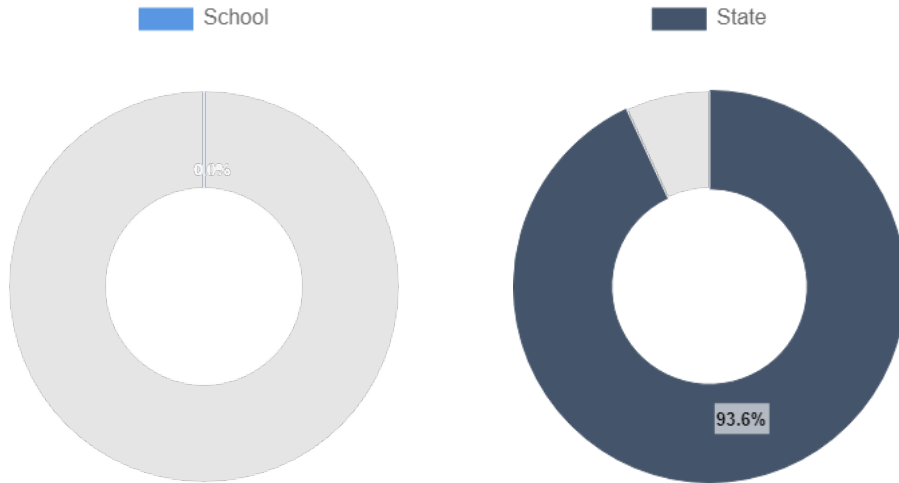

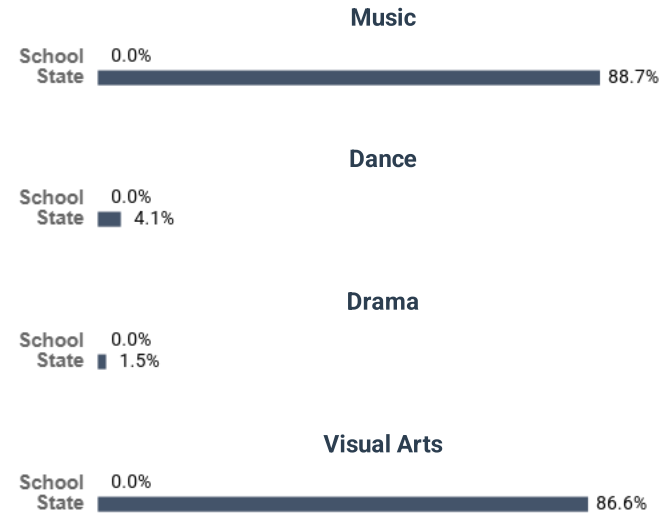

Students enrolled in one or more classes by discipline:



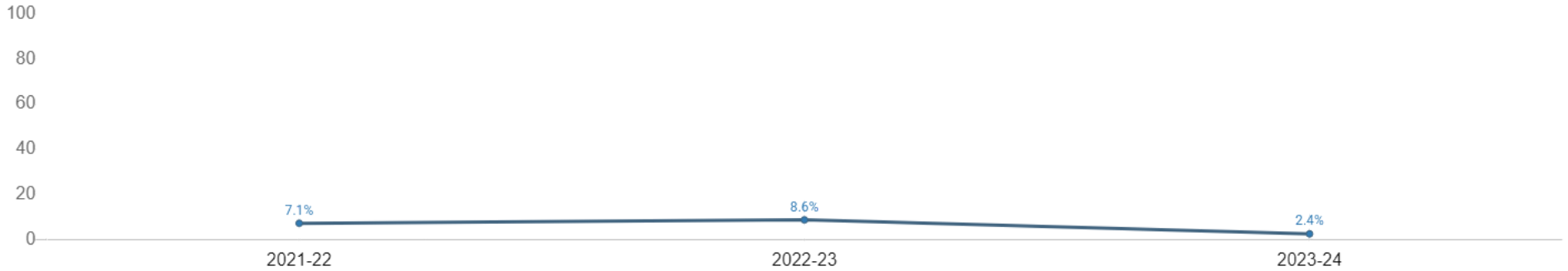
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

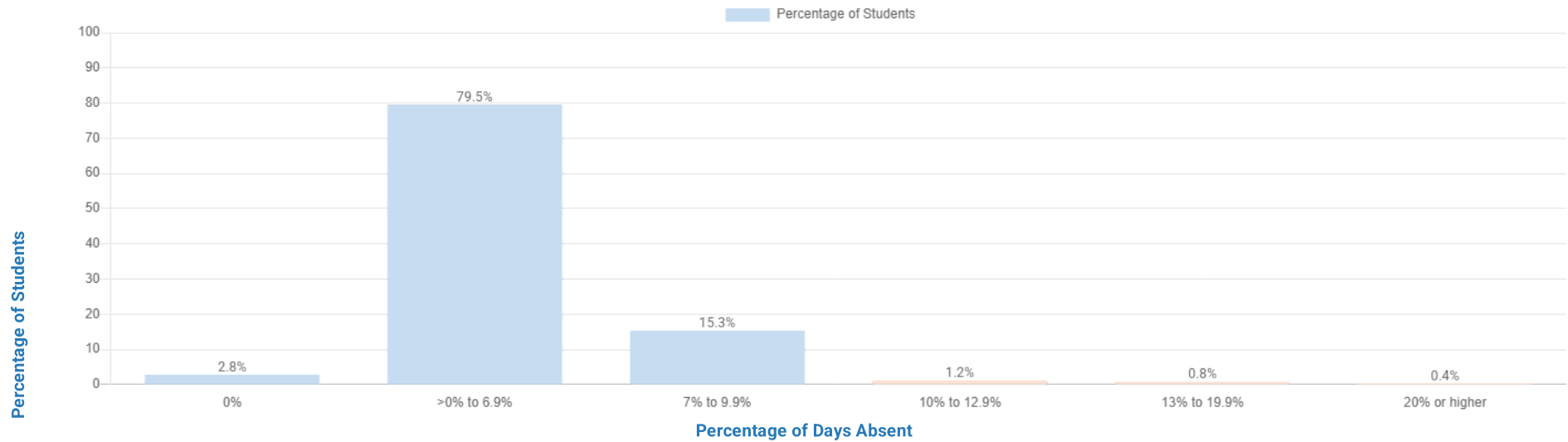

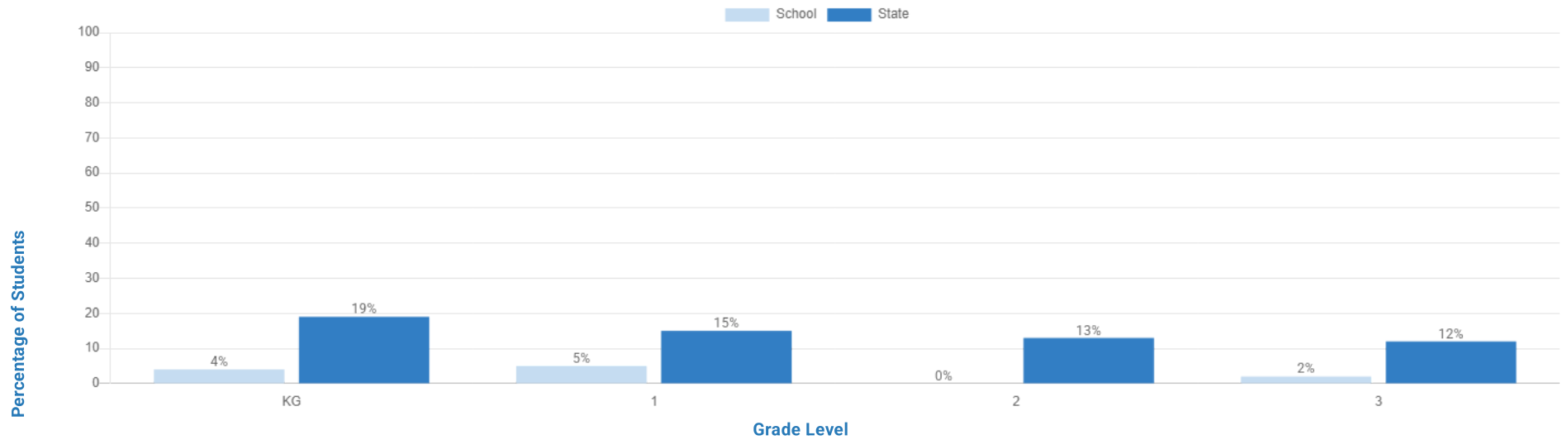

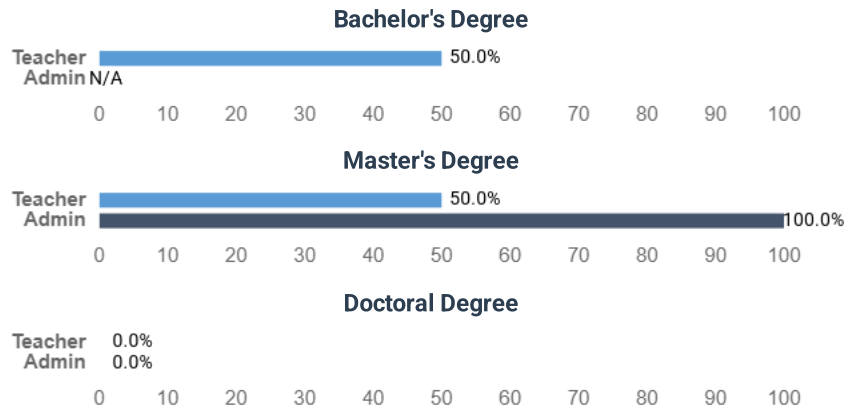

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

Our reading and writing programs, based on the Columbia University Teachers College Workshop model, emphasize just right books, author study, and writing in multiple genres. Students receive explicit instruction in phonemic awareness and phonics through Open Court. This is a structured phonics program that is used five days a week. Our mathematics program, Everyday Math, emphasizes problem-solving and the development of higher-level thinking skills. Our students experience 3-dimensional learning through hands-on science and STEAM activities and explore themes and primary source documents in social studies. We offer PE, Art, Music, Library, Coding and Spanish. We also have Math and ELA instructional coaches to offer curricular support for our staff.



Clubs and Activities:

Our LEGO Club is a creative, hands-on space where students collaborate on fun building challenges, explore their imaginations, and develop teamwork skills.



Before and After School Programs:

The Wyckoff YMCA runs morning and aftercare programs in our schools.

Staff and Professional Learning:

Mahwah is committed to providing professional development that improves teaching craft and student learning outcomes. We have professional development opportunities on varied topics and have started our teachers-teach-teachers academies where teachers have a chance to lead professional development workshops. Teachers also participate in Professional Learning Communities one time per month. Through their PLCs teachers do action research in their classrooms and report on their findings. As in previous years we continue to implement quarterly data teams to not only provide opportunities for data analysis, but also to work toward Tier 1 interventions in NJTSS to improve student outcomes.



Student Supports and Services:

Our school provides comprehensive support for our ML students with classes held five days a week. We offer both general education and resource room settings, facilitated by certified special education teachers. Students also have access to OT/PT, speech, and behavioral therapies as needed. Our 504 and health plans are in place to ensure individualized support for every student. We provide targeted instruction in reading and math, and we implement I&RS action plans to support general education students as necessary. Additionally, our certified K-3 guidance counselors provide behavioral and emotional support through whole-class and individual lessons. They also host lunch bunches to help new students acclimate to Betsy Ross and encourage friendships among all students.



Student Health and Wellness:

All students participate in two PE classes per week and have 30 minutes of recess per day. Our health and fitness teacher implements a health curriculum focused on healthy eating and students learn how to keep themselves fit and strong. Pomptonian Food Service offers balanced and nutritious lunch options that comply with state and government mandates. Two of our teachers are designated as SEL coaches to help implement social-emotional learning opportunities into our daily programs. Every Monday we discuss mindfulness at our school wide morning meeting to give students the necessary tools to regulate their emotions and express themselves. Finally, we have the addition of a school counselor who is in the building two days a week to push into classes to teach about respect, character education, anti-bullying, and to see students individually based on needs that arise.

Parent and Community Involvement:

Parents are an integral part of the Betsy Ross School Community. Our HSO has over 30 committees that sponsor numerous events to raise money for assemblies, field trips, science day, and Field day. Our teachers seek mini-grants to fund innovative curricular projects through the Mahwah Schools Foundation, a volunteer group of parents and community members who, supported by local businesses and fund-raising efforts, have donated over a million dollars to the Mahwah schools. Our HSO runs a yearly walk-a-thon event to bring the community together and raise funds to provide unique learning opportunities to our students. The MSF also hosts a yearly 5k event to raise money for their grant programs that provide valuable curricular enhancements to our daily programs.



Facilities:

The original building was erected in 1931. There were two additions added to extend the building in 1960 and in 1996. Our classrooms, offices, and all-purpose room have air-conditioning. There are continual updates made to the doors, windows, security systems, boilers, and more to ensure that our school is up to date, safe, and functions at its full capacity. Our facilities team is onsite often to assess the building condition and address any issues promptly as they arise.



School Safety:

Two drills a month are held in the school and drills are reviewed throughout the year with the staff. A safety presentation is provided to all staff members in the beginning of the year by our Police Department and our school safety team meets multiple times a year to stay updated on the proper practices and procedures. In October we highlight fire safety with a visit from the Mahwah FD and we have daily walk throughs from the Mahwah PD to check in on building security.

Technology and STEM:

Students have the opportunity to participate in coding classes once a month, as well as engage in hands-on learning that promotes creativity and critical thinking in our STEAM/Makerspace Lab. Students also participate in a unit on digital citizenship in their Library Media classes. Students in grades 2 and 3 are 1:1 with laptops in their classrooms to enhance student learning. Grade 1 classes are 1:4 with laptops in the classroom and kindergarten utilizes Osmos to learn basic coding skills.

Character education is the center for our daily and monthly activities.
