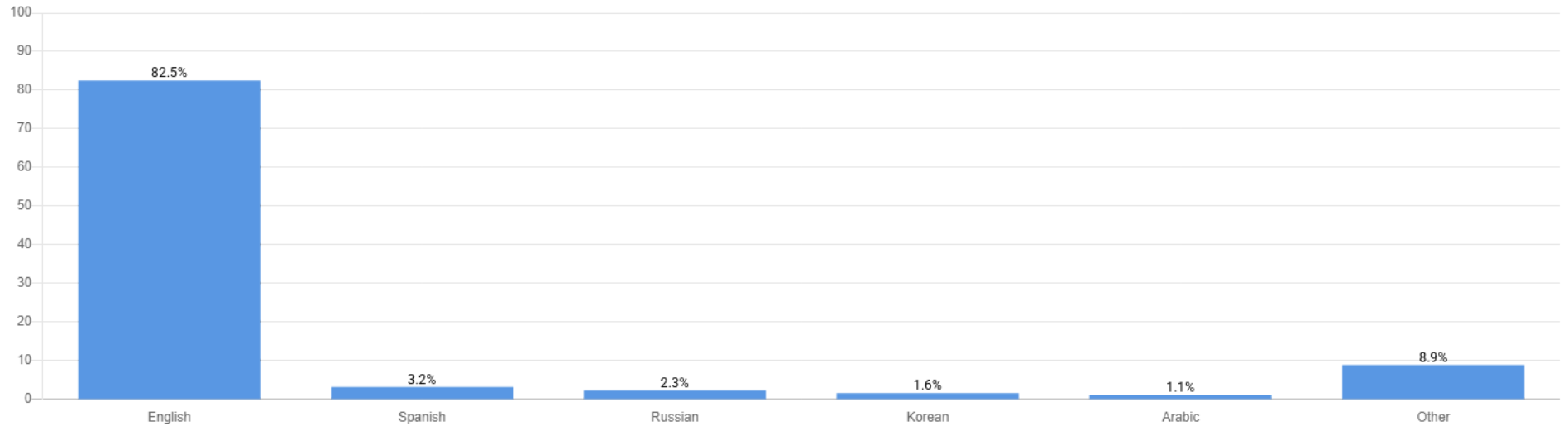

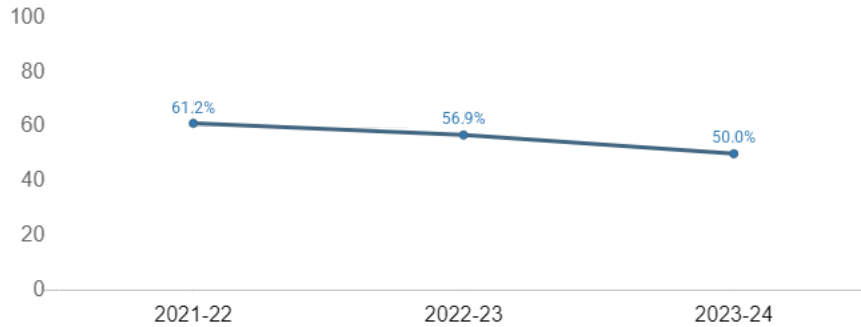

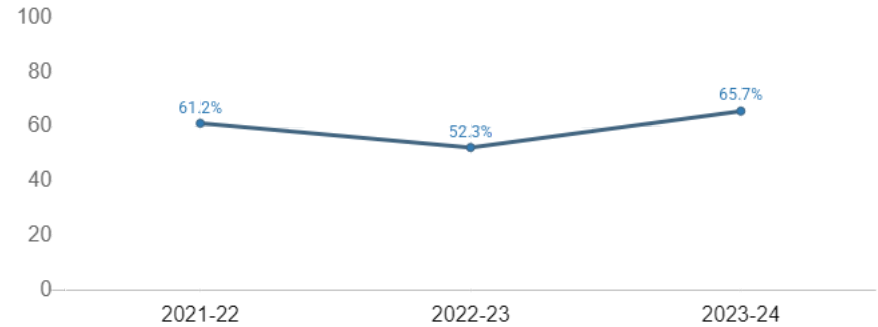
English Language Arts and Mathematics Performance Trends

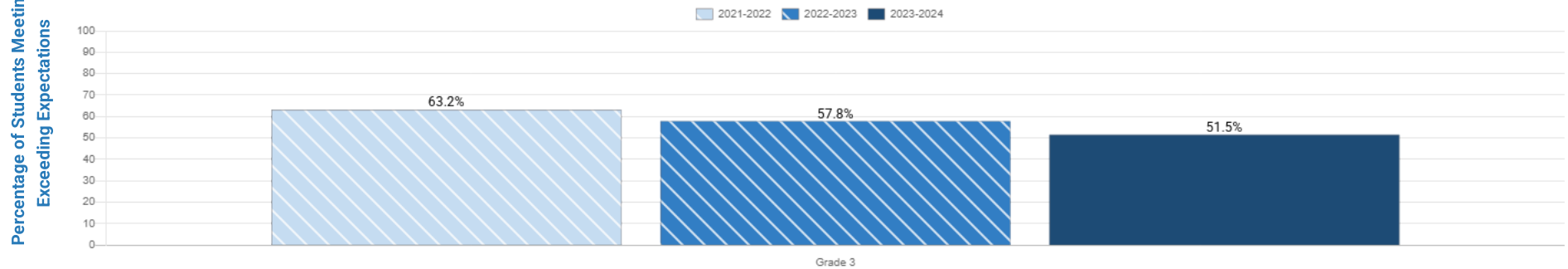

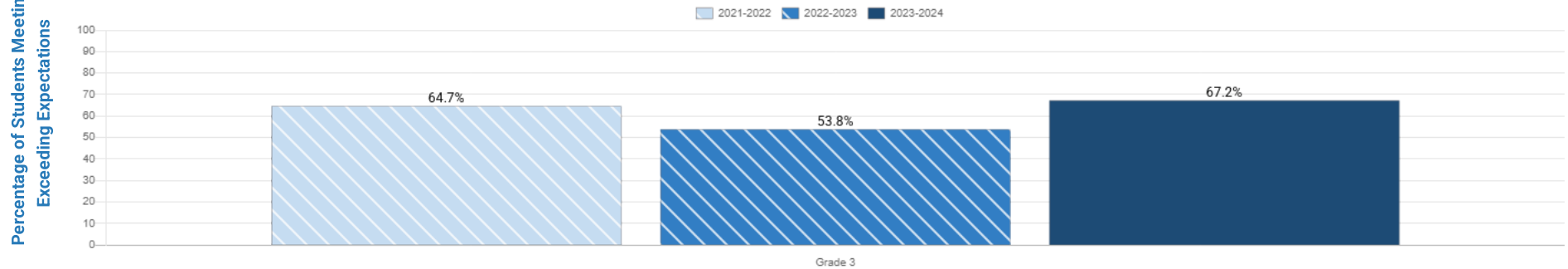

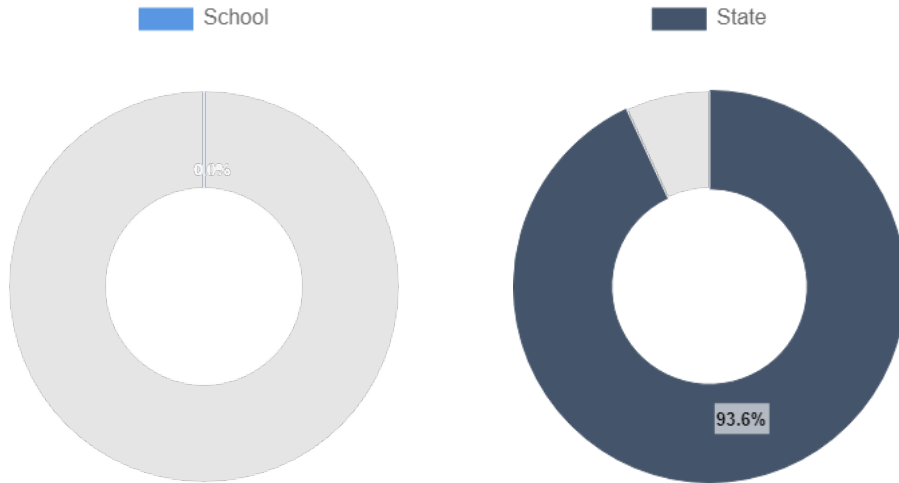

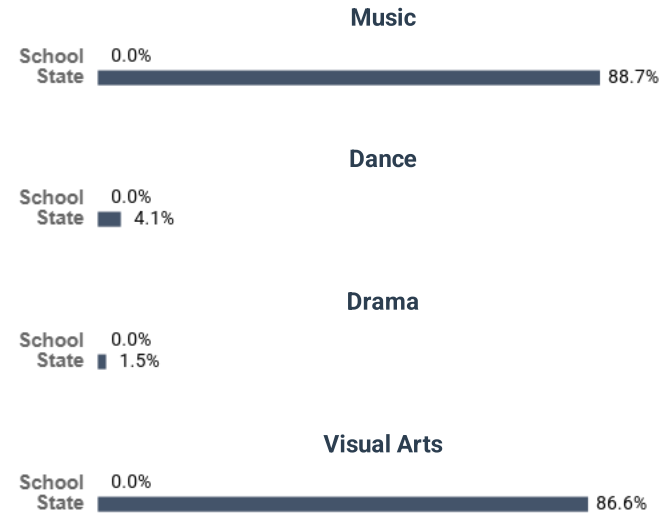

Students enrolled in one or more classes by discipline:



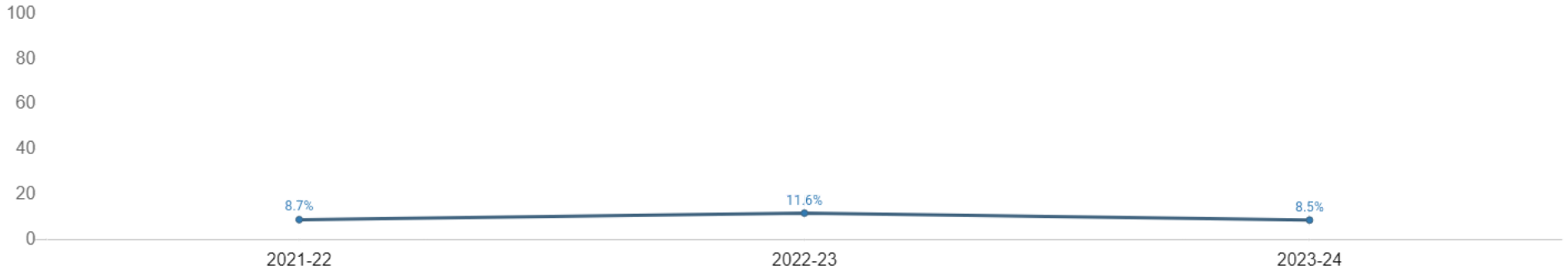
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

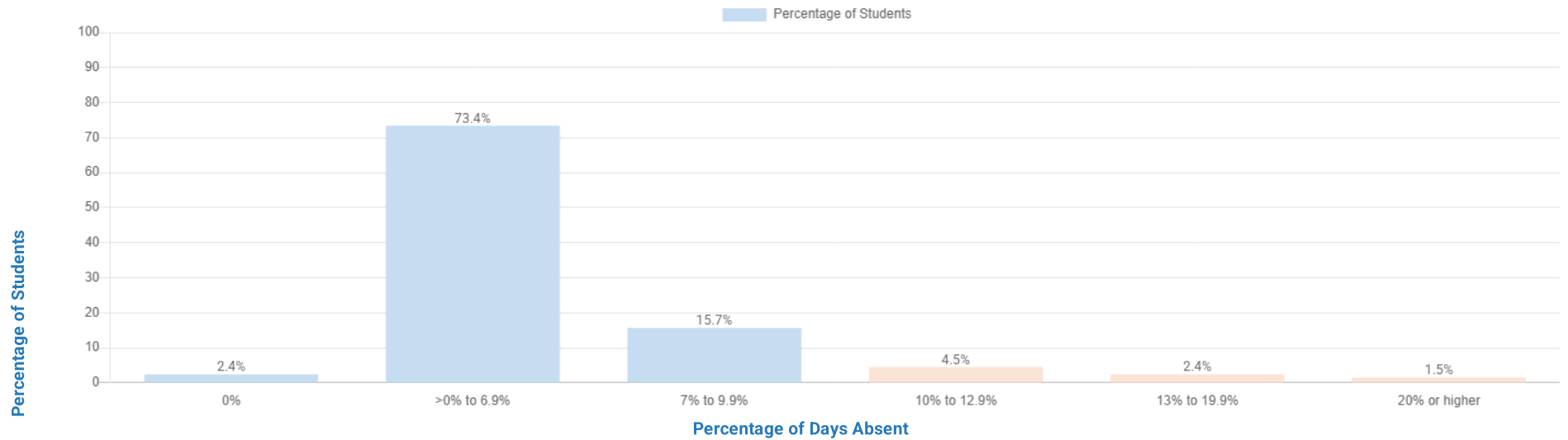

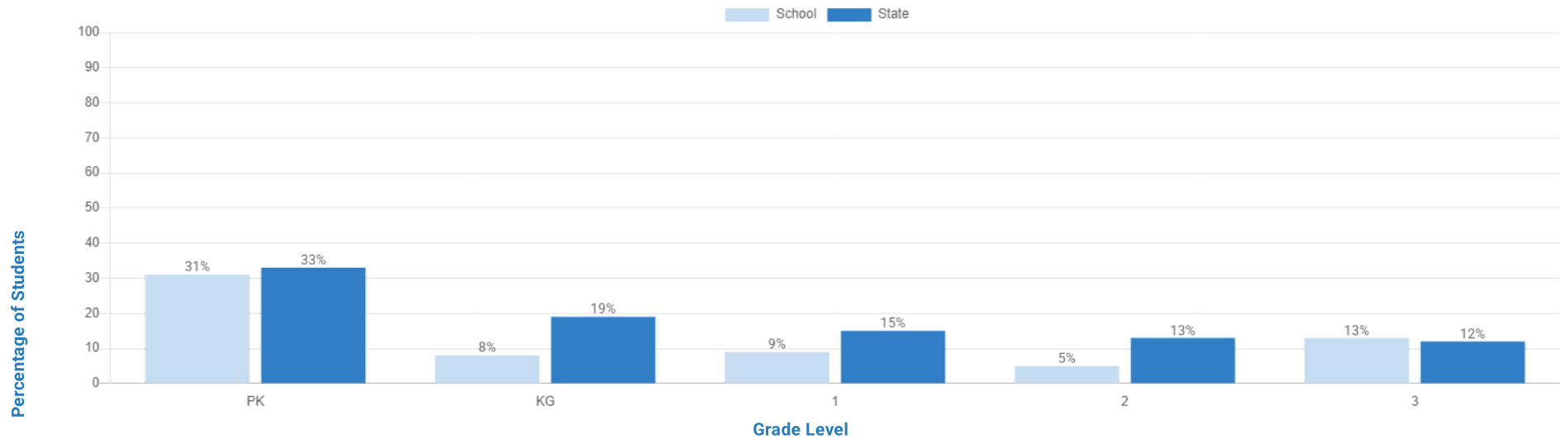

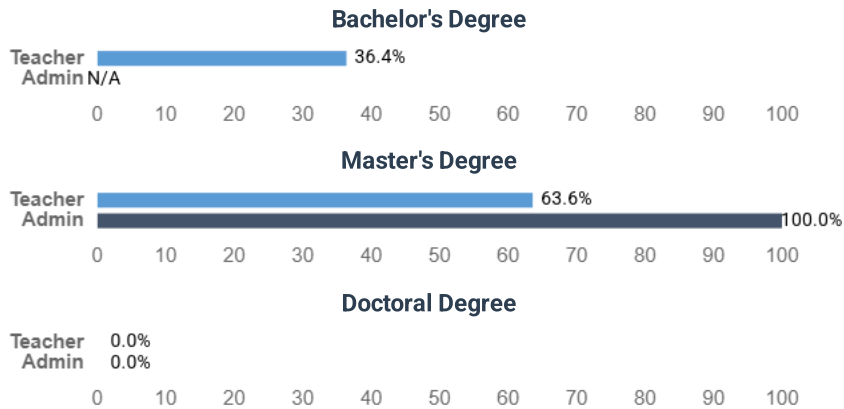

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Courses, Curriculum, Instruction:

Our reading and writing programs, based on the Columbia University Teachers College Workshop model, emphasize just right books, author study, and writing in multiple genres. Students receive explicit instruction in phonemic awareness and phonics through Open Court. This is a structured phonics program that is used five days a week. Our mathematics program, Everyday Math, emphasizes problem-solving and the development of higher-level thinking skills. Our students experience 3-dimensional learning through hands-on science and STEAM activities and explore themes and primary source documents in social studies. We offer PE, Art, Music, Library, Coding and Spanish. We also have Math and ELA instructional coaches to offer curricular support for our staff.

Our third-grade students have the opportunity to be members of our School Safety Patrol. They carry out many responsibilities that focus on being good role models and citizens for our younger students. Additionally, our third grade students participate in the Spirit Squad.. Selected students visit teachers' classrooms to spread positivity and kindness by offering them an item from our kindness cart.

Staff and Professional Learning:

Mahwah is committed to providing professional development in areas that improve teachers' instructional methods and student learning outcomes. An area of focus is how to embed social-emotional learning and mindfulness throughout the school day so students are mentally and physically in a better place to learn. We offer in-house PD opportunities on varied topics and offer Professional Development Academies, including our Mahwah Thunderbird Academy, focusing on technology, where teachers have a chance to lead workshops. Teachers also participate in monthly grade-level meetings, which focus on reviewing and analyzing curriculum and student work. Self -Directed Professional Learning Communities one time per month. Through their PLCs, teachers do action research in their classrooms, develop lesson plans together, and analyze student work to drive their instruction.

Student Supports and Services:

We have classes 5 days a week for ELL students. We offer general ed and resource room settings through special education. If applicable, students are offered OT/PT, speech, and behavioral therapies. We have 504 and health plans in place that support our students. We offer support in reading, multi-sensory reading, and math and have I&RS action plans to assist general education students as needed. Tutoring services are available to all students during their lunchtime. All teachers are certified in the corresponding specialized area. Our K-3 guidance counselors have helped educate and support students behaviorally and emotionally through whole class and individual lessons. Additionally, they conduct lunch bunches to help new students become acclimated to Lenape Meadows and help current students form friendships.



Student Health and Wellness:

All students participate in 2 PE classes per week and have 30 minutes of recess per day. Our PE/Health teachers implement a health curriculum focused on wellness practices, and students learn how to keep themselves fit and strong. Pomptonian Food Service offers a balanced and nutritious menu and ensures that the food complies with all state and government mandates. Specialized menus are available for students that have specific allergies or food restrictions.



Parent and Community Involvement:

Parents are an integral part of Lenape Meadows. Our HSO sponsors numerous events to raise money for assemblies, field trips, Science and Field Day, all of which provide school-wide enrichment. Our HSO meets monthly and works collaboratively with administrators. They run two book fairs a year and our Move-A-Thon. Our teachers seek grants to fund innovative curricular projects through the Mahwah Schools Foundation, a volunteer group of parents and community members who, supported by local businesses and fund-raising efforts, have donated over a million dollars to the Mahwah schools. The district's Thunderbird Partnership Program allows local community experts in specific areas to share their knowledge with our students.

Facilities:

Our school building was built in 2002. The entire school building has central air conditioning, which was updated in 2019. The doors, windows, security systems, boilers, floors, and more are continuously updated to ensure that our school is safe, up-to-date, and functions at its full capacity. We have updated our blacktop to provide more recess opportunities and to promote social-emotional learning with affirmations.



School Safety:

Lenape Meadows works collaboratively with the district to make sure that all safety measures are in place. Two drills a month are held in the school, and drills are reviewed throughout the year with the staff. A safety presentation is provided to all staff members at the beginning of the year by our Police Department, and our school safety team meets four times a year to stay updated on the proper practices and procedures. All visitors are screened by our Raptor system, and cameras are strategically located throughout the school. Specific staff members carry walkie-talkies to communicate with one another and also have a button that gives them direct access to the Mahwah Police Department.



Technology and STEM:

Technology is incorporated into all areas of the curriculum. 2nd and 3rd grade students utilize Google Classroom in school/home. Assignments are completed individually & with partners. Students utilize online programs to support learning and differentiate instruction, including iReady, Epic, RAZ Kids, Connect Ed, Math Fact Monster, Kahoot, BrainPop, BrainPop Jr. BookFlix, and Splashlearn. Teachers utilize Remind App to support communication with parents/guardians. Technology standards are supported within the curriculum and Media classes, which exposes students to the Google Suite and its applications. Monthly coding classes are held in our STEAM room, and students use coding applications, Ozobots, coding robots, and cubelets. These activities are geared toward learning programming, building mastery in sequencing skills, counting, problem-solving, and logical/critical thinking. Classrooms are equipped with Promethean Boards & teachers use ActivInspire to support lessons

The Lenape Meadows staff and parents create a close-knit family of dedicated stakeholders providing a nurturing school environment - a home away from home. Character education is the center of our daily and monthly activities, including our monthly Spirit Day. Our social-emotional learning program, Responsive Classroom, teaches children to value honesty, responsibility, and respect and actively teaches caring for one another. Our students work together daily during Morning Meetings to build their classroom community and learn about respect and kindness. Each morning, as our 375 students gather together and before they begin their day, all students recite our Lenape Meadows Pledge: I pledge as a Lenape Meadows citizen to work hard, be kind to my schoolmates, and follow the rules of my school. This is just one reason why Lenape Meadows School is so special. Our Library/Media Center provides instruction in research and technology skills, as well as the development of lifelong readers. Students have supervised Internet access in all classrooms. All of our classrooms, including our three Pre-K classrooms, have Promethean interactive whiteboards, which allow teachers to deliver lessons using multiple sources that provide dynamic auditory, visual, and kinesthetic experiences for all students. Lenape Meadows staff and parents have banded together to create a safe and caring school environment that is truly our home away from home. We maintain weekly communication with all families through our weekly One Call messages sharing that focus on school information and upcoming events.
