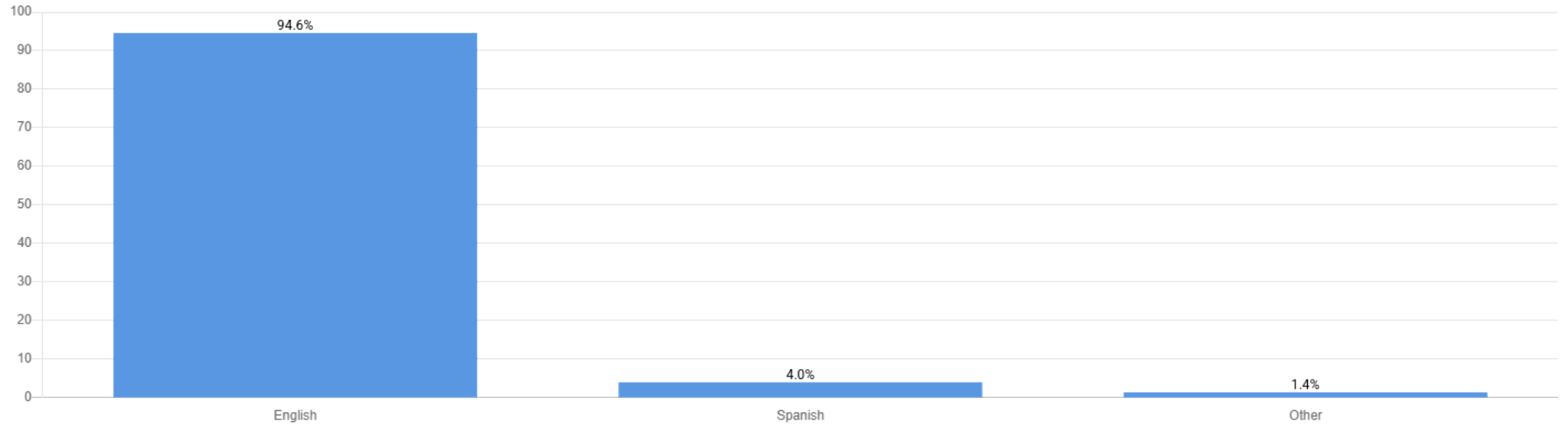

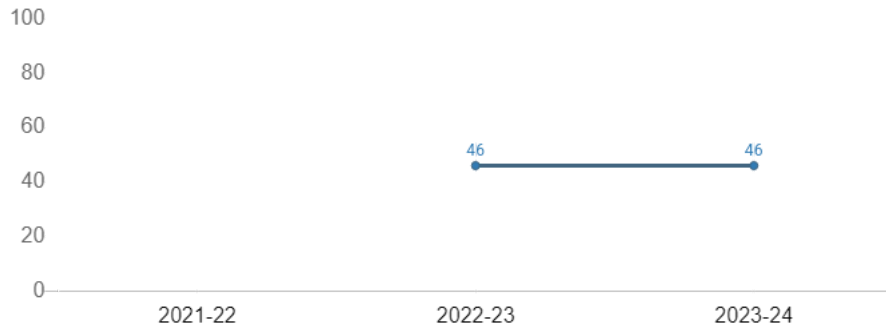

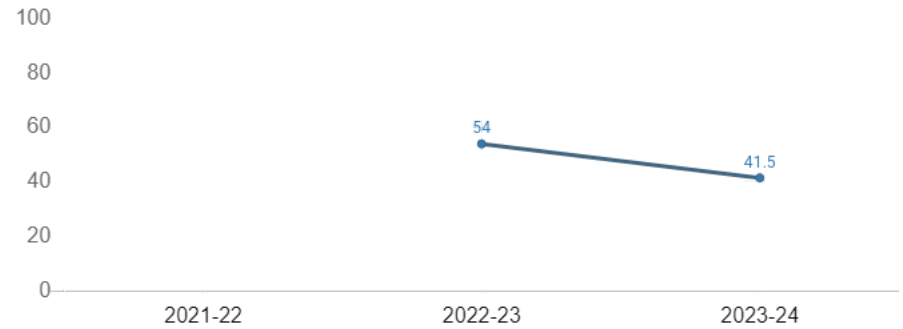

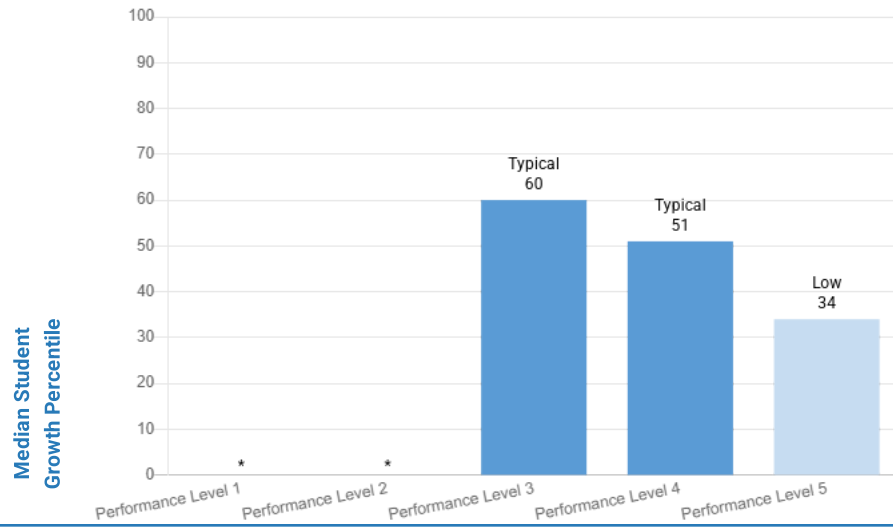

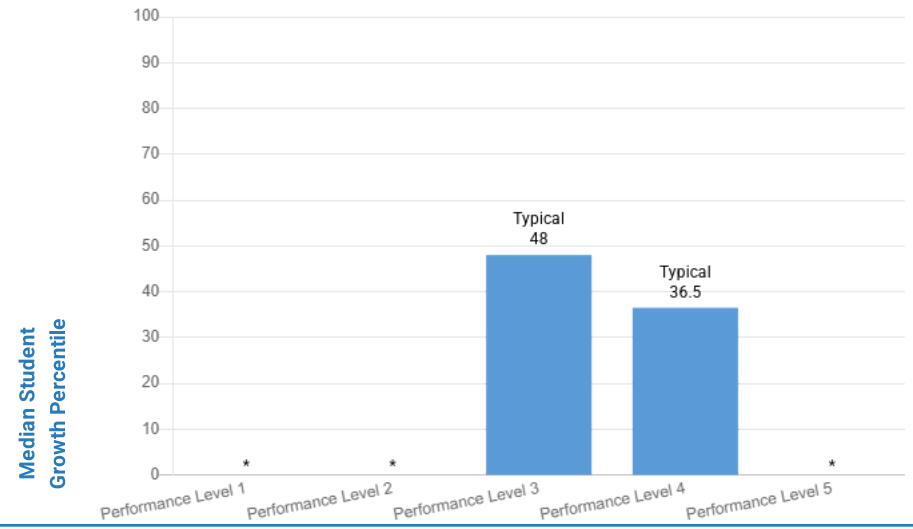

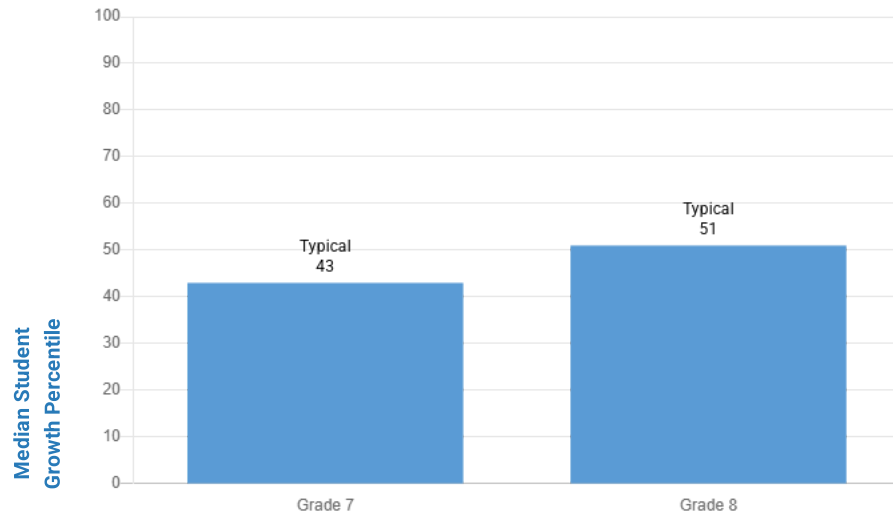

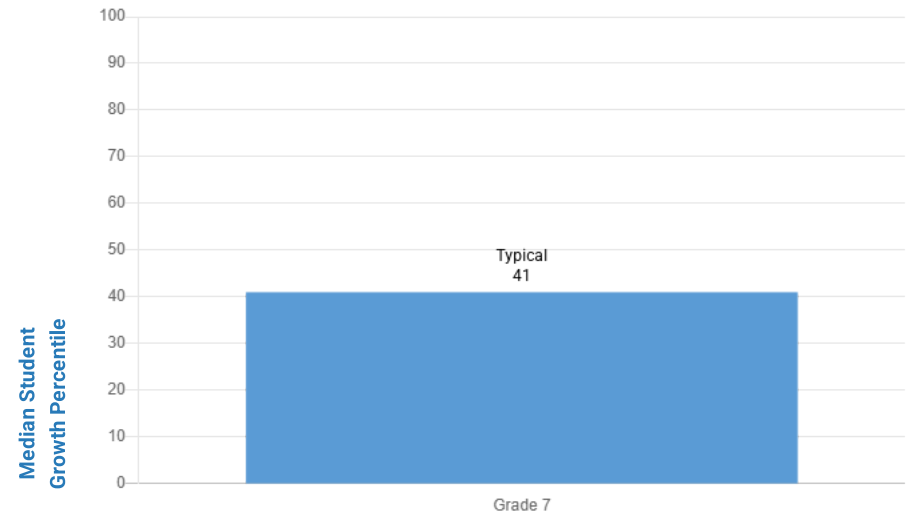

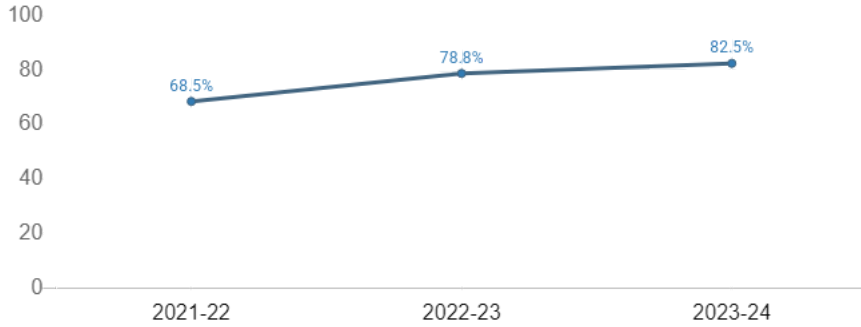

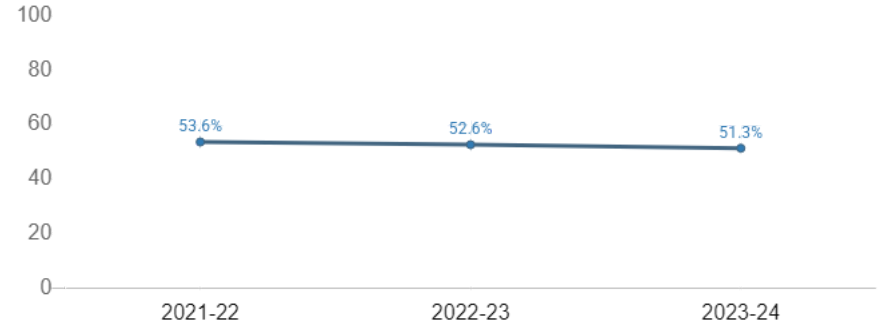
English Language Arts and Mathematics Performance Trends

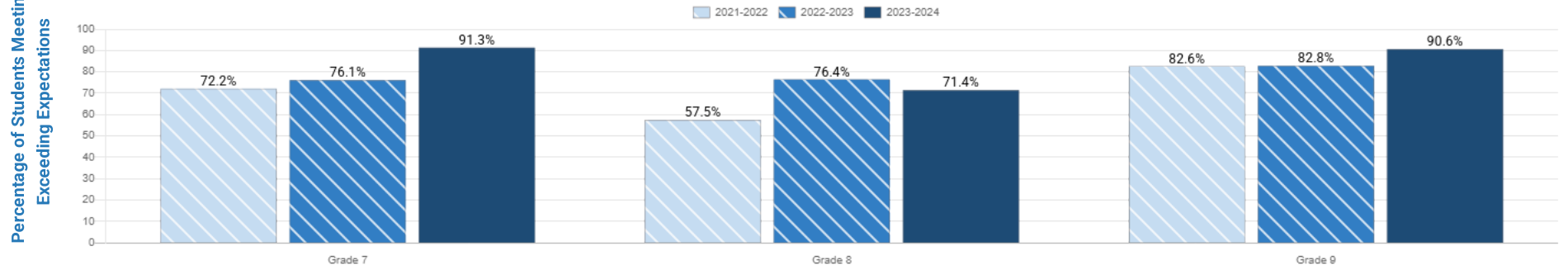

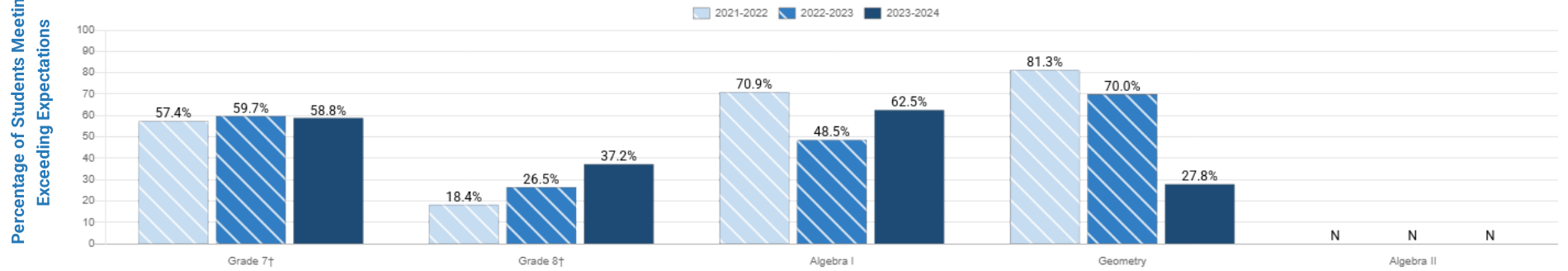

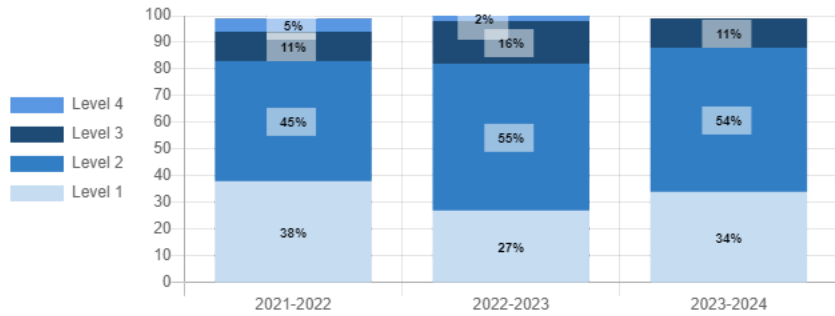

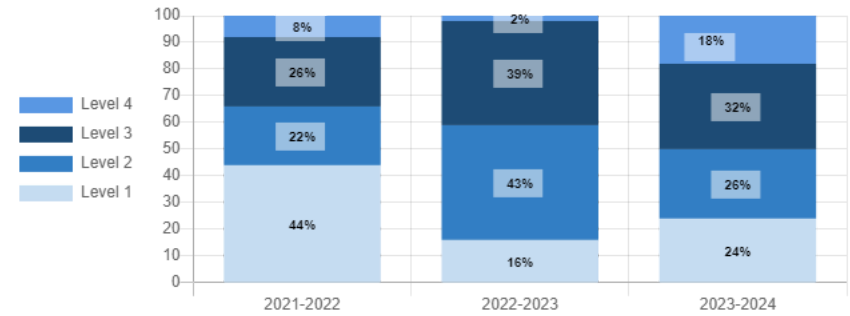
NJSLA Science Assessment: Grade 8 Summary

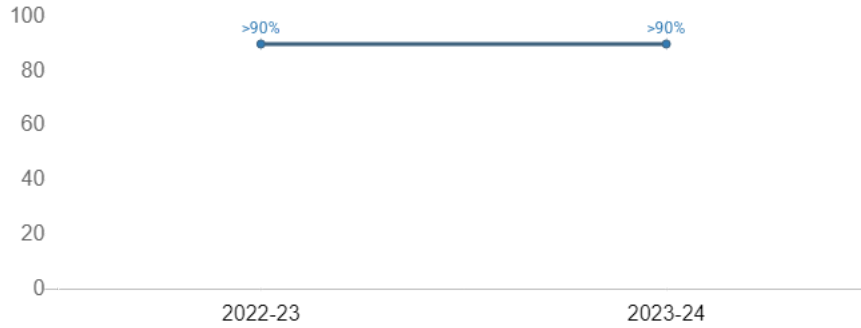

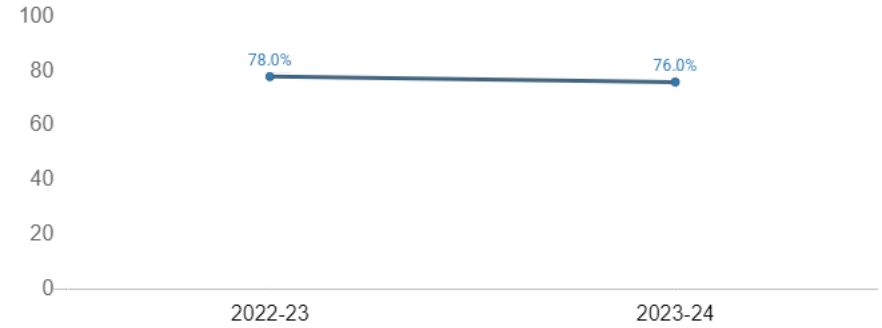

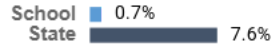

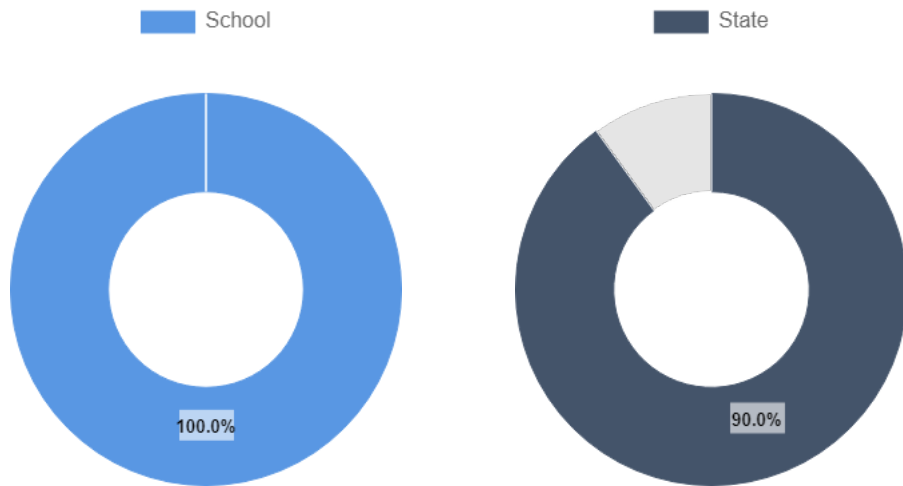

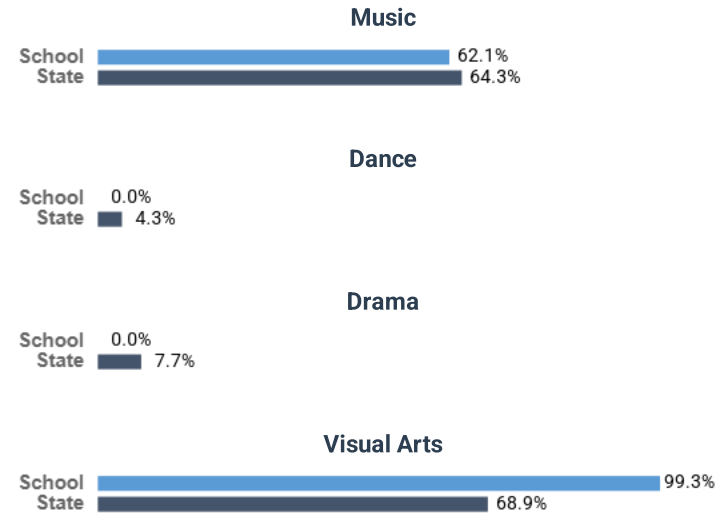

Students enrolled in one or more classes by discipline:



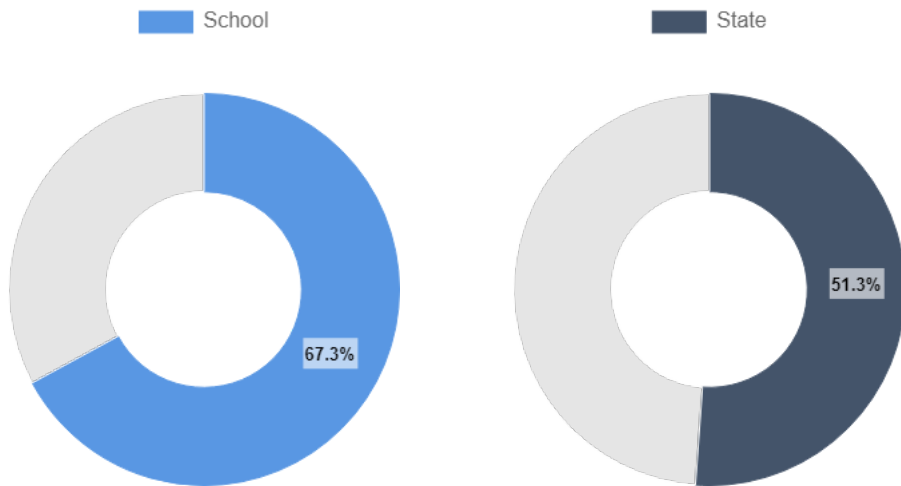

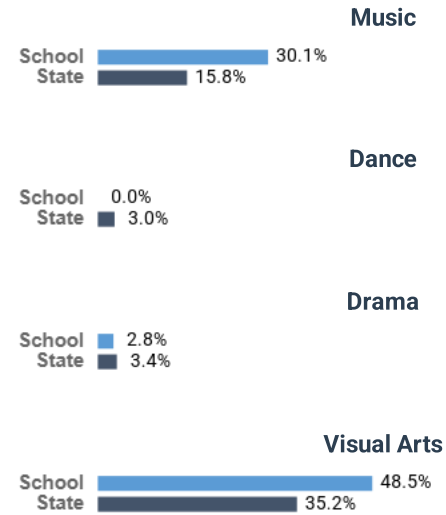

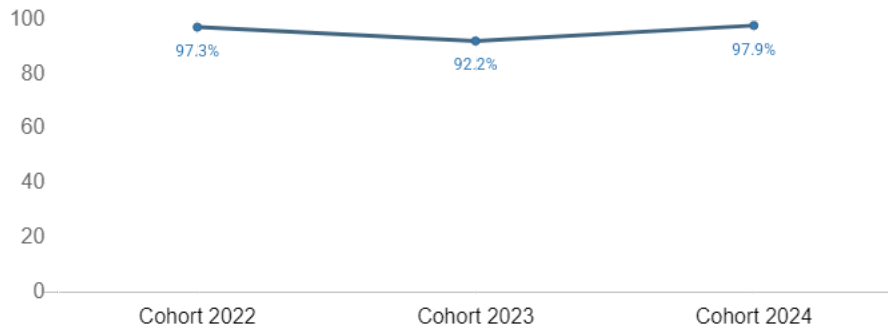

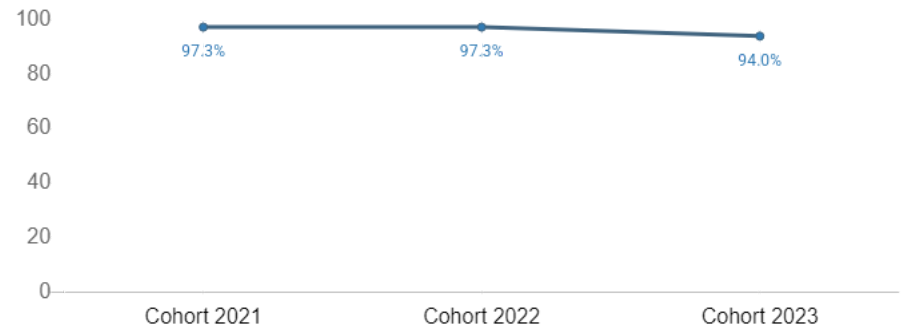

Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have meet state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. The Federal Graduation Rates and Accountability Graduation Rates tables reflect the "federal version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

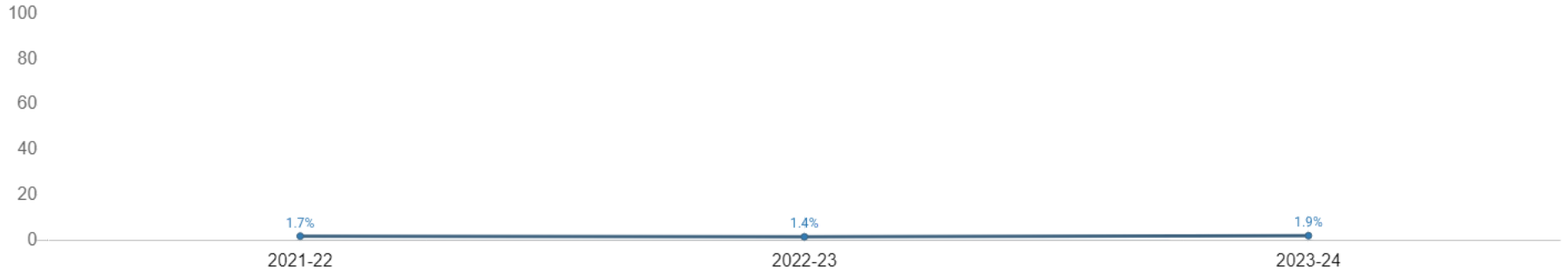

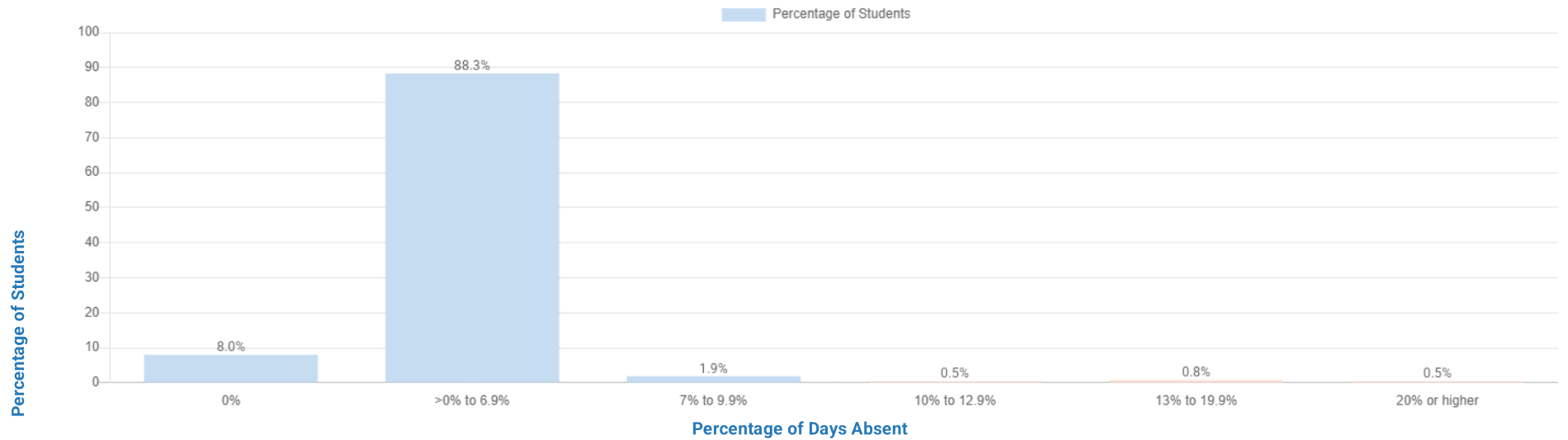

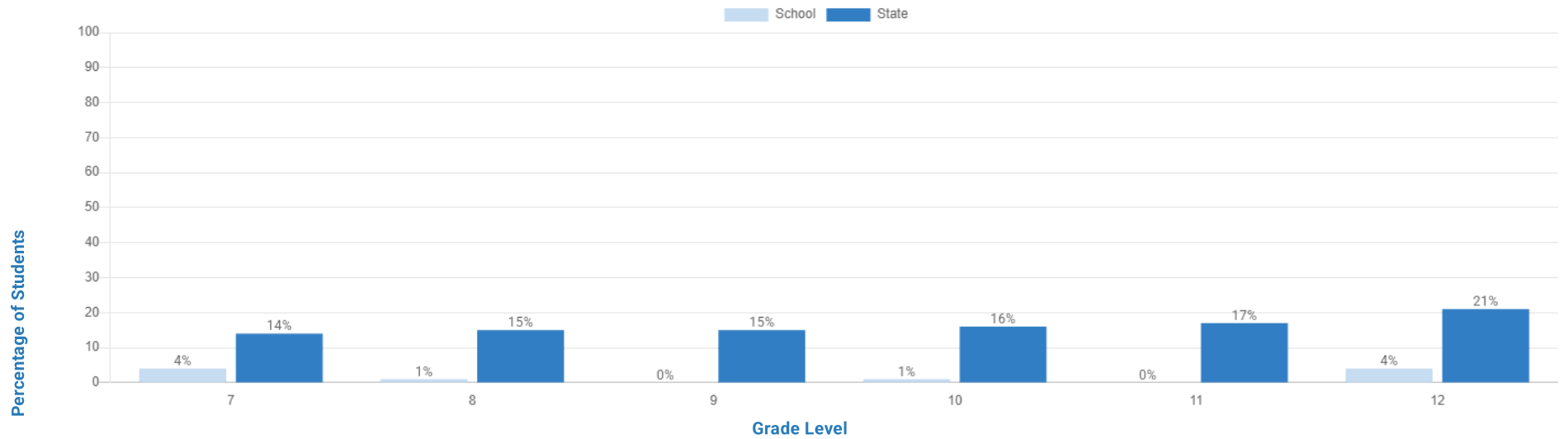

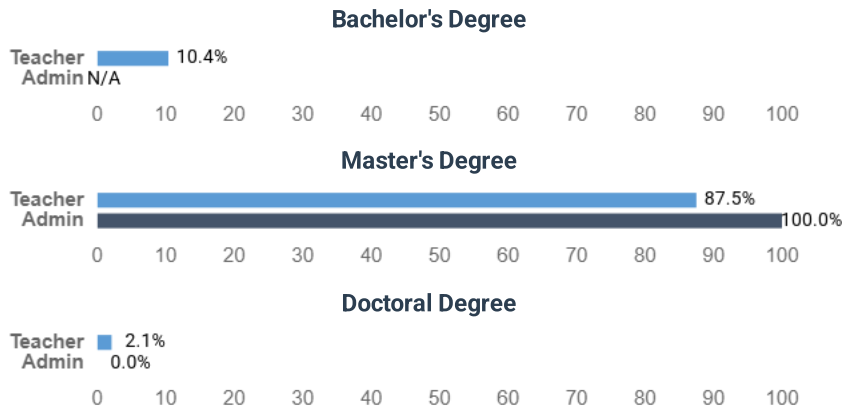

Accountability Summary by Student Group - 2023-24 School Year

Before and After School Programs:

The Midland Park Community School offers the following workshops and clinics for varying grades from Kindergarten through 8th grade: Chef It Up To Go, Basketball Camps, Field & Track Clinic, Tennis, Youth and Middle School Golf, Volleyball for Girls. These workshops and clinics are offered by local outside organizations, teachers and coaches in the community. * Before & After School Child Care is offered to Midland Park students (Kindergarten through 6th grade), from September to June. Students who attend our program enjoy many activities which include arts and crafts, games, outdoor play, and assemblies. Our caring and dedicated staff also assist in homework help. We offer a scholarship to a qualifying Midland Park High School Senior(s) who work for our Before & After School Child Care program. The Community School employs many adults, college and high school students from Midland Park and surrounding towns in these programs.



Staff and Professional Learning:

Faculty and staff work in department and faculty PLC's receiving a variety of professional development from safe schools modules and outside consultants. Designated PD days are approved for staff by administration. The faculty are encouraged to seek other degrees and rewarded with tuition reimbursement and monetary increases in salary, and encouraged to seek professional development on an ongoing basis. School Psychologist speaks about staff wellness. She utilizes her background as a psychologist to educate the staff. Staff was in-serviced on emergency management procedures by utilizing the Share 911, an app on their cell phones.

Student Supports and Services:

Students with disabilities participate in general education, collaborative, resource center or CBI self-contained class. Related services are delivered when mandated in the student's IEP. These include: speech, OT, PT, and counseling. ESL support services are available to those in need of assistance to become English proficient. 504 and I & RS committees meet regularly to address struggling learners to ensure interventions necessary for success in the mainstream environment are provided. Middle school grade level team meetings occur on a weekly basis to address student academic and behavior issues.



Student Health and Wellness:

MPHS received the "Bronze Award" for the Sustainable NJ for School program (June 2008). A school-instituted Wellness Council and Green Team is charged with creating programs to address student and staff physical, social and emotional needs. A "Wellness Month" was created and the school provides homework-free weekends, Sexting Presentations, healthy bake sales, blood drives, Walk & Ride your Bike to School Days, Digitally Distracted Assemblies. We have a comprehensive PE program that includes instruction on childhood obesity and promotes physical activity. The middle school health curriculum incorporates the CASEL Program in their social emotional learning. The new Mental Health Club (THRIVE) and the Diversity Club will provide the students with another outlet.



Parent and Community Involvement:

There are strong partnerships between the school and local parent groups: Athletic Booster Club, PTA, PAPS, SEPAC and MPPEF, which provide grants to teachers and scholarships to students. Annual programs for students sponsored by the PTA include Career Day, Social Emotional Day of Learning, Wellness Month & Cultural Awareness Week. The PTA and high school administration continue to collaborate in organizing the parents of the district in the "Parent Academy". MPPEF has raised money to refurbish the Media Center, Broadcasting room and now the new culinary arts suite which was rolled out this Fall. Parents have access to student records through the PowerSchool Parent Portal.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students. Students in grades 2-12 participate in an anonymous electronic School Climate Survey on an annual basis (14 consecutive years). The survey, through active parental consent, is designed and interpreted by a private consultant. The school uses the results to design and formulate the action plans for the School Climate/Safety Teams. We have seen positive trends in student perceptions of sensitivities to school climate issues.



Facilities:

The high school was built in 1957. A referendum was passed in 2002 to renovate the science labs. In 2014, a second question was approved to install a new roof. A referendum was passed in 2015 to renovate the stadium field, replace the heating system and the auditorium was renovated. In 2016 MPPEF provided grant money to renovate the media center. In 2017 the barn was renovated to create more instructional space at the school by relocating administrative offices. In 2018, four classrooms were created (Room 14, 15, 24, 54B) including a state of the art broadcasting room. In 2019, BCSS with MP administration raised money to create a culinary arts suite (Room 33). In 2021, air conditioning was installed in all the classrooms. New classroom doors, drop ceilings and LED lights were installed in the classrooms. Upgrades in sound (2019) and LED lighting (2023) in the auditorium. New STEM Lab (2022), renovated & reimagined art rooms (2023) and guidance suite (2024).



School Safety:

MPHS installed an emergency notification system, Eastern DataComm, to alert students, staff and local law enforcement on lockdowns, shelter in place, and building evacuations/emergencies. Staff and law enforcement continue to use the Share 911 App to improve communication during emergency situations. The high school is compliant with all fire drills and security drills including code blue and tabletop exercises. District collaborates with local law enforcement and emergency response teams to ensure the District Emergency Management Plan and MOA is reviewed and approved. A new security vestibule was created in the front lobby. When visitors enter the building they are buzzed in through two sets of doors. Visitors must present a valid driver license for security check-in. The reconfiguration of the main office and lobby ensures improved security procedures. Digital emergency notification signs & vape detectors were installed in all the student bathrooms.

Technology and STEM:

MPHS has a 1:1 chromebook technology initiative. Students and Faculty utilize the Google platform (drive, calendar, e-mail, docs, classroom, sheets, forms, etc.). A PC computer lab is utilized for the computer programming classes and the MAC computer lab is utilized for the graphic design classes. The broadcasting classes produce high definition student-based work, which is showcased over the local access channel for the community to view. The robotics class creates and builds robots through engineering design. A STEM lab was created that houses 3D printers, a laser cutter, Cricut machines & a heat press, all which can create tangible objects and be used for rapid prototyping. The STEM lab houses our Innovative Computer Design classes, which combined engineering design with computer science. A \$43,000 grant was awarded to increase student enrollment in AP Computer Science Application class. The grant also specified that there was an increase in female enrollment.



Early Childhood Education:

Midland Park Community School offers a variety of programs for the youth of Midland Park and other communities: * Our "Jr. Panthers Summer Camp" offers Full and Half Day sessions for Kindergarten through 6th grade. Campers enjoy a variety of daily activities including culinary, art, field trips, STEM workshops, pool days, various sports and many more fun events; * Park Players Summer Theater Program is offered to children grades 1 through 6 for 3 weeks during the summer. Students learn about theater production including acting, singing, dancing, lighting and set design. The program concludes with an evening performance for all to enjoy! * February and Spring Break Mini-Camps are offered during the Midland Park school breaks for Kindergarten through 6 grade students. Children's activities include arts and crafts, sports, culinary and much more.

Other Information:

MPHS has a standard 8 period day with a 0 period in the morning for Band and Broadcasting. The middle school schedule has a built in block schedule which is used at teacher's discretion. Seniors can leave early for work study programs through the Option 2 program. Students in grades 7 - 12 are issued chromebooks that are incorporated in daily instruction. The teachers utilize the Google platform for e-mailing students, sharing documents, posting in the classroom, shared calendars, etc. Students have access to Naviance for college planning and PowerSchool to view grades and attendance. The school utilizes robo-calls to inform students of school closing or early dismissals. Information is also disseminated through e-blasts, principal newsletter, front digital sign and social media feeds, such as Twitter & Instagram. The school provides parent informational nights: HIB Community Presentation, 7, 9, 12 grade orientations & a financial aid night. The Wellness Council, Green Team, SciP & School Climate Safety Team are standing committees that look to create a safe and friendly environment for the students.
