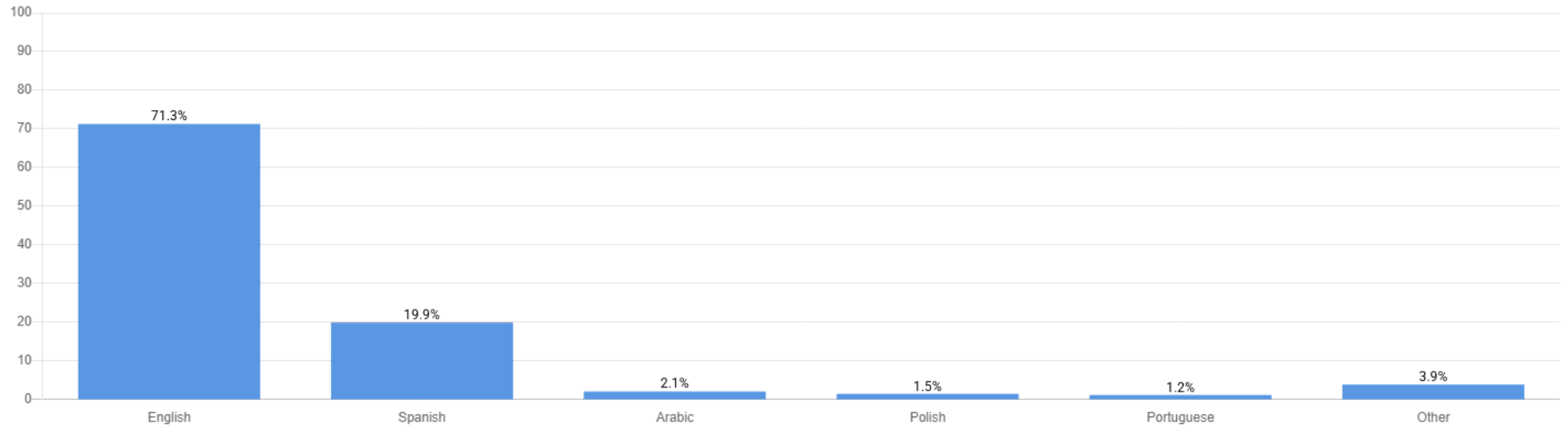

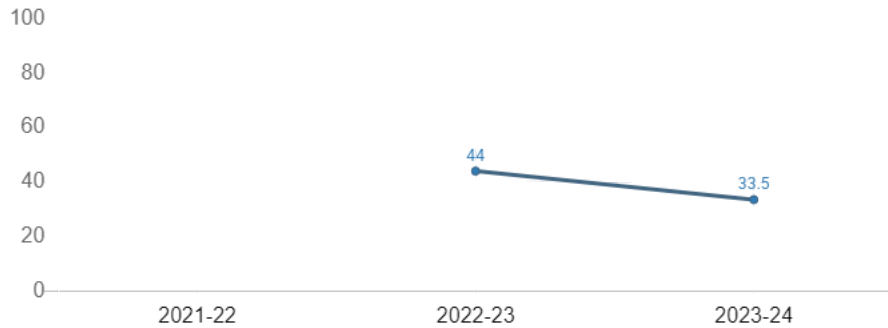

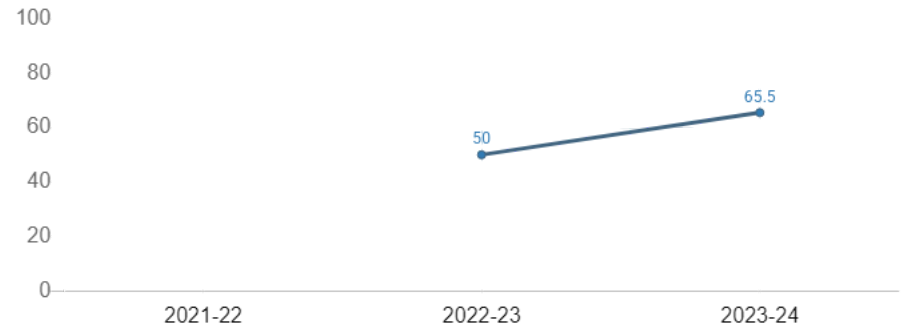

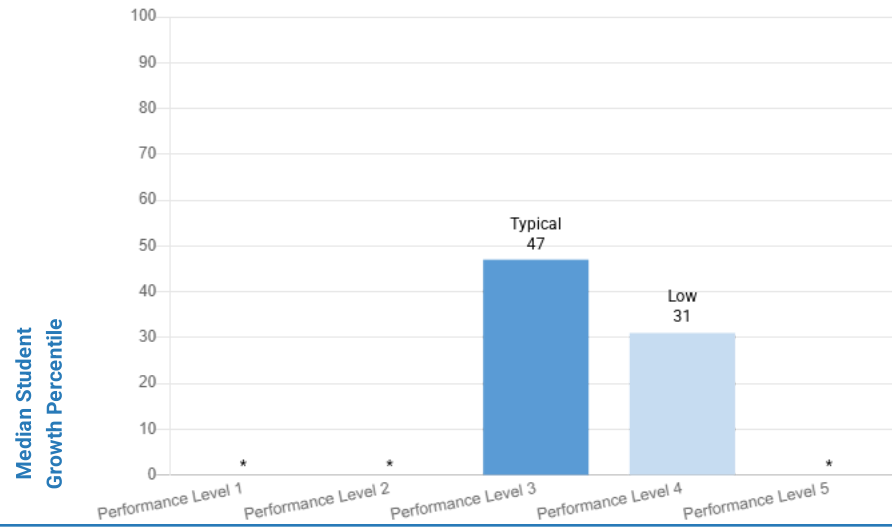

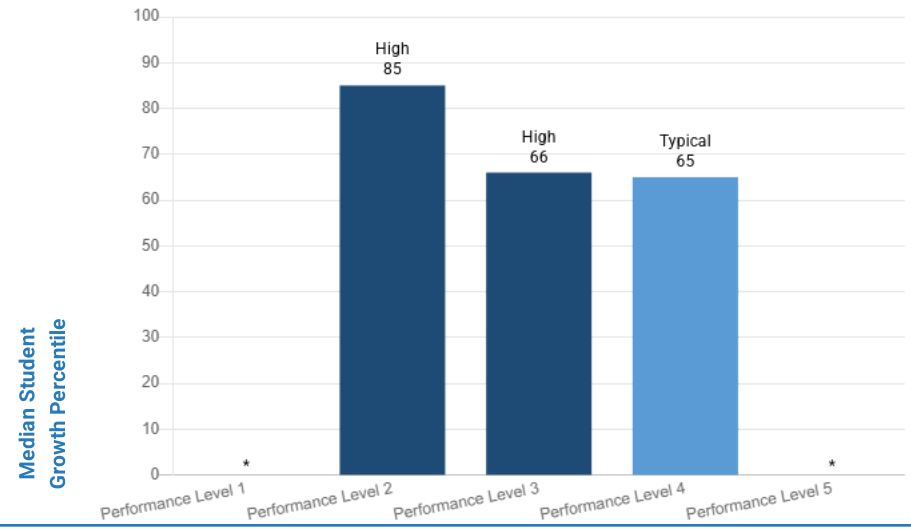

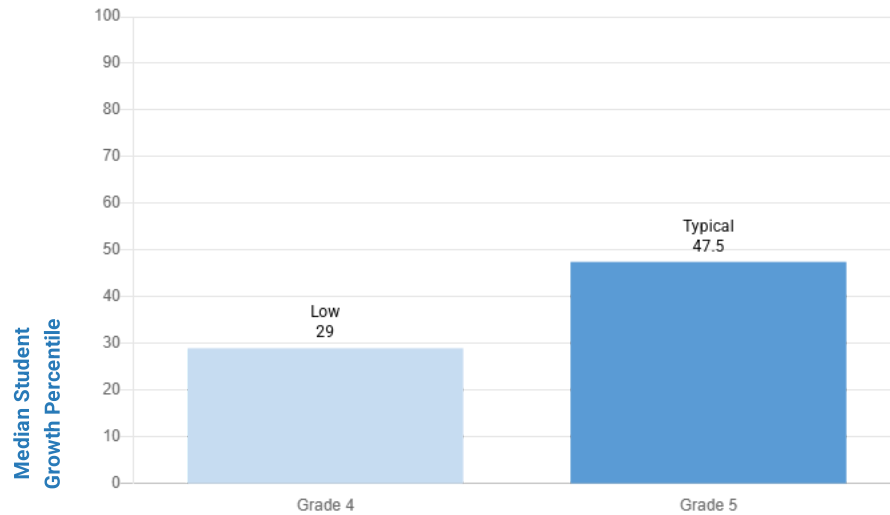

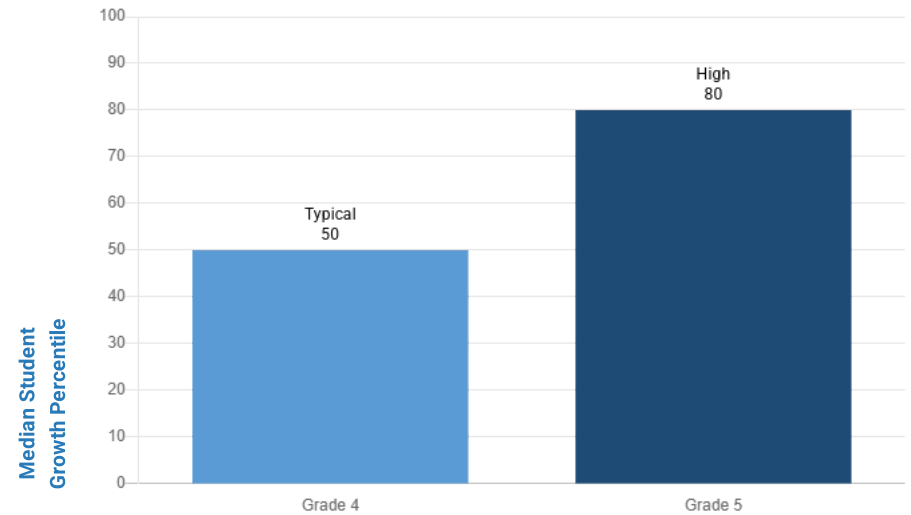

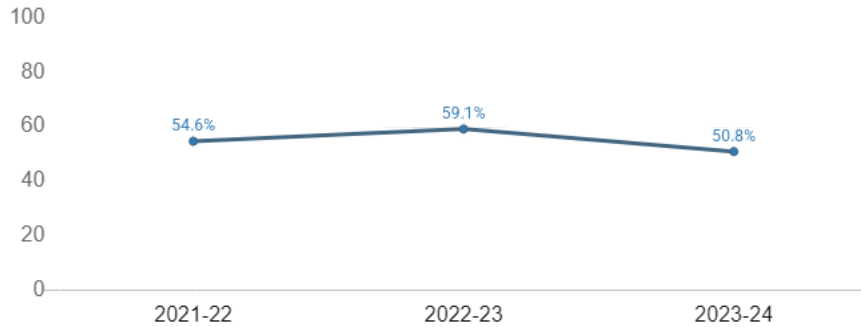

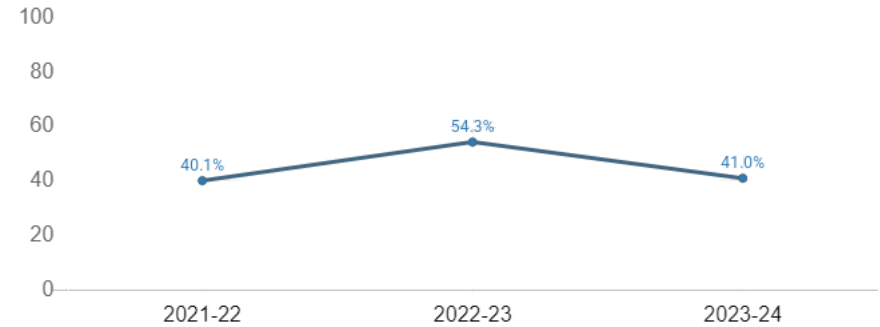
English Language Arts and Mathematics Performance Trends

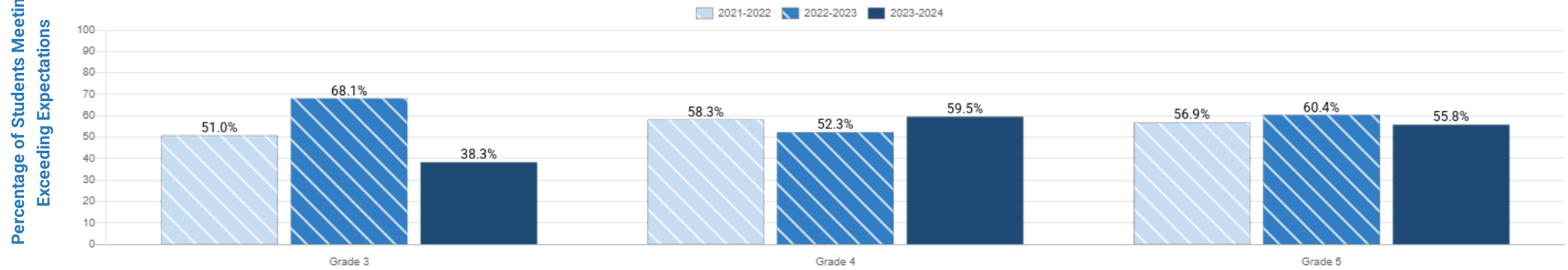

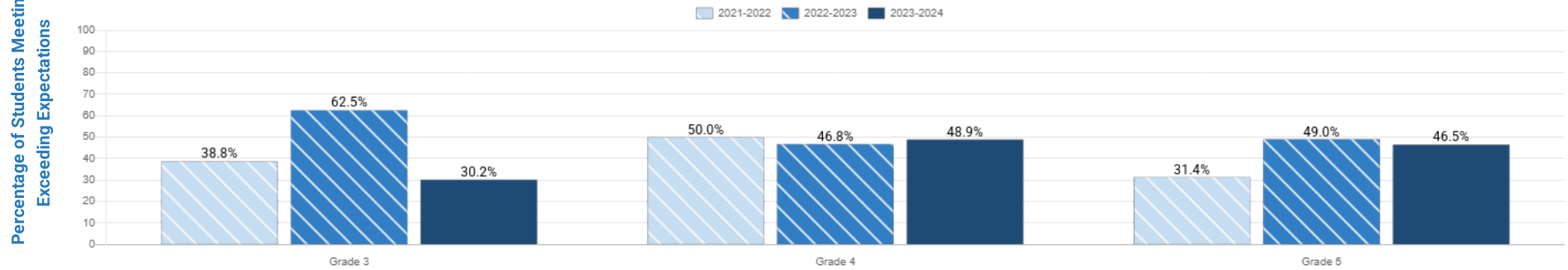

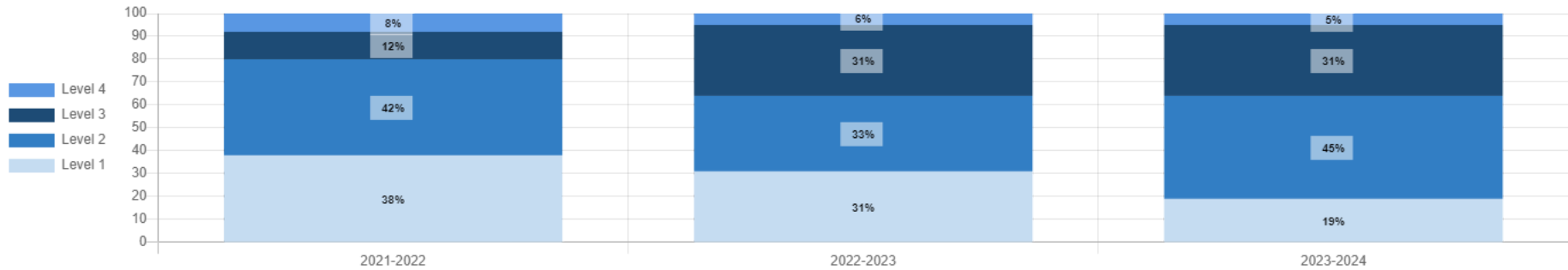

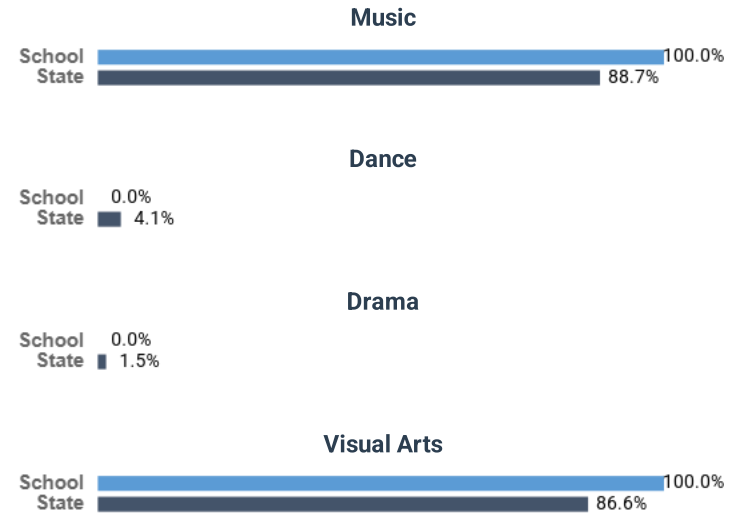

Students enrolled in one or more classes by discipline:



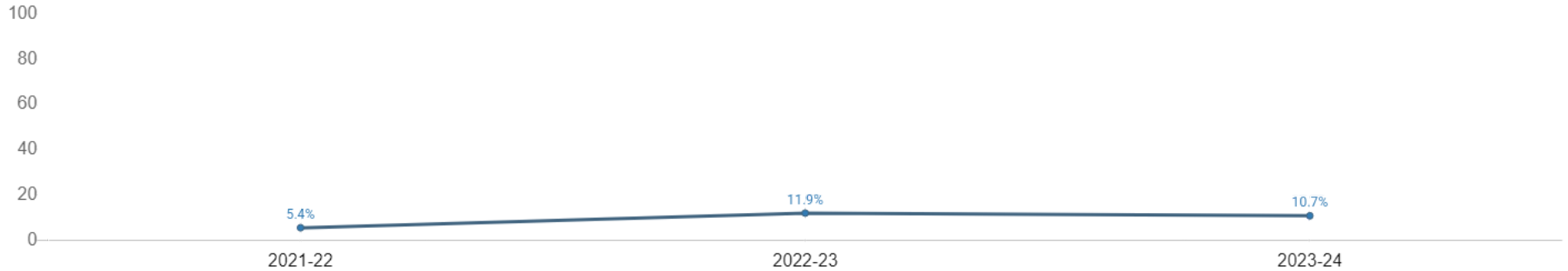

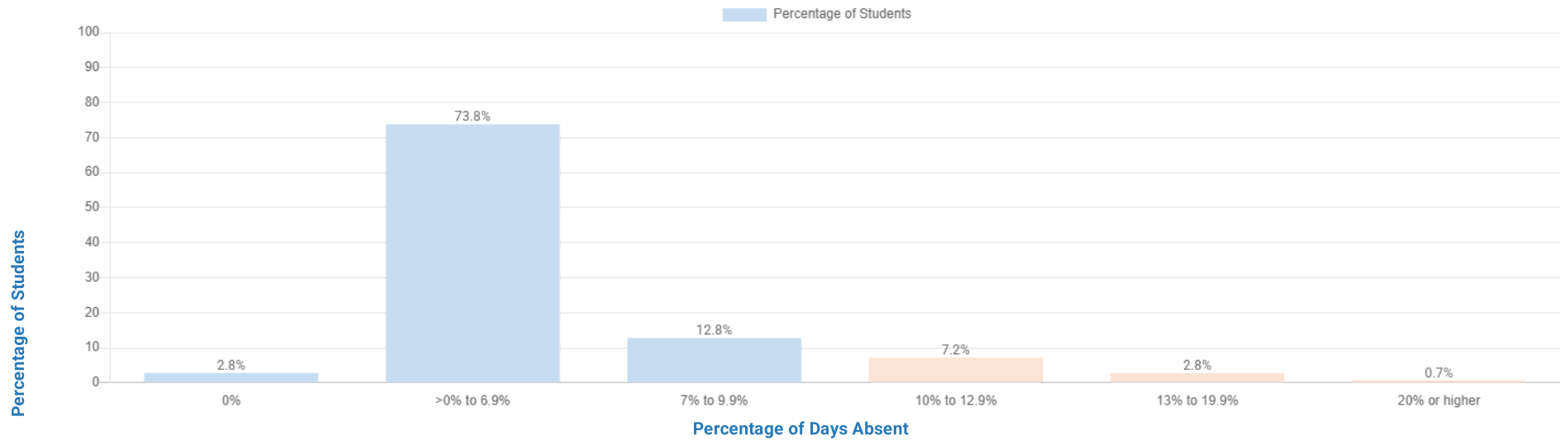

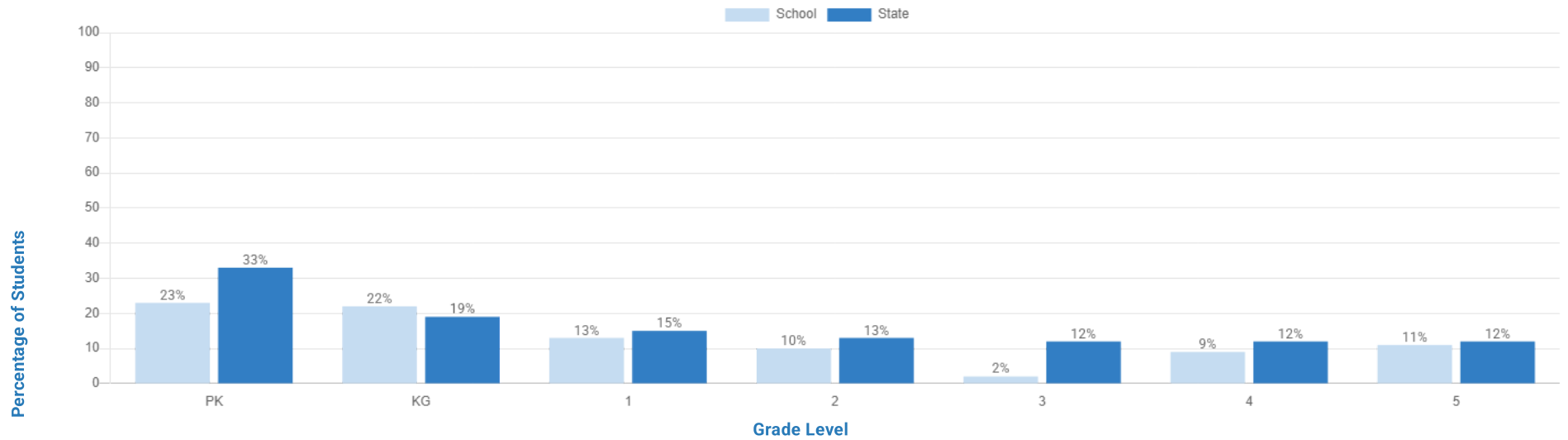

Staff

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 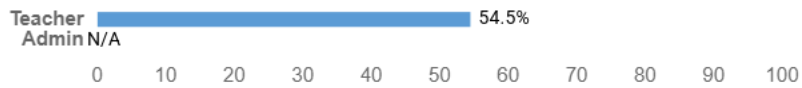

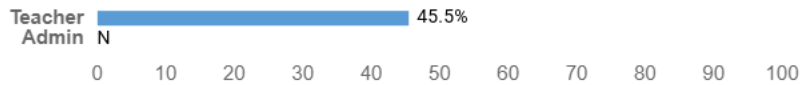

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Our curriculum is aligned to all mandated standards and statutes; it includes modifications for every type of learner. We utilize the Science of Reading as well as a wealth of fiction and non-fiction literature that reflects the diversity of our community. Our special education programming, data-driven pedagogy, and continuous evaluation of curricula foster the growth of all students, while informing future initiatives. Students are exposed to various subjects including Spanish, Technology, Physical Education, Health, Mathematics, ELA, Science, Social Studies and VPAs. Students in grades 4 and 5 are departmentalized and invited to play an instrument in Band, all of which prepares them for secondary success.

Many teachers are enrolled in graduate courses to refine their content knowledge and pedagogy.



Student Supports and Services:

Our school offers ESL classes to support ML students and families within the learning community. Our special education teachers provide instruction to students in their least restrictive environments. Our I&RS Committee assists students who are experiencing academic, behavioral, and/or attendance difficulties. Behaviorists work with staff and students to provide targeted interventions. BSI teachers also offer remedial support for struggling students. Our school counselor conducts classroom lessons and supports students and families in need.



Student Health and Wellness:

Health and wellness is promoted throughout our school for students and staff. We set goals for nutrition promotion, nutrition education, physical activity and other school-based activities that promote overall wellness. We encourage healthy eating and exercise to all members of our school community. Students are physically active throughout the day and encouraged to bring healthy snacks and water to school. We are also designated as a Stigma-Free Zone and have been very supportive of mental wellness. A strong focus on Social Emotional Learning (SEL) remains at the forefront district-wide.

Back to School Night welcomes parents to meet administration, including the superintendent, and the classroom teachers. Our PTO is actively involved throughout the year and fully committed to our students. Preschool and Kindergarten Orientation is an opportunity for parents to meet with the future stakeholders of their child's academic career. Parents are invited into the classrooms as "Mystery Readers." We have formed partnerships with community organizations and collaborate on food drives, coat drives and helping others. School Safety:

School Safety drills are conducted monthly. Staff members work with other colleagues of the district as part of the School Safety Team. The team meets regularly to ensure that our staff and students are practicing the most up-to-date and effective practice. A school safety specialist coordinates all safety protocols district-wide.



Technology and STEM:

All classrooms are equipped with Promethean Boards and all staff members have been issued laptops. Technology is infused into all units of our district-wide curriculum, which includes guiding practices for responsible use. Students in all grade levels have Chromebooks. We utilize many programs that support student learning (i.e. LinkIt!, Raz Kids, IXL, SAVVAS).



Early Childhood Education:

The state-funded Preschool Education Aid (PEA) allows our school to provide free, full-day, PK 4 programming to families in our community. Our PEA program adheres to all requirements linked to high-quality early childhood education, as per the NJDOE, and utilizes the Creative Curriculum, which is fully endorsed by the Department of Early Childhood Education (DECE). Our program includes best practices related to inclusion, cultural competence, SEL, early intervention, and early child development. Additionally, Washington Elementary School offers a PSD program as determined by individual IEPs. This program maintains a 3:1 student to teacher ratio and a multi-sensory approach to learning. These factors provide students with a learning environment that offers minimal distractions and allows them to work at their own pace. Furthermore, students are provided with mainstreamed specials and extra-curricular activities. Related service staff is on-hand to provide speech, OT or PT, as needed.

The North Arlington Public School District has utilized ESSER funds to address various aspects of student achievement, mental health support & building operations. To address the learning loss of specific students, the district utilizes multiple measures of qualitative & quantitative data. All data is broken down by subgroup & applied directly to programmatic recommendations for in-class supports & programs beyond the school day, such as Extended Instructional Support (EIS). EIS is a before & after school program for students who are at risk of not acquiring NJSL-based skills; it takes place from the fall to spring. To provide additional social & emotional support for students, we expanded services & behaviorists to facilitate interventions, positive behavior supports, & other resources in accordance with the NJTSS goal "to improve student achievement."
