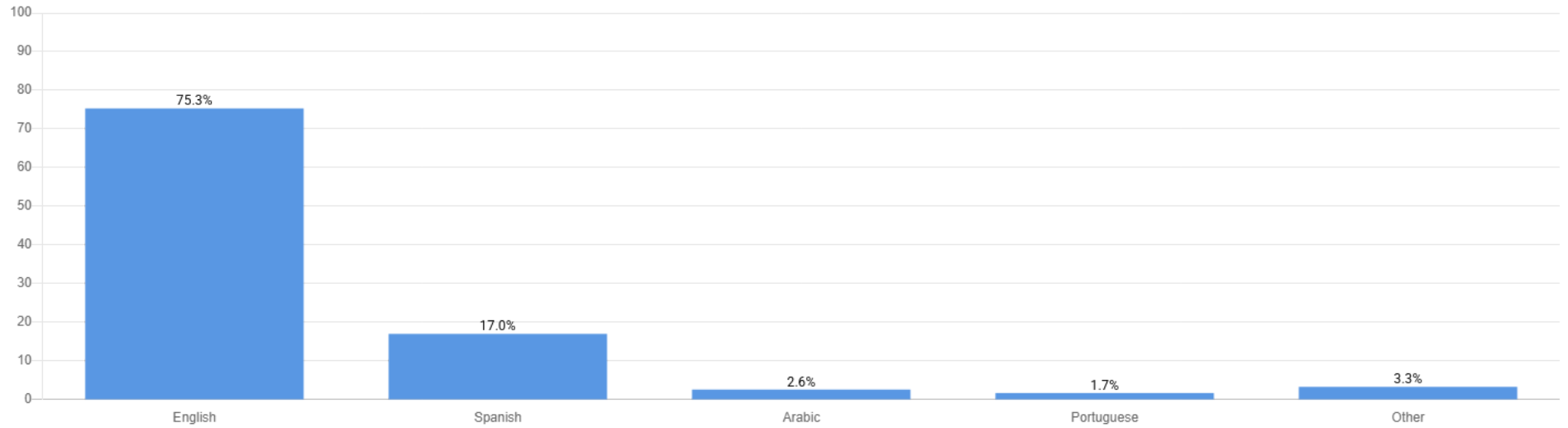

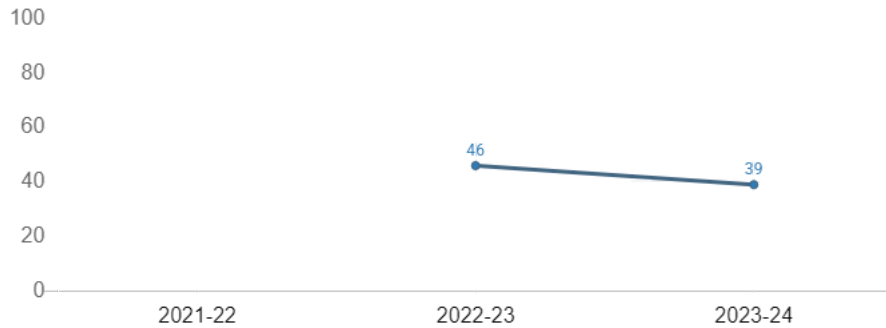

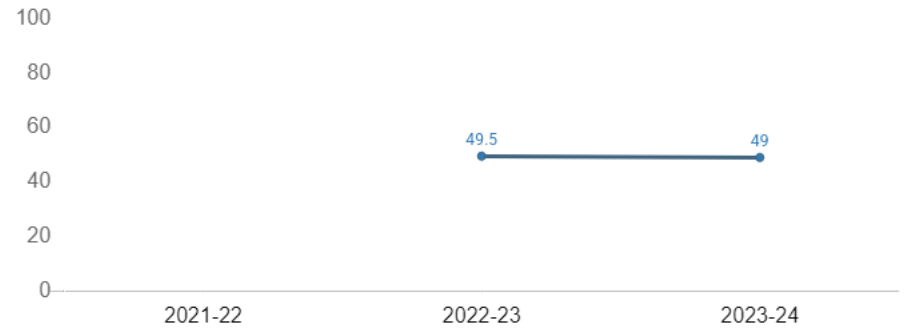

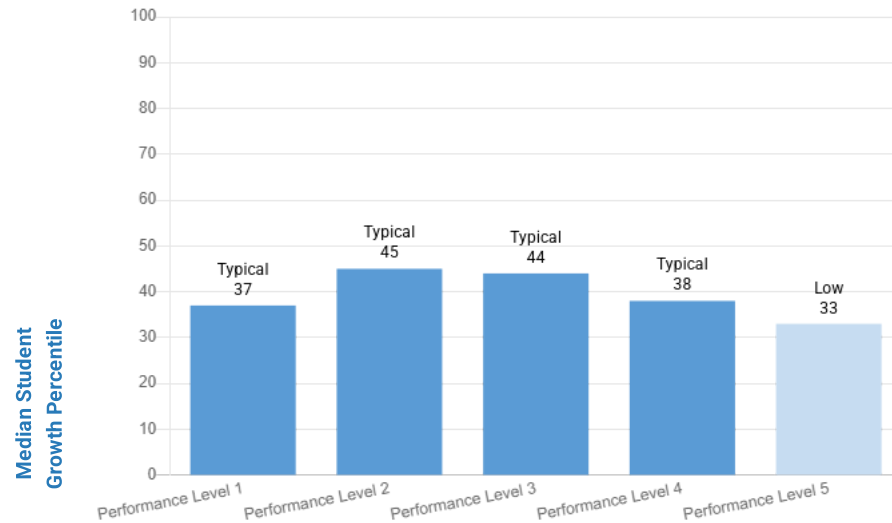

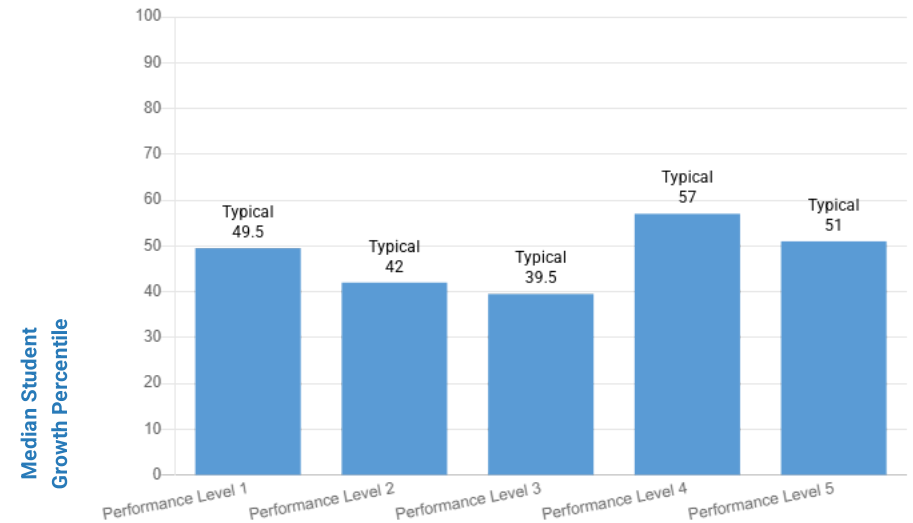

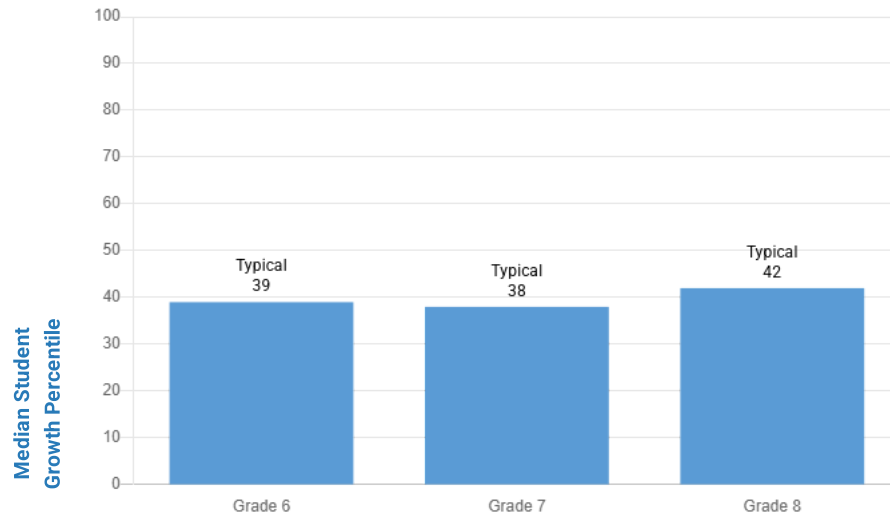

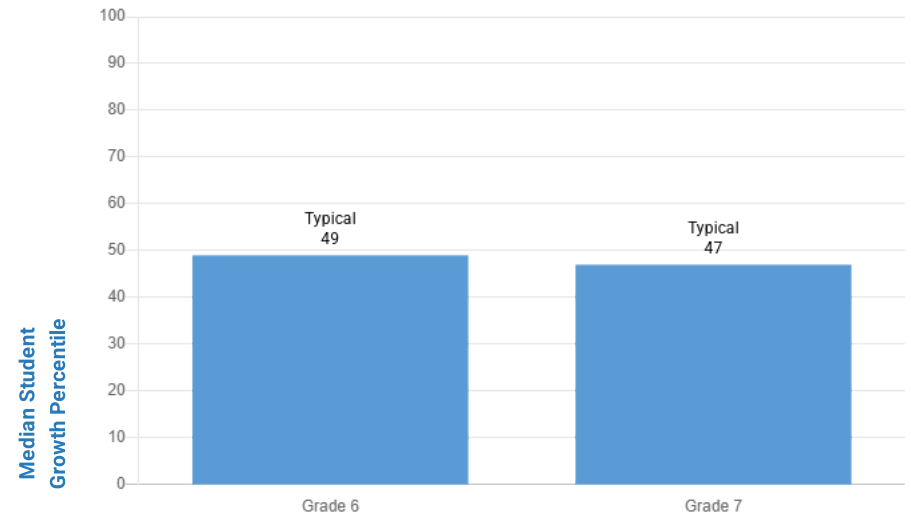

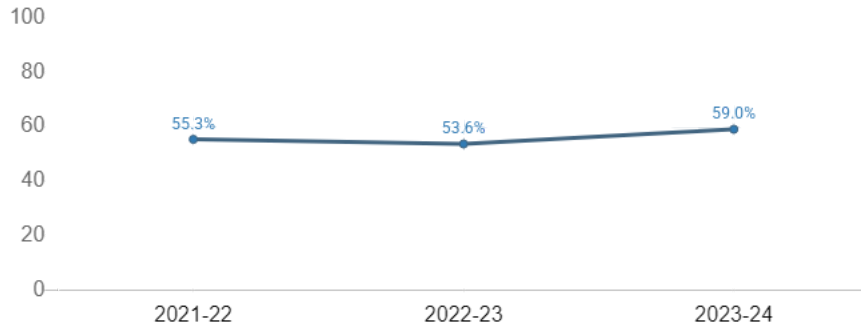

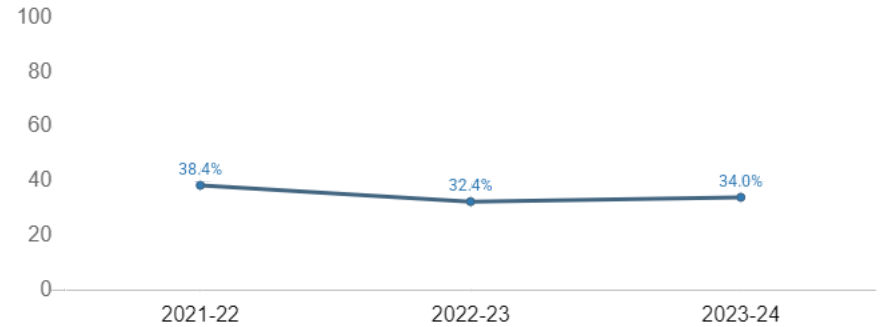
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 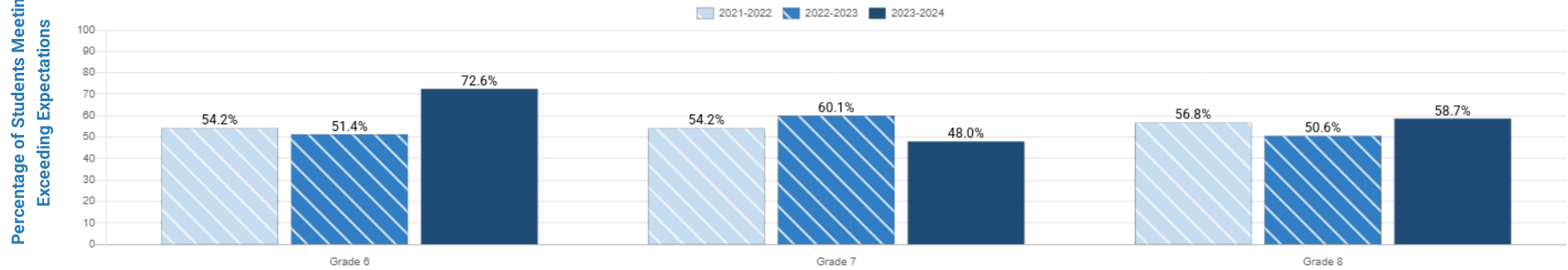

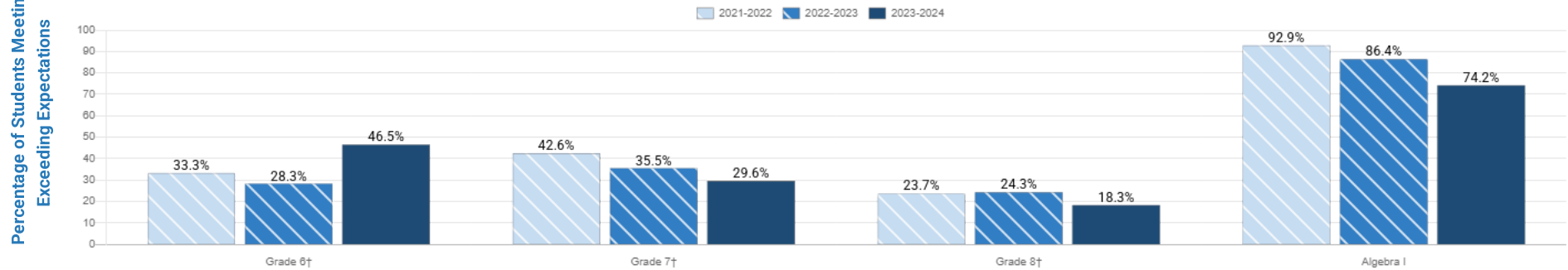

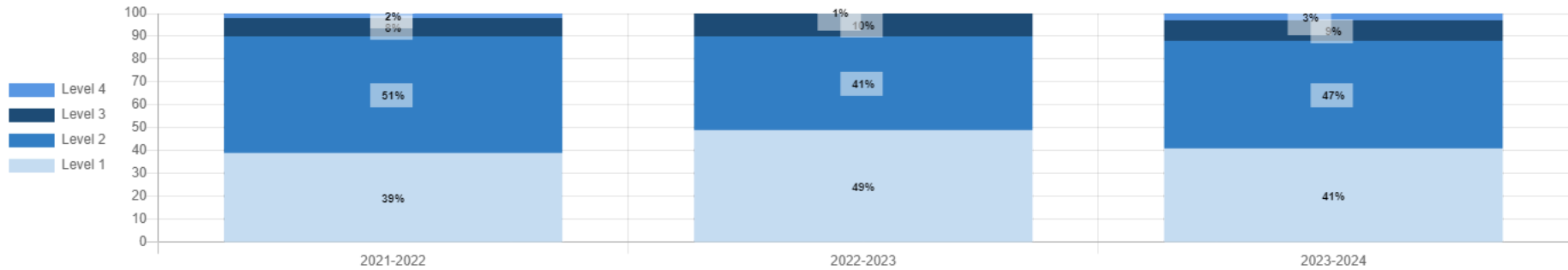

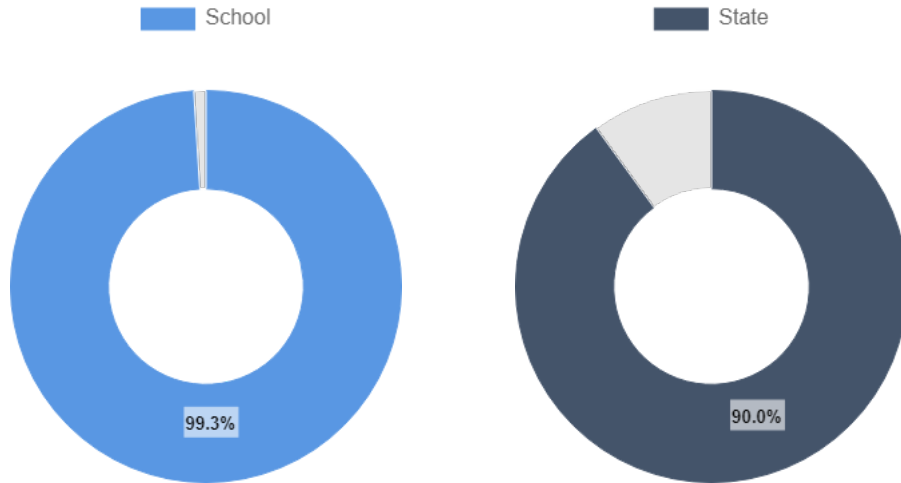

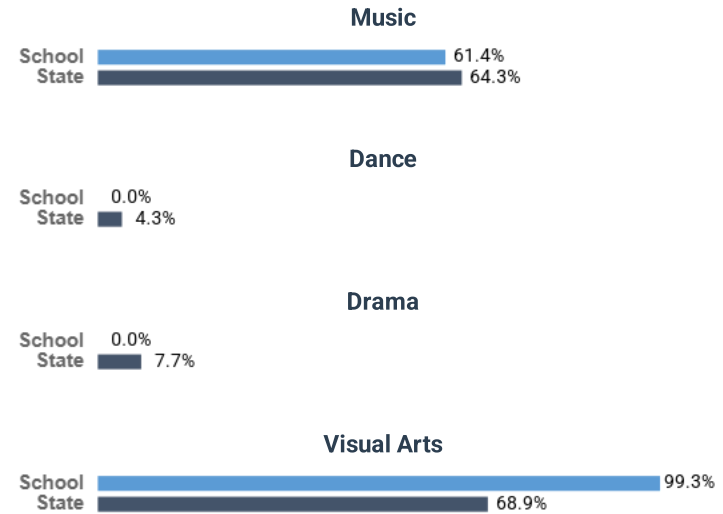

Students enrolled in one or more classes by discipline:



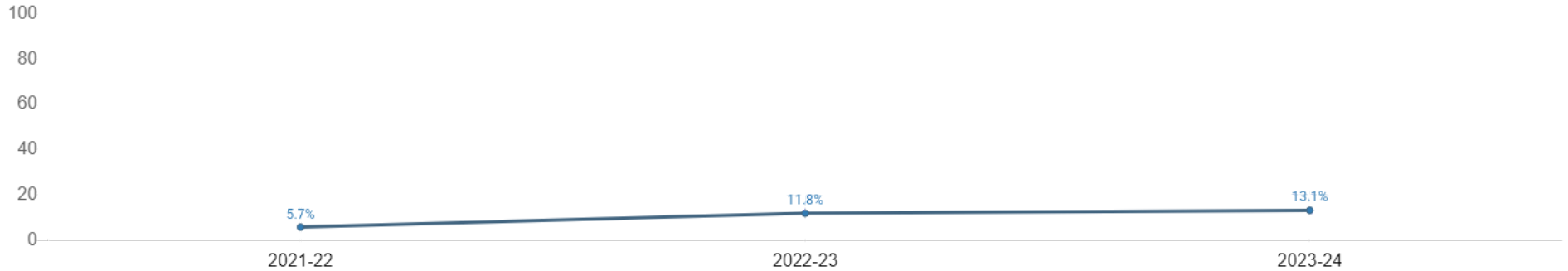

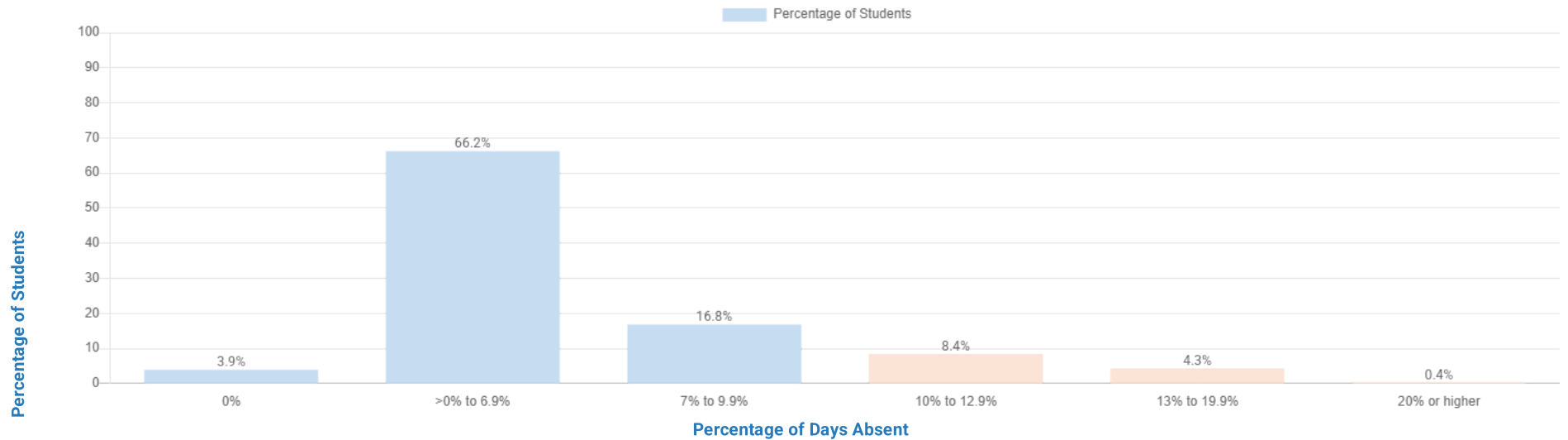

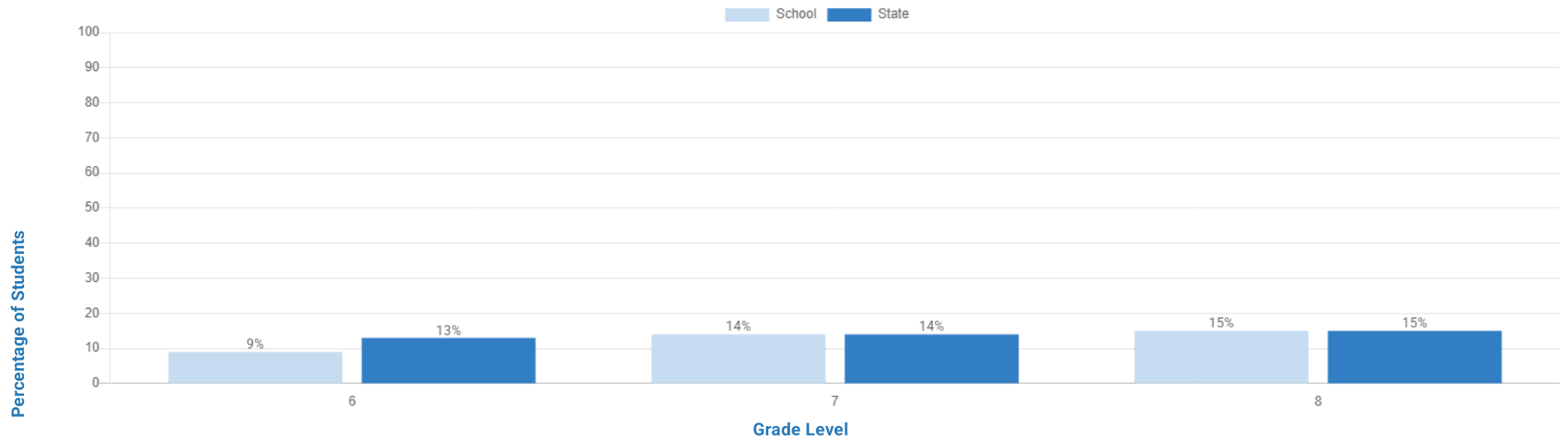

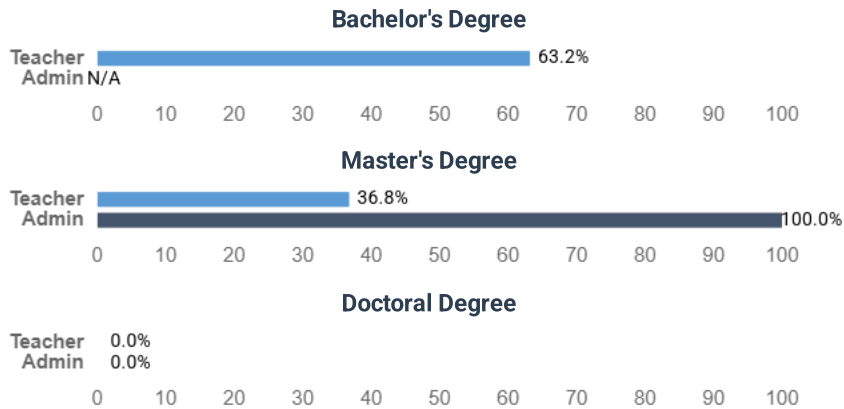

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Courses, Curriculum, Instruction:

Through differentiated instruction, we are able to meet the academic needs of every learner. Our comprehensive curriculum is aligned to all mandates standards and statutes, with modifications embedded in every guide. We proudly offer advanced courses and unified classes to meet a wide spectrum of academic needs. Students are exposed to various subjects including Spanish, Technology, Physical Education, Health, Mathematics, ELA, Science, Social Studies and VPAs. Our young entrepreneur program provides early career pathways for students in grades 6-8 as we prepare students for secondary and post-secondary success.

Before and After School Programs:

Mandatory extra help is scheduled in coordination with the guidance department and classroom teachers. We also have a homework room for students after the extra help period ends. Students are supported during the allocated time slots to address areas of focus to ensure students success. Additionally, students identified as "at-risk" will have an opportunity to take part in morning and afternoon Extended Instructional Support (EIS).



Staff and Professional Learning:

Teachers are encouraged to pursue professional development opportunities and receive district support. School-wide professional learning communities meet weekly to deepen their understanding of topics such as applying student achievement data, sharing best practices, differentiating instruction, and applying NJSLs. As a school, we encourage and support our staff to seek professional development given by the district and/or outside educational organizations.



Postsecondary Information:

VMS offers HS Algebra 1 to our Advanced Grade 8 population. This course puts students on track as they enter high school as part of their eligibility for the Early College Program. Student Supports and Services:

Communication is the key to meeting the needs of our students. Constant communication occurs between the Child Study Team, ML Department and the I&RS committee. Support plans for students are reviewed on a regular basis and adjustments are made on an as needed basis. Accommodations for MLs, special education, at-risk students, and gifted and talented are built into the curriculum.



Student Health and Wellness:

Our physical education program consists of dynamic warm ups followed by units of instruction. These units include skills and game play. The students also participate in many cardiovascular activities including the pacer test, Play 60, Hoops for Heart and field day. In health class, students are exposed to age-appropriate topics for nutrition, drug and alcohol awareness and human sexuality. VMS is also designated as a Stigma-Free Zone and we have been very supportive of mental wellness. The VMS Guidance Department works closely with our CST department and administration to conduct classroom lessons regarding mental health and wellness, kindness and self-care. A strong focus on Social Emotional Learning (SEL) remains at the forefront district-wide.



Parent and Community Involvement:

Veterans Middle School is fortunate to have a strong partnership with the PTO. They provide a variety of programs for our students and volunteer their time throughout the school year. The partnership between our school and families is an essential part of every child's successful middle school experience. Parents are also encouraged to become involved with the district-level SEPAC to discuss issues related to special education. We have formed partnerships with various organizations and collaborate to run food drives, coat drives and other functions for the betterment of our community. Technology and STEM:

All classrooms are equipped with Promethean Boards and all staff members have been issued laptops. Technology is infused into all units of our district-wide curriculum, which includes guiding practices for responsible use. Teachers have incorporated the Google Suite to enhance day-to-day instruction. Every student has been issued a Chromebook and has access to additional technology resources including VR Headsets, 3D Printers, and STEM work stations.



Attendance:

The North Arlington Public School District has strategically utilized remaining ESSER funds to enhance student achievement, mental health support, and building operations. To address specific student learning loss, the district employs multiple measures of qualitative and quantitative data, disaggregated by subgroup, to inform programmatic recommendations for in-class supports and extended learning opportunities, such as Extended Instructional Support (EIS). EIS, offered before and after school from fall to spring, serves students at risk of not meeting NJSL-based skills. To further support students' social and emotional well-being, we have expanded services and behaviorists who deliver interventions, positive behavior supports, and other resources in alignment with the NJTSS goal to "improve student achievement."
