




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 






Students enrolled in one or more AP or IB course









Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.









- Northern Highlands is committed to fostering a supportive, vibrant community that enriches the lives of our students who come from Allendale, Upper Saddle River, Ho-Ho-Kus, and Saddle River.
- Through our Career and Academic Pathways program, we offer a variety of programs including courses for advancement and enrichment, senior internships, community service, and work-based learning.
- Our athletic and co-curricular programs offer students (93%) the chance to explore their interests, build character, and develop teamwork skills, all within a nurturing and inclusive environment.



Our mission at Northern Highlands is to forge strong, positive connections and provide a safe haven where everyone is valued and respected. We will promote intellectual, social, and emotional growth while preparing students for a rapidly changing world by instilling critical thinking skills, a global perspective, and a respect for core values.



Students at Northern Highlands Regional High School continue to score above the state and national average on all standardized tests. The class of 2024 averaged well-above their peers on the Scholastic Aptitude Test (SAT) at both the state and national level. Of the 318 graduates in the class of 2024, 97% (309 students) are attending college. More specifically, 95% (301 students) are attending four-year institutions and 2% (8 students) are attending two-year institutions. In May of 2024, 497 students sat for 1,181 AP exams in 31 subject areas. Northern Highlands students continue to achieve outstanding scores. Of the 1,181 AP exams that were given, 91% (1,080) of the students who sat for a multitude of exams earned a score of three (3) or better. 108 students were named as AP Scholars. Of the Class of 2024, there were 17 National Merit Commended students and one National Merit Semi-Finalist.

Northern Highlands provides a rich array of challenging courses tailored to meet the needs of all students. Our dual enrollment programs allow students to earn college credits through partnerships with Syracuse University, Rutgers University, Ramapo College, Bergen Community College, and Seton Hall University. In addition to 29 Advanced Placement courses, we offer 40 honors-level courses across subjects, promoting advanced learning and preparation for college and beyond. As a 1:1 district, each student uses a laptop to access digital texts and resources through our learning management system, creating a seamless and modern learning environment. Our curriculum exceeds state mandates, incorporating diverse texts and mentor works that reflect a variety of perspectives and experiences. Students can pursue a range of electives across disciplines, encouraging them to explore interests deeply, build critical skills, and broaden their horizons to prepare for future academic and career pathways

Northern Highlands offers a wide range of interscholastic sports. Our highly competitive athletic program offers 14 sports for boys and 16 sports for girls. Our programs offer competition at the Varsity, Junior Varsity & Freshman levels and span all three seasons; Fall, Winter, & Spring. The campus & athletic facilities are among the finest you will come across and includes, but is not limited to: multi-sport turf stadium field, six lane all weather track, multiple grass fields for multi-sport use, two baseball fields, two softball fields, seven tennis courts, two varsity locker rooms for boys & girls, two full size gymnasiums & an auxiliary gym, a weight training facility, as well as a state of the art stadium scoreboard. A member of the Big North Conference, Northern Highlands Athletics prides itself on competing with good sportsmanship & upholding all of the positive values sport represents.

Northern Highlands has over 60 clubs/activities offered to students. The full slate of offerings can be found on the Northern Highlands Regional High School website. Staff and Professional Learning:

Teachers at Northern Highlands engage in meaningful professional learning, fulfilling the state-mandated 20 hours annually. Our district's commitment to continuous growth is led by a Professional Learning Committee, which includes representatives from various departments, instructional coaches, and administrators. Beyond state requirements, professional development is closely aligned with district goals and individual teacher aspirations. Through the PD Pathways initiative, teachers explore pathways in diversity, equity, and inclusion; supporting diverse learners; and fostering connectedness. This approach empowers staff to set and meet goals aligned with their personal interests and instructional needs. The Professional Learning Committee gathers and analyzes feedback regularly, ensuring future sessions are responsive to educators' evolving needs. In this way, we create a culture of intentional professional growth that directly benefits student engagement and learning outcomes.



Postsecondary Information:

Northern Highlands is committed to helping all students achieve their post-secondary goals. 95% of the student body was accepted to and plans to attend a four year college or university. Approximately 2% are planning on attending a two-year college and approximately 3% are attending either the military or pursuing the workforce. Northern Highlands provides multiple opportunities over the course of the school year for students to take the ACT and SAT on campus. We also offer the PSAT and PreACT to sophomore and junior students preparing to take the SAT and/or ACT. Information nights are hosted annually by the school counseling department to provide students and parents valuable insight into college standardized testing, post-secondary planning and financial aid. This Fall, Northern Highlands hosted its second college fair with over 100 college and university representatives. Northern Highlands also utilizes Scoir, a college and career readiness platform to assist students/parents



Student Supports and Services:

Northern Highlands has multiple resources available for struggling learners. The National Honor Society provides peer tutoring for students in need of academic support. Teachers are available both before school and after school to assist students. The I&RS process is a valuable resource to teachers and students that need additional support and intervention. The I&RS team meets bi-weekly to discuss students of concern, create action plans, monitor progress and data and make appropriate referrals. Learning Lab placement in English and Mathematics provides additional content support to students. Our ELS program is designed to support and teach students who speak languages other than English how to understand, speak, read, and write in English while learning about American culture. The Special Services Department provides consultation, counseling, and academic support programs to special education students.

We have over 15 counselors who support students through individual and small-group counseling services. Support is provided through academic and social-emotional counseling, classroom connections, full-school assemblies, and targeted mental health interventions. We also partner with Care Solace, so families have access to mental healthcare outside of traditional school hours. Our Mindfulness room is open to students for quiet reflection during lunch. Students can drop in and get support in our wellness center or school counseling office suite throughout the day. After school, our GSA, S.A.D.D, Active Minds, and Yoga clubs continue to support student mental health and overall wellness. Our award-winning cafeteria is open throughout the day and after school. At Northern Highlands, we offer programs to meet the health & wellness needs of our students including a comprehensive physical education program, after-school fitness center accessibility, and a variety of athletic programs.



Parent and Community Involvement:

The goal of all parent organizations connected to Northern Highlands is to serve the entire school community by fostering strong relationships and maintaining open communication with administration, staff, and parents. This collaboration aims to enhance the excellence of the school's educational and co-curricular programs, uphold the vision, mission, and guiding principles of the school, ensure the well-being of the students, and support school-sponsored activities. The Home and School Association (HASA) conducts monthly meetings and has played a significant role in funding numerous initiatives at the high school. Each September, HASA organizes a welcome-back breakfast for the parents of incoming ninth graders, along with a holiday raffle in December. Additionally, the Music Performing Arts Association (MPAA) is a parent group dedicated to supporting the instrumental, vocal, and drama programs at our school. Facilities:

Northern Highlands, built in 1965, originally featured a library, auditorium, 2 gyms, a planetarium, and 2 cafeterias. In 1974, renovations added a Guidance Office, woodshops, CAD labs, a weight room, and a back gym. The science building with A/C and the senior cafe were built in 2004. A new roof was added in 2014, and a security vestibule in 2018. Athletic upgrades include 7 new tennis courts, a turf field, a track, and a scoreboard installed in 2022. In 2023, a ticket booth, gated turf field entrance, curbs, sidewalks, bus drop-off areas, and updates to the band room were completed. The Field House, Reflection Garden, and major 2024 renovations included the Media Center, Art rooms, TV studio, AI, CAP classrooms, and offices. A new planetarium projector was also installed.



School Safety:

We provide a robust security program to ensure the safety of all including: behavioral threat assessment training for staff, electric locks on all exterior doors, electronic door sensors to detect when exterior doors are propped open, a visitor security vestibule, a visitor management system to issue visitor passes & track guests to the school, labeling of all doors, stairwells, classrooms & offices from the interior & exterior, over 120 cameras, one point of access during school hours, medical kits & bleeding control stations, the ability for any staff member to call a lockdown, classroom doors that lock from the interior, automatic lockdown announcements, strobe lights, panic buttons for staff in distress, electronic applications to communicate and provide maps to law enforcement. We employ a SLEO Class 3 Officer and drill monthly. Our Wellness Dept. pushes into Health classes to teach lessons on Acknowledge Care Tell (ACT) and have conducted extensive school climate surveys.



Technology and STEM:

Technology is regularly used in the classroom to introduce and enhance the curriculum and assess student learning. Technology integration ranges from the use of our learning management system and note-taking programs such as Canvas and OneNote to using science simulations, math manipulatives, and virtual/physical field trips to differentiate and enhance instruction. NH offers various STEM electives including Real World Engineering, CAD, Woodshop, Interior Architecture, Robotics, Introduction to Computer Science, JAVA, statistics, Sports Medicine, and Forensics. We also have diverse AP offerings including AP Computer Science Principles/A, AP Statistics, AP Calculus, AP Biology, AP Chemistry, AP Environmental Science, and AP Physics 1 and C. We also offer dual enrollment with Seton Hall, NJIT, Rutgers, and Syracuse University for courses including but not limited to Anatomy and Physiology, Forensics, Multivariable Calculus, and CAD II. Clubs include STEM, Robotics, and Science & Math Lea

Early Childhood Education:

Northern Highlands has an Early Childhood program that is open to 3 and 4-year-olds. The goal of the program is to provide a safe and nurturing environment where our preschoolers can thrive and learn. The program begins in late September and will continue until early June. Classes are held three days/week from 8:45 to 10:45 am. Tuition for the program is \$75 per month and parents are billed semi-annually by the Office of the Board of Education. The program is capped at 15 students. The unique feature of this program is that it ties in directly with our Child Development course that we offer to upperclassmen. This course is designed to meet the needs of students planning to enter a career involving children, fostering better parenting skills, and developing a better understanding of themselves and others. This course includes the study of the theory of child development, as well as a practical application through participation in the Early Learning Center.



Attendance:

Northern Highlands Regional High School prioritizes regular attendance as a cornerstone of student success. In 2023-2024, we launched evidence-based strategies to combat chronic absenteeism, which was 9.3% in 2022-2023. Key initiatives include proactive monitoring of attendance data, early interventions by counselors, teachers, and administrators, and personalized family outreach to address barriers. Flexible support systems, such as wellness check-ins and academic programs, help resolve attendance challenges. Incentive programs celebrate milestones and promote a positive school culture. Through faculty collaboration and targeted initiatives, we strive to ensure all students feel supported and motivated to attend regularly.
