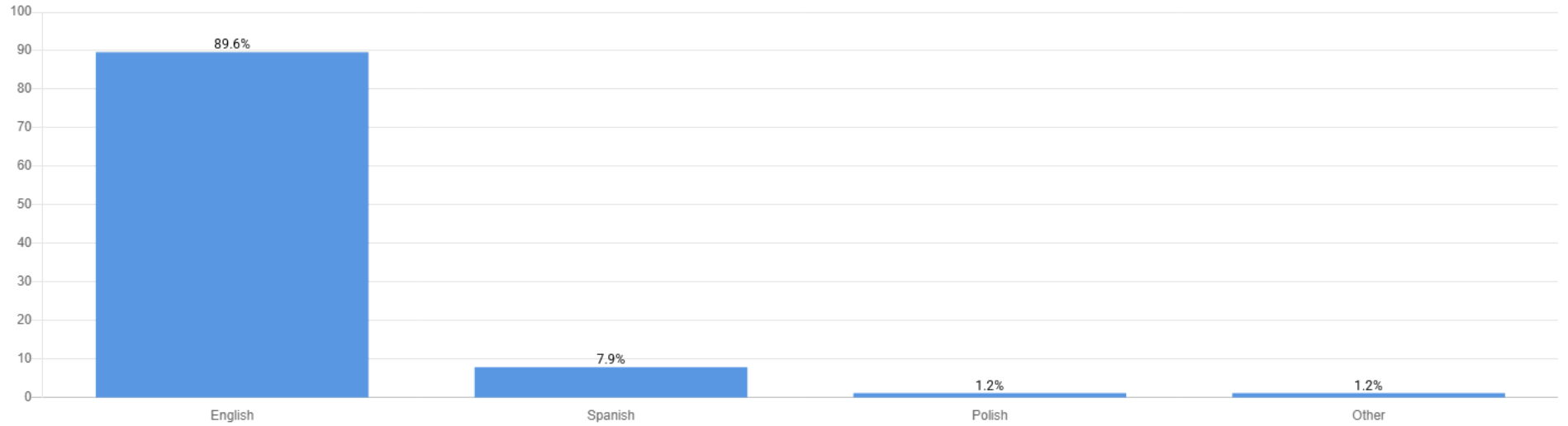

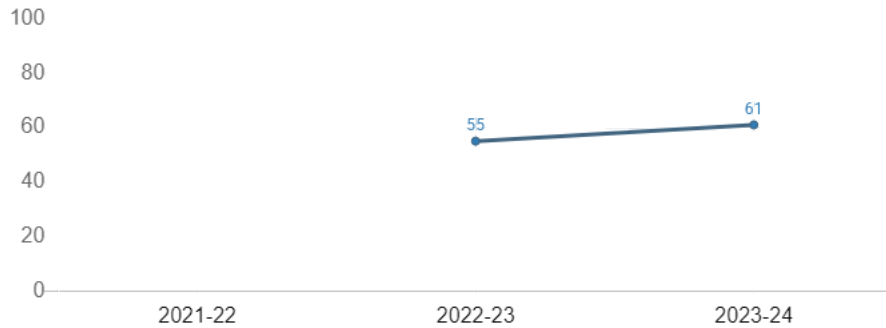

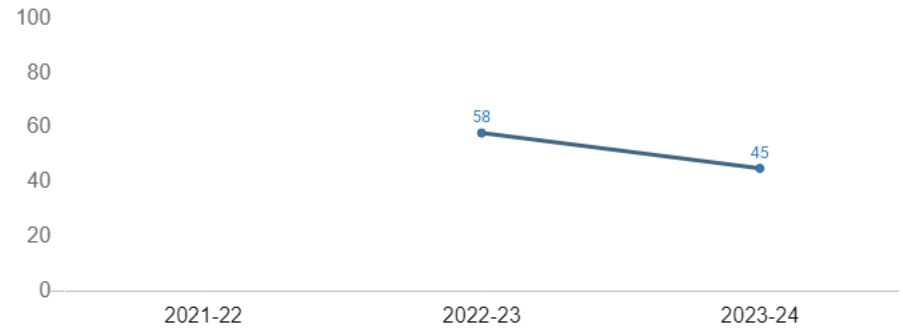

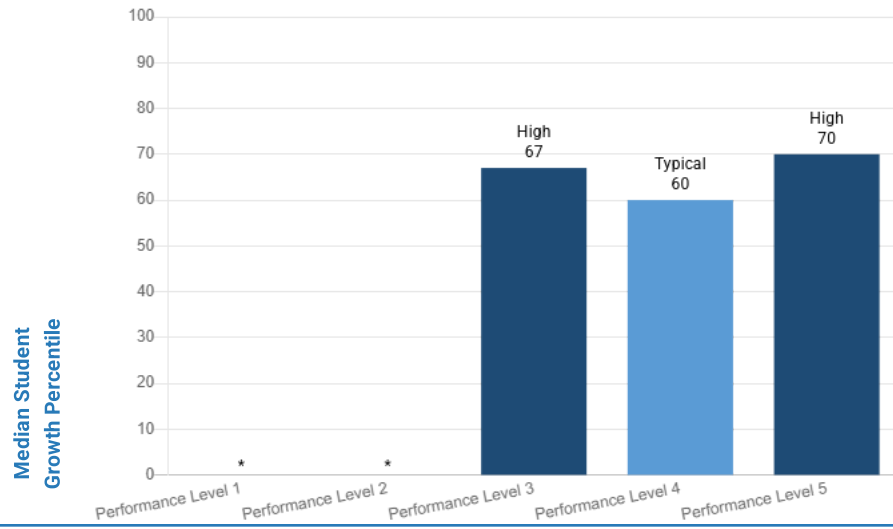

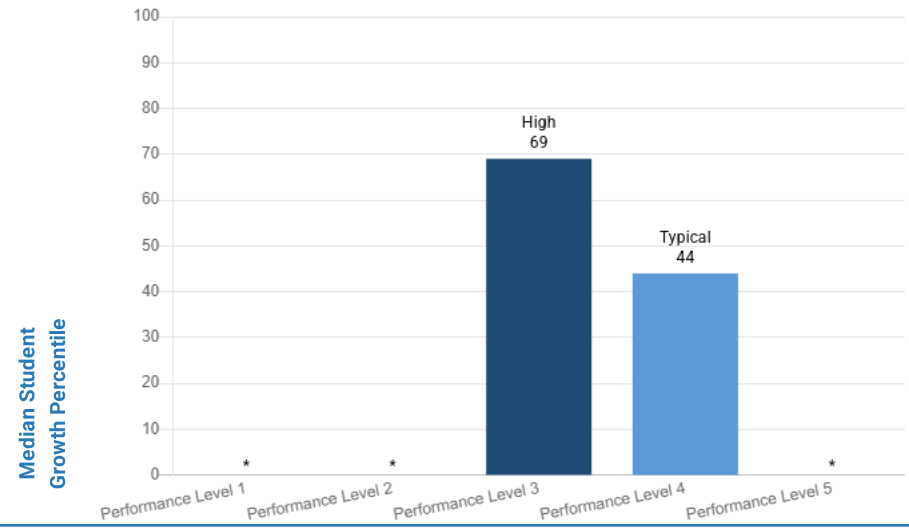

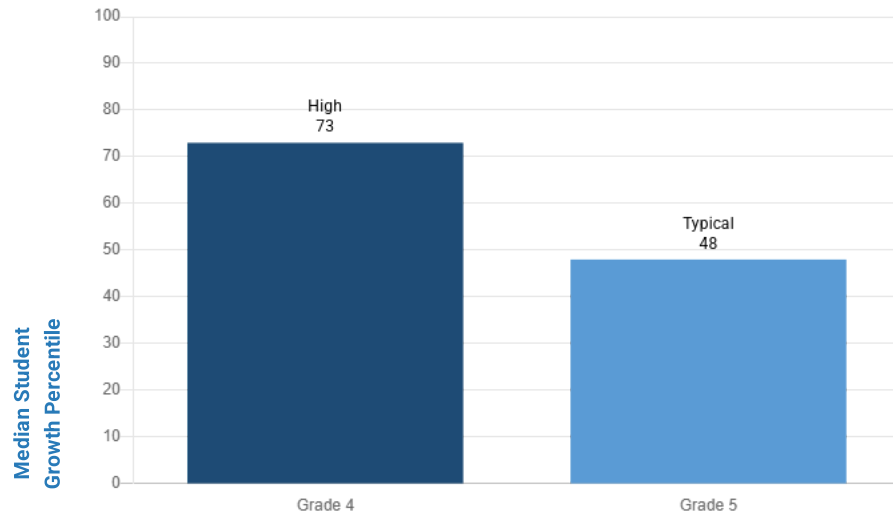

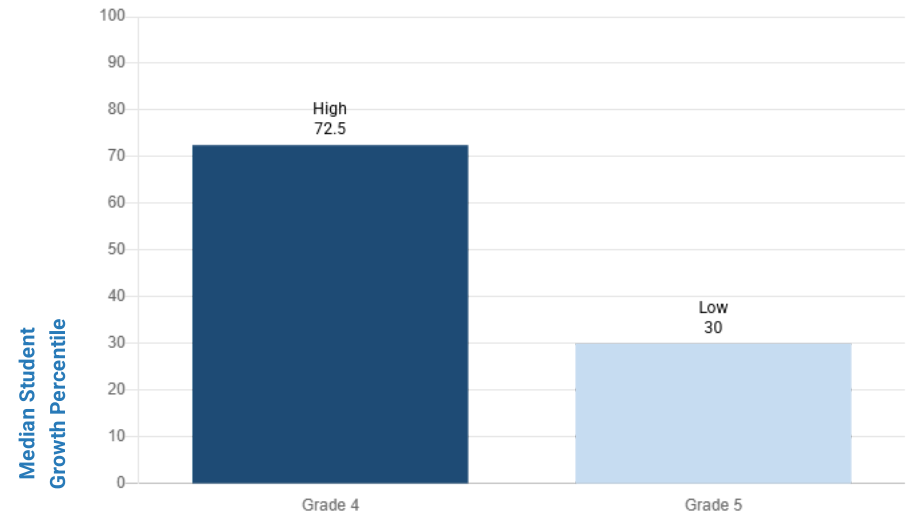

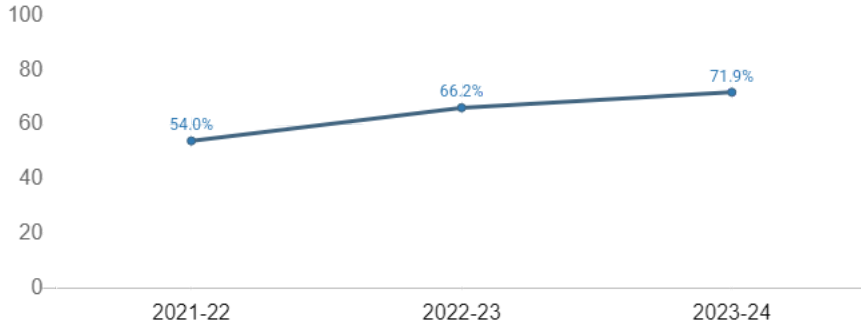

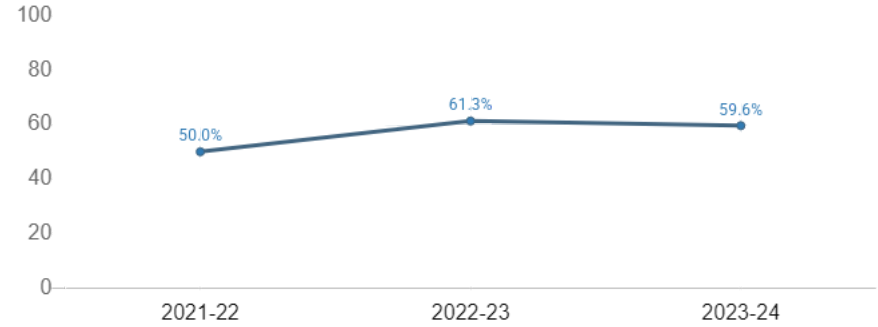
English Language Arts and Mathematics Performance Trends

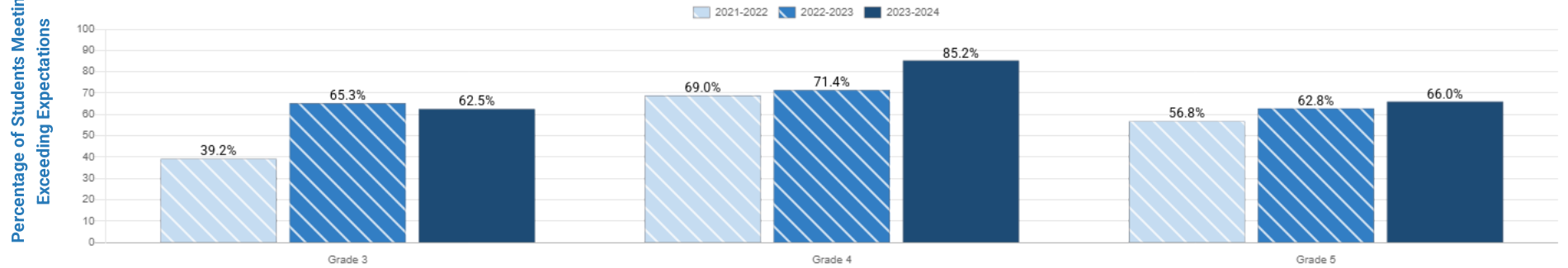

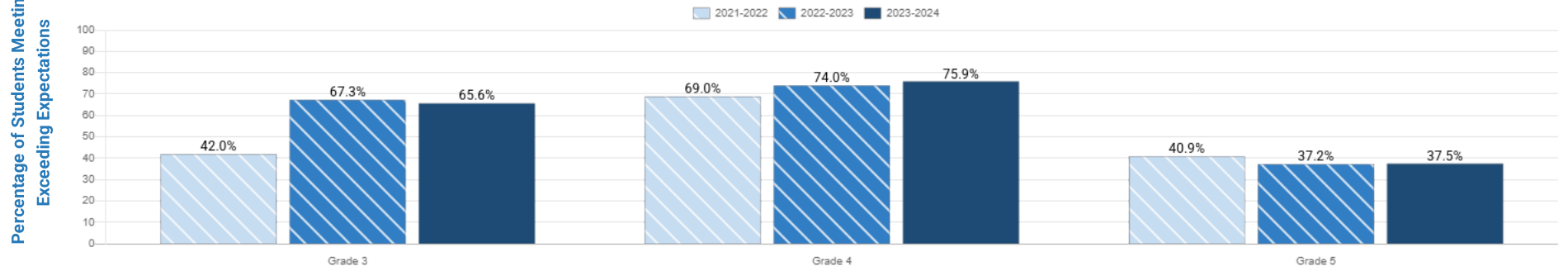

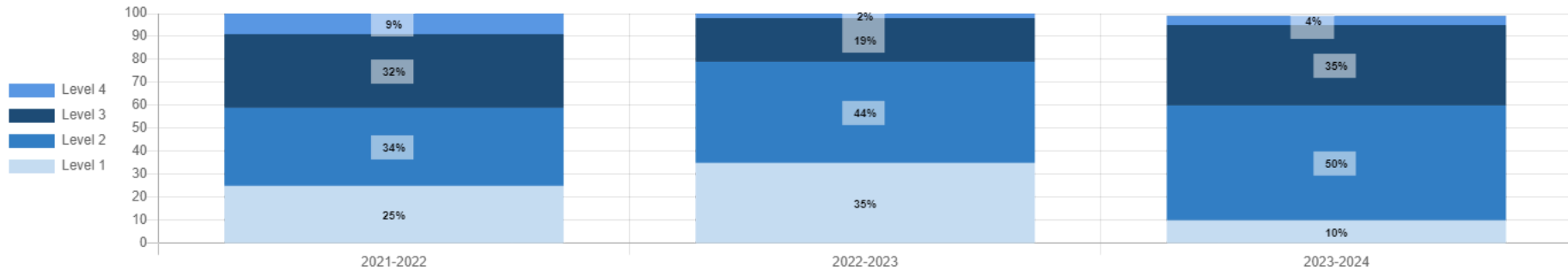

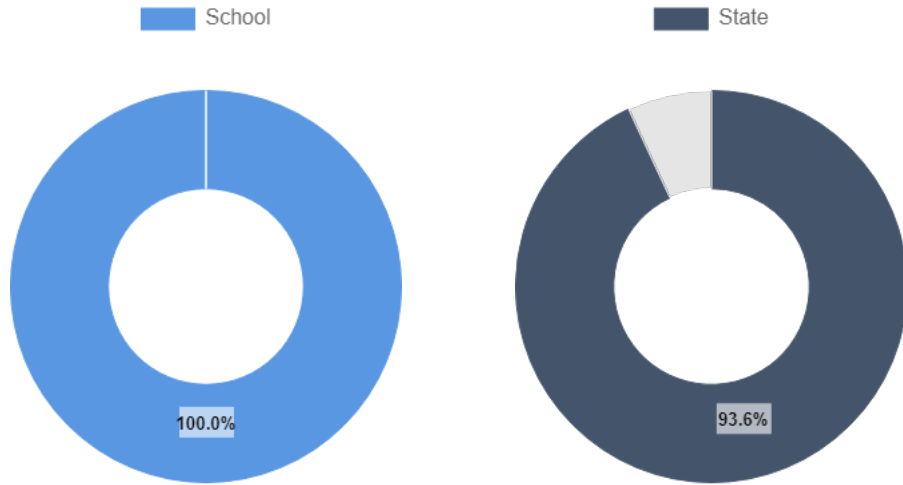

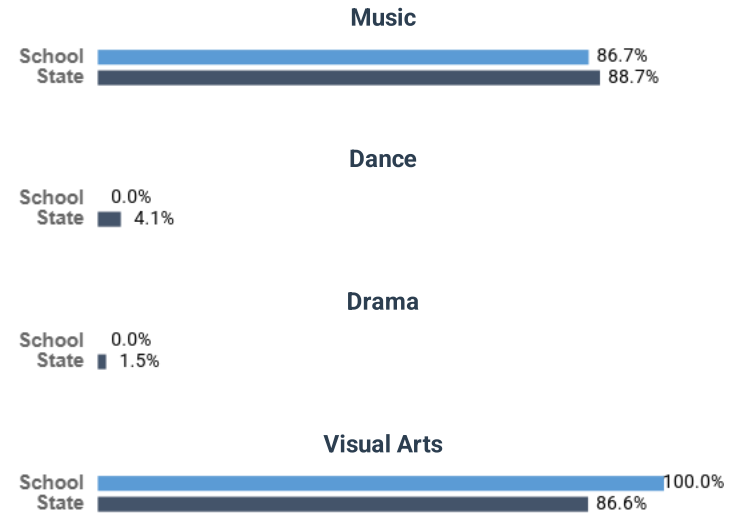

Students enrolled in one or more classes by discipline:



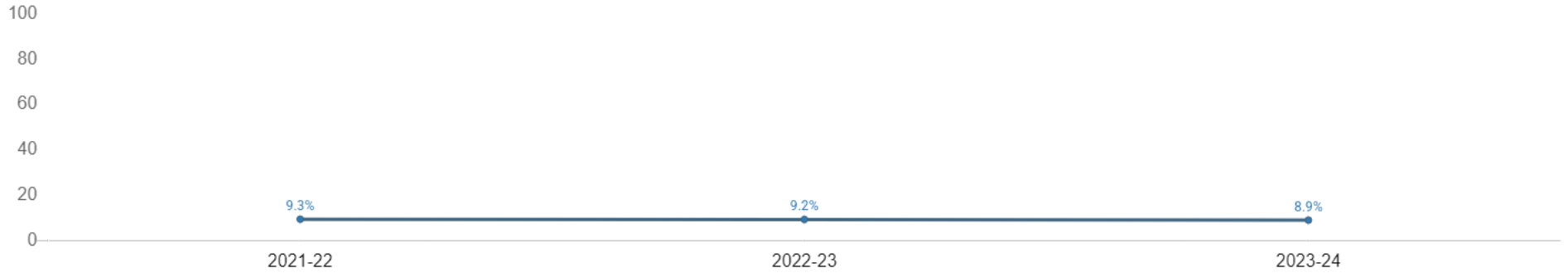

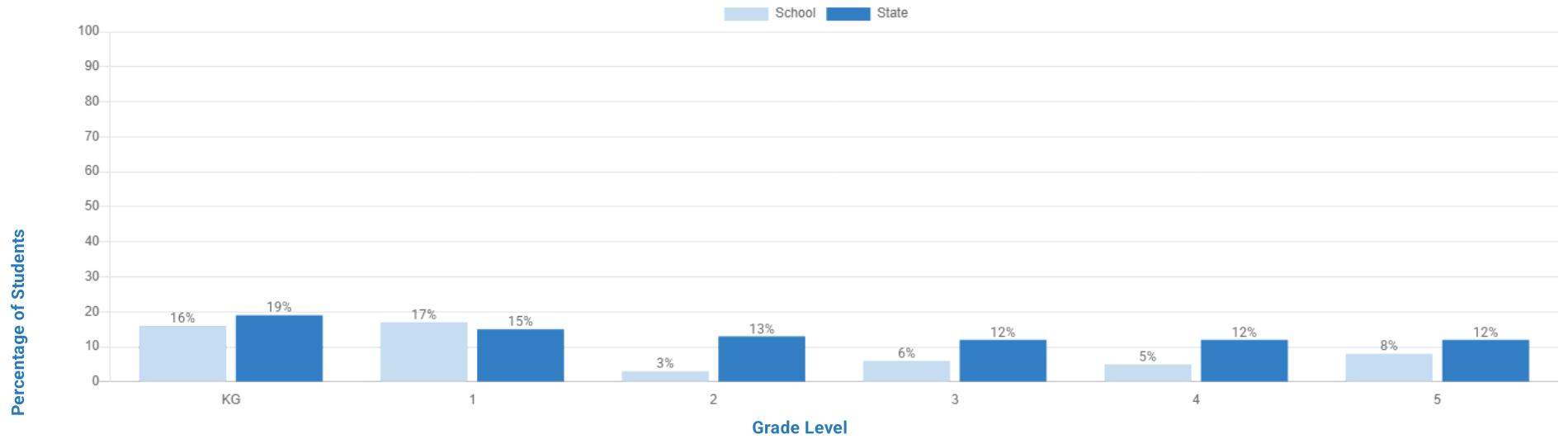

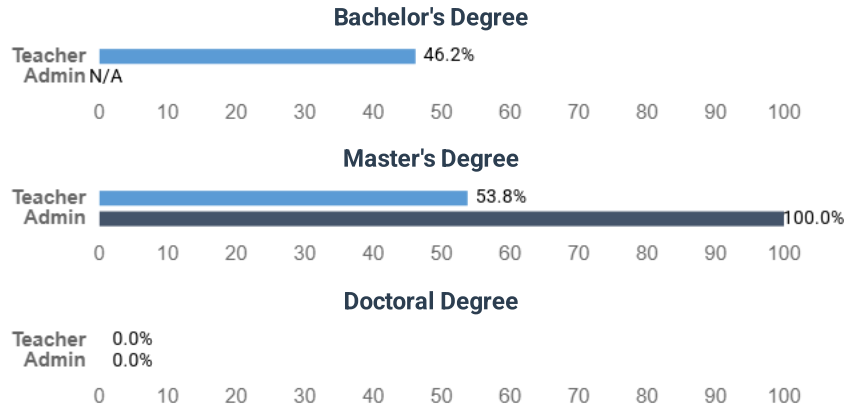

Our school day begins at 9:00 am for students. There are 8 instructional periods per day in addition to lunch and recess.
