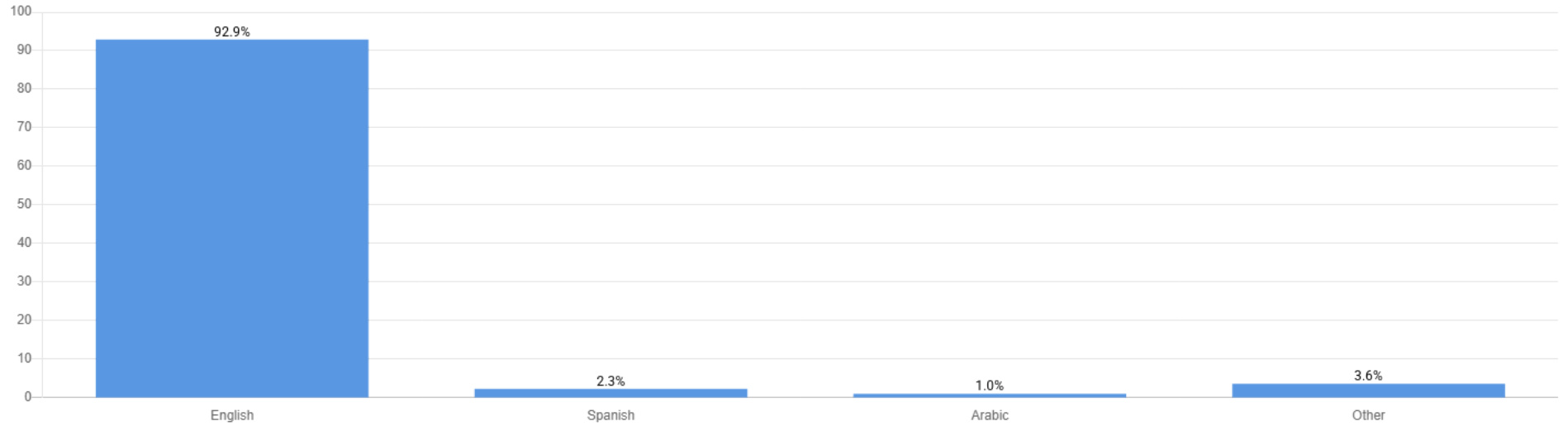

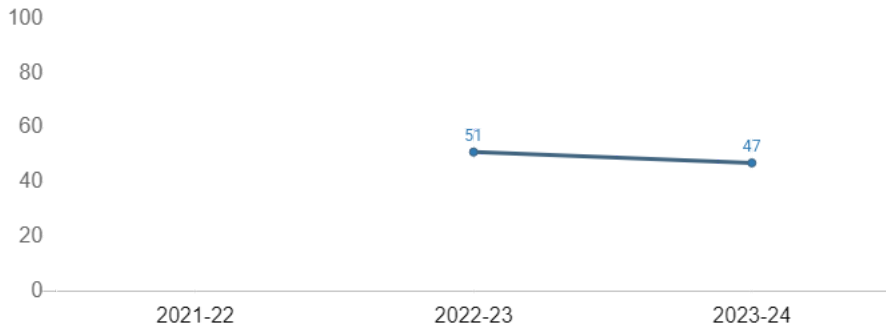

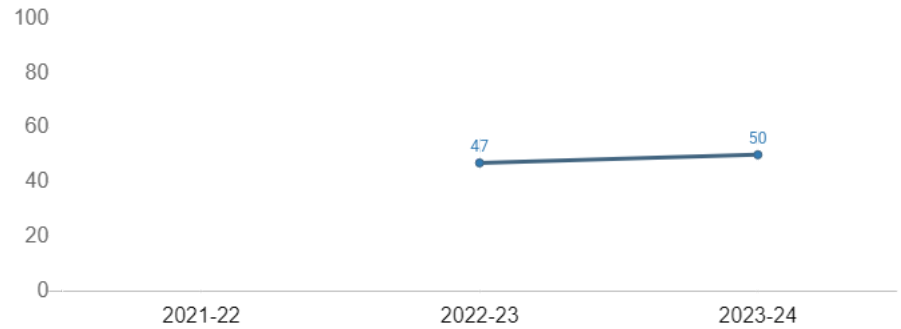

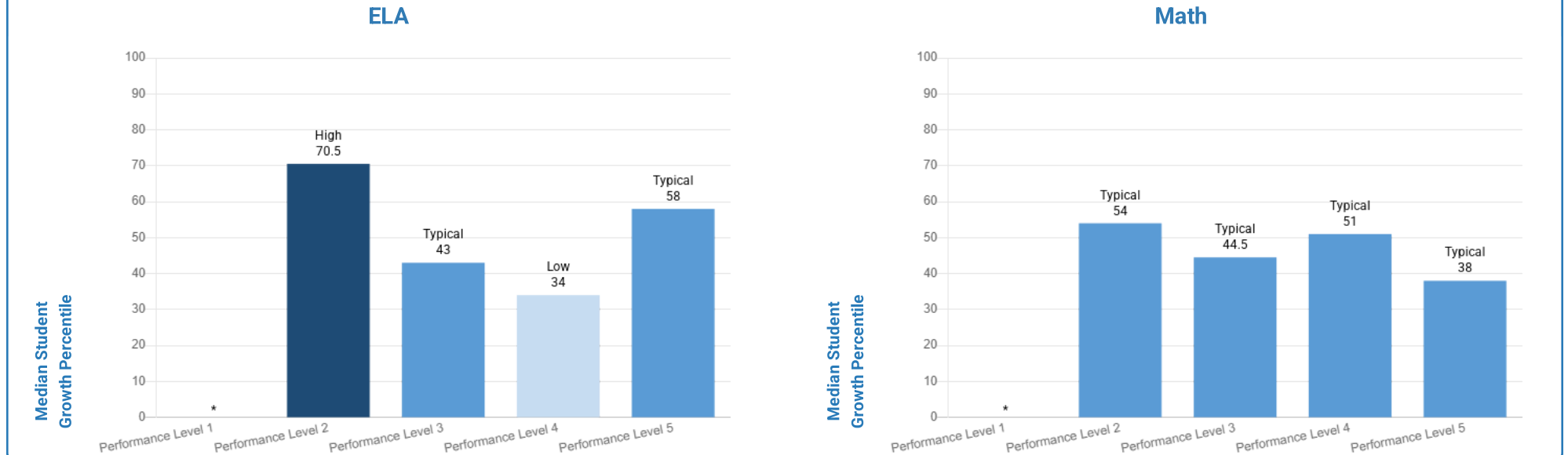

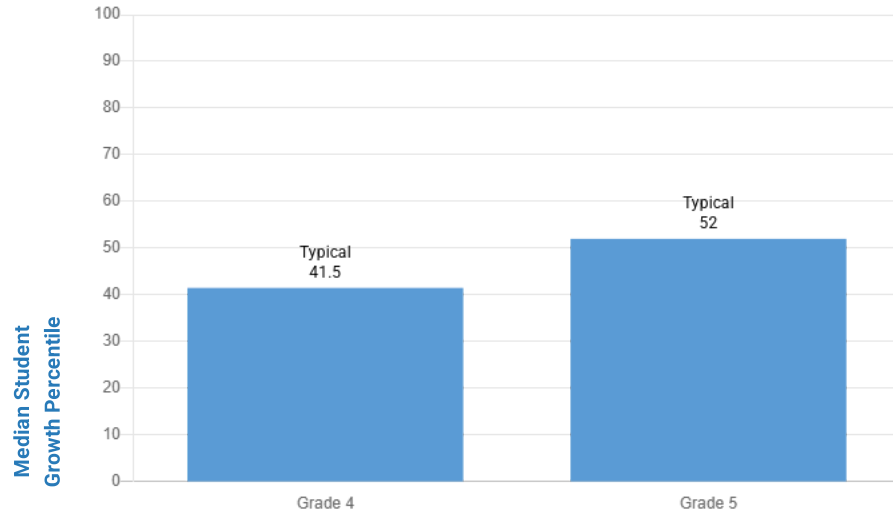

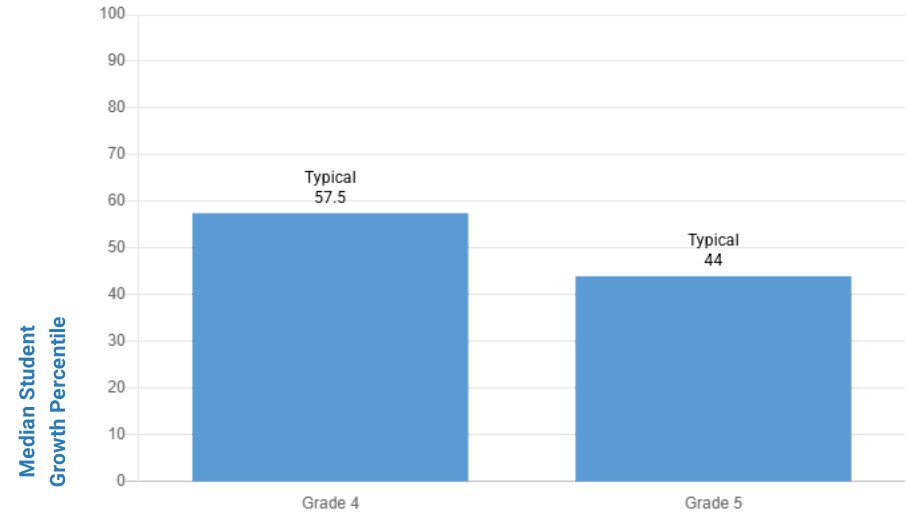

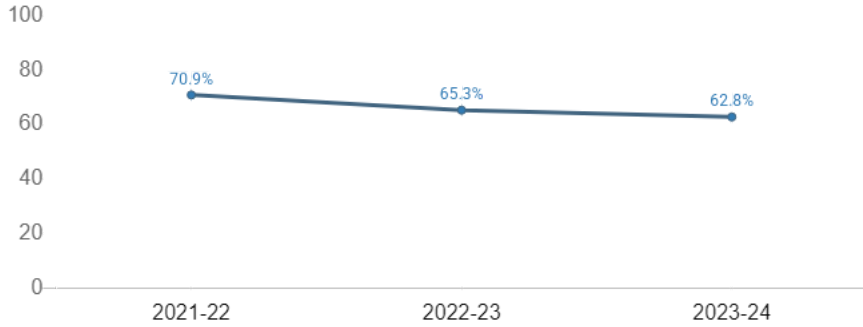

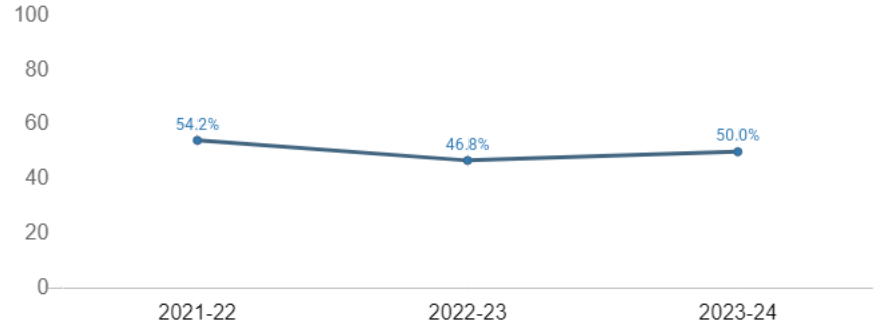
### English Language Arts and Mathematics Performance Trends

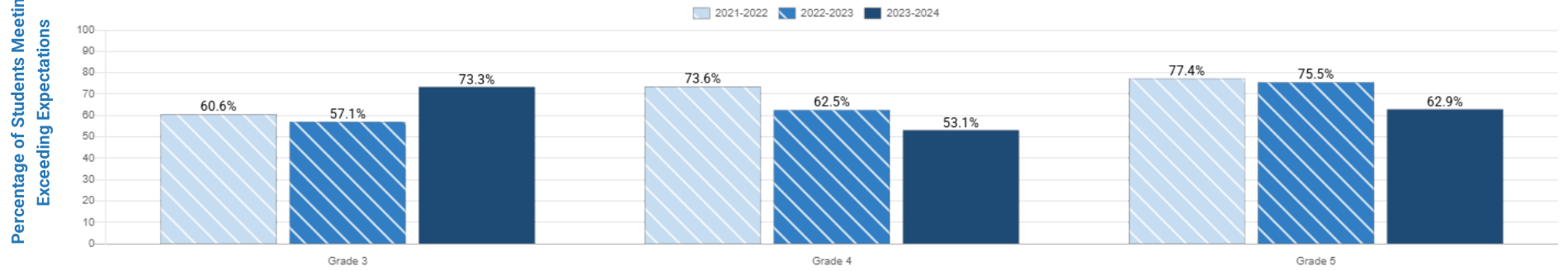

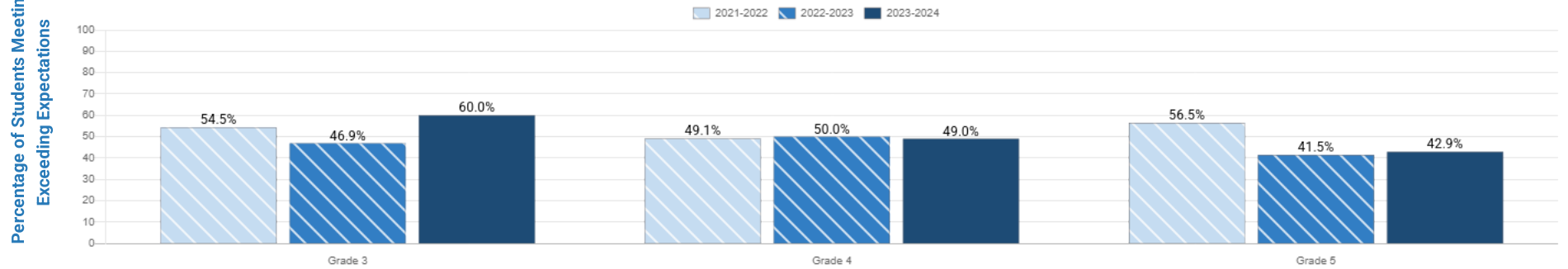

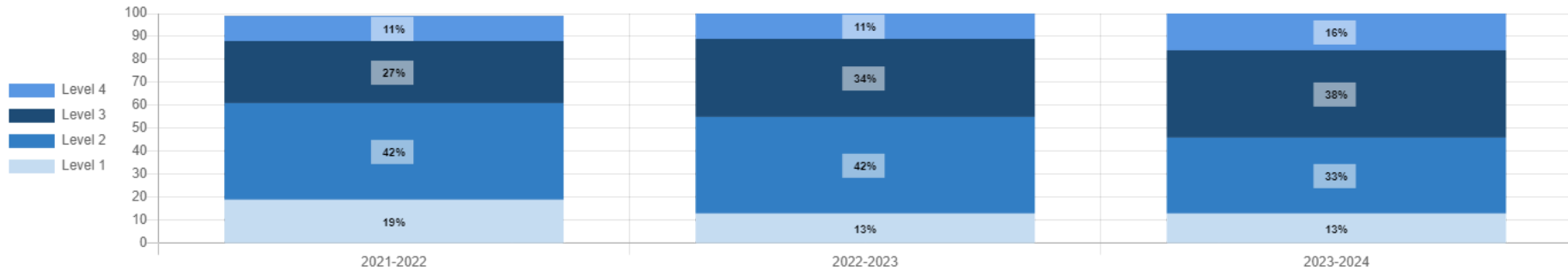

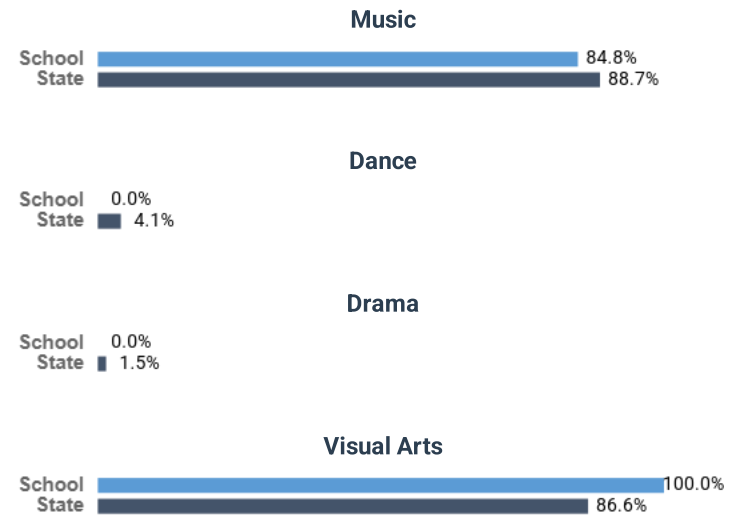

**Students enrolled in one or more classes by discipline:**



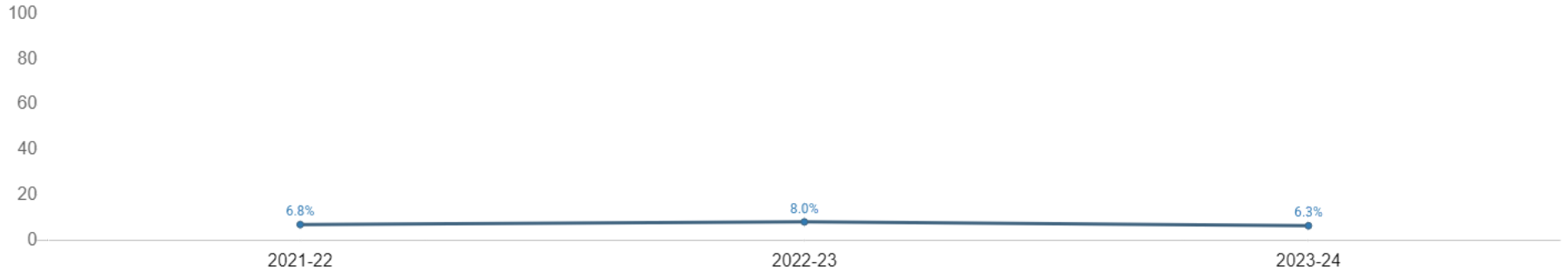

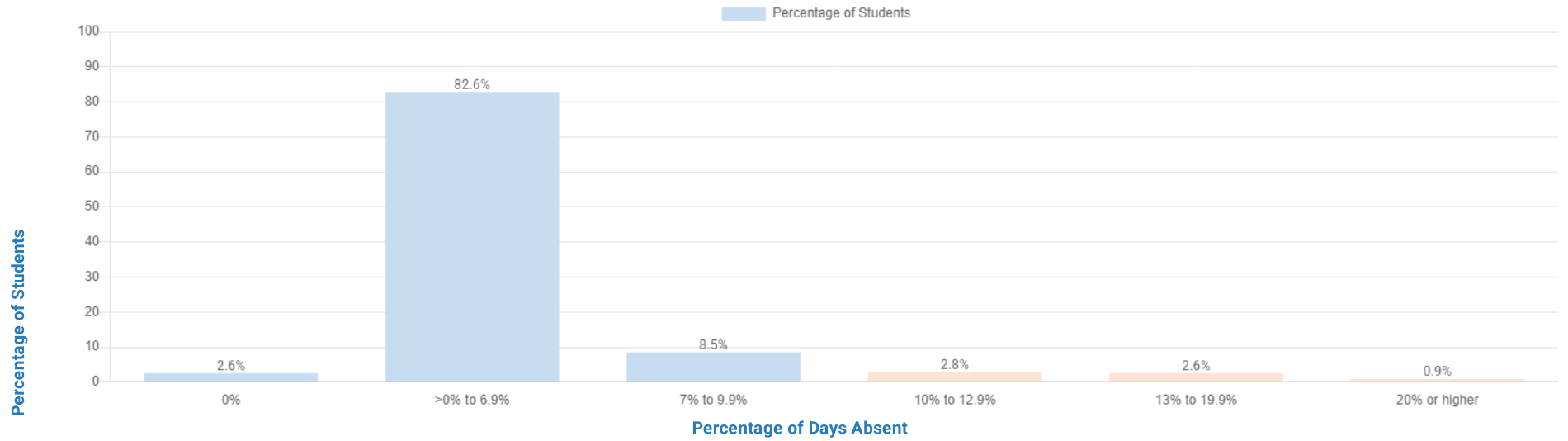

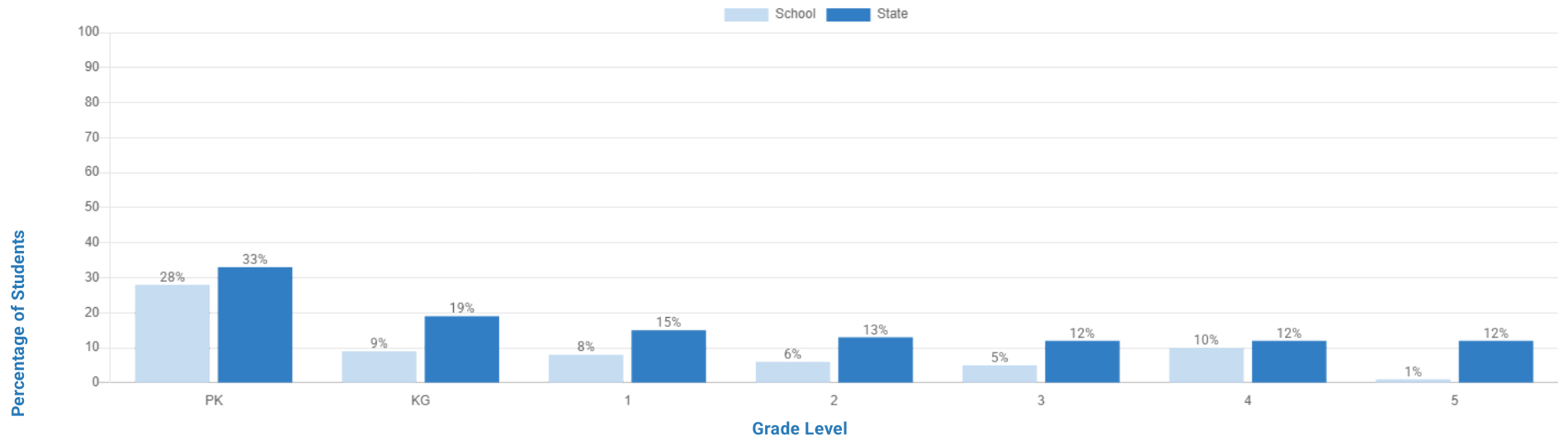

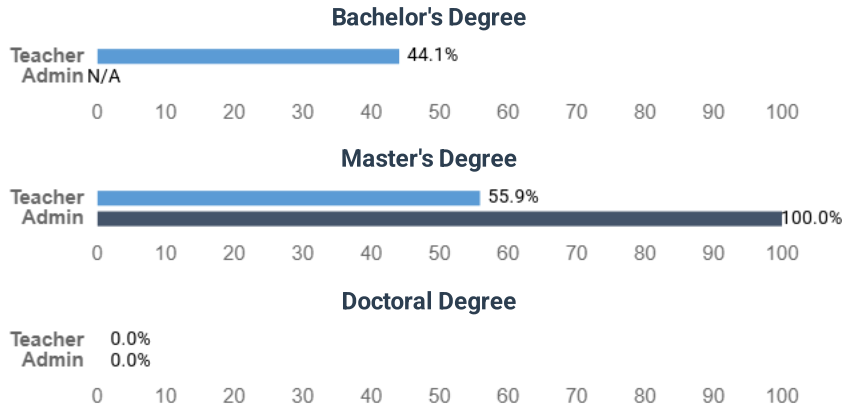

### Staff and Professional Learning:

A District-wide professional development program provides opportunities for teachers to expand their professional repertoire to ensure that their instructional practice reflects current best practices and cutting-edge theory. Teachers often attend PD seminars outside of the District to pursue graduate degrees that support their teaching assignments. The District also contracts with Curriculum experts and provides PD opportunities during designated times throughout the year.



### Student Supports and Services:

English language learners and students with learning disabilities are afforded various accommodations designed to help them meet or exceed the NJSLs. Students experiencing academic, health-related or social challenges may be referred to the Intervention and Referral Services Committee (I&RS) for assistance. Our school counselor also offers a weekly lunch bunch program to teach and reinforce social skills among children in Grades K-5.



### Student Health and Wellness:

Our school nurse and counselor work collaboratively to promote the health and wellness of students and staff. Our counselor meets with individuals, small groups and whole classes to address social and emotional issues. Our nurse addresses the overall health and wellness of all members of the school community. K-5 students have PE twice weekly and outdoor recess daily. Kindergarten students have additional recess or structured play at the end of each day. Additionally, all classes are scheduled for wellness activities daily.

### Other Information:

Heights, constructed in 1959 is the oldest elementary school in our District and houses approximately 350 students in Preschool through Grade 5. Our classrooms are equipped with SMART Boards,/Promethean Boards in addition to sets of either laptops, Chrome Books or iPads. Technology is infused into the curriculum throughout the content areas. We have a school safety team that monitors the procedures that are put in place to ensure the health, safety, and welfare of all students and staff. We also promote our Conflict Resolution Program by conducting lessons for children on resolving conflict in a non-violent manner, peacefully. These lessons are provided by the New Jersey State Bar Association curriculum. We partner with community-based organizations, e.g., Oakland Education Association, Municipal Alliance, Police Department, Mothers' and Fathers' Club, etc., to bring enrichment experiences to our students. It is our intention to provide a meaningful, well-rounded education for all of the children in our care and to ensure their social, emotional development.
