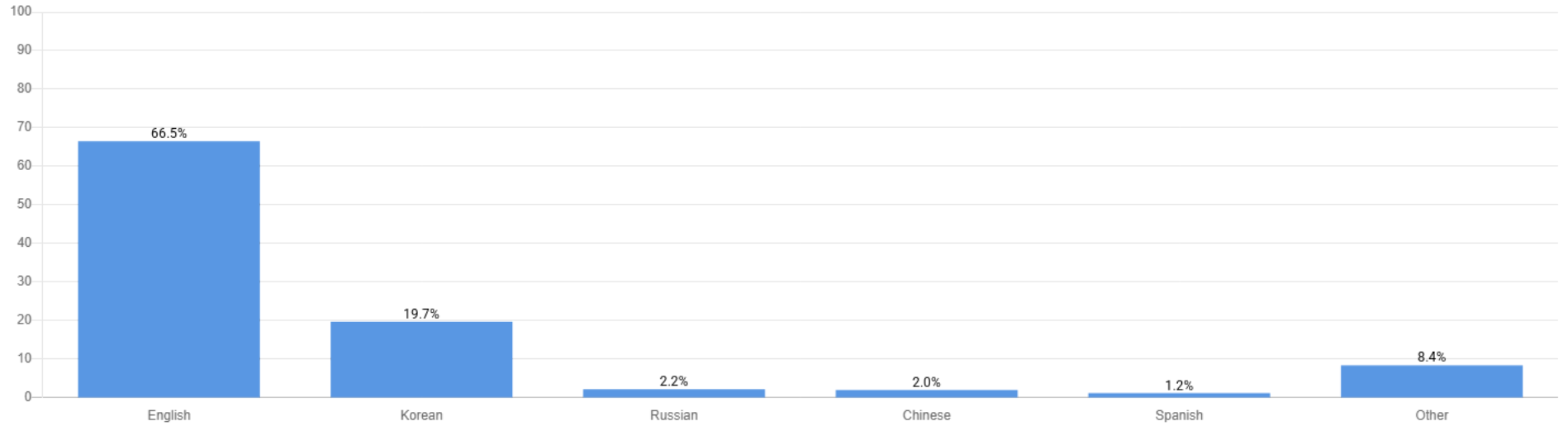

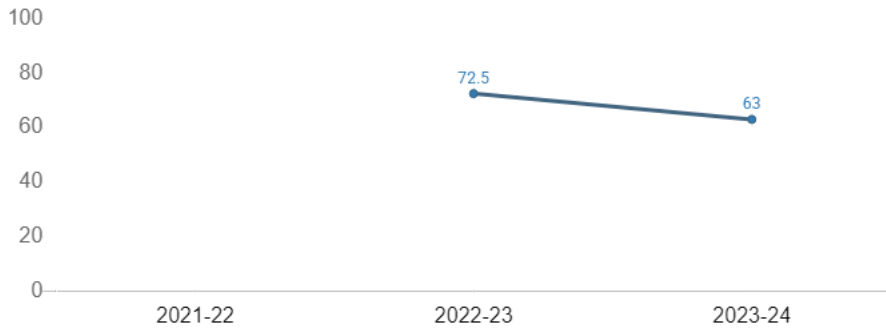

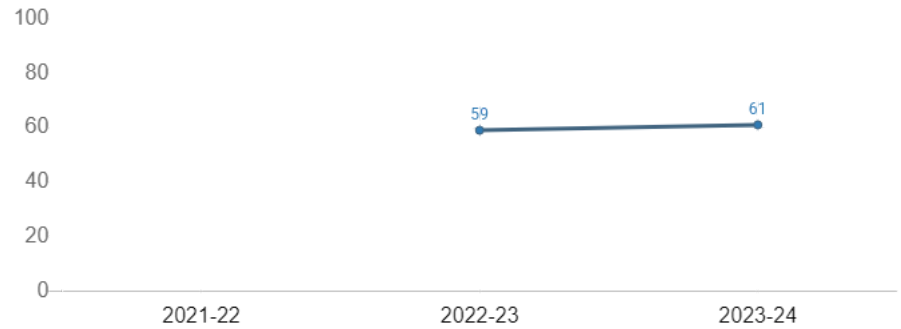

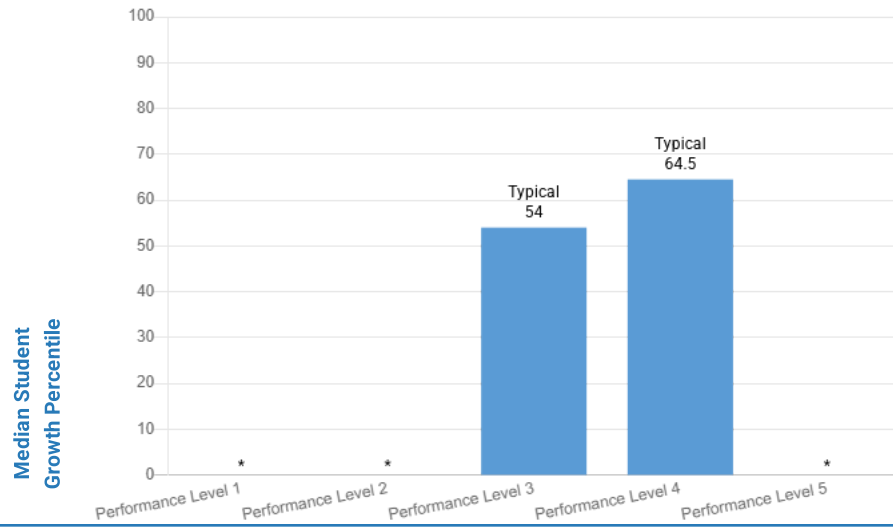

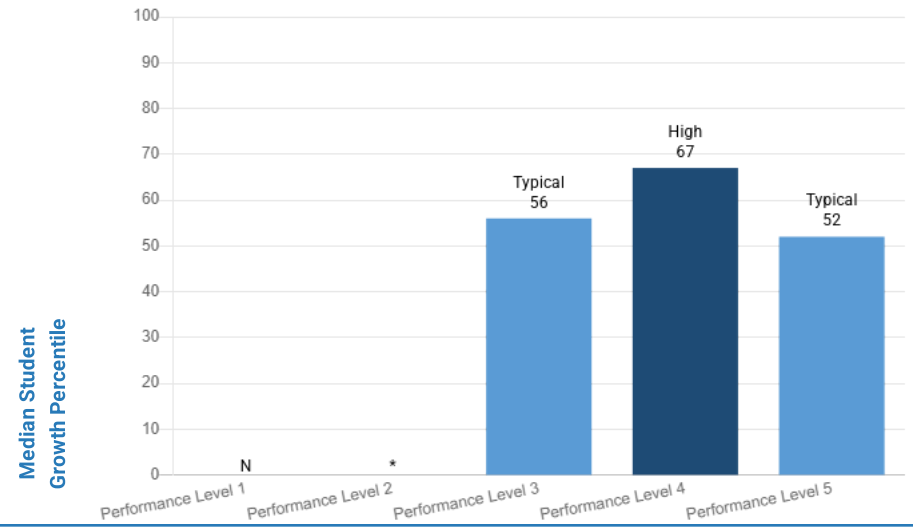

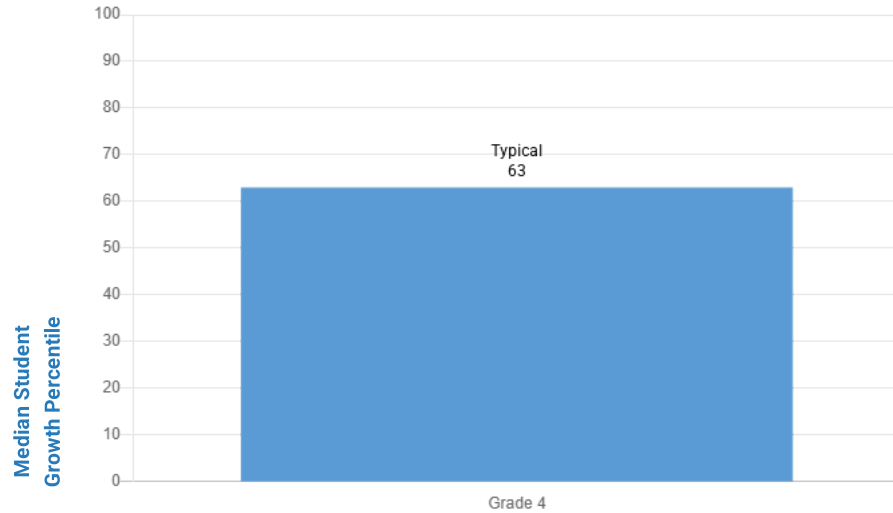

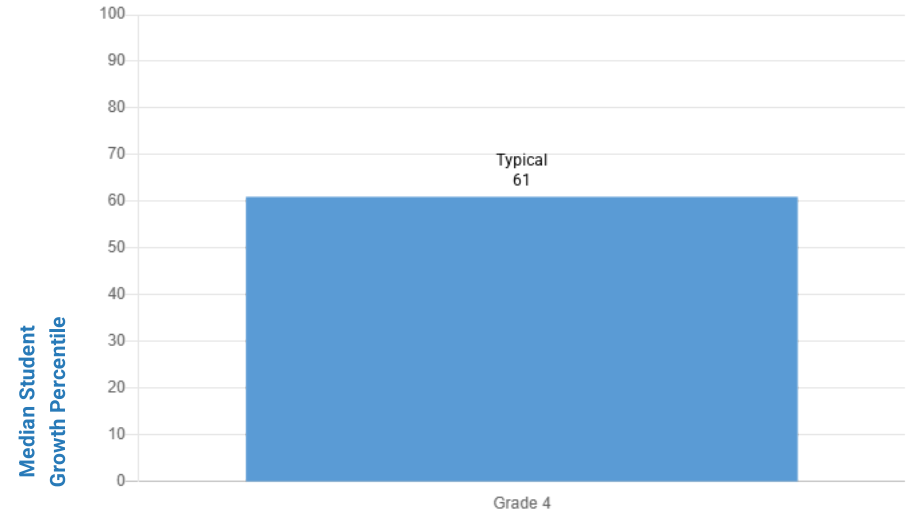

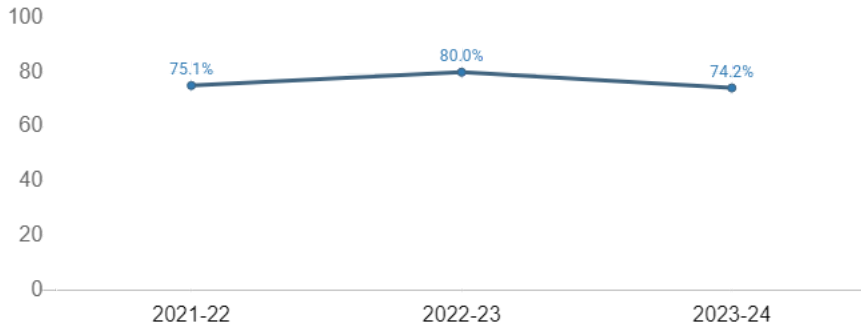

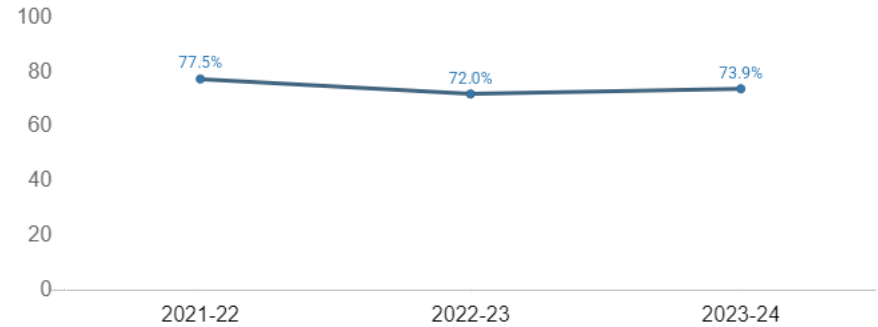
English Language Arts and Mathematics Performance Trends

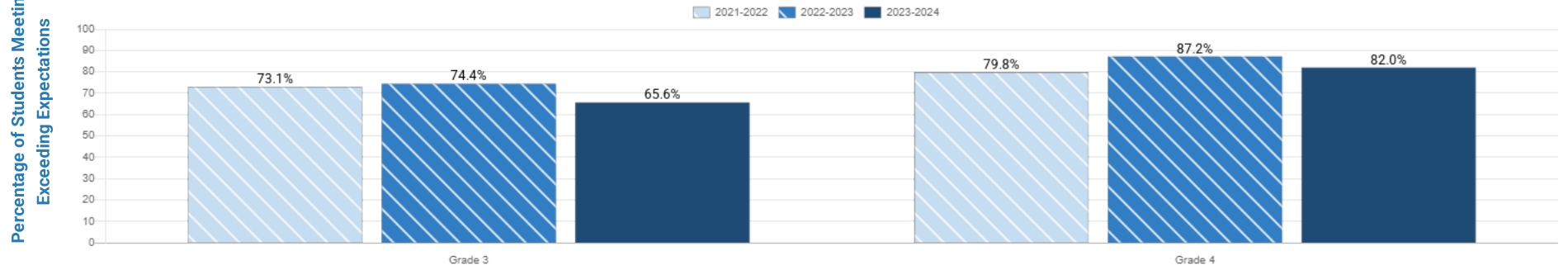

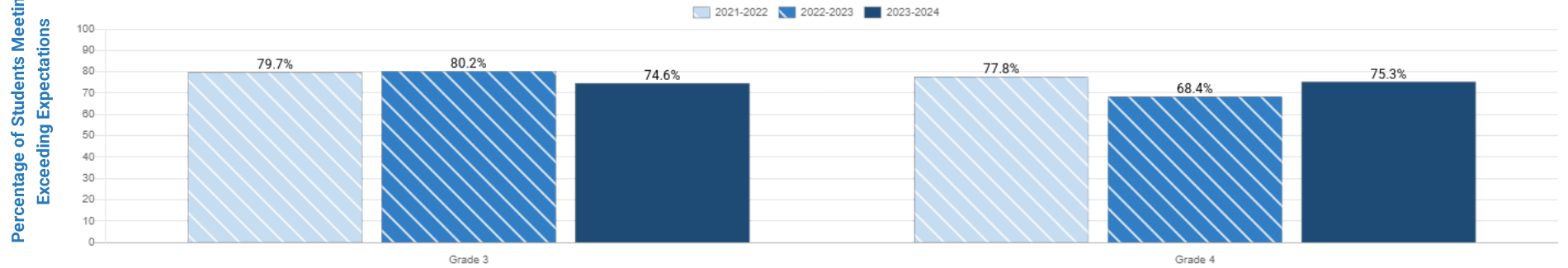

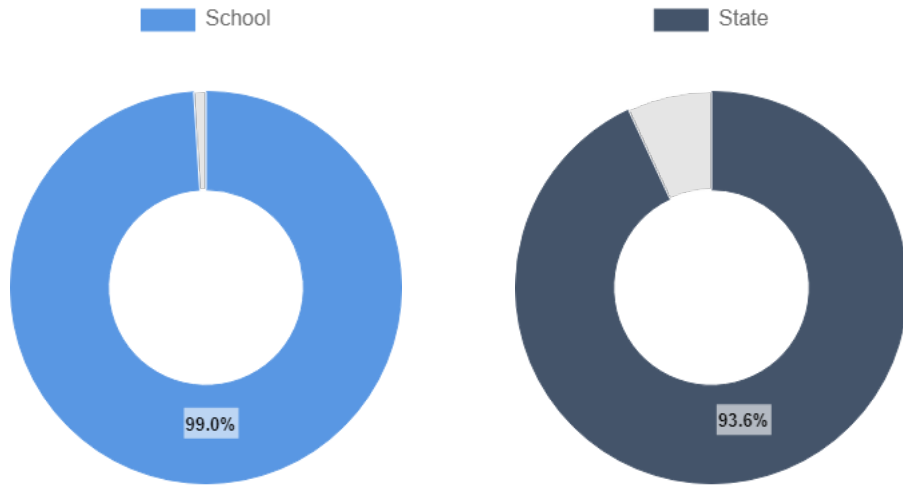

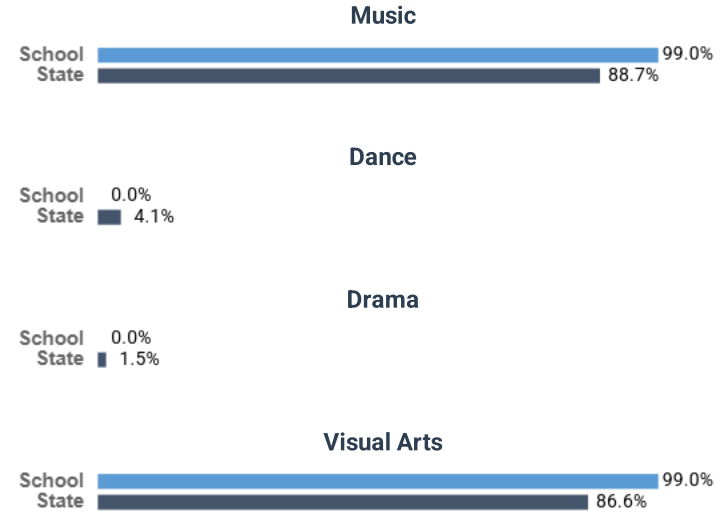

Students enrolled in one or more classes by discipline:



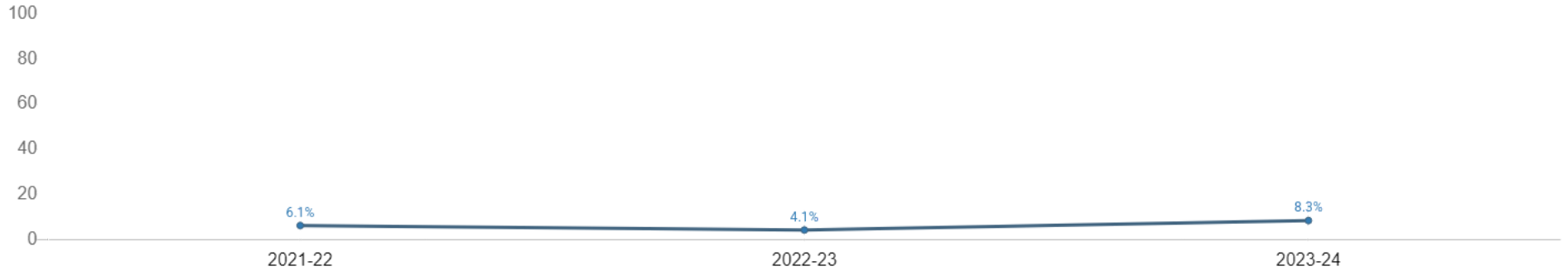

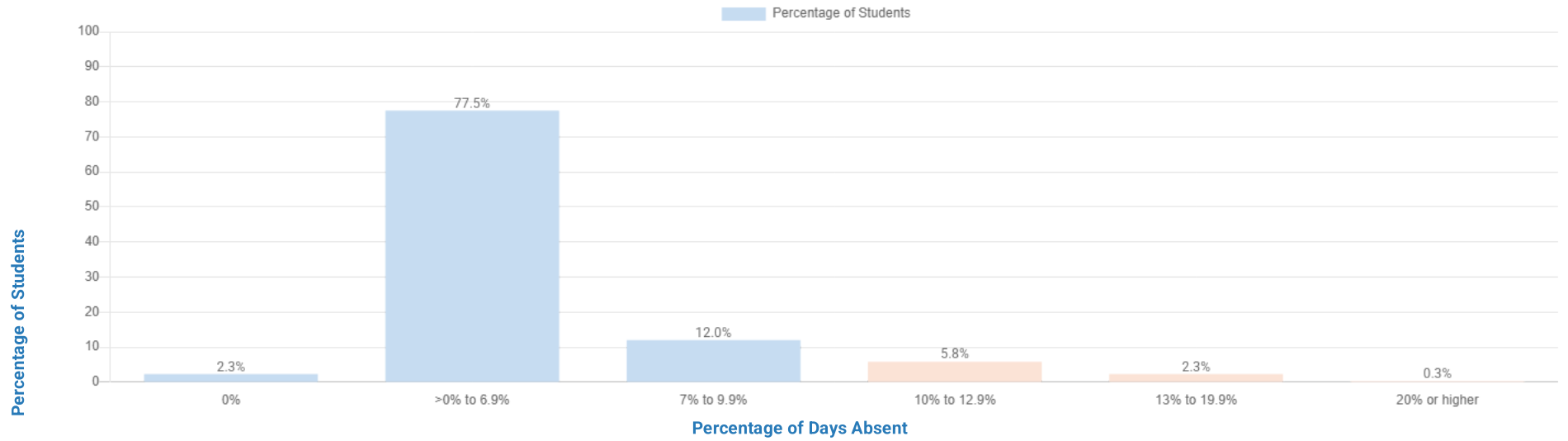

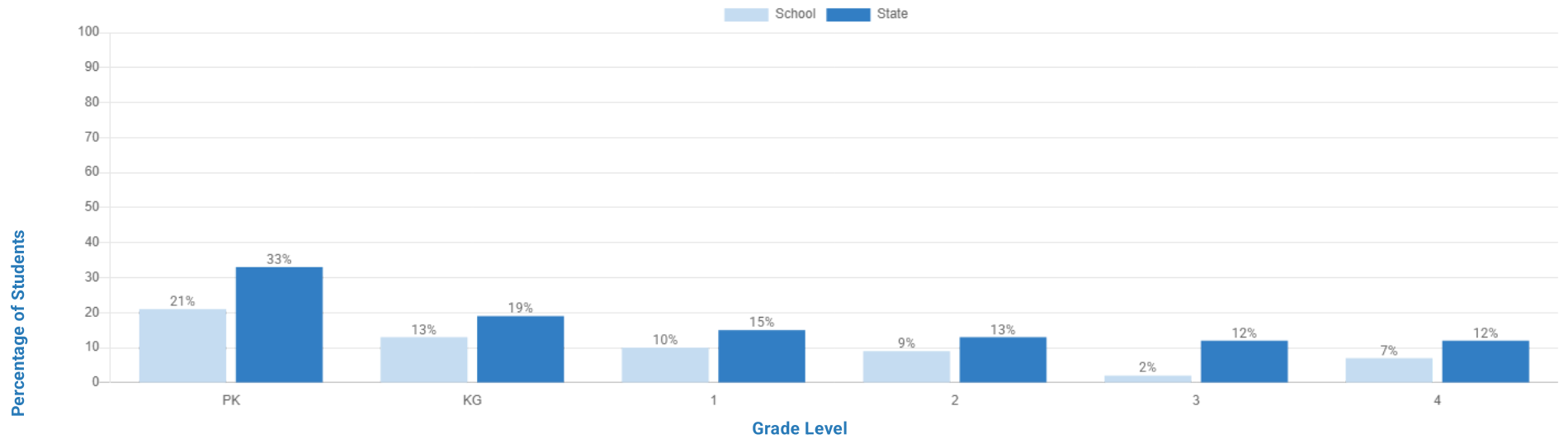

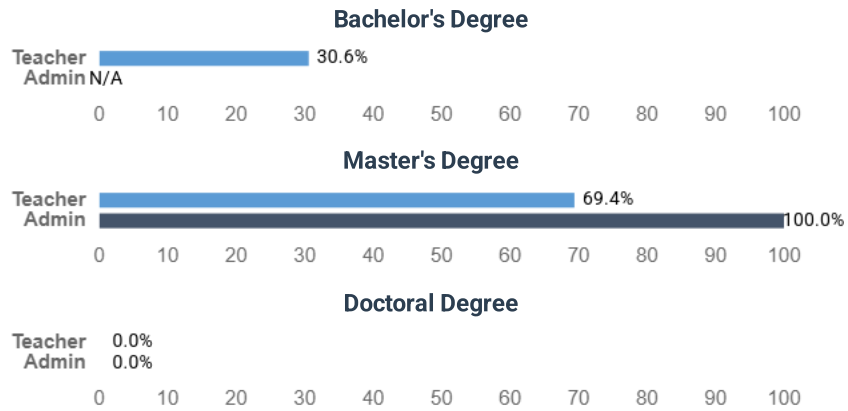

The school's instructional staff is focused on developing the foundations of reading, writing, and mathematics. Language Arts instruction is presented within a reading/writing workshop framework. Real-life problem-solving activities provide opportunities for the students to make mathematical connections to real-world situations while experimenting with numerous problem-solving strategies. Project-based, hands-on learning is the hallmark of our science and social studies program.

In order to provide a high quality education for our children, the staff actively participates in district sponsored workshop offerings, on-going Northern Valley Curriculum Center seminars, and off-site conferences. Grade-level teams meet weekly and Professional Learning Community groups meet monthly to collaborate on best practices. Additionally, study groups and committees provide opportunities for teachers to explore a multitude of educational topics of interest.



Student Supports and Services:

Students are supported by an array of services. Interventions generally begin with the I&RS Committee and may advance to our in-house CST, if warranted. A reading specialist, math intervention teacher, speech therapist, ESL teacher, behaviorist, and occupational therapist provide on-site academic and/or therapeutic support.
