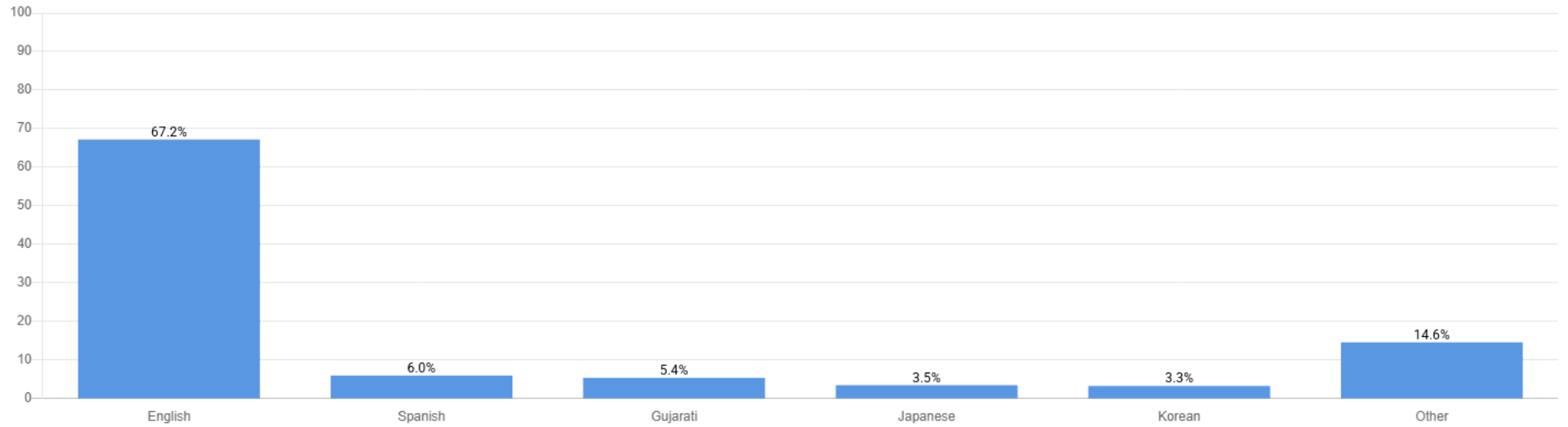

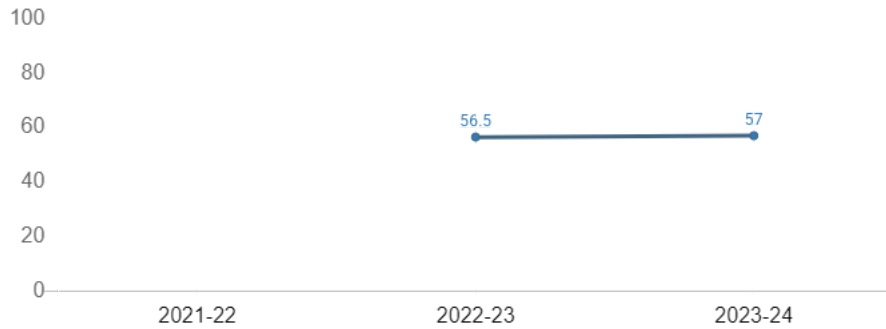

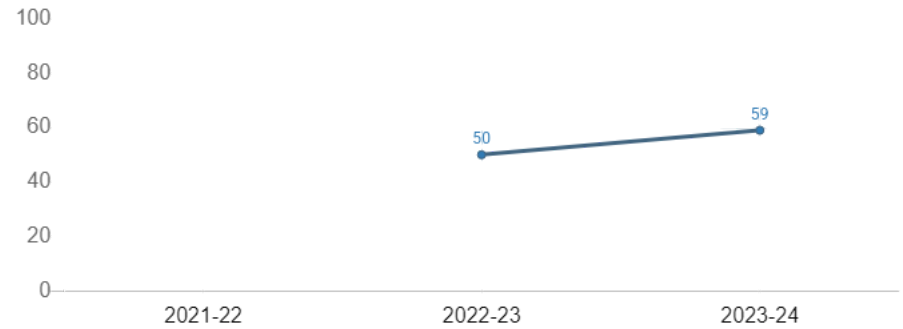

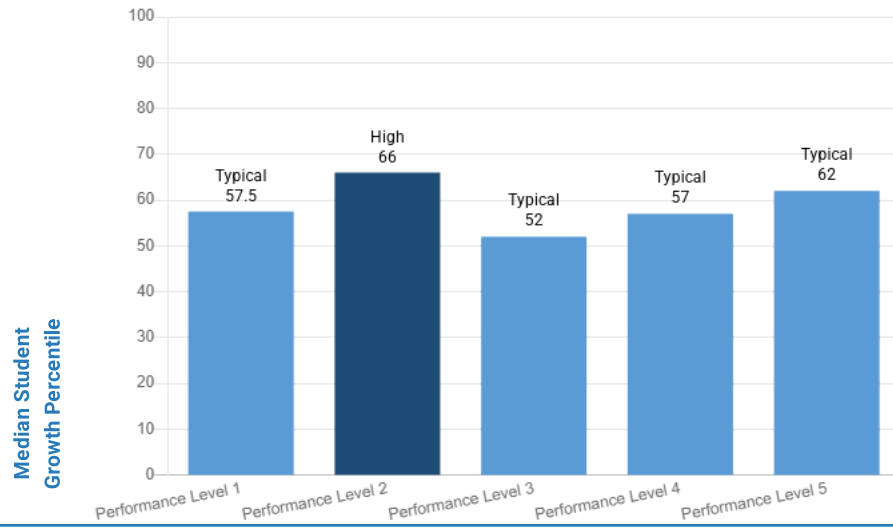

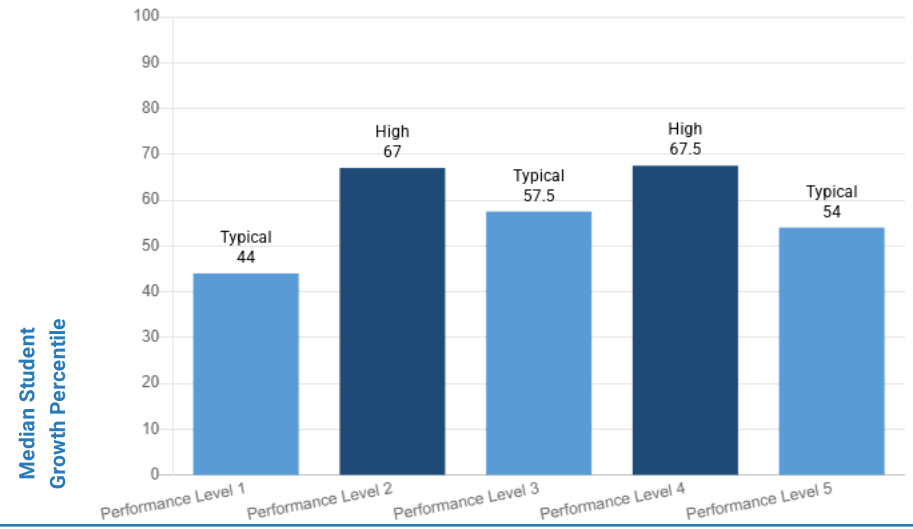

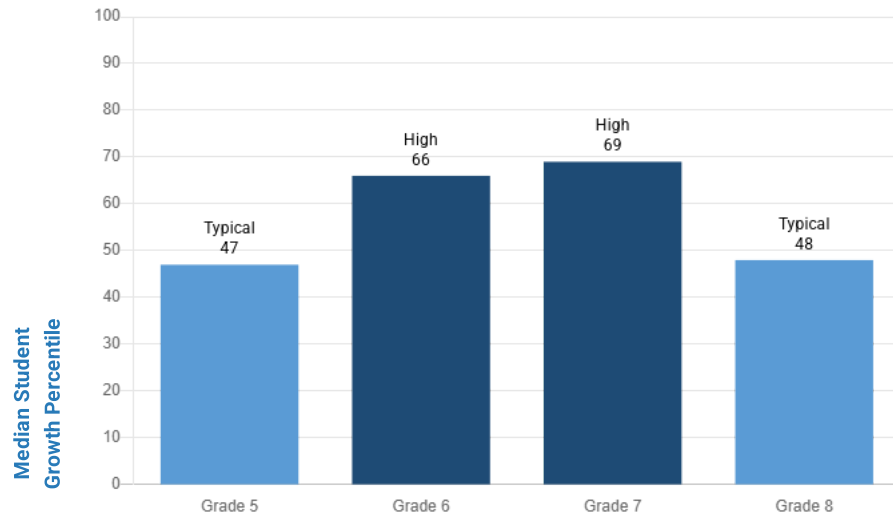

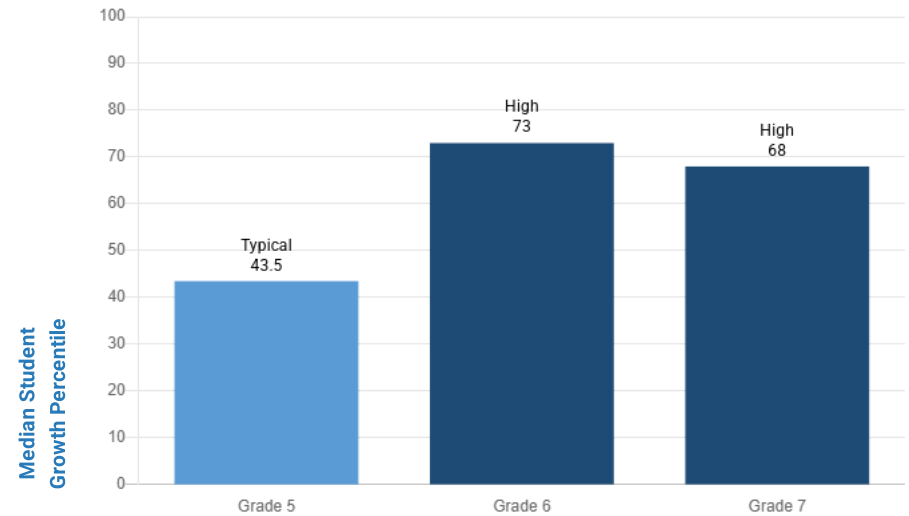

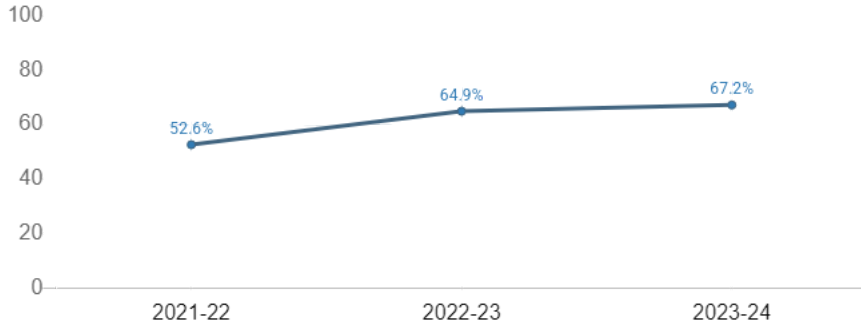

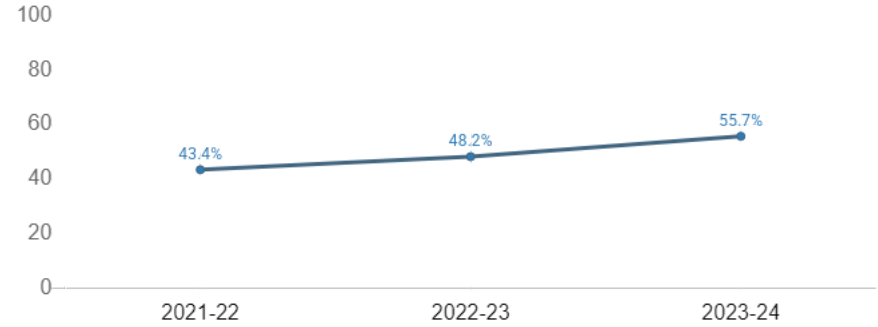
English Language Arts and Mathematics Performance Trends

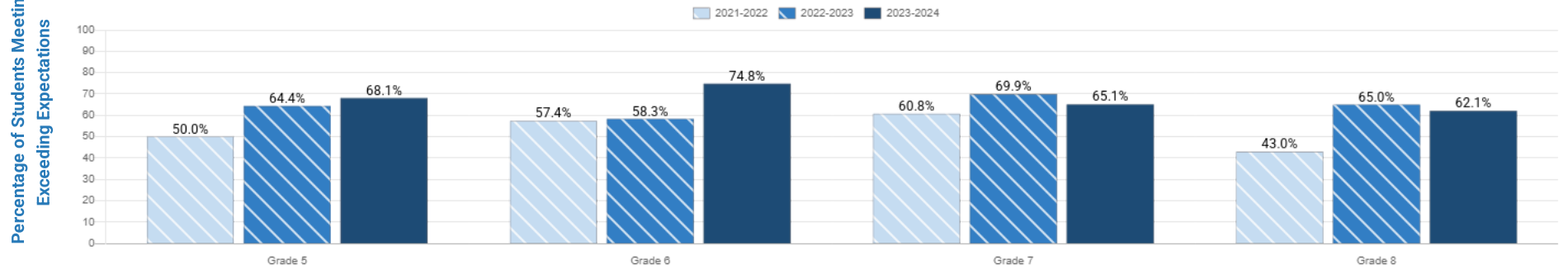

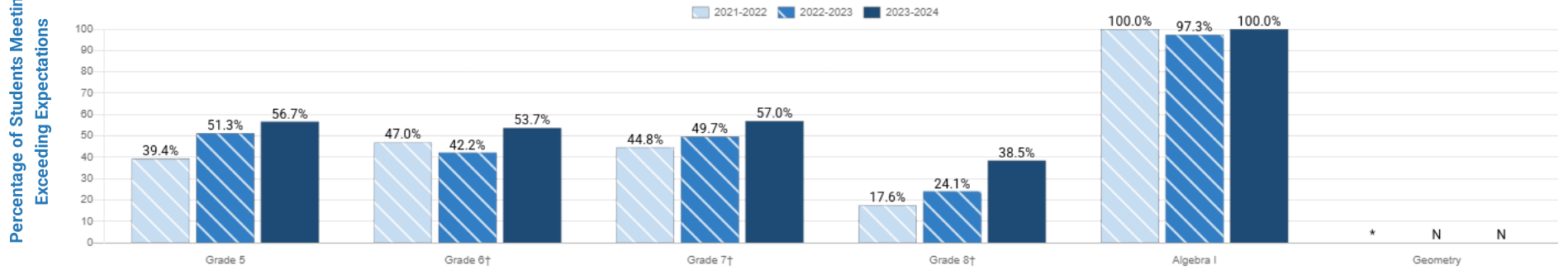

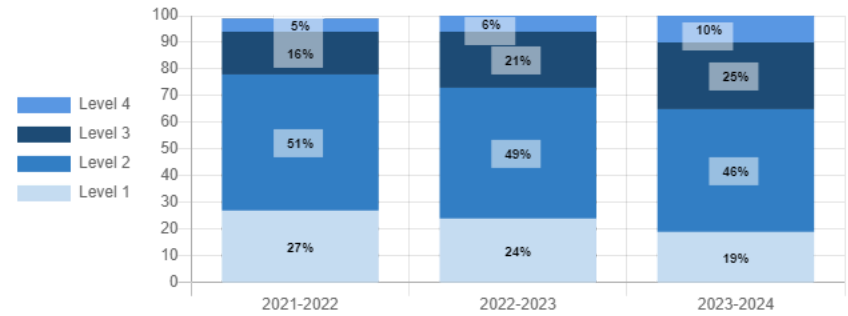

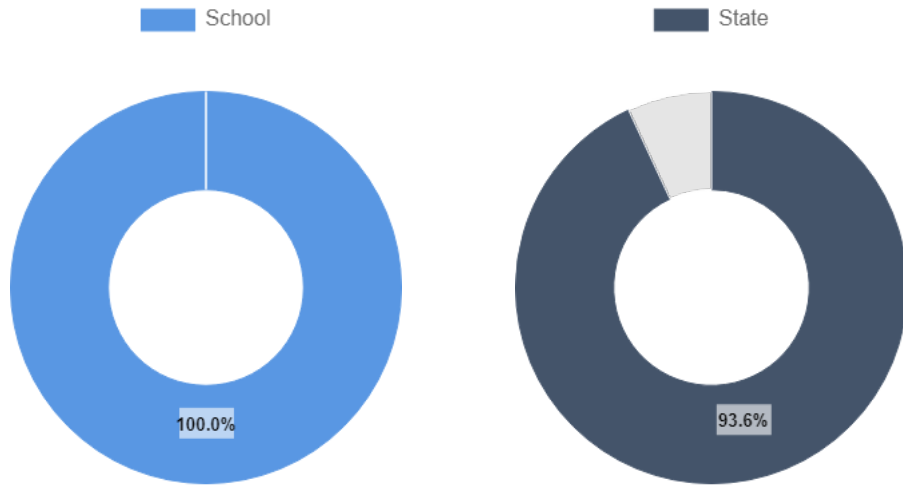

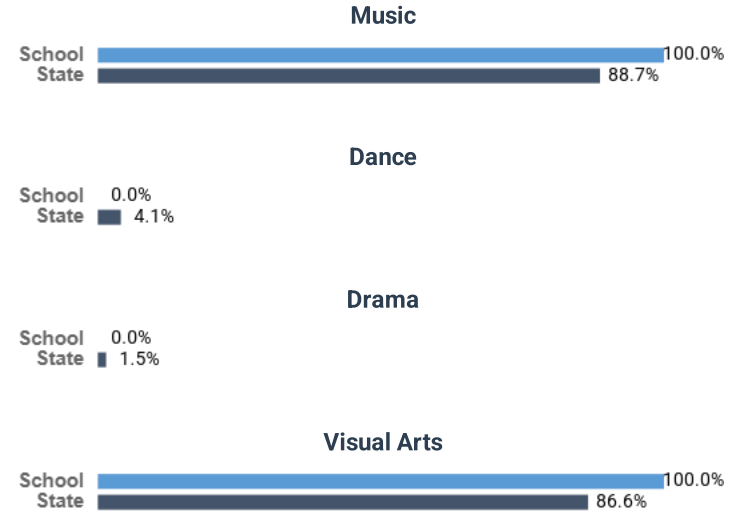

Students enrolled in one or more classes by discipline:



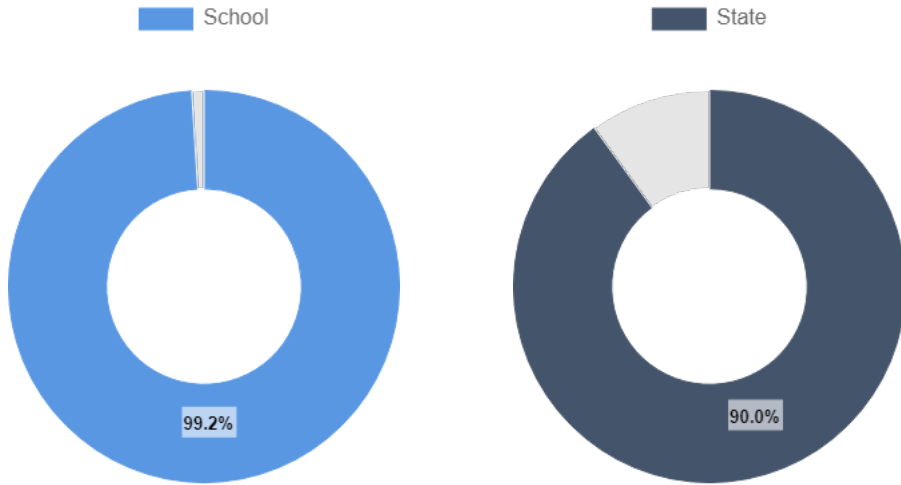

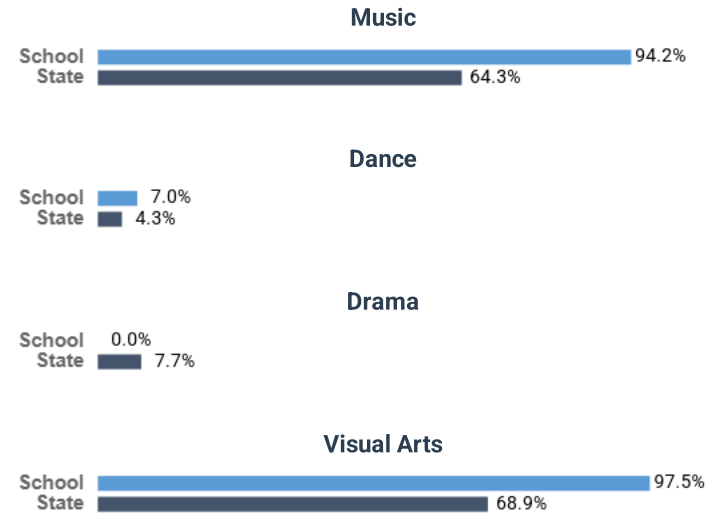

Students enrolled in one or more classes by discipline:



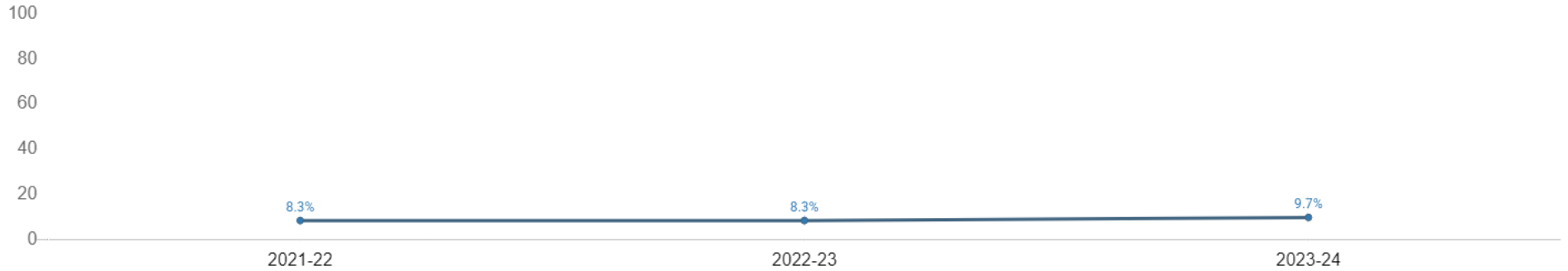

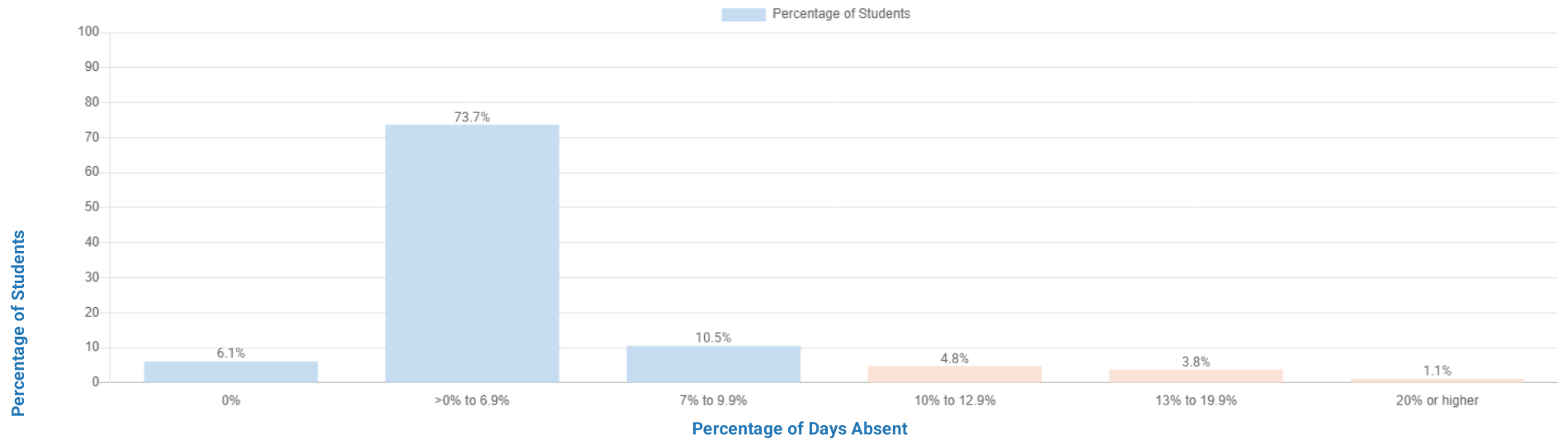

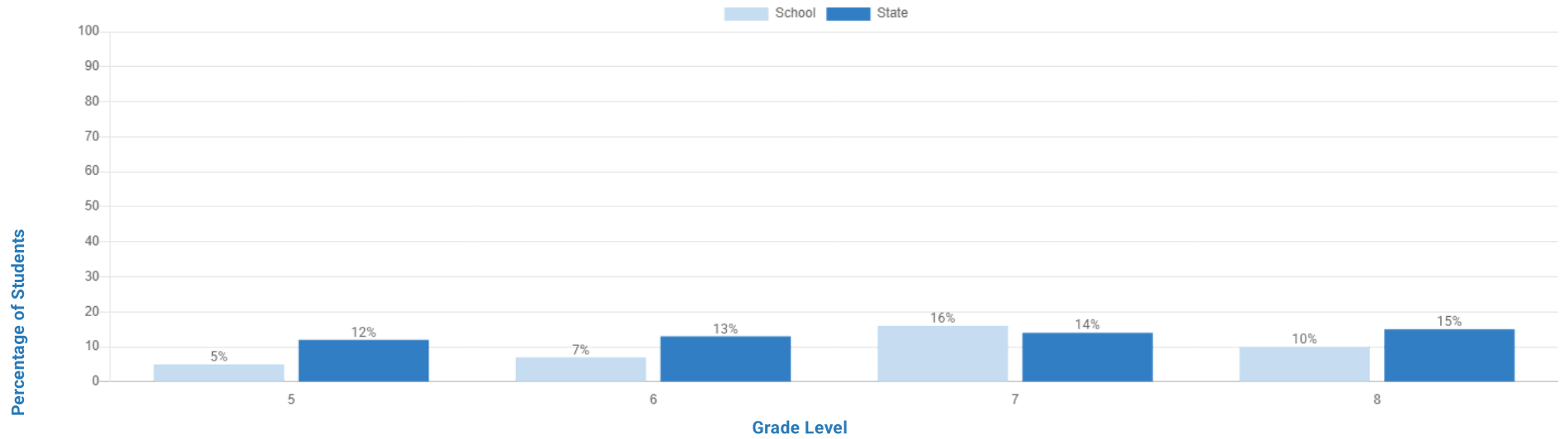

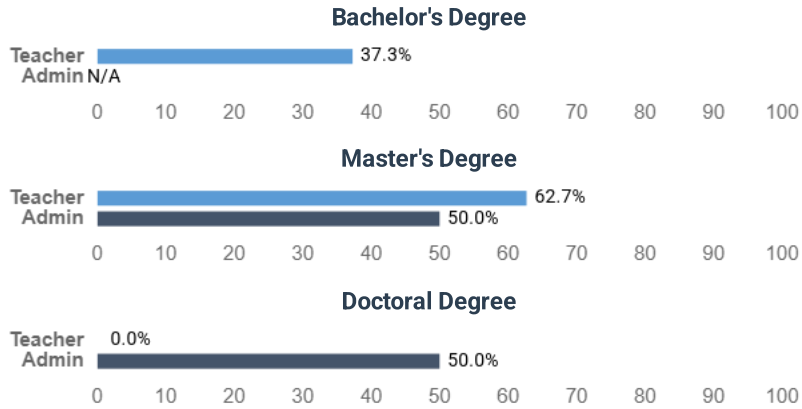

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Courses, Curriculum, Instruction:

West Brook offers a comprehensive program that meets the diverse needs of its students. Our academic program provides instruction in language arts, mathematics, science, and social studies in addition to world languages, art, music, physical education, STEM, dance, theatre, 21st Century Skills, enrichment, speech, special education, and an English Second Language (ESL) Program. Special programs include an Advanced Math Program (6-8), and Enrichment Program. Technology is an integral component of everyday instruction. An Advisory Program supports our adolescents in current issues related to social skills and challenges that are typical in middle school, including navigating conflict and friendships. An active Student Council and Culture and Climate Team provide feedback to enhance a positive school culture.



Sports and Athletics:

Intramural Sports are offered as a part of our Co-Curricular Club offerings. These include Volleyball, Basketball, and Floor Hockey. Introduced during the 24-25 school year were Flag Football and Soccer. All intramural sports are co-ed.

Before and After School Programs:

West Brook has an after-care program called Champions, a member of KinderCare Education. Champions provides an extended learning program for busy working parents with a safe, convenient program where their child's potential is fostered through engaging learning experiences. In addition to clubs offered after-school, teachers are available to provide extra assistance in curricular areas.



Staff and Professional Learning:

Faculty participate in ongoing professional development in the content areas and best practices to support student engagement. Professional learning is differentiated to support the needs of teachers and their work with our diverse learners. Teachers participate regularly in Professional Learning Communities and Instructional Coaching that focus on improving practice to support student learning. Our teachers are also part of curriculum development and the development of benchmark assessments.



Student Supports and Services:

English Language Learners participate in ESL Programs. Programs that support students with disabilities include: In-Class Support, Resource Room, Academic Support, and Self-Contained programming. Reading and Mathematics Support classes are provided for students struggling with academics, in addition to teacher support after-school. Intervention and referral services are available to assist students with academic, behavior, or health difficulties, in addition to a Student Wellness Coordinator.

Student Health and Wellness:

Students engage in physical education and recess as a part of their daily schedule. The health curriculum focuses on nutrition and wellness, character building, drug education and prevention, the five components of physical fitness, understanding heartrate, eating disorders, building self-esteem, drug use and misuse, the reproductive system, and communicable and non-communicable diseases. A Nutrition Advisory Committee meets throughout the school year in order to promote healthy lunch choices and provide students with voice and choice in food selection through our food services program.

Facilities:

West Brook Middle School is a spacious building comprised of three full-size gymnasiums, a recently renovated cafeteria and library, and air conditioned classrooms. Outdoor facilities include basketball and tennis courts, as well as a full-size baseball field. Most of our classrooms are dynamic learning environments with flexible seating for students. Renovations in August 2018 included a STEM lab, Band Room, Music Room, and Orchestra Room. Our 7th and 8th grade classrooms were completely renovated in July 2022 to include new flooring, walls, and lighting.



School Safety:

West Brook has a School Safety Committee that meets regularly to discuss Discipline Referrals, HIB, and suspension data. The team works to ensure responsive and restorative discipline approaches, and ways to support a positive school climate. Our Security team meets to ensure security and safety measures for students and staff. Safety measures include locked entrances with swipe card entry; a full time armed security guard, video surveillance inside and outside of the building; a visitor management system to screen, that requires photo id for all visitors; and monthly security drills. Additionally, WBMS works closely with the Paramus Police and Fire Departments to ensure best practices in these areas. Finally, our Behavioral Threat Assessment Management Team (BTAM) meets consistently to review best practices and the process steps for initiating and managing a behavioral threat assessment.
