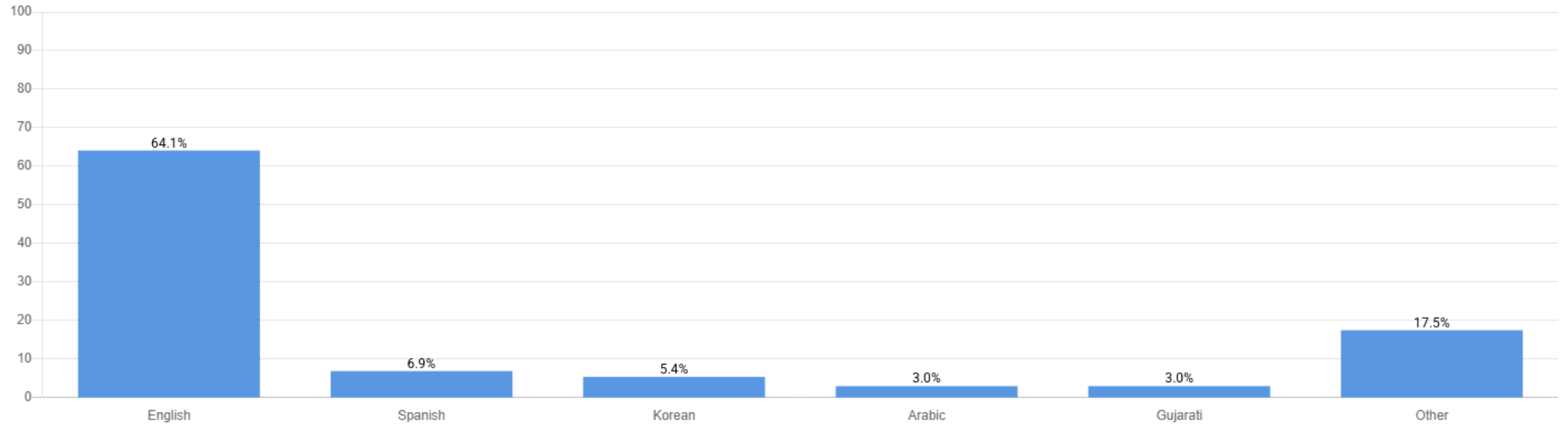

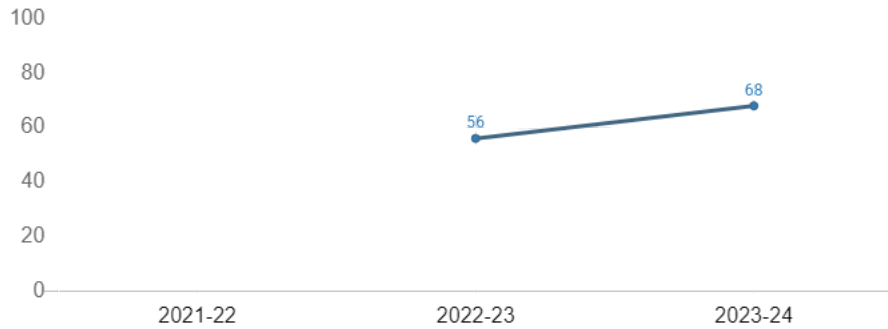

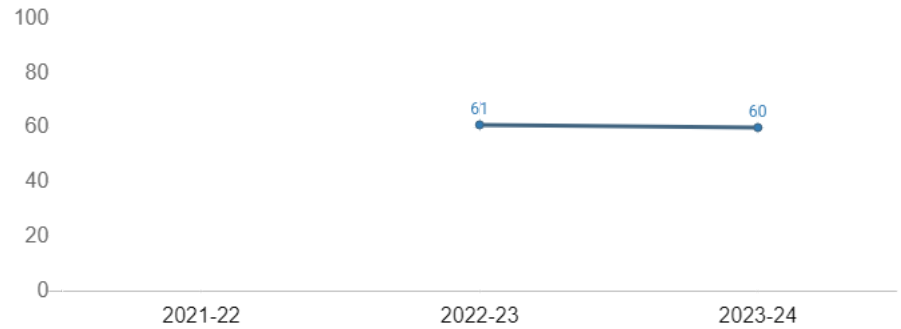

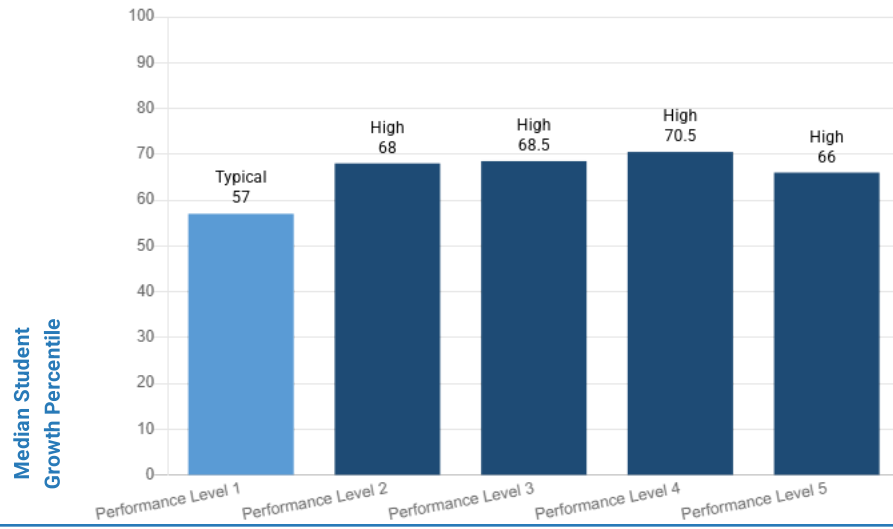

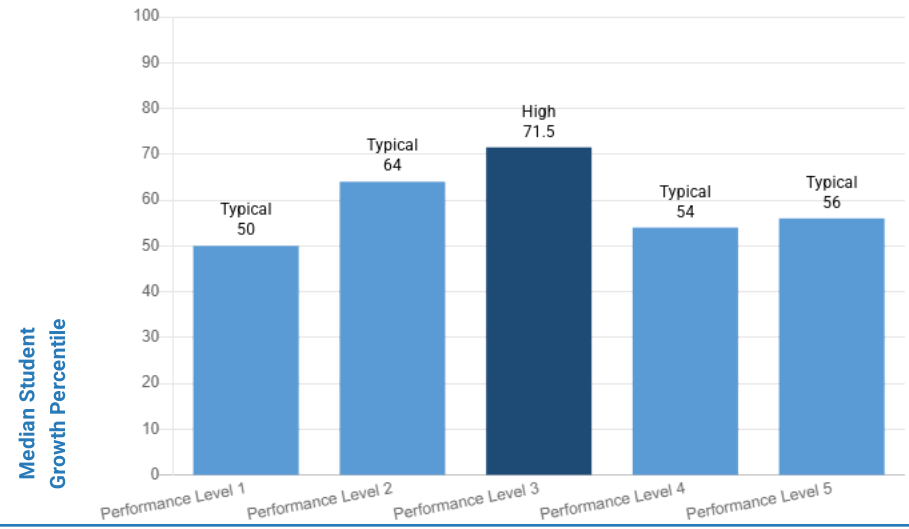

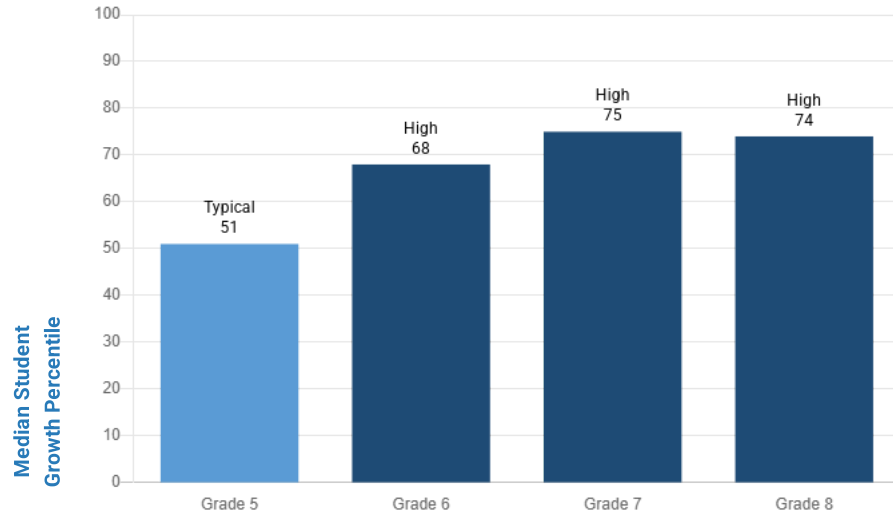

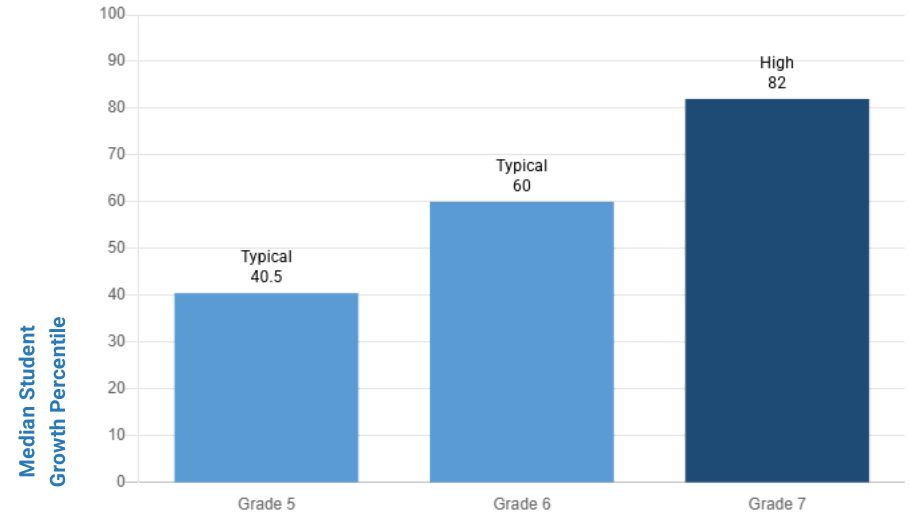

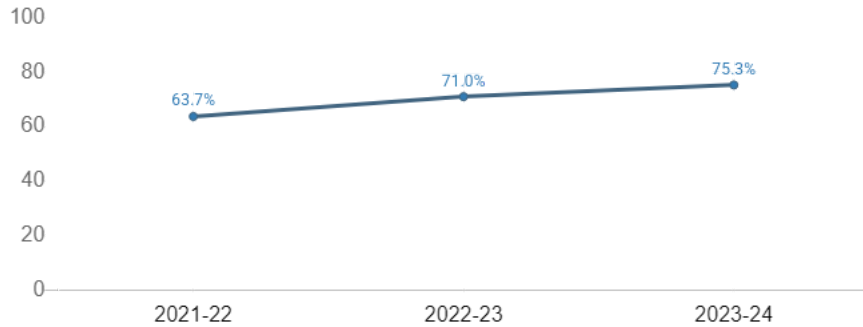

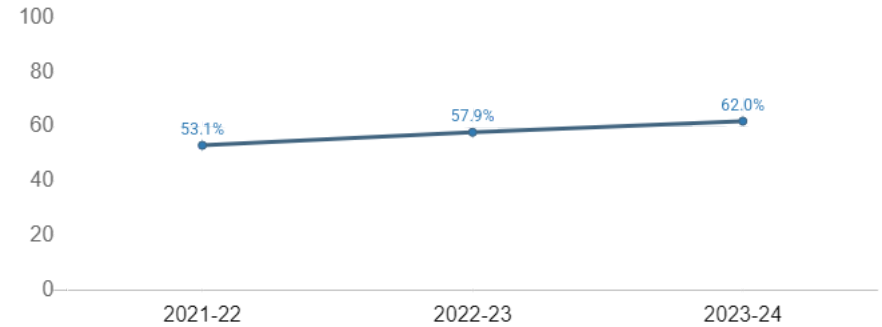
### English Language Arts and Mathematics Performance Trends

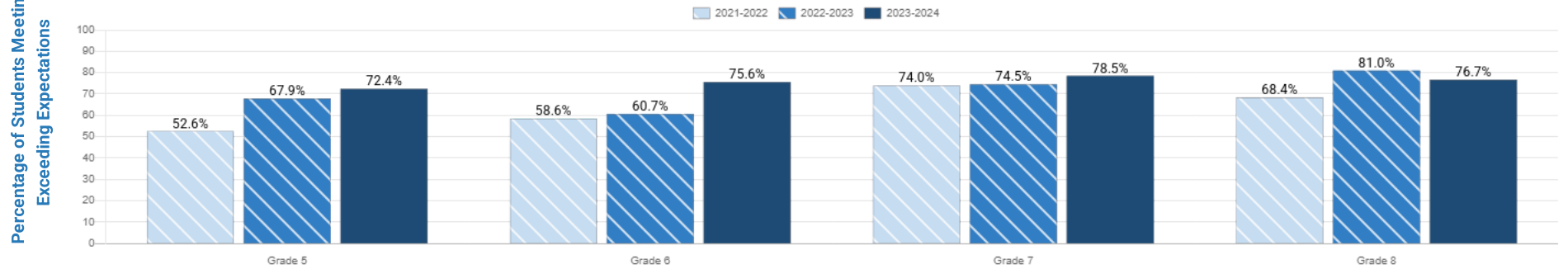

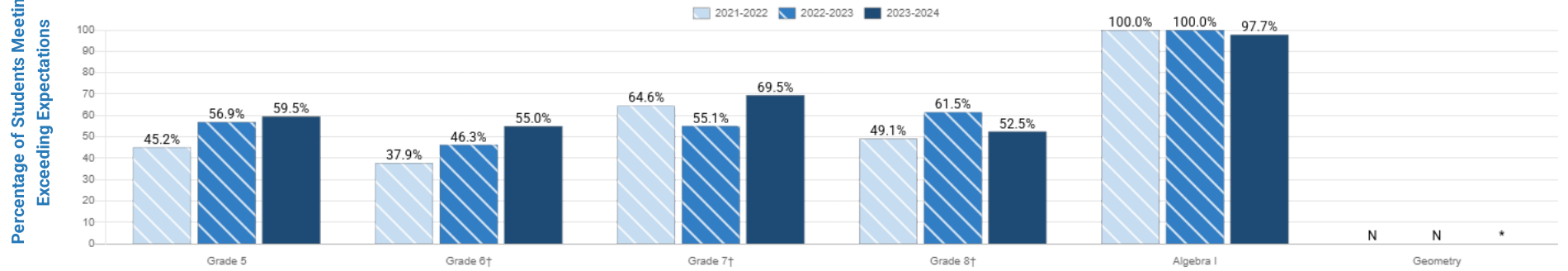

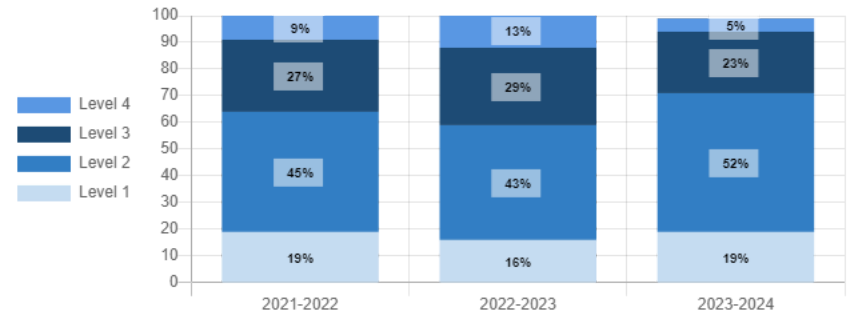

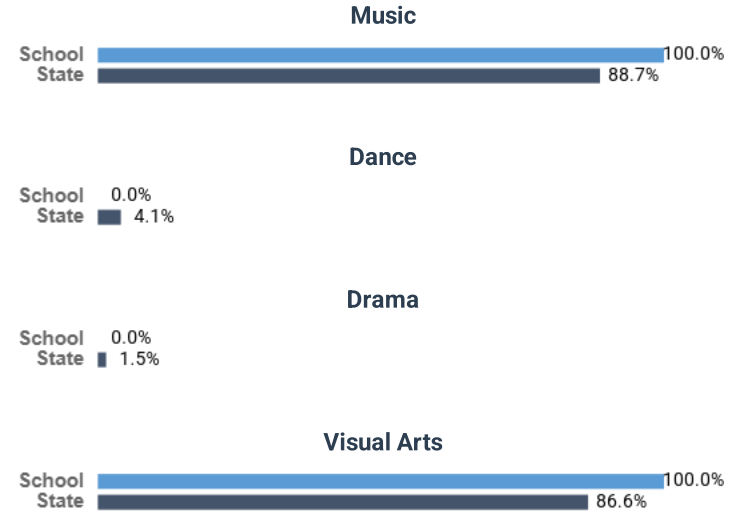

**Students enrolled in one or more classes by discipline:**



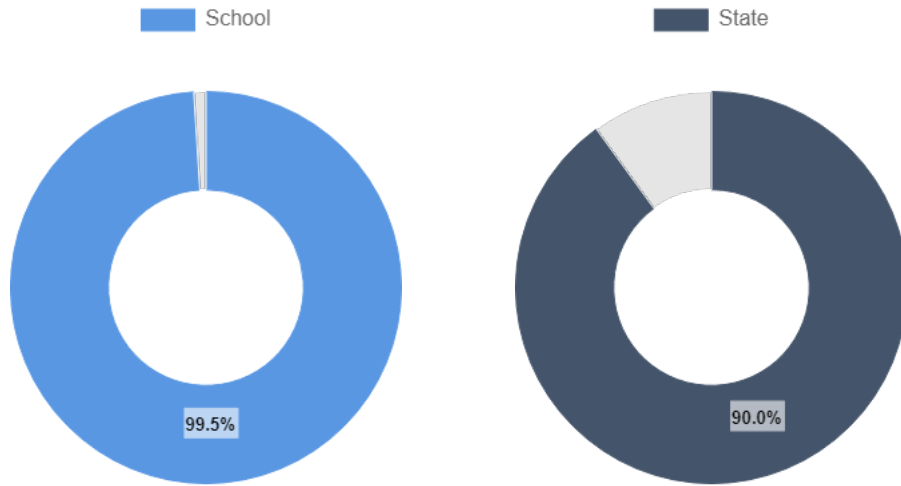

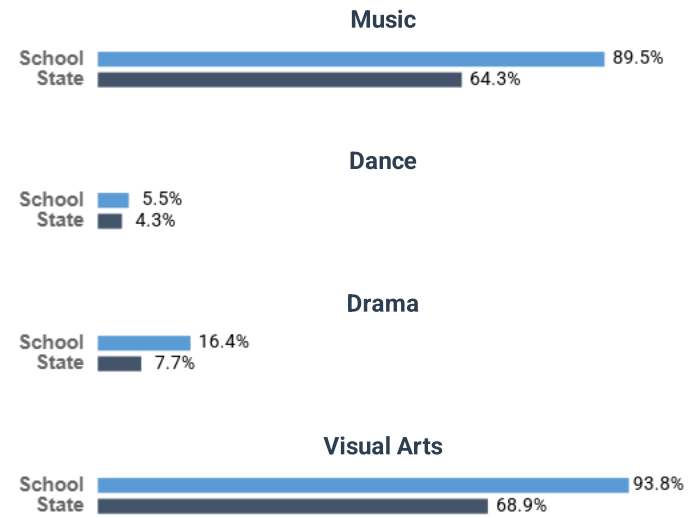

**Students enrolled in one or more classes by discipline:**



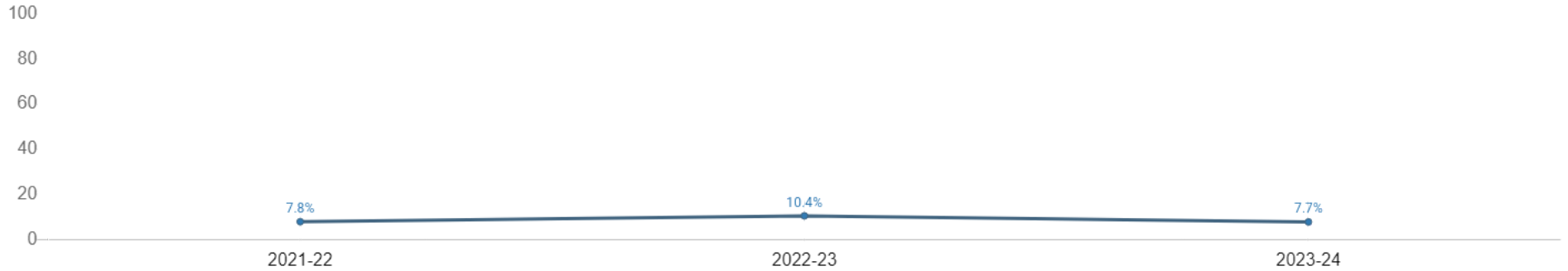

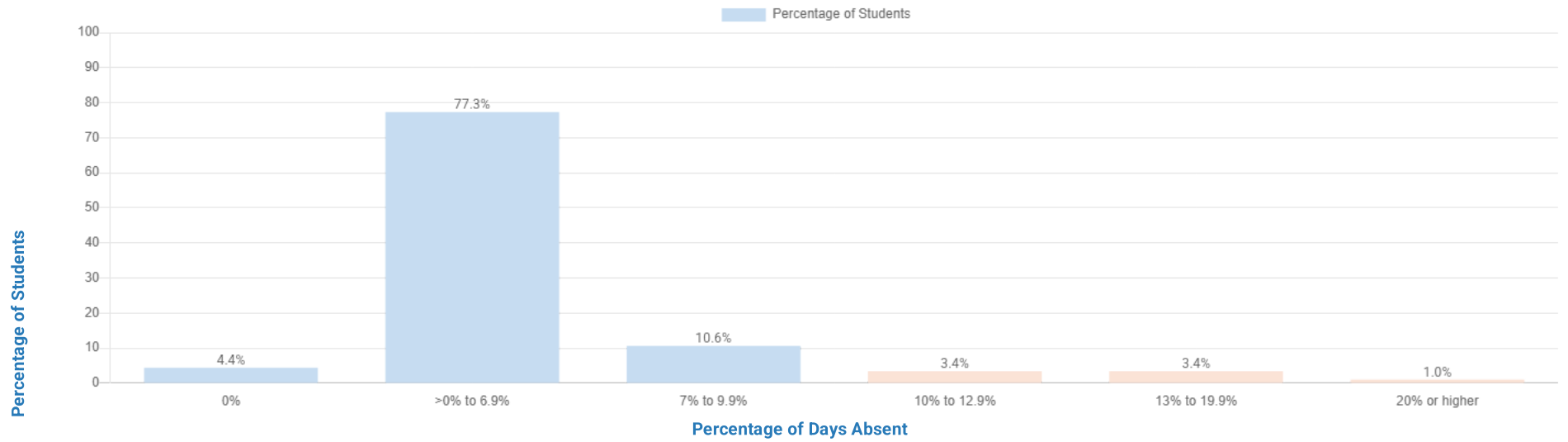

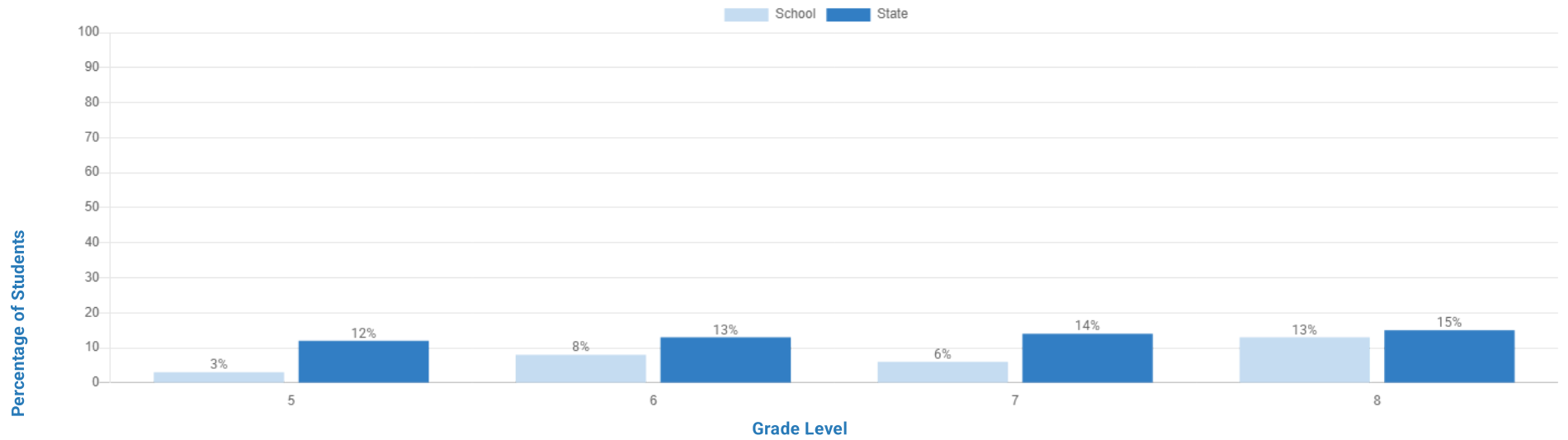

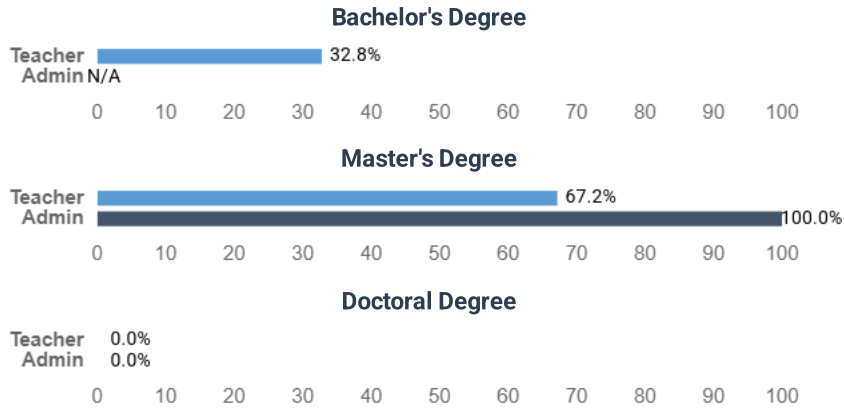

This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. East Brook offers a comprehensive program that meets the diverse needs of its students. Our academic program provides instruction in language arts, mathematics, science, and social studies in addition to world languages (Spanish, Italian, German), art, music, physical education, STEM, dance, theater, 21st Century Skills, enrichment, ESL (English as a Second Language), speech, and special Education (in-class support, resource room, self-contained Learning-Language Disabilities program, self-contained Multiple Disabled program). Special programs include Accelerated Math Program (6-8) and an Enrichment program. An Advisory program addresses the social and emotional challenges middle school students often face.



### Sports and Athletics:

Intramural Sports are offered as a part of our co-curricular club offerings. The sports activities enjoyed by students include, but are not limited to, basketball, indoor soccer, floor hockey, softball, and badminton. All intramural sports activities are co-ed.

### Before and After School Programs:

The Paramus School District has contracted Champions, an independent after school program for students in need of aftercare. East Brook students are supervised by Champions employees on school premises.



### Staff and Professional Learning:

All faculty participate in rigorous and differentiated professional development designed to meet the various needs of our staff, including an ongoing focus on best practices in literacy, technology, and the implementation of critical thinking take place in our classrooms. Teachers participate regularly in Professional Learning Communities and have opportunities to join ad hoc study groups on professional topics of interest. Furthermore, the assistance of a full-time Instructional Coach is available to all faculty. East Brook teaching staff contribute to curriculum development, implementation, and evaluation as well as the development of benchmark assessments across content areas.



### Student Supports and Services:

East Brook offers an ESL (English As A Second Language) program for students in grades 5-8. We provide comprehensive Special Education services for a wide range of learners, these include resource room, in-class support, and a self-contained program. We also offer literacy and math support for at-risk students in grades 5-8. Finally, East Brook offers all students pupil assistance after school. A multi-tiered system of supports is available to assist students with academic, behavior, and/or health difficulties.

### Student Health and Wellness:

Students engage in physical education which emphasizes practicing healthy behaviors and goal-setting. In addition to developing physical, social, and emotional wellness skills to promote lifelong health, students participate in regular physical activities including interval training, yoga, and cardio exercise as well as develop communication, problem-solving, and conflict resolution skills through playing soccer, basketball, team handball, floor hockey, volleyball, badminton, and pickle ball. The health curriculum focuses on nutrition and wellness, character building, drug education and prevention, the five components of physical fitness, understanding heart-rate, eating disorders, building self-esteem, drug use and misuse, the reproductive system, and communicable and non-communicable diseases.



### Parent and Community Involvement:

East Brook has a very active PTA with various committees sponsoring many programs and activities, in addition to supporting the activities of the 8th grade graduating class. The PTA sponsors events for the student body as well as events for the entire family. Other PTA contributions include providing student assemblies, organizing social activities for students, and refurbishing the courtyard and front entranceway with plants and benches.



### Facilities:

East Brook Middle School is a spacious building with two gymnasiums, an auditorium, cafeteria, and media center. Recent renovations include the remodeling of STEM and 21st Century Digital Skills classrooms, construction on the main office and the updating of the student bathroom facilities, as well as the creation of a new entrance vestibule with increased security has been added to ensure the safety of our students and staff. The entirety of the building has been updated with air conditioning. The common space was recently furnished with high top tables and chairs to provide an inviting meeting space for students. Updates to the outdoor spaces include new basketball courts, a recently refinished tennis court, a turf field, and a courtyard with a new pond.

### School Safety:

School safety is promoted at East Brook Middle School through several measures including armed security guards, video surveillance, a visitor management system, keycard building access for authorized staff only, and the practice of regular safety and security drills. East Brook also has a School Crisis Response Team that meets regularly to discuss these and other preventative measures to ensure the continued safety of our staff and students. The committee also reviews suggestions shared by various first-responder organizations during debrief meetings after the completion of safety and security drills as well as any information provided by the district's security team throughout the school year. Additionally, the School Safety Committee meets to discuss HIB and suspension data and student discipline trends to develop actions plans and evaluate programming to support a positive school climate.



### Technology and STEM:

East Brook students have moved to a one-to-one technology initiative providing students in grades 5-8 with Chromebooks. In addition, all students are required to take a STEM class one quarter semester a year to expand their knowledge of science, technology, engineering, and math.
