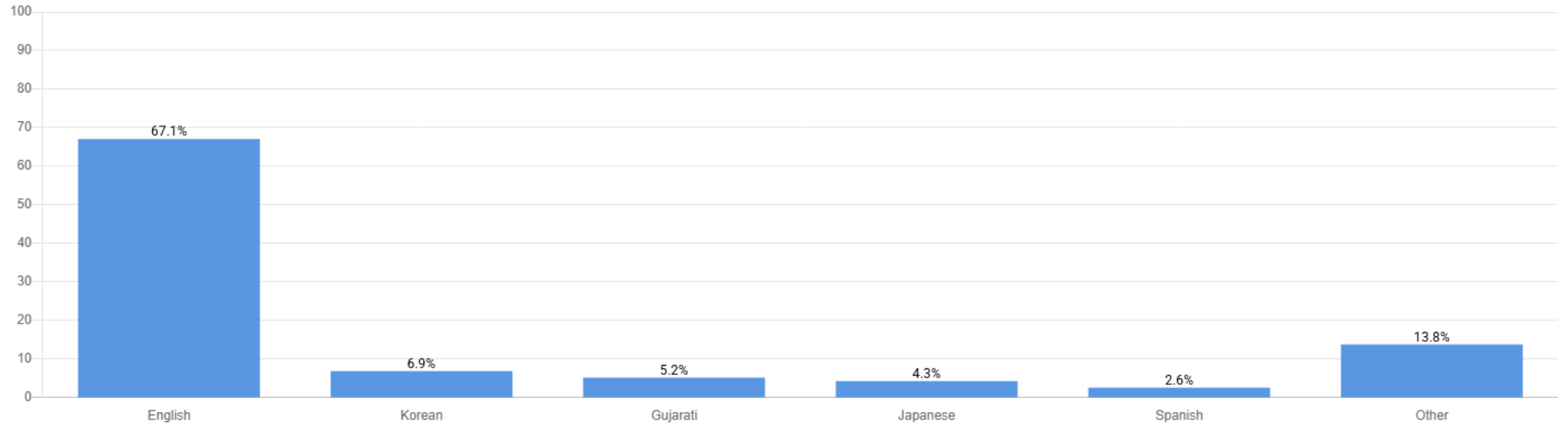

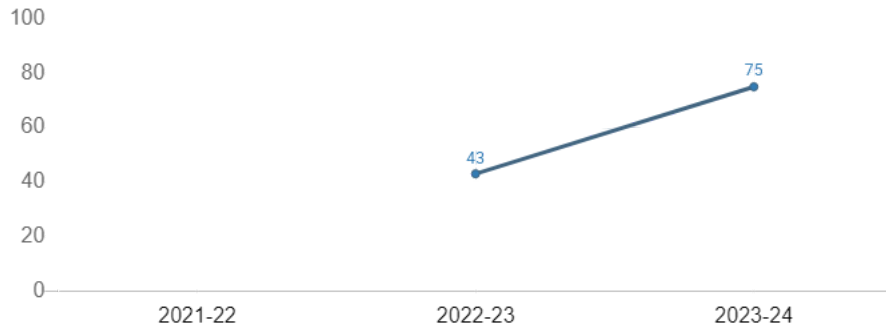

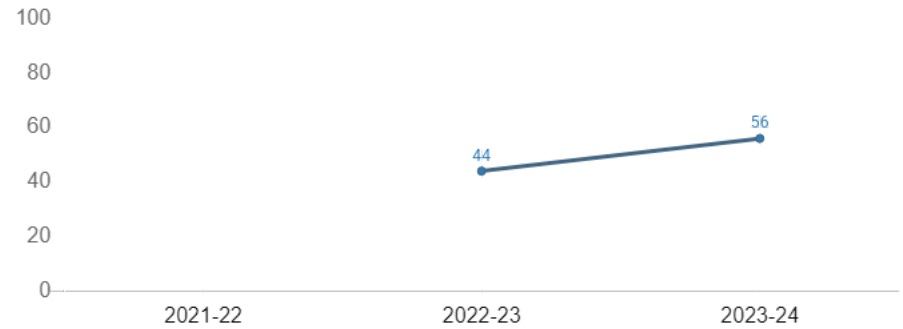

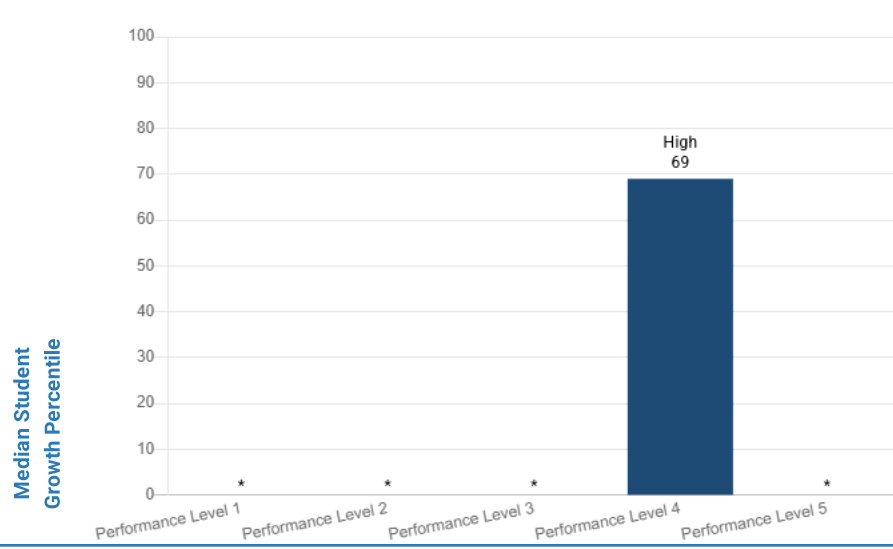

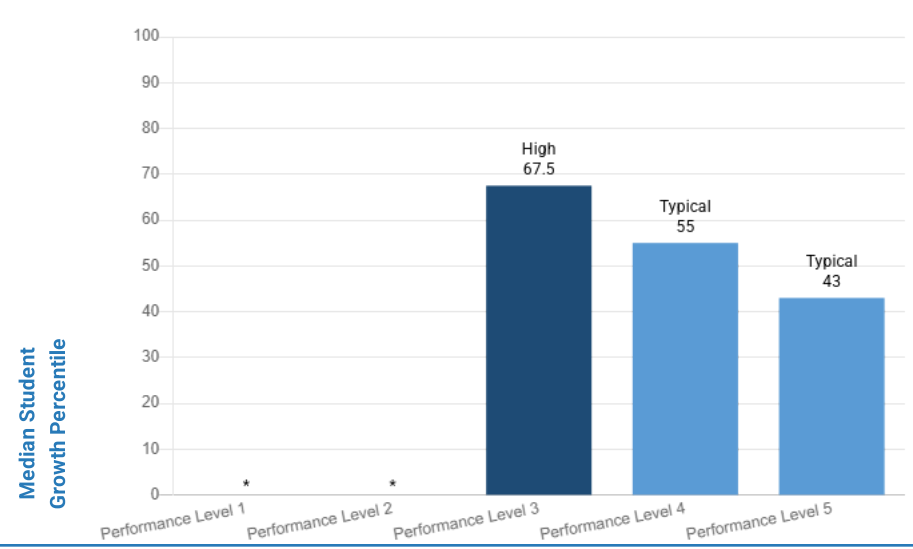

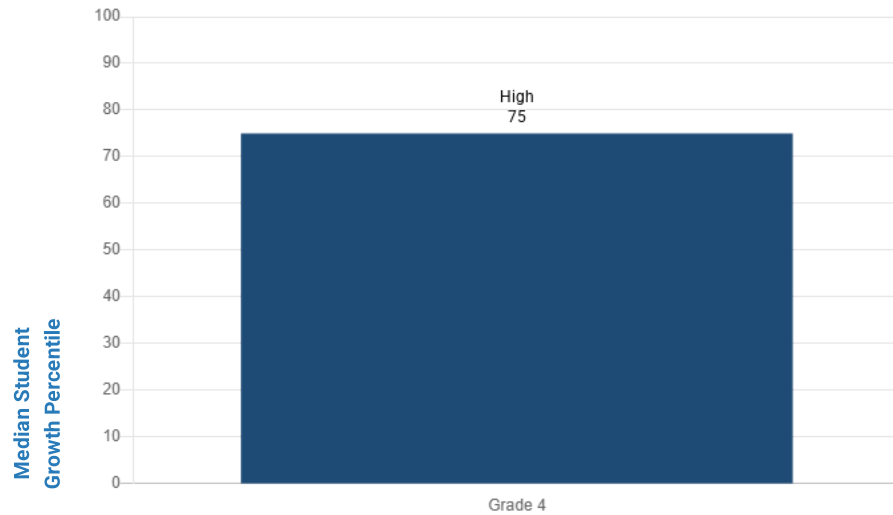

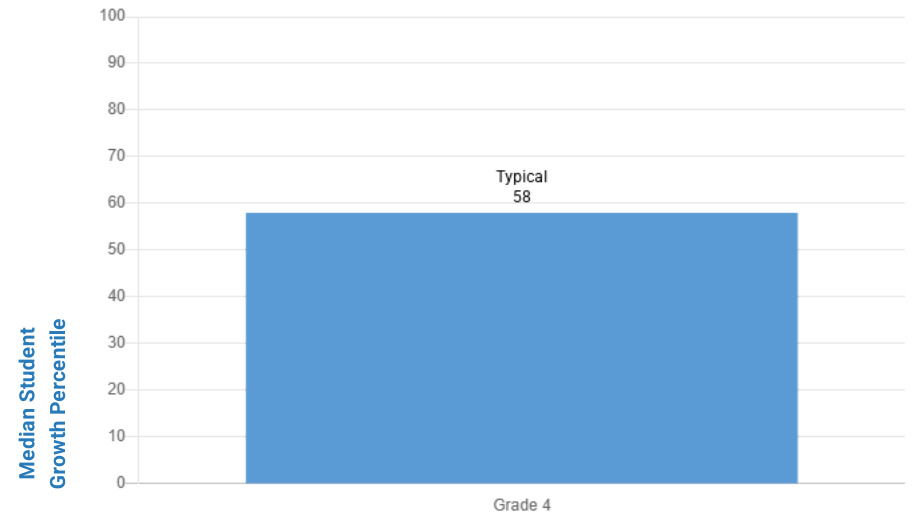

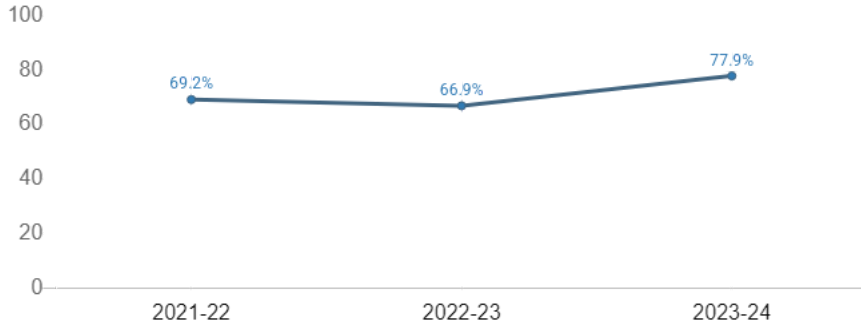

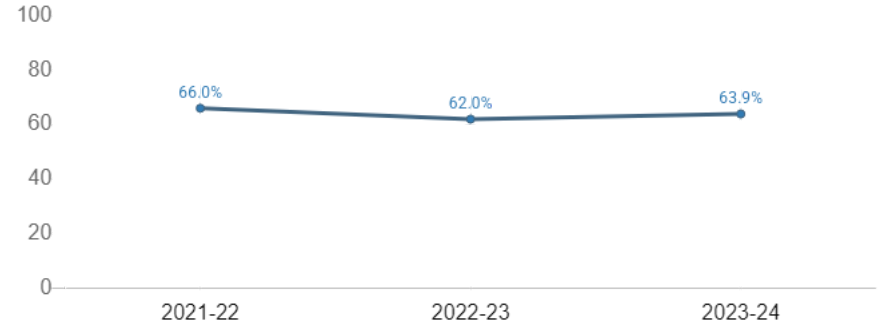
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

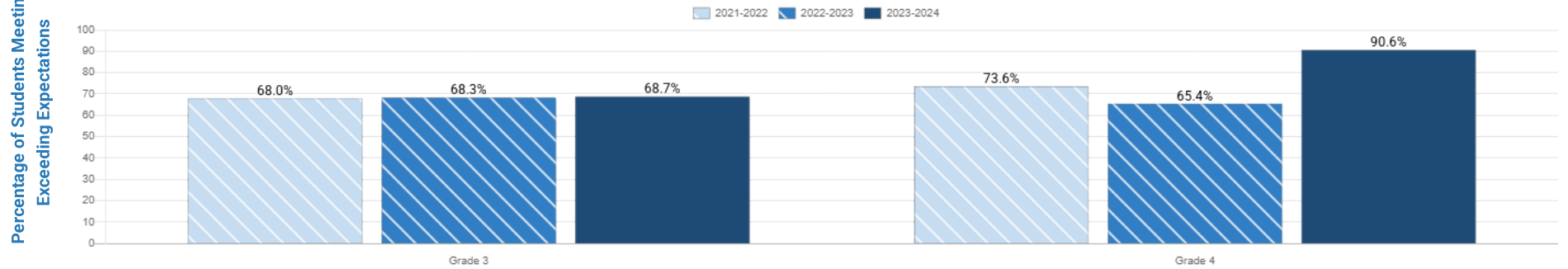

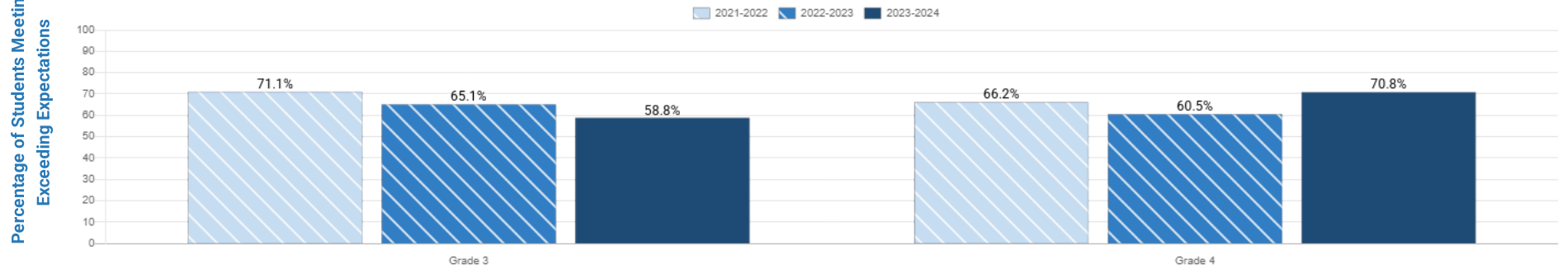

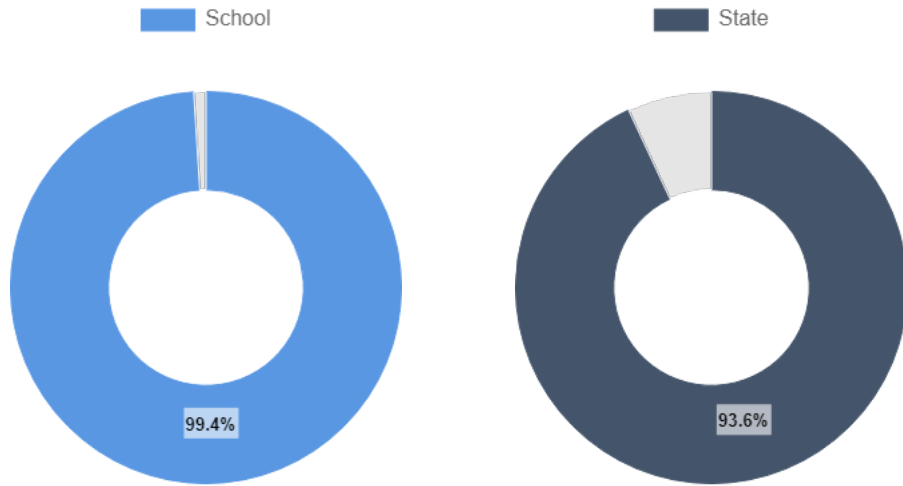

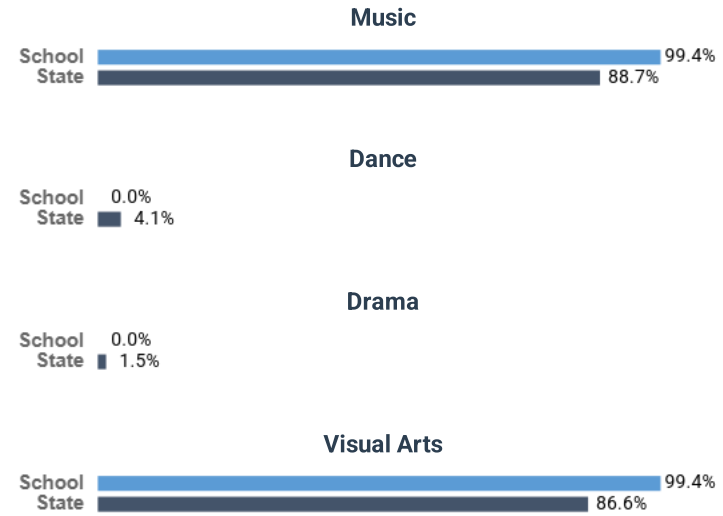

**Students enrolled in one or more classes by discipline:**



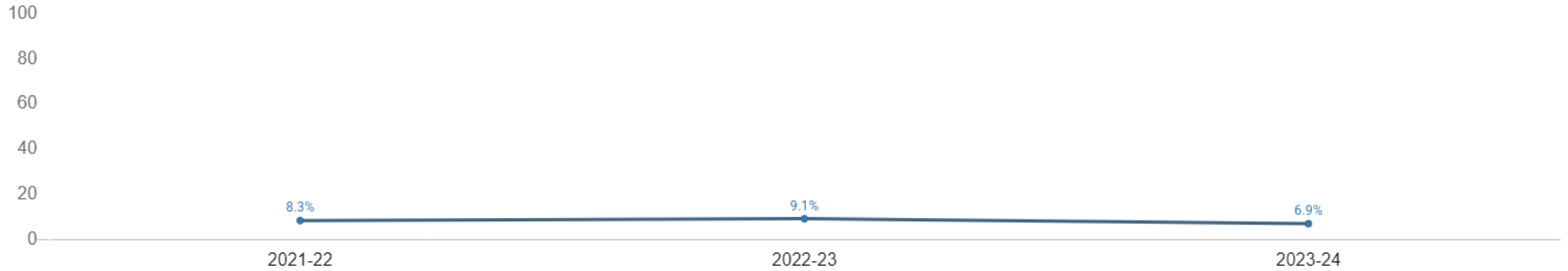

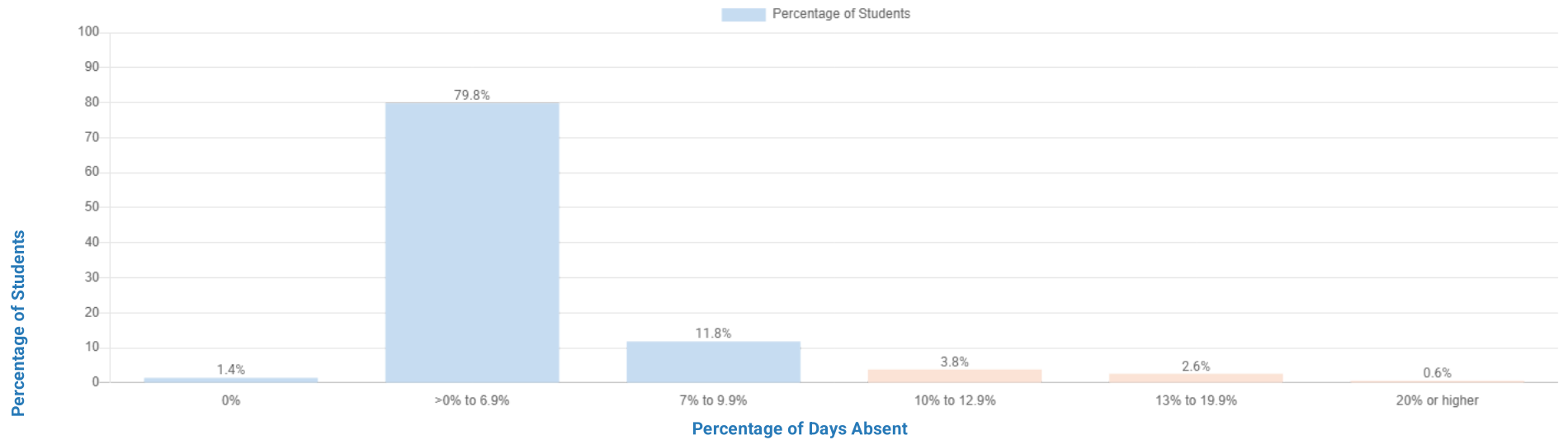

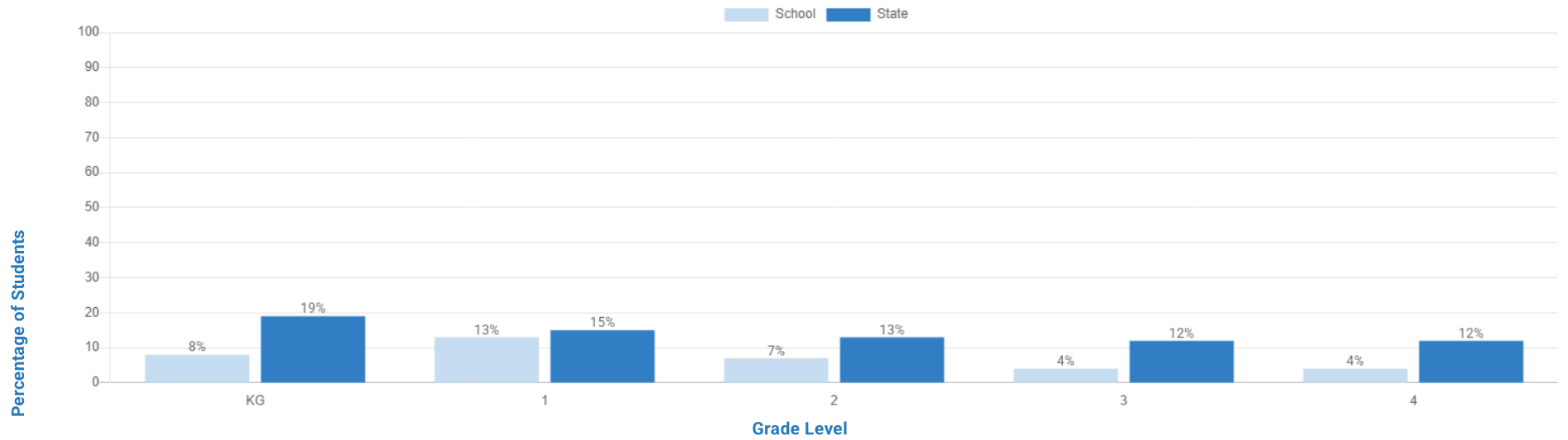

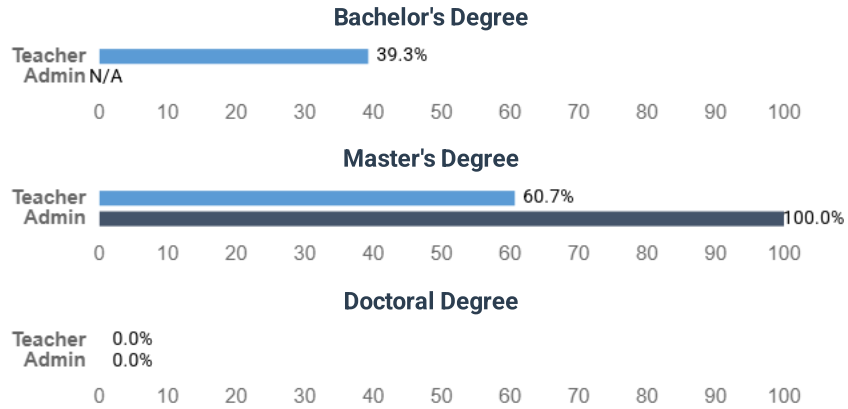

### Technology and STEM:

Ridge Ranch School integrates technology into daily instruction. All classrooms are equipped with digital soundfield systems (teacher amplification) and Smart Board technology. All students have access to one to one Chrome books. The school is also outfitted with a maker Space designed to support STEM initiatives.
