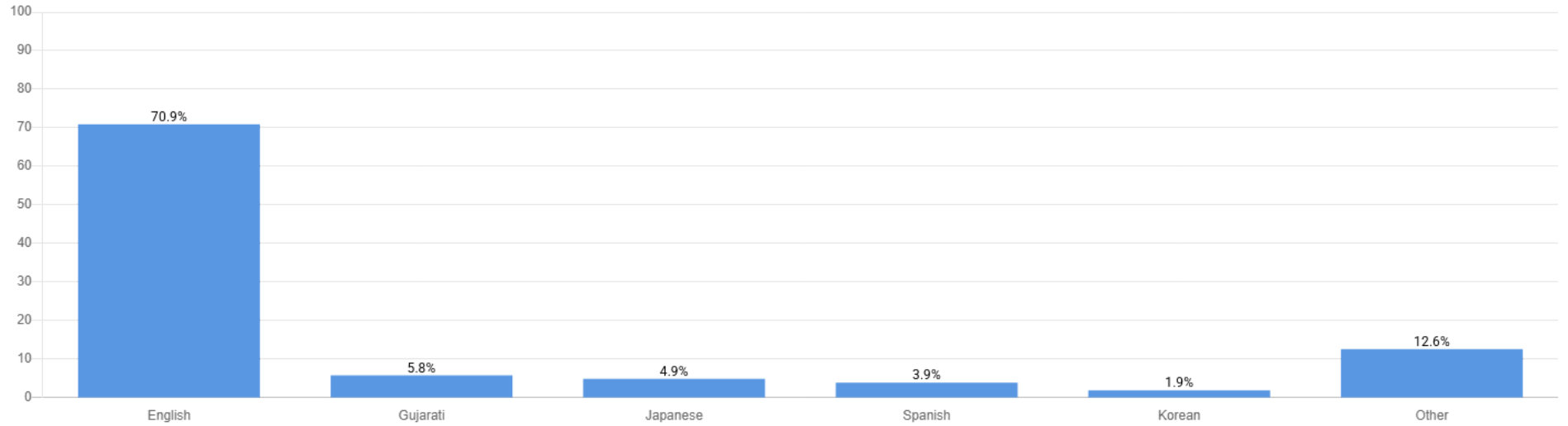

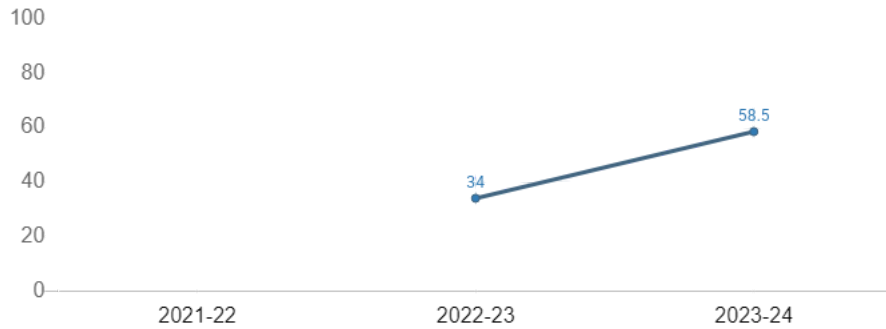

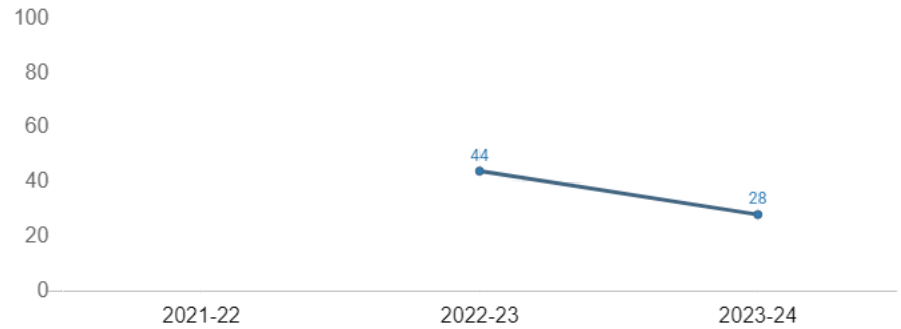

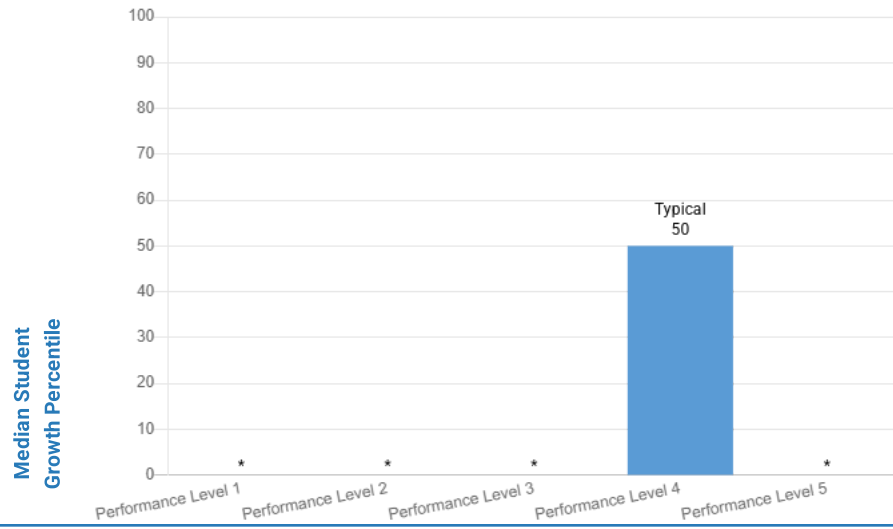

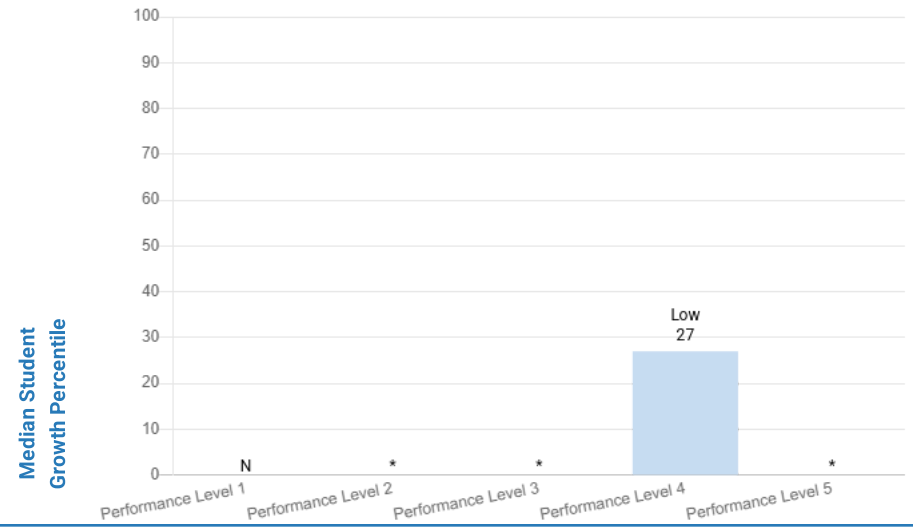

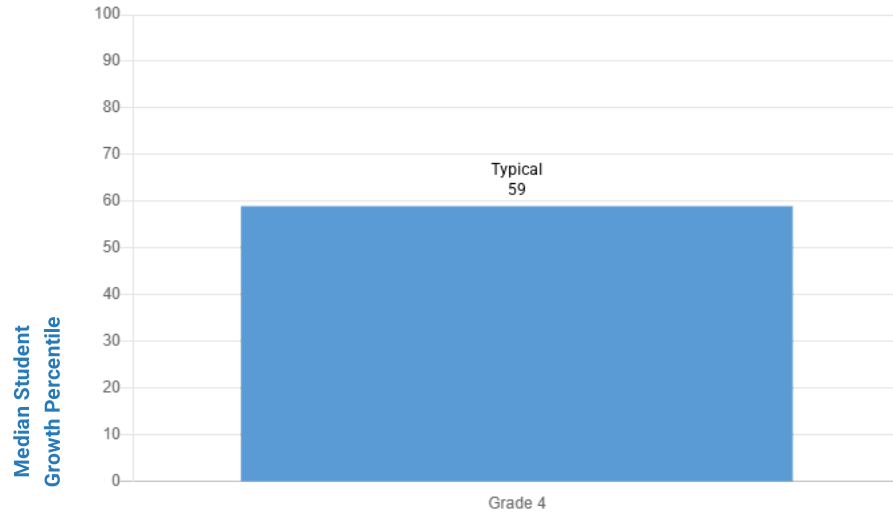

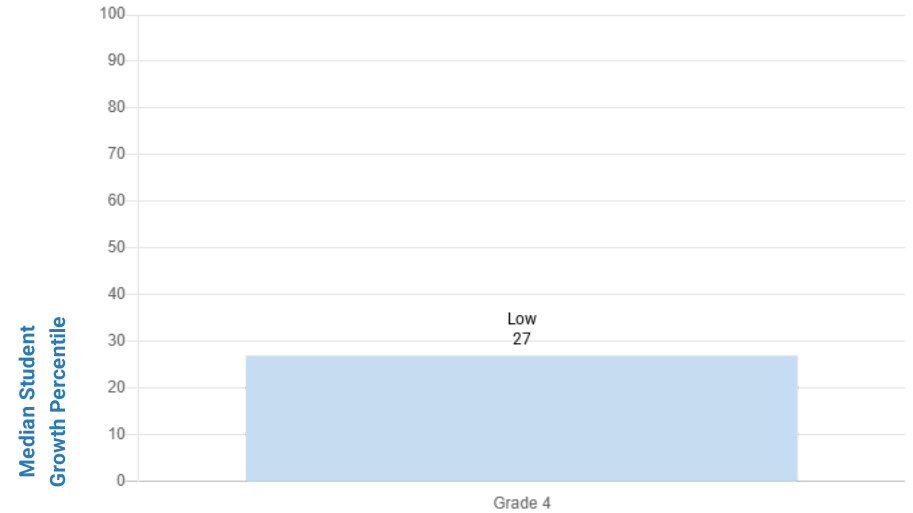

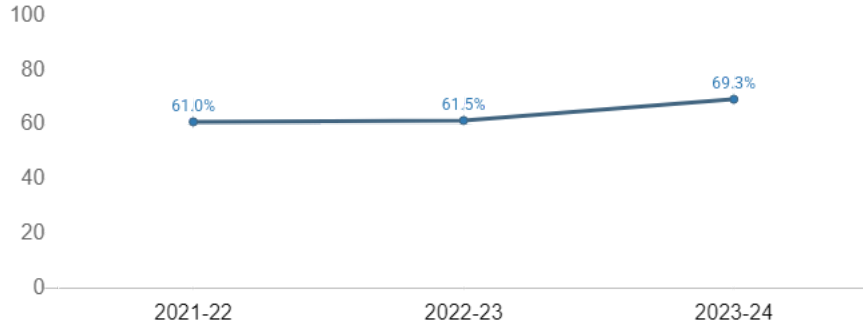

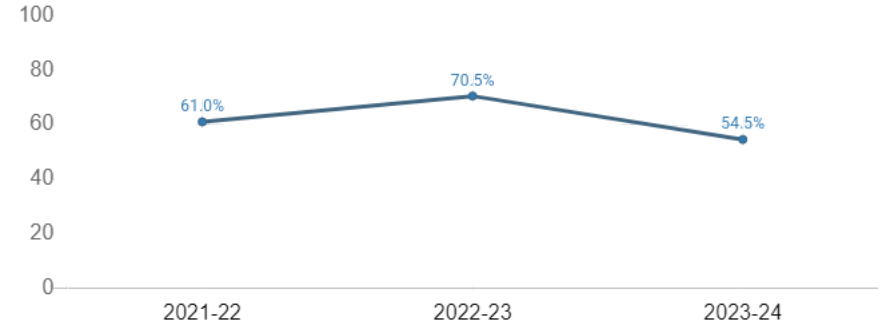
### English Language Arts and Mathematics Performance Trends

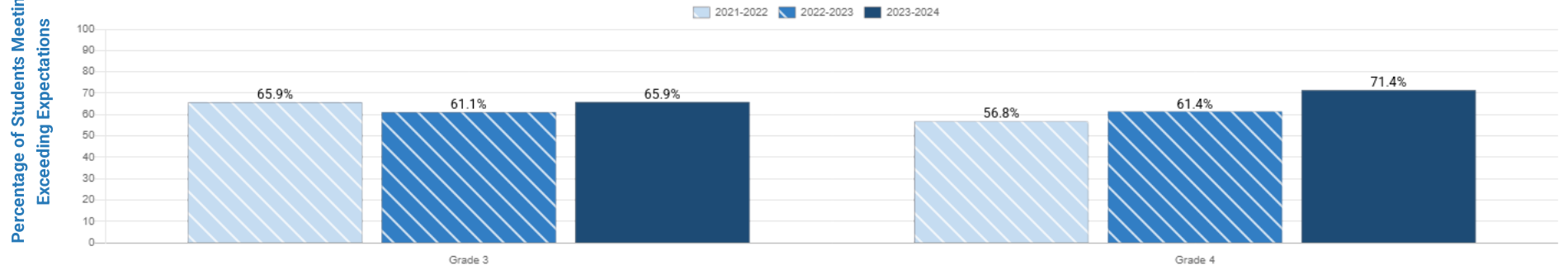

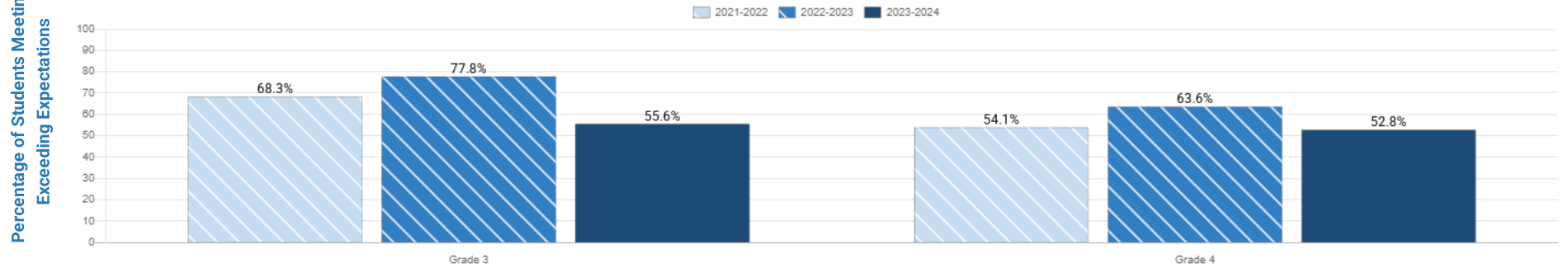

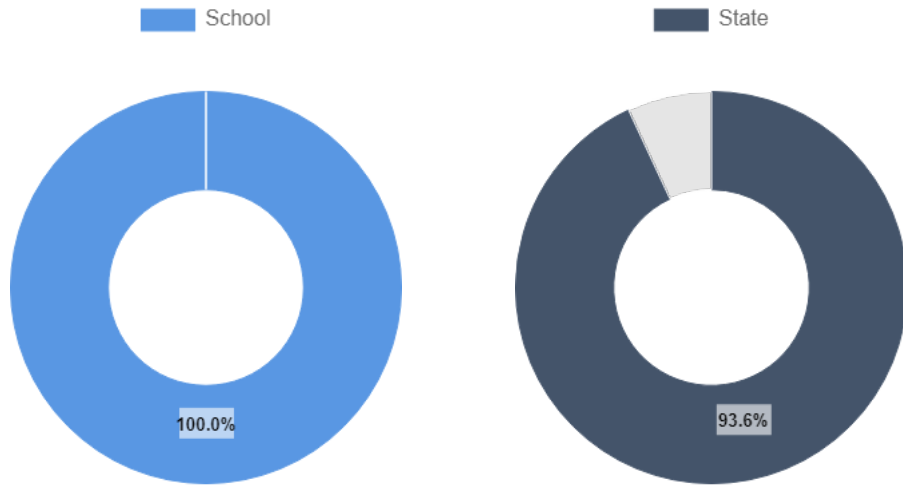

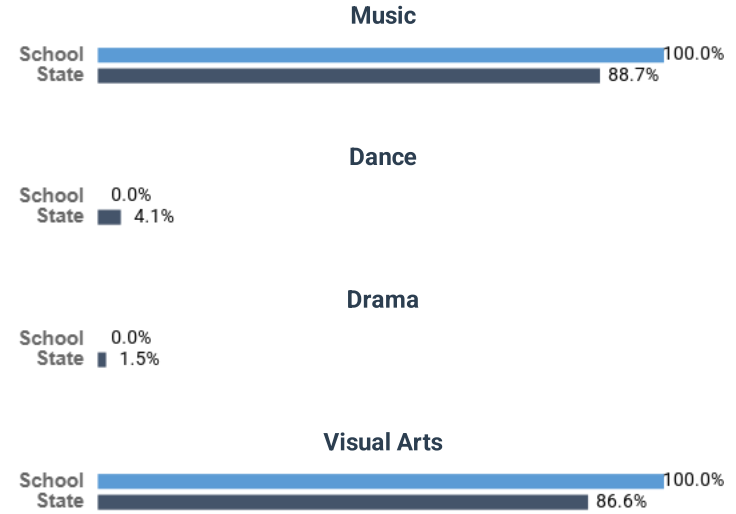

**Students enrolled in one or more classes by discipline:**



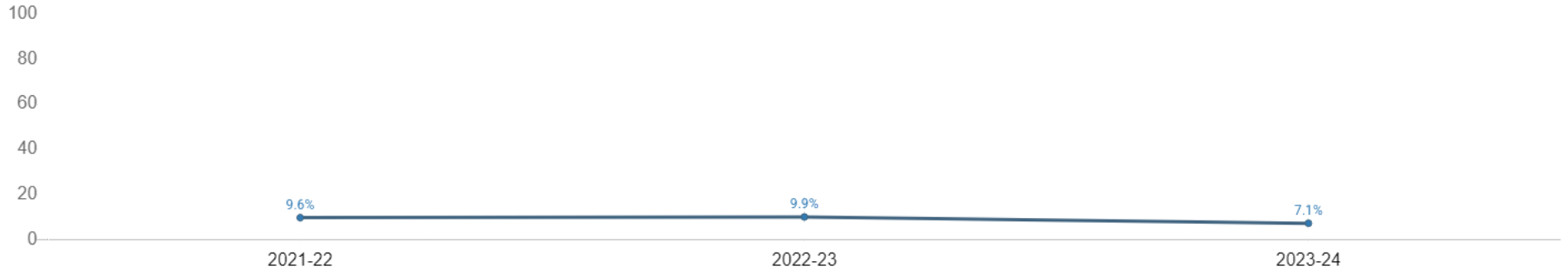

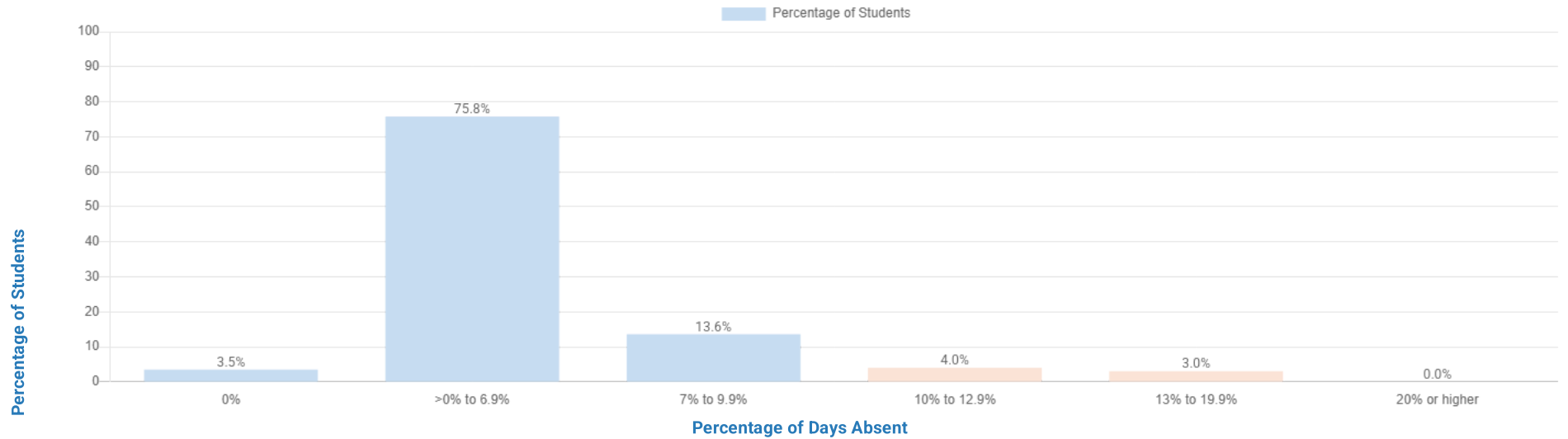

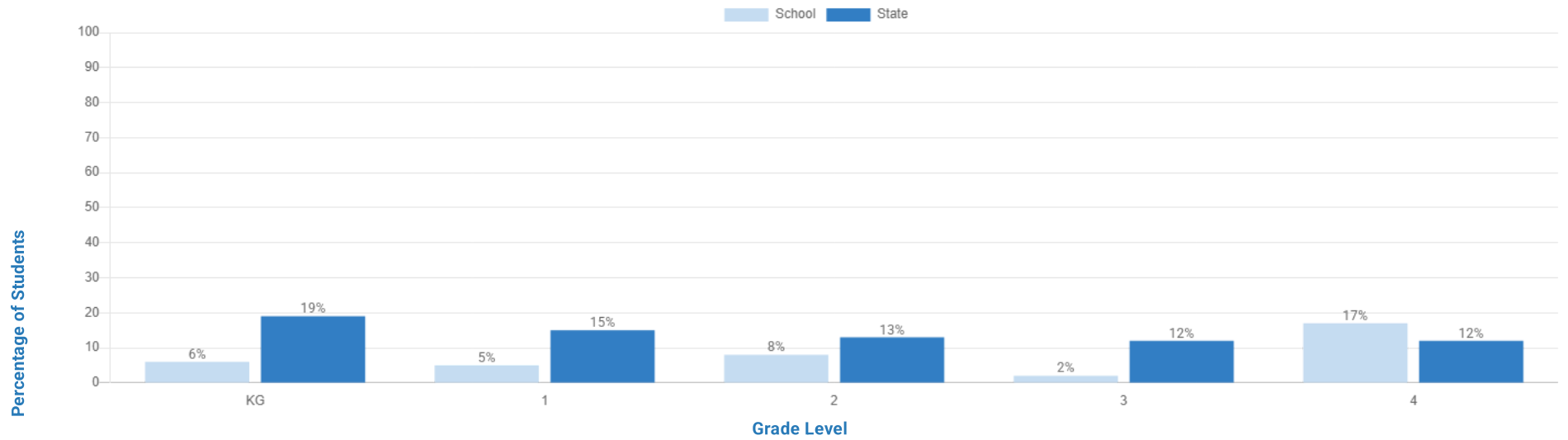

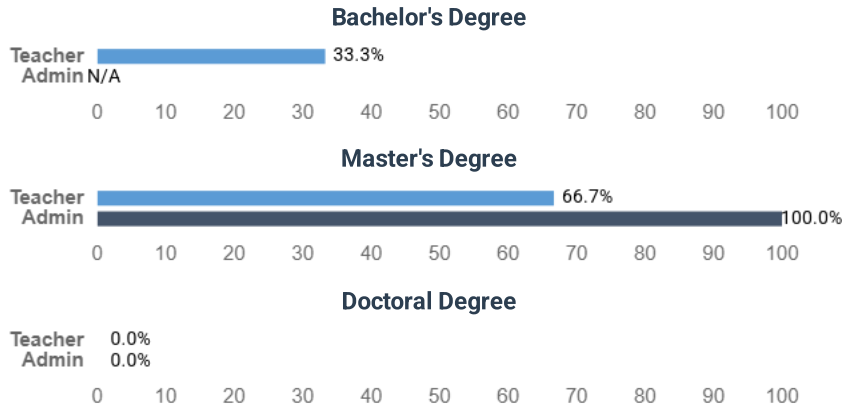

Special Education and Bilingual teachers are generally assigned to a subject area and also either special education or bilingual, so those teachers will be counted in multiple subject areas.

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). ### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. ### Facilities:

Stony Lane School is a beautiful ADA-compliant facility with 21st century classrooms. Each classroom is supplied with SMARTBoards, reading nooks, student workspace, and technology hubs. Other features include a media center, computer lab, and a new playground for active learners.



### School Safety:

Stony Lane School takes many security measures to ensure the safety of the students and staff. Safety measures include locked entrances with swipe card entry; a full time armed security guard, video surveillance inside and outside of the building; a visitor management system to screen, that requires photo id for all visitors; and monthly security drills.



### Technology and STEM:

Stony Lane School integrates technology into daily instruction. All classrooms are equipped with digital soundfield systems (teacher amplification) and Promethean Board technology. The students in all grades have access to one-to-one Chromebooks, and use Google Classroom technology to support distance learning.
