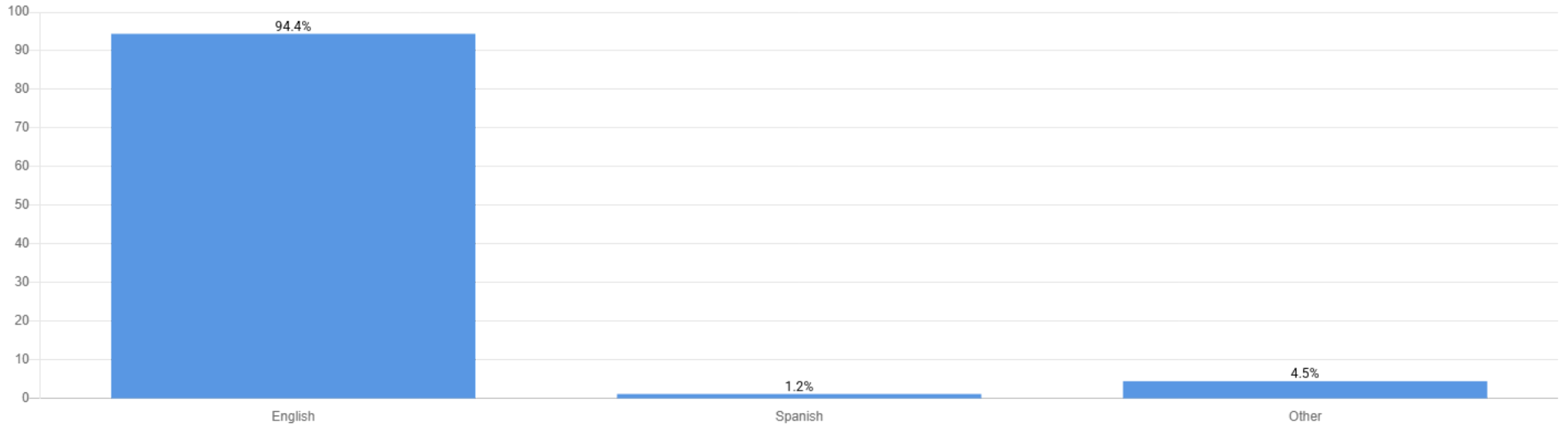

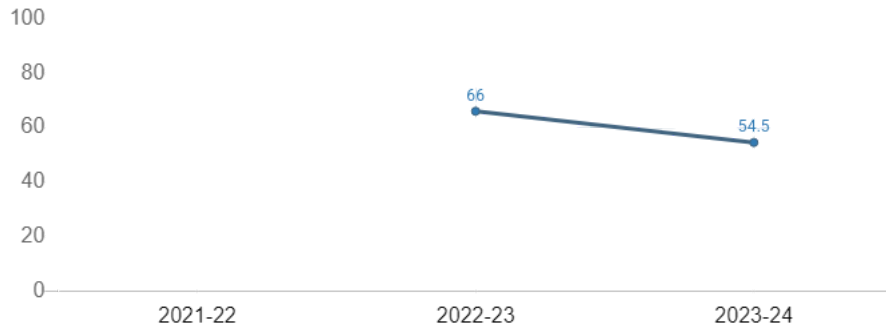

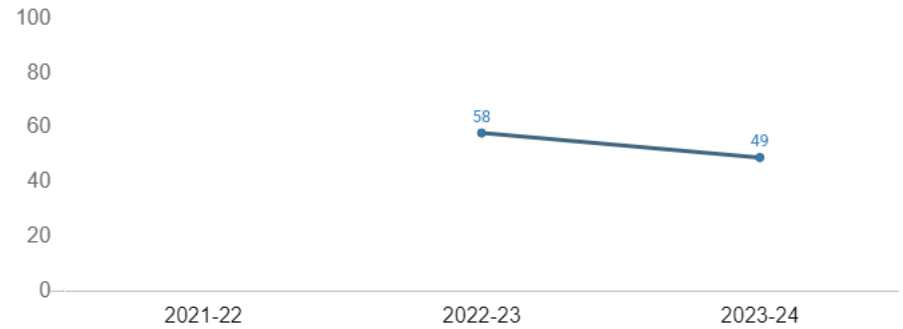

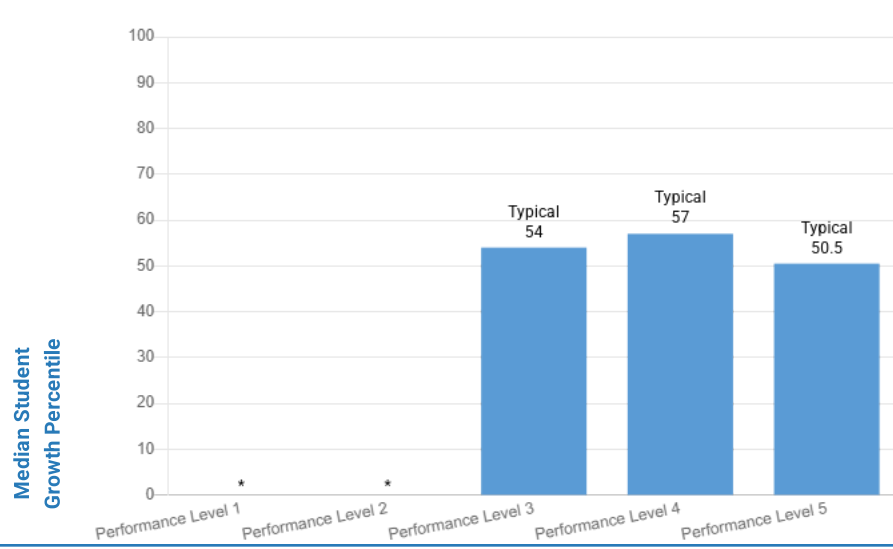

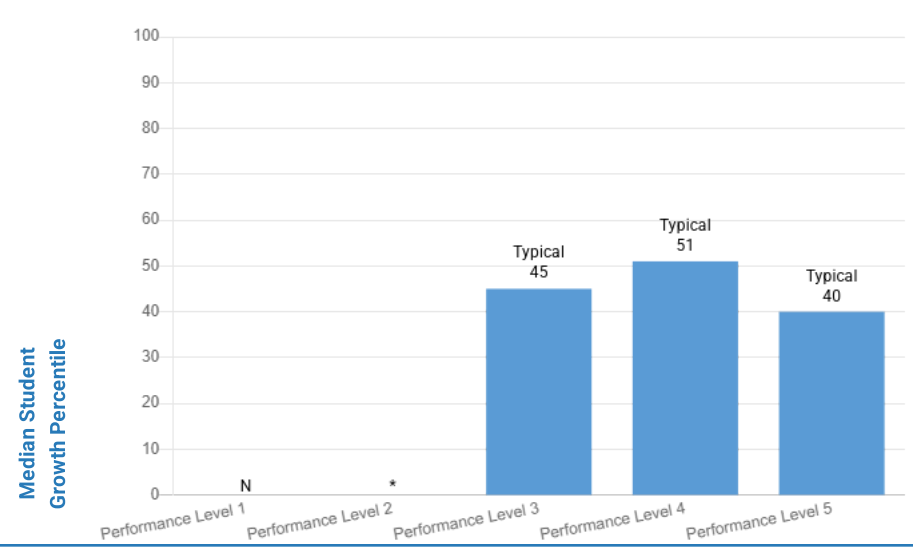

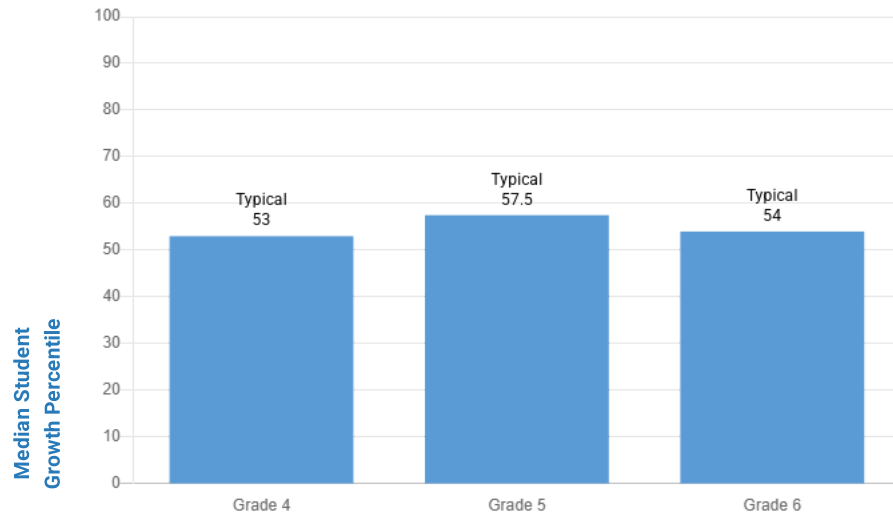

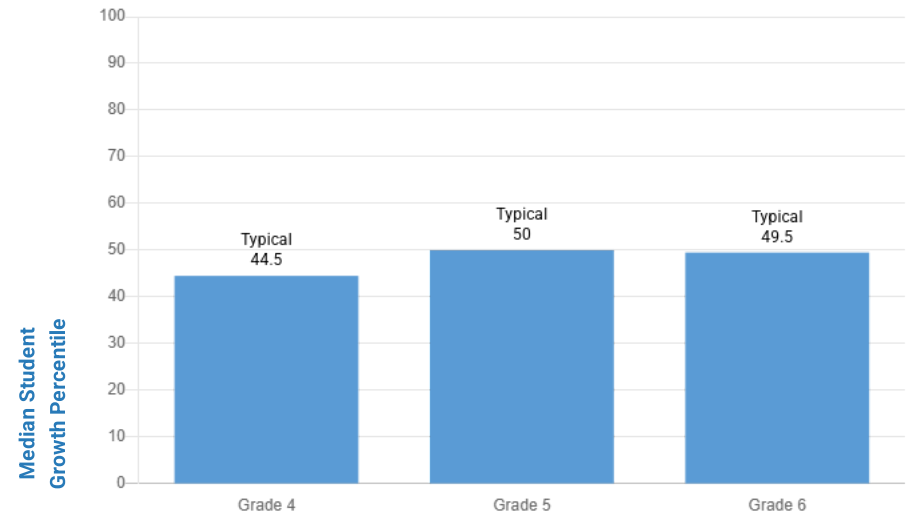

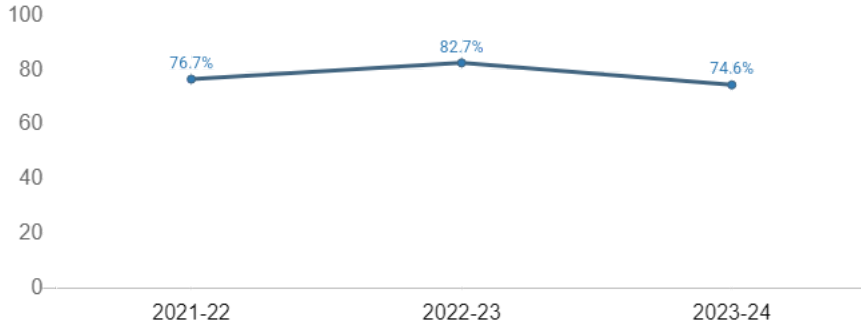

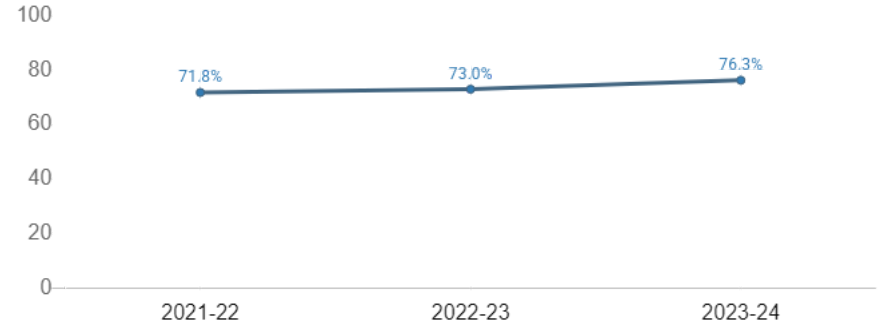
### English Language Arts and Mathematics Performance Trends

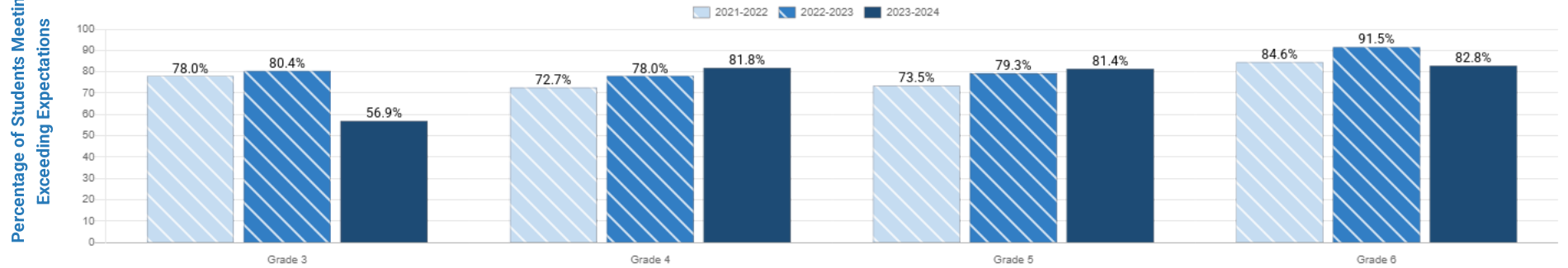

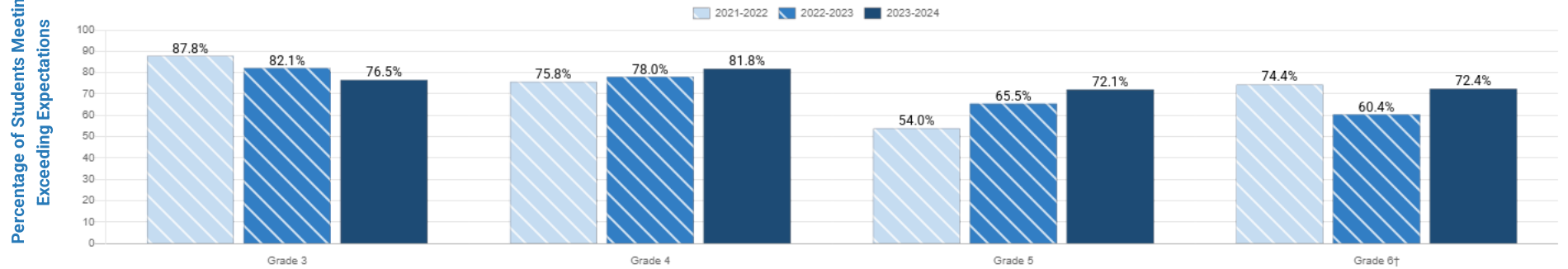

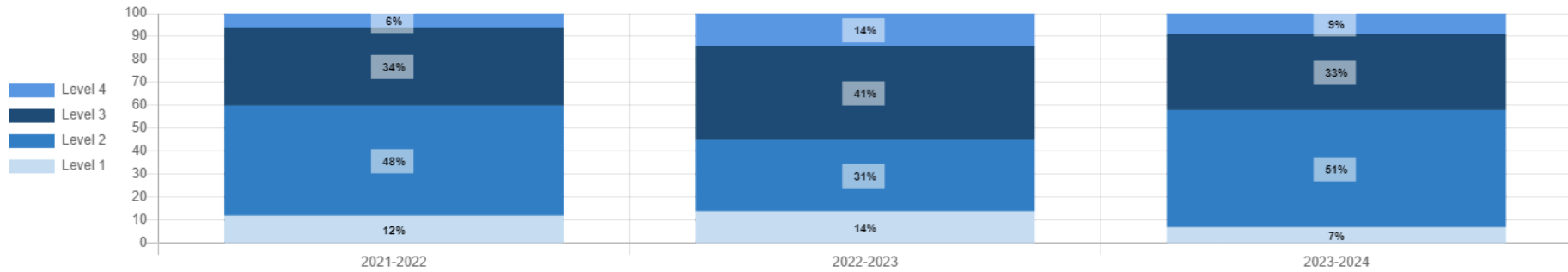

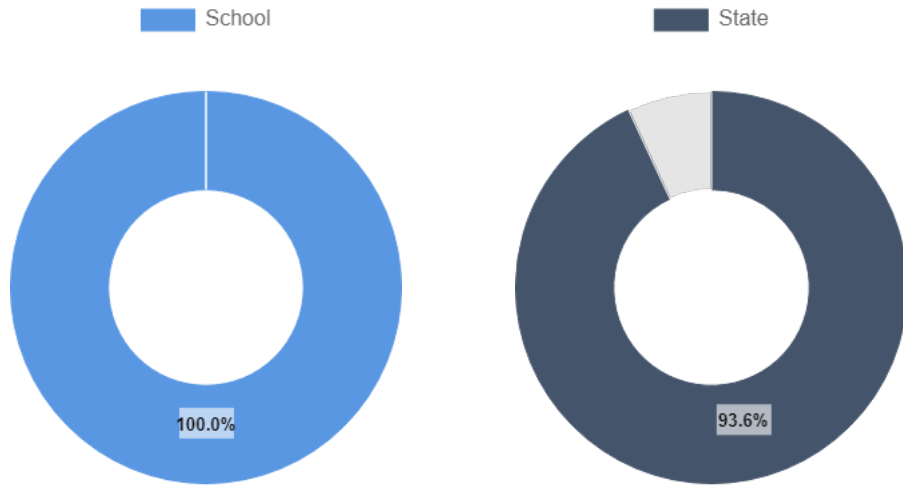

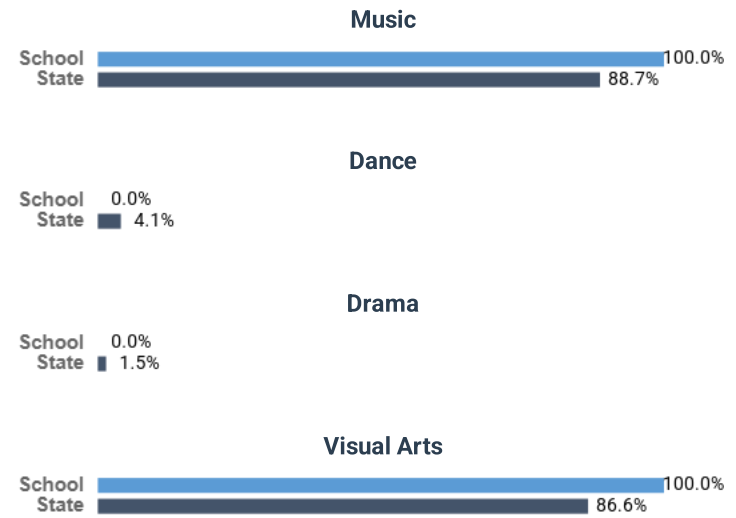

**Students enrolled in one or more classes by discipline:**



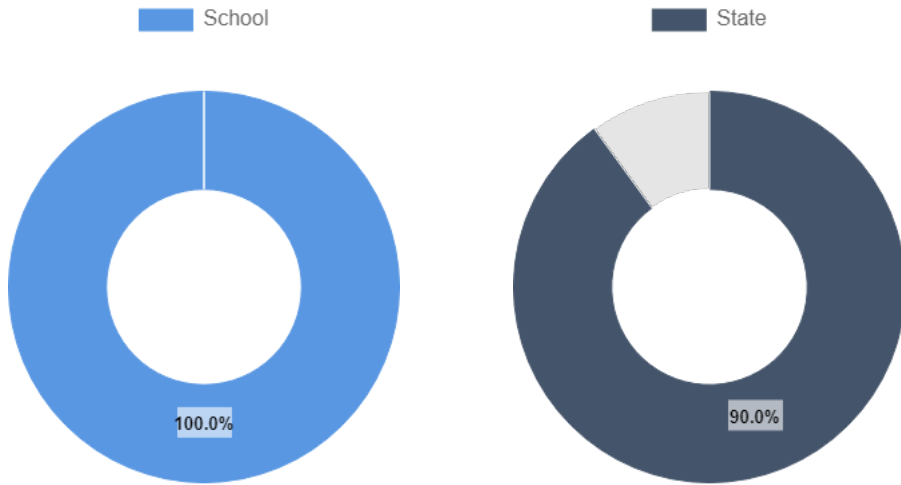

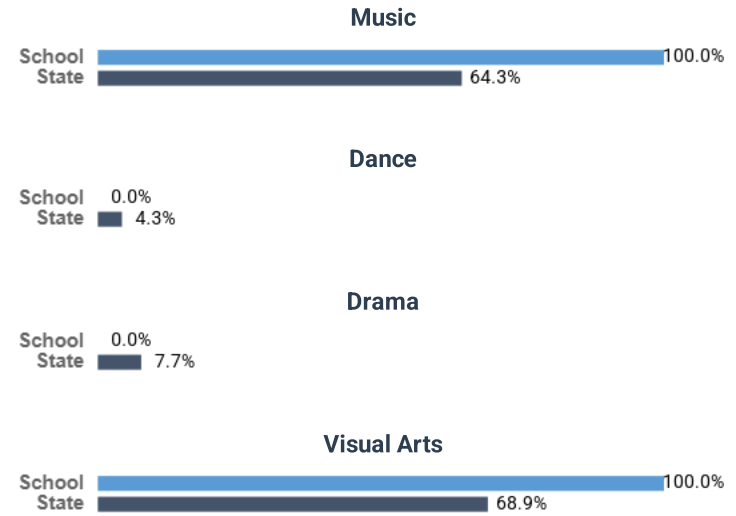

**Students enrolled in one or more classes by discipline:**



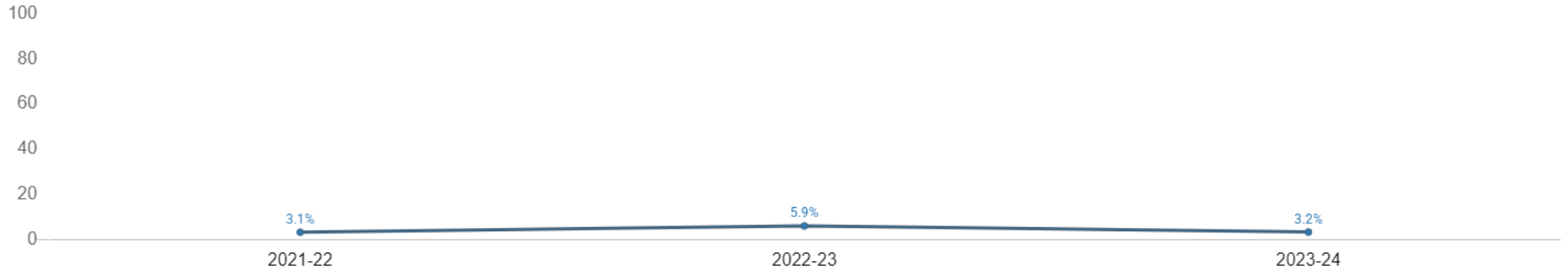

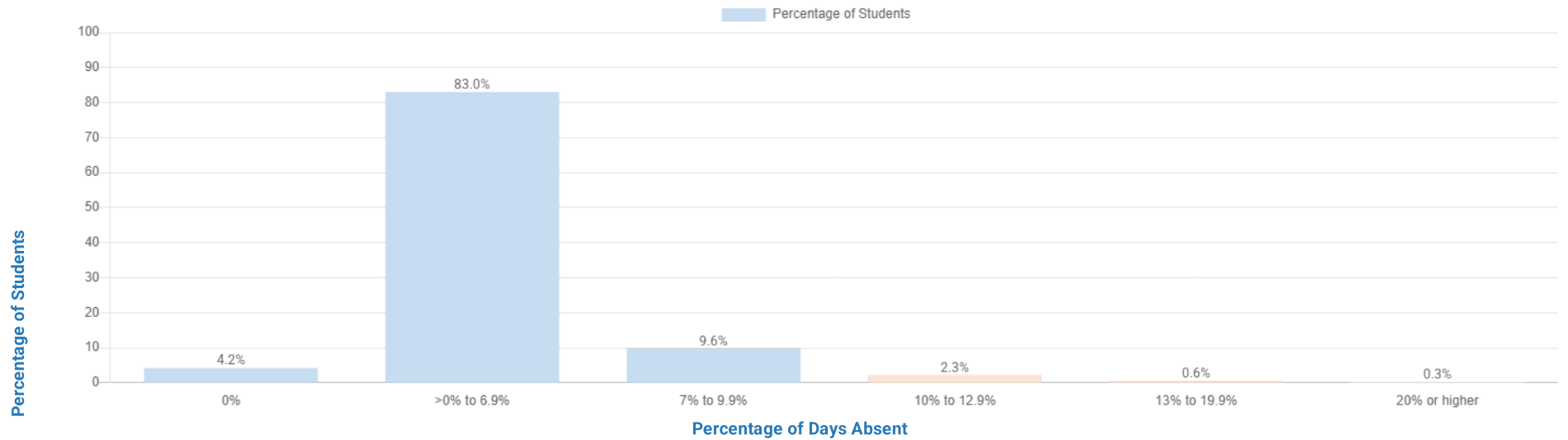

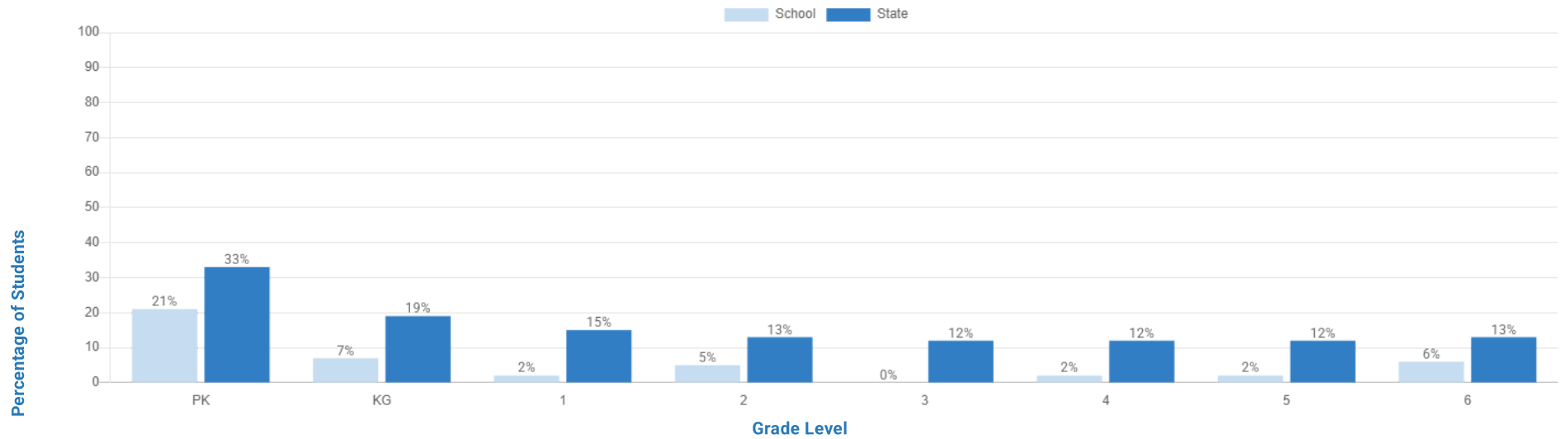

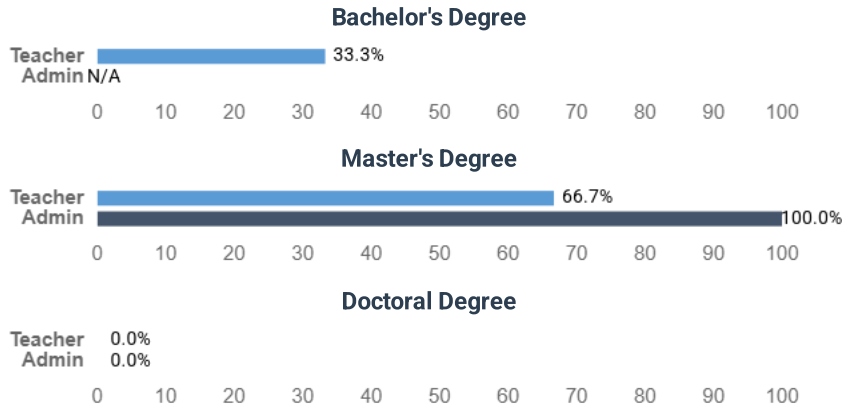

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. ### Highlights:

- 1:1 laptop initiative for all students in grades 3-6 for added resources for students in the classrooms and at home, helping with the efficiency of assignments and preparation for middle school.
- Character Education informs school activities. The presence of a full-time school counselor helps with numerous in-class lessons and social groups.
- Each classroom is equipped with projectors, white boards, and document cameras for use for students in large group and small group settings. Classes visit the computer lab once a week.



### Mission, Vision, Theme:

The district has taken on the motto, "Owls Together". Through community and a feeling of belonging, West Ridge School makes all learners feel as if they are supported both academically and socially. The addition of counseling services, enhanced literary programs, the return of numerous school and community after school/evening activities, and the use of social media and regular school wide updates to increase communication help bring the many stakeholders of West Ridge "together".



### Awards, Recognition, Accomplishments:

Students are recognized with monthly awards in the character education theme word of focus. West Ridge teachers are selected to teach professional development in areas of expertise and one is selected each year as the "Teacher of the Year" and honored at the county level. Awards are also presented to graduates at the end of year Promotion Ceremony, including the President's Award for Academic Excellence and Citizenship awards, as selected by staff members. The school and principal have been recognized locally for their contributions on Veterans Day and in coordination with the local veterans. The school has also received local grants for environmental concerns.

### Courses, Curriculum, Instruction:

Classroom libraries provide numerous options for differentiated reading. Significant additions based on student reading level have been made in conjunction with the building reading specialist and donations through the Parent Teacher Organization. Online texts for math, social studies, and science enable quick access both in school and at home on curricular areas. World Language is offered, starting in Kindergarten, to all students. Students get exposure to both Spanish and French, and then choose in second grade which they will pursue. ML students receive instruction both in a pull-out and push-in model and do well on state ACCESS testing. Programs for gifted and talented are offered at all grades, including both push-in and pull out models. Basic Skills classes are offered for both math and literacy, both during school and as part of a "0" period. A Homework Club is run after school for those who need additional time and direction on completing homework/classwork assignments.



### Sports and Athletics:

"Morning gym" intramurals are run by the PE teacher and offered to upper grade students (4-6). Classes participate in a fall fitness competition in line with the PTO and the school year culminates with Field Day in June, where students participate in a number of athletic games and activities.



### Clubs and Activities:

A theater instructor works with fifth grade students each spring. Chorus and Band give students an opportunity to take up an instrument and sing. Rehearsals for whole group band take place before school and students get individual/small group instrumental lessons on a rotating basis during the school day. Within these rehearsals, advanced students have options for solos or small group ensembles. Each spring, an art show is held to celebrate student work. Service projects are an important part of the learning process, including working with our local veterans for Veterans Day and regular food drives for local groups, culminating around Thanksgiving in conjunction with Tri Boro Food Pantry. Sixth graders participate in lunchtime jobs and safety patrol to help foster a greater sense of responsibility. An afterschool entrepreneur club was started in 2023-2024 to teach students about their "own business" and topics like product design, price point, and advertising.

### Before and After School Programs:

The Instrumental Music Program is for grades 4-6. Students come Before School for the Band Program. Instrumental lessons take place during the school day. The Homework Club is after school and it is run by the Basic Skills Teacher. The Physical Education Program, "Early Morning Gym", is once a week before school and it is run by the Physical Education Teacher. Teachers provide some afterschool class options in the winter and spring, such as yoga, cartooning, and coding classes. These are run through the BOE.



### Staff and Professional Learning:

PD is completed in district on full-day and half-day early dismissal days. Teachers also attend outside workshops on various topics, including academic, behavioral, and others related to school safety. Many out of district workshops are furnished through the Northern Valley Curriculum Center on a wide variety of topics. In-district, teachers are selected to turnkey topics they are "expert" in, especially literacy, math, and technology. The District Technology Supervisor will lead whole staff groups. Safe School is used to provide teachers with PD on topics such as HIB, building safety, and health related requirements. Teachers work closely with the Director of Curriculum and Instruction and the Supervisor of Elementary Education, both in the classroom and through small group meetings. There is academically-based PD on this as well, including reading assessments and use of the Start Strong and NJSLA scores to help guide weaker areas of learning.



### Student Supports and Services:

The Intervention and Referral Services team connects teachers and parents to provide children with academic and behavioral interventions. Data from these interventions give the team positive steps for student success. The district supports students in Individual Education Programs under Special Student Services. A comprehensive Basic Skills program is used as a resource for struggling students in reading and math. The implementing of a new Basic Skills writing section is expected later this year. ML students are taught and monitored through a pull-out and inclusive program. 504 plans are set up for those that qualify through a distinct diagnosis and highlight modifications within the general education setting, as well as any necessary accompanying special services or therapies. Additional staffing has been added in the past few years, including a multi-sensory reading teacher and additional staff in both resource and Basic Skills.

### Student Health and Wellness:

Students attend physical education twice per weekly cycle and have recess for 25 minutes per day. Health and wellness is an important part of the curriculum and is taught within each classroom PK-6 and part of the regular curriculum. One K-6 health teacher addresses the district curriculum and specifically teaches only health lessons. This maintains consistency across classrooms. The School Climate Team promotes health through monthly assemblies and awards. The School Nurse leads lessons with classes on topics such as germs, hand washing, and self-care. The School Counselor runs both individual counseling as well as group "Lunch Bunches" to address student health and wellness needs.



### Parent and Community Involvement:

The West Ridge PTO provides support to teachers which includes educational materials, assemblies and recess equipment. Communication is key to success with parents. Teachers are given opportunities to put items on a wish list, as well as get donations through the Scholastic Book Fair for their classrooms. PTO communicates with parents through use of the Remind App for any parent wishing to sign up. We have instituted a Monday morning West Ridge Update Newsletter to update parents on happenings and provide a look at the week ahead. We run parent meetings for the benefit of new parents and pre-k parents, as well as Kindergarten Orientation for new incoming parents. The spirit of volunteerism is evidenced at many functions sponsored by this group, which provides enrichment, enhancement and excitement for students and faculty. PTO provides lunch options for parents to purchase, rather than packing lunch for their child. All lunch options are voluntary.



### Facilities:

All of the classrooms are air conditioned. All rooms also have a ventilation unit for full air return of outside air. The building has a courtyard, which is used for student-based science projects and also provides an outdoor area for student learning and outdoor lunch. The building is kept clean and inviting by the daytime and night maintenance staff. Room space is utilized in many different facets to deal with staff members who go back and forth between buildings, as well as provide the necessary privacy for special education or counseling based programs. Group restrooms were renovated and a new "family" restroom was added for use by staff and parents, during school events. The Media Center is large enough to host large group functions and provides a large movie screen for displays and presentations. The VR Room has a "Green Screen" for use on the sixth grade news program or other student technology initiatives.

### School Safety:

Drills are held twice a month, as per state statute, many with the assistance of the local Police Department. This year an evacuation drill to the nearby staging area will take place. The School Climate Team meets twice per year, as does the Code Blue team. The Code Blue team performs two drills and looks at various procedures should an emergency arise during school. The School Safety Patrol has older students (sixth graders) assisting younger students in movement throughout the building before school, after school, and during lunch/recess. Sixth graders each get a job/ responsibility, many of which include assisting their younger peers during lunch/recess/ arrival. Steps and protocols for all drills and emergencies are reviewed twice yearly and handouts are given to all staff members and substitutes on how to handle each situation. Blackout shades were added to all classroom doors and new key locks were put in place on all indoor/outdoor locks.



### Technology and STEM:

We have a 1:1 MacBook Air program for grades 3-6. Students in the younger grades have laptop carts. The Technology teacher runs a Grade 6 News program highlighting events around the school. Grade 6 students also complete a quarter class in coding and developing skills. STEAM/Makerspace are a critical part of teaching engineering and Media Center classes highlight steam skills. Technology classes itemize skills from keyboarding to podcasting and meet once every six days. Each year, more subscriptions and sites are utilized for student resources and to increase students' digital footprints. Next year, the district will evaluate the laptop program, its financial backdrop, and make a decision towards the future of 1:1 devices in the district and what they will look like.



### Early Childhood Education:

West Ridge has two preschool classes. The program is planned through the Special Services Offices. Classes house students who are in need of special services and their typically developing peers. Classes are half day sessions. Therapies are available to all who qualify including, but not limited to, speech, physical therapy, and occupational therapy. Open slots are filled via a lottery system and require tuition. The number accepted via lottery varies by year, based on how many spots remain. Preschool students attend all specials (PE, music, art, media) similar to other grades and also have in-class support lessons from speech and other therapy areas. Two paraprofessionals assist the teacher in both classes, regardless of class size.

Attendance is monitored through one of the assistants in the main office. It is reported online twice a day by teachers through the PowerSchool data system. Students who arrive late or leave early, are required to sign in in the main lobby. After the first marking period, students who are on pace to reach the "chronic absenteeism" mark of greater than 10% (18 in a 180 day school year) days absent, receive notification from the principal. As the year progresses, any student who is on pace or does pass 18 absences for the school year is marked for review. The classroom teacher (or teachers depending on lower grade/upper grade) will review the student progress and work mode, and meet with parent to decide if progression to the next grade is in the best interest of the child. If the child's poor attendance has influenced their performance in the class, a meeting with the parent will occur to discuss possible retention or summer school opportunities, depending upon their status.
