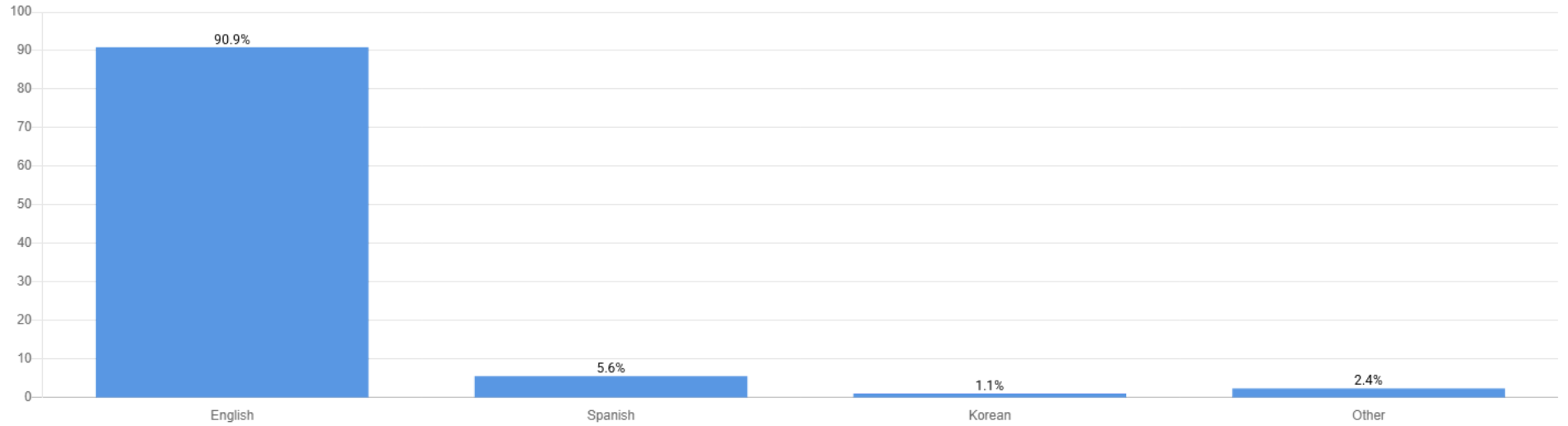

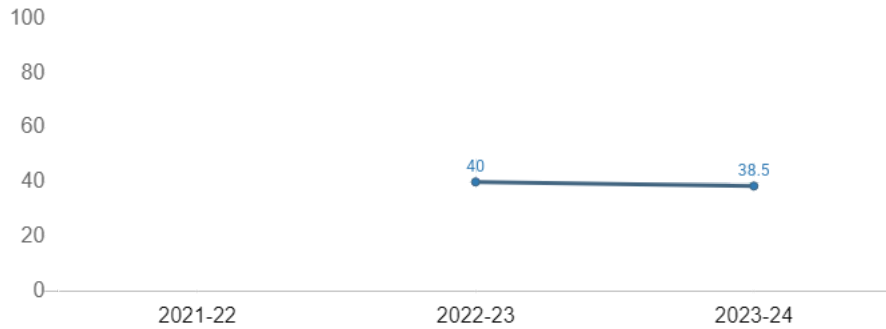

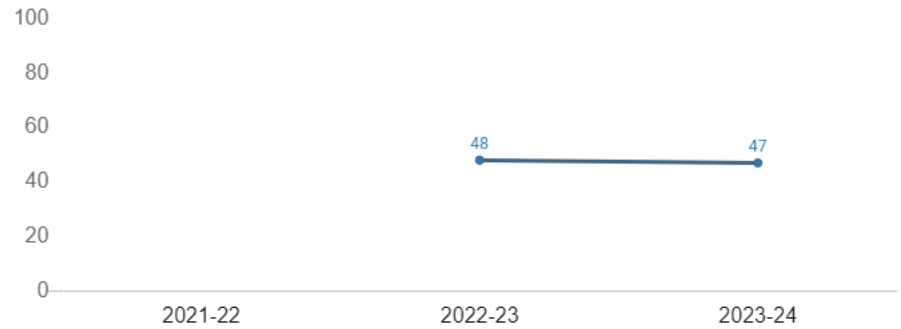

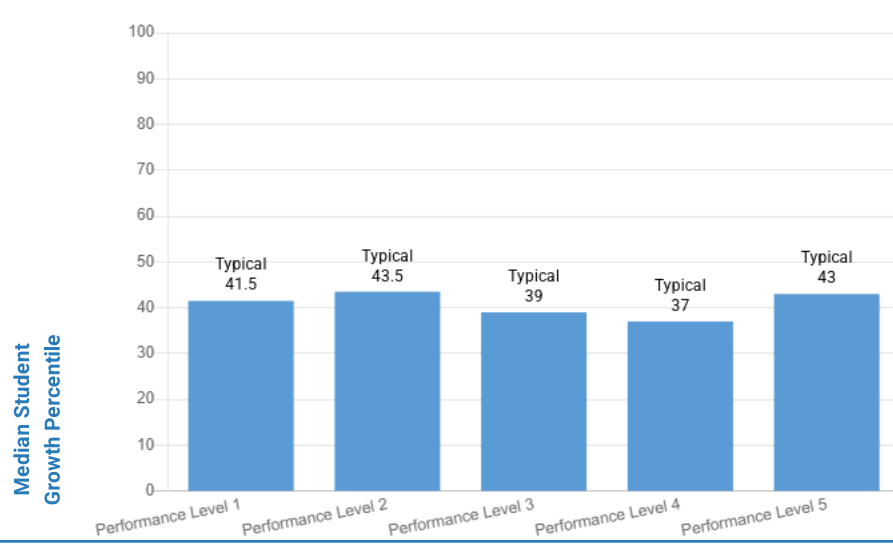

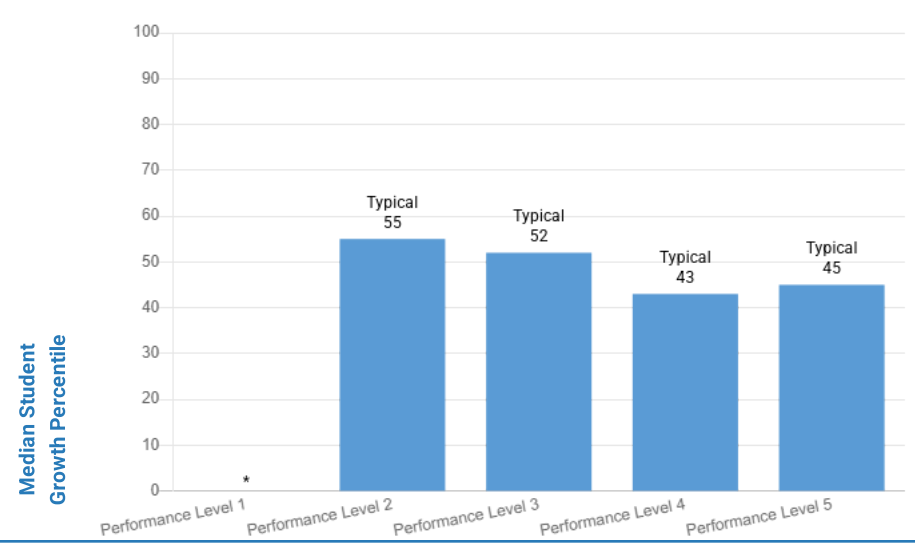

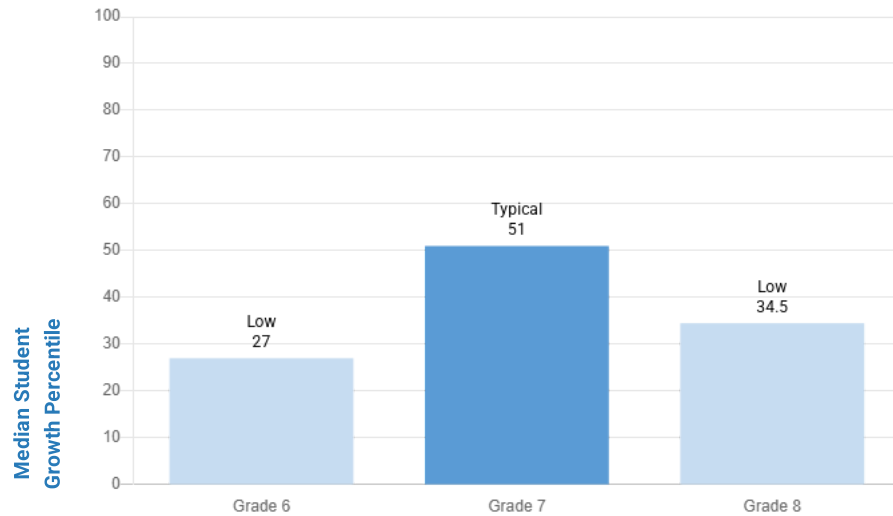

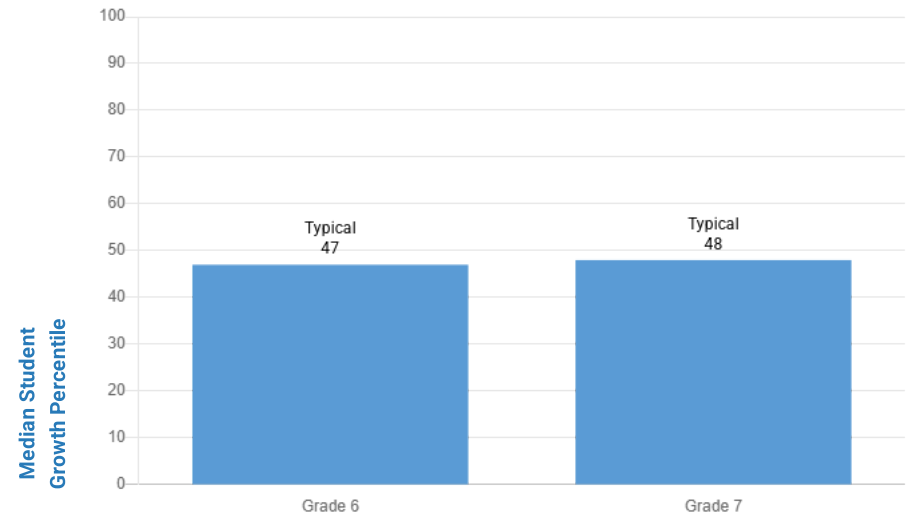

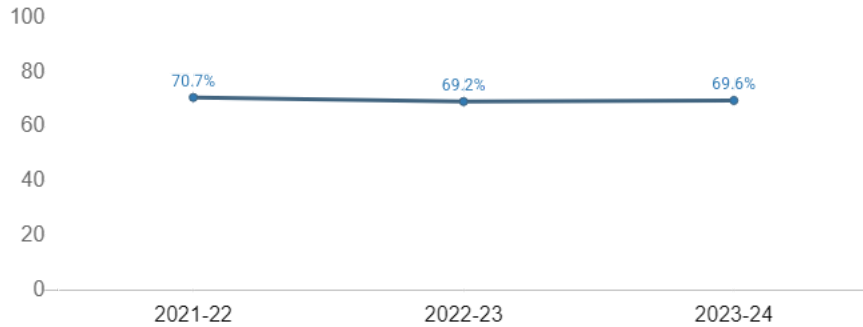

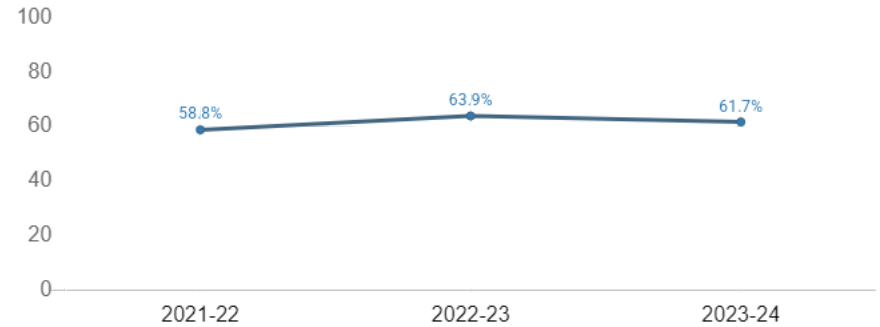
### English Language Arts and Mathematics Performance Trends

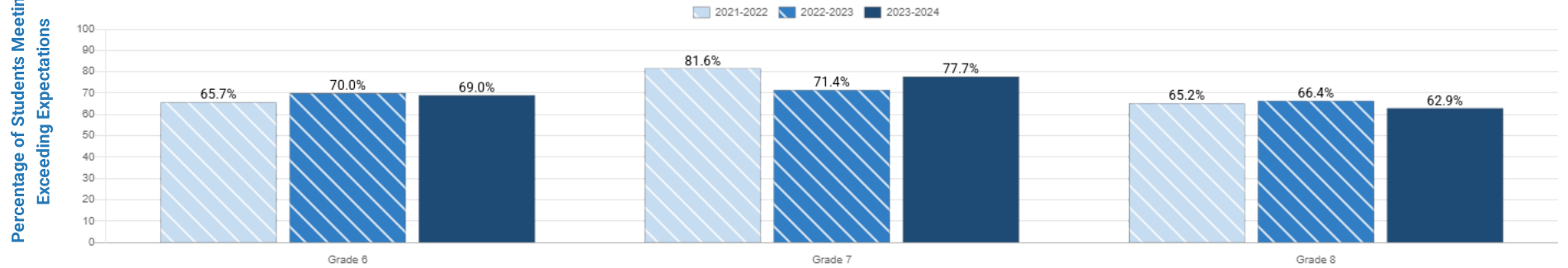

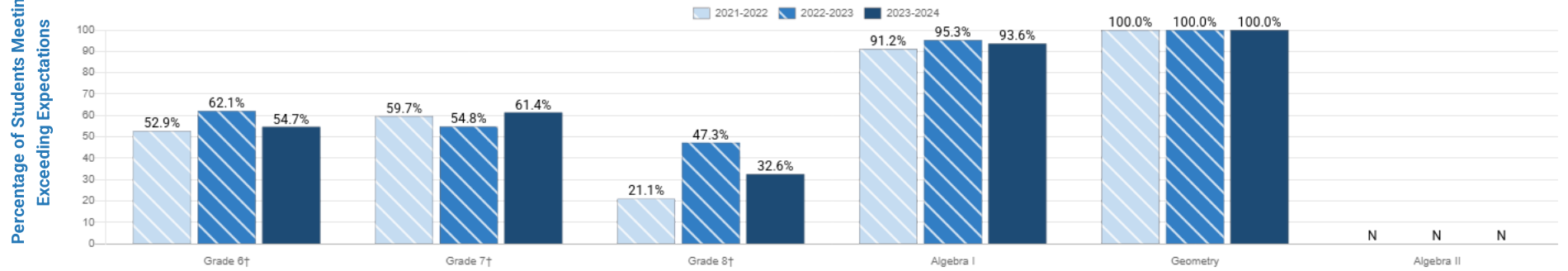

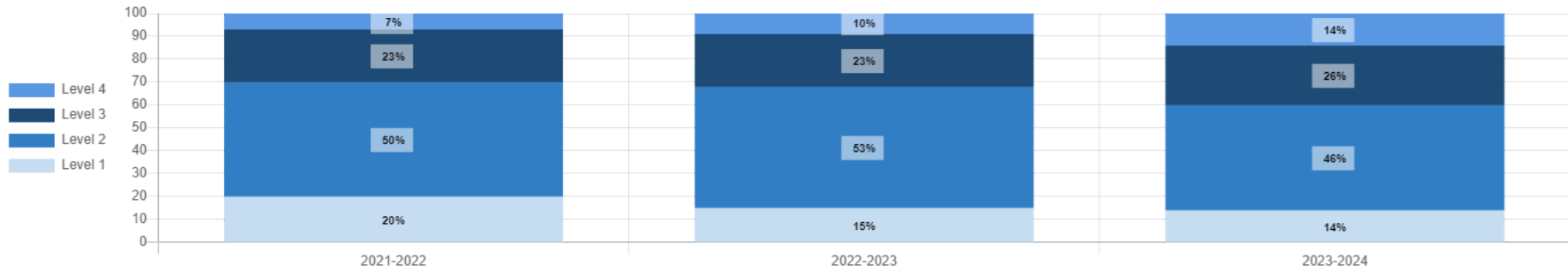

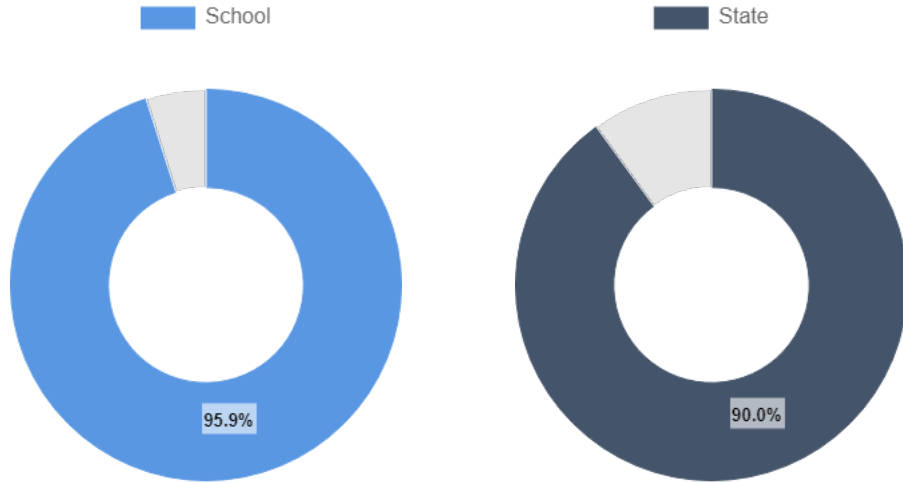

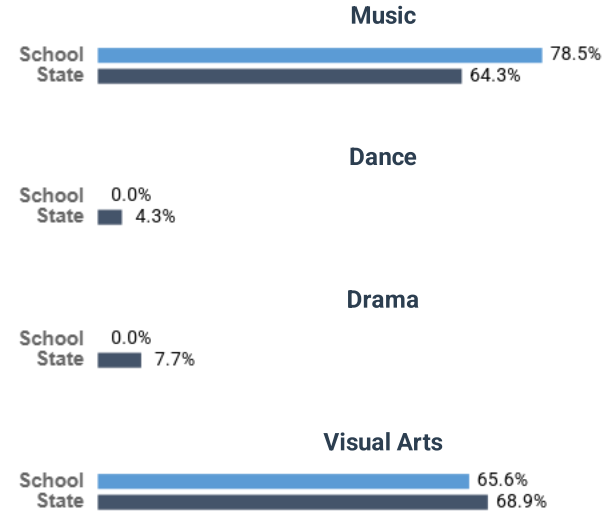

**Students enrolled in one or more classes by discipline:**



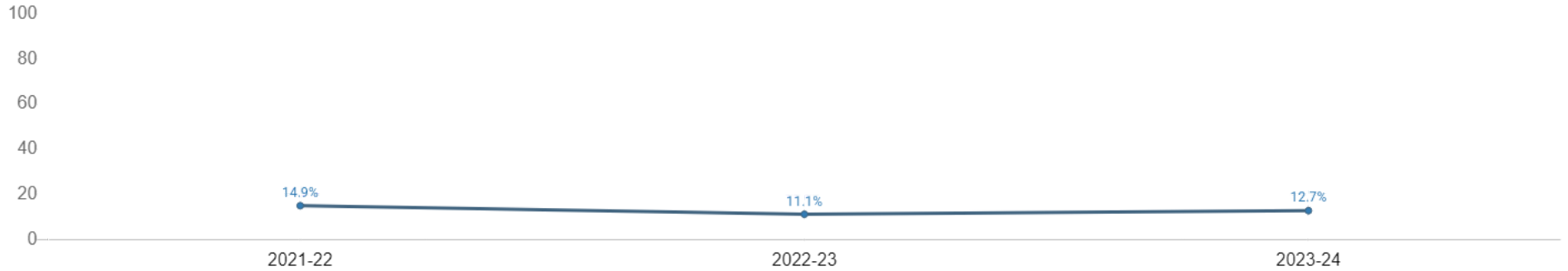

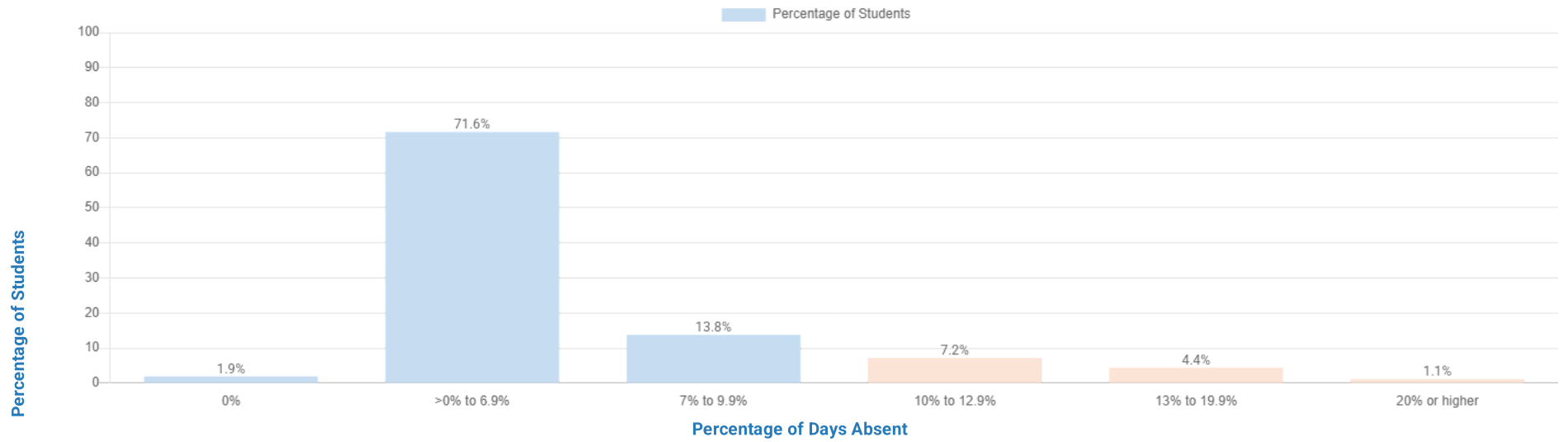

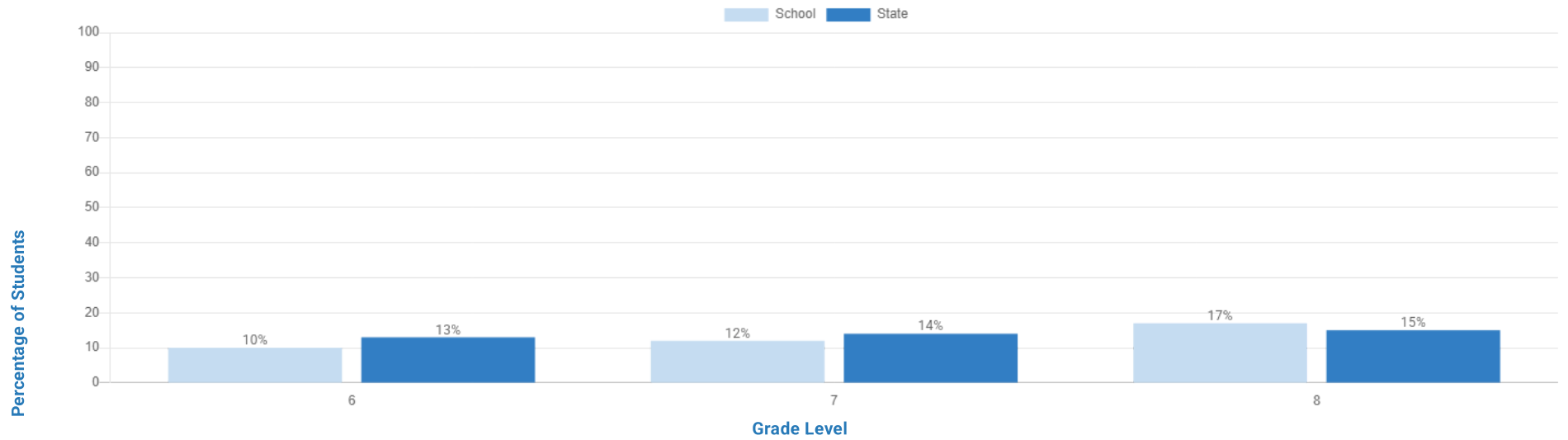

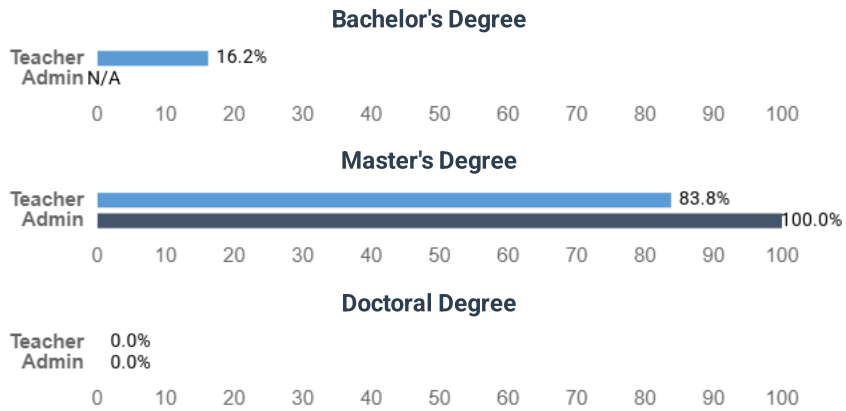

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. ### Staff and Professional Learning:

Staff participates in a variety of Professional Development opportunities throughout the year ranging from PLCs (professional learning communities), residencies in balanced literacy and math, and interactive opportunities in our lab site classrooms alongside coaches and consultants across disciplines. Opportunities for PD are also offered by teachers in their own classrooms with peer observers on topics such as technology integration, student-centered learning, sensory learning, sheltered instruction, balanced literacy, and differentiated instruction.



### Student Supports and Services:

We use a Multi-Tiered Systems of Support (MTSS) Model which is run through school-based Committees that review benchmark assessment data to identify students who may be in need of extra support. They also review requests from teachers/parents for assistance with students who are experiencing difficulty in school. Should further assistance be required, the CST provides diagnostic and consultative services to pupils who are identified in need of special education. The ELL program serves children in the school who speak different languages. Accelerated Learning supports also provides in the areas of reading and mathematics.

Science labs have been renovated and the school houses a tech room, wood shop, and robotics spaces. A full (newly refurbished) gymnasium, cafeteria, art room, culinary arts center, enrichment room, computer lab, media center, and coaching corner are also contained at Smith. All Smith students benefit from the building and technological resources.



### School Safety:

School safety is a priority of all schools. Our schools employ strict visitor protocols through vetting and identification software, students and staff practice required safety drills monthly, and there is a school Crisis and Safety Committee that reviews procedures in place throughout the year. Visitors enter the buildings through separated, secure vestibules. The school district employs a full-time Security Officer at each of the five district schools and they maintain a close partnership with the Ramsey Police Department.



### Technology and STEM:

Smith School is 1:1 Chromebooks. Each classroom is equipped with Promethean boards, document cameras, printers, and other technology resources for student and staff use. Technology is infused throughout the curriculum to enhance the students' instructional experience.
