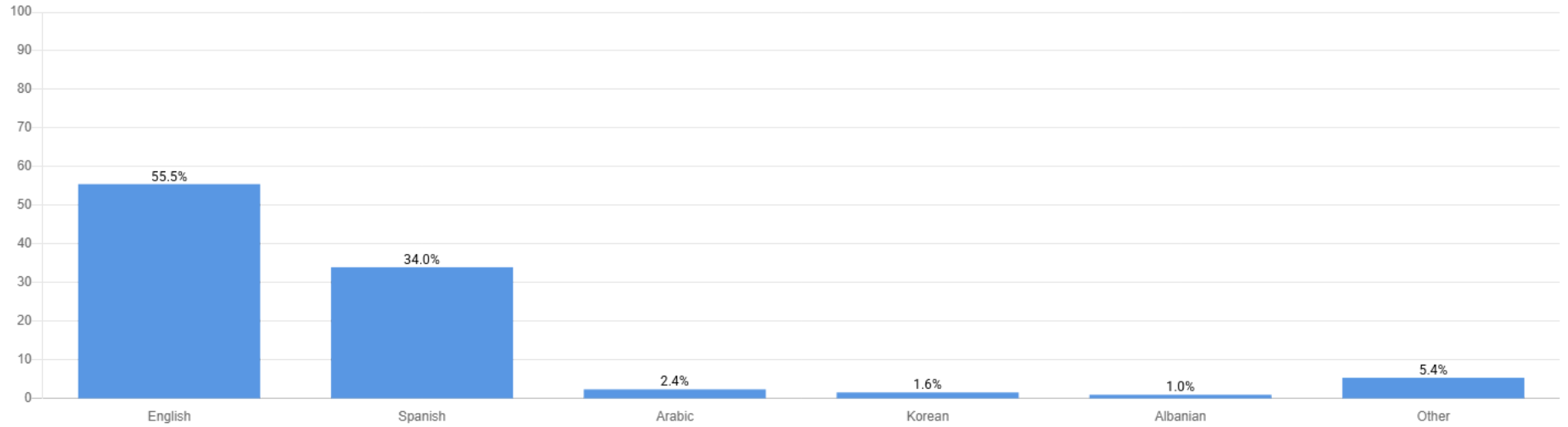

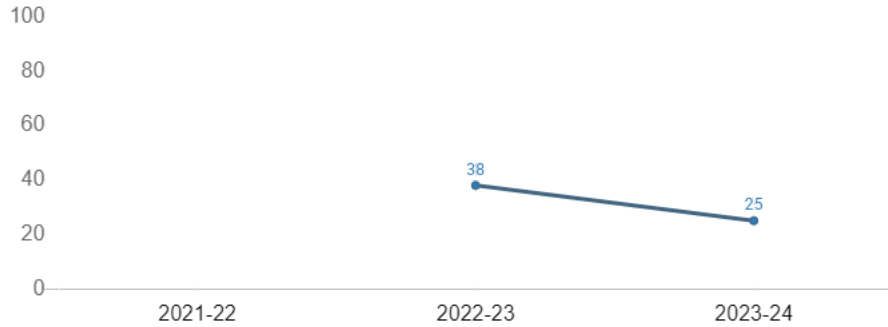

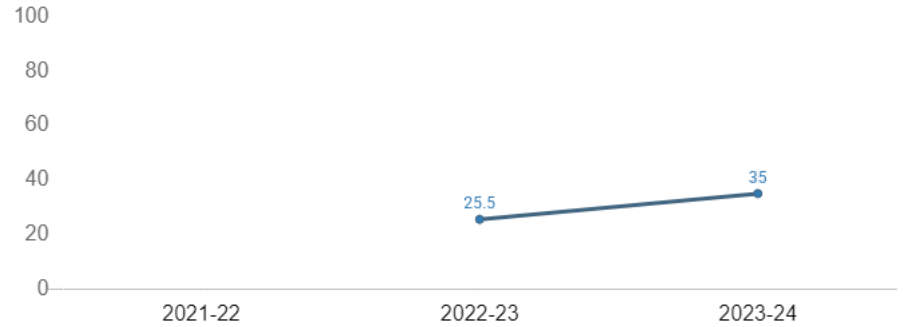

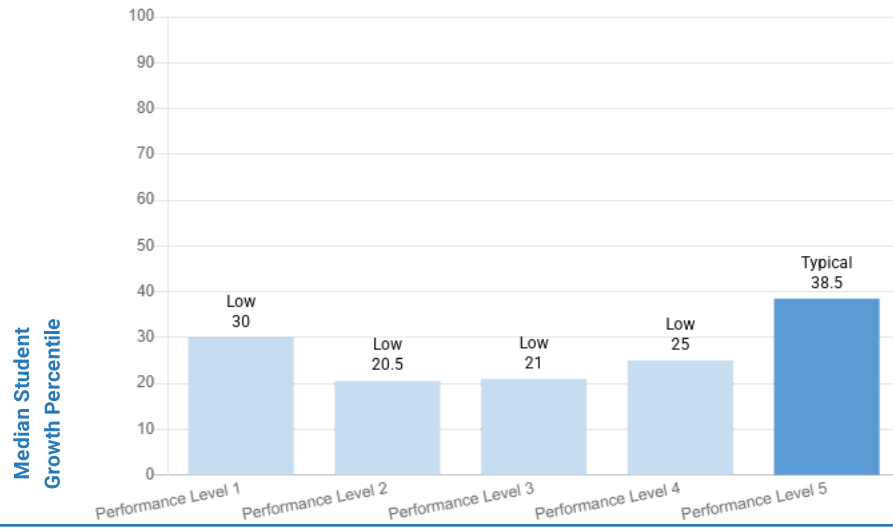

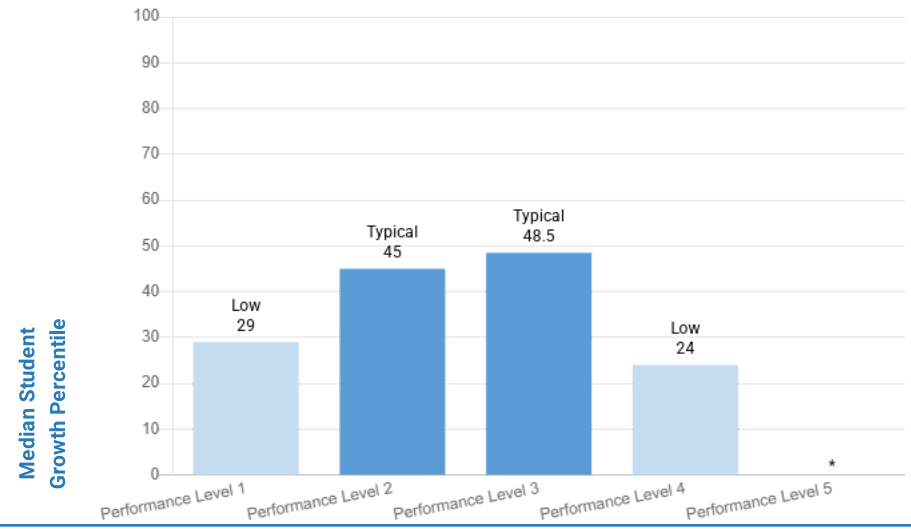

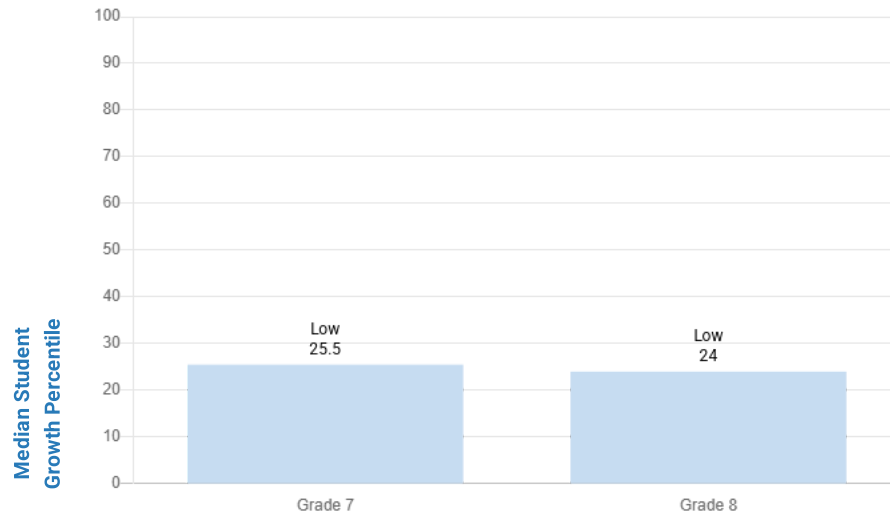

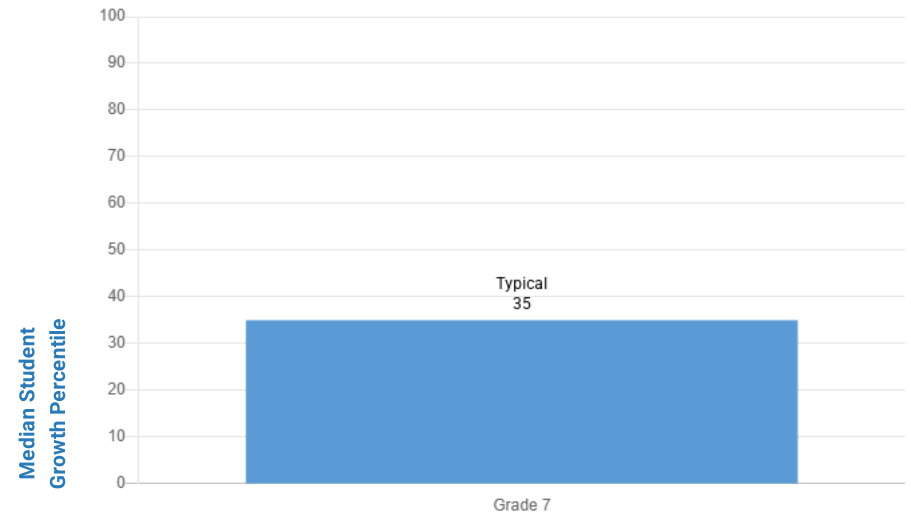

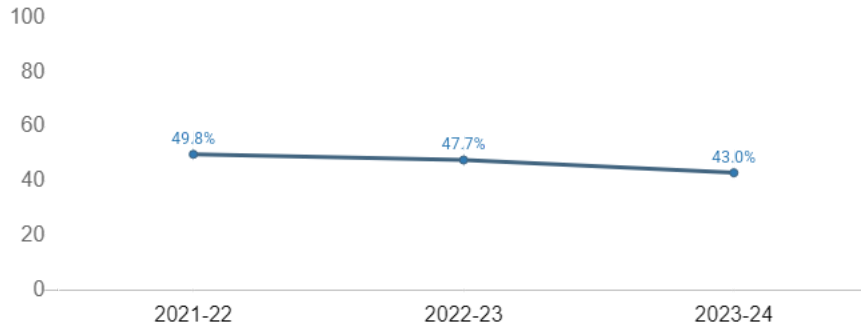

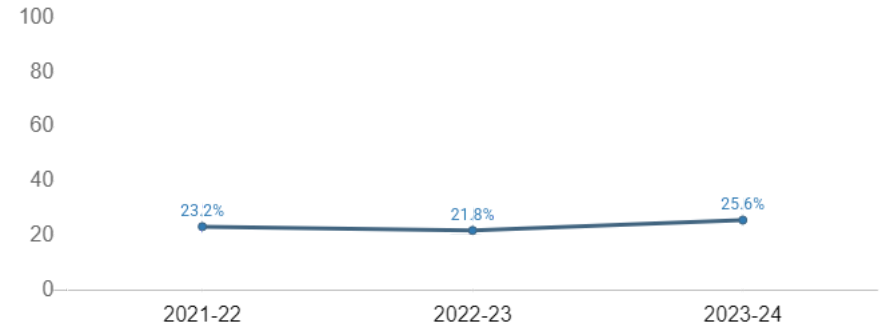
English Language Arts and Mathematics Performance Trends

English Language Arts Assessment - Participation and Performance

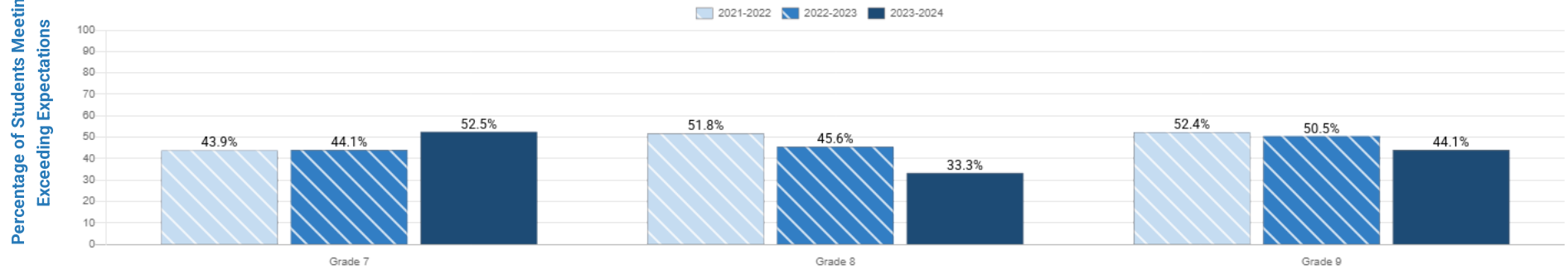

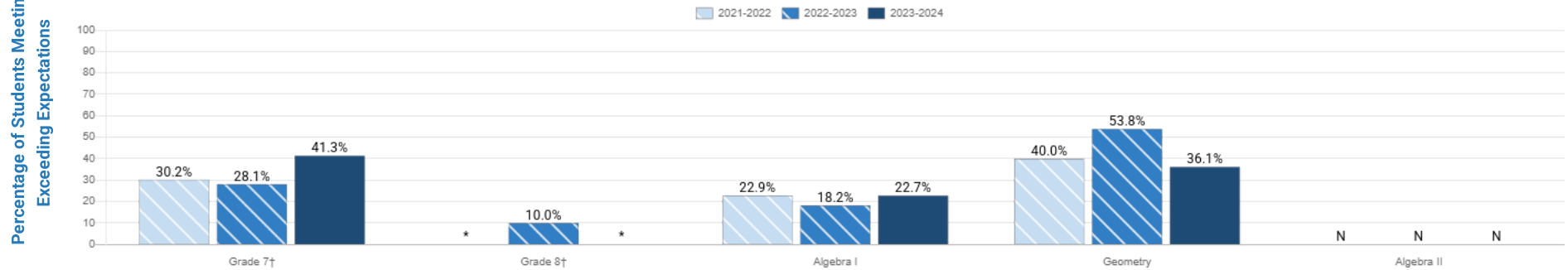

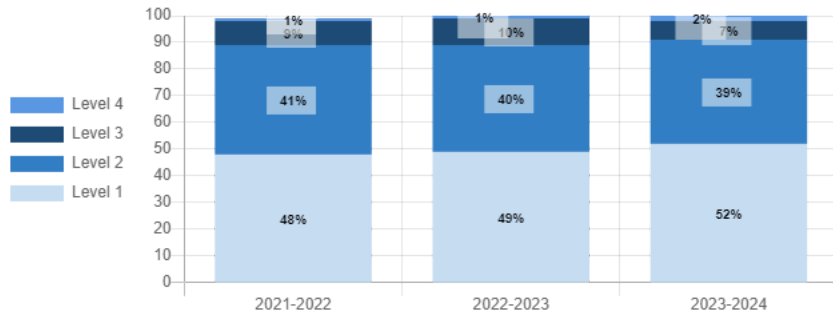

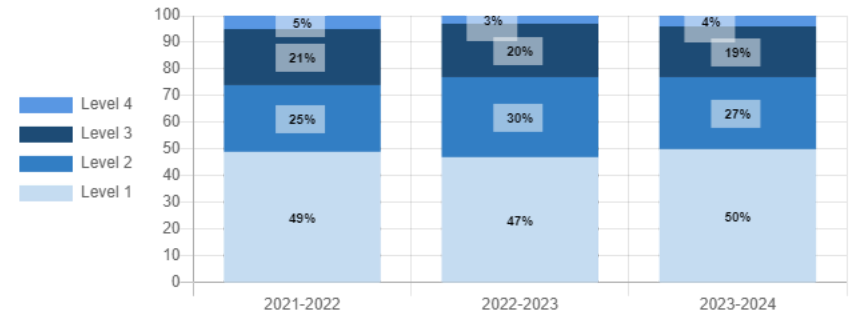

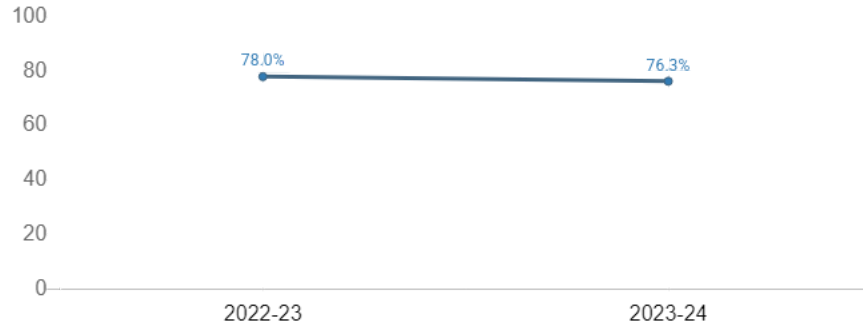

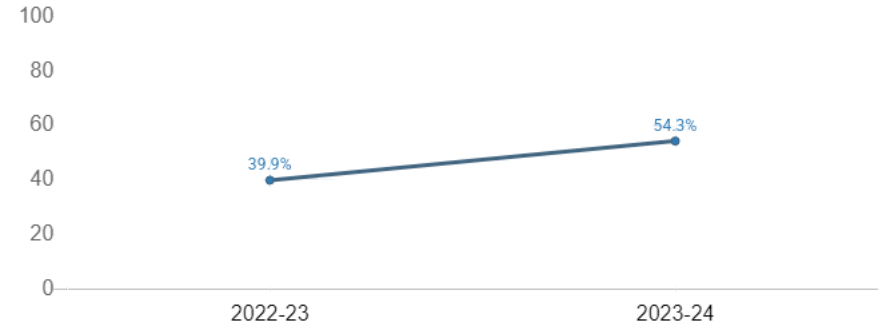

Students taking one or more AP or IB exam

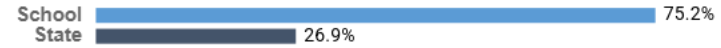

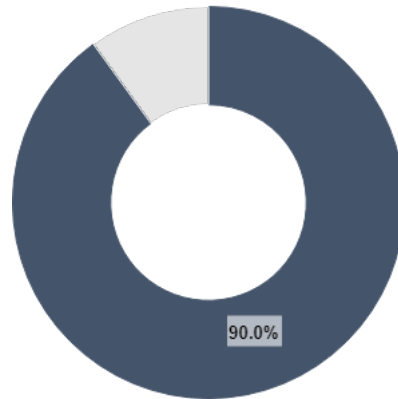
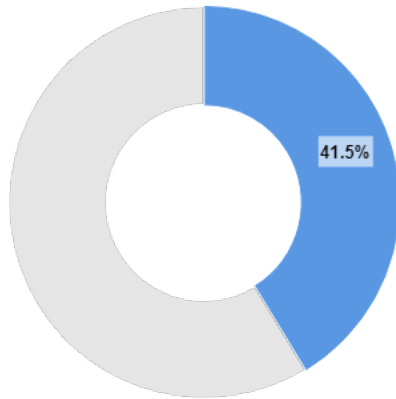

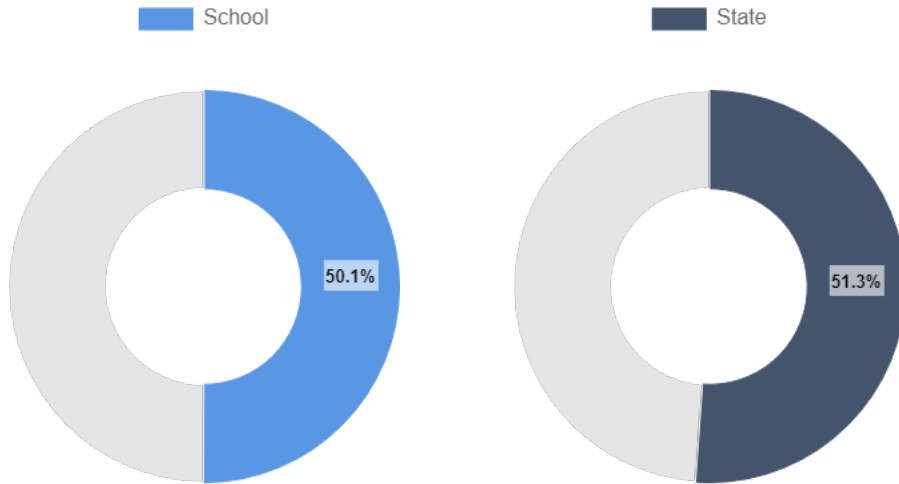

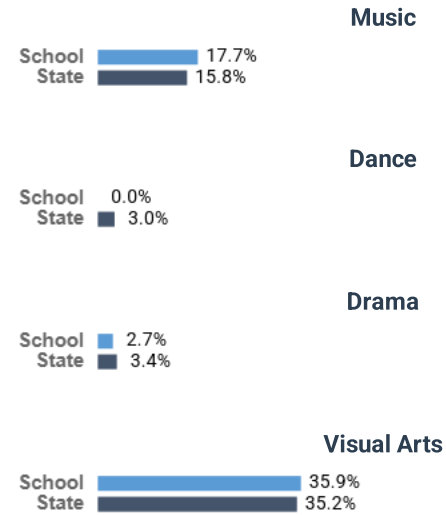

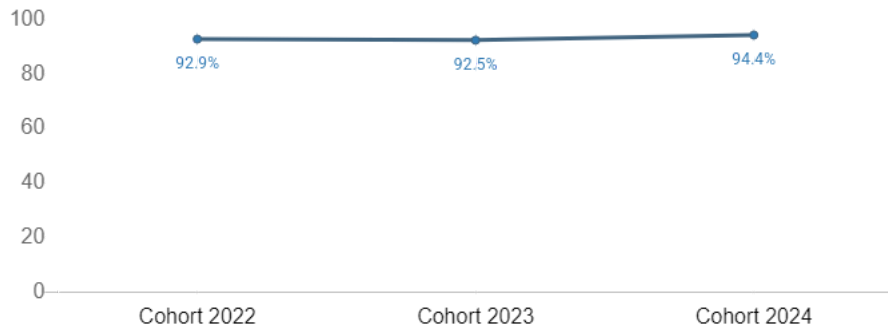

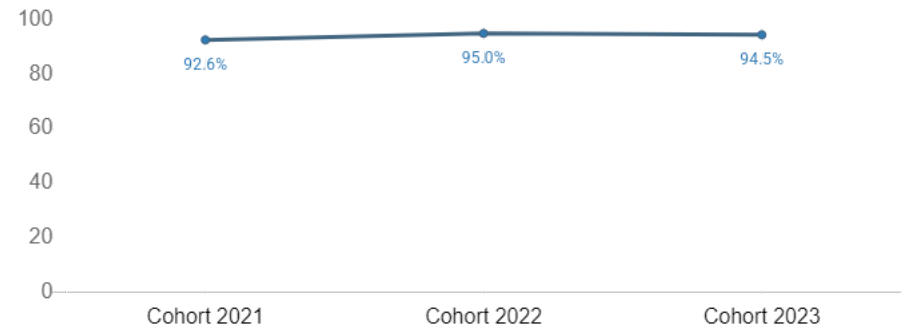

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

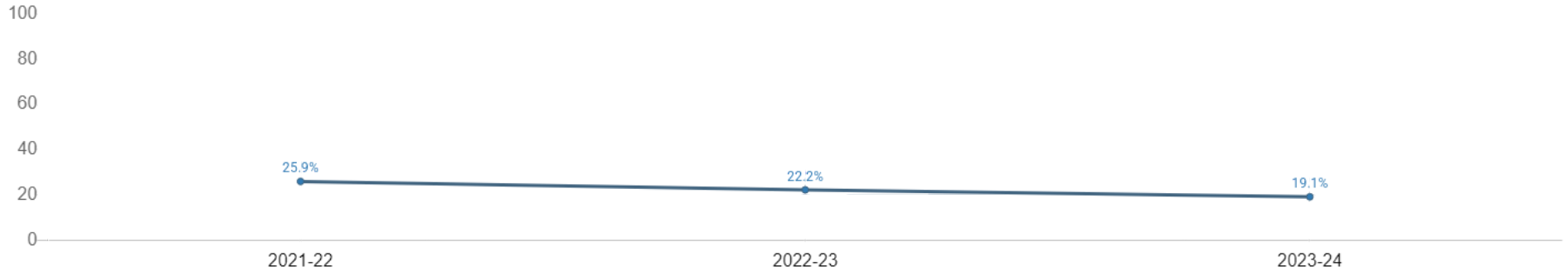

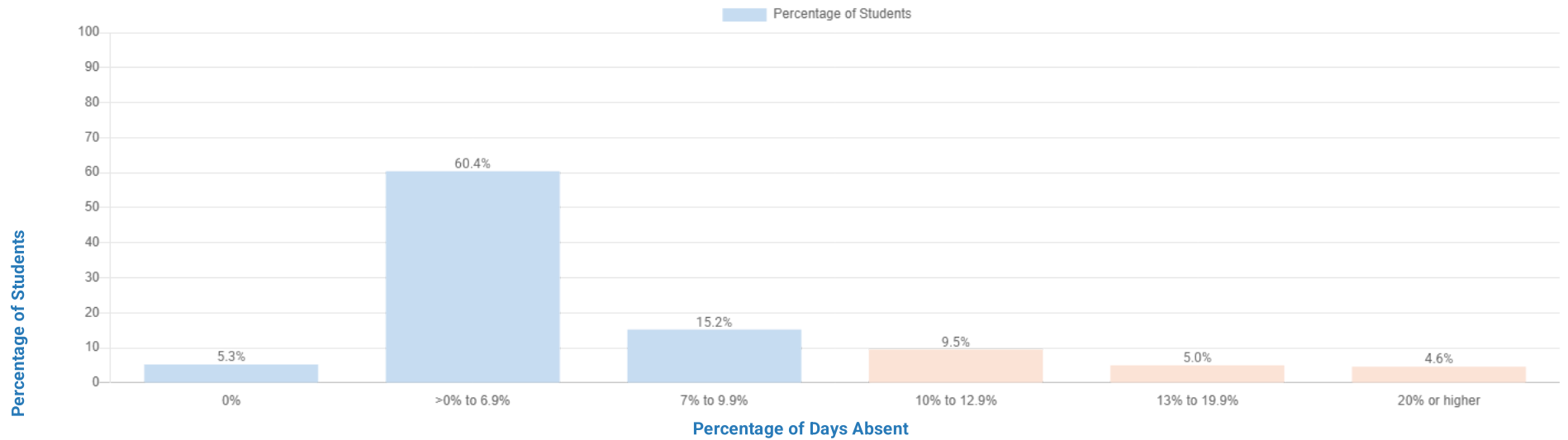

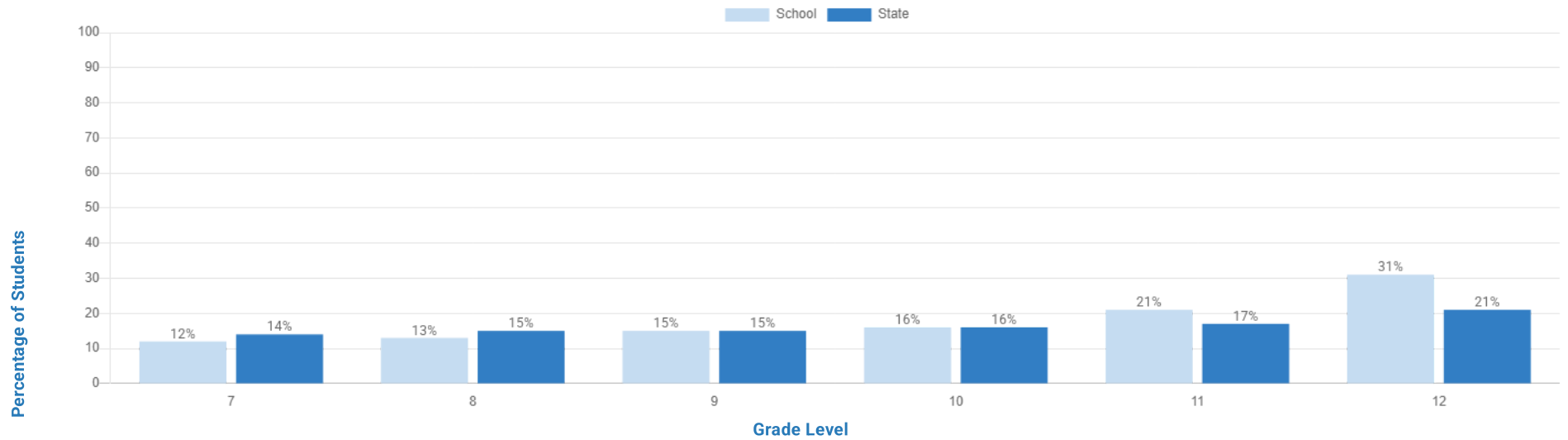

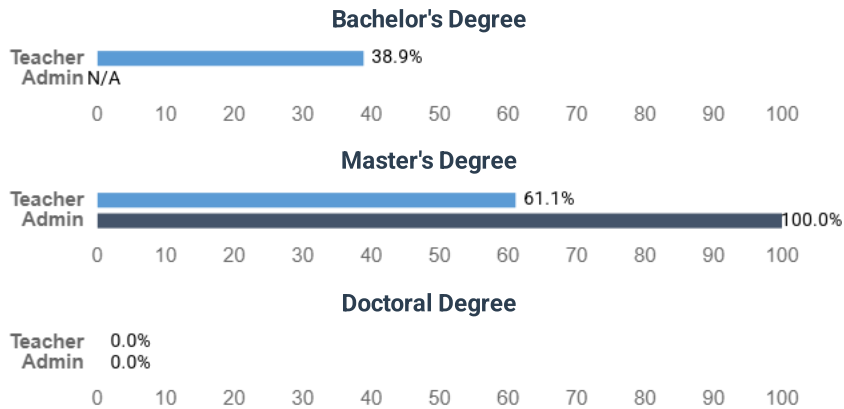

Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

 - Title I schools with a summative score in the bottom 5% of Title I schools.

Accountability

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Courses, Curriculum, Instruction:

AP courses in Biology, Chemistry, Physics, Calculus, English Composition, English Language, European History, US History, World History, Italian, Spanish, Psychology, and Art are offered to students in grades 9 - 12. 15 AP exams were administered in Spring 2024 with approximately 75% of the exams resulting in a score of 3 or higher. Additionally, 18 dual enrollment courses are offered to students in grades 10, 11 & 12 where college credit can be earned through post secondary partnerships. We partner with Bergen Community College for the Early College Program which allows students to earn their Associate's Degree while still in high school. The class of 2024 was the fourth cohort of students to complete this program.

The longstanding tradition of Scarlet Athletics continues on, with our teams competitive in their league. Our school has established a cooperative program with Bogota for Wrestling and Baseball. Girls Wrestling continues to grow steadily in Ridgefield Park, with 5 female wrestlers on last year's team.

Staff and Professional Learning:

School staff engage in professional learning throughout the school year. We utilize SafeSchools for online compliance training, and all staff members complete a minimum of 8.5 hours of training on this module. In addition, faculty engage in ongoing professional development opportunities related to their specific content areas, classroom management, social-emotional learning, and updated course materials. Faculty members also engage in PLC (Professional Learning Communities) to collaborate on topics related to student performance, data, and planning. The school has been focused on curriculum revisions as we migrate to Atlas, in addition to an intense focus on increasing rigor, problem-solving, critical thinking and student engagement in the classroom.



Postsecondary Information:

The JSHS provides opportunities for students and families to explore post-HS options via evening workshops, information sessions, representative visits, college visits, trade school visits, Instant Decision Day, and career speakers. Recent graduates have entered military service, trade school, as well as Cornell, Rutgers, Montclair, NJIT, Marist, Penn State.



Student Supports and Services:

English Language Learners - our school has offered after school support for ELLs through Title III. ELLs (or MLs) have the opportunity for additional instruction and support with their teachers. All students, including those with disabilities and those identified for interventions, have access to Peer Tutoring provided by National Honor Society seniors. The I&RS team meets weekly and consists of the Supervisor of School Counseling, School Counselor, School Social Worker, CST member, AP and 2 core content teachers. Mandatory Tier 2 interventions include Peer Mentoring and Peer Tutoring. Our school has a robust Peer Mediation and Mentoring Program. Interested junior and senior students apply and go through an interview process to serve as role models for students who are experiencing behavior or social difficulties, as well as function as mediators for underclassmen and junior high students who are experiencing peer conflict.

Student Health and Wellness:

Our students have 210 minutes of physical education weekly. Our cafeteria services provides a breakfast program for students. Our health and physical education department has worked on incentive programs for healthy lifestyles, including developing an interactive fitness challenging using QR code and the walking path that goes through our campus. The Scarlet Strong Training Center will be incorporated into the curriculum for grades 9-12.



Parent and Community Involvement:

Our school has an active PTSA that meets monthly and engages in activities to support students and staff throughout the year. The district has an active SEPAG (Special Education Parent Advisory Group) that meets quarterly and engages with guest speakers and community resources. There is also a Project Graduation Parent Committee, which serves to fundraise and execute the Project Graduation event for the seniors. School-sponsored opportunities for parent involvement include "Back to School Night" held in September; two Parent-Teacher Conference Nights in which parents/guardians may confer with their child's teachers. We utilize Genesis Parent Portal and parent/guardians have accounts to monitor their child's grades, attendance, and other pertinent information. Our school works closely with community organizations, such as the Board of Recreation and Sustainable RP to provide opportunities for students.

Facilities:

Our building opened in 1967. In summer 2023, we renovated three Science classroom labs as well as our Culinary lab. Our gymnasium was renovated in 2021, and the building underwent a multi-phase curtain wall and window replacement project. Our school has one gymnasium, one auxiliary gym, convertible auditorium, a library/media center, three computer labs, two art rooms, a STEM room, 7 science labs (including the 3 newly renovated ones), a culinary lab, and a wood shop. Our facility is air conditioned. In summer 2024, construction on the Training Center and Wellness Centers were started, with the Wellness Center opening for students in October and the Training Center scheduled to open in early December.



School Safety:

Our school follows the safety protocols as listed: We have a full time SLEO (Class III) officer from 7:30-3:00 daily. We use two monitored entrances for student arrival, RFID swipe entrances for staff. Staff use electronic sign-in and sign-out when leaving the building. We have signage around the exterior of the school for visitors to report to the Main Entrance. All doors are locked during the school day. Protocol is "no visitors without an appointment". We utilize the Raptor system to check in expected guests, contractors, etc. and all visitors must wear the ID while on school property. Students must wear school IDs and lanyards. We have ample security cameras in both interior and exterior of school property. We have established a "No Phones Visible" practice for students during the school day.



Technology and STEM:

Our district is 1:1 and all students are issued Chromebooks for educational use. Most classes utilize Google Classroom as learning management system, as well as curriculum-specific software such as IXL. We are a "Google School" and use the G-Suite of applications for both students and staff. We offer courses specific to Technology Education, not limited to but including G-Suite and Digital Citizenship, Computer Technology and Literacy, Pre-Engineering, Technical Fabrication, Intro to Engineering Design, Advanced Engineering Design, Computer Programming, Robotics and AP Computer Science. Technology in the classroom includes, but not limited to desktop PCs, Brightlink interactive displays, document cameras, Juno voice amplifiers and speakers. Some courses/classrooms have MacBook Pros and/or tablets. We have a GlowForge and X-Carve machine in our STEM lab, and large format printers in our Art department.

The JSHS will complete a Corrective Action Plan for the 24-25 to address the percentage over 10% of chronically absent students.
