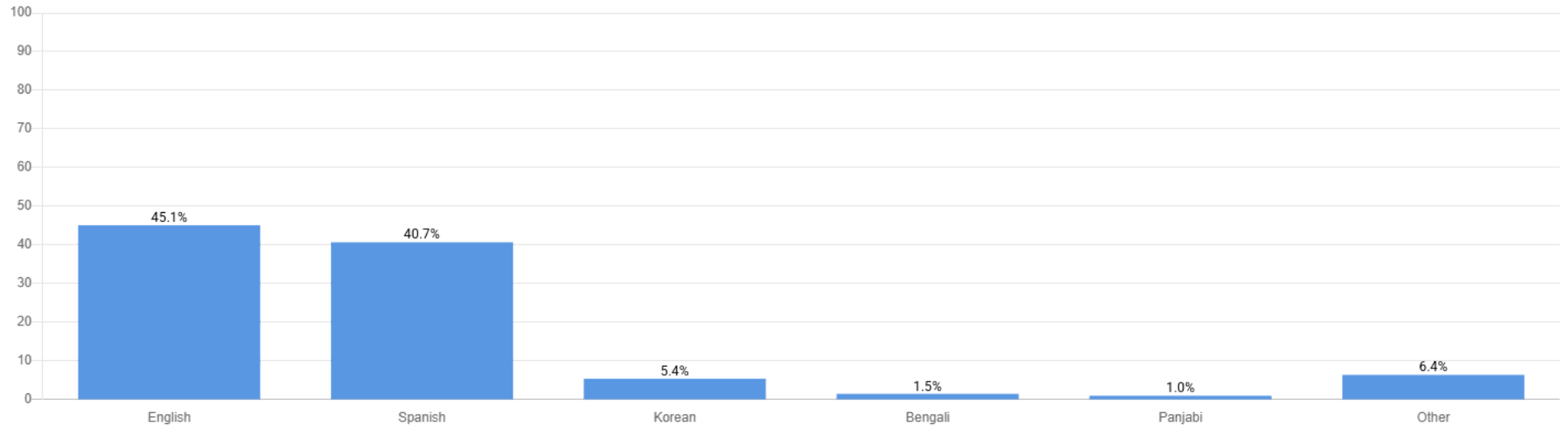

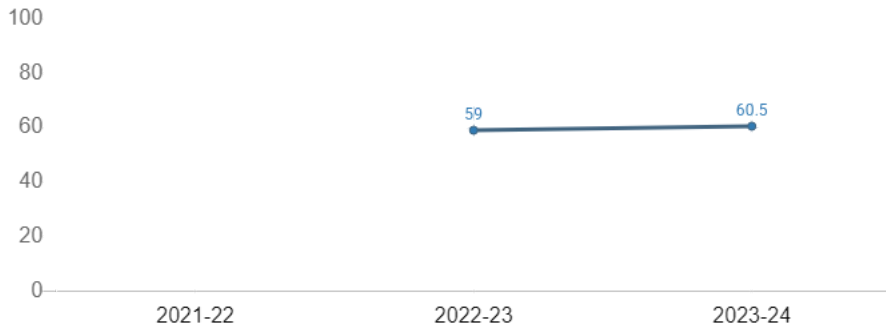

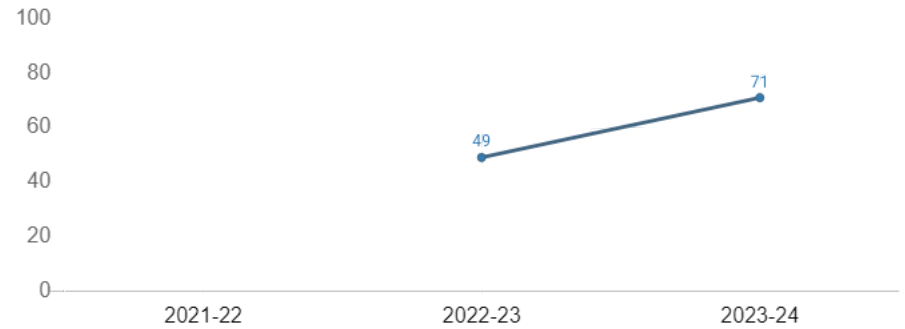

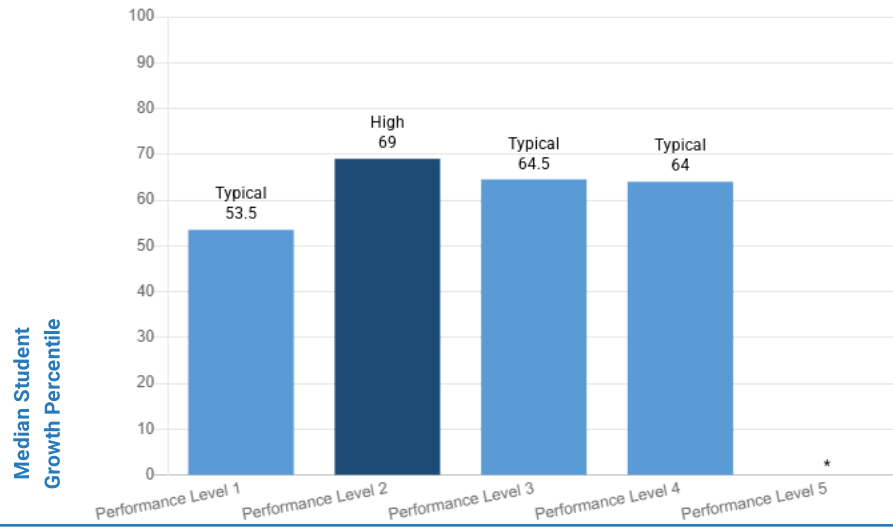

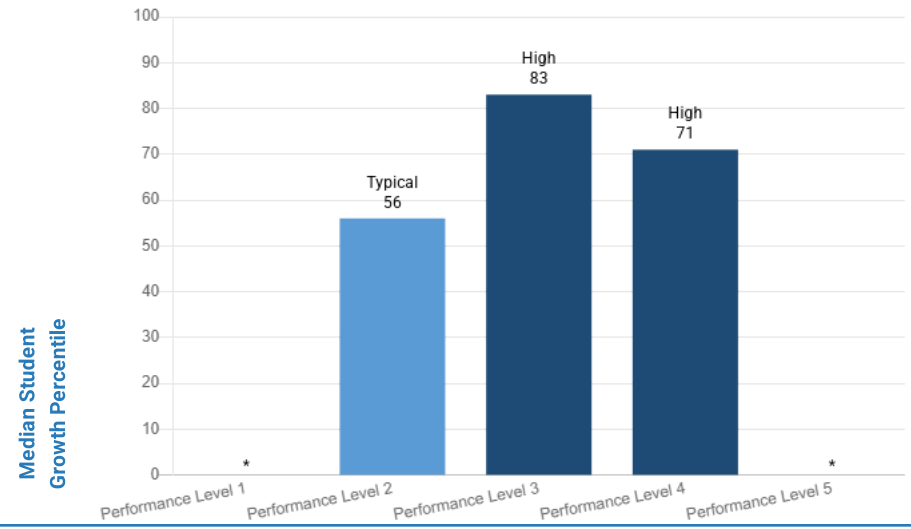

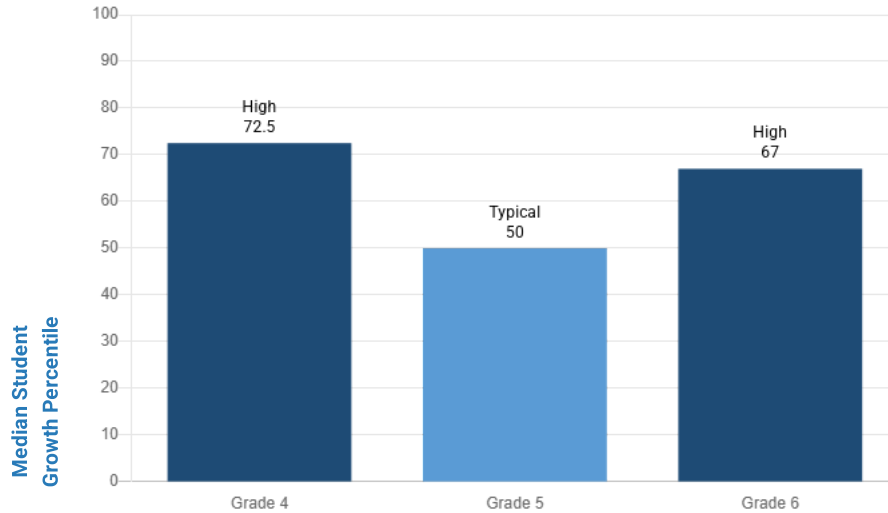

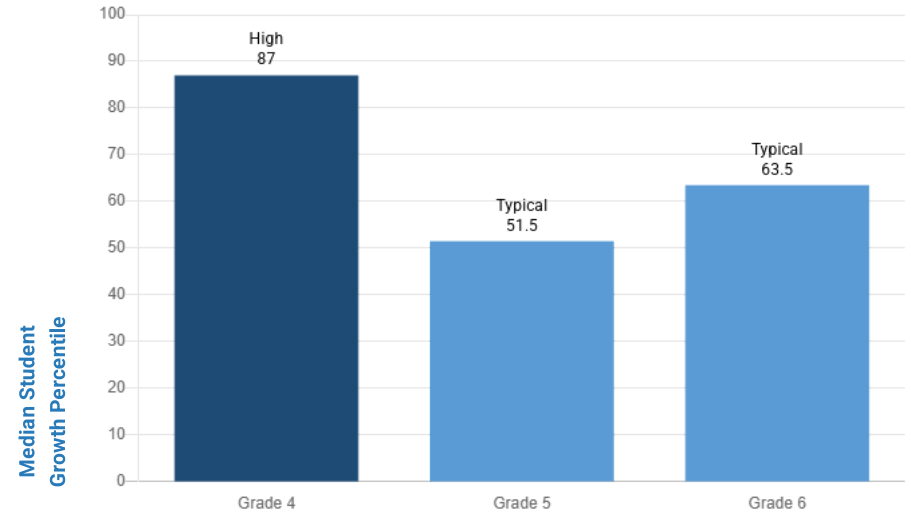

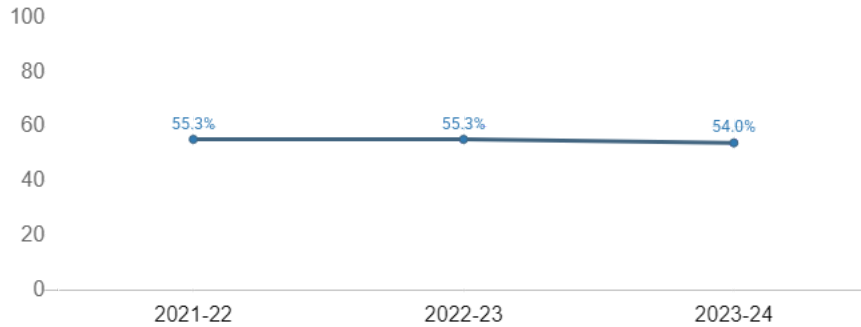

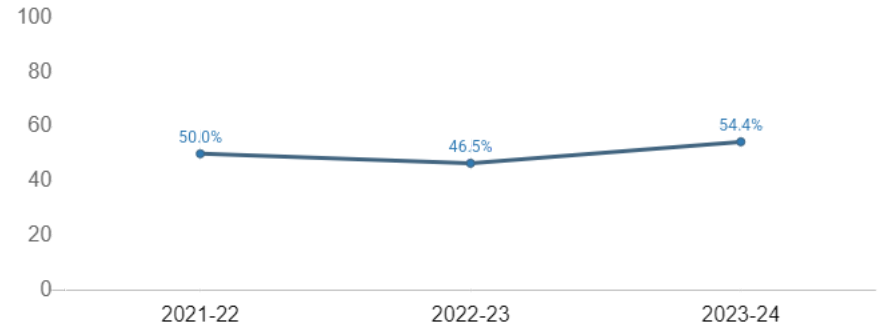
English Language Arts and Mathematics Performance Trends

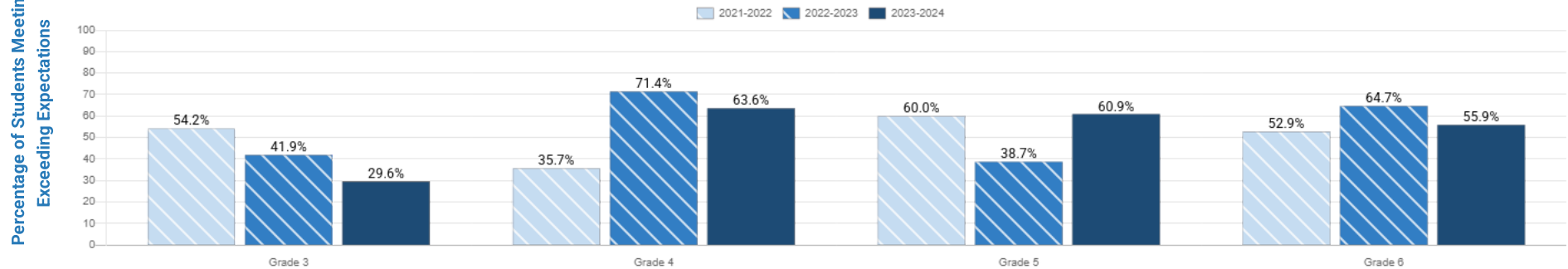

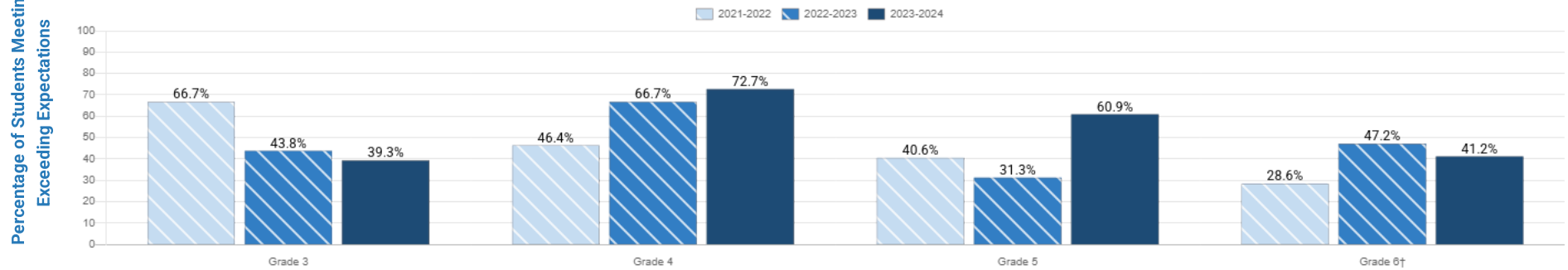

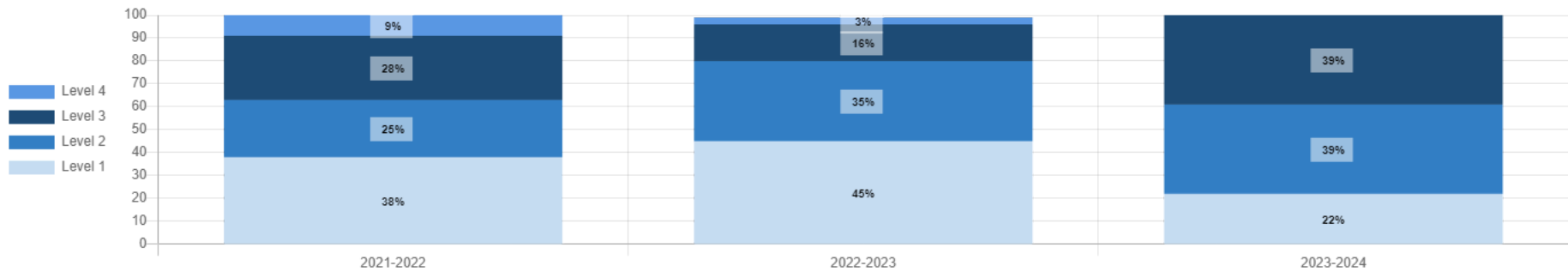

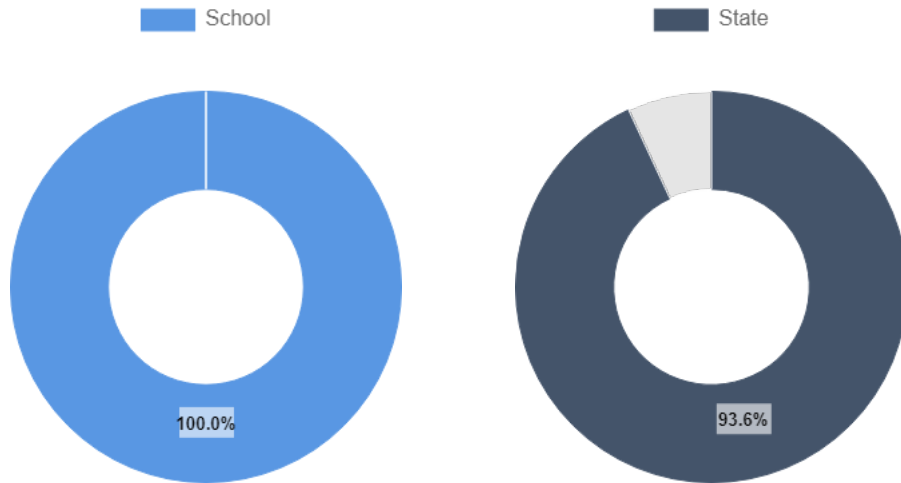

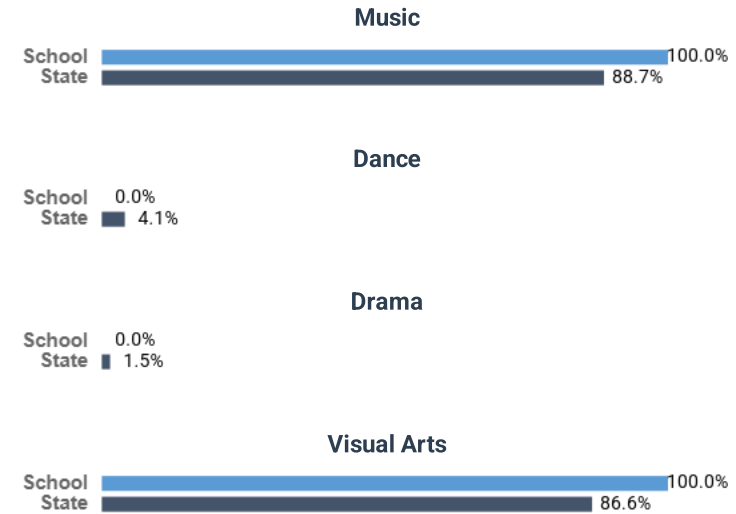

Students enrolled in one or more classes by discipline:



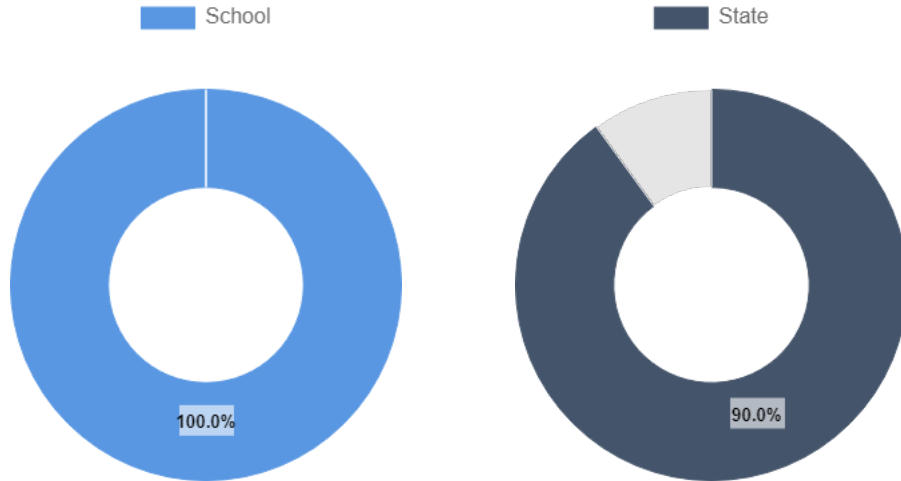

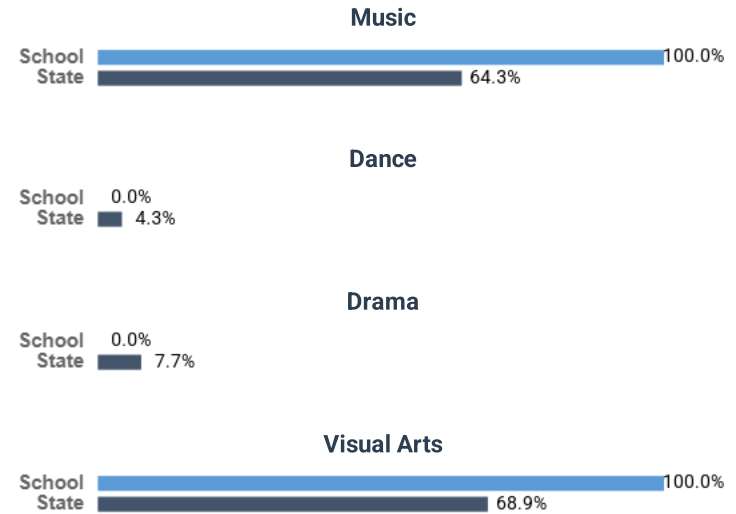

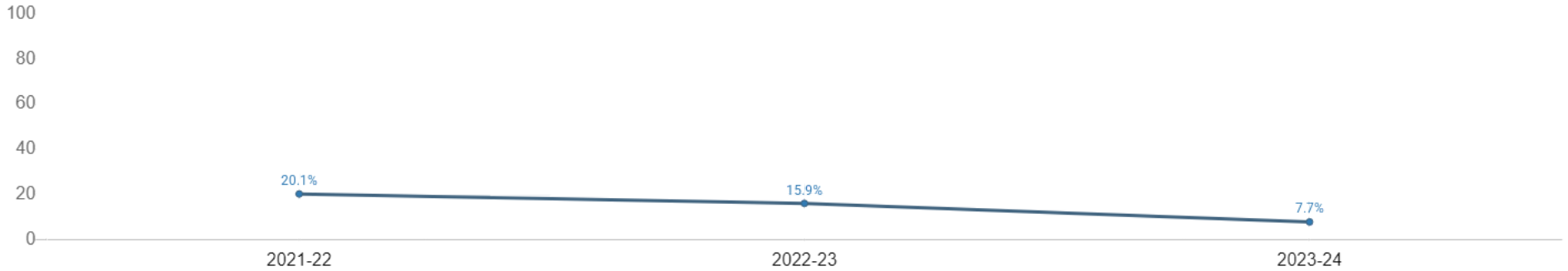

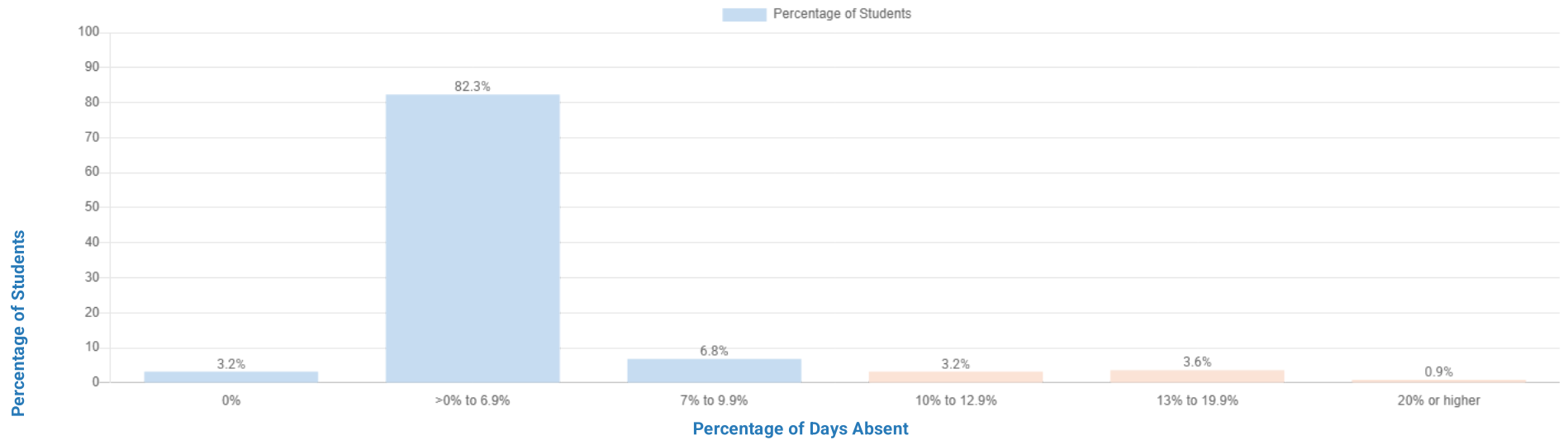

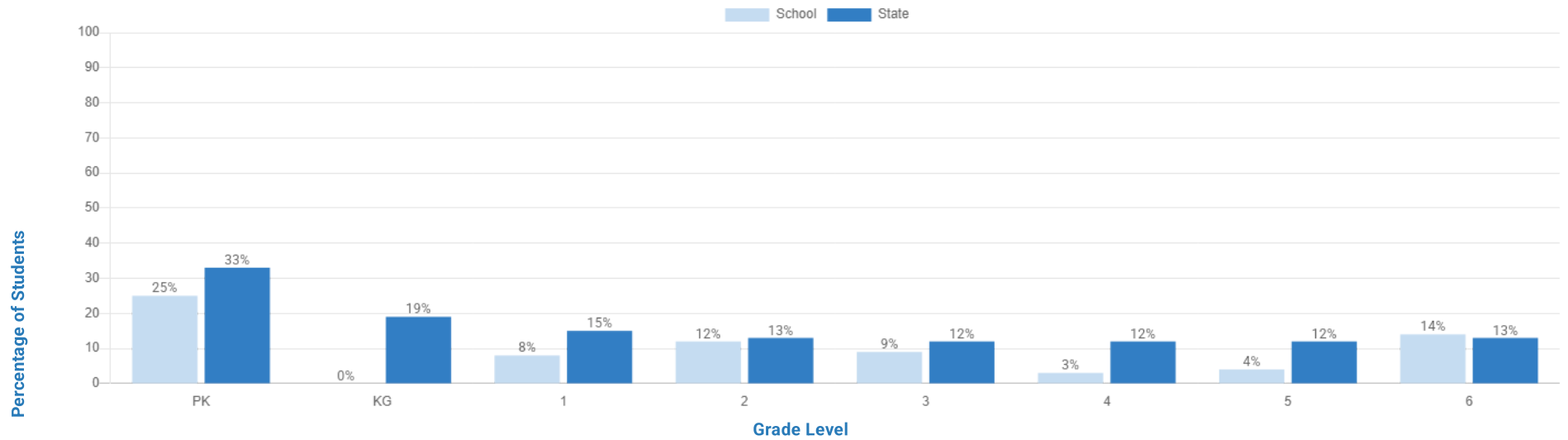

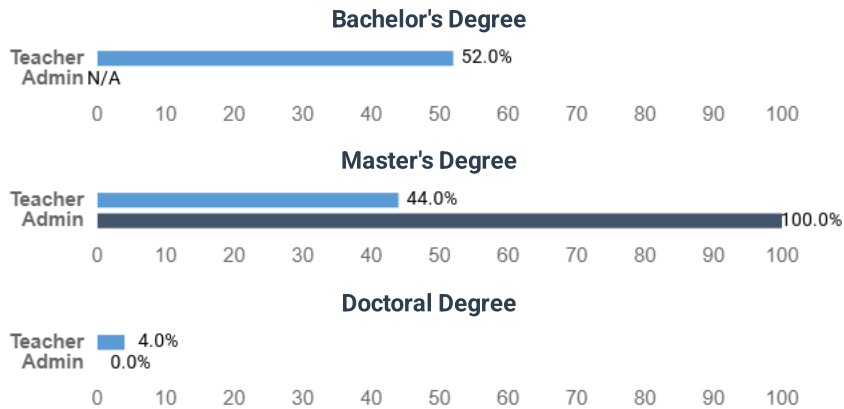

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. All curriculum is closely aligned with the NJSLs. Over the course of the past couple of years we have adopted the use of several resources to support the teaching of the NJSLs in grades K-6th. Fountas and Pinnell Classroom is utilized to help support the implementation of reader's and writer's workshop. Elevate Science is utilized to support the implementation of the Next Generation Science Standards. In addition Grant School uses Envision Math and various electronic editions and web-based software at all levels. We have a full and diversified fine, performing, and practical arts opportunities for all grades. Social-emotional learning is highlighted through weekly guidance lessons and our school-wide CharacterStrong SEL program.

Grant School offers the Ridgefield Park Before Care/After Care Program. Some of our support staff members also work as Supervisors of the Before Care/After Care Program, which provides stability for students. Supplemental academic instruction is provided to students through Grant School's Title I After School Programs for Math and English Language Arts. Our teachers also offer extra help before and/or after school by appointment.



Staff and Professional Learning:

The staff of Grant School participate in ongoing Professional Development throughout the school year. Workshops are offered both in-district and out-of-district. Physical and mental health are promoted at Grant School through the comprehensive Physical Education, Health, and School Counseling programs. Students engage in a variety of structured and unstructured physical activities during Physical Education classes and Recess. Mental health is promoted through bi-weekly classroom guidance lessons, small group and individual counseling, conflict resolution meetings, and school-wide activities, including our Character Shout Out and Student of the Month. Several teachers also utilize the GoNoodle platform in their classrooms to incorporate daily brain breaks and movement activities with their students. In addition, we continue to utilize CharacterStrong social emotional learning resource in the classroom.



Parent and Community Involvement:

We have a very active and supportive PTA that enhances our students' experience at Grant School. The PTA sponsors many events and programs throughout the year, including an Annual Pizza and Pastries in the Park, school-wide dances, book fairs, movie night, assemblies, fundraisers, field trips, and more. Students and staff participate in various fundraisers and collections to support local and county organizations.

Facilities:

Grant School was built in 1908. Starting in the summer of 2020, the building underwent several major renovation projects that have enhanced the safety and comfort of the students. All student restrooms received a complete overhaul making the facility state of the art. Also, the entire building at Grant School was updated with beautiful, energy efficient windows and LED lighting in the gymnasium. In addition, a new projector and sound system as well as the main stage curtain and rear stage curtain was installed on the stage. Also, new fire doors were installed throughout the building as well as several classrooms received new doors. Other large scale projects include a new boiler system, a new roof on the lower annex, new soffits around the entire building, a freshly paved playground and playground games such as four square and hopscotch were installed.


School Safety:

Grant School has several security measures that have been implemented to ensure the safety and security of our students, faculty and staff. All faculty, staff and students wear IDs and visitors must sign in when entering the building. Other safety measures include a Level 3 Special Law Enforcement Officer (SLE03), security cameras in and around the perimeter of the school, a security vestibule located at the main entrance and visitor protocols that include the use of the Raptor system to screen guests. In addition, we have established a close working relationship with the Ridgefield Park Police and Fire Departments.


Technology and STEM:

Grant School is a one to one with Chromebooks and is supported by wifi throughout the building. Teachers have been provided with laptop, voice amplifiers, interactive display panels, poly smart cameras, and Hovercams to support their instruction. In addition, the district has purchased digital applications such as Screencastify, Pear Deck, Flipgrid, IXL, EdPuzzle and Razkids to be utilized by the faculty. Students also receive technology class on a weekly basis.

In addition, high dose tutoring was implemented and teachers worked one on one with students to support specific needs. In the summer, a summer learning academy was offered to students in need. Along with academic support, social emotional support was provided in the form of bi-weekly guidance lessons.
