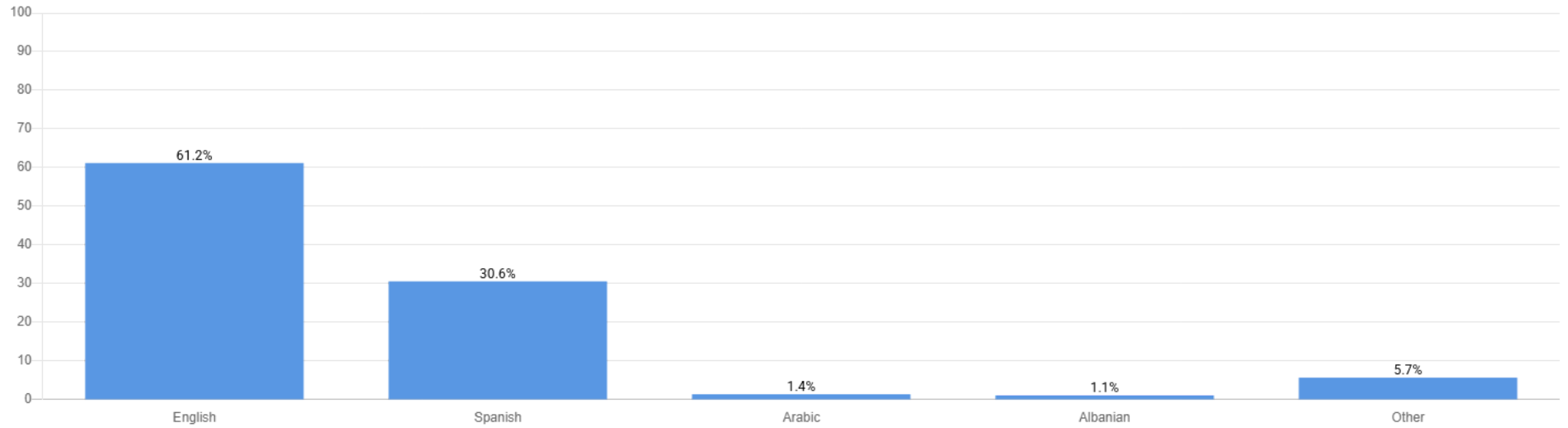

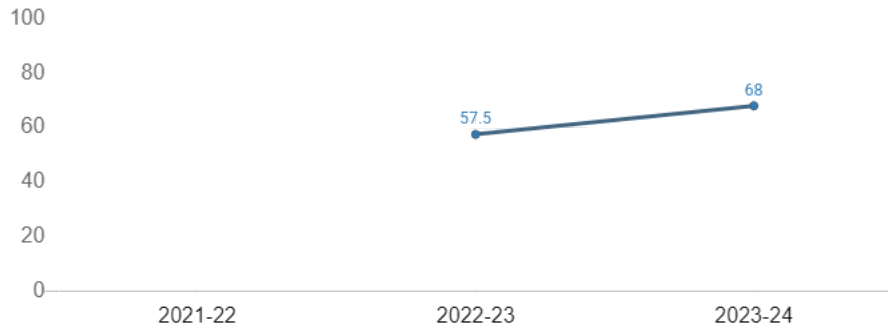

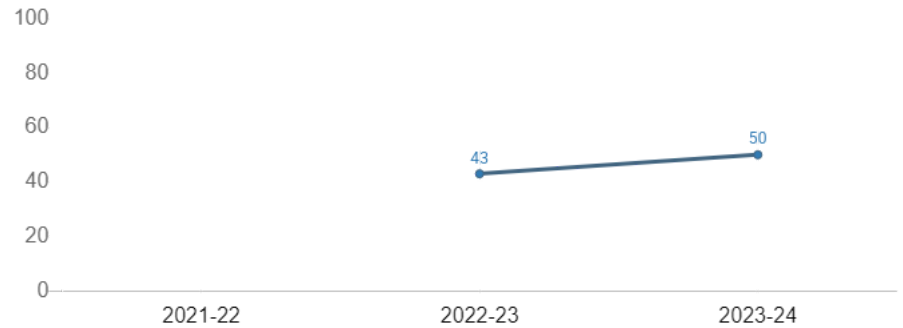

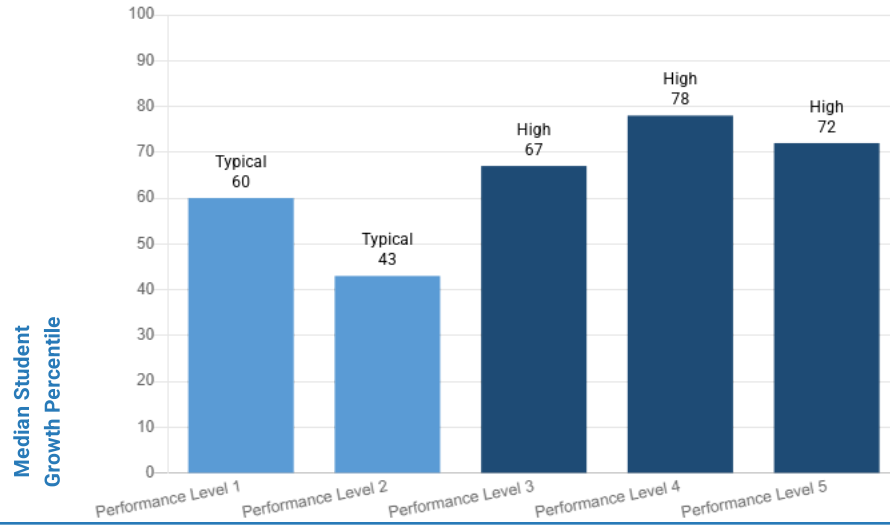

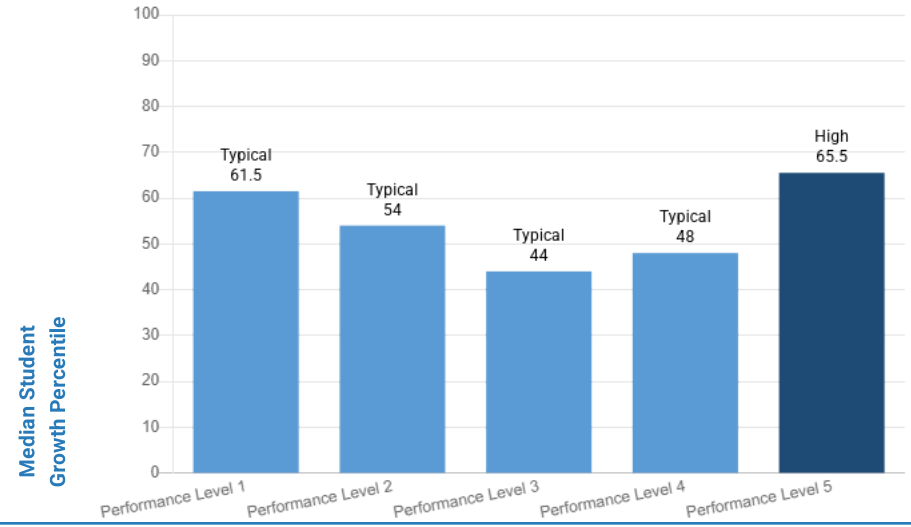

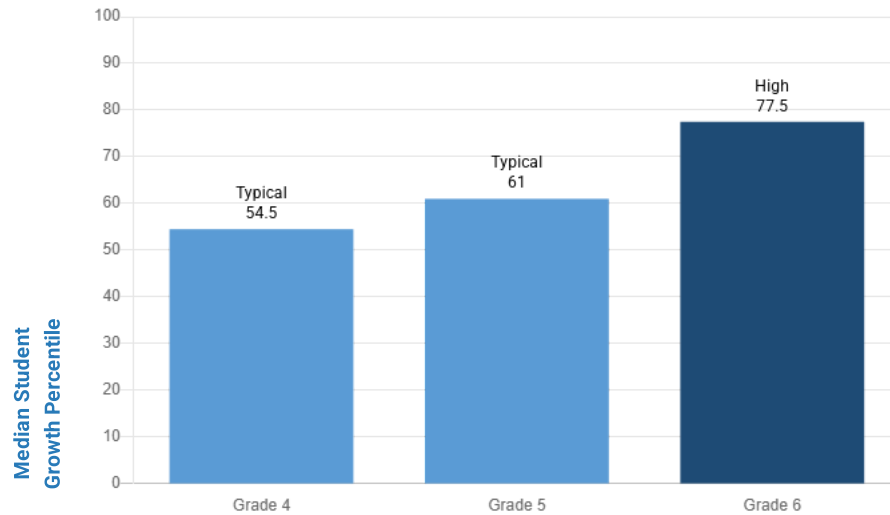

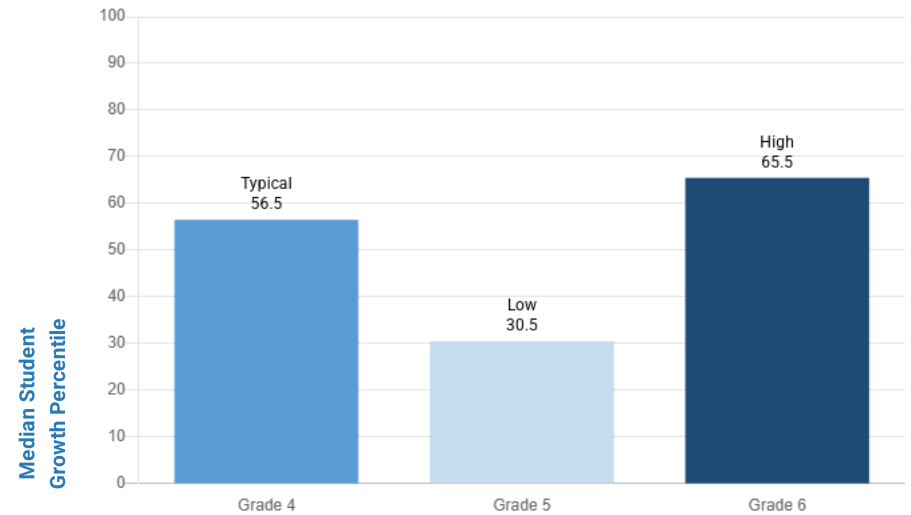

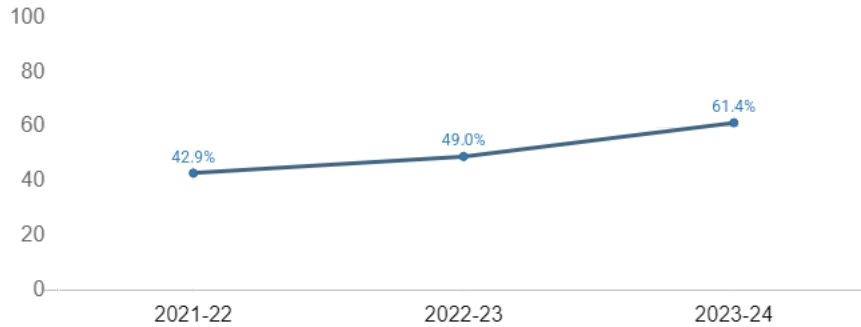

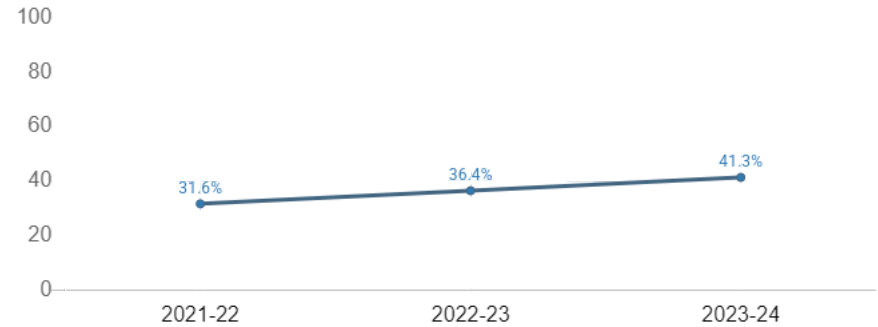
English Language Arts and Mathematics Performance Trends

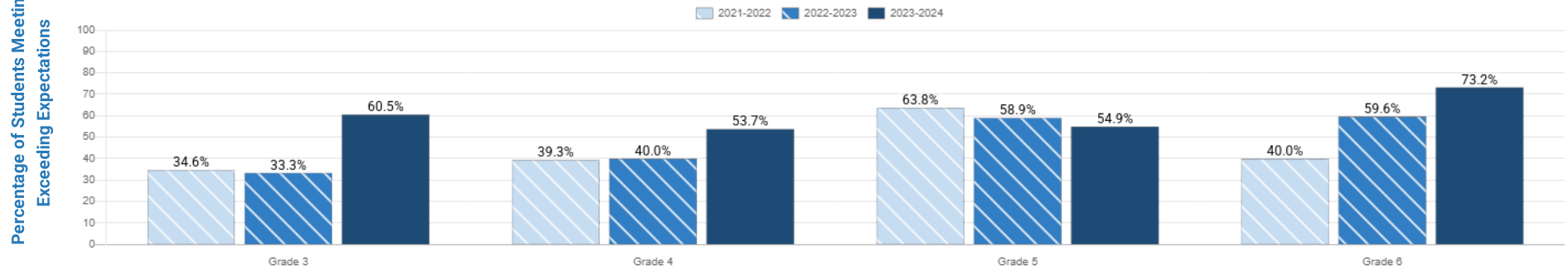

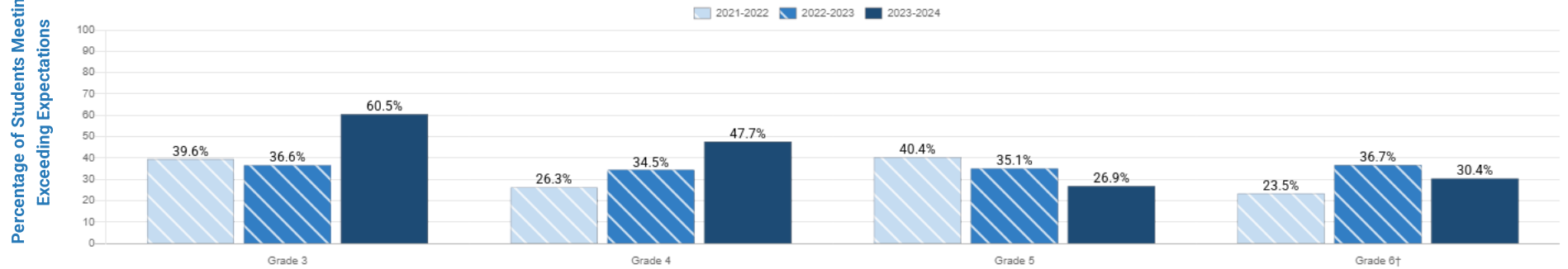

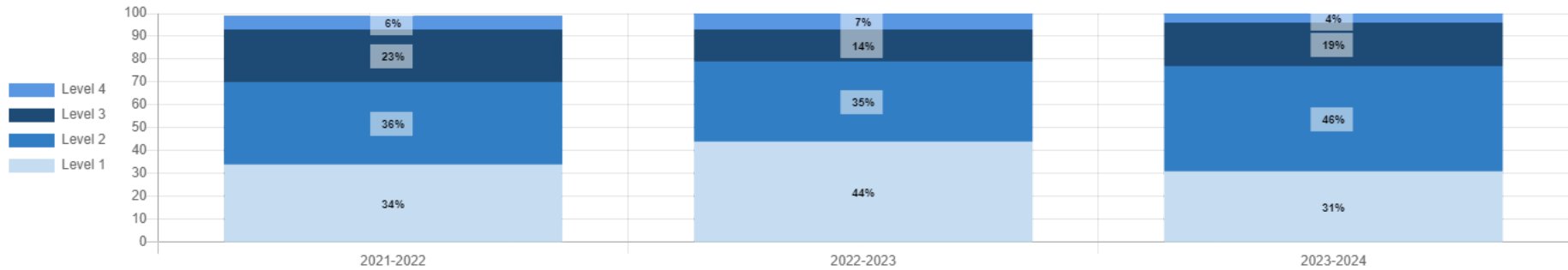

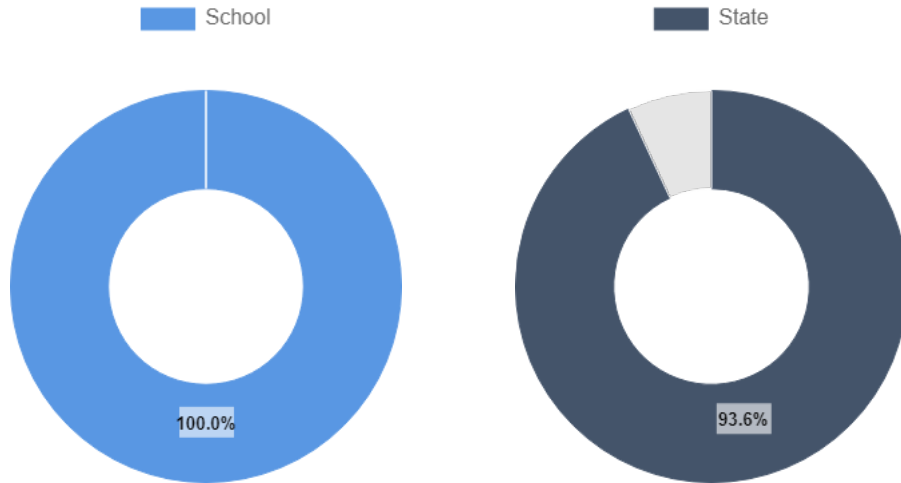

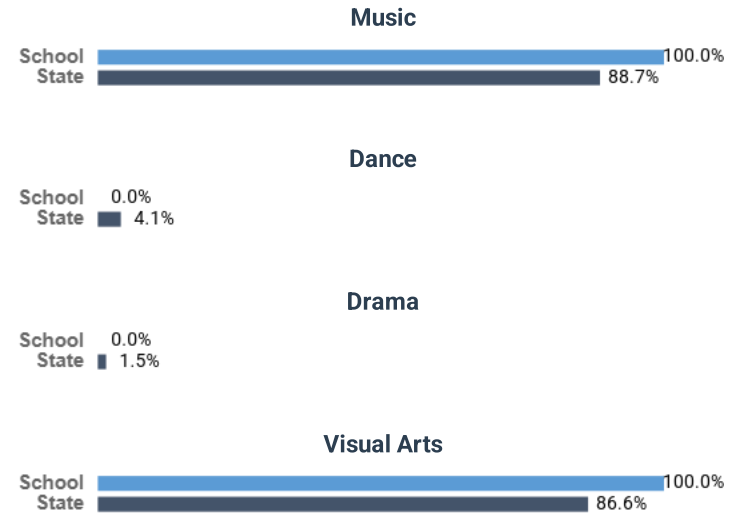

Students enrolled in one or more classes by discipline:



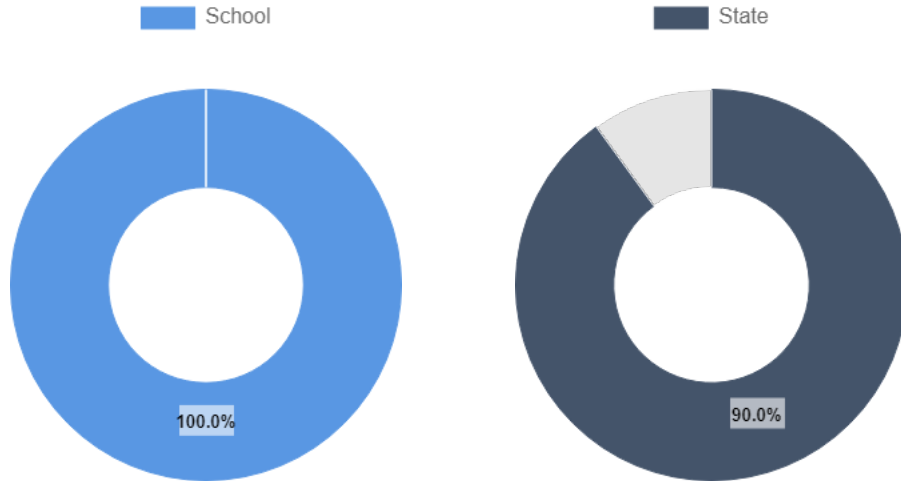

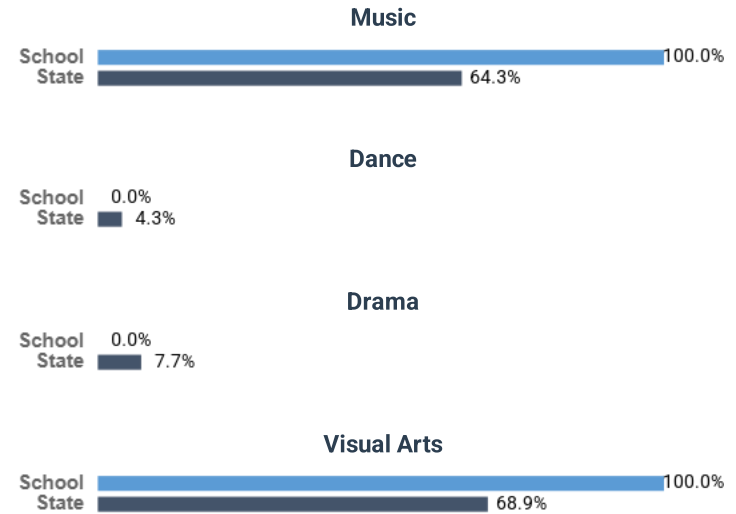

Students enrolled in one or more classes by discipline:



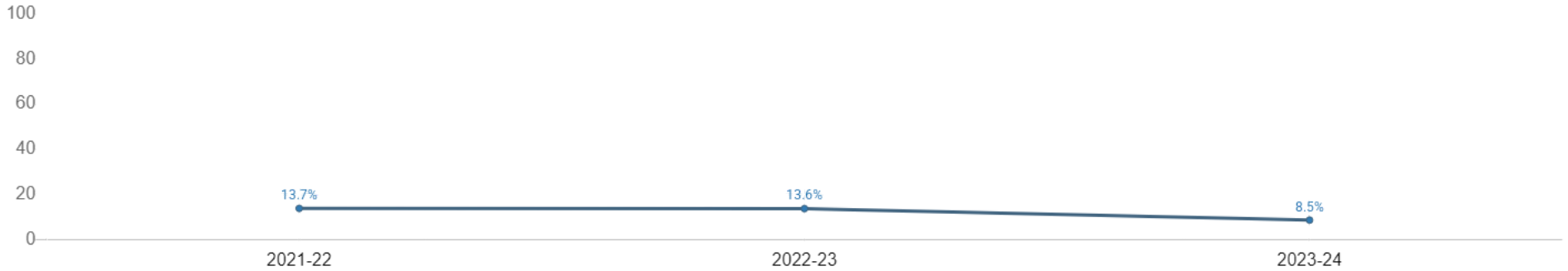

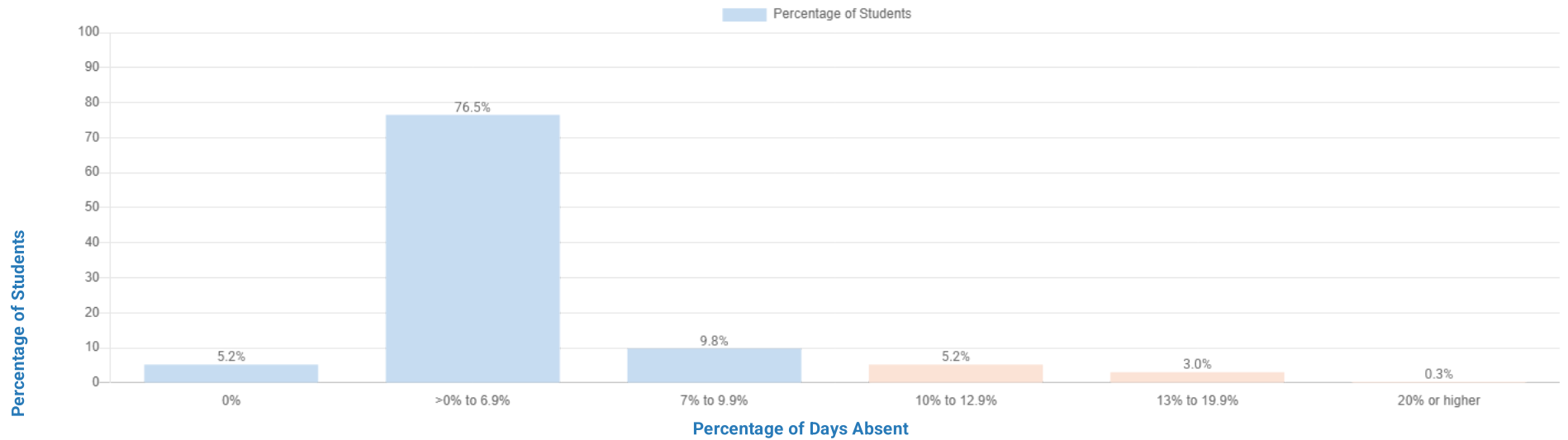

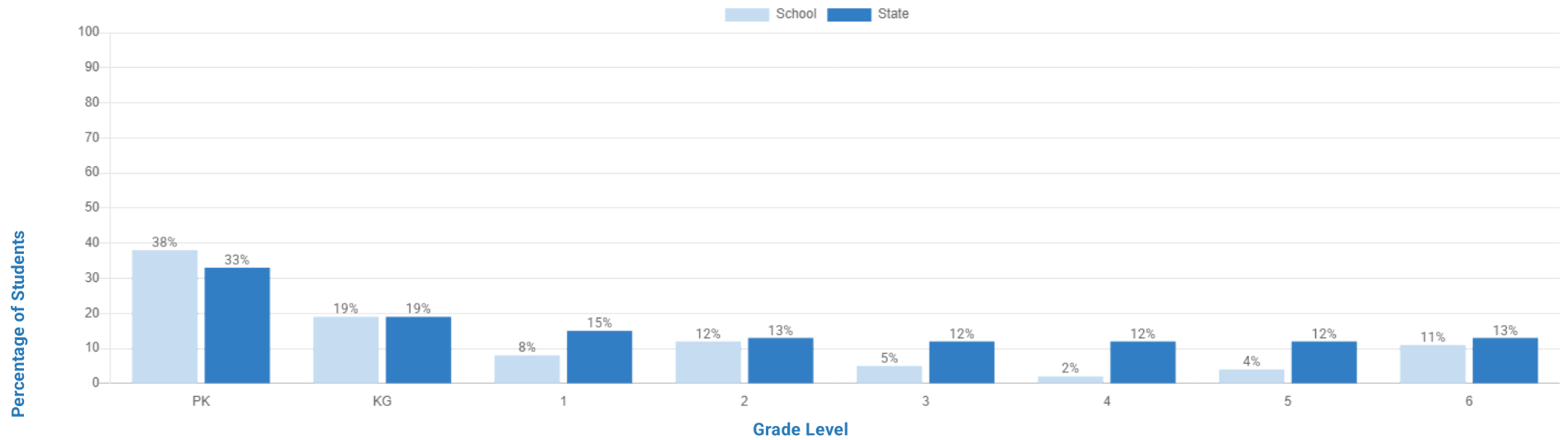

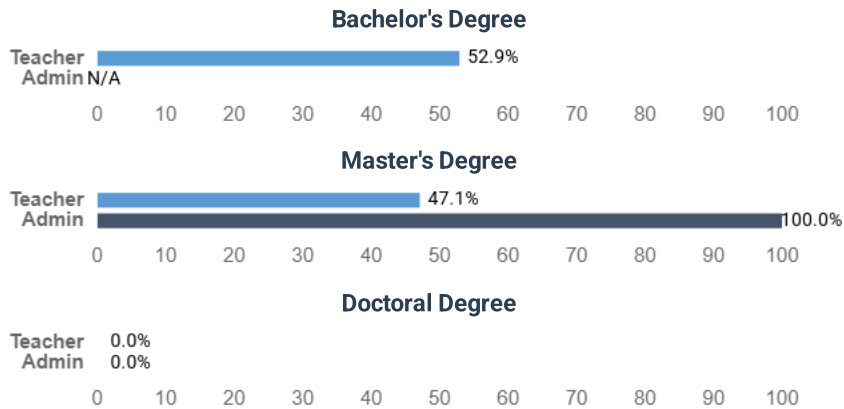

Accountability

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Elevate Science, Envisions Mathematics, and Fountas and Pinnell are some of the instructional components. A Social Emotional Learning program called Character Strong has been incorporated into our instruction which includes Social Justice for all learners to help foster student growth, well-being, and respect ourselves and others. A supervisor of elementary education was added to the district to support our curriculum and instruction. We have academic interventionists (LLI, Math, and Reading Interventionist) along with a revamped I&RS process to support struggling learners.

The district proudly supports the Ridgefield Park Before Care/After Care Program. This program provides an opportunity for parents to pay for both before and after school programs. The program is staffed with many members of the district and provides the students with a homework hour and a focus of learning social skills. In addition, supplemental academic instruction is provided to students through Roosevelt School's Title I After School Programs for Math and English Language Arts.



Staff and Professional Learning:

Professional development occurs throughout the school year via participation in PLCs, district professional development days and outside conferences and workshops. Topics include: Conquer Math, Coaching sessions from a supervisor, administration, and/or ELA Consultants, Social Well-Being, Supporting Students through Differentiated Instruction, I&RS, Recognition of Substance Abuse, Making Content Comprehensible for ELL's, Character Education, Online Apps and programs to engage remote learning to name a few.



Student Supports and Services:

We offer a wide range of student support services. English as a Second Language (ESL), Inclusion Classrooms, Resource Room, In Class Support, Basic Skills Instruction (BSI), and Gifted and Talented (G&T), Reading Intervention Specialist. We have a child study team, learning consultants, behaviorist, psychologist, speech pathologist, and a tremendous guidance counselor to assist and advocate for the students of Roosevelt School. Other programs include Intervention & Referral Services (I&RS), and a 504 Committee.

Student Health and Wellness:

Physical and mental health are promoted at Roosevelt School through the comprehensive Physical Education, Health, and School Counseling programs. Students engage in a variety of structured and unstructured physical activity during Physical Education classes and Recess. Mental health is promoted through monthly classroom guidance lessons, small group and individual counseling, conflict resolution meetings, and school-wide activities. Several teachers utilize the Character Strong platform in their classrooms to incorporate daily brain breaks and movement activities with their students. It is paramount that every student's well-being (social, emotional, physical, behavioral and creative developments) are balanced against their academic learning goals and personal interests.



Parent and Community Involvement:

The Roosevelt School PTA provides our children with educational programs and activities that enrich our students' experiences. The members of our PTA plan and present special events such as Book Fairs, grade level field days, assemblies, fundraisers, planners, programs, and field trips. Our students in all grades are provided with take home folders and supplies. Through social media and email blasts the community is well informed and supportive. The Roosevelt Community (Parents and Staff work together to foster the best opportunities for the student learners. Additionally, Roosevelt School has a wonderful partnership with the local fire departments in town and the public library.

Facilities:

Roosevelt School was built in 1921. The building has four levels with a total of 24 large classrooms. The gymnasium and cafeteria are on a separate level which prevents distractions from classroom learning environments. The cafeteria was created to allow for a more functional gymnasium for scheduling productivity and recess all year long without the concern of weather. This also helps create additional space for assemblies and programs. A large playground is equipped with basketball courts along with a very large fenced in field with a jungle gym and backstops for baseball/softball. Recent Facility Improvements include, new energy efficient windows, new fencing and blacktop, Colorful and engaging lining on the blacktop to promote play and learning, Secure Vestibules and Bathroom Renovations. Current Work in Progress includes Door Replacements and HVAC.



School Safety:

The Board of Education and Village of Ridgefield Park promote school security and take it very seriously. A consistent Police Officer is stationed at Roosevelt School on a daily basis who is present before, during, and after students are in the building. The school is also equipped with numerous digital video surveillance cameras which monitor and record 24 hours a day. New cameras are added each year to add additional coverage of the building and grounds. School drills are conducted within the guidelines of New Jersey. All staff members receive professional development on the state guidelines and expectations of the school building for all members' safety. The main office also scans every visitor who enters the school while they are in a secured vestibule.



Technology and STEM:

Roosevelt School continues to increase its technology platform with wireless services including iPads or Chromebooks for every student (K-6) and laptop computers for the teaching staff member. Audio devices have also been added to each classroom to help amplify teacher voices. The district purchases licenses for many applications such as Screencastify, Pear Deck, Flipgrid, IXL and EdPuzzle. Many of our curriculum including Envision Math, Elevate Science, and Social Studies is moving to online textbooks making the materials readily available for students and parents to gain access to assignments, practicing, and other resources.

In order to address learning loss, Roosevelt school has been part of a district initiative to provide additional support in ELA and math instruction for students who are identified through collaboration with our guidance counselor and data reviewed from our benchmark assessment tool, LinkIt. Our summer programs are used to help reduce any learning loss or gaps. Roosevelt staff members have also worked with students in regard to reading support, homework hotline, and SEL clubs.

Other Information:

Roosevelt School has approximately 350 students in grades PreK-6. Data-driven decisions continue to shape instructional practices and guide lesson planning. Formative and summative assessments are used to gauge student abilities and plan for appropriate instruction. A number of different types of benchmark tests are used throughout the year to assess the students' academic achievement in reading and math. Through these assessments, teachers design data-informed differentiated lessons to meet each student's needs. Furthermore, with the data gleaned from New Jersey's Standardized Assessments, teachers and administration work together to identify gaps in academic instruction to ensure our obligation in preparing students for future schooling is realized. To complement the rigorous curriculum in the core academic subjects, our students participate in other curricular programs including Physical Education/Health classes several times a week, Music, Technology, Art, Dance and World Language. Students have an opportunity to participate in Band. We consider these classes just as important in the development of our students as the core classes. All subjects now infuse technology into the curriculum through an integrative approach, which ensures students are keeping up with technological trends that support research, discovery, socialization, presentation, and creation. Roosevelt School is a Google Apps for Education School that gives every student access to an iPad or Chromebook, making us a successful 1:1 program.
