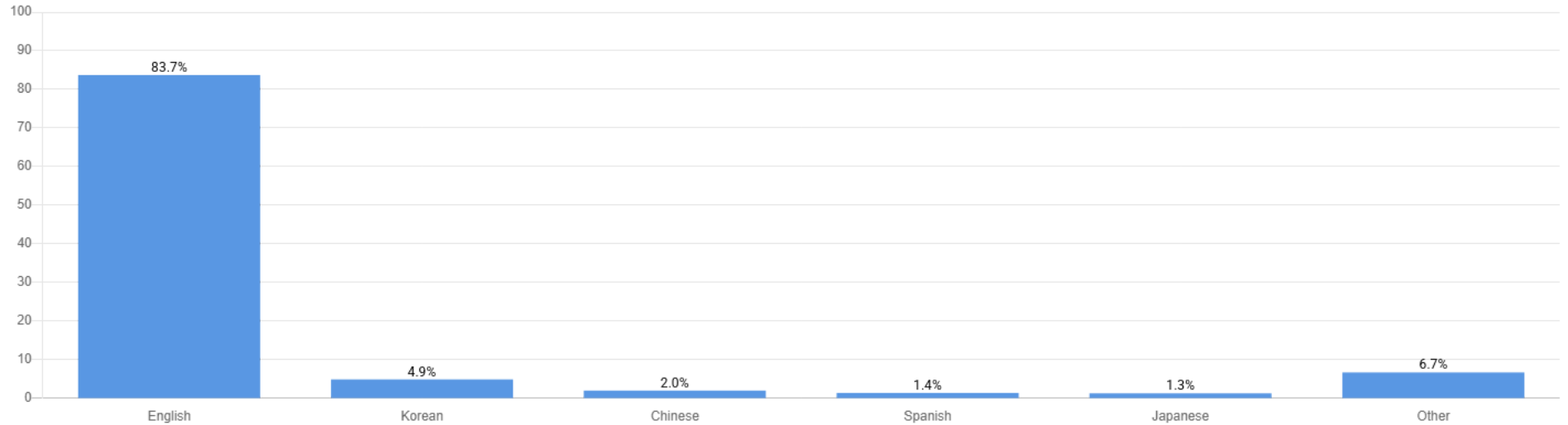

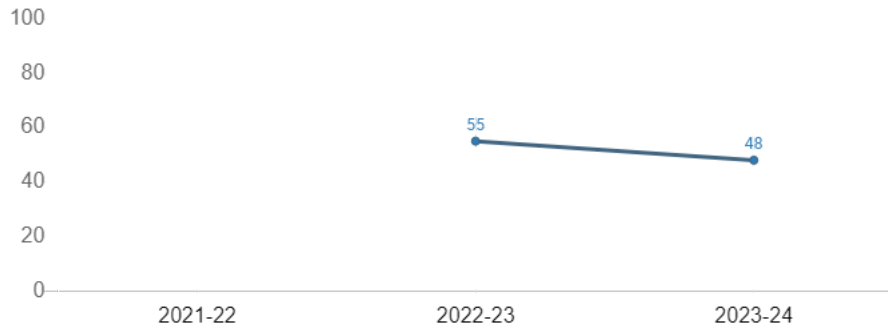

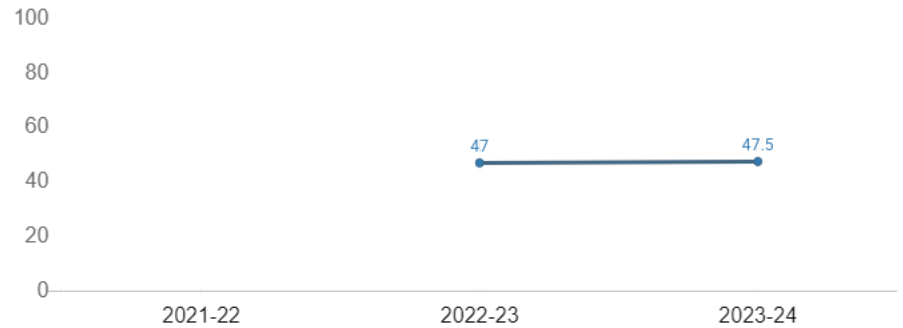

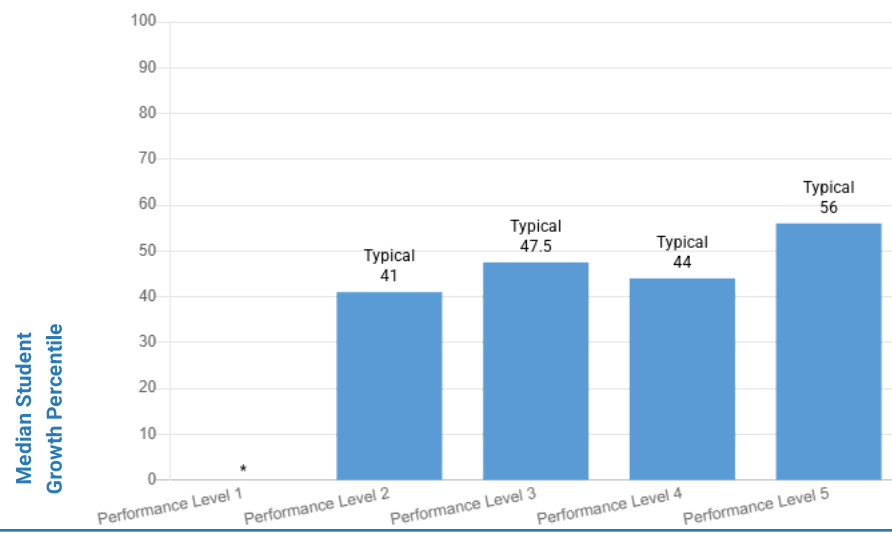

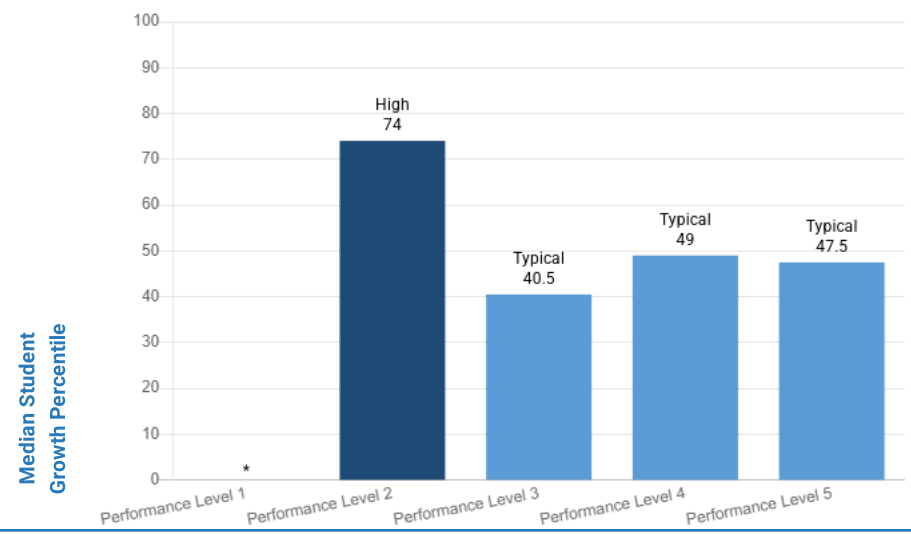

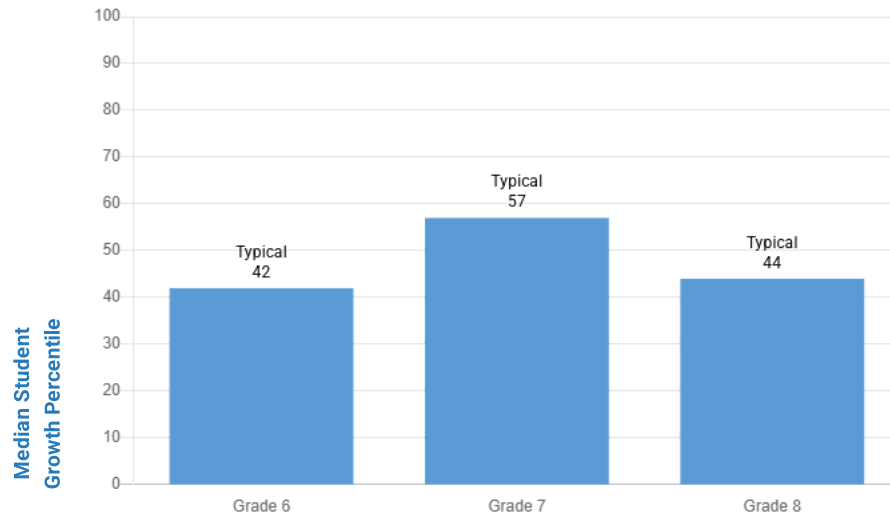

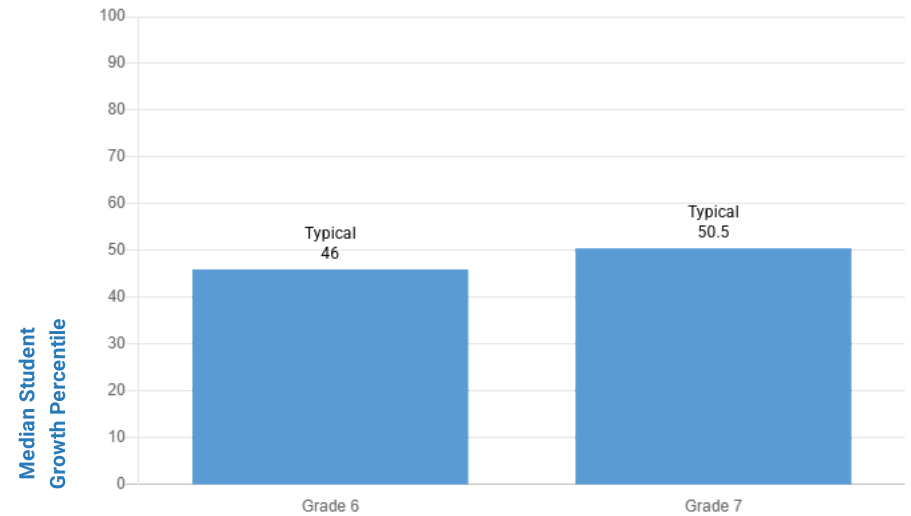

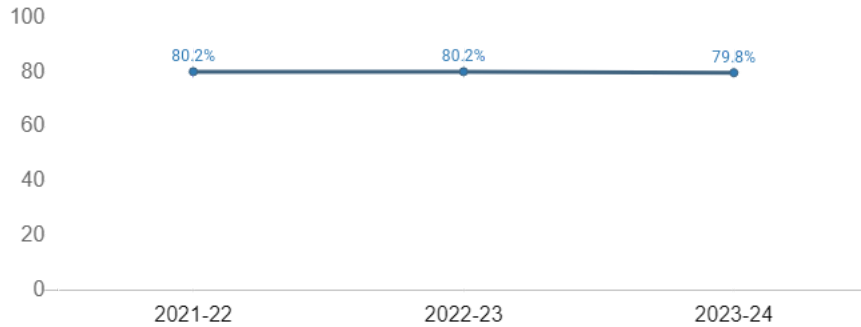

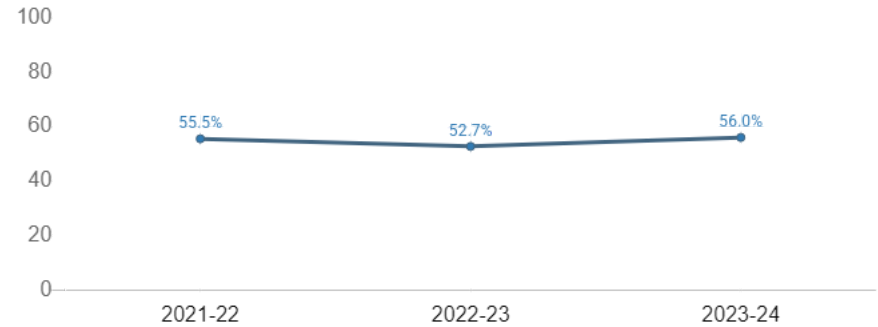
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 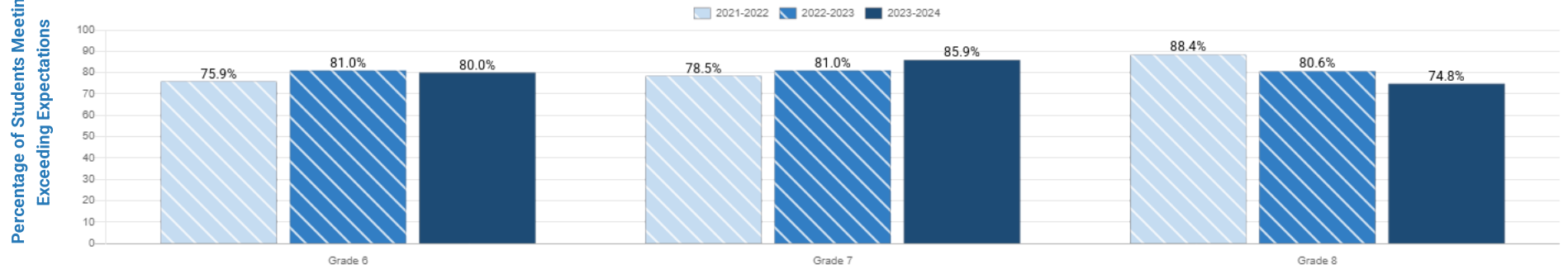

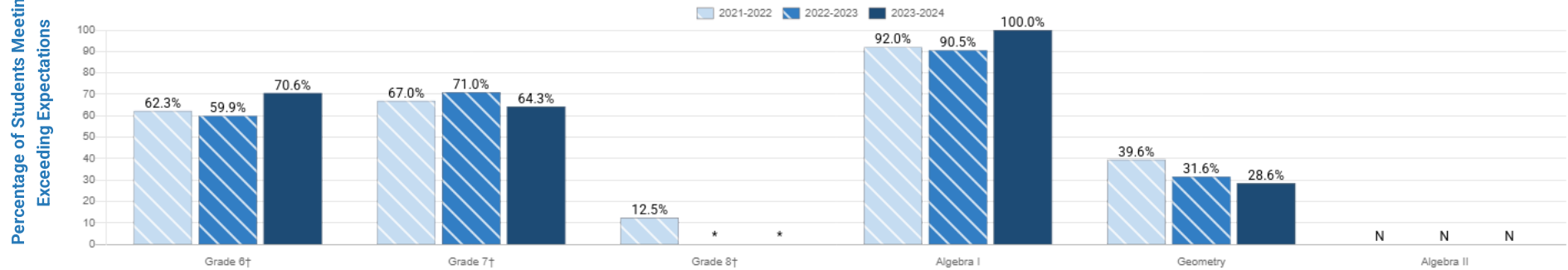

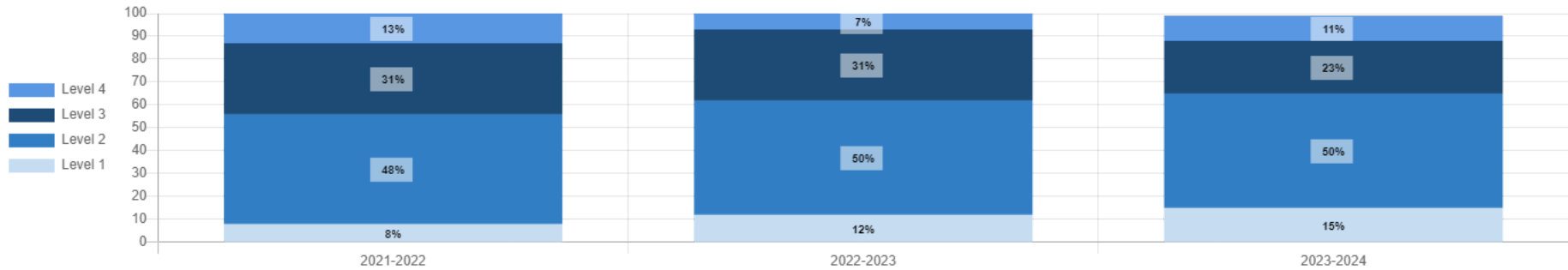

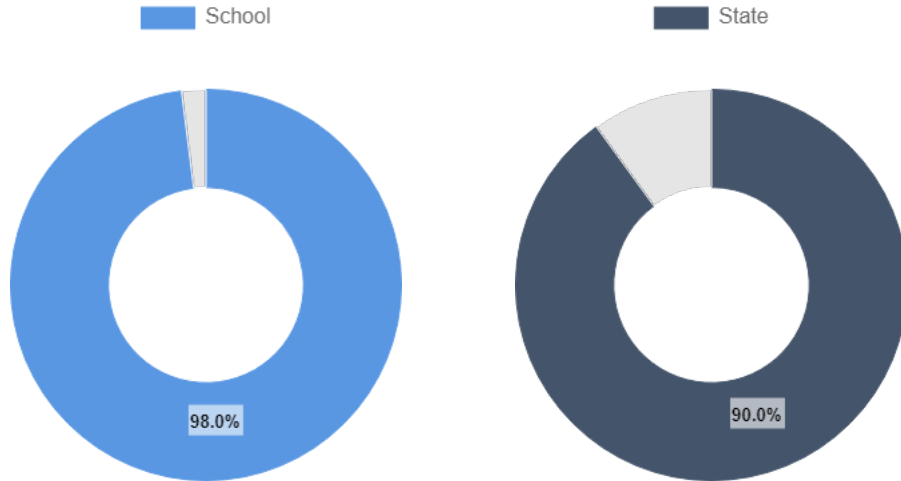

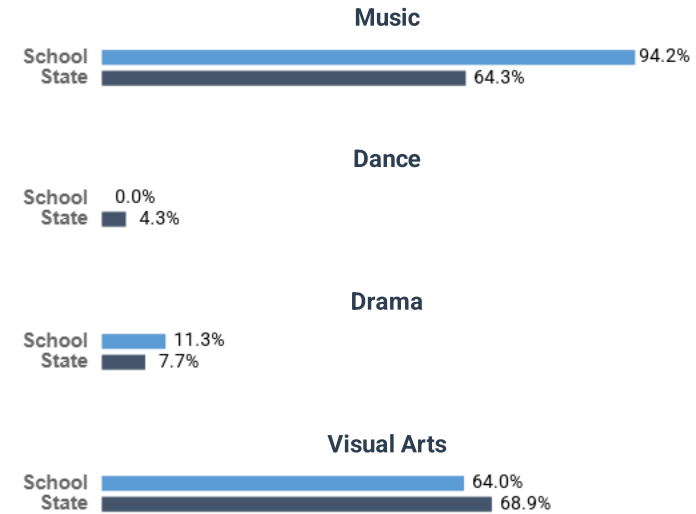

Students enrolled in one or more classes by discipline:



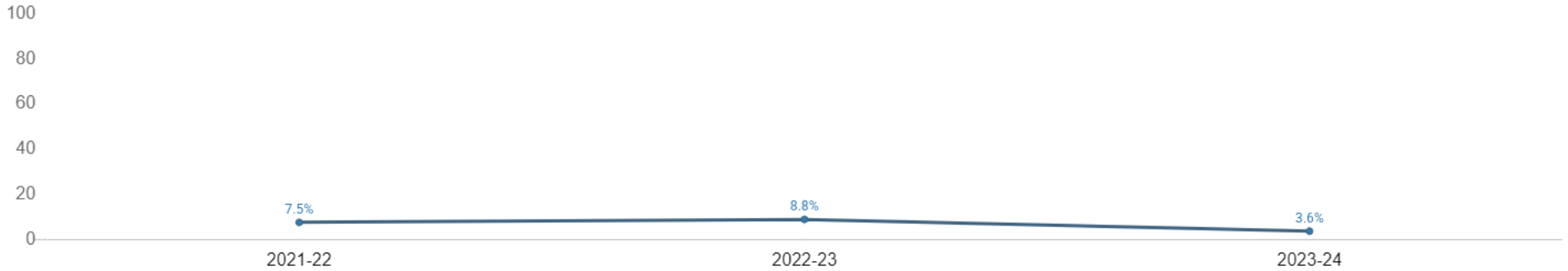

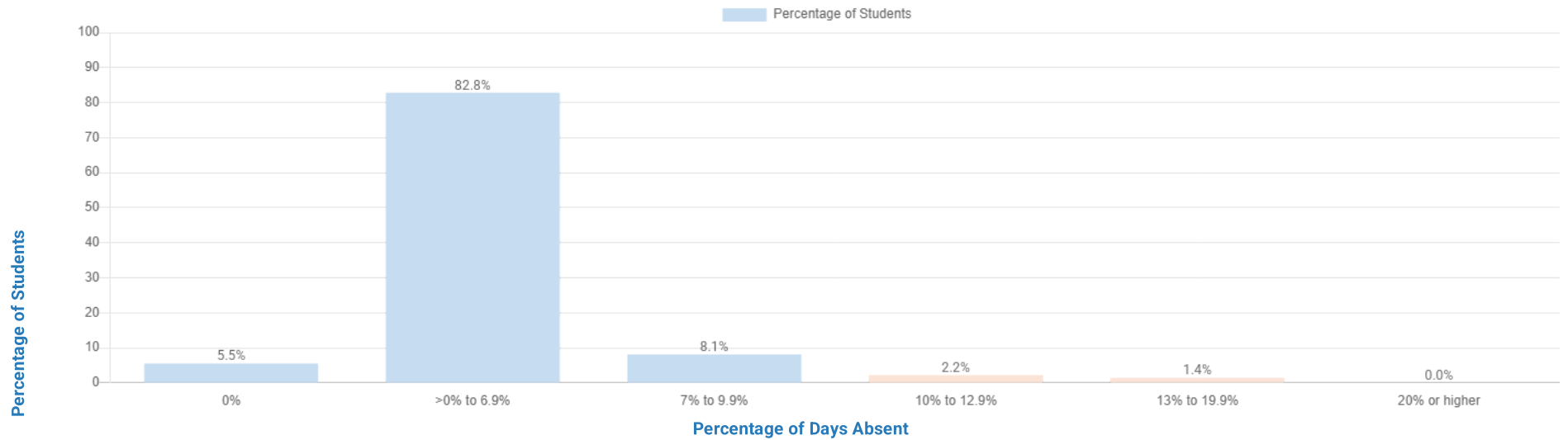

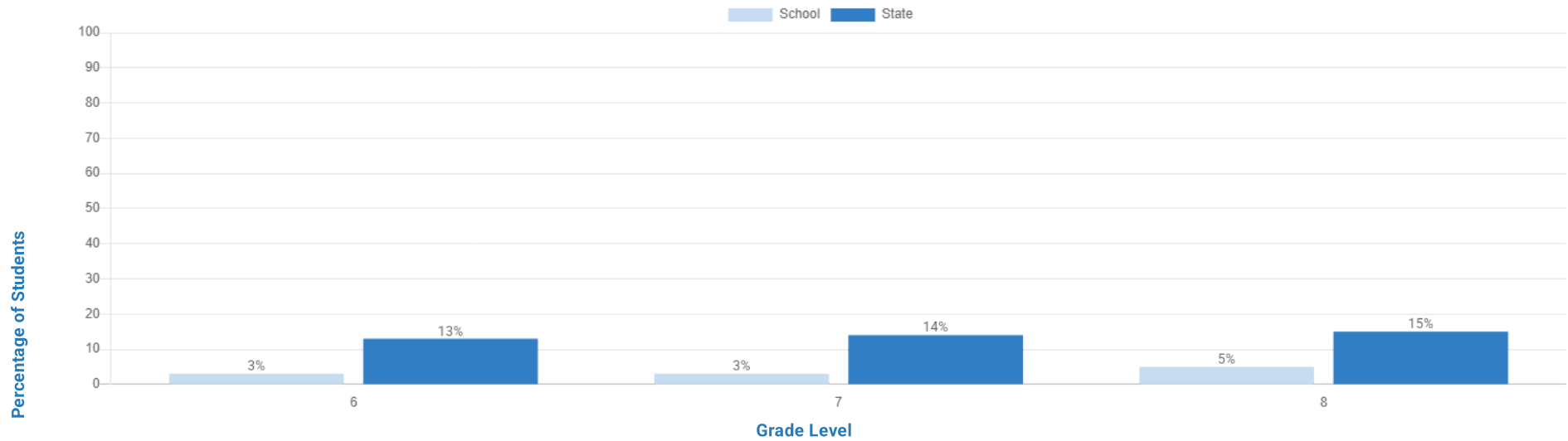

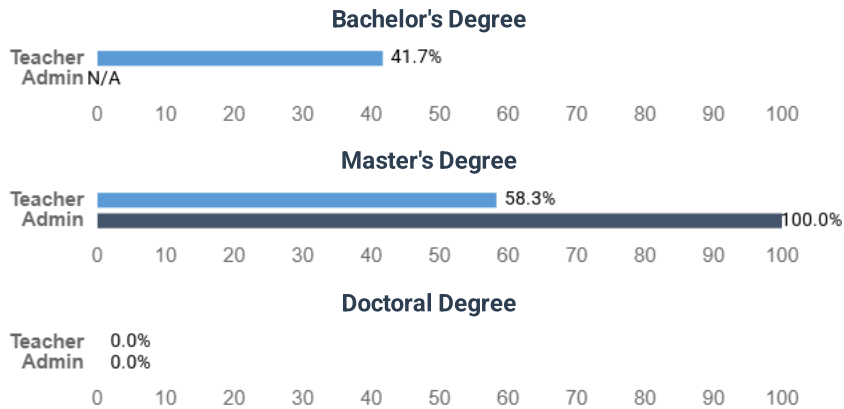

Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

Accountability

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

The NJDOE identified schools for ATSI status based on data from the 2022-2023 school year, so schools will not be identified for ATSI status based on data from the 2023-2024 school year. Schools will be identified for TSI status based on data from the 2023-2024 school year, since that is required annually. If at least one student group did not meet all targets and also did not meet all targets in the 2022-23 school year, then the school will be identified as requiring TSI.

Student Supports and Services:

The district offers an array of support services to meet the needs of diverse learners. This includes comprehensive programs for Special Education students, Multilingual Learners, students with 504 Plans and students with Health Plans. The district uses Intervention and Referral Services and offers Basic Skills Instruction. Guidance Counselors and Child Study Teams work closely with students and their families, and teachers consistently integrate differentiated instructional strategies. The district has partnered with West Bergen Mental Healthcare, a fully licensed and accredited mental healthcare organization, to provide a school-based counseling program that directly supports students and their families. The therapists are experienced in youth development, therapy and case management, and utilize a variety of effective models to develop skills and strategies for personal growth.



Student Health and Wellness:

Ridgewood Public Schools provides a comprehensive and progressive wellness program for students in grades K-12, aligned with the New Jersey Student Learning Standards for Comprehensive Health and Physical Education. Additionally, a robust Social-Emotional Learning (SEL) curriculum is available for students in PreK-8, with dedicated support time integrated into the schedules of middle and high school students.



Parent and Community Involvement:

Ridgewood Public Schools consists of 11 well-kept district facilities dating from 1894-1966. There have been multiple additions over time to ensure a positive and modern-leaning learning environment for the Ridgewood educational community.



School Safety:

Ridgewood Public Schools continues to add to our already significant school safety and security protocols. The district funds the position of School Security Specialist. Three Class III Officers shared by the schools are funded by the district and local municipality. All of our buildings have lockdown shades installed throughout, building exterior management systems, and communication systems to facilitate management of emergency protocols.



Technology and STEM:

The district offers a comprehensive STEAM education program spanning grades 3-12, combining both required and elective courses to foster students' engagement and skills in science, technology, engineering, arts, and mathematics. Middle and high schools utilize dedicated makerspace classrooms to deliver hands-on, innovative STEAM curricula, supporting creativity and problem-solving through project-based learning. Technology is seamlessly woven throughout the PreK-12 curriculum, enhanced by professional training for teachers in instructional technology to improve the overall learning experience. Recognizing the growing importance of computer science, the district is expanding its course offerings at both the middle and high school levels, preparing students with skills for a technology-driven future. Additionally, high school students have access to robotics courses, equipping them with hands-on, problem-solving experiences that develop computational thinking and engineering skills.

Other Information:

Benjamin Franklin Middle School (BF) seeks to maximize the unique potential of every learner. We do this by educating the whole child, including the social, emotional, and intellectual development of our students. Our standards-based curriculum emphasizes authentic and rigorous learning experiences, problem-solving, multiple intelligences, and cooperative and project-based learning throughout our instructional program. Both collaborative and consult teaching models are infused throughout our classes and continue to be a highlight of our program. We have fully embraced technology at BF. We have implemented a "one-to-one" initiative, and each of our students has their own Chromebook to use during the school day as well as at home. In this regard, we are very conscious of the number of hours students spend online and strive to find a good balance between screen and non-screen time. All of our students have Google accounts and can seamlessly work between home and school, as well as collaborate with their peers and teachers. We have a makerspace for STEAM activities within the school, and we added Design Thinking classes to the curricula. Students can choose from three world language options in grades 6-8: French, Latin, and Spanish. BF provides a full range of services to promote the social/emotional growth of our students including guidance counseling, student assistance counseling, and psychological and social work services. Additionally, West Bergen Mental Healthcare provides services to students and staff five days a week. BF emphasizes its commitment to nurturing a caring, supportive social/emotional learning environment, and the concepts of respect and responsibility are infused throughout our entire instructional program.
