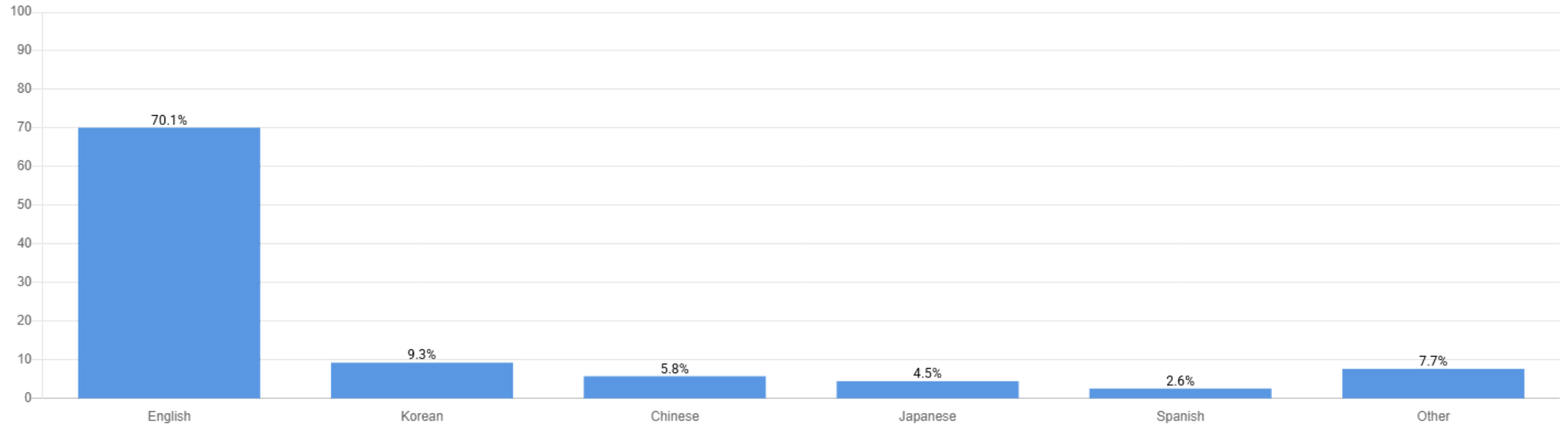

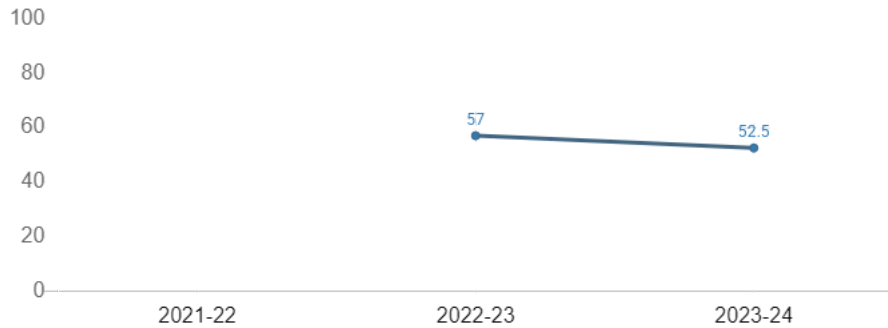

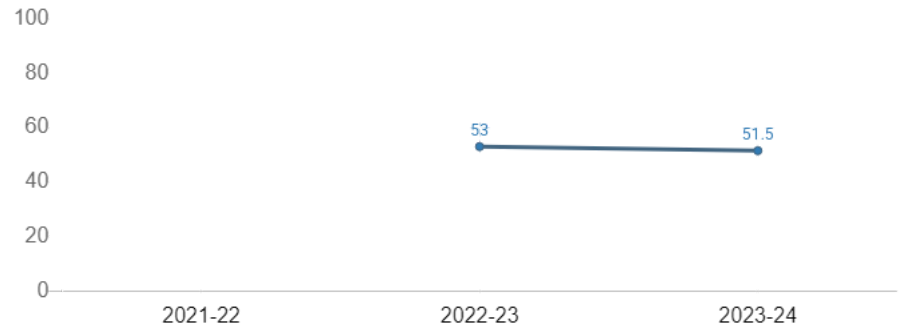

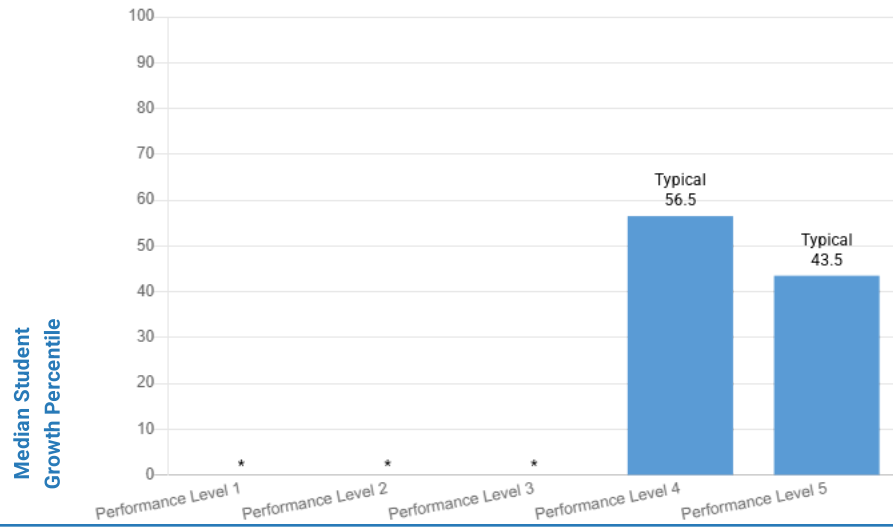

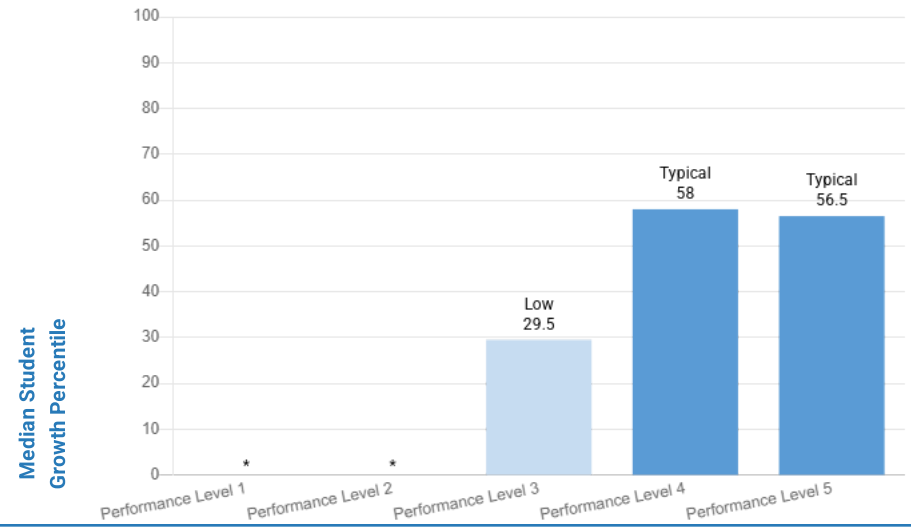

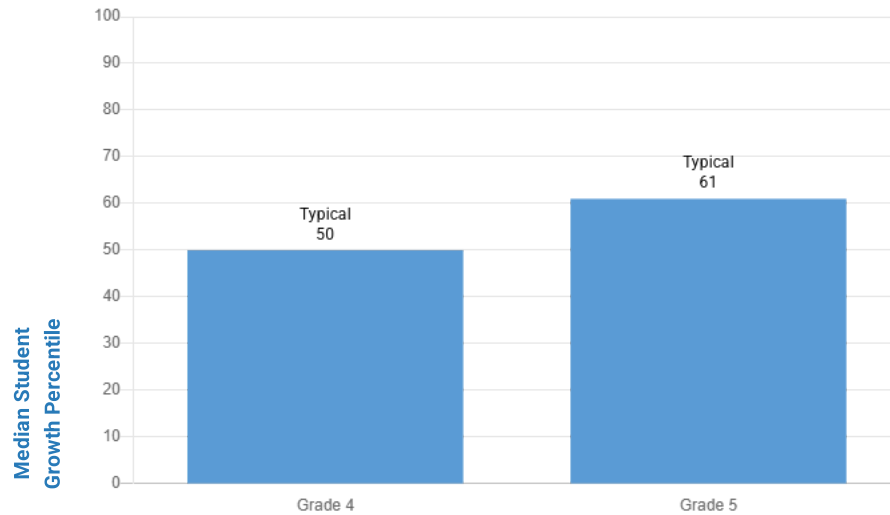

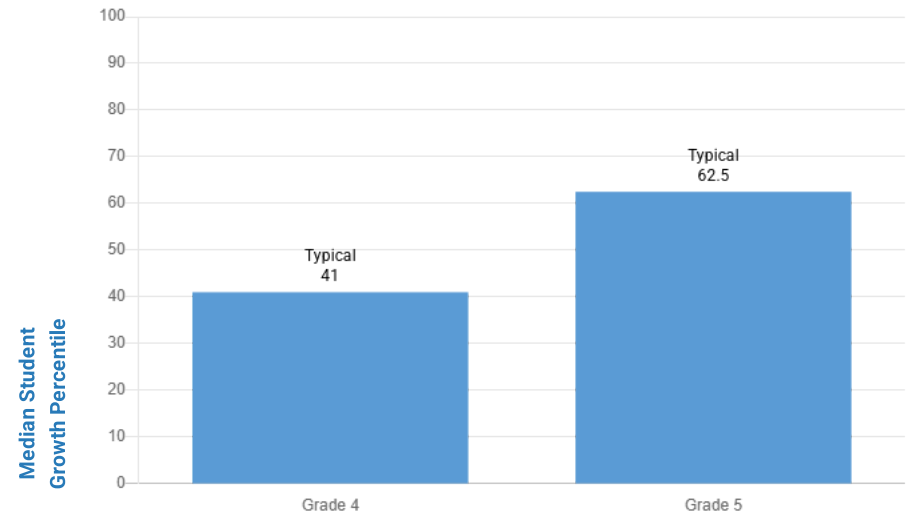

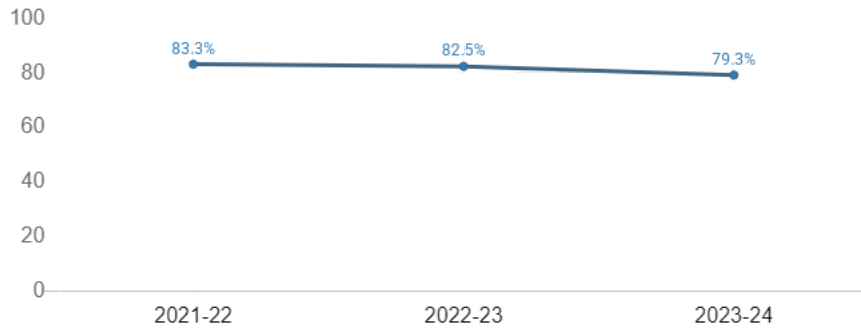

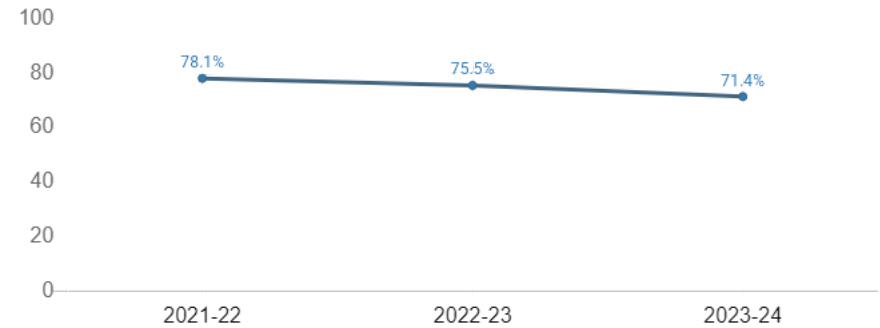
English Language Arts and Mathematics Performance Trends

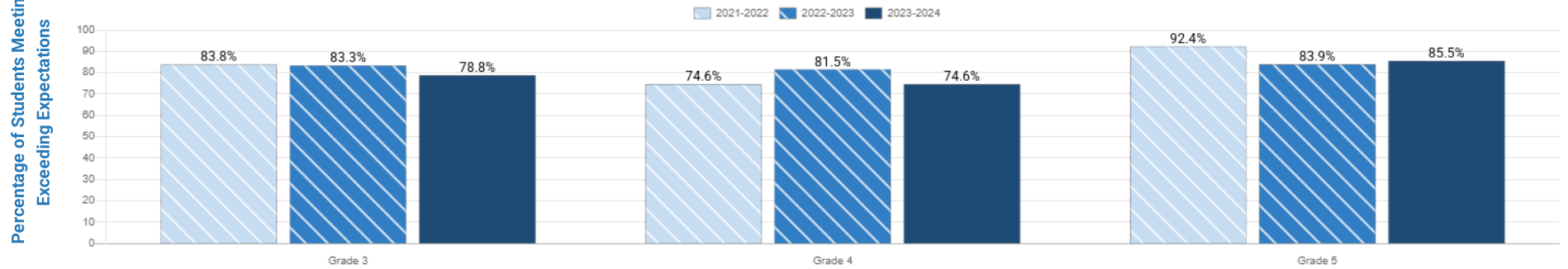

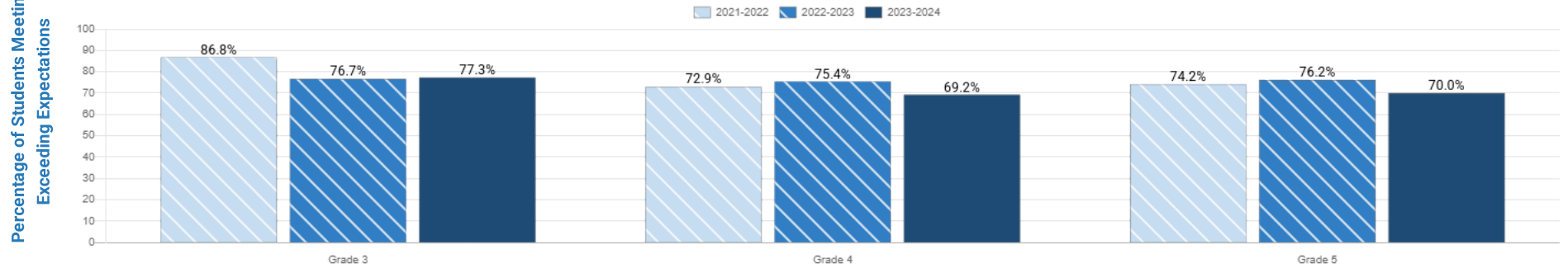

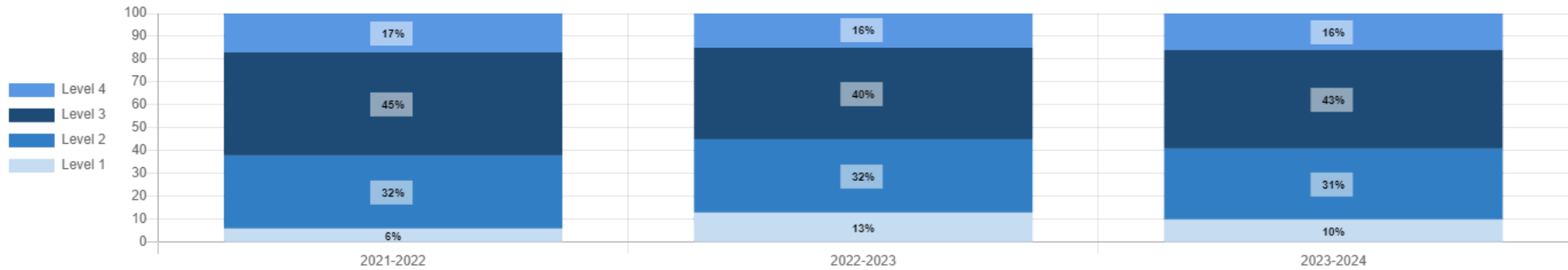

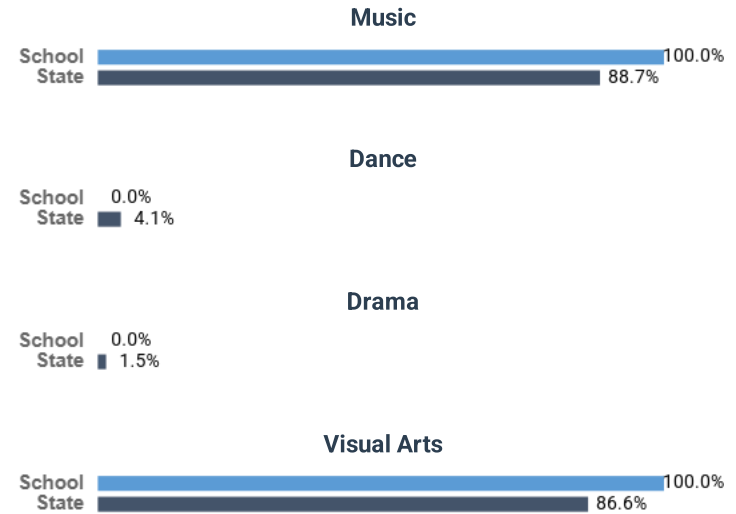

Students enrolled in one or more classes by discipline:



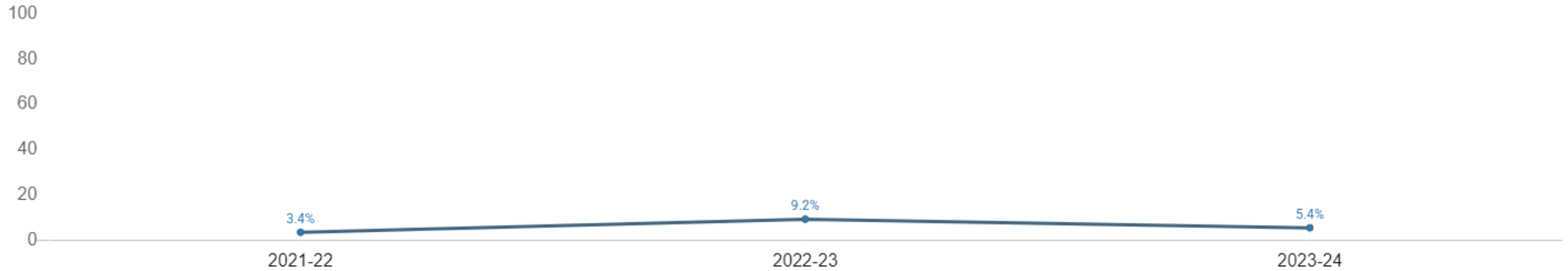

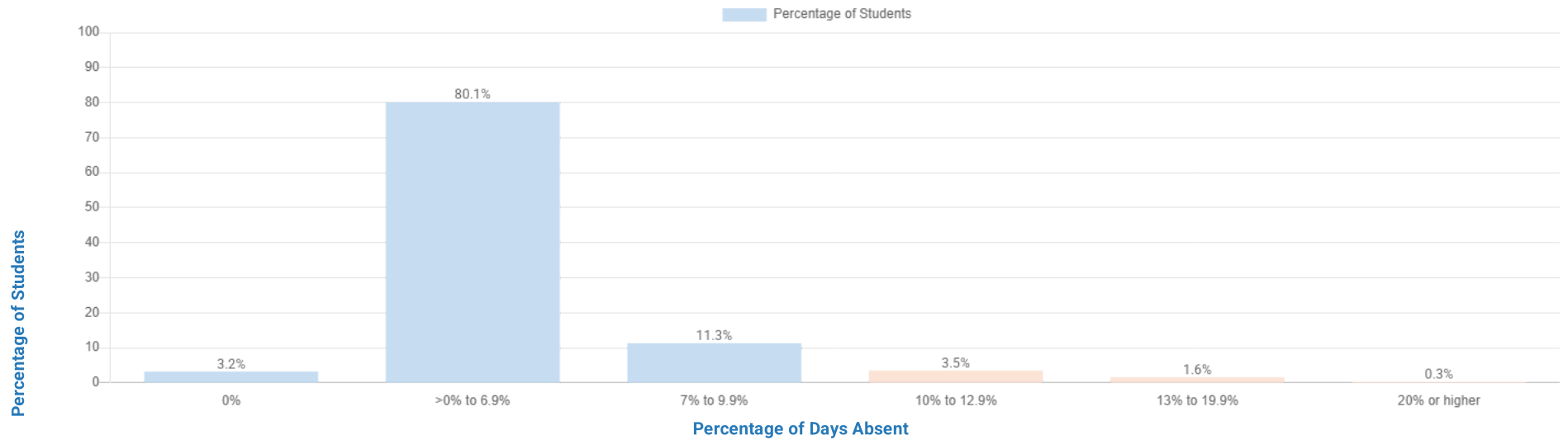

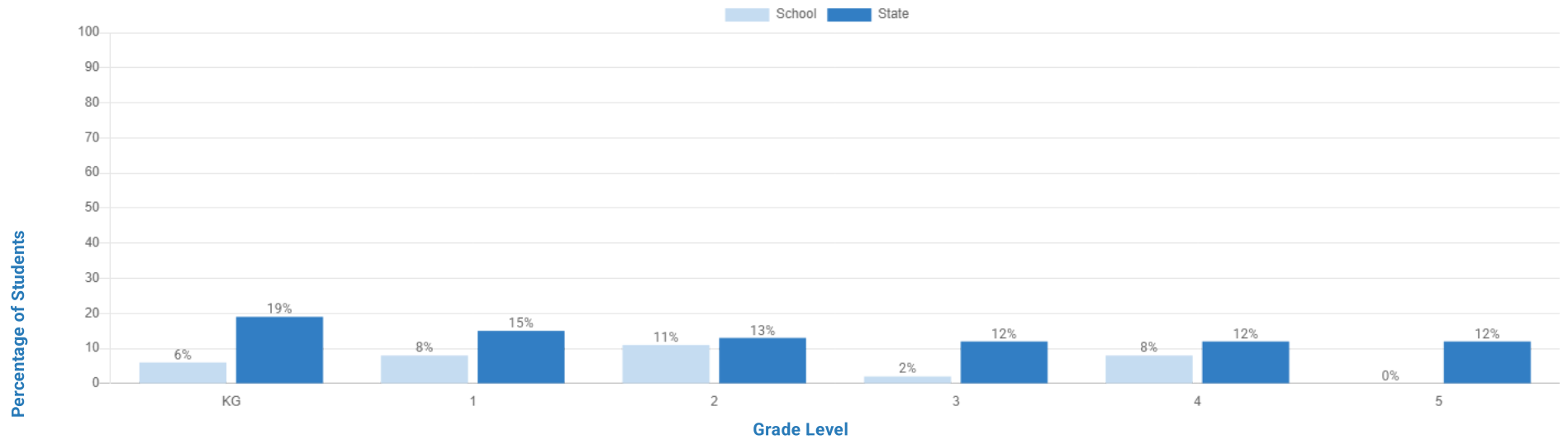

Key terms for staff data:

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

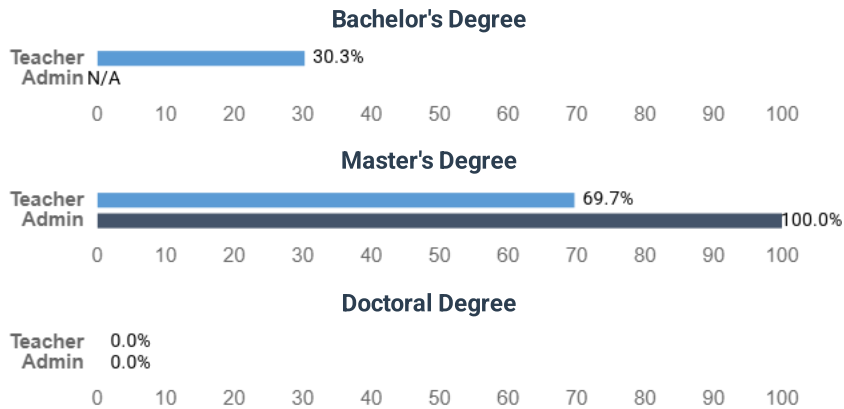

This includes comprehensive programs for Special Education students, Multilingual Learners, students with 504 Plans and students with Health Plans. The district uses Intervention and Referral Services and offers Basic Skills Instruction. Guidance Counselors and Child Study Teams work closely with students and their families, and teachers consistently integrate differentiated instructional strategies. The district has partnered with West Bergen Mental Healthcare, a fully licensed and accredited mental healthcare organization, to provide a school-based counseling program that directly supports students and their families. The therapists are experienced in youth development, therapy and case management, and utilize a variety of effective models to develop skills and strategies for personal growth.



Student Health and Wellness:

Ridgewood Public Schools provides a comprehensive and progressive wellness program for students in grades K-12, aligned with the New Jersey Student Learning Standards for Comprehensive Health and Physical Education. Additionally, a robust Social-Emotional Learning (SEL) curriculum is available for students in PreK-8, with dedicated support time integrated into the schedules of middle and high school students.

The district offers a comprehensive STEAM education program spanning grades 3-12, combining both required and elective courses to foster students' engagement and skills in science, technology, engineering, arts, and mathematics. Middle and high schools utilize dedicated makerspace classrooms to deliver hands-on, innovative STEAM curricula, supporting creativity and problem-solving through project-based learning. Technology is seamlessly woven throughout the PreK-12 curriculum, enhanced by professional training for teachers in instructional technology to improve the overall learning experience. Recognizing the growing importance of computer science, the district is expanding its course offerings at both the middle and high school levels, preparing students with skills for a technology-driven future. Additionally, high school students have access to robotics courses, equipping them with hands-on, problem-solving experiences that develop computational thinking and engineering skills.

Other Information:

Hawes Elementary School is a caring learning community with students in grades kindergarten through five. Visitors immediately sense the warmth and spirit of cooperation. Parents and teachers work together to provide an academically challenging curriculum and culturally rich environment for our children. K-5 English Language Arts is built on a gradual release instructional framework, which transfers responsibility from teacher to student. Literacy instructional components consist of clear, predictable, responsive structures. Reading components include interactive read-aloud, shared reading and independent reading. Writing components include modeled writing, shared and interactive writing and independent writing. Foundational components include word study and language conventions. The elementary mathematics program combines the practice of foundational skills, deep conceptual understandings, and critical thinking with problem solving. Our goal is for the students to apply their knowledge of mathematics to real-life situations in an accurate, efficient, and thoughtful manner. Enrichment activities, as well as support programs, provide the children with an exemplary experience in mathematics. An inquiry-based science program gives our students opportunities to make predictions, collect data, take notes, graph information, reach conclusions, and create hypotheses. Hands-on experiences with earth, environmental, life, and physical science materials allow students to develop both process and thinking skills and apply them in making decisions and solving real-world problems. The study of communities, cultures, and history is the basis of our social studies program. Grade level teams implement units of study designed to allow children to experience the traditions of others and life in the past. Infused in all lessons is the importance of social emotional learning and showing respect to all individuals and groups.
