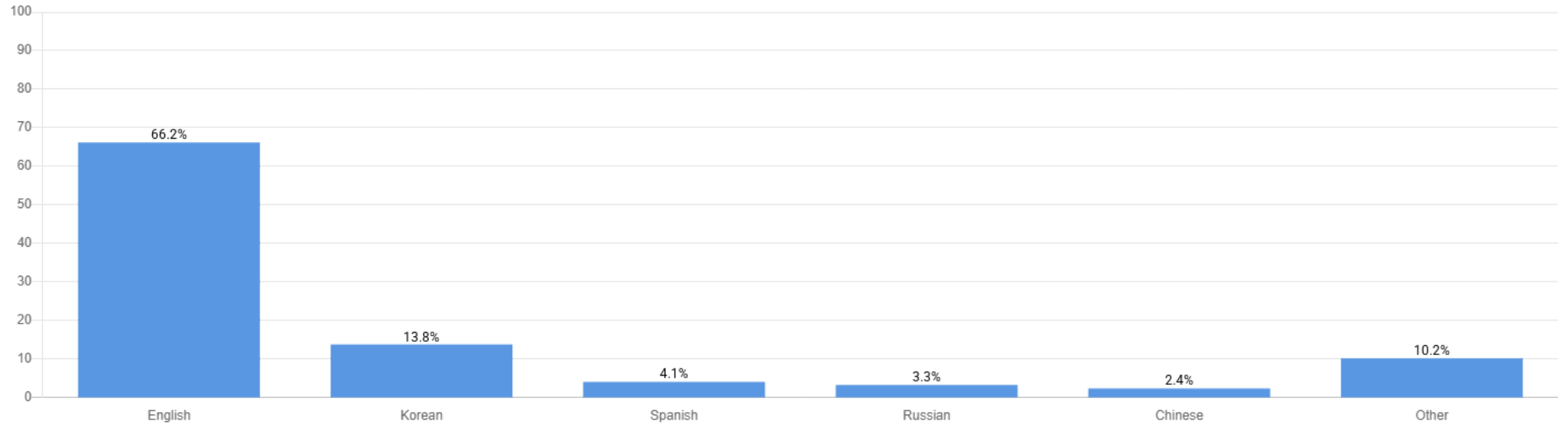

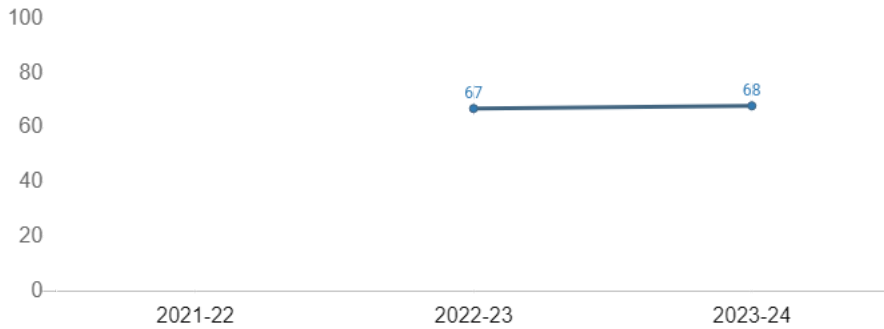

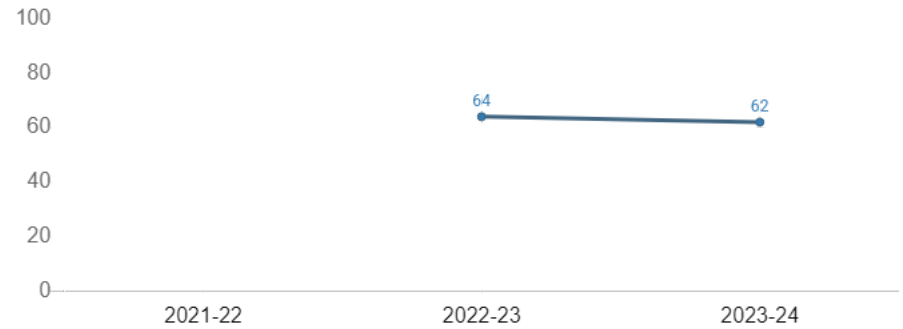

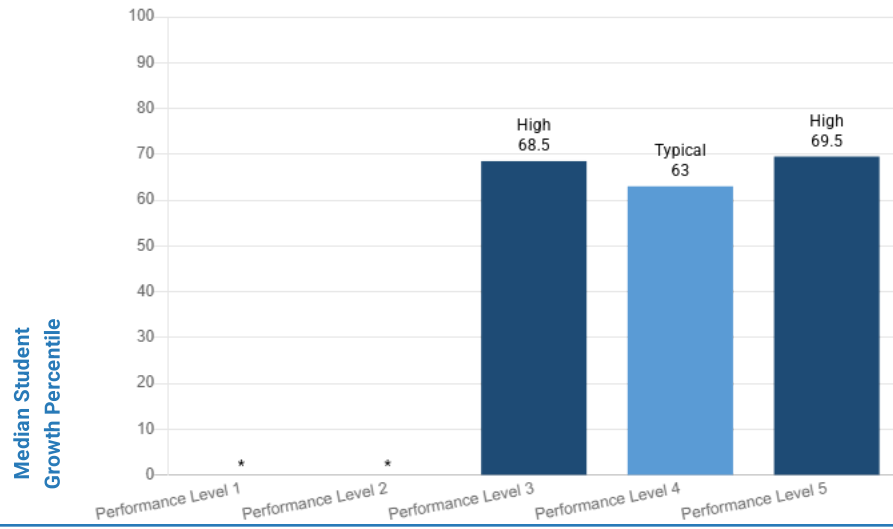

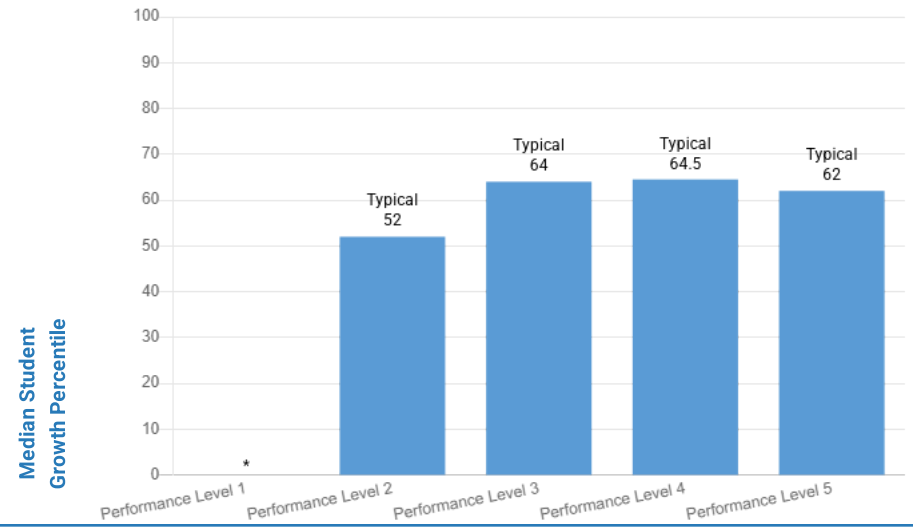

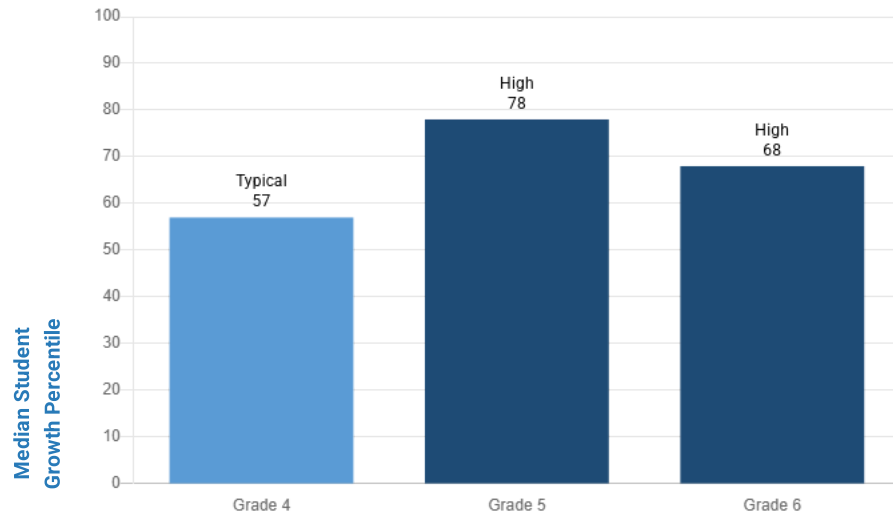

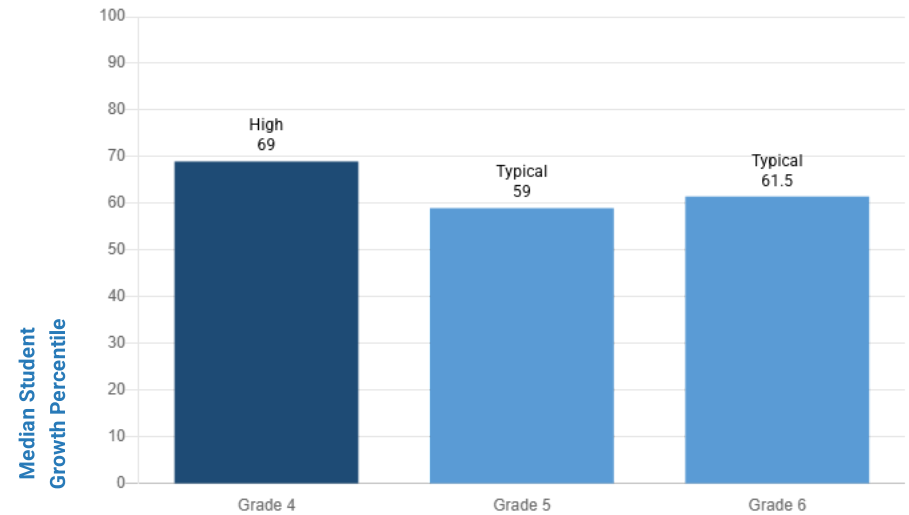

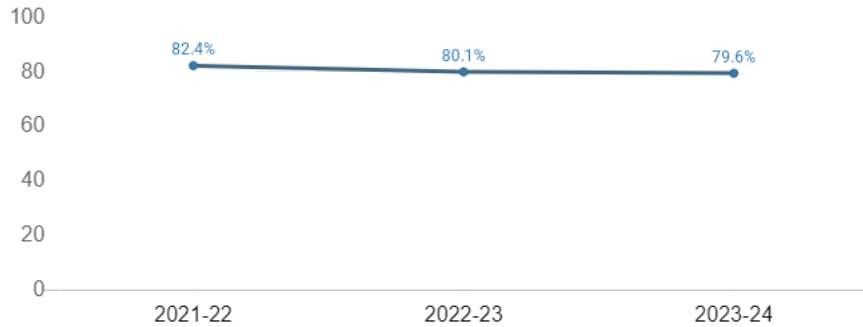

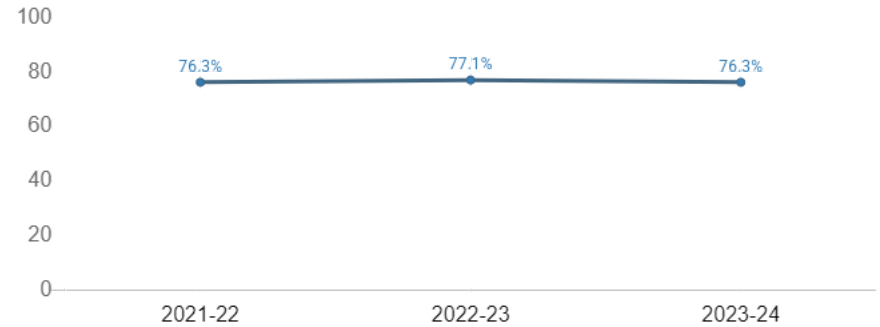
### English Language Arts and Mathematics Performance Trends

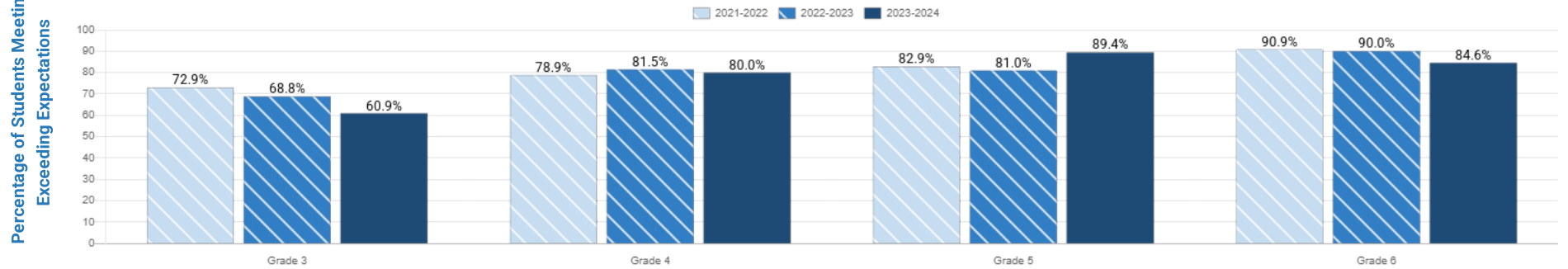

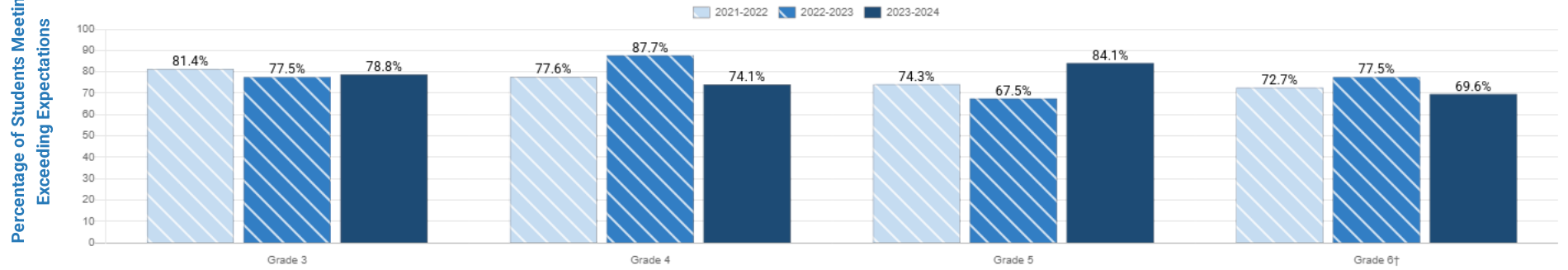

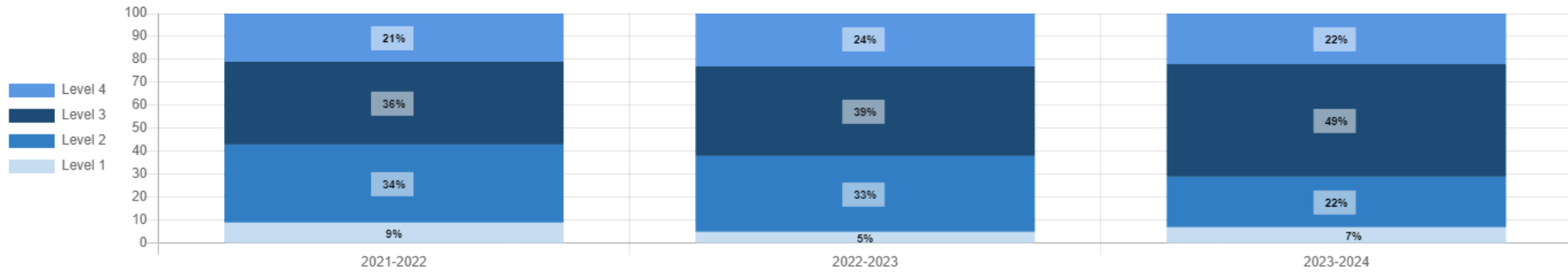

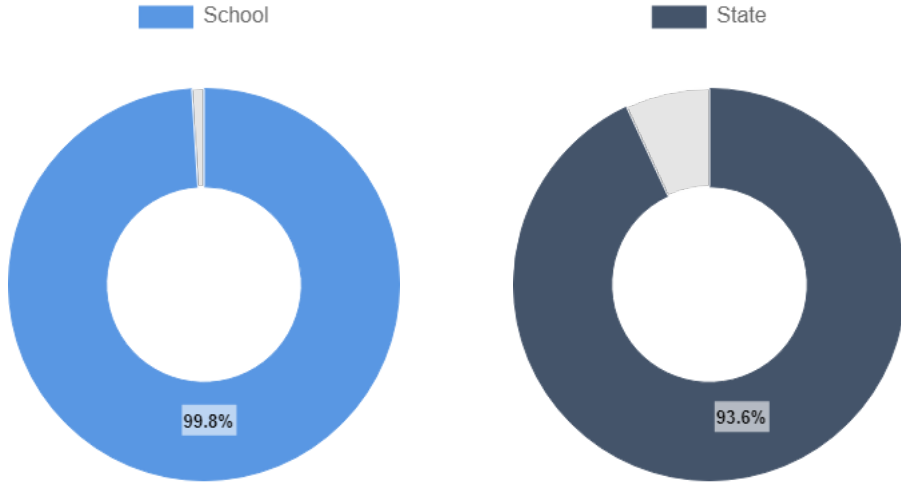

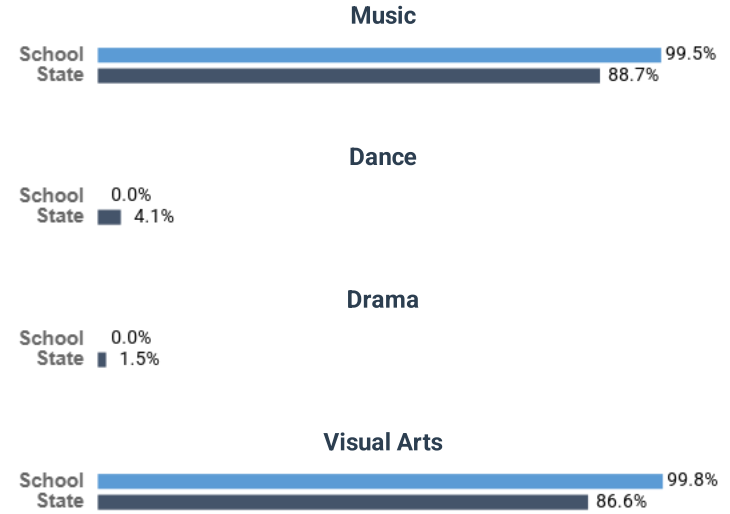

**Students enrolled in one or more classes by discipline:**



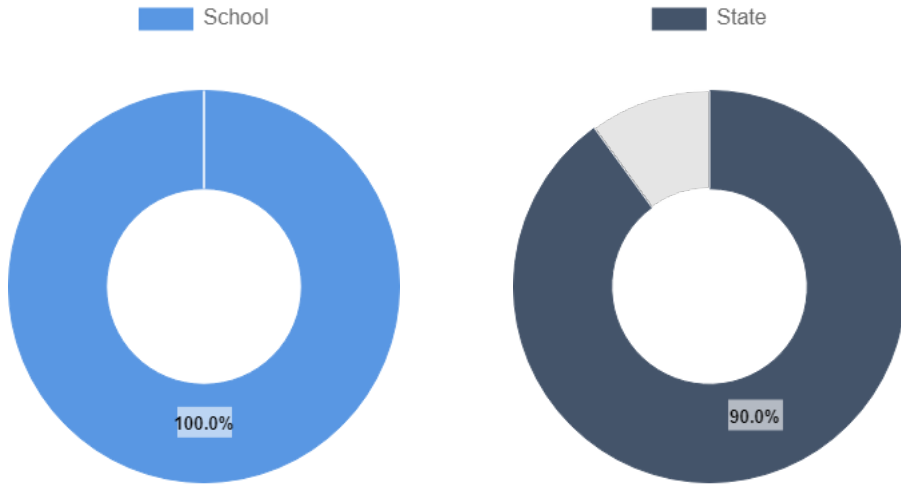

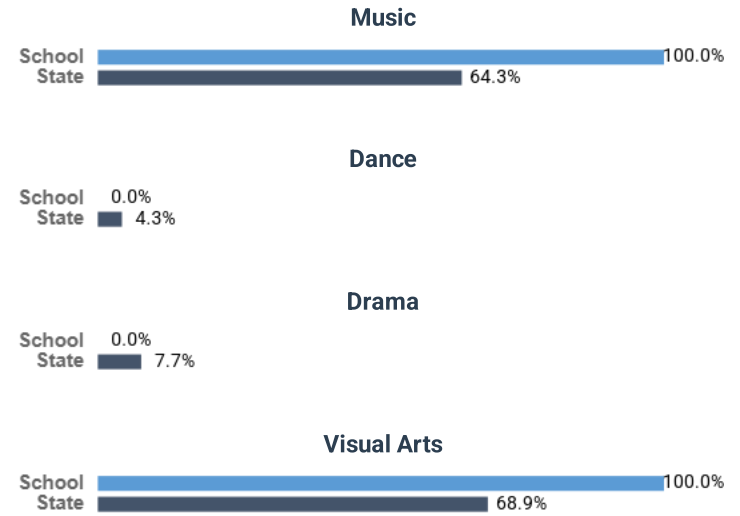

**Students enrolled in one or more classes by discipline:**



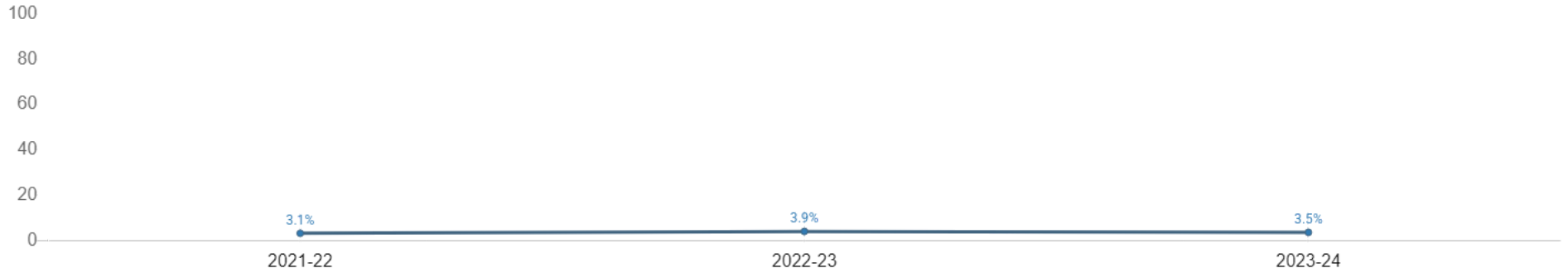

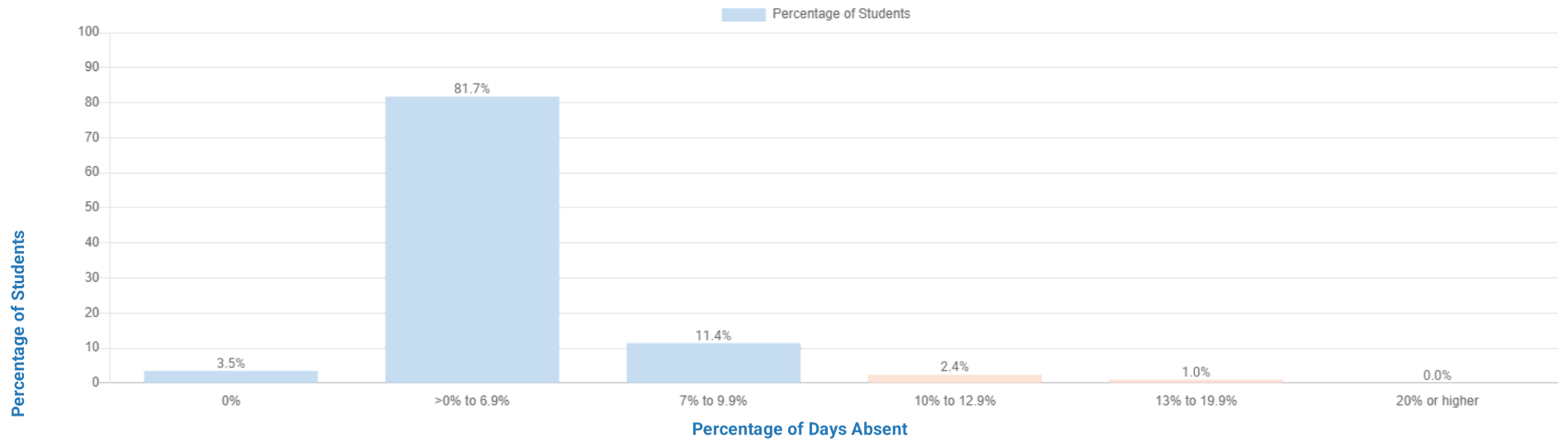

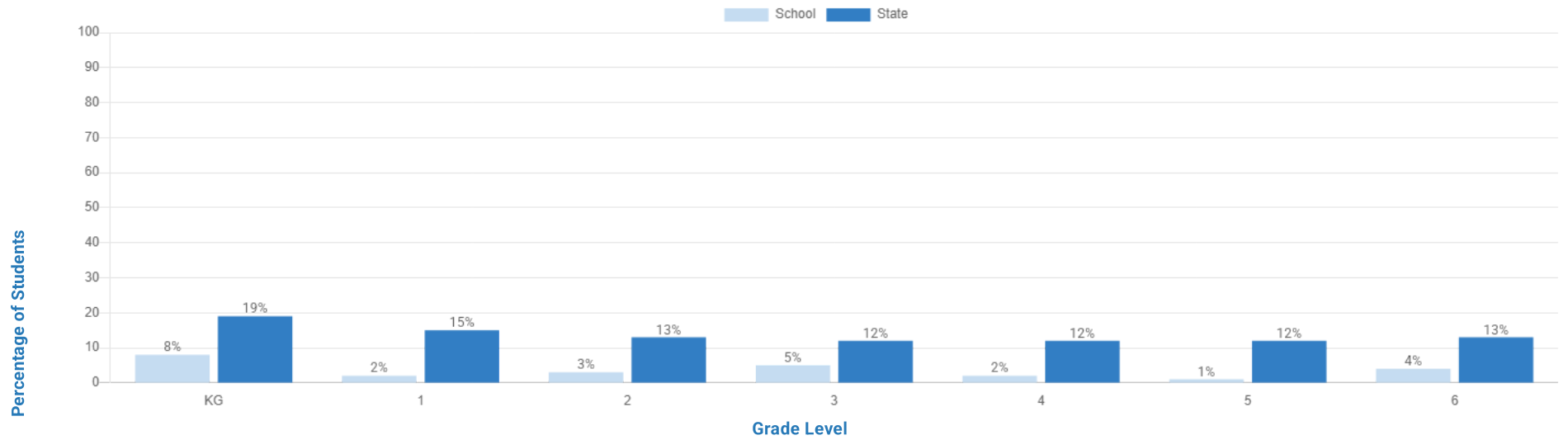

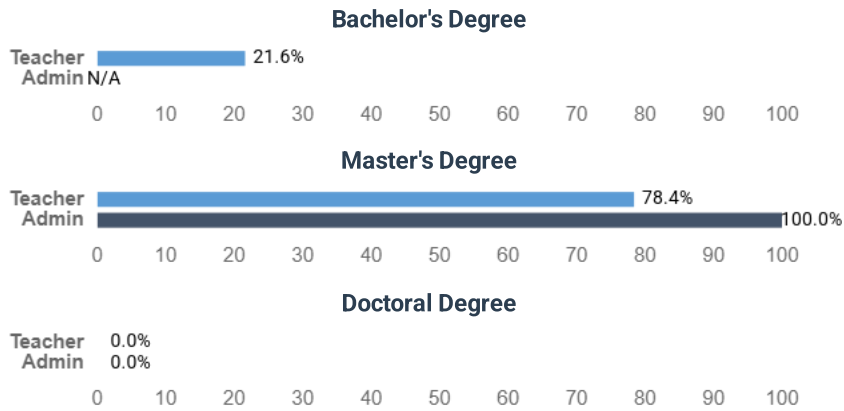

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

The NJDOE identified schools for ATSI status based on data from the 2022-2023 school year, so schools will not be identified for ATSI status based on data from the 2023-2024 school year. If at least one student group did not meet all targets and also did not meet all targets in the 2022-23 school year, then the school will be identified as requiring TSI.

### Courses, Curriculum, Instruction:

Each subject is anchored in a rigorous curriculum aligned to the New Jersey Student Learning Standards, ensuring that all students receive a strong foundation in core academic areas. Our curriculum emphasizes critical thinking, problem-solving, and creativity, enhanced by the integration of innovative programs and purposeful technology use, which allow students to engage deeply and prepare for future academic success. Starting in kindergarten, students engage in an exploration of the Spanish language, culture, and geography, broadening their global perspective and cultural awareness from an early age. Our enrichment program is designed to offer activities and resources in multiple content areas. Various differentiation models are used to support our curricula.



### Clubs and Activities:

Roosevelt offers a variety of clubs and extracurricular activities that nurture students' diverse interests and talents. Students can join DRUM, a percussion-focused club that cultivates musical expression and rhythm skills, or become part of the Artistically Talented program, where young artists explore various techniques to develop their creativity. The AV Club provides hands-on experiences in audio-visual technology. Chorus offers an opportunity to enhance vocal talents and perform at school events. Safety Patrol members help to maintain a safe and welcoming school environment. Through Student Council, students develop leadership skills, and take part in decision-making processes that positively impact the school. Big Buddies connects older students with younger peers, fostering mentorship, kindness, and schoolwide community building. These activities enrich the Roosevelt experience, providing students with valuable skills and memorable experiences beyond the classroom.



### Before and After School Programs:

We continue to expand our differentiation of learning by offering the Post-Dismissal Instructional Academy (PDIA). PDIA allows for weekly, after-school support to students who we feel need to close some learning gaps in English Language Arts and Mathematics.
